## On the sample size dependence of the critical current density in M gB $_{\rm 2}$ superconductors

Sample size dependent critical current density has been observed in magnesium diboride superconductors. At high elds, larger samples provide higher critical current densities, while at low elds, larger samples give rise to low er critical current densities. The explanation for this superising result is proposed in this study based on the electric eld generated in the superconductors. The dependence of the current density on the sample size has been derived as a power law  $j / R^{1=n}$  (n is the n factor characterizing E j curve  $E = E_c (j=j_c)^n$ ). This dependence provides one with a new m ethod to derive the n factor and can also be used to determ ine the dependence of the activation energy on the current density.

It has been reported that the critical current density derived from magnetic measurement in the magnesium diboride superconductors depends on the sample size [1, 2]. U sually a larger sample results in a higher critical current density at high elds. If this is a true intrinsic property of this new superconductor, it would be advantageous to use this superconductors in large scale applications. As far as we know, such a phenom enon has not been observed in either high tem perature or low tem perature superconductors. Explanations have been proposed to account for this observation [1, 2]. Jin et al. [2] m easured the relaxation of cylindrical m agnesium diboride superconductors of di erent lengths and found that the activation energy depends linearly on the length of the sample up to 1 mm and saturates after that. The authors suggested that the vortices in the magnesium diboride superconductors are quite rigid at sm all sam ple lengths and break into segments as the sample length  $\begin{pmatrix} 2 & 2 = \\ 0 & 2 = \end{pmatrix}^{1=3}$ reaches the collective pinning length L<sub>c</sub> the coherence length, with  $_0$  the basic energy scale, a param eter of disorder strength. How ever, their and proposal cannot explain the higher critical current density for smaller samples at low elds. Horvat et at. [1] proposed that di erent coupling between the superconducting grains at di erent length scales is responsible for the sam ple size dependent critical current density. How ever, this explanation is quite qualitative and not conclusive.

It is very important to clarify this problem. On the one hand, we need to understand the underlying mechanism governing this dependence in order to see whether we can further improve the critical current density by increasing the sample size and to understand why this phenom enon has not been reported in high temperature or low temperature superconductors. On the other hand, we need a standard to compare the current density of magnesium diboride superconductors fabricated by di erent techniques. In this paper, we propose an explanation for this observation based on the electric eld generated in the superconductors during a hysteresis loop measurement.

The samples used in this study are all in the shape of rectangular rods cut from a M qB<sub>2</sub> pellet. The sam ple preparation can be found elsewhere [3]. In order to elim inating any geometric e ects on the critical current density, the pellet was cut into a series of sam ples with constant size ratio a : b : c. Seven samples are used in this study with dimensions of a b c (m m<sup>3</sup>): 3:27 7:15,0:7 2:12 4:65,0:57 1:68 3:64, 1:07 2:92,0:36 1:08 2:29,0:29 0:85 1:87, 0:46 1:34 1:42 m m<sup>3</sup>. The critical current density is 0:24 0:68 derived from magnetic hysteresis loop measurements by means of a Quantum Design PPMS (Physical Property Measurement system) magnetometer with a sweep rate of 50 0 e/s. The measurem ents are performed with the applied eld parallel to the longest direction of the sam ple (caxis). The critical current density in full penetration can be estimated using the critical state model as: j = 20 M = a(1 a = 3b), where M is the width of the m agnetization hysteresis loop.




FIG.1: The magnetic eld dependent current density of the M  $gB_2$  samples at 5 K and 20 K. The arrows indicate the direction of increasing sample size.




FIG.2: The magnetic eld dependent current density of the M gB<sub>2</sub> samples at low magnetic eld for 5 K and 20 K. The arrows indicate the direction of increasing sample size.

Fig.1 shows the magnetic eld dependent critical current densities of all the sam ples at 5 K and 20 K. The arrows indicate the direction where the sam ple size increases. Flux jumping is observed for all sam ples at 5 K, but only for the two largest sam ples at 20 K. It can be clearly seen from Fig.1 that at high elds (larger than 3 T) the current density increases system atically as the sam ple size increases. But the current density tends to be saturated when the sam ple size is very large. The low

eld part of Fig. 1 is enlarged in Fig. 2, and again the arrow indicates the direction where the sample size increases. C ontrary to what is observed at high elds, the current density decreases as the sample size increases.

In order to explain this observation, we start from the ux creep equation derived from M axwell's equation r E = 0B = 0t with E = B v as discussed by Jirsa et al.

[4] and Schnack et al. [5],

The vortex velocity is assumed to be thermally activated, i.e. =  $_0 \exp[U(j)=kT]$ , where the attempt velocity  $_0 = x_0!_0$  with attempt frequency  $!_0$  and attempt distance  $x_0$  is the velocity of vortices when U(j) = 0 (i.e.  $j = j_c$ ). U(j) is the activation energy and k the Boltzmann constant. The di erential susceptibility  $_0$  and the geometric factor in Eq. (1) depend on the size and shape of the sample. Here we consider a disk with  $B_e$  parallel to its axis, then we have

where R is the radius of the disk,  $_0R =$  the self-inductance of the disk. Eq. (1) can be solved for U (j) as

$$U(j) = kT \ln \frac{B_e}{0\frac{dM}{dt} + 0\frac{dB_e}{dt}}$$

For a hysteresis loop measurement, we usually have  $0 \frac{dM}{dt} < 0 \frac{dB_e}{dt}$ , and Eq. (2) can then be reduced to

$$U(j) = kT \ln \frac{B_e 0}{0 \frac{dB_e}{dt}} = kT \ln \frac{2B_e 0}{RB_e}$$

here  $B_{e} = dB_{e} = dt$ . Eq. (3) is simply related to the current-voltage I V curves (or j versus E curves where

j is the current density and E the electric eld) since for a cylinder of radius R , Faraday's law leads to

$$E = \frac{R}{2} \frac{dB_e}{dt}$$

As can be seen from Eq. (4), a larger sample size R will lead to a larger electric eld in the sample, and therefore to a larger current density in the sample. This e ect is similar to the e ect of  $B_{\rm Te}$  on the hysteresis loop as has been used in dynam ical relaxation m easurem ents [4, 5].

A coording to Eq. (3), a di erent U (j) will result in a di erent dependence of the current density on the sam ple size. The relaxation results of M gB<sub>2</sub> sam ples have led to a logarithm ic dependence of the activation energy on the current density [6, 7]

$$U(j) = U_0 \log \frac{j_c}{j}$$

where  $U_0$  is the energy scale and  $j_c$  the true critical current density at which U ( $j_c$ ) = 0.

C om bining Eq. (3) with Eq. (5), we obtain the sample size dependence of the current density as

$$j = j_c R^{1=n} \frac{B_{-e}}{2B_{e 0}}$$

where  $n = U_0$  (B;T)=kT. The above analysis can also be applied to a rectangular rod with R ab=(a + b).

As can be seen from Eq. (6), the current density depends on the sample size as  $j / R^{1=n}$ , therefore the dependence is determined by the exponent n, which is a function of both temperature T and m agnetic eld B. If n is very large, there will be no sample size dependence as  $R^{1=n}$ ! 1, and this m ight be the reason why no sample




FIG.3: The sample size dependence of the current density of the M gB\_2 samples at 5 T, 6 T and 7 T for 5 K.Solid lines are the best thing to the linear dependence.

size dependent current density has been reported in low tem perature superconductors, characterizing the E j curve of the superconductors  $E = E_c (j=j_c)^n$ . Typical n factors in low tem perature superconductors vary between 10 and 100 [8]. As an example, magnets which work in the persistent mode without a drift require wires with a high n factor, typically larger than 30 at the highest eld [8]. In high tem perature superconductors, n values as low as 5 in NdBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> [9] and 4 YBa<sub>2</sub>Cu<sub>3</sub>O<sub>7</sub> [10] at high tem perature and high m agnetic eld have been reported, indicating that a signi cant sample size dependent current density should be observed. However, weak-links in polycrystalline high tem perature superconductors are very serious and prevail against the e ects shown in Eq. (6), resulting in a lower critical current density in larger sam ples.

A though the activation energy was reported to be very high in magnesium diboride at low temperature and low magnetic eld, it drops sharply as the applied magnetic eld and the tem perature are increased [6]. The n factors in M gB<sub>2</sub>/Fe tapes and w ires have been reported [11, 12]to be around 60 at 4 T, but drop to below 10 at high elds. From the I V curves of M gB<sub>2</sub> high density bulk sam ples reported by Pradhan et al. [13], the n factor is derived to be around 1.5 at 26.5 K and 5 T.A similar n factor around 1 has been obtained from I V curves by Kim et al. [14] at 30 K and 3 T.W hen the n factor is in this range, the sam ple size dependence of the current density is expected to appear as seen in Fig. 1. The power law dependence R<sup>1=n</sup> saturates as R is increased if n is larger than 1, which explains the reported saturation of the current density. A lthough no saturation is expected at very high tem peratures and elds (n m ay drop below 1), the total current is lim ited by the irreversibility line




FIG.4: The sample size dependence of the current density of the M gB<sub>2</sub> samples at 3 T, 4 T and 5 T for 20 K. Solid lines are the best thing to the linear dependence.




FIG. 5: The n factor as a function of the applied magnetic eld of the M gB $_2$  sam ples at 5 K and 20 K. The solid lines are only guides to the eyes.

Eq. (6) provides us with a new method to determ ine the n factor  $n = U_0$  (B;T)=kT by plotting lnj versus lnR. The inverse of the slope is just n. This method is applied to the samples used in this study, the results are shown in Fig. 3 and Fig. 4, where lnj versus lnR curves at 5 T, 6 T, and 7T at 5 K, and 3 T, 4 T, 5 T at 20 K are plotted respectively. The solid lines in Fig. 3 and Fig. 4 are the best ttings to the linear dependence between lnj versus lnR. The derived n factor is shown in Fig. 5 as a function of the applied magnetic eld at 5 K and 20 K. The solid lines are only guides to the eyes. This will be a very usefulm ethod when the critical current is too high to construct the whole I V curve to derive the n factor.

On the other hand, as the n factor is very high at low elds [11, 12] (m ore than 100), a sam ple size dependence of the current density is not expected ( $\mathbb{R}^{1=n}$  ! 1). The decreasing current density as the sample size increases might result from the self-eld e ect. Because larger sam ples carry larger currents (even if current density is alm ost the same), generating a larger self-eld, this results in a smaller current density. Signi cant self-eld has been observed in high tem perature superconductors, especially in tapes with large critical currents [15, 16]. And MgB<sub>2</sub> is expected to show similar behavior. Another possible reason is due to the surface pinning e ect [17]. In the presence of both bulk and surface pinning, the magnetization is just the sum of the bulk and surface contributions [18]. However, the surface component is only e ective in the elds  $H < H_p$  $H_{c1} = \ln$ , with the G insburg-Landau parameter and  $H_{c1}$  the lower critical eld [18]. For the rectangular rods in this study, the ratio between the surface area parallel to the applied m agnetic

eld and the sam ple volum e is 2(ac+bc)=abc=2=R, indicating a larger surface contribution as the sam ple size is decreased. This results in a larger current density in a smaller sam ple. The sam ple size dependence of the current density at low magnetic elds will be studied in m ore detail in our forthcom ing work.

A nother advantage of Eq. (6) is that we can use it to determ ine the current density dependent activation energy U (j) in the sample. This is because di erent U (j) relationships lead to di erent sample size dependences. For example, the linear current density dependent activation energy U (j) =  $U_0 (1 \quad j=j_c)$  will give rise to a logarithm ic dependence of the current density on the sample size,

$$j = j_c \ 1 + \frac{1}{n} \ln a + \frac{1}{n} \ln \frac{B_{e}}{2B_{e}}$$

which is di erent from the power law dependence shown in Eq. (6). The experimental results shown in Fig. (3) and Fig. (4) indicate that in magnesium diboride superconductors, the activation energy depends logarithm ically on the current density (Eq. (5)), rather than having the linear Anderson-K in type dependence suggested by Jin et al. [2].

In sum m ary, the dependence of the current density on the sample size in m agnesium diboride superconductors has been observed and explained in this Letter based on the electric eld generated in the superconductors. Starting from the ux creep equation, we have derived an analytical expression j / R<sup>1=n</sup> for the sam ple size dependent current density. We have shown that the sam ple size dependence of the current density can be used to derive the n factor of M gB<sub>2</sub> sam ples and can also be used to determ ine the dependence between the activation energy and the current density.
