## Excitations in con ned helium

We design models for helium in matrices like aerogel, Vycor or Geltech from a manifestly microscopic point of view. For that purpose, we calculate the dynamic structure function of  $^4\mathrm{He}$  on Sisubstrates and between two Siwalls as a function of energy, momentum transfer, and the scattering angle. The angle{averaged results are in good agreement with the neutron scattering data; the remaining dierences can be attributed to the simplied model used here for the complex pore structure of the materials. A focus of the present work is the detailed identication of coexisting layer modes and bulk{like excitations, and, in the case of thick lms, ripplon excitations. Involving essentially two{dimensional motion of atoms, the layer modes are sensitive to the scattering angle.

#### I. INTRODUCTION

There is much current interest in understanding the properties of super uid 4He in con nement. In particular, collective excitations of super uid helium con ned to silica aerogel have been studied by neutron scattering since the early 90's [1, 2], and by now a wealth of inform ation about helium in aerogel, Vycor and Geltech has been collected [3, 4, 5, 6, 7, 8, 9, 10, 11]. A erogel is an open gel structure form ed by silica strands (SiO<sub>2</sub>). Typical pore sizes range from few A to few hundred A, without any characteristic pore size. Vycor is a porous glass, where pores form channels of about 70 A diam eter. Geltech resembles aerogel, except that the nominal pore size is 25 A [11]. When liquid helium is placed in such an environment, it will rst be physisorbed to the free surfaces of the matrices. Such an adsorption occurs in layers, the rst layer of He is expected to be solid; on a more strongly binding substrate, such as graphite, one expects two solid layers. In this work we are restricted to the liquid state, and the layer of solid helium is considered as part of the substrate.

Recent very accurate instruments have, contrary to earlier ndings, revealed that the energies and lifetimes of phonon (roton excitations for conned He are nearly equal to their bulk super uid He values. Specically, the roton linewidth was found by Anderson et al. [12] to be less than the instrumental resolution, 0.1 m. As expected, dierences usually appear at partial llings. The appearance of ripplons is tied to the existence of a free liquid surface; neutron scattering experiments show clearly their presence in on adsorbed Ims [13, 14] and in aerogel containing few layers of helium [15, 16].

Since nothing spectacular could be seen in the bulk { like mode, the focus shifted to nearly two {dimensional \layer modes". The existence of collective excitations below the roton minimum has been demonstrated rst by Lauter and collaborators [17, 18, 19, 20]; these modes were identified as longitudinal phonons propagating in the rst liquid layer close to the substrate [21, 22, 23]. The nature of these modes has been found to be very resilient and quite independent on the substrate strength [24], only for very weakly attractive substrates like Cs,

the \layer phonons" acquire a transverse component and become similar to ripplons. Layer modes in helium have been observed in Vycor [25] and in both fully led and partially led aerogel above wave vector 1.7 A  $^1$  [26]. Therefore, layer modes are the only excitations observed that are characteristic for helium lm s or helium in aerogel or Vycor.

The e ect of disorder on macroscopic properties of both <sup>3</sup>He and <sup>4</sup>He has been investigated in detail, but there are only few theoretical studies on excitations that apply to con ned helium. Locally, the density pro le of the liquid can be assumed to be that of a helium lling a space between two planes [28]. [27] or helium Impurity induced disorder has been studied using Path Integral M onte Carlo [29]. At the m om ent there are no close (to (reality models of the con ning structures com bined with a proper theory of super uid helium . O bvious sim pli ed m odel system s are liquid helium lling random voids or helium between parallel planes. The former is com putationally very dem anding. Experim ents have covered the full range of helium thicknesses, from a bare m onolayer to a led sample, and the results show that layer modes are visible against the background of bulk excitations if there are about four or ve layers of helium; in those cases we are basically dealing with a thick He lm on Si. However, the pores in aerogeland Geltech are not lling uniform ly, which has lead to the notion of connected super uidity and localized Bose-Einstein condensation [11]. Thus a well{de ned phonon {roton spectrum may persist above the critical temperature.

## II. THEORY

The m ethod of choice for studying the strongly interacting quantum liquid  $^4\text{H}\,\text{e}$  is the Jastrow {Feenberg theory. The theory is m icroscopic in the sense that it begins with the best available representation of the many-body Hamiltonian,

where V  $(\dot{r}_i \quad r_j)$  is the HeHe interaction [30]. Compared to the bulk liquid, the essential new property that must be dealt with is the breaking of translational invariance and anisotropy of the system. Such symmetry breakings may be induced by the substrate potential  $U_{\rm sub}(r_i)$ , but they may also occur spontaneously like in the formation of quantum liquid droplets [31, 32]. The ground (state theory has been throughly discussed in Ref. 27 and the corresponding excited (state theory is covered in Ref. 23, therefore we only need to review the key points.

The ground { state wave function

is written in Jastrow-Feenberg form; the n-body correlation functions  $u_n \ (r_1; ::: ; r_n)$  are determined by functional minimization of the energy. The theory yields the ground state energetics and structure of the liquid and provides the raw material for investigating excitations.

To introduce excitations to the system one applies a small, time (dependent perturbation that momentarily drives the quantum liquid out of its ground state. This causes the n-body correlations in the wave function presented in Eq. (2) to acquire time dependence, hence the excited state has the form

The time {dependent correlation functions  $u_n(r_1; ::::; r_n; t)$  are determined by an action principle [33]

where  $U_{\text{ext}}\left(t\right)$  is the weak external potential driving the excitations.

Linearizing the equations of motion for the wave function j (t)  $i = j_0 i + j$  (t) i and calculating the time (dependent component of the transition density (r;t) =  $_0$  ^(r) (t) + cx: allow sus to calculate the density (density response function (r;r<sup>0</sup>;!) dened via

Once the response function is known, one can apply the uctuation {dissipation theorem to nd the dynamic

structure function,

To obtain the dynam ic structure function measured by, e.g., neutron scattering, one has to project  $S(r;r^0;!)$  onto plane waves:

Up to this points the form ulas are valid for any geom etry. Since the systems with slit or slab geom etry under consideration here are translationally invariant only in the (x y) plane, but not in the z direction, only the momentum transfer  $k_k$  parallel to the  $\,$ lm or slab is a good quantum number. In this case , we have

The truncation of the sequence of uctuating correlations  $u_h$  in Eq. (4) de nest he level of approximation in which we treat the excitations. The excitation spectrum can be quite wellunderstood [34, 35, 36] by retaining only the time (dependent one (and two (body terms in the excitation operator (4). The two (body terms  $u_2$  ( $r_1$ ;  $r_2$ ; t) describe the interaction of two excitations. The simplest non (trivial implementation of the theory leads to a density (density response function of the form [23]

the phonon propagator. The uctuating pair correlations give rise to the self-energy [23],

Here, the sum mation is over the Feynman states m;n; they form a partly discrete, partly continuous set due to the inhom ogeneity of the liquid. The expression for the three{phonon coupling am plitudes  $V_{m\,n}^{\,(s)}$  can be found in Ref. 23. This self energy renormalizes the Feynman \phonon" energies !n, and adds a nite lifetime to states that can decay to two lower{energy modes. The resulting density {density response function has the structure of a Brillouin-Wigner (BW) perturbation formula. The approximate form of the self energy given in Eq. (12) is also closely related to the one obtained using the theory of correlated basis functions (CBF) [34, 35]. As a nal renement to the theory, we scale the Feynman energies

 $!_{\,\rm n}$  appearing in the energy denom inator of the self-energy given in Eq. (12) such that the roton m inimum of the spectrum used in the energy denom inator of Eq. (12) agrees roughly with the roton m inimum predicted by the calculated S (k;!). This is just a computationally simple way of adding the self-energy correction to the excitation energies in the self-energy itself. We shall use this scaled CBF-BW approximation for the numerical parts of this paper.

A direct characterization of each mode is obtained by computing the transition density

where  $^{(r)}$  and  $^{(r)}$  are the fam iliar one{body density and current operators. The transition density shows the density change (arbitrary amplitude) and the transition current the ow pattern of atoms in the mode.

#### III. RESULTS

We have modeled the con ned quantum liquid by <sup>4</sup>He between two planar substrates. The distance between the substrate planes in our calculations is 40 A which is not too far from the diam eter of aerogel strands and an intermediate value between the pore or channel diameters in Vycor (d 70A) and Geltech (d 25A). We assume translational invariance in a plane parallel to the surface. This is, of course, not exactly true in the above mentioned materials. However, our assumption should only change the details of the excitations spectrum at long wave lengths that are comparable to the pore size, whereas rotons arise from short range correlations.




FIG. 1: The density pro less of the  $\,$  lm and the  $\,$  lled gap used in this work. The coverages of the  $\,$  lm is 0.3 A  $^2$ , and the  $\,$  lled gap has 0.85 atom sper A  $^2$ .

W e have computed the dynamic structure function as a function of the scattering angle for a thick lm and a lled gap. The density pro les for these two situations are shown in Fig. 1. The interaction of <sup>4</sup>He particles with the walls is described by the usual 3-9 potential obtained from averaging Lennard-Jones potentials over a half space. This is valid if the walls are smooth and, hence, U<sub>sub</sub> (r) is a function of one coordinate only. Our approximation is legitimate because the lateral structure of surface is smoothed out by the rst solid layer of helium atom s. The 3-9 potential used in this work is derived from the silicon-helium interaction [37]; we have supplem ented this potential by a 4-10 potential due to averaging Lennard (Jones 6-12 potentials for the <sup>4</sup>H e <sup>4</sup>H e interaction over a plane. Thus, our substrate potential has the form

with a well{depth D = 128 K and a range C<sub>3</sub> =  $2000 \text{ KA}^3$ . The potential U<sub>4</sub>(z) has the form

Here, =  $10.22\,\mathrm{K}$  and =  $2.556\mathrm{A}$  are the usual deBoer-M ichels parameters for the helium-helium interaction. The areal density of the solid monolayer was taken to be  $_1 = 0.07\,\mathrm{A}^2$  and a thickness  $z_0 = 3.3\,\mathrm{A}$ . The picture is consistent values for hectorite gaps [38], the areal density is somewhat lower than the one of the second solid layer on graphite [39].

The helium  $\,$  Im considered here is thick enough to support layer rotons; ripplons will also appear for the  $\,$  Im model which has a free surface. In the  $\,$  lled gap case the amount of helium between the Siplanes was chosen to correspond the  $\,$  lling of an aerogel sample surrounded by bulk liquid in equilibrium. The chemical potential of the conned liquid and that of a reservoir of bulk liquid turned out to be equal (  $\,$  72 K) at n = 0.85 A  $^2$  . For comparison, a 40 A thick slice of bulk liquid at the equilibrium density 0.02185 A  $^3$  would correspond to the coverage n = 0.87 A  $^2$  .

Som e excitations modes are bulk (like, these have no signi cantangle dependence. In the bulk liquid the roton energy decreases and the roton minimum moves to higher momenta as the density increases. Traces of this e ect are also visible in the 3D roton: the roton energy is above it's equilibrium bulk value because of the low density regions between the layers.

Layerm odes, on the other hand, are entirely dierent. In lm s, layer rotons propagate mainly in the highest density liquid layer closest to the substrate, hence their motion is well conned to two dimensions and their propagation direction is always parallel to the surface. Their energy has a parabolic minimum at a xed wave vector  $k_{k;0}$  in the plane parallel to the surface. Upon changing the orientation of the surface also the in {plane component of the total wave vector transfer changes. As a result, the location of the layer roton minimum shifts.

We will show our results for the dynamic structure function as gray {scale plots. In these maps of the dynamic structure function, darker areas correspond to higher value of S (k;!). To emphasize low {intensity regions we use the scale S  $(k;!)^{1-4}$ , the same gray scale will be used throughout this work. To facilitate plotting we have also introduced a 0.05 K Lorentzian broadening of the structure functions. We measure the scattering angle from the substrate plane, so = 0 corresponds to grazing angle and = 90 degrees is scattering perpendicular to the substrate plane.

## A. Thick <sup>4</sup>He lm son silicon




FIG. 2: The dynam ic structure function of a thick  $^4$ He lm on a Si surface (coverage n = 0:3 A  $^2$ ) at grazing angle (upper panel) and perpendicular to the substrate (lower panel).

Fig. 2 shows the dynam ic structure function of a thick  $^4{\rm H\,e}$  lm on Si for scattering angles = 0 and = 90 de-

grees. The form er shows a ripplon mode with dispersion  $k^{3=2}$ , and also two layer rotons below the bulk roton are clearly distinguishable. Perpendicular scattering shows a discrete set of low (energy dispersionless m odes, but som e strong resonances appear also above the continuum lim it = 7:7 K. In the perpendicular case the fam iliar phonon {roton form is still recognizable, but beside it there are secondary maxima, which are roughly evenly spaced in  $k_2$ . These strands appear because the projection onto plane waves in Eq.(9) gives contributions to multiple perpendicular momenta  $k_2$ , and the dynam ic structure function shows features coming from the Fourier transform of the density pro le. A detailed description of how the strands appear was recently given in Ref. 40.




FIG. 3: The dynam ic structure function of a thick  $\,$  Im on a Si surface (coverage n = 0.3 A  $^2$ ). The plot shows the sum of contributions at angles between 0 and 90 degrees with 5 degree steps. The dashed lines show the experimental layer roton dispersion for aerogel (upper curve) and Vycor (lower curve) by P lantevin et al. [10]; The solid curve shows the layer roton and ripplon data from Ref. 41.

Random ly oriented surfaces give rise to an angular averaged response. Fig. 3 shows such a theoretical dynamic structure function, where contributions from several scattering angles between 0 and 90 degrees have been added. W hile the contributions from bulk { like rotons add up to a single curve, the ones from 2D m odes do not. The low { k region shows faints steps at about h! = 0 K, 1.9 K, 4.4K, 6.0K etc., rem in iscent of the states turning dispersionless as the angle increases; hence the fan { like structures. The strongest of these comes from the ripplons, and is probably the only one that can be in experim ents. Asmentioned earlier, the layer roton minimum shifts to higher total m om entum transfers as the scattering angle increases. This has not been seen in neutron scattering experim ents, which show a clear parabolic dispersion for the layer modes. The parallel direction gives the the strongest signal in neutron scattering, and we can only assume that the contribution from other angles in the raw data is simply too small to give any information to be inverted to S (k;!).




FIG. 4: The fully angle(averaged S (k;!) of a thick  $\,$  lm at k = 1.8 A  $^{-1}$  . The coverage is 0.3 A  $^{-2}$  .

Fig. 4 shows a fully angle (averaged dynam ic structure function at k =  $1.8\,\mathrm{A}^{-1}$  , near the roton m in im um . A ngle





FIG. 5: Transition density (thick line) and transition current (arrows; right scale) for the low (energy modes at  $k=1.8\ A^{-1}$  for a thick  $\,$  lm on Si substrate and scattering parallel to the surfaces,  $\,=\,0$ . The grayscale plot shows the density pro le. Excitations energies are indicated in the gures, the lowest panel corresponds to lowest energy.

averaging causes the layer mode peaks to become asymmetric, while it has no e ect on the bulk { like modes. The asym m etry is clearly visible in the rst{layerpeak, which has a broad tail on the high {energy side. This broadening is just due to sum m ing up of the multiple layer roton parabola, which show as separate curves in Fig. 3. A direct identi cation of the modes is given by the transition density and current, shown for the thick Im in Fig. 5 for = 0. The scale on the right corresponds to the transition current, depicted as a vector eld, for the duration of one oscillatory cycle which takes about 48 picoseconds. The lowest energy mode for grazing angle is a layer roton, which involves atom s in the layer closest to the substrate. The next mode is loosely con ned to the second layer, but subsequent modes spread throughout the liquid as there are no more well separated layers available. From the third mode on the excitations are three dim ensional, as well as they can be in a 15 A thick




FIG. 6: Same as Fig. 5 for = 90 (specular scattering).

The situation in the perpendicular scattering is completely dierent. The lowest panel of Fig. 6 shows the mode at  $h!=1.9\,\mathrm{K}$ , which already has one node in the

transition density. Particle number conservation forbids a nodeless mode, so the rst real excitation is one where the liquid oscillates with respect to the substrate.

Fig. 6 can be looked upon as a pictorial view of quantum evaporation. Higher energy modes involve motion of atoms near the surface, and nally modes with energy abovem inus the chemical potential (now =  $7.7 \, \text{K}$ ) are energetic enough to kick out atoms to continuum states.

# B. <sup>4</sup>He lling space between two silicon surfaces




FIG. 7: The total energy (solid line, left scale) and pressure (dashed line, right scale) of a helium lled 40 A wide gap as a function of coverage. Liquid in the middle of the gap becomes unstable at about 0.68 A  $^2$  indicating the formation of two separate thick lms on both walls.

Fig. 7 shows the energy and pressure in the case, where helium—lls the space between the substrate walls. The equilibrium density of the—lled gap by itself would be

at about  $= 0.78\,\mathrm{A}^2$ , but the liquid is in balance with an external bulk  $^4\mathrm{He}$  reservoir at  $= 0.85\,\mathrm{A}^2$ . Below  $0.68\,\mathrm{A}^2$  the liquid is no longer translationally invariant parallel to the walls, and the instability in the liquid solution is an indication of capillary condensation. At low density liquid form stwo  $\,\mathrm{lm}\,\mathrm{s}\,\mathrm{covering}\,\mathrm{both}\,\mathrm{surfaces}.$  In the  $\,\mathrm{lled}\,\mathrm{gap}\,\mathrm{case}$ , if the density of helium between the walls is further increased, one observes a sequence of layering transitions: the number of helium layers increases. This  $\,\mathrm{lling}\,\mathrm{scenario}\,\mathrm{has}\,\mathrm{been}\,\mathrm{discussed}\,\mathrm{in}\,\mathrm{detail}\,\mathrm{in}\,\mathrm{R}\,\mathrm{ef.}\,[28].$




FIG. 8: The dynam ic structure function of the lled gap. The plot shows the sum of contributions at angles between 0 and 90 degrees in 5 degree steps. The calculated layer roton shifts to higher k as a function of angle. The dashed lines show the experimental layer roton dispersion for aerogel (upper curve) and Vycor (lower curve) by Plantevin et al. [10]; the solid curve shows results from Ref. 41.

The (partially) angle averaged S (k;!) in Fig.8 is qualitatively dierent from the lm case result in Fig.3 only in the low (momentum region. There is now only one strong maximum corresponding to bulk phonons on top of a faint step structure. The steps are a remainder of the discrete states in the perpendicular or nearly perpendicular directions. The angle averaged S (k;!) near the roton wave vector is quite similar to the one in the thick lm case, depicted in Fig.4




FIG. 9: Transition density (thick line) and transition current (arrows; right scale) in the low {energy modes at  $k=1.8~A^{-1}$  in the helium—lled gap at  $n=0.85~A^{-2}$  for grazing angle. The grayscale plot shows the density pro—le. The transition density has arbitrary scale. Excitations energies are indicated in the gures, lowest panel corresponds to lowest energy. Due to the sym metric density pro—le there is pairwise degeneracy of modes corresponding to in {phase and out{of{phase oscillation between the left and the right side; we show here only the latter ones.




FIG. 10: Same as Fig. 9 for the 90 degree angle (specular scattering), except that now there is no degeneracy and we show all low (energy modes.

The transition densities and currents are shown in Figs. 9 and 10 for scattering angles 0 and 90 degrees, respectively. At grazing angle the low {energy excitation reside in the layers near the substrate, and pairs ofm odes corresponding to in{ and out{of{phase oscillations are degenerate. The modes with even number of oscillations have their counterparts in the case of two Ims on both walls, as one can see by comparing Figs. 6 and 10. The lowest mode depicted in Fig. 10 with odd number of oscillations have liquid oscillating back and forth in the middle of the gap, and with decreasing density this oscillation is nally able to divide the system into two Ims. The point where this mode becomes soft is the spinodal instability of the Iled case.

### IV. CONCLUSIONS

In order to model <sup>4</sup>He con ned in materials like aerogel, Vycor or Geltech, we have calculated the energetics, the density pro le and the dynam ical properties of thick <sup>4</sup>He Im on Sisubstrate and between two substrate planes. The simulation of con nement in spherical pores, which is perhaps the model that is closest to reality, is also feasible with our techniques, but computationally less e cient. For the excitations near the roton wave vector, where the most interesting phenomena are occurring, the use of a simpli ed planar geom etry should not make much di erence because the roton wave length is much shorter than any lengthscale on which the lateral structure of the aerogelchanges. The two {wallgeom etry has actually been used in speci cheat measurements by Gasparini and collaborators [42, 43, 44, 45], but the distance between the silicon planes was a couple of magnitudes larger than in our model. For a large wall distance the m id section of the liquid is essentially unaware of the substrate. Thus one would have a thick region of basic bulk helium, which would show up almost exclusively in the dynam ic structure function.

The results for thick helium Ims are relevant for large pores at low Iling, when opposite walls are approximately noninteracting and the curvature of the liquid can be ignored. We have not considered the possibility of unevenly Iled pores or a distribution pore sizes, because the characteristics of porous systems are very material dependent, and our aim was to discuss phenomena that are universal in such materials.

There are presently two sets of data for the layer roton, those of Refs. 10 and of 41. When comparing theory and experiment, two aspects are of interest: One is the

energy of the layer roton, and the other one the dispersion curve. As can be seen from the measurements of Ref. 10 and 41 shown in Figs. 3 and 8, as well as from other measurements [25, 26], that the energy of the layer roton depends sensitively on the nature of the substrate. This is expected because dierent substrates will lead to dierent densities of the rest liquid layers and, hence, to

di erent phonon{roton spectra. Indeed, the dependence is so sensitive that it m ight be possible to determ ine the strength of the substrate potential from the energy of the roton gap.

The measurem ents of Ref. 41 show a signi cantly smaller curvature of the dispersion curve than those of the other experiments, but they agree better with our calculations. Keeping the extremed is culty of extracting these data from neutron scattering spectra in mind, we tend towards the view that the experiments of Ref. 41 provide a more accurate description. This is so for two reasons: First, the curvature of the roton in purely two (dimensional He is smaller than that obtained in Ref. 10, and second, as shown in Figs. 3 and 8, the angular averaging leads to a further broadening.
