X-Ray Magnetic Circular Dichroism at the K edge of Mn₃GaC

We theoretically investigate the origin of the x-ray magnetic circular dichroism (XMCD) spectra at the K edges of M n and G a in the ferrom agnetic phase of M n₃G aC on the basis of an ab initio calculation. Taking account of the spin-orbit interaction in the LDA scheme, we obtain the XMCD spectra in excellent agreement with the recent experiment. We have analyzed the origin of each structure, and thus elucidated the mechanism of inducing the orbital polarization in the p sym metric states. We also discuss a simple sum rule connecting the XMCD spectra with the orbital moment in the p sym metric states.

I. IN TRODUCTION

X-ray magnetic circular dichroism (XMCD) has attracted much interest as a useful tool to investigate magnetic states¹. The spectra directly re ect the magnetic order at the L2:3 edges of transition-m etal com pounds and at the M_{4;5} edges of rare-earth compounds, because by photoabsorption the core electron enters the 3d or 4f states which constitute the magnetic order. Sum rules have been found useful to evaluate the or $bitalm agnetization^{2,3,4}$. On the other hand, at earlier time, it was not clear where the XMCD spectra at the K edge of transition-m etal com pounds com e from , because the 4p states the core electron enters by photoabsorption are not the states constituting the magnetic order^{5,6,7}. One of the present authors and H irai have analyzed the XMCD at the K edge of ferrom agnetic m etals, Fe, Co, and Ni, and have found that the spectra com e from the 4p orbital polarization induced by the mixing to the 3d states at neighboring sites^{8,9}. Subsequent experiments and calculations reached the similar conclusion for severaltransition-m etal com pounds.^{10,11,12,13,14,15,16,17}

The above mechanism is a consequence of an extended character of 4p states, and is closely related to the mechanism of the resonant x-ray scattering (RXS) at the K edges of transition m etals in several com pounds^{18,19}. The RXS intensity on superlattice spots was considered to be a direct re ection of the orbital order in LaM nO₃²⁰, but subsequent studies based on band structure calculations have revealed that the RXS intensity arises mainly from the lattice distortion which modulates the 4p states in the interm ediate state of the second order process of the RXS^{21,22,23}. Recently, ab initio calculations of the RXS spectra have been carried out for Y T iO₃ and Y VO₃, having clari ed the important role of lattice distortion^{24,25}.

D espite such progress, the underlying mechanism of inducing 4p orbital polarizations is not fully understood. The XMCD experimental data recently obtained in the ferrom agnetic phase of M n_3 G aC 26,27 seem s suitable to make clear the mechanism, because considerable signals

have been found not only at the K edge of M n but also at the K edge of G a. In this paper, we analyze the XM CD spectra at the K edges in M n₃G aC through an ab initio calculation. W e use the K orringa-K ohn-R ostoker (K K R) m ethod within the mu n-tin (M T) approximation ³⁴ in the local density approximation (LDA) scheme, and take account of the spin-orbit interaction (SO I). W e neglect the core-hole potential in the nal state. W e expect that the nal-state interaction is unimportant except for the Ferm i-edge singularity, because it is known from the study of the XM CD in Fe, Co, N i, that the spectra are w ell reproduced without taking account of the nal-state interaction^{6,7,8,9}. This may come from the fact that the 4p states have sm allam plitude inside the M T sphere and thus are little subject to the core hole potential.

In Sec. II, we calculate the electronic structure in a ferrom agnetic phase of M n_3 G aC. In Sec. III, we present the form ulas for the XMCD spectra and derive a sum rule. We also discuss the calculated spectra in comparison with the experiment. Section IV is devoted to concluding remarks.

II. ELECTRONIC STRUCTURE




FIG.1: Inverse perovskite-type crystal structure.

This material takes an \inverse" perovskite structure²⁸, as schematically shown in Fig. 1. It. has an interesting magnetic property; the antiferrom agnetic phase in low temperatures turns into a ferrom agnetic phase in high tem peratures through a rst-order transition at 168 K²⁶. We carry out the band calculation assuming a ferrom agnetic phase with the magnetization xed to the opposite of the [111] direction, although an antiferrom agnetic phase may be stabler than the ferrom agnetic phase. By xing the m agnetization direction, we neglect the sm all m agnetic anisotropy. W e de ne the density of states (DOS) inside the MT sphere at a Mn site and at a Ga site. On Mn sites, the DOS projected onto the d symmetric states is dom inating near the Ferm i level. The s and p sym m etric

DOS's are found extremely small. The spin and orbital angularm om enta, denoted as S and L in units of h, are de ned also inside the MT sphere. W e get S = 0.73 and L = 0.042 in the d symmetric states, both of which are pointing to the [111] direction, while we get S = 0:0006, L = 0.00006 in the p sym m etric states (the sign m eans that the angular momentum is pointing to the opposite of the [111] direction). The total magnetic moment becomes $(2S + L)_B = 1.50_B$ per Mn. This value is consistent with the magnetization measurement²⁸ and the previous band calculations without taking account of the SO $I^{29,30}$. On the other hand, on G a sites, the 3d states are located about 12 eV below the Ferm i level. The s and p sym m etric D O S's are found sm all above the Ferm i level. Sm all angular m om enta are induced due to the in uence of the magnetic moments at Mn sites. We get S = 0:011, L = 0:00046 in the p sym m etric states, and much smaller values, S = 0.0021, L = 0.00041, in the d sym m etric states.

III. XM CD SPECTRA

W e calculate the absorption coe cient, neglecting the core hole potential. A ssum ing that photons are propagating along the [111] direction, we have the expressions for the right-handed (+) and left-handed () circular polarizations,

where the spherical harm onic function $Y_{1; 1}()$ is de ned with the quantization axis along the [111] direction. The step function (x) ensures that the sum is taken over states above the Ferm i level. The R_{1s} represents the 1s wave function of M n or G a, and $_{n;k}$ represents the wave function with the band index n, wave-vectork and energy $_{n;k}$. In the actual calculation, we replace (h! $_{n;k}$) by a Lorentzian form (=)=((h! $_{n;k})^2 + ^2$) with = 1 eV, in order to take account of the 1s core hole life-time width. The total absorption coe cient and the XM CD

spectra are de ned by

The XM CD intensity arises from the porbital polarization in the unoccupied states, as is obvious from Eq.(3.3). This quantity can be connected with the orbitalm om ent in the p symmetric states as follows. Let the wave function be expanded in the M T sphere as

where $\gamma_{m}^{n,k}$ (r) represents the wave function projected onto the state with the angular momentum fign g, and spin , and normalized inside the MT sphere. Then the orbital angular momentum in the p symmetric state is expressed as

where the sum is taken over the occupied states. Note that, if the sum is taken over all the states both occupied and unoccupied, one may get n_{jk} ; $(f_{1,1}^{n,k}, f) = 0.0$ n the other hand, the absorption coefficient may be rewritten as

The last factor represents the transition probability from the 1s state to the p symmetric states, which varies little with respect to the energy of the p symmetric states above the Fermi level up to 20 eV (within 10% variation). This is because the p symmetric states are well approximated by the atom ic 4p wave function on the region close to the center of atom s. Replacing the last factor by the value at the Fermi energy (denoted as $\beta_F f$) in Eq.(3.6), we obtain approximately the relation,

W e need to introduce som e upper cuto $!_2$, because the transition probability is replaced by a constant $\beta_F \stackrel{2}{J}$. It may be set by $h!_2 = _F + 20 \ eV$. This sum rule is an extension of the relation previously derived on the basis of the tight-binding m odel for Fe, Co, N im etals^{8,9}.




FIG.2: (a)Totalabsorption coe cient $_0$ (!), and (b)XMCD spectra $_c$ (!) at the MnK edge, as a function of photon energy. The origin of energy corresponds to the excitation to the Ferm i level. The normalized intensities are magnied to 10^3 times. The experimental data are for a powdered sample in the ferror agnetic phase at T = 200 K^{26} . (c)XMCD spectra calculated with turning o the SOI on all the states at G a sites, on the p symmetric states at M n sites, and on the d symmetric states at A n sites is turned o.

Now we discuss the calculated spectra at the M n K edge. Figure 2 (a) and (b) show the total absorption coeffcient $_0$ (!) and the XM CD spectra $_c$ (!) in comparison with the experim ent²⁶. The experimental data are for a pow dered sample under a small magnetic eld H = 0.6 T at 200 K. The sample is in the ferrom agnetic phase

with the magnetization 0:8 B per M n, which value is smaller than the calculated one 1:5 B. The di erence may be ascribed to a temperature e ect, which usually reduces the magnetization. The calculated value of $_{c}(!)$ is divided by the value of $_0$ (!) at h! = $_F$ + 20 eV, while the experim ental XMCD spectra are divided by the value of the total absorption coe cient at the energy about 40 eV higher than the threshold. Both $_0(!)$ and $_c(!)$ are in good agreem ent with the experim ent. For the total absorption coe cient, peaks A and B correspond well with shoulders A' and B' in the experimental curve. For the XMCD spectra, dipsC, D, and peak E correspond well with the experim ental ones C', D', and E'. Only one deviation from the experim ent is that the sm all peak at the Ferm i level is not reproduced. The intensity integrated up to $!_2$ is found negative. This is consistent with the sum rule, Eq.(3.7), because the value of L_p is positive at M n sites.

The XMCD spectra com e from the orbital polarization in the p symmetric states, which may be induced by (i) the spin polarization in the p symmetric states through the SOI, and (ii) the orbital polarization at neighboring sites through hybridization. For making clear the inducing mechanism, we calculate the XMCD spectra at Mn sites with turning o the SOI on several specied states. The top panel among three panels of Fig. 2 (c) shows the XMCD spectra with turning o the SOI on all the states at G a sites. The spectra remain similar except for a slight suppression of peak E, indicating that the orbital polarization at G a sites have little in uence on the XMCD spectra at Mn sites. The middle panel in Fig. 2 (c) shows the XMCD spectra with turning o the SO I only on the p sym m etric states at M n sites. D ip C keeps the sim ilar shape, while dip D alm ost vanishes. This indicates that the porbital polarization corresponding to dip D is induced by the spin polarization in the p symmetric states through the SO I. The bottom panel shows the XMCD spectra with turning o the SOI only on the d symmetric states at Mn sites. The intensity of dip C is drastically reduced, but dip D and peak E remains similar, indicating that the 3d orbital polarization gives rise to dip C.W ithin the MT approximation, the 3d orbital polarization cannot polarize the p orbital in the same M n site, because the p-d C oulom b interaction is spherically averaged inside the MT sphere. Thus we conclude that the 3d orbital polarization at neighboring M n sites induces the p orbital polarization corresponding to dip C through the p-d hybridization.




FIG.3: (a)Total absorption coe cient $_0$ (!), and (b)XMCD spectra $_c$ (!) at the GaK edge, as a function of photon energy. The origin of energy corresponds to the excitation to the Ferm i level. The normalized intensities are magnied to 10^3 times. The experimental data are for a powdered sample in the ferror agnetic phase at T = 200 K²⁷. (c)XMCD spectra calculated with turning o the SOI on the p symmetric states at G a sites, and on the d symmetric states at M n sites, respectively. $_{\rm Ab} = 0$ means that the SOI on the b symmetric states at A sites is turned o.

Next we discuss the XMCD at the Ga K edge. Figure 3(a) and (b) shows the calculated $_0$ (!) and $_c$ (!) in comparison with the experiment²⁷. Both $_0$ (!) and $_c$ (!) are in good agreement with the experiment. For the total absorption coe cient, peaks F and G correspond well with the experimental ones. Also, for the XMCD spectra, dip H, peak I and dip J correspond well with the experimental ones. The intensity integrated up to !₂ is found negative. This is again consistent with the sum rule, because the value of L_p is positive at G a sites.

Form aking clear the mechanism, we also calculate the XMCD spectra at Ga sites with turning o the SOI on several specied states. The top panel in Fig. 3 (c) show s the XMCD spectra with turning o the SOI on the p symmetric states at Ga sites. Peak I and dip J are almost suppressed, indicating that the porbital polarization corresponding to those structures is induced by the spin polarization in the p symmetric states through the SO I. On the other hand, dip H is half suppressed, indicating that the above mechanism works in a small part on dip H. The bottom panel shows the XMCD spectra with turning o the SO I on the d sym m etric states at M n sites. D ip J remains similar, dip H is half suppressed, and peak I is even enhanced. This indicates that the negative values are added to both dip H and peak I due to the coupling to the 3d orbital polarization at neighboring M n sites.




FIG.4: (a)Total absorption coe cient $_0$ (!),and (b)XMCD spectra $_c$ (!) at the MnK edge in Mn₃ZnC, as a function of photon energy. The origin of energy corresponds to the excitation to the Ferm i level. The normalized intensities are m agni ed to 10^3 times. The experimental data are for a pow-dered sample in the fermomagnetic phase at T = 300 K²⁷.

As shown above, the calculation reproduces well the experimental curves. Only the exception is the small positive peak W at the Ferm i level on Mn sites in the XMCD spectra (see Fig. 2). We might take it a smallerror, since the peak is small. However, in case of Mn₃ZnC, the similar positive peak at the Ferm i level becomes large on Mn sites. To gain condence in our calculation, we carry out a similar calculation for Mn₃ZnC, assuming a ferrom agnetic phase. We get S = 1.088, L = 0.019 in the d symmetric states, and S = 0.0003, L = 0.0005in the p symmetric states on Mn site. Figure 4 shows the calculated absorption and XMCD spectra at Mn K edge, in comparison with the experiment at T = 300 K (ferrom agnetic phase). The positive peak at the Ferm i level is clearly reproduced.

IV. CONCLUDING REMARKS

W e have reported an ab initio calculation of the XM CD spectra at the K edges of M n and G a in the ferrom agnetic phase of M n_3 G aC, by taking account of the SO I

in the LDA scheme. The calculated spectra show excellent agreement with the recent experiment. The spectra have explicitly been shown to arise from the porbital polarization, and the mechanism of its induction has been fully analyzed; the associated process is identied for each structure. The present result may serve a guide to analyze the K edge XM CD spectra in other materials. Such usefulness has been demonstrated for the ferrom agnetic N im etal. We have also derived a simple sum rule, which connects the XM CD spectra with the orbital moment, and have con rm ed it works. Judging from the agreement of the calculated spectra with the experiment, we think that the elect of the 1s-core-hole potential in the nal state is negligibly small.




FIG. 5: Calculated XMCD spectra at the K edge in the ferrom agnetic N im etal, as a function of photon energy, which are divided by the total absorption coe cient at $h! = _F + 20 \text{ eV}$ and m agni ed to 10^3 times. The broken and dotted lines are values calculated with turning o the SOI on the p sym m etric states and on the 3d states, respectively.

The present nding is rather general and can be applied to other system s. To demonstrate this, we compare the XMCD spectra in M n₃G aC with those in the ferrom agnetic N i m etal. Figure 5 shows the latter quantity calculated with the same m ethod as above. We divide $_{\rm c}(!)$ by $_{\rm 0}(!_2)$ at h! $_2 = _{\rm F} + 20$ eV. A large dip K appears above the Ferm i level; it is half suppressed if the SO I is turned o either in the p symmetric states or in the 3d states. This behavior is sim ilar to dip C in M n₃G aC, although the contribution of the SO I in the p symmetric states is a little larger in N i. On the other hand, a tiny dip L at high energy disappears without the SO I in the p symmetric states, sim ilar to dip D in M n₃G aC.

F inally we point out that this type of ab initio calculation can be applied to analyzing the magnetic RXS spectra at the K edge in transition-m etal com pounds^{31,32}, and may clarify the p orbital polarization in antiferrom agnetic phases. A coording to our recent calculation of

the magnetic RXS spectra in N iO 33 , the main peak intensity almost disappears when the SO I on the 4p band is turned o . This noting is consistent with the above analysis, because the 4p states are located at 10 eV higher than the Ferm i level.
