# O rientational orders of sm all an isotropic m olecules con ned in slit pores

We have studied phase behavior of hard gaussian overlap molecules with smallanisotropic parameter conned in two plane parallel structureless hard walls. Our investigation based on standard constant-NPT Monte Carlo molecular simulation led us to some interesting notings. For small anisotropic molecules the nematic phase is instable in bulk, while, if the distance between the walls is small enough, an orientation-ordered phase can form. This result indicates that the required molecular elongation forming liquid-crystal phases is smaller in connement than that in bulk. Considering the value of the elongation of molecules, the computed result inplies that small molecule liquid crystals may exist in connement.

I. IN TRODUCTION

There is a great number of molecular simulations in the literature on the properties of liquid crystals. Am ong these simulations, liquid crystalm olecules are described using an isotropic m odels, such as the hard gaussian overlap (HGO) models [1{3], the sim ilar hard spherocylinder [4{6] and the hard spheroidal models [7], and the wider used Gay-Berne (GB) models [8{11]. A lthough the detail results depend on the models used, som e general conculsions have been found: for example it is generally con med that liquid-crystal phases can form only when the anisotropic parameters of these models are greater than som e critical values. O therwise (i.e. for m olecules with small an isotropic parameters), as one increases the pressure or decreases the tem perature, these system swill freeze or crystallize before form ing liquid-crystal phases. M any recent works focus on the m acroscopic properties and phase transitions of models with large anisotropy param eters. For example, based on molecular simulation and statistical theories, global phase diagram s of hard potential models [5,6] and GB models [8] in bulk have been developed.

On the other hand, con nem ent in nanom eter scale is found to induce phase transitions not observed in bulk system s and shifts in phase transitions [12{14]. Recently, G elb et al. [12] system atically review ed research trend on con ned simple uids based on statistical physics, molecular simulations, and carried out som e experim ental investigations. The properties of con ned liquid crystals also attracted wide interests on both sciences and technologies, such as the surface anchoring e ects of liquid crystals [15]. More recently, Gruhn and Schoen [10,16] studied the m icroscopic structure of con ned liquid crystals based on GB m odels. So far, these researches on the bulk and con ned properties of liquid crystals only focus on system s com posed of large anisotropic m olecules which model the usual liquid-crystal molecules. To the best of our know ledge, properties of sm all an isotropic m olecules have shown no interests, probably becuase they

are believed not to form orientation-ordered phases in bulk [17].

But there is a need to address the following question: A reliquid crystal phases in connement stable even in the small-anisotropic-molecule systems? A coording to the knowledge on conned simple uids, although these systems cannot form orientation-ordered phases in bulk, connement induce new phases when these molecules are conned in nanometer-sized pores. The answer to the above question is important not only for the sake of properties of conned uids, but implies the possibility of existing small molecule liquid crystals.

In this paper, we study phase behavior of m olecules con ned between two plane parallel structureless hard walls (i. e. slit pore), we investigate orientation-ordered phases and their transitions on a few kinds of m olecules with di erent anisotropic parameters (m olecular elongation), and show that sm allanisotropicm olecules can form stable orientation-ordered phase (nem etic phase) in con-

nem ent, though in bulk the phase does not exist. Our results indicate that the required m olecular elongation which provoke stable liquid-crystal phase in HGO systems decreases with con ning conditions. Therefore we suspect that small m olecules m ight form liquid crystals in con nem ent. Some related discussions are presented in Sec. IV. Simulation results are shown in Sec. III. W e begin, however, in Sec. II with a description of the HGO m odel and the presentation of our simulations.

### II. POTENTIAL MODEL AND COM PUTATIONAL DETAILS

D ue to a general belief that repulsive interactions are key roles to determ ine liquid cyrstal structures, som e hard nonspherical models  $[1 \{7\}]$  are used to study properties of liquid crystals. Am ong them, one of the most sim – plest models is the HGO model  $[1 \{3,17\}]$ . In the model, interaction between a pair of molecules i and j is given by

where,  $\mathbf{\hat{r}}_{ij} = \mathbf{r}_{ij} = \mathbf{r}_{ij}$  is a unit vector along the line joining the centers-ofm ass of the molecules,  $\hat{u}_i$  and  $\hat{u}_j$  are unit vectors along the principal axes of the molecules, is dependent on the molecular orientation and explicitly given by

Here,  $_0$  is constant, which corresponds to the width of molecules, X is a measure of the nonsphericity of the molecule de ned as  $X = (k^2 \quad 1) = (k^2 + 1)$  with k being the length-to-width ratio of the molecule.

We use the standard constant-pressure (const-NPT) M onte C arlo simulations to obtain the equation of state P () (for hard potential, tem perature T is not present explicitly). The simulations are performed with N = 108or 256 for the molecular elongations k being between 2:0 and 3:0. For k 3:0, a great num ber of simulations have shown that there is isotropic-nem atic phase transition in the bulk [1{3], but fork 2:0, the nem atic phase is instable in bulk up to a typical high density of liquids [17]. In simulations of bulk systems, the simulating box is cubic and equally uctuates in three directions, cubic periodic boundary conditions are used. In con nem ent, the distance between two walls (z direction) is xed, the box equally uctuates only in the two directions (x and y) and uses periodic boundary conditions. The simulations are organized in M C cycles, each M C cycle consisting (on average) of N trial translational and rotational m olecular displacem ents and one trial volum e uctuation. The maximum step length of each trialm ove is automatically chosen at each pressure for making the acceptable probability fall between 0:4 and 0:6. The starting con guration is a foc lattice ( in con nem ent, the num ber of lattic in z direction may be smaller than that in other directions), which melte at low pressure and equilibrate for 100,000 M C cycles. The system is slow ly compressed in small pressure steps. For any given pressure, the system is typically equilibrated for 100,000 MC cycles and an average is taken over 100,000 additional M C cycles, then the nalcon guration is set as the starting con guration of the next pressure. But 300,000 M C cycles are used near the isotropic-nem atic transition. A fter arriving at a high pressure point, in some cases, we slowly expand the system from this high pressure point to a low pressure point. In calculating average values (such as density, orientational order param eter ), we sam ple partial equilibrated con gurations. However, the obtained results (average values and their uctuations) are alm ost the same as that using all equilibrated con gurations.

The orientational order parameter S is calculated in the simulations as the largest eigenvalue of the ordering Q tensor, de ned in terms of the components of the unit vector  $u_i$  along the principal axis of the molecules,

In the simulation of con ned system s, a similar hard potential is set as the interaction between m olecule and walls [10], thus

where  $z_i^{[k]}$  is the distance between center-ofm ass of molecule i and wallk, and w is given by

Here =  $(k^2 \quad 1)=k^2$ . We suppose the walls are at z = 0and z = D, respectively. O fcourse, the center-ofm ass of the molecules must be between two walls.

In the remainder of this paper,  $_0$  is set as unit of length,  $P=k_B\,T$  is noted as P .

#### III. R E SU LT S

We rst simulate the equation of state of HGO systems with k = 3.0 in bulk. For this case, isotropic-nem atic (N) phase transition had been found in previous simulations [1{3]. Based on free energy calculations of isotropic and nem atic phases, the N transition pressure was about 5 for k = 3.0. In this paper, we do not try to determine exactly IN transition point by using these free energy m ethods, but only estim ate the transition from their S P curves.




Fig.1 X. Zhou et al. 108 HGOs with k=3

O ur results are shown in Fig.(1), It is clear, the equations of state exhibit a discontinuity at P 5. In Fig. (1) (b), the behavior of the orientation order parameter S shows that a spontaneous IN phase transition occurs at the discontinuous point. The result in increasing and decreasing pressure (com pressing and expanding sim ulations) are sim ilar to each other and in agreement with previous sim ulations.




FIG.2. Equation of state P () of a HGO system in slit pores is shown. Here, N = 256, and k = 3.D is the width of the used slit pore in our M onte C arlo simulations.




Fig.3 X. Zhou et al. 256 HGOs with k=3 confined in slit pores

To test the e ects of con nem ent, we study the conned HGO system s with k = 3:0 in di erent D, the obtained results are shown in Fig.(2) and Fig.(3). This leads to our rst interesting result: the IN transition point shift to lower pressure (i. e. density) direction as the distance between two walls D decreases. U sually, for sm all anisotropic m olecules, the nem atic phase is instable, the reason can be understood. The system will freeze or crystallize before form ing liquid-crystal phase while increasing the pressure or decreasing the tem perature. So the shift at low pressure indicates that nem atic phase form in con nem ent easiler than in bulk. Therefore, we suspect the required smallest k form ing nem atic phase is smaller in con nem ent than that in bulk. In Fig.(4) and Fig.(5), we show the equation of state of smaller anisotropic molecules (k = 2.0). Up to a typical high density of liquid (packing fraction y is about 0.5), nem atic phase is not found in bulk. Here  $y = v_m$ , where

is density of the liquid,  $v_m = -6k_0^3$  is the volume of the molecule. The result is in agreement with previous simulations [17]. However, we do not nd stable nem atic phase in the system in con nem ent (the distance D between walls is 3:5 and 4:0). Consider that k = 2:0 maybe too small, we simulate another system with a little larger elongation (k = 22) and con ned in a thiner pore (D = 2:5), the results are shown in Fig.(6) and Fig.(7). The system is compressed up to a typical high density ( y = 0.57), no phase transition is found in bulk. But for the con ned system in slit pore with a part of D = 2.5, an obvious IN phase transition is found. In principle, to strictly determ ine the existence of liquid-crystal phase in bulk and in con nem ent, we should use free energy m ethods to calculate the global phase diagram of the system including calculations of chem ical potetials in isotropic phase, orientation order phase and crystallized phase, respectively. However, in this paper, we use a rougher method used by earlier Rigby [17]: compress the system to a typical high density (y is about 0:5), if there is no nem atic phase in the density zone, the nem atic phase does not exist, since in higher density zone, uids usually freeze or crystalize. The result is a rough approximation, but we still can obtain a general qualitative conclusion: con nem ent will decrease the required m olecular elongation k to form a nem atic phase. W e believe that a nematic phase exists for a certain k in systems in suitable con nem ent, though the nem atic phase of the system s is instable in bulk. Of course, it is important to obtain quantitative results on this e ect, and we shall study globalphase diagram s ofm ore realistic sm all-anisotropic molecules in con nem ent.

### IV . C O N C LU S IO N

From the ongoing investigation, we can state that orientation ordered phase exists in bulk for som e values of the molecular elongation k above a critical value  $k_c$ ; for sm aller value of k, the ordered phase becomes instable, but as these sm all k molecules are conned in very thin pores, the orientation ordered phase can be found. This result con rms our expectation that sm all-anisotropic molecules form liquid crystals in connement.

U sually, the elongation of liquid crystal molecules is about 4 5 and k of nonspheric inorganic molecules, such as  $CO_2$ ,  $CS_2$  etc., are only about 2. Hence, the usual smallmolecules cannot form liquid-crystal phases in bulk. But in con nement, according to our results, the required k form ing liquid crystals will decrease, so it is interesting to study whether or not som e smallmolecules will form

liquid crystal phase in special con nem ent. Due to the wide interests in smallm olecule liquid crystals, it may be important to study phase behavior of real con ned sm all m olecules. On the other hand, com plicated geom etrical pores m ay induce m ore com plex behavior in uids [12]. Recently, Chiccoli et al. studied the properties of liquid crystals with dispersed polymer brils [18], where the polym er brils form ed networks and served as com plicate pores to con ne liquid crystals. Considering the required sizes of pores to induce possible liquid crystal phases in sm allm olecules m ay be very sm all (in m olecule scale), we shall study the e ects of con nem ent in sm all an isotropic m olecules with dispersed large anisotropic m olecules. In the mixture, large anisotropic molecules may serve as complex pores to con ne small molecules and induce possible orientation-ordered phases, which m ight induce characteristic of sm all-m olecule liquid crystals.

Fig.4, X. Zhou et al, N=256, and k=2.0




FIG.4. Equations of state P () of a HGO system in bulk and in con nem ent are shown. Here N = 256 and k = 2. The density of the system is increased to a typical high density of liquids from zero.

## Fig. 5, X. Zhou et al. Confined HGOs with k=2.0, D=4.0




FIG.5. Equations of state P () of systems are shown. Here N = 256 and 108. k = 2 and D = 4.0. Our result indicates no obvious sized e ects in our simulations of con ned systems.

Fig. 6, X. Zhou et al. N=108, k=2.2




FIG.6. Equations of state P () in a system in bulk and in con nem ent are shown, respectively. Here, N = 108 and k = 2.2. The densities of the system are increased to a typical high density from zero. In a thin slit pore (D = 2.5), the equation of state exhibits a discontinity.
