Full counting statistics of incoherent Andreev transport

A b stract. { We study the full counting statistics of heterostructures consisting of normal metal parts connected to a superconducting term inal. A ssum ing that coherent superconducting correlations are suppressed in the normal metals we show, using Keldysh-Nambu Green's function, that the system can be mapped onto a purely normal system with twice the number of elements. For a superconducting beam splitter with several normal term inals we obtain general results for the counting statistics.

Introduction. { A complete statistical description of a transport process can be obtained from the full counting statistics (FCS) [1]. The FCS of charge transport in mesoscopic conductors has recently attracted a bt of attention [2]. It was shown that scattering between uncorrelated Ferm i leads is described by binom ial statistics [1,3], in which charge is transfered in elementary units. Subsequently, the FCS in normal-superconducting systems have been studied and it was shown that Andreev rejection leads to a doubled charge transfer [4{6]. Later on, several approaches to FCS have been put forward. A theory of full counting statistics based on Keldysh-Green's function was developed [7]. This formulation allows a straightforward generalization to superconductors [8,9], multi-terminal structures [10] and Coulomb blockade systems [11]. As another example, the FCS of charge transport was expressed via the counting statistics [12] of photons emitted from the conductor. Very recently, a classical path-integral approach to FCS was developed [13].

The second moment of the FCS is related to the shot noise [14]. Suppression of the shot noise from the classical Poisson value can result from the Ferm i statistics of the electrons [15{17}]. Particularly interesting are the correlations between currents at dierent term in als { the cross correlations. For uncorrelated Ferm i leads they are in general negative [17,18], which has been experimentally con med [19{21}]. If the current is injected from a superconducting term in al, the sign of the cross-correlations may become positive [22{27}]. If the proximity e ect is absent both negative cross correlations [6,28] and positive cross correlations [29] were theoretically predicted.

The positive correlations are a direct consequences of the charge being transfered in pairs across the normal-superconducting interface [4,26,27,30]. This is the case, independent of the presence or absence of the proximity e ect in the normal metal. Since the proximity e ect introduces additional pair correlations, it is of special interest to investigate, under general circum stances, the charge transfer in normal-superconducting systems with suppressed proximity e ect.

C incuit Theory of Incoherent Andreev Transport. { All transport properties of quasiclassical superconductor-norm alm etal heterostructures can be calculated from the so-called circuit theory [7,10,31{33}]. This theory is a discretization of the norm alm etal parts into connectors and nodes. The mesh has to be chosen in a way that approximates the real structure to the required precision. To each node (label i) a matrix G reen's function G_i is ascribed. A matrix current I_{ij} ows through the connector between nodes i and j. Conservation of the matrix current on each node $I_{ij} I_{ij} = I_{i$

Electrons and holes (connected by Andreev rejection at the superconducting term in als) propagate through the structure. In the circuit theory the decoherence due to the inite energy difference 2E between electron and hole is described by a decoherence term in ald, which is connected to the respective node [32]. The matrix current from the node into the decoherence term in alhas the form $I_{id} = i(\vec{e} = h) (E =)[z; G_i]$, where is the spacing. Alternatively the coherence is suppressed by a magnetic ux penetrating the node. The corresponding matrix current reads $I_i = \vec{e} (e = 0)^2 = zG_i = z; G_i$. Here $e_i = 0$ denotes the third Pauli matrix in the Nambu matrix space and $e_i = 0$ is the ux quantum.

The full matrix current conservation on node ithen takes the from

If we assume that the relevant energies are large in comparison to the mean level spacing multiplied by the dimensionless conductances of the connectors to the node (or if the magnetic eld is large), allo -diagonal elements of G_i in the Nambu space are suppressed. To show this, we choose a representation of the Green's functions, in which the electron—and hole-Keldysh Green's functions are block-diagonal. For example, a normal terminal (labeled) has the form

Here electron (hole) Green's function are still matrices in Keldysh space, de ned as

with $f^{e(h)}$ (E) = (1 + exp[(E eV)= k_B T]) ¹. The G reen's function of the node i is




Fig. 1 { Mapping of a beam splitter circuit. a) A number of normal term inal (here: three) is connected to one node. The node is connected to a superconducting term inal by a contact with transm ission eigenvalues fT_n g. Strong decoherence of electrons and holes is accounted for by a decoherence term inal connected to the node. This allows to map the circuit on the structure depicted in b). All normal parts of the structure a) are doubled and the superconducting term inal connects these two circuits. The connector between electron and hole circuit has transm ission eigenvalues fR_n^A g, where $R_n^A = T_n^2 = (2 - T_n)^2$ is the Andreev rejection probability corresponding to the transm ission eigenvalues of the original circuit a).

Thus, if the decoherence current dom inates over all other currents, the matrix current conservation equation Eq. (1) becomes $I_i^{\text{dec}} = 0$ and the o-diagonal components of G_i vanish, i.e. G_i becomes block-diagonal.

The connection between two nodes is described in general by a matrix current

where fT_ng is the ensemble of transmission eigenvalues. The matrix current between two nodes with block-diagonal Green's functions is also block diagonal. Each block has again the form (6). Thus, in the whole circuit (except at the superconducting terminals) the electron and hole blocks decouple.

At energies well below the superconducting gap, a superconducting term in a lat zero chem - ical potential has the G reen's function

The matrix current to the superconducting term in all has the form (6), where the Green's function on the normal side has a block-diagonal form. Then, the block-diagonal components of the current can be rewritten, after some algebra, as

Here we introduced the Andreev re ection probabilities $R_n^A = T_n^2 = (2 - T_n)^2$. Thus, the superconductor matrix current constitutes a (2 - 2)-matrix current between electron and hole G reen's functions of the node. Note, that the 'transmission probabilities' are given by the Andreev re-ection probabilities. We conclude, that the transmission properties between electron and hole blocks (mirrored at the superconductor) have exactly the form of a normal contact with the usual transmission probabilities T_n replaced by R_n^A .

W ith this result, we are ready to present the mapping rules [34], illustrated in Fig. 1:

1. All norm alelem ents, norm alterm in als and all connectors between norm alparts of the circuit are doubled (electron and hole circuit).

- 2. The superconducting term in als are the only connections between electron and hole circuit. They play the role of normal connectors, in which the normal transmission eigenvalues T_n are replaced by the Andreev rejection probabilities $R_n^A = T_n^2 = (2 T_n)^2$.
- 3. A counting eld e(h) = 0 is assigned to corresponding electron and hole term in als.
- 4. The counting statistics is obtained from the solution of the normal circuit.

An important general property of the extended circuit is electron-hole sym m etry. In our case this is form ally a consequence of the perfect sym m etry of the extended circuit. M athem atically the sym m etry relation reads

Below we will use this sym metry relation to obtain some general properties of beam splitters. We can draw a general conclusion about the parity of the transferred charge number through the superconductor. Due to the Andreev process this number should be even. Since we have replaced the superconducting circuit by a purely normal on, the even parity is not obvious anymore. However, for a two term inal device the FCS is 2—periodic in the dierence between the counting elds $_{\rm e}$ $_{\rm h}$, which, according to our rules, should be replaced by 2. Thus, the CGF is now a—periodic function of . This argument can be generalized to an arbitrary number of term inals, if we are interested only in the charge transfer through the superconductor. The total transfered charge is obtained by taking all counting elds equal. A gain the CGF depends only on dierences between counting elds and, therefore, charge transfers between two electron (or hole) term inals are not counted. With the same argument as given above, it follows that the total CGF is invariant under a shift of all counting elds by .

Counting statistics of two-term inal devices. { As a check, we rst apply the mapping rules to a simple two-term inal contact without internal structure. The results for the cumulant generating function (CGF) of a normal contact with transmission eigenvalues fT_ng is [1] $(k_BT=0)$

where we have introduced the number of attempts per channel M = 2eV t_0 =h. Using the recipe outlined above we replace T_n by R_n^A and $_1$ $_2$ by 2 and nd

which is the result rst obtained in Ref. [4].

The counting statistics of a di usive w ire between a norm aland a superconducting term in al can also be found analytically. Let us write the CGF of a norm aldi usive conductor with conductance g_N as [7,33,35]

Now, according to the mapping rules, we have to replace the dissive connector by two dissive wires in series. We can neglect the interface resistance and use that the CGF for a series of two dissive conductors is the same as for a single dissive conductor. The total conductance is halved and we thus and

This result proves that the FCS of the di usive SN-wire in the incoherent regime is the same as in the coherent regime [33], which has so far only been demonstrated for the rst two moments [5,6,9].

As another example we consider a chaotic dot, which is much stronger coupled to the superconductor than to the normal term inal. In this case, the connector between the electronand hole node does not contribute to the FCS (the G reen's functions in the electron and the hole dots are the same). We can then consider the equivalent circuit with a single dot, symmetrically coupled to the electron and hole term inals. The G reen's functions of electron and hole term inal are (for £ j< eV and $k_B T = 0$)

For a moment we take independent counting elds in the electron and hole term in al, and replace $_{e(h)}$! only in the end. The solution for the central node is

At this stage we can safely take the $\lim_{e(h)} =$ and obtain

which ensures the -periodicity of the CGF.

We now turn to the general case of the counting statistics of a beam splitter as depicted in Fig.1. The central node is connected to several normal terminals (labeled with) and one superconducting terminal. This structure has been studied in dierent $\lim_{n \to \infty} R_n^A$ governs the coupling between the electron and hole circuit.

Counting statistics of a beam splitter { weakly coupled superconductor. { We assume here that the superconductor is only weakly coupled to the beam splitter in the sense that $g_A = g = (2e^2 = h) - T_n$ is the conductance of the connector to term in al. All normal term in als are held at the same potential V and zero temperature. Expanding all quantities to rst order in $g_A = g$, we nd (similar to Ref. [29]) that the total CGF can be expressed by the CGF of the superconducting contact alone:

Here \hat{G}_{c}^{e0} is the electron G reen's function of the central node in the absence of the superconductor (for $g_{A}=0$). All G reen's functions are evaluated at E < V and we used Eq. (9) to express S in terms of \hat{G}_{c}^{e0} only. The G reen's function \hat{G}_{c}^{e0} can be obtained quite generally. Due to the triangular shape of all \hat{G}^{e} (see Eq. (14)), also \hat{G}_{c}^{e0} has the same form. The matrix current between the central node and term in al then becomes $\hat{\Gamma}=\frac{q}{2}$ (\hat{G}_{c}^{e0} ; \hat{G}^{e}). Thus, all normal connectors behave as tunnel contacts. The solution for the central node is [26]

Such a CGF leads to a FCS of the form

where $Q = {P \choose N}$ =2 is the number of transferred Cooper pairs. The total probability distribution is therefore the probability P_C (2Q) that Q Cooper pairs are transferred, and then distributed among the normal term in alswith respective probabilities p. A similar result has previously been obtained for tunnel contacts [26] and a chaotic cavity [29]. Here, this derivation holds for any type of connector, i. e. point contacts, discipled transparency, etc.

We note that if the beam splitter is connected to the superconductor by another connector (incoherent!), the solution is again given by Eq. (20). This is the case since the additional node, connected directly to the superconductor, has the same G reen's function as the central beam splitter node, \hat{G}_c^{e0} , to leading order in $g_A = g$, i. e. with the superconductor completely decoupled.

Counting statistics of a beam splitters { strongly coupled superconductor. { A nother important case is when the superconductor is strongly coupled to the beam splitter, i. e. g_A g . In this lim it the superconducting connector is absent and the system is a chaotic dot coupled to the electron and hole term in als. We consider here the case, in which the norm alterm in als are coupled by tunnel contacts. The solution for the central node is then [26]

The CGF follows straightforwardly,

In the present form the -periodicity is evident. However, calculating explicitly the cumulants by taking successive derivatives of S (f g) with respect to , we cap equally well take the square-root in Eq. (23), giving S (f g) = M g [exp (i) 1] = S (). From this form of S, no longer evidently pi-periodic, it follows, interestingly, that all cross correlators vanish.

Conclusions. { We have studied the full counting statistics of normal metal-superconductor heterostructures in the incoherent regime. The original circuit with one superconducting terminal can be mapped on a purely normal circuit consisting of an electron and a hole block. The superconductor plays the role of a normal connector between the electron and the hole block, with the usual transmission probabilities $fT_n g$ replaced by the Andreev rejection probabilities $fR_n^A = T_n^2 = (2 - T_n)^2 g$. We have illustrated our approach with several examples.
