Charge transport in underdoped bilayer cuprates

W ithin the t-J m odel, we study the charge transport in underdoped bilayer cuprates by considering the bilayer interaction. A lthough the bilayer interaction leads to the band splitting in the electronic structure, the qualitative behavior of the charge transport is the sam e as in the case of single layer cuprates. The conductivity spectrum shows a low energy peak and the unusual midinfrared band. This midinfrared band is suppressed severely with increasing temperatures, while the resistivity in the heavily underdoped regime is characterized by a crossover from the high temperature metalliclike to the low temperature insulating-like behaviors, which are consistent with the experiments.

It has become clear in the past ten years that cuprate superconductors are among the most complex systems studied in condensed matter physics^{1;2}. The complications arise mainly from (1) strong anisotropy in the properties parallel and perpendicular to the CuO₂ planes which are the key structural elem ent in the whole cuprate superconductors, and (2) extrem e sensitivity of the properties to the compositions (stoichiom etry) which control the carrier density in the CuO₂ plane, and therefore the regim es have been classi ed into the underdoped, optim ally doped, and overdoped, respectively^{1;2}. In the underdoped and optim ally doped regim es, the experim ental results³ show that the ratio of the c-axis and in-plane resistivities $R = _{c}(T) = _{ab}(T)$ ranges from R 100 to $R > 10^5$, which re ects that the charged carriers are tightly con ned to the CuO₂ planes. This large magnitude of the resistivity an isotropy also leads to the general notion that the physics of doped cuprates is alm ost entirely two-dimensional, and can be well described by a single C uO $_2$ plane⁴. How ever, this picture seem s to be incom patible with the fact that the superconducting transition tem perature T_c is closely related to the num ber of CuO₂ planes per unit cell, with single layer com pounds of a fam ily generically having lower T_c than bilayer or trilayer com pounds². Additionally, there are som e subtle di erences of the magnetic behaviors between doped single layer and bilayer cuprates. By virtue of system atic studies using NMR and SR techniques, particularly the inelastic neutron scattering, only incommensurate neutron scattering peaks for the single layer lanthanum cuprate are observed in the underdoped regim e^{5} , how ever, both low -energy incom m ensurate neutron scattering peaks and high-energy commensurate [,] resonance for the bilayer yttrium cuprate in the norm alstate are detected⁶. These experimental results highlight the importance of some sort of coupling between the CuO₂ planes within a unit cell. It is believed that all these experiments produce interesting data that introduce the important constraints on them icroscopicm odels and theories.

The charge transport of doped single layer cuprates has been addressed from several theoretical view points^{7;8}. Based on the charge-spin separation, an attractive proposal is spinons and holons as basic low-energy excitations, serving as the starting point for the gauge-theory approach⁷. It has been show n^7 within the t-J m odel that above the Bose-E instein tem perature, the boson inverse lifetime due to scattering by the gauge eld is of order T, which suppresses the condensation temperature and leads to a linear T resistivity. On the other hand, the spin-ferm ion m odel near the antiferrom agnetic instability has been developed to study the norm al-state properties of doped cuprates⁸. This spin-ferm ion model describes low -energy ferm ions interacting with their own collective spin uctuations. Within this approach⁸, the anom alous transport of doped single layer cuprates has been studied extensively⁸, and the results are consistent with the experim ents.

As regards an intracell hopping, the band splitting in doped bilayer cuprates was shown by the band calculation⁹, and clearly observed^{10;11} recently by the angle-resolved-photoem ission spectroscopy in the doped bilayer cuprate B $\frac{1}{2}$ Sr₂C aC u₂O₈₊ above T_c. This bilayer band splitting is due to a nonvanishing intracell coupling. M oreover, the magnitude of the bilayer splitting is constant over a large range of dopings¹¹. Considering these

highly unusual norm alstate properties in the underdoped regim e^{1;2;5;6}, a natural question is what is the e ect of the intracell coupling on the norm al state properties of doped bilayer cuprates. This is a challenge issue since the mechanism for the superconductivity in doped cuprates has been widely recognized to be closely related with the anisotropic norm al-state properties¹². Based on the t-J model, the charge transport and spin response of doped single layer cuprates in the underdoped regim e have been discussed $^{13 \{15\}}$ within the ferm ion-spin theory 16 , and the obtained results are consistent with experiments¹⁷. In this paper, we apply this successful approach to study the charge transport of the underdoped bilayer cuprates. Our results show that although the bilayer interaction leads to the band splitting in the electronic structure, the qualitative behavior of the conductivity and resistivity is the same as in the single layer case. The conductivity shows the non-D rude behavior at low energies and anom alous m idin frared band separated by the chargetransfer gap, while the tem perature dependent resistivity in the heavily underdoped regime is characterized by a crossover from the high tem perature m etallic-like to the low tem perature insulating-like behaviors.

W e start from the bilayer t-J model, which can be written as,

The bilayer t-J model (1) is de ned in the subspace with no doubly occupied sites, 1. The strong electron correla-C^y_{ai} C_{ai} i.e., tion in the t-J m odel m an ifests itself by this single occupancy on-site local constraint⁴. To deal with the local constraint in analytical calculations, the ferm ion-spin theory¹⁶, $C_{ai^{"}} = h_{ai}^{y}S_{ai}$ and $C_{ai^{\#}} = h_{ai}^{y}S_{ai}^{+}$, has been proposed, where the spinless ferm ion operator hai keeps track of the charge (holon), while the pseudospin operator Sai keeps track of the spin (spinon), then it naturally incorporates the physics of the charge-spin separation. In this case, the low-energy behavior of the bilayer t-J model (1) in the ferm ion-spin representation can be rew ritten as,

Since the single occupancy local constraint has been treated properly within the ferm ion-spin theory, this leads to disappearing of the extra gauge degree of freedom related with this local constraint under the charge-spin separation¹⁶. In this case, the charge uctuation couples only to holons^{13;14}. However, the strong correlation between holons and spinons is still included self-consistently through the spinon's order param eters entering the holon's propagator, therefore both holons and spinons are responsible for the charge transport. where R_{1i} (R_{2i}) is lattice site of the CuO₂ plane 1 (plane 2), = $hS_{ai}^{+}S_{ai+}$ i and $P_{i+} = hS_{1i}^{+}S_{2i}$ i are the spinon correlation functions, and e is the electronic charge, which is set as the unit hereafter. The holon currentcurrent correlation function can be calculated in terms of the holon G reen's function g(k;!) as in the single layer case^{13;14}. However, in the bilayer system, because there are two coupled CuO $_2$ planes, then the energy spectrum has two branches.




FIG.1. The conductivity at = 0.05 (solid line), = 0.06 (dashed line), and = 0.07 (dotted line) for t=J = 2.5, t₂ =t = 0.25, and J₂ =J = 0.25 in the zero tem perature. Inset: the experimental result on the underdoped YBa₂Cu₃O_{7 x} taken from Ref.¹⁹.

The frequency-and tem perature-dependent conductivity is a powerful probe for system s of interacting electrons, and provides very detailed inform ations of the excitations, which interacts with carriers in the norm al-state and might play an important role in the superconductivity. In Fig. 1, we present the results of the conductivity (!) at doping = 0.05 (solid line), = 0:06 (dashed line), and = 0.07 (dotted line) for parameters $t=J = 2:5, t_2 = t = 0:25, J_2 = J = 0:25$ with temperature T = 0 in comparison with the experimental data¹⁹ taken on the underdoped YB a_2 C u_3 O $_7$ x (YBCO) (inset). The conductivity of bilayer cuprates in the underdoped regime shows a sharp low energy peak at ! < 0.5 t and the unusual midinfrared band appearing inside the chargetransfer gap of the undoped system . A fter an analysis, we found that this low-energy peak decays fastly as




FIG.2. The conductivity at = 0.06 for t=J = 2.5, t₂ =t = 0.25, and J₂ =J = 0.25 in T = 0 (solid line), T = 0.3J (dashed line), and T = 0.5J (dotted line). Inset: the experim ental result on the underdoped YBa₂Cu₃O_{7 x} taken from R ef.¹⁹.

(!) 1=! (non-D rude fall-o) with increasing energies. M oreover, the weight of the m idinfrared peak is doping dependent, and the peak position is shifted to low energy with increasing dopings. For a better understanding of the optical properties of doped bilayer cuprates, we have studied conductivity at di erent tem peratures, and the results at doping = 0.06 for t=J = 2.5, t =t = 0.25, and $J_2 = J = 0.25$ in T = 0 (solid line), T = 0.3J (dashed line), and T = 0.5J (dotted line) are plotted in Fig. 2 in comparison with the experimental data¹⁹ taken on the underdoped YBCO (inset). It is shown that (!) is tem perature dependent, and the charge-transfer gap is severely suppressed with increasing tem peratures, and vanishes at higher tem perature (T > 0:4J). Our results are in qualitative agreem ent with the experim ents¹⁹. In comparison with the results from Refs.^{13,14}, it is shown that the present conductivity also is qualitatively consistent with these in the single layer case. In the above calculations, we also nd that the conductivity (!) is essentially determ ined by its longitudinal part [(L) (!), this is why in the present doped bilayer cuprates the conductivity spectrum appears to re ect the single layer nature of the electronic state^{1;2;13;14}. This is also why the inplane charge dynam ics is rather universal within whole doped cuprates1;2.




FIG.3. The resistivity at = 0.05 (solid line), = 0.06 (dashed line), and = 0.07 (dotted line) for t=J = 2.5, $t_2 = t = 0.25$, and $J_2 = J = 0.25$. Inset: the experimental result on the underdoped YBa₂Cu₃O₇ x taken from Ref.²⁰.

Now we turn to discuss the resistivity, which is closely related to the conductivity, and can be obtained as $(T) = 1 = \lim_{n \neq 1} (!)$. This resistivity has been calculated, and the results at doping = 0.05 (solid line), = 0.06 (dashed line), and = 0:07 (dotted line) for $t=J = 2.5, t_2 = t = 0.25, and J_2 = J = 0.25 are plotted$ in Fig. 3 in comparison with the experimental results²⁰ taken on the underdoped YBCO (inset). These results show that in the heavily underdoped regime, although the tem perature-dependent resistivity is characterized by a crossover from the high temperature metallic-like to the low tem perature insulating-like behaviors, the nearly temperature liner dependence in the resistivity dom inates over a wide tem perature range, in agreem ent with the experimental results²⁰. In comparison with the re-

sults from Refs.^{13;14}, it is shown that the present resistivity also is qualitatively consistent with these in the single layer case. We emphasize that since the order parameters, decoupling parameter , and the chemical potential have been determined self-consistently, then these theoretical results were obtained without any adjustable parameters. Furthermore, it is found in the above discussions that the present results are insensitive to the reasonable values of t=J, t₂ =t, and J₂ =J as in the single layer case^{13;14}.

An explanation for the metal-to-insulating crossover in the resistivity in the heavily underdoped regime can be found from the competition between the kinetic energy and magnetic energy in the system. Since cuprate superconducting materials are doped M ott insulators, obtained by chemically adding charge carriers to a strongly correlated antiferrom agnetic insulating state, therefore doped cuprates are characterized by the competition between the kinetic energy (t) and magnetic energy (J).

The magnetic energy J favors the magnetic order for spins, while the kinetic energy t favors delocalization of holes and tends to destroy the magnetic order. In the present ferm ion-spin theory, although both holons and spinons contribute to the charge transport, the scattering of holons dom inates the charge transport¹³, where the charged holon scattering rate is obtained from the full holon G reen's function (then the holon self-energy (5) and holon spectral function) by considering the holonspinon interaction, therefore in the heavily underdoped regime the observed crossover from the high temperature m etallic-like to the low temperature insulating-like behaviors in the resistivity is closely related with this com petition. In lower tem peratures, the holon kinetic energy is much smaller than the magnetic energy, in this case the magnetic uctuation is strong enough to severely reduce the charged holon scattering and thus is responsible for the insulating-like behavior in the resistivity. With increasing tem peratures, the holon kinetic energy is increased, while the spinon magnetic energy is decreased. In the region where the holon kinetic energy is much larger than the spinon magnetic energy at higher tem peratures, the charged holon scattering would give rise to the tem perature linear resistivity.

In sum m ary, we have studied the charge transport in the underdoped bilayer cuprates by considering the bilayer interaction. It is shown that although the bilayer interaction leads to the band splitting in the electronic structure, the qualitative behavior of the charge transport is the same as in the single layer case. The conductivity spectrum shows a low-energy peak and the anom alous m idinfrared band. This m idinfrared band is suppressed severely with increasing tem peratures, while the resistivity exhibits a crossover from the high tem perature m etallic-like to the low tem perature insulating-like behaviors. Our results also show that the m echanism that cause this unusual charge transport in the underdoped cuprates is closely related to the background antiferrom agnetic correlations.
