Inelastic light scattering and the excited states of many-electron quantum dots

A consistent calculation of resonant inelastic (R am an) scattering amplitudes for relatively large quantum dots, which takes account of valence-band mixing, discrete character of the spectrum in interm ediate and nalstates, and interference e ects, is presented. R am an peaks in charge and spin channels are compared with multipole strengths and with the density of energy levels in nalstates. A qualitative comparison with the available experim ental results is given.

The inelastic (R am an) scattering of light by a sem iconductor quantum dot is an optical process which has proven to be very useful as a experim ental technique to study excited states.^{1,2} The interpretation of a resonant R am an experim ent requires, how ever, a big experim ental and theoretical e ort. The theoretical description is often so complicated that consistent calculations have been carried out only for the sm allest dots.^{3,4}

In the present paper, we address the question about resonant R am an scattering in a relatively large quantum dot, aim ed at reproducing the m ain features of the R am an phenom enology by m eans of a transparent and consistent com putational schem e. Particularly, we focus on topics such as the character (single-particle or collective) of the R am an peaks, the role of interference e ects, R am an peaks for spin-excited nal states, the modi cations of the spectrum as the background electron density is changed , or the evolution of the spectrum as the incident laser energy m oves from close to the e ective band gap to wellabove it. R esults of calculations are presented for G aA s dots with A IG aA s barriers. A qualitative com – parison with the available experimental results is also given.

0 ur starting point is the perturbation-theory expression

for the am plitude of R am an scattering.⁵ The kets jii and jfi are written as: $jii = j_iiN_ii$, $jfi = j_fiN_i$ 1;1_fi, where j_ii , and j_fi are initial and nal N -electron states, N_ii is a state with N_i photons of frequency i, and N_i 1;1_fi is a state with N_i 1 photons of frequency $_i$ and one photon of frequency $_f$. On the other hand, the interm ediate states are written as: jinti = $j_{int}iN_i$ 1; where $j_{int}i$ contains, besides the initial N electron, an additional electron-hole pair.

 H_{e} r is the electron-radiation interaction ham iltonian, and int = 0.5 meV { a phenom enological broadening.

Eq. (1) shows the di culties in computing A_{fi} for a dot containing dozens of electrons. One should construct approximations to j_f i in a 30 m eV excitation energy interval, in which there could be hundreds of states, and approximations to j_{int} i in a 30 m eV energy interval above the band gap. In the latter situation, hole-band mixing should be taken into account in order to describe scattering to spin-excited nal states. Notice that interference e ects may come out from the sum over interm ediate states. The 30 m eV upper bound in nal states is a typical threshold for phonon excitations.

Commonly, one avoids computing the intermediate states by approximating the whole expression for A_{fi}. In Ref. [6], for example, Ram an intensities are almost identi ed with strength functions (modulated multipole strengths), in accordance to the interpretation given by authors of paper [2] of their results. This approxim ation to A fi neglects contributions from single-particle nal states and interference e ects from interm ediate states. It is supposed to be valid for laser energies well above the e ective band gap. A second com m on approxim ation to A_{fi}, which also neglects interference e ects, is the socalled extrem e resonance condition, in which h i is very close to the band gap. In this case, R am an intensities are alm ost identi ed with excited-state lum inescence peaks, i.e. with the peaks in the density of nal-state energy levels. This interpretation was used by the authors of Ref. [1].

In our calculations, we start from the exact quantum – m echanical expression (1), and construct R andom –P hase approximations to j_{fi} , and Tamm–D anko approximations to j_{int} .⁷ Explicit form ulae, which should be particularised to the pure electronic system, may be found in [8]. As the number of electrons in the dot is supposed to be relatively high, we expect that the insertion of the mean eld functions j_{int} i and j_f i into (1) would lead to a qualitatively correct picture for the positions and in–

tensities of R am an peaks. The H artree-Fock (HF) basis is used throughout. For holes, the HF equations include the electron m ean eld and the heavy-light hole m ixing, treated by m eans of the K ohn-Luttinger ham iltonian. A typical calculation in a 42-electron dot involves around 60 m any-particle nal states (for a given multipolarity and spin), and around 2000 interm ediate states.




FIG.1: (a) R am an spectra for charge monopole nal states at di erent frequencies of the incident light. In the present and next gures, h_i is given in meV.A vertical line indicates the position of the collective state. (b) R am an intensities of one SPE and the collective state as functions of h_i. The contribution of each interm ediate state at resonance to the intensity of the SPE is also shown.

We rst consider the extreme resonance condition, in which the incident laser energy is very close the elective band gap. In Fig. 1(a), the calculated R am an intensities (squared am plitudes sm eared out by means of Lorentzians of width $_{\rm f} = 0.5$ meV) for charge monopolar nal states are shown. The dot is assumed to have a disk geometry with a 25 nm width. The lateral con nement is parabolic, with ~!_0 = 6 meV, reproducing the observed position of the K ohn mode in the dots studied in Ref. [2]. The magnetic eld, equal to 1 Tesla, is perpendicular to the dot plane. The nal states considered in Fig. 1 have the sam e spin and angularm om entum projection onto the magnetic eld axis as the initial state values. The nom inalband gap is taken as 1560 m eV. This gap is renorm alized by C oulom b interactions to, approxin ately, 1567 m eV.R am an am plitudes are computed in backscattering geometry. The initial and nal light polarization vectors are parallel. The laser energy is swept from 1562 to 1590 m eV, that is from below the e ective band gap to 20 m eV above it. The position of the collective m onopolar state, which carries m ore than 99 % of the energy-weighted sum rule, is signalized by a vertical line. In all of our calculations, the incident (and scattered) light form an angle of 30 degrees with the dot norm al, which means that the maximum transferred mo- 10^5 cm⁻¹. Under these mentum of light is q_x 0**:**8 circum stances, R am an spectra are dom inated by the low est multipolar nal states².

Let us notice that the collective monopolar state is seen as a distinct peak at any laser frequency. However, to nal states carrying an almost zero fraction of the sum rule, for which reason we will call them single-particle excitations (SPE), are associated stronger, and wider, R am an peaks at energies below and above the collective state.

Figure 1 (b) shows the R am an e ciency of two particular nal states, that is their R am an intensities as a function of h_i. In general, the intensity of a given R am an peak in Fig. 1 (a) is the result of three factors: (1) the number of nal states contributing to it, (2) the R am an e ciencies of these states, and (3) interference e ects.

Raman intensities corresponding to the collective monopolar state and to a SPE with Ram an shift of 8.8 meV are shown in Fig. 1(b). The rst interesting remark, in qualitative accordance with the existing observations, is that SPE are enhanced when h_{i} is close to the band gap, whereas collective states are enhanced as h_i is raised. On the other hand, the contribution of each particular intermediate state at resonance, i.e. ff_{e} , f_{e} , of the SPE is also included in the gure (vertical lines) in order to evaluate interference e ects. Peaks in the Raman e ciency are related to particular interm ediate states giving strong contributions to the sum (1). In the gure, weak constructive or destructive interference in the neighborhood of these interm ediate states can be appreciated.




FIG.2: Upperpanel: R am an intensities for charge m onopole nalstates. Low erpanel: R am an spectra in spin dipole states. The position of collective excitations are signalized by drop lines. The density of nal-state energy levels is superposed in the gure.

The density of nalstate energy levels, computed from the R andom P hase approximation to $j_f i$, is superposed to the R am an spectra in Fig. 2 in order to show its correlation with R am an peaks. The shape of the R am an spectrum depends on the frequency, but it is apparent that strong R am an peaks are associated to bunches of energy levels. These notings are in qualitative agreement with the experimental results of paper [1].

In Fig. 2, curves labelled by a ? symbol represent a situation in which the incident an scattered light polarization vectors are orthogonal. For charge excitation

(CE) channels, in the upper panel, the Ram an spectrum in the orthogonal-polarization case is sim ilar to that one in the parallel-polarization geometry. In the lower panel, Raman intensities in spin-excitation (SE) dipolar nal states, are shown. By SE we mean states in which the total electronic spin projection is di erent from the initial state value. The di erence in m agnitude of peaks related to CE and SE in the orthogonal polarization would mean that SE peaks will be, in general, washed out, and only the lowest-energy SE levels, which are shifted to the left of CE states, have a chance to be measured. Notice also that the collective SE dipolar state, carrying m ore than 95% of the sum rule, and which position is represented also by a drop line, is observed only as a very sm all shoulder in the R am an spectrum .

Next, we consider the question about the e ect of the density of the electronic cloud on the R am an spectra. In our 42-electron dot, we can control the density by varying the con nement strength: $N^{1=2}m_{e}!_{0}=$ ~. Notice, for instance, that the density of larger dots with around 200 electrons, as those studied in Ref. 2, is similar to the density of our 42-electron dot when the parameter ~!_0 is doubled from 6 to 12 m eV. Calculations were done also for a smaller frequency, ~!_0 = 3 m eV, with the purpose of




FIG.3: Ram an spectra for charge monopole nalstates and parallel polarization. The magnetic eld is set to zero. (a) \sim !₀ = 3 m eV, (b) \sim !₀ = 6 m eV, and (c) \sim !₀ = 12 m eV.

obtaining the whole picture. In our calculations, we xed the C oulom b-to-oscillator ratio of characteristic energies, given by the parameter $e^{2m}e^{1=2} = (\ \sim^{3=2}!_0^{1=2})^{10}$ It means that the relative strength of C oulom b interactions is kept constant when the density is varied.

The results are shown in Fig. 3. For each value of ~! $_0$, R am an spectra are computed for laser energies 5 and 25 meV above the elective band gap. The curves can be qualitatively understood on simple grounds. An increase in ! $_0$ leads to a scaling of energies. For example, in Fig. 3 (c), only the rst SP and the rst collective peaks are seen, the rest of the spectrum ism oved to higher energies. In accordance to this scaling, the density of energy levels decreases both in interm ediate and nal states. Thus, the intensity of the R am an peaks should decrease by roughly a factor of 4 as ! $_0$ is doubled. The relative intensity of peaks depends on the R am an election of a solution of the relative intensity above.

Finally, we want to discuss the situation in which the incident laser energy is well (around 50 m eV) above the e ective band $gap^{2,9}$ This regime is characterized by the following properties: (a) an overall decrease of R am an amplitudes, (b) a reinforcement of the peaks associated




FIG.4: Ram an spectra for laser energies 25 and 50 m eV above the e ective band gap. Only the o -resonance contribution to the latter is shown. See explanation in the main text.

to collective states, and (c) a suppression of the SP peaks, except at the lower edge of SP excitations $^{\rm l1}$.

In this case, it seems useful to distinguish the resonant and o -resonance contribution to the sum 1). Only the latter can be evaluated within our computational scheme because, for excitation energies around 50 m eV, the interm ediate states are doubtfully described by a simple Tamm-D anko approximation, and a constant _{int} is not a reasonable approximation. Indeed, one expects, for example, an increasing _{int} as we move to interm ediate states with higher excitation energies.

In Fig. 4, the o -resonance contribution to the Raman spectrum for laser energy 50 m eV above the band gap is drawn, along with one spectrum, already shown in Fig. 3 (c), corresponding to an incident photon energy 25 m eV above the band gap. The o -resonance curve is computed from a sum which includes, as before, interm ediate states with excitation energies below 30 m eV. The sm aller am plitude of this curve is due to the big energy denom inators. It is apparent, how ever, that the SP peak is stronger suppressed than the collective one.

In general, the amplitude of the resonant contribution to (1) shall decrease as h_i rises. The reason is that both hf H^+ jinti and hint H^- jii decrease, while int increases in this case. The reinforcem ent of collective states could be the e ect of resonances in the interm ediate states, but this is a question that requires a further work.

In conclusion, we presented calculations for the am plitudes of resonant R am an scattering in 42-electron G aA s quantum dots based on the exact perturbation-theory form ula (1). To our know ledge, the largest previous calculation¹² considered a 12-electron dot, only one valence hole sub-band (the heavy hole), and assum ed a spin unpolarized HF ground state.

Features related to SP (dom inant) and collective nalstate excitations are apparent when the incident laser energy is varied in a 20 m eV energy interval above the e ective band gap. These features may be correlated to bunches of nal-state energy levels and to particular interm ediate states giving strong contributions to the sum (1). Weak constructive or destructive interference e ects can be appreciated in this regime. The intensity of spin-excitation peaks is shown to be one or two orders of magnitude weaker than the intensity of chargeexcitation peaks for these laser energies. It means that only the lowest-energy spin excited states have a chance to be measured. On the other hand, for h_{i} well above the band gap, the o -resonance contribution to the Ram an spectrum shows a strong suppression of SP peaks. These results are in qualitative agreem ent with the observations.

There are m any interesting points still uncovered. For example, to clarify the properties of the interm ediate states giving a strong contribution to (1). In quantum wells and for R am an shifts above 30 m eV, peaks in the R am an e ciency of collective SE are shown to correspond to the absorption or em ission of photons of particular frequencies, which are identified in PLE as a series of \excitonic" states¹³. These \resonances" in interm ediate states could be the reason of strong enhancem ent of collective SE in quantum dots for h_i well above the band gap. Indeed, SE collective peaks were observed in this regim e². These, and other, uncovered aspects of R am an scattering in quantum dots indicate the need for m ore experimental and theoretical work on this subject.
