Critical behavior of frustrated spin system s with nonplanar orderings

The critical behavior of frustrated spin system s with nonplanar orderings is analyzed by a six-loop study in xed dimension of an elective O(N) O(M) Landau-Ginzburg-Wilson Hamiltonian. For this purpose the large-order behavior of the eld theoretical expansion is determined. No stable xed point is found in the physically interesting case of M = N = 3, suggesting a rst-order transition in this system. The large N behavior is analyzed for M = 3;4;5 and the line N_c (d = 3;M) which limits the region of second-order phase transition is computed.

I. IN TRODUCTION

The critical behavior of frustrated spin systems with noncollinear order represents an important and, at the same time, enchanting issue.^{1,2,3} The debated topic concerns the nature of the phase transition which these systems should undergo. In the case of a second-order phase transition, the universality class is expected to be novel^{1,4,5} and characterized by new critical exponents different from those of O (N)-symmetric models.

Typical systems which have been studied for many years and where the situation is still unclear are the staked triangular antiferrom agnets and helim agnets, which present a noncollinear but planar spin orderings of the ground state.^{1,4} On this issue, there is much debate since eld theoretical methods, M onte Carlo sin – ulations and experiments provide contradictory results in many cases, sometimes supporting a weak rst-order phase transition, and sometimes a second-order one (see Refs. 1,2,3 for reviews on this topic). The perturbative eld theoretical studies on canted magnetic systems are based on an elective O (N) O (M) Landau-Ginzburg-W ilson (LGW) Hamiltonian with M N, which describes M -dimensional spin orderings in isotropic N -spin space^{1,2,4} with the O (N)=O (N M) pattern of symmetry breaking:

where a (1 a M) are M sets of N-component vectors. Negative values of v_0 correspond to simple ferrom agnetic or antiferrom agnetic ordering, and to magnets with sinusoidal spin structures.¹ The condition $0 < v_0 < M = (M - 1)u_0$ is required to have noncollinearity and the boundedness of the free energy. For M = 2 the H am iltonian (1) describes m agnets with noncollinear but planar orderings as the X Y (N = 2) and H eisenberg (N = 3) frustrated antiferrom agnets, while for M 3 systems with noncoplanar ground states.^{1,5}




FIG.1: Examples of nonplanar spin orderings (M = 3) in foc antiferrom agnets of type-II (left) and type-I (right).

The physical relevant case M = N = 3 represents the noncoplanar spin orderings which are three-dimensional in spin space and can be realized in structures in which the instability occurs simultaneously at three inequivalent points in the wavevector space as shown in Fig. 1.^{1,5}

For M = 2, the critical properties of the H am iltonian (1) have been extensively studied in the fram ework of the = 4 $d_r^{1,6,7}$ 1=N $r_r^{1,7,8,9} \sim = d$ 2 expansions r_r^{10} as well as in xed dimension $d = 2r_r^{11,12,13}$ and $d = 3r_r^{13,14,15,16,17}$ and with the exact renorm alization group (ERG) tech-

nique.^{18,19,20} The existence and stability of the xed points were found to depend on N in three dimensions. For su ciently large values of components of the order parameter four xed points exist in the region u; v > 0: Gaussian, O (2N), chiral and antichiral. The chiral xed point is the only stable one. Decreasing the value of N expansion predicts the existence of an N_{c} (M = 2) the greater than three at which the chiral and antichiral xed points coalesce, disappearing for $N < N_{c} (M = 2)$. These results, which are in agreement with the 1=N $,^{1,7}$ and the ERG ones,¹⁸ suggest the existence of a rst-order phase transition for X Y and Heisenberg frustrated antiferrom agnets. However one should consider that both and 1=N results are essentially adiabatic moving the from large N and small . For this reason they do not necessarily provide the (essentially nonperturbative) features of the models in the region below $N_{c}(M = 2)$. In fact six-loop calculations perform ed directly in three dimensions^{14,15} showed a di erent scenario characterized by two critical num bers of com ponents of the order pa-

ram eter N_c (M = 2) = 6:4(4) and N_{c2} (M = 2) = 5:7(3): for N_{c2} $(M = 2) < N < N_c (M = 2)$ no stable xed point is present in the RG ow, while for N < N_{c2} (M = 2) a stable chiral xed point appears again,¹⁵ which is a focus¹³ not related with its counterpart found within the

and 1=N expansions. The discrepancy between the ERG predictions and the weak-coupling ones remains an open problem which could be explained either with the low order considered in the derivative expansion in the rst case, or by the problem of Borel-sum mability in the second one.

For generic values of M 3, the and 1=N expansions give rise to the same scenario with the only di erence being the value of N_c (M) which varies with M. In the physically in portant case of M = N = 3, the expansion predicts the absence of a stable chiral xed point. Several M onte C arb simulations^{21,22,23,24} based essentially on Stiefel's m odels and ERG results¹⁹ agree indicating a rst-order phase transition for this system. A nyw ay no data in the xed dimension expansion exist.

In this paper we analyze the H am iltonian (1) for M 3 through a six-loop perturbative study in the fram ework of the xed dimension approach, in order to investigate the critical behavior of frustrated spin system s with nonplanar orderings directly in three dimensions and to have a global picture of the region where the results obtained with di erent perturbative methods are in agreement.

The paper is organized as follows. In Sec. II we introduce the eld-theoretical approach for the eld-theoretical approach for the eld-theoretical approach for the eld-LGW Hamiltonian (1), in Sec. III we present the analysis method and we discuss the singularities of the Borel transform, in Sec. IV we present the results and nally in Sec. V we draw our conclusions.

II. FIXED D IM ENSION PERTURBATIVE EXPANSION OF THE O (N) O (M) LG W HAM ILTONIAN

The Ham iltonian (1) is studied in the framework of the xed dimension eld-theoretical approach. As in the case of X Y and Heisenberg frustrated models¹⁵, the idea is to perform an expansion in terms of the two quartic coupling constants u_0 and v_0 , and to renormalize the theory imposing the following conditions on the (oneparticle irreducible) two-point, four-point and two-point with an insertion of $\frac{1}{2}$ ² correlation functions:

where $S_{ai;bj;ck;dl}$ and $C_{ai;bj;ck;dl}$ are appropriate combinatorial factors. 11,12

The perturbative know ledge of the functions $^{(2)}$, $^{(4)}$ and $^{(1;2)}$ allow s one to relate the renorm alized parameters (u;v;m) to the bare ones (u_0;v_0;r).

The xed points of the model are de ned by the com - mon zeros of the functions,

A xed point is stable if both the eigenvalues have a positive realpart, while a xed point which possess eigenvalues with nonvanishing in aginary parts is called a focus.

The other critical exponents can be derived by scaling relations from and .

In this work the following symmetric rescaling of the coupling constants is adopted in order to obtain nite xed point values in the limit of in nite components of the order parameter:

where $R_{N} = 9 = (8 + N)$.

For N ! 1 four xed points exist: G auss (u = 0;v = 0), H eisenberg (u = 1;v = 0), chiral (u = M;v = M) which is stable, and antichiral (u = M 1;v = M). In the following we denote with u and v the functions corresponding to the above rescaled couplings.

III. RESUMMATION AND ANALYSIS METHOD

The perturbative six-loop series²⁵ for the RG functions are asymptotic and some resummation procedure is necessary in order to extract quantitative physical informations. In this work the property of B orel summability is exploited resumming the perturbative series by a B orel transformation combined with a conformal mapping²⁶ (CM) which maps the domain of analyticity of the B orel transform (cut at the instanton singularity) onto a circle (see Refs. 26,27 for details). This resummation procedure needs the knowledge of the large order behavior of the perturbative series which is connected with the singularity (u_b) closest to the origin at xed z = v=u.^{11,15} For the Ham iltonian (1) with generic O (N) O (M) symmmetry and M N we nd

where a = 0:147777422.

In the case of M=2 the singularity reduces correctly to the one of Ref. 15. For $z>\frac{M}{M-1}$ there is a singularity on the real positive axis which how ever is not the closest one to the origin for $z<\frac{2M}{M-1}$. Thus, for $z>\frac{M}{M-1}$ the series are not Borel sum mable. The region where the perturbative series are not Borel sum mable is the same of the one where the condition for the boundedness of the free energy is satis ed. It is easy to show that the conditions are equivalent.

W ith this resummation procedure one obtains a lot of approximants for each RG perturbative series characterized by three parameters p, b and which can be varied in order to estimate the systematic errors in the nal results. If $R(\overline{u};\overline{v})$ is a perturbative series in \overline{u} and \overline{v}

and the coe cients B $_k$ are determ ined by the condition that the expansion of E (R)_p (;b; $\overline{u}; \overline{v}$) in powers of \overline{u} and \overline{v} gives R ($\overline{u}; \overline{v}$) to order p.

In order to nd the xed points of the Ham iltonian (1) the two functions are resummed in the whole zone (u > 0; v > 0). For each function the approximants are chosen which stabilize the series for small values of the coupling constants with varying the considered perturbative order (number of loops), i.e. = 0;2;4 and b = 3;6;9;12;15;18. The stability eigenvalues $!_i$ are evaluated by taking the approximants for each function and by computing the num erical derivatives of each couple of them at their common zero. Only the approxin ants which yield xed point coordinates compatible with their nalvalues are considered. The critical exponents are computed by choosing the approxim ants which are more stable with varying the perturbative order (see Ref. 11,12 for details).

IV . RESULTS




FIG.2: Zeroes of the -functions for N = 3 and M = 3 in the (u;v) plane. Pluses (+) and crosses () correspond to zeroes of $_v$ (u;v) and $_u$ (u;v) respectively.

Fixing M = 3, the analysis of the six-loop RG series reveals the absence of a stable chiral xed point for the physical interesting case of N = 3; in this case no second-order phase transition is expected as it is clear from the picture of the zeros of the functions in Fig. 2. In this Figure the domain 0 u 6, 0 v 6 is divided in 40^2 rectangles, and all the sites in which at least two approximants for u and v vanish are marked. These results are in agreem ent with the ERG prediction of Ref. 19 where no stable xed point is found, and with M onte Carlo simulations on the corresponding Stiefel's model^{23,24} which show a rst-order phase transition. Increasing the value of com ponents of the order param eter N, the curves of the zeros of the two functions become closer and it exists a value N_{c} (M = 3) at which they intersect each other. For $N > N_{c} (M = 3)$ four xed points exist in the region v > 0; u > 0; the Gaussian one, the Heisenberg one, the antichiral one and the stable chiral one. This last drives the system to a continuous phase transition. For N = N_c (M = 3) the chiral and antichiral xed point merge and for N < N $_{\odot}$ (M = 3) no stable xed point is found. The estimate of N $_{\rm c}$ is obtained by considering all the 324 possible combinations of the approximants for the two functions and evaluating for

each of them the value of N_c. W ith this procedure we have N_c (M = 3) = 11.1 (6) at six-bop order.

The same scenario of xed points holds for M = 4 and M = 5 with di erent values of N_c.

All the ve-loop and six-loop estimates of N $_{\rm c}$ for M = 3; 4 and 5 are shown in Tab. I where the expansion and the 1=N predictions of Ref. 7 are reported for a comparison. The agreem ent of the results is good even if it worsens with increasing the magnitude of M . Nevertheless, in the case of a comparison with the expansion results, only three-loop series are known which need to be resummed in order to extract some inform ation. Due to the low perturbative order considered, one m ay only have an indication of the right results. In fact the perturbative series can be evaluated extending them analytically by m eans of a Pade Borel transform 6 (e.g. 3:39) or by di erent techniques⁷ (e. g. $N_{C}(M = 2)$ 5:3) and the results strongly depens on the $N_{\rm C}$ (M = 2) method applied. In the case of the 1=N expansion, one has to consider that N_c is determined by perturbative series which are known only to $0 (1=N^2)$, the correction to the leading term is not small, and since N_c is expected not to be large in m agnitude, one is extrapolating the results to value of N which could be dangerous. Furtherm ore the results of the di erent perturbative approaches are nearer in magnitude for small values of M because with

increasing the perturbative order considered, the corrections to the leading terms become more important for bigger M . Even the xed-dimension results become less stable with increasing the value of M . In order to provide a complete characterization of the critical properties of the Ham iltonian (1) we analyze it for large values of com ponents of the order parameter at xed M . The location of the chiral xed point, the stability eigenvalues and the critical exponents are calculated for N = 32;64 and are displayed in Tab. II. For the evaluation of the critical exponents and we resum the perturbative series of 1= and 1= because of their better behavior. In these cases one can see a quite good agreem ent or the results with the 1=N expansion predictions. The data of Tab. II corroborate the expectation for which the line N_{c} (M) lim its the region where all the perturbative investigations bring to the sam e predictions.

V. CONCLUSIONS

In this work we have studied the critical therm odynamics of the O(N) O(M) spin model for N Μ 3 and M 5 on the basis of six-loop RG series in xed dim ension. We have evaluated the large order behavior of the perturbative RG series and we have analyzed them by means of a CM resummation technique. For the physically interesting case of N = M = 3, no stable xed point exists in the RG ow diagram leading to the conclusion that this system is expected to undergo a rstorder phase transition. This result agrees with previous ERG predictions¹⁹ and M onte Carlo studies on Stiefel's models.^{23,24} For M = 3;4;5 we have computed the critical value N $_{\rm C}$ (M) of components of the order parameter which separates the region of rst-order phase transition to the second-order one, nding N $_{c}$ (M = 3) = 11:1(6), $\rm N_{\,c}\,(M~=~4)~=~14$:7(8) and $\rm N_{\,c}\,(M~=~5)~=~18$ (1). In this case the comparison with the 7 and 1=N expansion⁷ predictions is quite good even if it worsens with increasing the magnitude of M. Finally, being the region $N > N_{c} (M)$ expected to be connected with that accessible by the large N analysis, we have given a characterization of the critical properties of these system s for large values of N nding a satisfactory agreem ent between the two perturbative m ethods.
