A bstract

The therm alrem agnetization (TR), i.e. the reentrance of magnetization upon heating in a steady- eld dem agnetized sam ple, is a com m on feature to the four types of polycrystalline perm anent m agnets, m ainly utilized for practical purposes, i.e. barium ferrites, Sm C o_5 , Sm $_2$ C o_{17} and N dF eB m agnets. The e ect is sm all for pinning controlled and large for nucleation controlled m agnets. The e ect is strongly dependent on the dem agnetization factor and m ay reach nearly 100% in Sm C o5 sam plesm easured in a closed circuit. The TR is very sensitive to a sm all superimposed steady eld. The maximum e ect and the position of the peak is dependent on the initial tem perature. The direction of the TR is correlated with the tem perature coe cient of the coercivity, resulting in a inverse TR in barium ferrite. The susceptibility of the therm ally rem agnetized sam ples is increased. Repeated cycles of steady- eld dem agnetization followed by heating result in the same TR. The phenom enology of TR and ITR is explained by means of a m odel taking into account both the internal eld uctuations due to grain interactions and the decay of single dom ain grains into multi-dom ain state. By taking the measured tem perature dependencies of the coercivity and the saturation m agnetization the theory is able to reproduce the experiments very well, allowing to determ ine the width of the eld uctuations, the width of the switching eld distribution and an internal dem agnetization factor as characteristics of the materials by tting.

1 Introduction




Figure 1: The scheme of the standard TR-Experiment. A fler saturation the sample is demagnetized isothermally by a steady eld at the initial temperature T_0 (upper sketch) and afterwards either heated (TR-experiment - left shaded picture) or cooled (TTR-experiment) with the external magnetic eld switched o, whereby the magnetization is measured.

The e ect of Therm al R em agnetization (TR) was rst mentioned in a paper of Lifshits, Lileev and M enushenkov [1] devoted to stability investigations of the coercivity of Sm C o₅magnets at elevated temperatures in 1974. They wrote: "We also found a rem agnetization upon heating in absence of an external eld at samples, which were partially or completely dem agnetized by a steady counter eld." [2]. One year later the same group [3] published a rst system atic study devoted solely to this e ect. As we will see in the following, TR is not restricted to SmCo5 magnets, instead it is quite com m on to all sintered hard m agnets. But, before giving an outline of the history, we have to explain the principle of the TR experim ent. In Fig. 1 the experim ental procedure

is sketched. Firstly the sample has to be saturated by a very large magnetic eld. Next a steady eld H_R (rem anence coercivity) opposite to the saturation direction is applied. Switching o the external eld drives the sam ple in the dc-dem agnetized state. Now the tem perature is changed and the related change of magnetization is measured. If a reentrance of magnetism with increasing temperature is observed the e ect is called therm al rem agnetization (TR), see the right shaded picture. O therw ise, if a magnetization return is observed upon cooling, as shown in the lower shaded gure, we call it inverse therm al rem agnetization (ITR). A lready in their st investigations Lileev et al. [1, 3] dem onstrated for Sm C o_5 , that the TR is strongly dependent on the dem agnetization factor, especially it amounts up to nearly 100 % in a closed circuit. Furtherm ore it was shown, that at least for Sm Co₅, the e ect is not necessary restricted to the dem agnetized state, but also occurs in a partially dc-dem agnetized state (23% of the saturation m agnetization). On the other hand the e ect is absent in acdem agnetized samples. Reconsidering the TR in SmCo₅ nearly ten years later, Livingston and Martin [4] suggested as explanation of the TR the conversion of the single dom ain state (SDS) of some grains into a multidom ain state (MDS). This assumption was supported by the observation of multidom ain states in a few big grains of Sm C o₅ at higher tem perature and also by the discovery of the TR in sintered N dF eB -m agnets [5], where the e ect is larger in samples with lower number of multidom ain grains in the dc-dem agnetized state. An alternate explanation was given in Ref. [6]. Based on investigations of the TR in Sm Co₅ and barium ferrite in 1985 the authors proposed the magnetic interaction between adjacent grains together with a broad distribution of the tem perature dependent switching elds to be responsible for the TR. This model, despite of its oversim pli cations, was able to explain the increase of magnetization qualitatively and it showed the key role of the tem perature coe cient of the coercivity resulting in the discovering of the ITR for sintered barium ferrites. Furtherm ore it was demonstrated that the TR is connected with a increasing susceptibility and that sm all external elds m ay suppress the effect at all. Additional support the interaction model got from a paper of Lileev and Steiner [7], proving that the TR e ect depends strongly on the volum e packing density, a fact which was shown to be responsible for the dierence in ITR in sintered and chem ical precipitated barium ferrite sam ples [6]. To decide, which of the both m odels accounts well for the observed effects Lileev et al. [8, 9] counted carefully grains in single-dom ain state and multi-dom ain state at di erent tem peratures. Their results proved that there is a delicate interplay of both interaction and formation of multi-domain grains, at least in the $Sm Co_5$ samples. From the very beginning it was assumed that TR is connected with the nucleation controlled m agnets. O therw ise, pinning controlled magnets should not show the e ect, and indeed, the $Sm Co_5$ -, N dF eB -, and ferrite-m agnets show rem arkable TR and ITR resp. [3, 4, 5, 6, 10, 11, 12], whereas the e ect in $\operatorname{Sm}_2\operatorname{Co}_{17}$ is small [13]. To what extend this statem ent is true together with the role of interaction in relation to the decay of SDS grains into MDS grains, motivated much of the theoretical and experim ental work. Since the e ect is most conspicuous in $Sm Co_5$, much e ort was spent to this material. O therwise it became clear, that it is a rather common e ect to all modern polycrystalline perm anent m agnets. N evertheless, as will be shown in the next section, the experiments demonstrate clearly the individuality of every com pound class. the tem perature coe cient of the coercivity has the opposite sign. For the Sm_2Co_{17} -m agnets M_{S} (T) and H_{C} (T) behave as in Sm Co₅, but there we have a complete di erent coercivity mechanism, i.e. volume pinning of domain walls. In N dF eB magnets the magnetic active phase is separated by one or more other phases reducing the interaction between ad jacent grains. In Tab. 1 we show schem atically how the four groups of magnetic materials are qualitatively distinguished by som e features being relevant for TR, i.e. the num ber of phases, the coercivity m echanism, and the tem perature coe cient of the coercivity.

In the third chapter, we will give a brief review over the models used so far to understand the di erent aspects of TR and present a theory which accounts for both the TR in Sm C o₅ and the ITR in barium ferrite in single-phase m agnets. The last chapter will be sum m arize what can be learned from TR measurements and some remarks to open questions will be appropriate.

2 Experim ents





Figure 2: The TR for various $Sm Co_5$ sam – ples taken from Ref. [3] (squares) and Ref. [4] (triangles) and a VACOMAX 200 sam ple (circle) [16]. The data were transformed slightly from the original data to t into the same plot. A lso the dem agnetization factors of the cylindrical sam ples were calculated from the geom – etry given by the authors. For details we refer to the original papers [3, 4].




Figure 3: The tem perature dependence of the coercivity $H_{\rm C}$, saturation magnetization $M_{\rm S}$ and the TR for two samples of Sm Co₅ with dem agnetization factors N = 0.08 and N = 0.53 [16].

2.1 The standard TR experiment in the Sm Co_5 , Sm $_2Co_{17}$ and N dFeB

shows an increasing coercivity up to 550 K, i.e. diagram [14, 15] of the Sm -Co system shows

that below about 750 C the magnetic active phase SmCo₅ is meta-stable with respect to a decomposition into Sm₂Co₇ and Sm₂Co₁₇ with reduced uniaxial anisotropy. W hile at moderate temperatures this decomposition process does not a ect the m icrostructure and the magnetic quantities, chemical instability becom es a problem in high tem perature m easurements, since a long lasting TR experiment m ay act as an unintentional heat treatm ent of a sample. The rst measurements of the TR in $Sm Co_5$ are collected in Fig. 2. The points shown as squares are taken from Ref. [3] and the triangles from Ref. [4] and the open circles are our own measurements at a VACOMAX 200 specimen [16]. The biggest TR (lled squares) was measured in a closed magnetic circuit what corresponds to zero dem agnetization factor. The rem aining curves represent open circuit measurements at cylindrical samples of dierent aspect ratio resulting in dierent dem agnetization factors. In Ref. [3] the remanence was measured at room temperature after heating to a certain temperature and cooling down to room temperature, whereas in Ref. [4] the magnetization was registered simultaneously while increasing the temperature stepwise. Every temperature step was followed by an annealing of 30 m in. The remaining curves were measured while continuously increasing the tem perature. In order to get the slightly di ering experim ents into one diagram we used the tem perature dependence of M $_{\rm S}\,$ m easured at our VACOMAX 200 sam ple together with the room tem perature rem anence data given in Refs. [3, 4] to scale the results. A lthough one m ay object that the results of Fig. 2 stem from Sm C o₅ sam ples produced in di erent ways, it is evident that a variation of the dem agnetization factor in uences the TR much stronger than a variation of the production conditions, at least if the result is a good $Sm Co_5$ hard magnet. Fig. 3 shows both the TR for two sam ples with di erent dem agnetization factors cut from the same material (VACOMAX 170)

saturation magnetization and the coercivity of that material. It can be seen from the curve for the N = 0.08 sample that the TR survives in the region above the tem perature $T_{H c}$, where the coercivity vanishes, which is about 700 K . As we will see in the theory, this unexpected behavior can be ascribed to the fact, that the Curie tem perature is more than 200 K higher than T_{Hc} . Likev et. al. measured the TR for SmCo5 samples with coercivities between (0.35 T / $_{0}$ and 3 T / $_{0}$. They found that the in ection point, visible also in Fig. 3, vanishes for room temperature coercivities [17] below 1.6 T/ 0. For higher coercivities they found a decrease of the initial slope and an increase of the maximum of the TR with increasing coercivity. Measurements at samples, where the low-temperature coercivity was reduced by a special heat treatm ent [18] but otherw ise [16], and the temperature dependence of the prepared in the same way as the samples


Figure 4: The tem perature dependence of the coercivity H $_{\rm C}$, saturation m agnetization M $_{\rm S}$ and the TR for a Sm $_2$ C o_{17} sam ple.

utilized in Fig. 3, did not show signi cant changes of the TR curves.




Figure 5: The temperature dependence of the coercivity ${\rm H}_{\rm C}$, saturation m agnetization M_S and the ITR of two NdFeB samples with N = 0.04 and N = 0.46 resp. [16].

In contrast to $Sm Co_5$, where the hysteresis mechanism is nucleation controlled, the coercivity of Sm₂Co₁₇ magnets is caused by volum e pinning of dom ain walls. For that behave a single phase solution of approxim ately 1:7 composition, i.e. slightly Co de cient with respect to Sm_2Co_{17} , is hom ogenized at approximately 1200 C and afterwards cooled down to 800 C, where it decays into the two adjacent stable phases by precipitation of $Sm Co_5$ and $Sm Cu_5$. The contemporary commercial magnets of the 2:17 type are composed typically Sm (Co,Fe,Cu,M)7, where the iron is used to increase the saturation m agnetization and the other m etals m ainly for metallurgical reasons to obtain the precipitation m icrostructure. The latter is common to all Sm_2Co_{17} -m agnets. The entirely dierent mechanism of magnetic hardening was the reason that in early years these compounds where believed not to show TR. Nevertheless a small TR is present also in Sm $_2$ C o_{17} , as it is as depicted in Fig. 5, is considerably smaller

visible in Fig. 4.W ith regard to the sm allness of the e ect, which amounts to not more than 3%, it is not yet clear, whether the e ect is characteristic for all Sm₂Co₁₇ magnets or whether it is caused by imperfections of the m icrostructure, especially by the presence of a small content of of SmCo₅ phase, as was argued in Ref. [13] in connection with the interpretation of virgin curves.

The NdFeB-type magnets consist of the magnetic active phase N d_{2 x} D y_xF e₁₄B surrounded by nonmagnetic phases. This guarantees for magnetic decoupling of neighboring grains. W ithin the main phase the nucleation m echanism was shown to controlm agnetization reversal [19]. A part from the much lower Curie tem perature and the spin reorientation below 137 K, the tem perature dependence of coercivity and saturation magnetization is qualitatively the same as in SmCo₅ within the interesting tem perature region, see Fig. 5. A remarkable di erence is that coercivity and magnetization vanish nearly at the same tem perature, i.e. at T_{Hc} T_{C} . The observed TR,

than in Sm Co₅, but, with 12 % for the sam ple with very small dem agnetization factor it is doubtless that it is an intrinsic characteristic of the magnet and can not be ascribed to imperfections in the microstructure. Livingston reported TR e ects of 3% for rod sam ples (N 0.17) with H_C about $1 \text{ T} / _0$ and 24 % for a high coercive sample $(2.5 \text{ T} / _0)$ [5]. Furtherm ore, the low coercive samples were shown to contain a lot of multidom ain grains in the dc-dem agnetized state, in contrast to the high coercive specimen, which contained only a few. The same correlation between coercivity and TR was also reported in [11].

2.2 The ITR in Barium Ferrite

In comparison with the above mentioned interm etallic magnets the ceram ic barium ferrite magnets exhibit a entirely di erent tem perature dependence of the coercivity, as shown in Fig. 6. That is why the normal TR cannot be measured in this substances. Nevertheless an analogous experiment, where an




Figure 7: The ITR for four samples with N = 0.1, N = 0.3, N = 0.7, and N = 0.9 respectively. The solid lines are theoretical ts.

at elevated tem perature and afterwards cooled down, shows also a rem arkable rem agnetization [6]. This e ect was called inverse therm al remagnetization (ITR). As seen from Fig. 7 we nd again a strong dependence on the dem agnetization factor. Since the coercivity upon cooling does not vanish one cannot observe a maximum. Instead one nds a plateau at lower tem perature. Barium ferrite magnets are single-phased and the coercivity mechanism of barium ferrite is nucleation controlled. In that respect, apart from the dierent tem perature dependence of the coercivity, the ITR of about 20% is similar to the TR in Sm C o5-m agnets.

2.3 The eld dependence

The dramatic dependence of the TR on the dem agnetization factor shows that a high sensitivity with regard to the internal magnetic elds is to expect. The in uence of a small superimposed steady eld was studied in [6, 20, 21]. To that behave the standard experiment was modied in the following way: A fter saturating the sample in a eld of (about 10 T initially saturated sample is dc-dem agnetized for $Sm Co_5$ - and Sm_2Co_{17} -samples and about





Figure 8: M easured TR-curves M (T) (circles) for $Sm C o_5$ [22] for di erent external steady elds applied during heating (sm all num bers at the curves). The solid lines are m odelcalculations with parameters determined by the H_{ext} = 0-curve (cf. section 3). The inset shows schem atically how the initial state for the TR m easurem ent is prepared.

2 T for the barium ferrite samples) it was dem agnetized by help of an opposite steady eld $H_{ext}^{(1)}$. If this eld equals the remanence coercivity H $_{\rm R}\,$ the m agnetization will go to zero after switching o the eld. Otherwise, if H $_{ext}^{(1)}$ deviates a little bit from H $_{\rm R}$, the dem agnetized state will be achieved on the recoil curve for a small negative residual eld H $_{\rm ext}$ < 0, if H $_{\rm ext}^{\rm (1)}$ is greater than H $_{\rm R}$, and for a small positive eld otherwise, as the inset in Fig. 8 shows schematically. The eld H_{ext} was then kept constant while the sam ple was heated (or cooled in the case of barium ferrite) and the resulting rem anence enhancem ent M (T) (TRcurve) was recorded. A set of such measured TR-curves (points) is given in Fig. 8 for Sm Co₅ [22]. The initial tem perature T_0 was 250 K. The solid lines are due to the theory, which will be explained below. The cases with $H_{ext} = 0$, i.e. $H_1 = H_R$, correspond to a \normal" TR-curve. A system atic shift of the maximum tem perature ${\rm T}_{m\ ax}$, the maximum remanence enhancement M_{max} and also of the initial slope M $_{TR}$ (T) = T [22] with increasing negative external eld is observed. The same qual-


tain negative eld H⁰. The order of magnitude of this "suppression eld" H⁰ is to some extent a characteristic of the di erent types of perm anent m agnets [6, 20]. Fig. 12 extracts the maximum TR values in dependence of H_{ext} from Figs. 8, 9, 10, and 11. Comparing these results with other reported m easurem ents one ndsH 0 of the order of 200–500 m T for Sm C o_{5} [6, 20, 22] and 30-80 m T for N dF eB -m agnets [24, 22]. For Sm 2 (C o; :::)17-m agnets this value seems to be more dependent on the chemical com position and technological treatm ent of the sample. P lease note the m T-scale in the lower picture of Fig. 12 showing M $_{max}$ via H $_{ext}$ data for $\text{Sm}_2\text{C}o_{17}$. Nevertheless H⁰ is in the H_C (T_{max}) H_C (T_0) is essentially for the TR.




Figure 11: Measured ITR-curves M (T) (circles) for barium ferrite for dierent external steady elds applied during cooling (sm all num bers at the curves) [23].

the assumption that the TR in Sm_2Co_{17} is caused by a sm all am ount of Sm C o₅ grains as was proposed in [13]. The suppression eld for the ITR in the barium ferrite sample of Fig. 11 is about 20 m T as may be seen from the lled squares in Fig. 12.

2.4 In uence of the initial tem perature T₀

O cularly the TR as well as the ITR are strongly connected with the tem perature dependence of the coercivity. The di erence of the coercivity same region as in $Sm Co_5$. This may support Thus the remanence increase should be depen-




Figure 13: TR curves for dierent initial tem – peratures T_0 . The upper picture shows the initial TR for low initial tem peratures.

dent on the initial tem perature T_0 as well. In Fig. 13, we show the results for oblate discs cut from a well aligned Sm C o5-m agnet (VA -COMAX200). The upper part shows the initial irreversible TR at very low tem perature, i.e. in the high coercive region, in detail, whereas the low er part show s the com plete m easurem ent to the maximum. Cooling down from the maximum the magnetization increases reversibly exactly proportional to M $_{\rm S}$ (T). M ore generally, if the TR experiment is interrupted at som e tem perature T_1 the magnetization change while cooling follows exactly m $_1$ M $_{\rm S}$ (T), with m_1 being the ratio M (T₁)=M_S (T₁), see e.g. Fig. 1 in [20]. On the one hand the amount of the TR is considerably in uenced by a change





Figure 14: TR curves for two di erent initial tem peratures for a N dFeB sam ple (N dFeB H R 510) with N = 0.46




Figure 15: ITR curves for three initial tem peratures for a isotropic sam ple.

of the initial temperature, on the other hand only a small shift of the maximum position to lower temperatures is observed, if the initial temperature decreases. A likewise behavior is observed in N dF eB as depicted in Fig. 14. Regarding the ITR in barium ferrite, where the initial temperature has to be chosen higher than the nal temperature, we found again a strong dependence of the remanence increase on the initial temperature, whereas the region where the curves run into the plateau is slightly in uenced only, as may be seen from Fig. 15.

2.5 Susceptibility and R epeating experiments

Since heat treatment is a mayor step in permanent-magnet production the possibility

is to envisage that the sample after the rst TR experiment is irreversible changed. This is of course of m inor importance for the ceramic magnets but may be important in Sm C o₅. Since the maximum temperature in Sm C o₅ is about 600 K, it is low enough not to destroy the samples if the TR experiment does not last to long. In [4] the stability of the magnetization of Sm C o₅ against therm all cycling between 20 C and 75 C was investigated. It was shown that it needs a few cycles to stabilize the magnetization change. For a sample which was partially dc-demagnetized (10% lowered remanence), it

was shown that 16 h annealing at 75 C after ten cycles produces a sharp positive M jum p while additional hold of 38 h after cycle 13 produced no further signi cant change, besides a very sm all increase continuing up to 53 cycles. In [22] "repeating" experiments were reported, which dier a little bit from the therm al cycling procedure. Contrary to [4], where after every TR cycle the sam ple was saturated with a high eld, the sam ple was dc-dem agnetized from the rem anent state which it reached after a cycle T₀ ! T_{m ax} ! T₀, i.e. without a new saturation. The idea behind this experiment was to prove the assumption, that the "hard grains", i.e. the fraction of grains which resist dc-dem agnetization, are not concerned by the TR experiment. Fig. 16 shows a TR experin ent together with its two repetitions. The di erence between the curves are more likely due to the uncertainty in achievement of the dc-dem agnetized state. Thus it is merely the "weak" grain fraction, which is switched both during dc-dem agnetization and TR. A fter the






Figure 17: Measured TR curves for the same sample as in Fig. 8 for $_{0}H_{ext} =$ 10m T (+). The circles represent the values measured for $_{0}H_{ext} = 0$. Furtherm one the H_{C} (T) is indicated.

ness of the week grains was considerably lowered by heating to $T_{m ax}$. As a consequence an increase of the susceptibility is observed. In the experiment shown in Fig. 17 the TR curve was started as norm al in the dc-dem agnetized state, but a very small eld of 10 mT was superim posed with alternating sign at every registration point of the magnetization. This results in a "normal" and two slightly shifted TR curves. The latter were taken as input for the calculation of the susceptibility , which was derived from the un-sheared susceptibility 0 = M = H _{ext} according to = 0 = (1 N 0) with N being the dem agnetization factor of the sample. The plot in Fig. 18 shows a continuous uprise with increasing tem perature, which becomes very large beyond T_{max} . This sharp increase is due to the partial conversion of the weak grain fraction into the MDS and due to the lowering of their switching elds. This reduced coercivity of the weak grain fraction is frozen if the sample is cooled back to $T_0.0$ therwise, the hard-grain fraction regains nearly reversibly its initial state, what means that the interaction eld distribution due to the hard grains is reestablished. 2.6 In uence of texture.




Figure 19: TR curve (1) and one repetition (2) for an isotropic sintered sample of $Sm Co_5$ (Quality as VACOMAX 170, sintered and pressed without aligning eld [18]). The inset shows the dc-dem agnetization curve for the rst and second run.

Due to the technical importance, most of the reported TR experiments were done at welltextured samples. In Refs. [22, 25] TR investigation at isotropic m agnets were reported. Comparing isotropic and well aligned samples of Sm C o5 one nds the same qualitative behaviour, but the TR of the isotropic specim en is reduced roughly four times with respect to the well aligned sam ple. Furtherm ore the difference of the TR curve and the rst repetition diers a little bit more than in the well aligned material, as may be seen from Fig. 19 tize the sam ple another time one has to over- itatively the same behavior was reported for

isotropic sintered barium ferrite [25] 0 therw ise, an isotropic barium ferrite sample made from chem ical precipitated 50 nm -pow der, does not show any TR [6, 26]. To what extent this is connected with texture is not completely clear. The nano-sized grains are nearly Stoner-W ohlfarth particles, with an entire di erent coercivity mechanism [27]. Furtherm ore the density is much lower than in the sintered barium ferrite sam ples, what reduces the inter-grain interaction. That the latter plays an essential role can also be concluded from the experiments of Lileev and Steiner [7], who measured the initial TR for $Sm Co_5$ in the temperature region from 42K to 270K for both wellaligned sintered magnets and polymer-bounded sam ples with a Sm C o_5 content of 20% and 80%. They found a considerable reduction of the TR with decreasing Sm C o5 packing density.

Under the assumption that the intrinsic switching elds of the grains are not strong correlated with its position, we will nd a extrem e inhom ogeneous m agnetization at a m icroscopic scale in the dcdem agnetized state giving rise to considerable stray elds. W hile there is agreem ent that it is this part of the energy which governs TR, two dierent explanations for the mechanism behind TR were proposed. The rst, introduced by Livingston [4], assumes that the downwards m agnetized grains, which are in a single dom ain state before heating, decay into a multidomain state upon heating. This model got support from the direct observation of such grains in Kerr photographs taken from the surface of dc-dem agnetized Sm C o₅-m agnets [4] and N dF eB m agnets [5]. dom inating role of the SDS-MDS mechanism . W ithout any calculations it is obvious that the maximum TR e ect may not be greater than 50%, since after a complete decay of the weaker half only the harder grains contribute to the magnetization. This contradicts the observation of a much greater e ect measured for $Sm Co_5$ in a closed circuit [3]. Furthermore, the number of the multidom ain grains seen in the shown K err photographs seems to be to low to explain the e ect, despite the fact that it is not completely clear to whether extent the surface observation is representative for the bulk behavior. The other model [6] assumed that the grain fraction with lower switching elds is rst switched downward by the dc-dem agnetization procedure. A fter taking away the external eld they remain in a metastable state since their switching eld is higher than the interaction eld caused by the surrounding upwards oriented, i.e. harderm ag-

back in its initial direction. The decrease of the TR with decreasing lling factor [7] hints strongly at the role of inter-grain interaction. Further support the interaction m odelgot from the ITR in barium ferrite, since contrary to $Sm Co_5$, Sm_2Co_{17} , and N dF eB, the low tem perature m in im um of the coercivity is still high enough to prevent a decay of grains into a multidom ain state, thus the SDS-MDS mechanism can not explain the ITR. To clarify the role of multidom ain grains Zaytzev et. al. [9] used Kerr m icrography to count the number of multidom ain grains in SmC o5 magnets in the dc-dem agnetized state at room tem perature and at 120 C. They dem onstrated clearly that in the considered sam ples three processes contribute to the TR: Downward magnetized grains are either switched back or decay into the MDS under the in uence of the interaction elds due to surrounding grains and in MDS grains the upward dom ains grow at cost of the downward domains. Besides the fact that the investigated sam ples exhibit a low ered coercivity and an unusual broad switching eld distribution (SFD) in comparison with usual com m ercial m agnets and that surface e ects m ay result in a slight overestim ation of the role of the MDS fraction from these experiments it becom es clear that a theoretical model has to describe both the interaction processes and the behavior of the MDS grains. It is interesting that they also observed hard grains changing from SDS to MDS. W hereas the theory presented below uses a phenom enological ansatz, Likev et al. [17] presented a model based on simulations of interacting dipoles. Thism odel, also taking into account the possibility of MDS states, was originally developed for the simulation of m inor loops of perm anent m agnets [28]. By taking into account the tem perature dependence of the model parameters it was also possible to simulate the TR. The shape of the only given curve deviates far from experim ents. 3.2 The inclusion model

The outlined theory was developed in Refs. [6, 10, 23, 29]. The poly-crystalline perm anent magnet is an ensemble of high-coercive magnetic uniaxial grains. To x our model we have to de ne the properties of both a single grain and the ensemble. For the single grain we assum e that the tem perature dependent saturation magnetization M_{S} (T) should be known. Furtherm ore every grain should be characterized by its tem perature dependent switching eld H $_{\rm s}$ (T), by its \internal" dem agnetization factor n, by the direction of the easy axis due to the high uniaxial anisotropy e_{r} and by its volume V. Here $H_{s}(T)$ is the absolute value of the eld needed for reversing the magnetization of the grain in a closed circuit. Regarding the ensemble we assume that all grains exhibit the same M $_{\rm S}$ (T), that the easy axis e of the grains are completely aligned, i.e. we restrict the model to ideally textured, single-phased magnets. These conditions are best ful lled in $Sm Co_5$ and barium ferrite magnets, whereas N dF eB m agnets contain m ore than one phase and Sm₂Co₁₇ magnets show a precipitation structure resulting in a di erent switching behavior of a grain. Furtherm ore we allow that the grains dier in their switching elds H s, but the distribution of these switching elds should be known. In non-interacting ensembles the switching eld distribution may be determined from rem anence m easurem ents [30], but if the grains interact strongly this method fails. In Ref. [24] both the therm alrem agnetization and the change of the H_s spectrum with increasing tem perature of a Sm C o₅ sam ple was measured, whereby the latter was approximately determ ined from dM =dH . This is justi ed if reversible magnetization processes are negligible as it is the case in SmC o5-m agnets, For sim plicity we assume a Gaussian normalized with




Figure 20: The grain is considered as an inclusion with magnetization M_S (here we assum ed M $_{\rm S}$, sym bolized by the long white arrow) embedded in an environm ent di ering in its magnetic eld H from the mean magnet eld hH i within the sample due to the uctuation H.Fluctuations of the magnetization in the environm ent are neglected, thus the m agnetization in the environm ent is equal to the m ean magnetization of the sample. This is symbolized by the two shorter white arrows of equal length.

For the mom ent we have to regard H $_{\rm s}$ and $_{\rm s}$ as model param eters. Fortunately we will see later on that the theory delivers a possibility to relate H_s to the coercivity H_c of the sample. An centralpoint of TR is the treatm ent of the graingrain interactions resulting in a collective behavior of adjacent grains. On a macroscopic length scale the internalm agnetic elds and the m agnetization of the sam ple are hom ogeneous. But, if the length scale is reduced to the order of som e grain diam eters the m agnetization becom es coarser and the inhom ogeneities gain in-

uence. A veraging over volum e elem ents containing a few grains only, yields values, which deviate from the average. Thus, we consider every grain as an inclusion embedded in a local environm ent, which m ay di er stochastically in its magnetic eld and magnetization from the related averaged values. W e show this schem atically in Fig. 20. For simplicity we approxim ate the magnetization in the vicinity of the inclusion by the mean magnetization hM i, neglecting the mentioned magnetization uctuations. O therwise we allow for eld uctuations H = HhH i around the mean internal eld in the environm ent of a grain. The mean internal eld is related to the external applied eld H_{ext} according to

Of course the local elds uctuate around the mean internal eld also in direction, thus, strictly speaking eq. (4) accounts for the uctuations of the z-com ponent only. Furtherm ore the deviation of the eld direction from the easy axis gives rise to rotation processes, but this is surely a small e ect in ideally aligned magnets with high anisotropy constants. In the early works on the TR theory a further point was stressed [6, 10, 17]: The eld dependence of the switching eld. This is indeed a crucial point, if one attempts to describe repeating experiments or the virgin curve, but can be neglected in the rst TR experiment, if H_R is large enough to make most of the dow nswitched particles hard, as it seems to be the case in Sm C o5 and barium ferrite. Taking into account this process is in principle not di cult, since it simply scales the SFD of the switched particles. This would introduce at least one additional parameter. We abstained from doing so by restricting the theory to the st TR run only.

3.3 Calculation of the Isothermal Dem agnetization Curve




Figure 21: Generalized scheme of the a TR-Experiment: A fler saturation the sample is demagnetized isothermally by a steady eld to an arbitrary point of the demagnetization curve, indicated by H₁ and M₁. A flerwards the eld is reduced to an arbitrary value H₂. The related magnetization is M₂. Finally the sam ple is heated (TR-Experiment) or cooled (ITR-Experiment) with the external magnetic eld kept constant.

The rst step is the calculation of the dem agnetization curve from the saturated state down to the magnetic eld H $_{\rm ext}^{(1)}$ in the third quadrant. see Fig. 1. To save the opportunity to describe also the in uence of a small steady eld or a non-zero initial rem anence on the TR we use a more general scheme of the TR experim ent as shown in Fig. 21. A fter the saturation all grains are up (") m agnetized. They posses theirm aximum switching elds and hM $i = M_{S}$ holds. If the external eld is low ered to a value $H_{ext}^{(1)}$ (c.f. Here H is the local eld in the environment of the grain. A variation of the external eld H_{ext} results in a change of M i on the one hand and on the other hand it changes the probability f (H)dH that the eld in the environment of a grain is between H and H + dH due to the relation (2) and eq. If the grain is large enough it solves the con ict by an incom plete jump, what turns its single-dom ain

state (SD S) into a multi-dom ain-state (M D S). W e will call such grains \weak". W hereas the \hard" grains can exist in states with M_S only, the magnetization of a weak grain hM i_i is an average over the upwards and dow nwards magnetized volume fractions within the grain. 3.4 Calculation of the Isothermal Recoil Curve

Next, the external eld is changed from H $_{\rm ext}^{\rm (1)}$ to $H_{ext}^{(2)}$ with $H_{ext}^{(2)} > H_{ext}^{(1)}$ via the recoil curve. Som e of the hard \down"-grains are switched back, whereas the weak grains shift their m aqnetization reversible. The related m ean m aqnetization is hM i2. The contribution of the weak grains results from eq. (14), if we insert now H $_{ext}^{(2)}$ for H $_{ext}$ and hM i_2 for hM i resp. followed by an integration from zero to nM s with respect to Hs. The contribution of the hard grains is more di cult to calculate, due to the memory e ect. Let us consider the probability w $_{\#}$ (H $_{\rm s}$) that a hard grain with a given H $_{\rm s}$ was switched by H $_{\rm ext}^{(1)}$ and switched back by $H_{ext}^{(2)}$ afterwards. To calculate this probability it is inevitable to make an assumption on the correlation between the uctuation of the local eld H $_1$ which acts on a grain if H $_{ext}^{(1)}$ is applied and the uctuation of H₂ according to the external eld $H_{ext}^{(2)}$. Of course, if $H_{ext}^{(2)}$ is only slightly di erent from H $_{ext}^{(1)}$ it is unlikely that the neighborhood of a grain changes considerably, so that H $_1$ and H $_2$ should be strongly correlated. 3.5 Calculation of the (Inverse) Therm alR em agnetization

The above calculation of the dem agnetization and the recoil curves was done with the implicit understanding that the magnetization changes isotherm ally at a tem perature T_0 . The actual TR (ITR) occurs if a dc-dem agnetized m agnet is heated (cooled) while $H_{ext}^{(2)}$ is kept constant. Changing the tem perature has two effects. On the one hand the saturation mag-) netization decreases with increasing temperature and on the other hand the switching elds H_s are changed. W hereas the tem perature dependence of the saturation magnetization can be measured easily, it is impossible to measure it for the switching elds. Fortunately, one can solve eq. (14) for H $_{\rm s}$ with H $_{\rm ext}^{(1)}$ = H $_{\rm C}$ and hM i_ = 0 [23]. H $_{\rm C}$ (T) and M $_{\rm S}$ (T) are taken from measurements . 



Figure 22: The TR for dierent levels of approximation. The solid line gives the results of the presented theory. The dot-dashed line results from neglecting the weak grain fraction and for the calculation of the dashed line, both the weak grains and $\mathbf{p}_2^{\mathrm{T}}$, i.e. the probability, that a grain which resisted $H_{ext}^{(1)}$ will be switched while heating at $H_{ext}^{(2)} = 0$, were neglected.

approximation levels. The in uence of weak grains is small as long as the tem perature is below $T_{m ax}$. For T > $T_{m ax}$ the neglect of the weak grains would result in a qualitative di erent behaviour, since we get a sign change of the TR before it nally vanishes, as shown in Fig. 22 in dashed-dotted manner. The reason for that peculiarity is made clear in Fig. 23, where we have plotted the temperature dependence of the probabilities w "", w "#, w #", and $w_{\#}$ regarding the hard grain fraction. It is obvious that at rst w #" increases and when it drops down w "# rises up, thus explaining the sign change. This behaviour is not observed if the probability p_2 , i.e. that a grain which resisted H $_{\rm ext}^{(1)}$ will be switched by H $_{\rm ext}^{(2)}$ is neglected, as it was done in form er theories,

the TR at higher tem peratures it is necessary to take into account, that above T_{max} even the switching elds of the hardest grains are lowered enough to be switched by the still existing stray elds. The latter do not vanish until the magnetization breaks down. It is

In some sense this models the well known avalanche e ects observed during hysteresis measurement, which should also occur to a certain extent if the sample rem agnetizes.

In the early works on the TR a further point was stressed [6, 10, 17]: The eld dependence of switching eld. This is a crucial point, if one attem pts to describe repeating experim ents or the virgin curve, but can be neglected in the rst TR experiment, if H $_{\rm ext}^{(1)}$ is large enough to make most of the down-switched particles

but then an overestimation of the TR occurs, barium ferrite. Taking into account this proas visible in Fig. 22. For the description of cess is in principle not diult, since it simply scales the SFD of the switched particles. This would introduce at least one additional param eter. We abstained from doing so by restricting the theory to the rst TR run only. Taking into account all probabilities and weak grains the model describes the TR dependence on the dem agnetization factor N of the sam ple and the initial tem perature T_0 well, as was shown in Ref. [23] for the TR and in Ref. [29] for the IT R. In the following we concentrate on the investigation of the in uence of internal model param eters.

C om parison to the experim ent 3.7

The limitations of the presented model, i.e. the assumed perfect texture and single phase consistency, are best ful lled in well aligned $Sm Co_5$ - and barium ferrite magnets. There are three unknown parameters of the theory n_{f} and s which have to be determined by adjusting the theory to the experiment. Fig.




Figure 24: C om parison of the best-ts for the $Sm Co_5$ sample from Fig. 8 with H_S (T) calculated self-consistently (solid line) and approximately (broken line) from H_C (T) and M_S (T).

hard, as it seems to be the case in Sm C o_5 and 24 shows the best t results for the Sm C o_5

of H_C and M_S (shown in Fig. 3) was used as input. The best agreement is achieved, if H_S(T) is calculated self-consistently from (18). Although up to the maximum eq. the di erence is negligible the approximated formula fails at higher temperatures where m ost of the grains are weak. Furtherm ore the in uence of the form of the m-dependence of 'f was checked. It com es out that the initial slope is a little bit increased and the maximum becomes a little bit lower and broader if the function f (m) is chosen wider. Unfortunately these changes are to less in comparison with the inaccuracies of the present experimental data that a de nite decision can not be made.




Figure 25: Calculated TR between T_0 and two reference temperatures T_{ref} in dependence on a small steady eld applied while heating (solid lines). The circles and squares are experimental points taken from Fig. 8.




Figure 26: Calculation of the in unnee of a small external eld variation. Solid line: Bestt TR curve for the same sample as in Fig. 8. Dotted Line: Calculation for $_{0}H_{ext} = 5m T$. Broken Line: Calculation for a for $_{0}H_{ext} = 10m T$.





Figure 27: Comparison of the calculated (solid line) and measured (diamonds) dependence of the ITR in barium ferrite on a small steady eld applied while cooling from 300 K down to 5 K.

For sm all internal dem agnetization factors, ie. for elongated grains, the TR is small, whereas e ects up to 100 % are possible for plateletshaped grains. This corresponds well with the simulation results of Ref. [33]. The shift of the TR peak to higher tem peratures as well as the sharpening with decreasing uctuation width can be understood easily from the fact that the switching eld of a volume fraction with given H_s has to be reduced more by temperature before it contributes to the TR. Taking into account the di erent tem perature dependence of H $_{\rm C}$ the sam e m ay be said for the IT R in barium ferrite, as seen in Fig. 29.

4 D iscussion

Sum marizing the experimental facts we nd that TR or ITR is observed in all technical relevant perm anent m agnetic m aterials. 


Figure 28: Calculation of the in uence of $_{\rm f}$ and n on the TR. The other parameters are the best-t values from Tab. 2

Regarding the data tting we learned 22 that both weak grains and from Fig. down-switching of hard grains for higher tem peratures has to be taken into account. This increased the computational e ort considerably, due to the self-consistency requirements for H $_{\rm s}\,(\!T\,)$ and hM i. The model parameters determ ined from the tting procedure have to be considered as estimates. To increase their reliability improvements of both the theory, as outlined above, and the experim ental data are necessary. Regarding the experiment, both labor experience and the presented theory show that the most critical point in a TR experim ent is the sam ple dem agnetization factor. Of course, a closed circuit measurement would be highly desirable, as was shown in the very rst reported TR experiment. This is hard to realize, especially for high-coercive samples and at low tem peratures. Therefore rotational ellipsoidal samples with the symmetry axis along the texture axis should be used to secure feedback of the neighborhood onto the grain, the hom ogeneity of the mean internal eld. A second point is a very accurate m easurem ent of H_{C} (T) and M_{S} (T). For the theory of the TR and ITR it was inquestionable. Thus, the presented theory may evitable to develop a theory for the hysteresis and the recoil curves also. W hereas there exist a multitude of m icro-m agnetic calculations trying to explain the coercivity by assuming special m icro-structures which give rise to eitherpinning of dom ain walls or nucleation, our theory starts a little above this level, since we do not judge about the reason for a switching eld, but simply accept its existence. In this point the theory resembles the Preisach [36] model (PM). A theory of the TR based on the classical model is not able to explain TR e ects ofm ore than 50% . Furtherm ore this model was shown to have the congruency and wiping-out property [37], which is a severe disadvantage, since in most of the interesting cases the measured magnetization behavior violates these conditions. The main disadvantage of the classical P reisach m odel is due to the fact that the P reisach distribution function is not dependent on the magnetization state [36, 38]. To describeTR e ects up to 100% it was necessary to take into account m any-particle e ects, i.e. the which result in a dependence of the form of the uctuation eld distribution on the magnetization state [10]. As shown above the TR model was further completed step by step by taking into account the contribution of multi-dom ain particles and by the inclusion approximation.

also by taking into account a mean eld shift [39, 40] in the moving PM (MPM). Although at rst glance the "moving term " H + khM i looks very similar, it describes a rigid mean eld shift which is the same for all magnetic units. Contrary, the "inclusion correction" Η n (M_S hM i)) describes the deviation of the grain magnetization from the magnetization of its neighborhood. To take reversible processes into account the MPM was modied another time by allowing non-rectangular elementary hysteresis loops [41] of the magnetic units, or by splitting the Preisach density function, as it was done in [42, 43] (GPM). The common drawback of all the mentioned P reisach m odels is the neglect of the state and history dependence of the form of the interacting eld distribution. This had been shown already by one of the st computer simulations [44], and also by experiments [45]. The variable variance Preisach model accounts partly for that observation [46]. If the improvements of the various mentioned Preisach models would be mounted together, it may be probably possible to describe the TR in perm anent m agnets also on that basis, if reasonable assumptions regarding the tem perature dependence of the model parameters are added. A rst step in this direction was done in Ref. [47].

In conclusion it can be said that the investigation of the TR and ITR may be used to characterize modern permanent magnet materials. In connection with the presented model it provides an alternative tool for studying interaction e ects in relation to the temperature dependence of the saturation magnetization and switching eld distribution.
