Role of interference in M M -wave driven DC transport in two dimensional electron gas

In this paper we point out that in addition to the density of states e ect proposed in R ef.[3, 4] one should consider the e ect of constructive interference between the multi-M M -wave-photon processes shown in Fig.2. This process enhances the dark value of the conductivity. W hen the sample is very pure, i.e., when the transport life time is very long, this interference e ect quickly dim in ishes as the M M -wave frequency deviates from the cyclotron frequency. In this paper we also present the linear response theory in the presence of strong harm onic time-dependent perturbation.

The recent observation of strong suppression of the longitudinal resistivity of a two-dimensional electron gas (2DEG) by a millimeter (MM) radiation source [1,2] has stimulated considerable interests in the condensed matter community β , 4, 5, 6, 7, 8, 9, 10, 11, 12]. In Ref. β] and Ref.[4] it is pointed out that the combined e ect of photo-excitation by the MM wave photon and scattering by in purities can lead to a sinusoidalm odulation of the conductivity as a function of $!_0=!_c$ (the MM wave photon frequency). When the amplitude of this modulation becomes big, the conductivity becomes negative and the system become unstable. In Ref.[4] and Ref.[5] it is postulated that this leads the system to self-organize into a state with zero conductivity ity.

In this work we propose another mechanism that may also be of importance for the observed phenomenon. In essence our mechanism associate the above experimental results with a phenomenon called \electrom agnetically induced transparency" [13]. This phenomenon occurs when an optical transition can take place through many alternative processes. When these processes destructively interfere with one another, the net optical transition amplitude vanishes. This has been observed when two of the levels of a three-level system is resonantly coupled together by a strong coupling laser. As a consequence, the resonant peak due to the absorption from the third level to one of these strongly mixed states is suppressed to zero.




FIG. 1: The processes in this gure and their particle-hole inversion analog causes interference discussed in the text. The vertical lines represent absorption or em ission of the coupling eld photons. The slanted horizontal arrows correspond to the absorption of the probing eld photon.

In the present case we assume that the M M wave is su ciently strong to couple many electronic states together. W hen an additional low frequency probing source is turned on, the transition that involves the absorption/em ission of a single probing photon can occur via many virtual processes with varying number of M M wave photons absorbed and subsequently em itted. The interference between these processes can lead to electrom agnetically induced transparency. The e ect is illustrated in Fig.1 where the vertical arrows indicate the em ission/absorption of the M M wave photons, and the slanted horizontal arrows indicate the absorption of the probing photons. If the matrix elements associated with the slanted horizontal arrows at di erent vertical levels

are in phase, this leads to constructive interference. O therw ise destructive interference will be resulted. In the D C lim it (vanishing probing photon frequency) destructive interference in plies a strong suppression of the longitudinal conductivity. This is equivalent to a suppression of the longitudinal resistivity when $x_y >> x_x$. In the following we shall argue that the ratio between the M M wave frequency and the cyclotron frequency determines whether the interference is constructive or destructive.

Our picture of this $!_0 = !_c$ dependence is the following. W hen $!_0$ is an integral multiple of $!_c$, the MM wave couples together states that have (essentially) the same quiding center orbit but di erent Landau level indices. Due to energy conservation we argue that the absorption/emission of a (low frequency) probing photon can only change the guiding center orbits not the Landau level index. More explicitly we assume that, with the initial and nalquiding center orbits of the processes depicted in Fig.1 being all the same, the matrix elements corresponding to the slanted horizontal arrows are approximately equal. The processes shown in Fig.1 tend therefore to interfere constructively. However, when $!_0$ is not close to an integer multiple of ! c, the initial and nal guiding center orbits of the di erent slanted horizontal arrows are di erent. This will generally give rise to matrix elements with di erent phases and lead to destructive interference.

The mechanism discussed here (like in [3, 4]) the electron-electron interaction does not play a central role. However it is important to keep in m ind that electronelectron interaction a ects the self-consistent potential each electron sees hence a ect the eigenstates ji > inEq. (1). In particular in the mechanism proposed in Ref.[5] where signi cant redistribution of charges can be resulted by the action of the MM wave radiation, the steady-state self-consistent potential can di er signi – cantly from that in the absence of MM wave radiation. In the rest of the paper we shall ignore the electron-electron interaction with the understanding that the potential the electrons see is the steady-state self-consistent one.

In the following we rst develop the form alism for describing this problem. We obtain a Kubo-like form ula (Eq. (29)) that allows one to compute the AC/DC conductivity in the presence of a strong harmonic timedependent driving eld. We would like to stress that method developed here is not restricted to the speci c problem considered. Rather it is a general form ulation of linear response in the presence of a strong timedependent perturbation, and in this respect it is a step in the direction of making a system atic approach to describing the behavior of a many-particle system in a presence of a strong oscillating eld.

W e em phasize that the mechanism described here is requires the assumption that M M wave eld acts coherently on the system. It is of interest to look for experimental tests of the importance of coherence. We suggest that application of two radiation sources to the same sample (see the concluding paragraph) is a good way to determine how important the interference e ects are.

In the rest of the paper we shall use the term coupling eld to denote the M M radiation eld, and probing eld to denote the low frequency eld associated the linear response m easurem ent.

I. THE GENERAL FORMALISM

A. The Floquet eigenvalue problem

To gain some intuitive feeling for what Eq. (9) represents we consider the following model. For each n in Eq. (9) we de ne a replica of the physical system with eigenspectrum given by Eq. (1). These replicas are coupled together by P_{ij} in the following H am iltonian

In the above c_{ni}^{+} create an electron in the ith states of the nth replica. The physical interpretation of the n variable

is the photon number of the coupling eld. The single particle states in the nth layer are fp;i>g, and the associated eigen energies are $_i$. The replicas are coupled together by hopping (the term s proportional to g_c), and an \electric eld" is turned on so that the potential energy of the nth replica is $n!_0$. The replica model is constructed so that Eq. (9) is its time-independent eigen equation. Each solution $_{ni}$ of Eq. (9) uniquely de nes an eigen state

of the replica m odel. Eq. (11) and Eq. (12) link a whole fam ily of replica states together.

B. The linear response theory

In this section we derive the form ula for the AC conductivity in the presence of the coupling eld. The form alism developed in this section is rather general. The only restriction is that the electron-electron interaction is neglected.

The AC conductivity is the response of the system to a time-dependent probing eld. The Ham iltonian in the presence of such probing eld is given by

where D_{ij} is the current matrix element coupling to the probing eld. Unlike the coupling eld, the probing eld is very weak. Therefore we will treat its e ect perturbatively to the lower order in g_p .

where $f_i = f(i)$ is the Ferm i function and is the volume (or area for 2D) of the sample.

In the limit of ! 0 only the diagonal terms in the expansion of j::: j in Eq. (27) survive. In that case E E $!_p$ is constrained to zero. For nite on the other hand E E is not strictly xed by energy conservation, but can take value within a range around $!_p$. In this case A and E do not only get contributions from the diagonal terms in the expansion of (27) but also from crossing terms. W hen the phase coherence length ism uch sm aller than the sam ple dimension, the above form ula should also be averaged over the con gurations of the random potential.

Eq. (27), Eq. (28) and Eq. (29), which express the linear response coe cients of a strongly driven system in terms of the eigenenergies and eigenfunctions of a time-independent H am iltonian (H $_{\rm r}$ in Eq. (21)), is a main result of this paper.

C. A sim ple m odel

In order to illustrate the application of the above form alism we now consider a simple model where the dark" energy levels are labeled by two parameters, i = (;a), and the energies are given by

contributions from higher levels + n are introduced, as illustrated by the vertical arrows in the diagram and by the sum over n in the formula.

The variations of D_{ab}^{+n} with n may give rise to term s in Eq. (39) that adds constructively or destructively. If we assume no dependence on n, $D_{ab}^{+n} = D_{ab}$, the sum over n can be explicitly done giving rise to N $_{p}$, hence p only gets contribution from p = 0 and the expression reduces to its "dark value", i.e. its value without the coupling eld

where K; c_1 ; c_2 ; c_3 are n-independent constants. From Eq. (42) we see that the suppression by large N depends on << . It is important to note that in the simple m odel considered here the suppression of the DC/AC conductivity is complete only when N ! 1 and = ! 0.

In the model we have introduced several simpli cations, in particular only including resonant couplings. However, we believe this model convey the essence of our idea. We note how ever, that with the simpli cations introduced we do not see enhancement of the amplitudes for constructive interference, but rather a return to the dark value.

II. APPLICATION TO THE 2-D IM ENSIONAL ELECTRON GAS.

W hen discussing the application of the general form alism to the 2DEG, there are two regimes of interest to discuss separately. The rst one is the weak coupling limit, where the F loquet state is well localized with respect to layer index n and where the coupling eld as well, as the probing eld, can be treated perturbatively. The other case is the strong coupling regime, where the state is extended through many n's. We rst treat the weak coupling case and discuss this in a generalway with focus especially on the e ect of the density of states. The strong coupling case we discuss more qualitatively, with speci c reference to the simple model discussed in the previous section.

A. W eak coupling. The density of states e ect.

In this lim it the eigenstates of H $_{\rm r}$ are qualitatively sim – ilar to those in the absence of the hopping between the replica's. In this lim it the our calculation produces result sim ilar that obtained in Ref.[3] and Ref.[5]. For a com – parison with these references we restrict ourself to the case of total coherence, i.e. ! 0.

B. Strong coupling. Constructive and destructive interference.

W hen the coupling constant g_c in Eq. (2) is large, the eigenstates of Eq. (21) become extended among many replicas, i.e. _{ni} is non-zero for a very wide range of n. For the electrons in the magnetic eld this means that the M M eld couples together many states, generally bcated at di erent guiding center orbits. The states coupled together will be selected by the condition of having the energy di erence in resonance (or close to resonance) with the oscillating eld.

The dipole matrix element of the coupling laser prim arily couples states at neighboring Landau levels and the same guiding center orbit, or close by guiding center orbits in the sam e Landau level. How ever, the observed e ect, with strong variations in the conductivity when the frequency of the coupling eld matches integer multiples of the cyclotron frequency, indicates a rather strong coupling also between non-adjacent Landau levels. Such coupling clearly requires Landau levelm ixing. Thism ixing m ay be due to the presence of a dilute concentration of strong and localized scatterers and/or high gradients in the potential at the sam ple edge. In this picture the electrons mainly drift adiabatically in a sm ooth background potential, but occasionally encounter regions of high potential gradients where the Landau levels is mixed. Due to the dilute concentration of such regions, the e ect on

e.g. the density of state can be very small. However for a strong coupling eld this is enough to generate su cient coupling to distant Landau levels/distant guiding center orbits that is required to delocalize the F loquet eigenstates am ong m any replicas. For the the transitions induced by the probing eld this m ixing is less in portant, since the low frequency transitions are limited to close by orbits in the same Landau level.

Let us rst consider the case where the coupling source is tuned to one of the frequencies m $!_c$, with integer m. The matrix elements D_{ij} of the probing eld in the sum of Eq. (28) now are dened between the same pair of guiding center orbits elevated to higher Landau levels by the coupling eld. The model of the previous section can be viewed as giving a simplied description of this situation, with the "vertical" index identied with the Landau level index and the "horizontal" index a labelling the guiding center orbit.

The matrix elements D $_{ab}$ now describe transitions between the same two guiding center orbits a and batdi erent Landau levels . These matrix elements are strongly correlated and we have checked that in an adiabatic approach they are only slowly dependent on the Landau level index .

As previously discussed, with D_{ab} independent of , the sum over n in Eq. (39) will include terms that interfere constructively. A lthough one should note that in the expression found there was no enhancement relative to the dark value. Such an enhancem ent is clearly present in the observed e ect. We believe such an enhancement is due to an increase in the magnitude of D_{ab} with and/or to the e ect of including non-resonant term sboth of which are ignored in our simple model.

Let us next turn to the case where the coupling frequency is not close to $n!_c$. In this case di erent j ;a > and j + 1;a > label two distant guiding center orbits with the potential energy of the second orbit $!_0$ higher than that of the rst.

Since the matrix element D $_{ab}$, for dierent , refers to transitions between distant pairs of guiding center orbits, they are no longer strongly correlated and may change substantially from one value of to the next. In an adiabatic approximation the matrix element can be related to variations in the drift velocity along the guiding center orbit, and in a random ly varying background potential we therefore expect a corresponding random variation in the matrix element. In this case the n sum in Eq. (39) add destructively.

To recap, the di erence between the case $!_0 = m !_c$ and $!_0 \in m !_c$ lies in the fact that for the form er the n sum in the absorption/em ission amplitude tend to add non-destructively, whereas for the latter the sum tend to add destructively. Thus, we propose that in addition to the density of state m echanism discussed in Ref.[3, 4], and seen in our discussion of the weak coupling lim it, the above interference m echanism will contribute, for $!_0$ between integer multiples of $!_c$, to suppress the m agnitude of the longitudinal resistivity. This can reduce the

resistivity or even suppress it to zero when the e ect is very strong. However, since our discussion at this point is qualitative, we cannot estim ate the real strength of the e ect.

III. SUMMARY

In this paper we present a general form alism for describing the DC/AC transport in the presence of an oscillating coupling eld. The oscillating eld couples together states in the form of a F loquet state, and by use of the expression for this state we derive a general form for the absorption and em ission probabilities of an additional low frequency probing eld. This gives a generalized K ubo formula for the conductivity in the presence of an oscillating eld.

W e further discuss in a general way the application of this to the 2D electron gas in a magnetic eld radiated by a M M wave. For a weak coupling eld we show the presence of oscillations due to variations in the density of states. For strong coupling we discuss in a qualitative way the di erence between constructive interference when the frequency matches the energy di erence between two Landau levels and destructive interference for interm ediate values of the frequency. The discussion of the interference e ects is illustrated by a simplied m odel.

Quantum interference between di erent virtual pro-

cesses described in this paper should in general exist. However, complete destructive interference requires a large number of interfering processes and small decoherence. We are currently uncertain about the values of these parameters for the experimental system. The mechanism presented here raises the question of whether an independent study of the strength of coherence e ects can be perform ed. C learly, if the coherent M M source is replaced by an incoherent source at the same frequency the coherence e ects will be destroyed. As a simpler experim ent we suggest that the importance of coherence for the observed e ect can be studied by use of two independent coupling elds. If one of these is tuned to one of the peak values (say 2! c) and the other to a suppressed value (say, around $\frac{1}{2}!_{c}$), we predict that the e ect of the second source will be to suppress the peak of the rst source, even to destroy the peak com pletely if the coherent e ect is su ciently strong.
