Coulom b Blockade Regime of a Single-Wall Nanotube

Abstract

We study a model of carbon nanotube with a half led conduction band. At this lling the system is the Mott insulator. The Coulomb interaction is assumed to be unscreened. It is shown that this allows to develop the adiabatic approximation which leads to considerable simplications in calculations of the excitation spectrum. We give a detailed analysis of the spectrum and the phase diagram at half lling, and discuss elects of small doping. In the latter case several phases develop strong superconducting uctuations corresponding to various types of pairing.

I. INTRODUCTION

Carbon nanotubes have attracted an enorm ous amount of attention and generated an immense level of theoretical and experimental activity. It has been rightly pointed out that single-wall carbon nanotubes (SWCN) represent ideal one-dimensional systems and one may expect to observe here exotic phenomena characteristic for strong correlations in one dimension. Most of the attention has been concentrated on a possibility of Tomonaga-Luttinger liquid. Though such liquid is certainly a very interesting object, it is just one of many wonders strong correlations can produce.

In this paper we concentrate on the physics of an arm chair SW CN at half lling. The features which dom inate this physics are the unscreened Coulom b interaction and Um klapp processes. The importance of the unscreened Coulomb interaction for nanotubes away from half lling was already noticed in the previous studies [1], [2]. At half lling some additional factors com e into play. It was realized in [3] that the long-range C ou lomb interaction makes the operators responsible for the U m klapp scattering term s relevant. Consequently, the gaps for collective excitations generated by such operators are not exponentially small, as it would be away from half lling, but have power-law dependence on the Umklapp scattering matrix elem ents. Such enhancem ent of the gaps increases chances for their experim ental observation. Unfortunately, in their further analysis the authors of [3] resorted to Renorm alization Group (RG) equations, which for systems with many elds do not provide much insight into the properties at the strong-coupling xed point. RG equations also do not take into account the drastic di erence between velocities of the plasm a modes and allother collective excitations. Instead of adding di culties, however, the di erence in velocities leads to considerable simplications in actual calculations (see [4]). In this paper we shall exploit this feature to our advantage and develop an approach based on the adiabatic approximation similar to the one used for the problem of electron-phonon interaction. As a result we will be able to provide a rather detailed inform ation about the spectrum and the phase diagram of the system. As will be shown below, the interplay of the long range Coulomb interaction and Umklapp processes at half lling gives rise to a phase diagram which includes several interesting strongly correlated states. The system has a hidden Z_2 Z_2 Z_2 sym m etry and these phases are conveniently classied as dierent symmetry breaking patterns of this group.

II. THE PROBLEM OF SINGLE-CHANNELW IRE AT HALF FILLING

To warm up, let us rst recall the problem of the unscreened Coulomb interaction for a single chain (or a single channel quantum wire) at half-lling. The charge and spin sectors decouple; the Tom onaga-Luttinger liquid Ham iltonian for the charge sector should be supplemented by the Um klapp term which contains only the charge eld c:

where Ua_0 is the $2k_F$ = Fourier component of the interaction. The full Ham iltonian density for the charge sector is $H = H_0 + V$, where

v being the Ferm i velocity. This model is very close to the sine-Gordon one. The spectrum contains solitons and their bound states (breathers or excitons). To get their spectrum one can just expand the cosine around its minimum and obtain:

where the breather gap is $m_b = (2=)^p \overline{U_F}$; $F = v=a_0$. The breathers are electively optical phonons of the one-dimensional Wigner crystal [5]. The soliton gap is larger; it was estimated in [4], a better estimate is

The spectrum in the spin sector is gapless, and the spin velocity is approximately v. Thus already for a simple one-chain problem, the long-distant C oulomb force brings three important new features: (i) strong upward renormalization of the charge velocity seen in Eq.(3), and (ii) the presence of exciton modes in the charge sector, (iii) power law dependence of the mass scales M $_{\rm S}$; m $_{\rm D}$ on the U m klapp matrix element U .

III. THE EXCITATION SPECTRUM OF NANOTUBE AT HALF FILLING




FIG. 1: The B ravais lattice cell (shown in dotted lines) including two inequivalent carbon ions (shown in red and green) and the B rillouin zone for graphite. e_1 and e_2 are basis vectors of the diatom ic unit cell. The positions of the tips of two D irac cones labeled by 1 and 2 are represented by blue and brown dots.

SW CNs are manufactured by wrapping two-dimensional graphite sheets into cylinders (compactication). The electronic spectrum of an in nite graphite sheet contains two D irac

cones with dierent chirality, centered at dierent points of the Brillouin zone (the blue dots on Fig. 1). Under compactication the spectrum is divided into subbands corresponding to dierent quantized values of the transverse momentum. In the so-called arm chair nanotubes $k_y=0$ remains an eigevalue and the spectrum in the lowest subband stays gapless; at half lling it is also doubly degenerate at low energies. This degeneracy is a vestige of the double-cone structure of the two-dimensional dispersion. We discuss the spectrum in some detail in Appendix A; more detailed information can be obtained from the book [6].

In Appendix B we derive the bosonized form of the e ective low-energy Hamiltonian.

The total Hamiltonian density is

where H_0 is given by Eq.(2); $C^{(+)}$ is the sym metric charge mode. The label a takes three values, a = (c;); (s; +); (s;), corresponding to the antisym metric charge eld and sym -

m etric and antisymm etric spin elds, respectively (see Appendix A). The interaction density V contains Um klapp terms

where the dots stand for all other term sthat do not involve $^{(+)}_{C}$ and stay m arginal even in the presence of the unscreened C oulomb intreaction. The couplings g_c , g_1 and g_3 are determined by the lattice H am iltonian. In Appendix B we estimate them for realistic carbon nanotubes, where, as it turns out, $g_c = g_1$ and, hence, there are only two independent coupling constants. The unscreened C oulomb interaction strongly reduces the scaling dimension of the operator $\cos(\frac{p}{4} - \frac{q}{C})$ in the long-wavelength limit, making it smaller than 1. Thus the Umklapp terms (6) become strongly relevant, with the scaling dimension almost equal to 1. This circum stance dramatically increases the values of the gaps.

One may well expect that the double degeneracy of the electron band in carbon nanotubes makes the problem similar to the problem of two interacting chains (the 'ladder' problem) much discussed in literature. This is indeed the case. To put the problem in a broader context, let us discuss two extreme types of ladders: (i) the ones where two chains are placed far apart such that there is no direct tunneling between them, and (ii) those in which the interchain tunneling is stronger than all the interactions. Ham iltonian (5,6) is formally equivalent to the rst case describing two well separated chains. As a matter of fact, the Ham iltonian for case (ii) is not very dierent. The calculations done in [7] for the ladder with strong interchain tunneling yields the same Ham iltonian as (6), but with c; eld being substituted by its dual counterpart, c;:

Therefore one expects that the two models have the same excitation spectrum though the response functions are dierent due to the dierent eldidentication.

Ham iltonian (6) is not very convenient to analyse in its bosonic form since the elective potential contains mutually nonlocal and noncommuting elds, $_{s}$; and $_{s}$; The physics becomes significantly more transparent when one uses the refermionization procedure [8], [9].

Ferm ionizing all the elds except of $\overset{\text{(+)}}{C}$ we obtain

where $_{\rm R}$; $_{\rm L}$ are M a jorana (real) ferm ions and $_{\rm R}$; $_{\rm L}$ are D irac ferm ions emerging from the ferm ionization of the operator $\cos(\frac{p}{4})$ c;) or, in the second case, $\cos(\frac{q}{4})$ c;). Notice that Eq.(8) is manifestly SU (2)-symmetric. The triplet of M a jorana ferm ions (a = 1;2;3) transform according to the spin S=1 representation of the SU (2) group, whereas the ferm ion labeled by a = 0 is a singlet under the SU (2).

Following [10], we shall handle Ham iltonian (8) using the adiabatic approximation, whose validity is guaranteed by the fact that the velocity in the symmetric charge sector is strongly enhanced by the long-distant Coulomb interaction with respect to the bare Fermi velocity. The results have certain similarity with the SU (4) theory proposed in [11], but also contain important dierences, which we shall discuss.

Thus, from the $^{(+)}_{C}$ -m ode point of view, the other degrees of freedom are static. Integrating over this mode, one obtains an elective potential for the fermions in the form of the ground state energy of the sine-G ordon model. A coording to [12] the energy density is proportional to the square of the breather mass $_{b}$ of such sine-G ordon model and in the regime of small sine-G ordon coupling constant 2 is equal to

where $v_c = v_F (1 + (2e^2 = v_F) \ln (_F = M))^{1-2}$ and $v = v_F$. So as we see, the integration over the fast m ode gives rise to the m ass terms for all of the fermions. The fermionic modes acquire gaps:




FIG. 2: A schematic picture of the excitation spectrum: a) at half lling and b) at small doping.

They correspond to neutral excitations with the quantum numbers given in the table that follows; see also Fig 2. As far as the fast modes are concerned, one has to treat dierently the ones with and without electric charge. The neutral modes do not involve solitons of eld $\binom{(+)}{C}$. One can get a good estimate of their spectrum replacing the term in the square

brackets in expression for the Hamiltonian (8) by a constant and expanding around the minimum of the cosine potential. As a result one gets the same spectrum as for the single chain (3) with

which further supports the adiabatic approximation. However, as we have already mentioned, its validity is already assured by the dierence in the velocities. Apart from the breather modes there are massive modes corresponding to half-period solitons in $^{(+)}_{\rm C}$ with zero modes of the fermions bound to them. These excitations have the largest gap (we call it M $_{\rm e}$) and carry quantum numbers of electron.

The results for the spectrum are summarized in Table 1; see also Fig 2. Excitations are characterized by quantum numbers associated with the full continuous symmetry group of the electron of the electron charge e, total spin S, and \vorticity" V. Let us comment on the latter. While the global U (1) phase invariance and the spin SU (2) symmetry, leading to conservation of the total charge and spin,




FIG. 3: A staggered ux (orbital antiferrom agnet) state corresponding to a nonzero value of vorticity V. The arrows indicate local currents owing across the links of the a (red) and b (green) sublattices.

From this construction it follows that the state with a nonzero $h^i_{p \log_2 a(b)}$ i would represent an orbital antiferrom anet, or a staggered ux phase, realized on the sublattice a(b), as shown in Fig.3. Projecting (13) onto the $k_y = 0$ subband and passing to the continuum $\lim_{b \to a} it$, one makes sure that the sum $\frac{1}{2} \log_2 a + \frac{1}{2} \log_2 b$ does transform to the avor charge density

Previous attempts to study the problem of two coupled channels have mostly relied on the assumption of equal velocities with the subsequent use of RG analysis. The approach was pioneered by Lin et al. [11] who argued that at strong coupling the spectrum of the two-chain problem at half lling acquires a higher symmetry, such as SO (6) or even SO (8). In fact, G ell-M ann-Low equations alone are insu cient to extract inform ation about strong coupling regime (they have to be supplemented by Callan-Symanzik equations for the physical observables) and therefore cannot provide a legitim ate ground for such conclusions. Our approach is based on a di erent assum ption; here the long-range C ou lom b interaction legitim ates a clear separation of scales between single particle excitations and collective modes. This signicantly simplies the calculations providing one with the well-controlled approxim ation. It is instructive to compare the results with those conjectured in [11]. Though the structure of the multiplets is the same as in the SU (4) SO (6) theory, there are important di erences in the spectrum. Two quasiparticle multiplets (particles and antiparticles) are four-fold degenerate, as in the SU (4) theory, but the six-fold degenerate multiplet of the SU (4) is split into a doublet with the mass M $_{\rm Ci}$, a magnetic triplet with the mass M $_{\rm St}$ and a singlet m ode with the mass M $_{S_{15}}$. The ratios of the quasiparticle mass to the masses of the neutral m odes are vastly di erent from the SU (4) G ross-N eveu m odel ratio M $_{\rm S}$ -M $_{\rm e}$ = $^{\rm p}$ $_{\rm e}$ They depend on the Coulomb interaction and the quasiparticle gap is much larger than the spin and the parity collective mode gaps. The gaps of the collective modes are not equal. In nanotubes where there are only two independent coupling constants we expect that

(recall that since we deal with M a jorana ferm ions, the masses may be negative, the spectral gaps being their absolute values).

IV. THE ORDER PARAMETERS OF DIFFERENT PHASES

From now on we shall concentrate on the model describing carbon nanotubes. Dierent phases, shown in Fig. 3, correspond to dierent ground state phase lockings and are determined by the signs of the fermionic masses[8], Eqs.(10). These sign changes are not rejected in the thermodynamics which is sensitive only to absolute values of the masses. The dierence in the correlation functions may, however, be quite dramatic.

We use the following conventions [8]:

where f $_{i}g$ and f $_{i}g$ (i = 1;2;3;0) are order and disorder parameters of the 2D Ising models associated with the singlet (i = 1;2;3) and triplet (i = 0) M a jorana ferm ions. A particular Ising model is ordered (h i \in 0) or disordered (h i \in 0) depending on the sign of the corresponding M a jorana mass, M < 0 or M > 0. In order to understand the structure and properties of the correlation functions, one has to recall that in the ordered phase of the Ising model, where h i \in 0, the correlation function hh (!;q) (!; q)ii contains a coherent peak, while the correlation function of the 's does not.

There are six possible phases, two of them being Haldane spin liquids. Such liquids are characterized by the presence of a coherent triplet magnetic excitation (magnon) in the two-point correlation function of the staggered magnetizations. In non-Haldane disordered phases, the spectrum of triplet excitations is incoherent; however spin-singlet modes may be coherent. Table 2 and Fig. 3 show what operators acquire nonzero expectation values in the corresponding ground states. It will be assumed that in all phases the symmetric charge eld is locked at $\binom{+}{C} = 0$, so that hops $\binom{p-}{C}$ if $\binom{+}{C}$ if $\binom{+}$




FIG. 4: The phase diagram. For each quadrant it is indicated which Ising models order and disorder parameters have non-zero ground state expectation values. The phases are separated by critical lines on which one of the particle masses vanishes. The green and red lines are Z_2 and SU_2 (2) critical lines respectively. The $g_1=0$ axis corresponds to the U (1) critical line. Phases A and D have density wave order. Under doping phases B, E and C,F develop a power law response to superconducting paring.

Below we give a brief characterization of each phase; for more details see the subsequent discussion.

Phase $A:g>jg_3j$. This phase has a long-range B ond D ensity W ave (BDW) order at T=0 (see Fig. 4 below).

Phase $B:0 < g < g_3$. This is a Haldane spin-liquid phase whose excitation spectrum contains a coherent triplet m agnon with the mass M $_{S,t}$, associated with the correlation function of the site-diagonal spin operator $S^{()}$; see Eq. (24). Under doping it develops a power-law response of the pairing susceptibility of type described further in the text. The corresponding superconducting order parameter transforms non-trivially under the lattice point group.

Non-Haldane phase $C: g < g_1 < 0$. The magnetic singlet mode with mass M $_{S,s}$ becomes coherent in this phase. As a result a coherent peak appears in the correlation function of the Charge Density Wave order parameter $_{CDW}$, Eq. (18). Under doping this phase develops superconducting correlations in the s-channel.

Phase D: g < jgj. There is a Charge Density W ave (CDW) long-range order in the ground state of this phase. Phases CDW and BDW are mutually dual.

Phase $E:g < g_1 < 0$. This is another Haldane phase dual to phase B. Phase E has a coherent magnon in the site-o-diagonal spin density (), Eq.(25). Under doping it develops superconducting correlations of the same type as phase B.

Phase F:0< g< g. This phase is dual to phase C and has a coherent spin-singlet mode displayed by the BDW order-parameter correlation function. Under doping it develops superconducting correlations in the s-channel.




FIG. 5: The dim erization in BDW phase

CDW. A lready for geom etrical reasons (the lattice is bipartite) one may expect that the system at half lling can develop a commensurate Charge Density Wave. Introducing locally averaged electron densities for a and b sublattices,

we de ne the CDW order param eter (OP) as follows:

This OP has a non-zero average value in phase D. In phase C where hsin $\binom{p-\binom{p}{2}}{1}$ if 0 and h $_a$ if 0 (a = 1,2,3), the most singular part of the CDW order parameter is proportional to $_0$. Since we are in the phase with h $_0$ if 0, operator $_0$ has a non-zero matrix element between the ground state and a state with one M a jorana fermion. Therefore the correlation function of CDW OPs contains a coherent peak corresponding to an emission of the singlet magnetic mode with the mass M $_{S,s}$.

BDW. The Bond Density W ave order parameter is similar to the CDW one, but is o -diagonal in the site indices:

This phase is dual to the CDW one. The BDW order parameter condenses in phase A. The dimerization ordering pattern in this phase is shown in Fig. 4. In the disordered phase F (which is dual to phase C), the spectral weight of the OP $_{\rm BDW}$ contains a coherent magnetic singlet mode with the mass M $_{\rm S,s}$.

Notice that the CDW and BDW OPs do not contain any oscillatory pieces. These show up in the density distributions that are not uniform across a sublattice but otherwise are consistent with the uniaxial symmetry of the nanotube:

Two incommensurate CDW OPs can then be constructed as follows:




FIG. 6: The charge distribution for the m CDW order.

The charge distribution corresponding to the OP $_{\text{mCDW}}^{(\)}$ is depicted on Fig. 6. This kind of order can be induced by applying a modulated potential of su cient strength that couples to $_{\text{mCDW}}$. The potential must be strong enough to overcome the energy gaps of the corresponding excitation branches and to drive the system into a state with an induced order of the mCDW type.

The OP $S^{()}$ (r) is coherent in the Haldane spin-liquid phase B, the corresponding particle representing a massive triplet magnon. Notice that in the expression (24) the vector eld N plays the role of the staggered magnetization of the elective antiferrom agnetic spin-1 chain [8].

The structure of (25) indicates that phase E represents a Haldane spin liquid and is dual to phase B. Indeed, in phase E it is the vector eld N that can be regarded as the staggered magnetization of the elective S=1 chain, and, hence, the spectral weight of the operator contains in this phase a coherent triplet magnon.

Pairing operators. Let us construct the s-wave superconducting (SC) order parameter $_{\rm SSC}$. To this end, we set build locally averaged, site-diagonal, singlet pairing operators:

The amplitude of this OP acquires a nite value in non-Haldane phases C and F. These two phases, with coherent singlet magnetic modes in their spectrum at half-lling, exhibit power-law sSC correlations under doping.

The swave type superconductivity is not the only possible singlet SC order one can imagine. One can introduce SC order parameter which transforms non-trivially under the point group:

where the avor ferm ion is associated with $\binom{0}{C}$ eld. Therefore there is an interesting possibility to drive a system into a peculiar critical state with a mixture of the magnetic singlet and nonmagnetic orbital mode by applying a magnetic eld with the corresponding period.

V. SMALL DOPING

The large velocity di erence between the sym m etric charge m odes and the other part of the spectrum holds a key to the stability of the approach at nite doping. For small doping k_F a exp (v=2 \mathring{e}) the soliton m ode of $^{(+)}_{C}$ eld, though becoming gapless, still lies above the others in the most of the momentum space (see Fig. 2b). This means that one can still integrate over $^{(+)}_{C}$ and obtain Eq.(9) though with a prefactor < 1. Thus a small doping

will decrease the gaps. It may also give rise to nite decay rates for the collective modes. This is a pseudogap regime which is perhaps similar to the one existing in the underdoped state of the cuprate superconductors (see, for example, the recent paper [13]). The physics of this regime will be governed by two energy scales: the scale of collective modes M $_{\rm c}$ (see Eq.(10) and the electronic scale M $_{\rm e}$. At energies smaller than M $_{\rm c}$ the system is a Luttinger liquid, at M $_{\rm c}$ < E < M $_{\rm e}$ the collective modes contribute to all physical properties giving rise to strong enhancement of the magnetic susceptibility and special heat. Above M $_{\rm e}$ the ects of backscattering disappear.

Let us brie y discuss a possible enhancement of the superconducting uctuations in a doped regime. In those phases where the amplitude of the SC order parameter is frozen (see the discussion above) its power law correlations are determined by the scaling dimension of operator $\exp[i^{D}]$. This scaling dimension is equal to $1=4K_{C}$ where K_{C} is the renormalized Luttinger constant. At large doping the value of this constant is determined by the long-distant C oulomb interaction and is small, but close to the transition (small doping) it is close to one (see [14] for a more detailed analysis). Therefore there is a window of doping where $K_{C} < 1=2$ where the pairing susceptibility diverges. A more detailed description of the pseudogap regime will be given elsewhere.

VI. CONCLUSION

Let us sum marize our results. We have analyzed the elect of the long-range Coulomb interaction on the low-energy properties of the arm chain nanotube. We have shown that the spectrum of the system is very rich. The phase diagram includes six phases diering from each other by their response functions. Under doping four of them have enchanced superconducting uctuations.

SW CNs exhibit two types of behavior: either band insulators or Luttinger liquids. A rm - chair CNs are believed to be metallic and be of the Tom onaga-Luttinger (TLL) type. This, in fact, is only true away from 1/2 lling. As shown in this paper, the picture changes dramatically at 1/2 lling when e ects of strong correlations become crucial. To observe these e ects in experimental conditions, the chemical potential must be ne tuned to the value = 0 at which the Ferm i \surface" is represented by two degeneracy (Dirac) points. Then, due to the special role of Umklapp processes in the presence of unscreen Coulomb interac-

tion, on lowering the tem perature, one must be able to see a crossover from the metallic, TLL behavior to an insulator discussed in the paper. Such insulating state is Mott-type, with a much richer spectrum than in the Hubbard model. One important dierence is that, unlike in the Hubbard model, the spin excitations have spectral gaps.

The estimates of interaction matrix elements for carbon nanotubes are provided in 31:

where N is the number of transverse bands of the nanotube and 1:4 is the dielectric constant. This estimates indicate that realistic nanotubes belong to phase B.Eq.(10) also gives the following estimates for the spectral gaps of the collective modes:

Since is the short distance cut-o of the bosonic theory and is therefore non universal, this formula contains a certain degree of am biguity. For noninteracting electrons $= a_0$ (the lattice spacing). Taking N = 10, $v=v_c = 1=3$ and $a_0 = 0.246$ nm we get the estimate of order of 0.1 ev. The single particle gaps should be even greater.

Since the gaps should be quite sizeable, one may wonder whether they have not been already observed. The existing techniques produce simultaneously carbon nanotubes of different sizes and chiralities and one has to select the relevant ones using some criteria. The simplest one is to dier between metallic and insulating (sem iconductor) nanotubes. Naturally, on the rst glance M ott and band insulators look alike. Therefore it is possible that the M ott insulating arm chair nanotubes have been overlooked being taken for sem iconducting ones. To distinguish M ott insulator from a band one one has to measure transport and magnetic properties and compare the gaps. The clearest sign of 'm ottness' is the dierence in gap sizes in dierent response functions. This is the feature to look for experimentally.

When a two-dimensional sheet of graphite is wrapped to produce an arm chair nanotube, k_y gets quantized, and the lowest-energy subband correspoding to $k_y=0$ stays gapless. The structure of these transform ations rejects the fact that different D irac points, $k_x = Q$ and $k_x = Q$, are not associated with fermions of different chiralities, as it is the case for standard chains and ladders; instead each of these points is characterized by a pair of right (R_j) and left (L_j) elds. This is because the gapless spectrum of the arm chair nanotube keeps the memory of the two-cone D irac structure of the dispersion law in the 2D graphite (in fact, the 1D spectrum is obtained from the 2D one by cutting the two cones by the plane $k_y = 0$). For this reason, in case of nanotubes, smooth components of the physical elds are contributed not only by the diagonal \currents", $R_j^y R_j$ and $L_j^y L_j$, but also by o -diagonal \mass bilinears", $R_j^y L_j$ and $L_j^y R_j$.
