We present electron spin resonance data of Ti^{3+} (3d¹) ions in single crystals of the novel layered quantum spin magnet Ti0CL. The analysis of the greensory ields direct evidence that the d_{xy} orbital from the t_{2g} set is predom inantly occupied and owing to the occurrence of orbital order a linear spin chain forms along the crystallographic baxis. This result corroborates recent theoretical LDA+U calculations of the band structure. The temperature dependence of the parameters of the resonance signal suggests a strong coupling between spin and lattice degrees of freedom and gives evidence for a transition to a norm agnetic ground state at 67 K.




FIG. 1: (a) C rystal structure of T iO C l; (b) sketch of the t_{2g} orbitals (, and) in the [T iO_4 C l_1] octahedron. The local coordinate fram e fxyzg is chosen so that zka axis, and the x and y axes are rotated by 45 w ith respect to the c and b axes, respectively. Note that in the LDA+U calculation of Seidelet al. 10 one-dimensional bands are formed from overlapping xy, yz, and xz orbitals, respectively, whereas on a single cluster level the = xy, = (xz+yz)= $\frac{1}{2}$ and = (xz yz)= $\frac{1}{2}$ states are the eigenstate orbitals, respectively.

Transition metal (TM) oxides with low-dimensional structural elem ents provide a fascinating 'playground' to study novelphenom ena such as high-tem perature superconductivity, spin-charge separation, spin-gap states and quantum disorder^{1,2,3}. Until recently, the emphasis has been put on Cu-based oxides, where a Cu²⁺ (3d⁹) ion has a single hole in the e_{α} orbitals with spin S = 1=2, and its orbitalm om entum is alm ost com pletely quenched by the crystal eld. The ions at the beginning of the TM elem ents row , like T i^{3+} and V $^{4+}$, have, in contrast, a single d-electron which occupies one of the t2g orbitals. Because these orbitals are much less Jahn-Teller active, their near degeneracy m ay yield m ore complicated physics, involving not only the spin and charge, but also the orbital sector⁴. As an example, the three-dimensional cubic perovskite LaTiO3 has been proposed to realize a quantum orbital liquid^{5,6}. However recent x-ray and neutron structural data suggest the ordering of the orbitals⁷. The structural dim ensionality is reduced in TiOCl, where [T iO $_4$ C $_2$] octahedra are arranged in bilayers separated from each other along the caxis (Fig. 1a). In fact, for quite a while this compound has been considered as a 2D antiferrom agnet, an electron analog to the high-Tc cuprates⁹, ow ing to an alm ost T-independent magnetic susceptibility reported in Ref. 8. However, very recently TiOCl has emerged in an entirely new light as a 1D antiferrom agnet¹⁰ and is proposed as the second example of an inorganic spin-Peierls compound after CuGeO₃¹¹. LDA+U band-structure calculations¹⁰ suggest ordering of the t_{2q} orbitals in TiOClwhich produces quasi-1D antiferrom agnetic (AF) S = 1=2 chains. This calculation favors the occupancy of the d_{xy} orbitals (Fig. 1b) which form a uniform chain along the baxis. A transition to a non-magnetic state at $T_c = 67 \text{ K}$ has been observed in the static magnetization 10. Remarkably, NMR data reveal the pre-existing pseudo spin-gap already above Tc which is ascribed to strong orbital uctuations¹².

In this paper we present electron spin resonance (ESR) data of Ti^{3+} (3d¹) in single crystals of TiOCL By measuring the anisotropy of the g factor and comparing it with our theoretical estimates in the framework of the

angular overlap m odel we conclude that the single d electron occupies the $d_{\rm xy}$ orbital which lies in the bc plane. This result suggests a form ation of a spin-1/2 chain along the b direction, owing to the overlap of the orbital states, and supports recent LDA+U calculations 10 . The ESR signal vanishes at $T_{\rm c}=67~{\rm K}$ signalling the transition to a non-m agnetic ground state. A pronounced dependence of the linew with and the g factor on tem perature suggests a strong coupling of spins to the lattice which may play an important role for the opening of the spin gap.

Single crystals of TiOCl have been prepared from TiCl₂ (Aldrich) and TiO₂ (K ronos Titan) according to experim ental details given in Ref. 13. The purity of the product was checked by x-ray pow der diraction at 293 K and 10 K. The latter measurem ent has been carried out in order to check for a possible structural phase transition, which we do not nd^{14} . Both diractograms could




FIG. 2: (a) Static susceptibility (T) of TiOCltogether with the ESR spin susceptibility and corresponding ts (see text); (b) and (c) ESR linewidth H and g factor, respectively.

be indexed in the orthorhom bic space group Pmmnwith a = 3.789(1) A, b = 3.365(1) A, c = 8.060(3)A at 293 K and a = 3.7946(3) A, b = 3.3584(2) A, c = 8.057(1) A at 10 K. It is interesting to note that the a axis is longer and the b and c axes are shorter at lower temperatures, which means that the already distorted [T iO 4C 12] octahedra are slightly less compressed at 10 K. The static magnetic susceptibility (T) has been measured in a Faraday balance in a eld of 1 Tesla in the temperature range 10 550 K (Fig. 2a). Within the experim ental accuracy (T) is isotropic and shows a behavior similar to that reported in Ref. 10. The t of the data with the formula (T) = $(T)_{1DAF} + (T)_{Curie} + _{0}$, where (T)_{1DAF} is the susceptibility of a uniform 1D Heisenberg antiferrom agnet 15 , (T)_{Curie} is the Curie term, and o is the sum of the diam agnetic susceptibility of Ti-OCland the Van-Vleck susceptibility of Ti3+, yields the num ber of free S = 1=2 spins (param agnetic defects), responsible for the low-T Curie uptum of (T) of order 0.6 %, and $_{0} = 2:3$ 10^{4} em u/m ole 16 . After the subtraction of $(T)_{Curie}$ and $_0$ from the raw data one sees that the model of a 1D antiferrom agnet with the nearest neighbor exchange J = 676 K and the g factor of 1.91 (see below) describes the data in the high-T regim e quite well (Fig. 2a). Below 130 K the susceptibility rapidly 60 K ^{17,18,19}. decreases and approaches zero at

ESR has been measured using a Bruker spectrom eter at X-band frequency 9.48 GHz and at temperatures between 2 and 300 K. A single resonance line of a Lorentzian shape has been observed. The intensity of the ESR signal I is proportional to the susceptibility of the resonating spins 20 . A comparison of I of TiOCl with that of a reference sample 22 gives evidence that within the experimental uncertainty practically all spins contributing to the static susceptibility participate in ESR. The T-dependence of the spin susceptibility ESR obtained from the integrated intensity I(T) is similar to that of the static (Fig. 2a) 21 . In particular, ESR drops sharply




FIG. 3: A ngular dependence of the g factor at $T=100~\mathrm{K}$: (a) (1-10) plane; (b) (001) plane.

alm ost to zero at $T_c=67~\rm K$ signalling the transition to a non-m agnetic state. In addition a smallkink can be seen at 90 95 K, which is ascribed in Ref. 12 to the onset of the structural instability. A small signal arising at $T < T_c$ is obviously due to a small amount of paramagnetic impurities in the samples (e.g. $T~\rm f^{3+}$ in structural defects). The bulk signal observed above T_c is anisotropic and exhibits a strong temperature dependence of the g factor and the linewidth H (Fig. 2b and c).

A representative example of the dependence of g on the direction of the external magnetic eld H is shown in Fig. 3. One notices that the caxis is a symmetry axis of the q tensor, where q reaches its m in im um value (Fig. 3a). The g factor in the ab plane is larger and also anisotropic, as expected in the orthorhom bic sym metry (Fig. 3b): The situation is typical for a Tioctahedron strongly compressed along the zaxis with smaller distortions in the equatorial plane, where the xy orbital ground state is realized²³. On the quantitative level we compare the experimental data with the results of the angular overlap model (AOM). The AOM has been a tool to rationalize spectroscopic and m agnetic properties of TM and rare-earth metalions in various ligand elds and provides a m athem atical approach to calculating relative energies of molecular orbitals of a TM complex from the overlap of the central-atom orbitals with the ligand orbitals²⁴. We calculated the g values for TiOC lusing the program package CAMMAG 25,26 . The best tofthe q tensorwith experimental data (Table I) clearly identies the d_{xy} orbital as the ground state orbital. The relative energies of the orbital states and the bonding param eters used in the calculation are listed in Table II. Even if one neglects a plausible anisotropy of the tions (Model A) the AOM predicts correctly a minimum value of the g factor along the c axis and larger values in the ab plane (gc < gb < ga). The agreem ent becomes even quantitative if one accounts for the anisotropy of the

bonding, which is quite reasonable owing to the fact the ligands are all bridging, e.g. [T iD $_{4=4}$ C $_{2=2}$] M odel B) 29 . In the LDA+U calculation of Seidel et al. 10 the

two higher-energy 1D bands are derived from unmixed d_{yz} and d_{xz} orbitals, which both make an angle of 45 with the caxis and the ab plane. Their occupation by the delectron can be excluded, as the symmetry of these states is dierent from the symmetry of the greensor.

The above discussion strongly supports the scenario proposed in Ref. 10 on the basis of the band structure results. The occupation of the d_{xy} states favors the occurrence of AF spin chains along the baxis owing e.g. to the direct overlap of the d_{xy} orbitals (Fig. 1). The neighboring chains in the $[\text{I iO}_4\text{Cl}_2]_1^2$ bilayer are shifted in a staggered fashion by a=2 and b=2 along the a and baxes, respectively (Fig. 1a), so that the inter-chain exchange interaction is expected to be weak and frustrated. Thus almost perfectly isolated spin-1=2 chains with a relatively strong AF exchange J 700 K, as deduced from the data, can be realized. The spin chains undergo the transition to a spin-gap state at $T_c = 67 \text{ K.How}$ ever, NMR data12 indicate that this is not a conventional spin-Peierls transition as observed e.g. in CuGeO 3 11 because of a much larger spin gap gap as compared with T_c (2 _{gap}= k_B T_c ′ 13)¹⁴. Probably additional orbital degrees of freedom play an important role in TiOCl. Indeed, the components of the g tensor exhibit a strong T dependence (Fig. 2c), suggesting that the energy of the orbital states alters appreciably with T. This is a rather unusual feature; for example, in CuGeO3 as well as in NaV2O5 which is another well-known low-D spingap TM oxide, the g values do not change with $T^{30,31}$.

A considerable decrease of the g anisotropy at low T signals a reduction of the distortion of the Ticomplex,

in agreement with our x-ray data. Such an appreciable coupling of the spin to the lattice should a ect the T dependence of the ESR linewidth as well. In a concentrated param agnet spin-spin interactions produce a nite ESR linew idth owing to the anisotropic part of the superexchange²⁰ H 0 = 1 S_iAS_i. This interaction yields a second m om ent of the line M $_2$ A $(q=q)^2 J^{32}$ Here g is the deviation of g from the spin-only value of 2, and J is the strength of the isotropic Heisenberg exchange $H = J^{T} S_{i}S_{j}$ which in the 3D case narrows the signal so that its width reduces to H M $_2^2$ =J $_2^{33,34}$ If the susceptibility (T) deviates from the Curie law, M $_2$ m ay acquire a T dependence proportional to Curie = (T). 36 Taking g=g 0:05 and J' 680 K we obtain H of the order of 30 Oe. The much smaller value of this rough estimate as com pared w ith the experim ental data for $T > T_c$ (Fig. 2b) m ay be in part due to the fact that it neglects the peculiarities of the bonding geometry in the 1D spin chain which in certain cases may considerably boost H. 37 More serious is the discrepancy of the T dependence of H . Because Curie (T) and the average value of gboth increase with lowering T, the width H is expected to increase, too. However, experim entally one nds the opposite behavior (Fig. 2b), suggesting that other mechanism s of spin relaxation e.g. via orbital and lattice degrees of freedom have to be considered 38. The interplay between orbital and spin uctuations in TiOClhas been proposed in the discussion of the NMR results $^{\!12}$. It is arqued that the opening of the pseudo-spin gap at T K is related to the suppression of the spin-Peierls transition caused by uctuations of the orbital states. Remarkably, in the temperature interval $T_c < T < T$ the ESR linewidth levels o at a minimum value of 150 170 Oe before dropping down at T_c. This implies that the spin uctuations in this temperature regime are strongly suppressed as expected in the pseudo-gap regime. The spin dynamics recovers above T resulting in the increase of H.An additional T-dependent contribution to H could arise due to the spin-phonon coupling, which may be signi cant as suggested by the strong sensitivity of the g factor to the change of the lattice param eters³⁹.

In sum m ary, we have studied electron spin resonance of T i^{2+} ions in single crystals of the novel low-dim ensional spin m agnet T iO C l. The analysis of the g tensor justi es the scenario that in an apparently 2D structure uniform spin S = 1=2 chains are formed along the b direction. The bulk E SR signal vanishes at $T_c=67\,\mathrm{K}$ evidencing the transition to a nonmagnetic, possibly a spin-P eierls state. The T dependence of the g values and the linewidth suggests that orbital and lattice degrees of freedom may play a key role in the magnetic properties of T iO C l. In particular, strong spin and probably also orbital uctuation e ects above T_c may be responsible for a peculiar temperature dependence of the E SR parameters.
