Abstract

We study the equilibrium, oscillatory and transport properties of a chain of charged particles which interact with each other via the Coulomb and power-like repulsive interactions. Exact, analytical expressions for the energy of the ground state, interparticle distances, and vibration spectrum are derived, and the stability criterion for a chain with equidistant particles is established. We also consider the phenomenon of deterministic transport of a chain in a ratchet potential subject to a longitudinal alternating electric eld.

I. INTRODUCTION

A chain of coupled oscillators is a universal mathematical model that describes a large variety of phenomena in physics, chemistry, biology and other sciences. Examples include energy localization and propagation, discrete solitons, them ical reactions, nonequilibrium phase transitions, the stochastic resonance, synchronization, brain dynamics and many others. A special case of that model, a chain of charged particles that interact via the Coulomb interaction, also has a variety of applications. In particular, if the charges have the same sign and are conned by a trapping potential, it describes the so-called one-dimensional Coulomb crystals, i.e., a crystallized structure of ions in a linear trap formed by external focusing elds. If neighboring charges have opposite signs and a repulsive interaction exists between particles, then a such chain represents a relevant model for one-dimensional ionic crystals. It seems that those models can be useful also for the study of one-dimensional crystals within carbon nanotubes. 16,17

During the last decade, much attention was devoted to the transport properties of particles in them all ratchets, i.e., spatially periodic stochastic models exhibiting noise-induced macroscopic transport. The ratchet elect or stochastic transport in asymmetric potentials is important for biological motors, separation techniques, surface smoothing and vortex density reduction, to name a few. Most studies of ratchets, including deterministic ones, significantly models are all particles. However, examples of coupled particles, and vortices show that their collective interactions can significantly modify the transport properties from the single particle case. To our knowledge, the transport properties of a chain of strongly coupled charged particles in deterministic ratchets have not been studied at all.

In this paper, we study the equilibrium, oscillatory and transport properties of a chain where the neighboring particles have the same mass and opposite charges. Particles interact with each other via both the Coulomb interaction and a repulsive interaction that depends on the interparticle distance as $jx_i = x_j j^r (x_i = x_i(t))$ is the coordinate of the ith particle, r > 1). In Sec. II, we consider the ground state of such a chain depending on the exponent r. Three dierent states of a chain, namely, a periodic chain with equidistant particles, a periodic chain with non-equidistant particles, and a chain with in nite period, are analyzed, and the interparticle distances and the chain energies as functions of r are calculated. In

contrast to intuitive expectations, we show that there is a critical value of the exponent, $r = r_2$ 2:799, such that for $r > r_2$ the m in im um energy occurs for a chain with equidistant particles, and for $r < r_2$ the m in im um energy occurs for a chain with in nite period.

Propagation of longitudinal waves in a chain with equidistant particles, its stability with respect to small displacement of particles from their equilibrium positions, and forced vibrations of particles under action of an alternating electric eld are studied in Sec. III. We derive the set of equations that describe small oscillations of the particles, and the phonon spectrum and its asymptotics near the center and boundary of the Brillouin zone, and calculate the amplitude of forced vibrations. We show that the spectrum consists of one branch; on the boundary of the Brillouin zone it has a non-analyticity which is caused by the long-range action of the Coulomb interaction, and a chain is stable only if $r > r_1 = 2.779$.

The determ in istic transport of a chain is studied in Sec. IV. We consider the case when the ratchet potential is charge independent, and a chain is driven by a longitudinal alternating electric eld. We not the average velocity of a chain and analyze in detail its dependence on the parameters characterizing the interparticle interactions, ratchet potential and alternating electric eld. Concluding remarks are contained in Sec. V, and some technical details are given in the Appendixes.

II. GROUND STATE

We consider a chain of particles which have the same mass M and any neighboring particles have opposite charges, i.e., $q_{i+1} = q$ and $jq_ij = q$ (the index i labels the particles). We assume that in addition to the Coulomb interaction a repulsive interaction exists between the particles. In analogy to ionic crystals, we choose a repulsive interaction that depends on a power of the interparticle distance $jx_i = x_j j$, and write the total interaction energy of a chain in the form

Here b is a dimensioned parameter characterizing the strength of the repulsive interaction, and the primes on the sum mation signs indicate the absence of self-interaction terms, i.e., i.e., $i \in J$. To prevent the unbounded contraction of a chain, we require r > 1.




FIG. 1: Part of the equilibrium chain of charged particles.

If a chain is periodic in equilibrium (see Fig. 1), then the coordinates of the positive and negative charges are written as $np + x_n^+$ and $np + a + x_n^-$, respectively. Here p is the chain

Analysis shows that these equations have three solutions: $= _s(r)$ and $= _s(r)$ (s = 1;2;3). Since a chain is transform ed to a chain with equidistant particles as r! r_1 , the equalities $r_2(r_1) = r_1(r_1)$, $r_2(r_1) = r_1(r_1)$, and $r_2(r_1) = r_1(r_1)$ hold. III. VIBRATION PROPERTIES

Since the inequality $\frac{1}{2}(1) > 0$ in plies that $\frac{1}{2}(1) > 0$ for all $\frac{$ $r > r_1$ is the stability criterion of a chain with respect to small displacements of particles from their equilibrium positions. Note that though for $r_1 < r < r_2$ a chain with in nite period is energy-wise preferred compared to a chain with equidistant particles, it is the latter therefore such chains are unstable. In this case the optical displacements of particles do not lead to an appearance of restoring forces. Therefore, to determ ine if a chain is stable or not at $r = r_1$, it is necessary to go beyond the harm onic approxim ation.

C. Forced vibrations

We brie y consider also the forced vibrations of particles under the action of the longitudinal alternating electric eld E (t) = E \cos ! ot, where E and ! o are the amplitude and frequency of the alternating eld, respectively. In such eld the electric force qE \cos ! ot acts on positive charges, and the force qE \cos ! ot acts on negative charges. If the friction force \underline{x}_n (is a damping \cos cient) also acts on each particle, then the forced vibrations of particles are described by the following system of motion equations:

IV. DETERM IN ISTIC TRANSPORT

In this section we study the transport properties of a chain whose particles are driven by the longitudinal alternating electric eld E(t) = Eh(t),

Here k and m run over all integers, is the half-period of E (t), $f_0 = jm in f(x) j$, and d is the period of V (x) (see Fig. 6). The dynam ics of particles in such a chain is described by the system of equations (3.27) in which the right-hand sides A $\cos !_0 t$ and A $\cos !_0 t$ must be replaced by Ah (t) + Rg (x_n^+) and Ah (t) + Rg (x_n^+) (R = $f_0 = M$), respectively. To simplify the problem, we assume that the condition a = Ld (L is a natural number) holds, so that the equilibrium positions of all particles coincide with the minima of V (x). In this case, under the action of the electric eld E (t) all positively charged particles and all negatively charged particles move identically, i.e., $x_n^+ = w$ (t) and $x_n^- = u$ (t), and we obtain

To nd v, we need to calculate and in the general case solve Eqs. (4.3). These equations have the important feature that we need to consider only the ratchet potentials with c > d=2. Indeed, the transform ation c! d cleads to the inverted potential $V_{in}(x) = V(x)$ which gives rise to the reduced force eld $g_{in}(x) = g(x)$. A coording to Eqs. (4.3), in such a potential the displacements $w_{in}(t)$ and $u_{in}(t)$ of positive and negative charges from their equilibrium positions are governed by the equations of motion

Comparing these equations with Eq. (4.3), we obtain w_{in} (t) = u (t) and u_{in} (t) = w (t). (4.5) and (4.6), we not the chain velocity in the inverted potential $v_{in} = v$, i.e., in the potentials $V_{in}(x)$ and V(x) a chain drifts in the opposite directions with the same velocity. If c = d=2 then $V_{in}(x) = V(x)$, both conditions $v_{in} = v$ and $v_{in} = v$ hold, and $v_{in} = v = 0$. Hence, to study the transport properties of a chain, we indeed can consider only those ratchet potentials for which c > d=2. In this case, a chain can drift only along the positive direction of the x axis and so K 0.

Since our aim is to nd the chain velocity v, we need to solve Eqs. (4.8) only for t2 (0;2). To simplify the problem further, we assume that the conditions L K 1 and 1 < A = R < c = (d c) hold. The former implies that the interparticle distance a is much larger than the chain displacement , which, in turn, is much larger than the potential period d. The latter shows that for h(t) > 0 (h(t) < 0) positive (negative) charges can overcome the potential barriers of V(x) and they move along the positive direction of the x axis, whereas negative (positive) charges stay in the minima of V(x). After h(t) changes sign, the particles at rest begin to move, and the moving particles move to the appropriate minima of V(x) and stop there. Since the maximal distance that the moving particles travel after h(t) changes sign does not exceed c, i.e., this distance is much less than , we assume that the moving

particles reach the corresponding m in im a of V(x) im m ediately as h(t) changes sign. W ithin this approximation, the dynamics of positive and negative charges is described separately, and Eqs. (4.8) yield u(t) = 0 and

which shows that for 1 K max K the chain velocity does not depend on the chain characteristics. Since 1 < A = R < c = (d c), for a given ratio A = R = (> 1) the parameter c=d must belong to the interval (=(+1);1). On this interval, v is a decreasing function of c=d, and according to Eq. (4.17) v! $_12 = (+1)$ as c=d! = (+1), and v! $_1$ as c=d! 1.

V. CONCLUSIONS

We have studied the ground state, vibration properties and determ inistic transport of a chain of charged particles interacting via both the Coulomb interaction and a repulsive interaction, which is characterized by the power r. We have shown that a chain with equidistant particles has minimum energy for $r > r_2$ 2:799. For a such chain, we have calculated its energy and period as functions of r, derived and analyzed in detail its phonon

spectrum, and established that it is stable with respect to small displacements of particles from their equilibrium positions only if $r > r_1$ 2:779.

We have studied also the determ inistic transport of a chain in the case when the particles are acted upon by both a longitudinal alternating electric eld and a force eld generated by a ratchet potential. We have derived the set of equations that describes the chain transport, analyzed the general properties of its solution, and calculated the chain velocity in the overdam ped limit. If the period of the electric eld is large enough, then the chain velocity strongly depends on the interparticle interactions. O there is, i.e., if the period of the electric eld is small enough, the chain velocity does not depend on them.




FIG. 2: Plots of $_1$ (r) and $_2$ (r); for the third solution $_3$ (r) = 1 . The function $_2$ (r) increases from $_2$ (r₁) = $_1$ (r₁) 4:959 to $_2$ (3) = 1 .




FIG. 3: Plots of $_{\rm S}$ (r). All functions $_{\rm S}$ (r) decrease monotonically, and $_{1}$ (r $_{1}$) = $_{2}$ (r $_{1}$) 2:420, $_{2}$ (3) = $_{3}$ (3) = $_{3}$ (3) = $_{3}$ (7) $_{3}$ (7) $_{4}$ (8) $_{5}$ (8) $_{5}$ (9) $_{7}$ (9) $_{7}$ (10) $_{8}$ (11) $_{1}$ (12) $_{1}$ (13) $_{2}$ (13) $_{3}$ (13) $_{4}$ (13) $_{5}$ (13) $_{5}$ (13) $_{7}$ (13) $_{7}$ (13) $_{7}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (14) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (13) $_{8}$ (14) $_{8}$ (13)




FIG. 4: Plots of U_1 (r) and U_3 (r) [gure (a)], and U_1 (r) and U_2 (r) [gure (b)]. The functions U_3 (r) and U_2 (r) are very close to each other $[U_3]$ (r) $< U_2]$ (r) for $r_1 = r < 3$, $U_3]$ (3) = $U_2]$ (3) = $1=3^p \frac{7}{3}$, and $U_2]$ (r) $U_3]$ (r) (




FIG. 5: Dependence of the phonon spectrum ?() on for r = 4 (curve 1), r = 3 (curve 2), and $r = r_1$ (curve 3). Since for $r = r_1$, the function j ? ? () jgoes to in nity very slow ly [as p ? () jln (1) jl as p ? () as p ? () 1, this feature of the spectrum is not represented on the chosen scale of the axis.




FIG. 6: Illustrative plots of the reduced alternating electric eld h(t) [gure (a)], the ratchet potential V(x) [gure (b)], and the reduced force eld g(x) [gure (c)].
