High-pressure molecular phases of solid carbon dioxide

W e present a theoretical study of solid carbon dioxide (CO₂) up to 50 GPa and 1500 K using rstprinciples calculations. In this pressure-tem perature range, interpretations of recent experiments have suggested the existence of CO₂ phases which are intermediate between molecular and covalentbonded solids. We reexam ine the concept of intermediate phases in the CO₂ phase diagram and propose instead molecular structures, which provide an excellent agreement with measurements.

U nderstanding the evolution of the bonding properties ofm olecular crystals as a function of pressure is a fundam ental question in condensed m atter physics. Recently, this question has received a widespread attention due to key progress in experim ental techniques and hence, the availability of new data for a number ofm olecular solids [1]. In the case of CO_2 , the interest has been further intensi ed due to its in portance for planetary science and technical applications. However, despite several experim ental investigations of the CO_2 high-pressure phases, the changes of intra- and inter-m olecular bonds, as well as of electronic and vibrational properties, as a function of pressure are not yet wellunderstood. In addition, large portions of the CO_2 phase diagram are unexplored from a theoretical standpoint.




FIG.1: Phase diagram of CO_2 according to Ref 9, where CO_2 -III (Cm ca) is reported to be m etastable.

At low pressure (P) and tem perature (T), CO_2 condenses as a molecular solid in the cubic P a3 structure (known as dry ice, phase I), which is characterized by strong double bonds (C = 0 distance of 1.16 A) and rather weak intermolecular interactions [2]. Recently, a high-P and high-T phase of CO_2 (phase V) has been discovered [3, 4, 5, 6, 7], which is completely di erent from the molecular solid. It has a polymeric quartz-like structure, and a very low compressibility (the experimentally derived bulk modulus, B_0 , is 365 G Pa). Following this exciting discovery, two additional new phases have been reported [8, 9, 10] experimentally (II and IV in Fig. 1), both of which were credited with unusual properties; their structures were described as intermediate between that of molecular and covalently bonded crystals.

In this Letter, we present a study of the CO₂ phase diagram based on rst-principles density functional theory (DFT) calculations. Our results challenge the interpretation of CO₂-II, III, and IV as exhibiting dram atic di erences in the nature of the molecular bonding with respect to the low-pressure molecular crystal. In place of the previously proposed structures for CO₂-II and IV, we suggest new, molecular ones. We demonstrate that in addition to being stable, our new ly proposed structures give results in excellent agreement with measurements and provide a consistent explanation of experimental observations.

At am bient T, CO₂-I undergoes a pressure-induced

transformation to the orthorhom bic Cm ca symmetry (phase III) between 12 and 22 GPa β, 11, 12, 13, 14, 15, 16]. The exact nature of this transition and the structure of phase III are still unsettled; experim ental studies have suggested a region of co-existence between CO2-I and III [14], and also an interm ediate distorted low -T phase [16]. Furtherm ore, it was reported [9] that the I to III transition is strongly tem perature dependent, becoming abrupt above 400 K, and that CO_2 -III m ay actually be m etastable. The two new ly discovered phases II and IV are believed to be therm odynam ically stable and quenchable. It was proposed that CO $_2\text{-II}$ has the P 4_2=m nm sym m etry with elongated C = 0 bonds, 1.33 A, reduced inter-molecular distances below 2.38 A (hence named associated or dimeric phase), and $B_0 = 131$ GPa [9, 10]. CO_2 -IV was described as P bon, with C = O bonds as long as 1.53 A, and bent (0 = C = 0 angle of 160) and strongly (dipole) interacting m olecules [8]. Such rem arkable properties would imply that CO_2 is losing its molecular character in a \gradual" way, a concept prom oted as a key for understanding its phase diagram in analogy with solids like N_2O and SiO_2 . In addition, CO_2 -III, despite having a stable C = 0 bond, was also assigned a B_0 as high as 87 GPa [9]. The stability of the proposed bent and associated phases, and the unusual bulk properties of CO₂-II, III, and IV have not been investigated theoretically up to date.

We performed a series of rst-principles calculations, including full structural optim izations, phonon spectra, and free energies, in order to study the stability and properties of the phases proposed experim entally up to 50 GPa and 1500 K. The DFT calculations were carried out within the Perdew-Burke-Emzerhof (PBE) [17] generalized gradient approximation (GGA) using the ABINIT code [18], which im plements plane-wave basis sets [19].

First, we have exam ined the stability of the bent and dimeric structures for phases II and IV. Starting from the previously proposed P 42=m nm and P bon with elongated m olecular bonds, we carried full structural optim izations at various pressures up to 50 GPa. In all cases, upon relaxing the atom ic coordinates the C = 0 bond lengths decreased by about 15% and 30% for P 4_2 =m nm and P bon respectively, to become comparable to the free CO_2 molecule [20]. In the case of P bon, the O = C = O angle also straightened to 180 . The energy di erences between the theoretically stable molecular structures and the associated and bent phases are respectively more than 3 and 6 eV per molecule. These are energy scales corresponding to the breaking of a covalent bond. They are beyond the errors of the GGA and present a strong evidence that the previously proposed bent and dimeric structures are not stable. In order to further investigate this issue, we exam ine below published experim ental data for CO_2 -II, III, and IV, and demonstrate that they can be explained in term softwo stable structures, Cm ca and P 4_2 =m nm , which are strictly molecular.




FIG.2: Pressure-volum e dependence of selected CO_2 structures: Pa3 (black), Cm ca (blue), and P 4_2 =m nm (red). The solid lines are ab initio calculations; the points indicate experimental data from Ref.14 (no error bars), Ref.3 (P a3 and Cm ca), and Ref.10 (P 4_2 =m nm). The inset shows calculated reduction in volume of P 4_2 =m nm and Cm ca relative to P a3.

C om puted equation of state (EOS) at T = 0 for the three m olecular structures P a3, C m ca, and P 4_2 =m nm are reported in Fig. 2, along with the available experimental data. In all three cases, the calculated EOS agrees very well with the measured one; the com puted P V curves fall within the experimental uncertainties. We

nd about 2% relative volume reduction from Pa3 to Cm ca [21] above 30 GPa and another 0.5% from Cm ca to $P 4_2 = m nm$ (see insert in Fig. 2). Yoo et al. reported а 5-7% volume decrease associated with the III to II transition; however, they also observed lattice strain in their phase III samples [9], which may explain the difference between their results and ours. Furtherm ore, the PV curve of Cm ca com es close to and eventually m erges with that of P a3 below 20 G P a in agreem ent with A oki et al. [14]. Thus, the m easured EOS data are reproduced well despite the lack of molecular association in our optim ized P 4_2 =m nm . The computed EOS parameters are sum marized in Table I together with values derived form experiment [22]. The agreement is good for Pa3, but there is an order of magnitude di erence for the values of B $_0\,$ of C m ca and P $4_2 = m\,$ nm . Since we are using the same EOS tas Ref. 10, and we in fact agree very well with the direct PV measurements, the large di erence likely com es from extrapolating the experim ental data, spread above 20 GPa, down to am bient pressure.




FIG. 3: Computed R am an-active modes (solid symbols) of the theoretically stable structures. (a) Sym metric stretching vibron. The dashed lines indicate experimental data from Ref. 9; they are from a Ferm i resonance band, and have been shifted by 52 cm¹ for comparison. (b) Externalmodes.

The published experimental evidence invoked to propose that CO₂-II exhibits the properties of a dimeric polym orph consists of: (i) a large splitting of the internal sym m etric stretching m ode, $_1$ [9], (ii) a broad librational mode identi ed as B_{1q} [9, 10], and (iii) powder x-ray di raction m easurem ents [10]. W e carried out calculations of the vibron spectrum [23] of m olecular P 4_2 =m nm and Cm ca as a function of P. A plot of $_1$ in Fig. 3a shows that the measured splitting, as well as the relative values for P 4_2 =m nm and Cm ca, are reproduced remarkably well by the theoretical structures. Yoo et al. assumed that the large vibron splitting observed in CO2-II is an evidence for decreased inter-molecular distances; our results indicate that the crystal eld in the molecular P 4_2 =m nm is su cient to explain the splitting. O ne should note that phonons are calculated as a second derivative of the energy; therefore the agreem ent with experim ental frequencies within meV, as found here, is a strong indication that com puted total energies and forces are extrem ely accurate.

The computed pressure dependence of the Raman-

active external modes of the three theoretical structures is shown in Fig. 3b. The agreem ent with experiment [16] is again good, though our values are consistently slightly lower than the measured ones. The experimental frequencies of the two Raman-active modes of CO2-II at 19 GPa are about 260 and 320 cm 1 -the form er being a broad peak – and were classi ed as B_{1q} and E_q respectively [9, 10]. The broad m ode was previously associated with dynamical disorder in the lattice. The molecular $P 4_2 = m nm$ has modes with frequencies 245 and 300 cm 1 at this P; however it is the degenerate E_{q} which has the low er frequency, and therefore corresponds to the experim entally observed broad peak. Its broadening can be explained by invoking a lifting of the E_{α} degeneracy when the tetragonal cell is deform ed into an orthorhom bic one (resulting in the Pnnm symmetry). Such a distortion is consistent with the x-ray data reported in Ref. 10 and we estim ate that between 20 and 30 GPa there is 10 cm $^{-1}$ splitting for every 1% modi action of a and b.

We now turn our attention to the x-ray analysis. In P 4_2 =m nm, the atom ic positions are C (2a) at [0,0,0], and O (4f) at [x,x,0]. The associated phase, according to R ef. 10, corresponds to x = 0.2732, while our stable structure corresponds to x = 0.23075, i.e. x 0.25 for both structures, where = 0.02. Am ong the observed di raction peaks, only the (101) and (211) re ections depend on the sign of ; their m easured intensities relative to the calculated intensities of the same re ections are in ratios of 2.3 and 0.3 for the associated, and 0.4 and 1.8 for the m olecular structures respectively [24]. We therefore conclude that at present the di raction m easurem ents are insu cient to distinguish between the proposed dim eric and the theoretical m olecular P 4_2 =m nm structures.




FIG.4: (a) Enthalpy versus P relative to the Cm ca phase at T = 0. (b) Phonon free energy versus T relative to the Cm ca structure at 16 GPa; the reported di erences do not vary strongly with P. (c) Relative stability of selected CO₂ structures from G ibbs free energy com parison; here P includes phonon contributions. The dotted lines indicate the experim ental phase diagram constraints from R ef. 9 (see Fig. 1).

Finally, we exam ine the relative stability of all considered crystal structures as a function of both P and T. A plot of enthalpies showing that Cm ca is never thermodynamically stable at low T is reported in Fig. 4a. This nding con ms a previous observation by Iota and Yoo [4] that the orthorhom bic sym metry obtained during am bient T compression of CO_2 -I is metastable; the reason why the system reverts to it is the low kinetic barrier associated with the rotation of the molecules from their alignment in Pa3 to that in Cm ca. In additional support of this conclusion, we have perform ed structural optim izations starting from the P bca structure, and relaxing the atom ic coordinates. The P bca lattice is obtained from P a3 by deform ing the cubic cell; further rotations of the molecules in the y-z plane then leads to C m ca. In all such calculations above 15 G Pa, the CO $_2$ molecules quickly align in the y-z plane, thus ending up in the Cm ca, rather than in the energetically favorable $P 4_2 = m nm$ phase. This happens regardless of whether the unit cell is tetragonal or orthorhom bic; the deform ation of P 4_2 =m nm to the orthorhom bic P nnm costs only about 1 m eV perm olecule for 1% distortion of a and b.

The kinetic barrier between Cm ca and P 4_2 =m nm can be overcome by heating the system above am bient T. Interestingly, we nd that upon further heating at constant P there is a therm odynam ic phase boundary above which the orthorhom bic phase is now stable. The phonon free energies, com puted as described in R ef. 23, are plotted in F ig. 4b. The transition to Cm ca is entropy driven and is

m ainly due to a soft acoustic phonon m ode. Its physical origin is in the speci c geometry of C m ca, allowing for a relatively unobstructed shear-like m otion parallel to the y axis; we have con m ed this by sam pling the potential surface with frozen-phonon calculations.

The computed stability regions for P a3, P 4_2 =m nm, and C m ca are shown in F ig. 4c. Since we are comparing the relative stability of a limited number of structures, we cannot im ly conclude that F ig. 4c represents the actual phase diagram of CO₂. However, the almost perfect m atching of the stability region of C m ca with that of CO₂-IV m akes the identic cation between the two phases rather compelling. We note that a phase IV of CO₂ was

rst suggested by O lijnyk and Jephcoat [16] based on the observed multiplicity of external Raman-active modes between 10 and 20 GPa, at am bient T. Their data is consistent with the Ram an spectrum of Pa3, Cm ca, and P bca. A s we discussed above, P bca is interm ediate between P a3 and C m ca, and m ay be present close to the boundary of stability between these two phases, which extends from 5 to 16 GPa in our calculations. In addition, Cm ca has a soft (below 100 cm 1 at 20 GPa) zone-boundary libron, B_{1q}, tilting the molecules away from the y-z plane, which crosses two of the acoustic m odes. Thus, when excited at high T, Cm ca could actually turn into a peculiar distorted phase. R ef. 16 observed a sim ilar distorted phase with a weak (otherwise forbidden) R am an activity of the bending internalm ode, which they related to the presence of pressure inhom ogeneities in the sample. We nd such an explanation of the Ram an activity observed by Yoo et al. [8] around 650 cm $^{-1}$ m ore plausible than the existence of bent m olecules.

In conclusion, we have presented a new interpretation of experimental data recently obtained for CO_2 -II, III, and IV. Our ab inito calculations identify CO_2 -II as a molecular structure with the P 4₂=m nm symmetry. We have also elucidated the high-T behavior of molecular CO_2 , and have found the Cm ca symmetry to be preferable due to its relatively large entropy. Based on our ndings, we propose that measurements of the high-T phase IV be interpreted along the lines of an orthorhom bic, and possibly distorted, phase. Finally, we note that the externalR am an modes of several CO_2 molecular structures are very close in frequency (see Fig. 3), and thereforem ay not be su cient to discriminate between di erent phases.

A 45 Haplane-wave cut-o and 4 4 4 Monkhorst-Pack (MP) grids were found su cient for energy, pressure, and bond length converged better than 1 meV/m olecule, 5 10^{-3} GPa, and 10^{-3} A, respectively. U sing DFT-PBE we obtained a very accurate description of the free molecule (bond length and harm onic vibrational frequency within 0.5% and 1.5% of the experim ental values, respectively) and of the P a3 crystal structure. G G A calculations also correctly predict the polymerization of CO₂ at high P.
