# Two nonm agnetic impurities in the DSC and DDW state of the cuprate superconductors as a probe for the pseudogap

The quantum interference between two nonm agnetic in purities is studied numerically in both the d-wave superconducting (DSC) and the d-density wave (DDW) state. In all calculations we include the tunnelling through excited states from the CuO<sub>2</sub> planes to the BiO layer probed by the STM tip. Compared to the single impurity case, a system atic study of the modulations of the two-impurity local density of states can distinguish between the DSC or DDW states. This is in portant if the origin of the pseudogap phase is caused by preformed pairs or DDW order. Furthermore, in the DSC state the study of the LDOS around two nonmagnetic impurities provide further tests for the potential scattering model versus more strongly correlated models.

#### I. IN TRODUCTION

The study of magnetic and nonmagnetic impurities in the CuO<sub>2</sub> planes of the H igh-T<sub>c</sub> superconductors is far from settled. Experim entally, the local density of states (LDOS) measured by scanning tunneling microscopy (STM) in Bi<sub>2</sub>Sr<sub>2</sub>CaCu<sub>2</sub>O<sub>8+</sub> (BSCCO) around a nonmagnetic impurity such as Zn displays a sharp peak close to the Ferm i level on the impurity site and a second maximum on the next-nearest neighbor sites<sup>1;2</sup>. Theoretically, the question remains whether a traditional potential scattering form alism 3;4 or m ore strongly correlated m odels<sup>5</sup> are needed to describe the impurity elects. Though still a subject of controversy, it was recently shown that at least for weak in purities a potential scattering scenario qualitatively agrees with the measured results for optimally doped BSCCO<sup>6{10</sup>. Furthermore, it was shown by Martin et al.<sup>11</sup> that both the energetics and the spatial dependence of the resonance state around a strong potential scatterer (e.g. Zn) can be accounted for by including the tunnelling (the lter) through excited states from the CuO<sub>2</sub> planes to the top BiO layer probed by the STM tip<sup>12</sup>. There is also evidence from nuclear m agnetic resonance (NMR) measurements that magnetic m om ents are induced around nonm agnetic in purities<sup>13</sup>. In this paper we assume, however, that the large potential scattering o the impurity site itself is dominating the nalLDOS.

Recently the experimental ability to manipulate the positions of surface in purities has increased the interest in quantum interference phenomena between multiple in purities. This includes the physics of quantum mirages<sup>14</sup> and various multiple in purity e ects in superconductors<sup>15{18</sup>. For example, it was shown in Ref. 17 that in purity interference can be utilized as a sensitive probe for the gap symmetry of exotic superconductors. Motivated by the experimental progress we compare the expected LDOS around one and two strong nonmagnetic in purities in either the d-wave superconducting

(DSC) or the d-density wave (DDW) state. Though still controversial we include the lter e ect in all the calculations presented below. As has become clear only recently  $^{15{17}}$ , we stress that the probed in purities need be well separated (10-50 lattice constants) from other possible defects.

The DDW state was recently proposed as a model for the pseudo-gap state of the cuprates<sup>19</sup>. Any di erence in the in purity modi ed LDOS between the DSC and DDW states may reveal the hidden DDW order and distinguish between the scenario of preform ed pairs versus static staggered orbital currents as the origin for the pseudo-gap state<sup>20 {22</sup>. Recently, there has been several other proposals to probe the DDW order in the cuprates<sup>23;24</sup>.

#### II.M ODEL

In this section we brie y discuss the models for the DSC and DDW states and how to calculate the LDOS around several in purities. The BCS G reens function  $\hat{G}^{0}(k;i!_{n})$  for the unperturbed d-wave superconductor is given by

where ^ denotes the Paulim atrices in Nam bu space,  $_0$  being the 2 2 identity matrix, (k) the quasi-particle dispersion, and  $!_n$  is a Matsubara frequency. For a system with  $d_{x^2} y^2$ -wave pairing symmetry, (k) =  $\frac{-2}{2} (\cos(k_x) - \cos(k_y))$ .

In the DDW state the mean-eld H am iltonian is given by  $^{19}$

where  $c_k^y$  creates an electron with momentum k and spin , Q = (;) and D (k) =  $\frac{D_0}{2} (\cos(k_x) - \cos(k_y))$ . Below,  $_0$  = D  $_0$  = 50m eV and the lattice constant is set to unity. The large value of the gap corresponds roughly to the experim entally measured maximum gap in the underdoped regime of B SCCO .

The G reens function for the clean DDW state is given by

Performing the Fourier transform,  $\hat{G}^{0}(\mathbf{r}_{i};\mathbf{r}_{j};i!_{n}) = \sum_{kk^{0}} \hat{G}^{0}(k;k^{0};i!_{n})e^{ik} r^{ik^{0}}$ , of the Greens function with reference to the entries of Eqn. (3) gives

with the sum extending over the reduced Brillouin zone. The presence of scalar in purities is modelled by the following delta-function potentials

where  $\hat{n}_i$  is the density operator on site i. Here fig denotes the set of lattice sites hosting the impurities and U<sub>i</sub> is the strength of the corresponding e ective potential. In this article all the presented results arise from impurities modelled by a potential, U = 15t, corresponding to -4:5eV. In the DSC state this U generates resonances at a few meV for a single nonmagnetic in purity<sup>1;2;11</sup>. The large scale of this potential renders the elects on the LDOS from corrections to other energy scales around the impurity site less important. For instance, we have checked that gap suppression near the impurity or slightly larger spatial extension of the impurity does not qualitatively a ect the results reported below. In general these e ects tend to push the resonances slightly further towards zero bias. We have also perform ed calculations (not shown here) with other values of U and comment on the results below.

The full G reens function  $\hat{G}$  (r;!) in the presence of the impurities can be obtained by solving the real-space G orkov-D yson equation

The size of the matrices in this equation depends on the number of in purities and the dimension of the Nam bu space. We have previously utilized this method to study the electronic structure around in purities<sup>17</sup> and vortices that operate as pinning centers of surrounding stripes<sup>27</sup>. This method is identical to the traditional T-matrix formalism. However, for a numerical study of several in purities at arbitrary positions we not it easier to solve Eqn.

6 directly.

The 2D Fourier transform of the clean G reens function  $\hat{G}^0(k;!)$  is performed numerically by dividing the rst B rillouin zone into a 800 800 lattice and introducing a quasi-particle energy broadening of = 1m eV with dened from the analytic continuation  $i!_n ! ! + i$ . The di erential tunnelling conductance is proportional to the LDOS which is determined from the imaginary part of the full G reens function.

So far nothing has been said about the form the bandstructure. It is still controversial which quasi-particle energy applies to the DSC and DDW states<sup>22;25;26</sup>. The expression for (k) is in portant since it will in uence the nalLDOS around the impurities. We illustrate this in the following by studying two generic band structures: the nested situation, and a t-t<sup>0</sup> band believed to be relevant for BSCCO around 10% hole doping. With the notation (k) = (k) , and

t (t<sup>0</sup>) refers to the nearest (next-nearest) neighbor hopping integral and is the chem ical potential. The nested situation corresponds to  $t^0 = = 0.0$  while the param eters for the 10% hole doped band are: t = 300m eV,  $t^{0} =$ 0:3t and 0:9t. These parameters corre-= spond to the ones previously studied for a single in purity by Morr<sup>22</sup>. As discussed in Ref. 22 there are physical reasons to expect the nested band to be relevant for the DDW state and the  $t-t^0$  band for the DSC phase. However, recent photoem ission measurements on LSCO by Zhou et al.<sup>26</sup> observed a Ferm i surface consisting of straight lines connecting the antinodal regions which may indicate that the nested band is more relevant for im purity studies in LSCO. Thus we nd it in portant for study both cases below.

In the results presented we include the LDOS  $_{p}$  Her<sup>11</sup>. This e ect modi es the LDOS,  $(r;!) = _{n} j_{n}(r) j (! _{n})$ , by including the four nearest Cu neighbors in the underlying CuO<sub>2</sub> layer,  $_{n}(r) ! _{n}(r + e_{x}) + _{n}(r - e_{x}) _{n}(r + e_{y}) _{n}(r - e_{y})$ . Here  $e_{i}$  denote the unit vectors in the CuO<sub>2</sub> plane. It is important to keep in m ind that the ltering e ect is still controversial. How ever, determ ining experimentally the interference e ects around two impurities in the DSC state m ay help resolve the relevance of the lter.

## III. R E SU LT S

#### A . single im purity

Before studying the two impurity interference e ects it is worthwhile to brie y review the single impurity LDOS in the DSC and DDW states and discuss the in uence of the lter. W ithout the tunneling lter we not full agreement with previously published results<sup>7;15;20 {22</sup>. We will see that a single in purity is not a good probe for distinguishing between these two states.




FIG.1.DOS (arb. units) as a function of energy (m eV) in the DDW state: (a) for the clean system with nested (solid) or  $tt^0$  (dashed) band. (b) DOS at (0;0) (solid), (1;0) (dashed), and (1;1) (dash-dotted) for a nested band with the impurity at (0;0). (c) same as (b) but for a  $tt^0$  band.

In the DDW phase one can utilize Eqn. (4) and (6) to calculate the full G reens function  $\hat{G}(r_i; r_j; i!_n) =$  $\hat{G}^{0}(\mathbf{r}_{i} | \mathbf{r}_{j}; i!_{n}) + \hat{G}^{0}(\mathbf{r}_{i}; i!_{n}) T(i!_{n}) \hat{G}^{0}(\mathbf{r}_{j}; i!_{n}) w \pm h \text{ the}$ T-matrix given by, T (i!<sub>n</sub>) = U  $[1 UG^{0}(0;i!_{n})]^{1}$ . The single resonance condition,  $1 = U R e [G^{0}(0; !)]$ , has been previously studied for the DDW state without the ltering e  $ect^{20{22}}$ . It is well known that the resulting LDOS strongly depends on the band structure. In Fig. 1a we plot the DOS in the clean DDW state for the nested and the  $t-t^0$  band without the lter. Even though the above resonance condition is satis ed at certain energies for the t-t<sup>0</sup> band, we expect the large value of the DOS at all frequencies to overdam p the impurity peaks. This is contrary to the nested situation where a sharp in purity resonance is allowed to appear in the gap. This is clearly veried in Fig. 1b(c) which depicts the LDOS for the nested  $(t-t^0)$  set of band parameters including the lter. The peaks in Fig. 1c are not impurity resonances (note scale), which are overdam ped, but simply the shifted DDW gap edges. The impurity can only slightly modify the amplitude of these gap edges. We note that it is t<sup>0</sup> which causes the impurity resonances to be strongly overdam ped. W hen  $t^0 = 0$ ,  $\epsilon$  0 the density of states always vanishes at m inus the chem ical potential<sup>21</sup> allow ing a well-de ned resonance peak to appear.

As is evident from Fig. 1b the most important in uence of the lter is to shift the LDOS maximum from the nearest neighbors to the impurity site and induce a second maximum on the next-nearest neighbor sites<sup>28</sup>. This weight redistribution is identical to the situation in the superconducting phase<sup>11</sup>.




FIG.2. Same as Fig. 1 but for the DSC state.

In the DSC state, the clean DOS is plotted in Fig. 2a for both the nested and the tt<sup>0</sup> band. By comparison to Fig. 1a we see the well known result that the nested DOS is identical for the clean DDW and DSC phase. Indeed thism otivated the original studies of single in purity resonances in the DSC versus DDW states<sup>20 {22</sup>. The single in purity resonance condition in the DSC phase,  $1 = URe[G^0(0; !)]$ , generates peaks at positive and negative energies around a single nonm agnetic in purity. How ever, the majority of the quasi-particle weight may reside on only one of these resonances<sup>17</sup>.

It is evident from both Fig. 2b and Fig. 2c that indeed only one resonance has weight. This is contrary to the situation without the lter<sup>22</sup>. Thus by comparing Fig. 1b to Fig. 2b (or 2c) the result is two almost identical gures. Therefore, since no qualitative di erence is guaranteed to exist the single nonm agentic in purity cannot easily distinguish the DSC and DDW phases . However, as shown below, the interference between several im purities can be utilized to tune the amplitude of the potential resonances and thus clearly distinguish the phases. The impurity LDOS plotted in Fig. 1 and Fig. 2 was forU = 15t. Though of less experim ental relevance, we brie y mention another di erence between the DSC and DDW states. This relates to the fate of the resonance in the unitary limit, U ! 1 : for the DDW phase

the resonance energy approaches m inus the chem ical potential, ! = , whereas it approaches the Ferm i level in the DSC phase (except for a sm all residual energy shift caused by a possible particle-hole asymmetry<sup>29</sup>). The di erent resonance energy (as U ! 1) arises from the way the chem ical patential enters the bands of the clean DDW  $(E \ (k) = j \ (k)^2 + D \ (k)^2)$  and DSC  $(E \ (k) = p \ (j \ (k) j \ )^2 + \ (k)^2)$  states<sup>20;21</sup>.

#### B.two im purities, nested band




FIG.3. (a) DOS at (0;0) as a function of the distance between two nonmagnetic in purities (here:  $t^0 = 0.0$ ). One in purity is xed at (0;0) while the other moves from (0;0) (top) to (10;0) (bottom). (b) the in purities are xed at (1;0) while the STM tip is moved from (0;0) (top) to (8;0) (bottom). The di erence between each scan is 0.2 lattice constants and the graphs are o -set for clarity.

In general when several in purities are in close proxim ity the resonances split, and one expects to see additional peaks in the density of states. The evolution of the LDOS as a function of distance and angular orientation between two nonmagnetic in purities in the DSC state has been already studied by several authors  $^{15\{17}$ . In the follow – ing we elaborate on this work by a num erical study of the LDOS including the ltering e ect and study for the rst time the quantum interference between two strong nonm agnetic in purities in the DDW state. In the superconducting phase Fig. 3a shows the resulting LDOS for the nested band when one in purity is xed at the origin (0;0) while the other is moved out along a crystal axis to (10;0). In Fig. 3b the impurities are xed at (1;0) and (+1;0) while the STM tip is moved from (0;0) to (8;0). As seen from both gures there are strong variations in the LDOS in agreement with previous studies without the extra tunnelling e  $\operatorname{ect}^{15;17}$ .




FIG.4. Same as Fig. 3 but for the d-density wave state.

The num ber of apparent resonances, their energetic position and width strongly depend on the impurity con guration and the position of the STM tip. In particular, for certain in purity separations the resonances completely disappear. In Fig. 4 we show the LDOS for the same impurity and STM positions as in Fig. 3 but for the DDW state. Clearly, strong quantum interference between the two nonmagnetic in purities also exists in this state. However, by comparison with Fig 3 it is evident that the additional resonance states in the DSC allows one to distinguish this from the DDW phase. We have perform ed identical calculations to the ones presented in Fig. 3-4 for other (but still large) values of the scattering potential U, and always nd qualitatively the same interference pattern.




FIG.5. Same as Fig. 3 but for  $t^0 = 0.3t$  and = 0.9t.

A s m entioned above, the resonances split when two in – purities are in close proximity. It is therefore nontrivial that only a single, nondispersive peak is seen in e.g. Fig. 4b. This is closely connected to the particular STM scan and one m ay worry about the robustness of this result. However, we always nd that whenever the impurity positions are invariant under m irror re ection through the STM scan line, only a single nondispersive peak remains<sup>30</sup> in the DDW state. Importantly, for these same con gurations we nd the alternating double peak structure (similar to Fig. 3b,5b) to be a robust feature in the superconducting phase. Furtherm ore, as expected for a d-wave gap<sup>17</sup>, we nd (not shown) that the quantum interference patterns are longer ranged along the nodal directions than along the Cu-O bonds.

A sexpected from the discussion of the single impurity in the DDW state, we end this section by noting that when  $t^0=0.0,~~6~0.0$  the interference pattern is identical to that shown in Fig. 4 except for a shifted (by ) energy range.

## C.two impurities, $t-t^0$ band

W e now turn to the quasi-particle dispersion given by Eqn. (7) with  $t^0 = 0.3t$ , = 0.9t. In this case we know from Fig. 1a and Fig. 2a that the clean DOS is clearly di erent in the DDW and DSC states. This section serves as an illustration of the importance of the quasi-particle dispersion in the nalLDOS.Fig. 5 shows the LDOS in the superconducting phase from the same STM and impurity positions as Fig. 3. It is clear that again the strong interference between the impurity wavefunctions survive the ltering e ect and pose new constraints on the potential scattering scenario versus m ore strongly correlated m odels<sup>5</sup>. We note that despite the very di erent band structure used to calculate the LDOS in Fig. 3 and Fig. 5, the overall evolution of the resonances is quite sim ilar except that the apparent resonances are shifted to higher energies for the  $t+^0$  band. As mentioned above, it has been previously suggested that the nested  $(t-t^0)$  band is appropriate for the DDW (DSC) state<sup>22</sup>. In that case we need compare Fig. 4 and Fig. 5. As opposed to the single in purity LDOS, the

con guration in Fig. 4b and Fig. 5b again allows one to distinguish the DDW and DSC states by the number of resonance peaks. This is contrary to Fig. 4a and Fig. 5a which are remarkably similar.




FIG.6. Same as Fig. 5 but for the d-density wave state. Note the energy range. The peaks evident in these scans are the shifted DDW gap edges (not impurity resonances).

In the DDW phase we know from the single in purity case that the current choice of band param eters leads to strongly overdam ped in purity resonances (Fig. 1c). However, for completeness we show the calculated STM scans in Fig. 6. As expected the quantum interference is weak and causes only m inor changes in the DDW gap edges. Furtherm ore, the LDOS shown in Fig. 6 changes only slightly upon varying U or the in purity positions.

### $\ensuremath{\texttt{IV}}$ . C O N C LU S IO N

In summary we have shown that a systematic STM study around two nonmagnetic in purities can clearly distinguish the DSC and DDW phases. In particular, we suggest to perform STM scans with the positions of the impurities being invariant under a mirror relation through the scan line. Even for the nested band, where the clean and the single impurity LDOS are not a good probe for the underlying state, this situation provides a robust test for DSC versus DDW order.

The impurities are modelled as potential scatterers and the results pose further tests on this approach. An im portant question remains whether phase uctuations present about  $T_{c}$  in the pseudo-gap state are strong enough to wash out the interference patterns. This will be discussed in a future publication<sup>31</sup>. It would also be interesting to study similar multiple impurity interference e ects within other pseudo-gap models and within other proposed scenarios for the resonances around nonm agnetic in purities in d-wave superconductors. In particular, within models explaining the single in purity LDOS as a K ondo resonance arising from a con ned spinon<sup>5,32</sup>, one m ay expect m ore novel changes as the distance between two nonm agnetic in purities is decreased. This is because the cost of frustrated dim ers decrease in this lim it m aking it unfavorable to break another dim er, and hence no spin is expected near the nonm agnetic in purities.
