W ave Propagation in Generalized Gyrotropic Media

W ave propagation inside generalized gyrotropic media is considered in the present Letter. It is shown that in this type of materials, the left- and right-handed circularly polarized light can be coupled to each other, which may possess some potential applications to quantum information.

Gyrotropic media whose electric permittivity and magnetic permeability are tensors has peculiar optical and electromagnetic properties [1,2]. Recently we proposed an experimentally feasible scheme of testing the so-called quantum vacuum geometric phases of zero-point electromagnetic elds in the helically curved optical bre by using the gyrotropic medium bre [3]. In this Letter, we investigate the wave propagation in a generalized gyrotropic medium with the following permittivity and permeability

This type of materials is a generalization of the ordinary gyrotropic medium with [1,2]

and can encom pass the electrom agnetic parameters of $_{ik}$ and $_{ik}$ in (1) m aterial responses experimentally obtained. A ssum e that the wave vector k of electrom agnetic wave propagating inside this medium is parallel to the the third component of the Cartesian coordinate system. A coording to Maxwellian Equations, one can arrive at

It should be pointed out that the interaction between left-and right-handed polarized light arises in Eq.(13), which is analogous to the Josephson's exect and may therefore be of physical interest.

The coupling of left-handed polarized light to the right-handed one can be characterized by the frequency shift $_{\rm L}$ and $_{\rm R}$, namely, the amplitudes of left- and right-handed circularly polarized light propagating along the 2-direction are written as follows

¹For sim plicity, without loss of generality, it is assumed that the two mutually perpendicular real unit polarization vectors $^{\mathbf{R}}(\mathbf{k};1)$ and $^{\mathbf{R}}(\mathbf{k};2)$ can be taken to be as follows: $^{\mathbf{R}}_{1}(\mathbf{k};1) = ^{\mathbf{R}}_{2}(\mathbf{k};2) = 1$, $^{\mathbf{R}}_{1}(\mathbf{k};2) = ^{\mathbf{R}}_{2}(\mathbf{k};1) = 0$ and $^{\mathbf{R}}_{3}(\mathbf{k};1) = ^{\mathbf{R}}_{3}(\mathbf{k};2) = 0$. Thus by the aid of the formula $\mathbf{E} = \frac{\theta \, \mathbf{A}}{\theta \, \mathbf{t}}$ for the electric eld strength, in the second-quantization framework one can arrive at [3]

which is a restricted condition regarding the frequency-shift relation between left- and right-handed circularly polarized light.

Note that in the case of conventional gyrotropic media characteristic of such permittivity and permeability tensors (2), where $d_e = b_e = d_h = b_h = 0$, $a_e = 1$, $c_e = 2$, $a_h = 1$, $c_h = 2$, the optical refractive index squared is of the form

and the coupling coe cients B are vanishing.

M ore recently, one of the articial composite metamaterials, the left-handed medium which has a frequency band (GHz) where the electric perm ittivity () and the magnetic perm eability () are simultaneously negative, has focused attention of m any authors both experim entally and theoretically [4{8]. In the left-handed m edium, m ost phenom ena as the Doppler e ect, Vavilov-Cherenkov radiation and even Snell's law are inverted. In 1964, Veselago $\,$ rst considered many peculiar optical and electromagnetic properties, phenomena and electromachism edium and referred to such materials as left-handed media, since in this case the propagation vector k, electrice ld E and magneticeld H of light wave propagating inside it form a left-handed system [1]. It follows from Maxwell's curl equations that such media having negative simultaneously negative and exhibit a negative index of refraction, i.e., $n = \frac{r}{n}$. In experim ents, the negative and can be respectively realized by using a network (array) of thin (long) metal wires [9] and a periodic arrangement of split ring resonators [6]. A combination of the two structures yields a left-handed m edium. Veselago's original paper and most of the recent theoretical works discussed mainly the characteristics of electrom agnetic wave propagation in isotropic left-handed media, but up to now, the left-handed media that have been prepared successfully experimentally are actually anisotropic in nature, and it may be very dicult to prepare an isotropic left-handed medium [10]. Hu and Chuipresented a detailed investigation on the characteristics of electrom agnetic wave propagation in uniaxially anisotropic left-handed media [10]. It is believed that the above-presented treatm ent of wave propagation in generalized gyrotropic media may be applicable to the uniaxially anisotropic lefthanded materials.
