C om m ent on "The nature of slow dynam ics in a m inim alm odel of frustration lim ited dom ains" by P.L.G eissler and D.R.R eichm an: In a recent paper G eissler and R eichm an<sup>1</sup> investigated a m odel w ith the H am iltonian

with scalar eld (r) in three dimensions using M onte C arbo simulations. The parameters of the model are the typical wave number,  $k_0$ , for modulations of , the "segregation strength", , between positive and negative , and the interaction strength, . M any years ago by B razovskii<sup>3</sup> argued that thism odelm ay undergo a uctuation induced rst order transition into a lamellar state.

We recently argued that systems described by Eq.1 may also undergo a self-generated glass transition, i.e. can become non-ergodic without the presence of quenched disorder<sup>4</sup>. This result was based on our earlier work<sup>5,6</sup> which demonstrated such glassiness in a related model discussed in the context of frustration lim ited domain formation by Kivelson et al.7. The qualitative features of that theory were con med in modecoupling calculations and M onte C arlo simulations of the corresponding lattice model by Grousson et al.8,9. The theory is based on a replica form alism and two key assum ptions were m ade in R efs.4,5,6: i) G lassiness can be studied within the mean-eld replica form alism with one step replica symmetry breaking which was shown to be marginally stable. ii) The self-consistent screening approximation (SCSA), including de Gennes narrowing, for the summation of the perturbation series in can be used. Recently we have been able to avoid this second assumption and found a complete solution of the mean eld replica equations by generalizing the dynam ic m ean

eld approach (DMFT) of correlated electron models<sup>10</sup> to the case of glassy system s.<sup>11</sup> G iven that our theory still relies on the applicability of the mean-eld replica form alism, computer simulations like those of Refs.1,8 remain crucial for a nal judgment on the existence of self generated glassiness in uniform ly frustrated systems of this type.

G eissler and R eichm an perform ed M onte-C arlo (M C) calculations and compared the results with two analytical approaches, one, a Hartree theory and the other, a mode coupling theory perform ed self-consistently up to second order in . For = 1,  $k_0 = 0.5$  and between 0:14 and 0, good agreem ent between the M C and Hartree approaches was obtained, whereas the primitive m ode-coupling theory yields glassy dynam ics already for

0:1, which was not seen in the M onte Carlo sim ulations. Thus, the M onte Carlo sim ulations could not con m the glassy dynamics found in m ode coupling calculations, but rather gave only fast, "liquid-like" relaxations. G eissler and R eichm an concluded that Eq.1 likely does not exhibit glassy dynamics.




FIG.1: Phase segregation strength at the dynam ic transition between the liquid and glass state as function of the coupling constant , obtained by using  $2^{nd}$ -order perturbation theory, the self consistent screening approximation (SC SA) of Refs.4,5,6 and the dynam ical mean eld theory (DM FT) of Ref.11. The diam onds indicate the parameters of the M onte C arbo calculations by G eissler and R eichman where only liquid like behavior was found. The SC SA and DM FT calculations are consistent with the M onte C arbo results whereas the  $2^{nd}$ -order calculation (similar to the mode coupling theory of R ef.1) strongly overestim ates glassiness.

In Fig.1 we compare our results for the dynamic transition between the liquid and glass state obtained within

the replica form alism and solved by using three di erent techniques: a self consistent second order theory (sim ilar to the mode coupling theory of Ref.1), the SCSA used in Refs.4,5,6 and the complete solution of the replica mean eld problem (DMFT) of Ref.11. In the second order calculation we determ ined the liquid state correlation function within Hartree theory, which seems to be closest to the procedure of R ef.1, who used M onte C arlo results for the liquid structure facture and nd that it is similar to the one obtained within the Hartree approach. The diam onds are the results of Geissler and Reichman (Figs.5 and 6 of Ref.1) where MC simulations give liquid like behavior. It is obvious from this plot that the results by G eissler and R eichm an indeed dem onstrate that a second order mode coupling theory gives a poor approximation for the location of the glass transition. However, their results cannot be used to rule out the glass transition we proposed. W ithin the complete solution of the replica mean eld theory this transition should occur only for -values sm aller than 0:2. In fact Fig. 2 of G eissler and R eichm an is not inconsistent with a very slow relaxation rate for < 02. Clearly, just as for any phase transition, even the best solution of the m ean eld approach m ight yield a phase boundary which is di erent from what the essentially exact M onte C arlo simulation nds. The key aspect of our theory was that

even a simple mean eld theory leads to a proliferation of metastable states and to an entropy crisis. Thus, self generated random ness emerges according to the random rst order transition scenario.<sup>12</sup>

That the param eters studied in Ref.1 are outside the region relevant for glassiness is consistent with their ndings that no indication for the rst order B razovskii transition was detected either. We argued in Ref.4 that the glass transition occurs due to the same type of uctuations and for similar param eters to the uctuation induced rst order transition proposed by B razovskii<sup>3</sup>. The absence of the glass transition could therefore m ost convincingly be demonstrated by showing the impossibility of achieving cooling rates that exceed nucleation rates.

In summary, the recent M onte Carlo calculations by G eissler and R eichman<sup>1</sup> are not conclusive in ruling out the self-generated glass transition proposed in R ef.5. N evertheless, if perform ed for param eters relevant for glassy behavior M onte C arlo calculations like theirs would be very useful in judging whether Eq.1 can be considered as a minim alm odel for glassiness or whether additional ingredients are needed. In addition they offer a powerful tool to study glassy dynamics beyond the limitations of replica mean eld theory.
