R abioscillations of 2D electrons under ultrafast intersubband excitation

W e investigate coherent nonlinear dynam ics of 2D electrons under ultrafast intersubband excitation by m id-IR pulses. W e include the e ects of relaxation and dephasing, both hom ogeneous and inhom ogeneous, as well as detuning within a non-M arkovian equation to obtain tem poralpopulation redistributions. W e show how, using a cross-correlation m ethod, the e ects of R abioscillations m ay be detected in this system, and brie y discuss other detection m ethods.

The coherent dynam ics and manipulation of two-level system s under ultrafast excitation dates back over three decades, where the majority of focus has been on atom ic ensembles [1]. During recent years, much attention has been given to interband coherent e ects in lowdim ensional heterostructures [2]. In particular, investigations of single quantum dots under interband ultrafast excitation $[\beta]$, where dephasing times can be hundreds of picoseconds, has seen the experim ental observation of Rabioscillations, providing the basis for possible readout devices for excitonic quantum gates [4]. P reviously, interband Rabioscillations under near-IR excitation had been observed in quantum well (QW) structures, albeit more highly suppressed by shorter dephasing times [5, 6]. Following these interband investigations we investigate the possibility of R abioscillations between n = 1 and n = 2conduction subbands in a QW under ultrafast mid-IR excitation. A dvances in m id-IR fem to second spectroscopic techniques [7] have culm inated with recent experim ental results [8] suggesting that 'partial Rabi ops' may be possible under relatively low pulse energies. Theoretical investigations of intersubband systems are therefore tim ely.

The occurrence of subband Rabioscillations under relatively low pump energies in low-doped QW s is made possible due both to the suppression of the LO -phonon em ission rate (assuming the interlevel energy is much greater than the optical phonon energy) and also the reduced e ciency of electron-electron scattering at low 10^{10} cm²). The inclusion of the 10 densities (role played by dephasing mechanisms is crucial for any description of coherent intersubband optics. W hilst a com plete treatment requires the full rigour of manybody calculations, we show in this paper that treating the di erent damping terms phenom onologically within a non-Markovian quantum kinetic scheme gives clear indications of the interplay between the various timescales involved, and provides insight into the possiblity of coherent manipulation. Experimental observations [9] show that carrier-carrier dephasing rates are e ectively independent of carrier density at low concentration (10^{10} cm 2). We therefore restrict our study to the low-density regime where the assumption of constant dephasing is approximately valid.

After introducing the fram ework of the two subband model, we consider the balance of population redistributions to derive an integro-di erential equation governing population dynamics under the in uence of an ultrafast pulse. By considering the ideal lim it, where dephasing and relaxation are neglected, we show that our model reduces to analytic expressions which essentially recover the area theorem [10]. The e ects of the various dam ping mechanisms are reintroduced in line with recent experim entalm easurem ents to investigate the degree of coherent behaviour which can realistically be observed. W e extend our calculations to analyse a detection scheme based on cross-correlation absorption under two-pulse excitation, and brie y discuss a scheme based on THz em ission from non-symmetric QW s. Such methods have previously been in plem ented for the near-IR interband pum p case [5, 11]. We conclude with a brief discussion on the approxim ations we have m ade.

We describe the coherent dynamics of the system using a density matrix approach, evaluating the balance equation for an interlevel redistribution of population under a resonant intersubband pump. We consider the response of the system due to the interaction with an electric eld E_t [E exp(i!t) + cx:]w perpendicular to the QW plane. The dipole perturbation operator is: $^{C}h_t \exp($ i!t) + H x:, with $^{C}h_t = (ieE = !) \hat{v}_2 w_t$, where \hat{v}_2 is the intersubband velocity operator and w_t is the form -factor of the pulse. We write the high-frequency component of the density matrix, $^{C}t \exp($ i!t) + H x:, in the form [12]:

where $_2$, the dephasing time, describes the decay of the induced coherence, and \hat{h} is the period-averaged H am iltonian of the QW. The density matrix averaged over the period 2 =!, $_{t}$, obeys the quantum kinetic equation

where \hat{I}_{sc} is the collision integral. The time-dependent generation rate, \hat{G}_t , is given by:

with non-M arkovian dependence on \uparrow_t . In the resonant approximation, we consider two states jjpi, j = 1;2, which we take to have parabolic dispersion laws, "j + $p^2=2m$. In this case one can neglect the o -diagonalterms in the density matrix under the condition: $h="_{21}$ 1, where " $_{21}$ is the interlevel energy and — is the characteristic relaxation time. A coording to particle conservation, we have that: $G_{1pt} = G_{2pt}$ G_{pt} , and the generation rate can be written in the form:

Here $f_{jpt} = hjpj_t jjpi$ is the population of the jth state, $h2j_{?}$ jli = $hlj_{?}$ j2i = $iv_{?}$ is the interband velocity, ! = ! "21= h the detuning frequency, and the kernel is given by t cos(!t) exp (t= 2). Taking into account the inhom ogeneous broadening of intersubband transitions we consider [13] an in-plane nonuniform intersubband energy "21 (x) = "21+ "x in the x-dependent generation rate G_{pxt} . By averaging over the 2D plane, the detuning term in the generation rate become es: hoss !xti. We therefore replace the kernel t in Eq. (4) with $t = t exp[(t=2h)^2]$ where $= h \frac{1}{x} \frac{r}{x}i$ is the energy broadening due to nonuniform ity.

W ithin this fram ework, we can now depne the concentration in the jth level as $n_{jt} = (2=L^2)_{p} f_{jp,t}$; L^2 is the normalisation area and the factor 2 is due to spin. The balance equations have the form :

where $G_t = (2=L^2)^P_{p}$ hjp $jG_t jjpi$ and $(@n_j=@t)_{sc} = (2=L^2)_{p}$ hjp $jI_{sc} jjpi$ describes interlevel relaxation. Due to particle conservation, $n_{1t} + n_{2t} = n_{2D}$ where n_{2D} is the total 2D concentration, so that $(@n_1=@t)_{sc} + (@n_2=@t)_{sc} = 0$. De ning the population redistribution $n_t = n_{1t} - n_{2t}$, and describing the interlevel relaxation by the relaxation time 1, we transform Eq. (5) into

where the generation rate G_t is expressed through n_t according to Eq. (4). We solve Eq. (6) subject to the initial condition $n_{t!-1} = n_{2D}$. Upon substitution of Eq. (4) into (6) we obtain the non-M arkovian integrodi erential equation

where we have introduced the phototransition frequency $_{r} = (2ev_{2} E = h!)^{2} _{p}$ with $_{p}$ the pulse duration. Factors which suppress the coherent response are described by the parameters $(_{1;2})^{1}$ and = h, as well as detuning of the pulse from resonance !.

Before we resort to numerical solution of Eq. (7), we consider analytic solutions in the limiting case $_{1;2}$! 1, ! 0, and !! 0, (i.e. t! 1). Eq. (7) can then be

transform ed into the second order di erential equation

to which we apply an additional boundary condition: $w_t^{1} d n_t = dt_{t!} = 0$. The population dynamics in this regime can be described by the expression




FIG.1: (a) Temporal population redistribution, n_t, for the ideal case ($_1$! 1; $_t$! 1) due to secant (thick solid curve) and G aussian (dashed curve) pulses of duration $_p$ (FW HM). The pulse pro les are shown as the thin solid (secant) and dotted curves (G aussian). Panels (i) and (ii) correspond to pulse areas (for secant pulse) $A_p =$ and 2.5 respectively. (b) The area theorem is recovered as naldistribution is plotted against secant pulse area (1:193^P $\frac{r_p}{r_p}$) for secant (solid curve) and G aussian (dashed curve) pro les.

which we illustrate in Fig. 1. As expected, population redistributions are solely determ ined by the area of the incident pulse: $A_p = \frac{p_{1} + p_{1}}{r_p_{1}} dzw_z$. In Fig. 1a we plot the solution as a function of time for both secant and G aussian pulses each with duration p_p (FW HM). As illustrated in panels (i) and (ii), which correspond to secant pulses with $A_p =$ and 2.5 respectively, population can be distributed among the two levels according to the area theorem. For xed values of r_p and p_p , the area under the G aussian pulse is slightly less than that under the secant pulse. The nal redistribution of population, shown in Fig. 1b as a function of the secant pulse area, $p_{1} = s$, where $s = 2 \sec 1$ [0.5], con m s this point.

The condition for population inversion, $A_p = can$ be obtained by a secant pulse, with duration $_p = 100$ fs, having a free space intensity per unit area of 5.22 MW /cm². In order to achieve maximum coupling of the transverse eld to the intersubband dipole, we consider a 45 prism integrated onto the sample. W ith this geom etry, approximately 33% of the incident power can be coupled to the transition. We assume parameters for a typicalG aA sQW, ofwidth 85 A, corresponding to an interlevelenergy of h! ' 100 m eV. B oth sets of parameters are typical of recent experiments [7].




FIG.2: The suppression of the ideal R abi op (solid curve) under 1.6 -pulse excitation (duration $_{\rm p}$ (FW HM)) due to: detuning (dot-dashed curve), inhom ogeneous broadening (dashed curve), hom ogeneous broadening (dotted curve) and LO -phonon em ission (dot-double-dashed curve). Each parameter is varied in turn with the rest set to ideal values.

To study the e ects of the various damping processes, we solve Eq. (7) numerically using a form of Picard iteration. We take as example a secant 1.6 -pulse, and gonsider the e ects of the parameters, 1, 2, ! ¹, and 2h =, setting each in turn to p with the other three set to the limiting values as outlined above. The results are shown in Fig. 2. LO -phonon emission (1) causes slow relaxation of the population back to the ground state after the pulse has passed. In contrast, the e ect of a large detuning as well as broadenings, both inhom ogeneous and hom ogeneous (2h =, 2), is to cause suppression of the Rabi op during the pulse. Clearly the potential for coherent manipulation depends on the interplay between these processes.




FIG.3: (a) Tem poralpopulation redistributions between subbands levels 1 and 2 due to excitation by a 100 fs (FW HM) secant pulse of area (i) , (ii) 3 . Decay parameters are taken to be $_2 = 320$ fs, $_1 = 1$ ps, corresponding to a two-level system hom ogeneously broadened by 4 m eV. A lso shown is the e ect of detunings of 6 m eV (dot-dashed curves) and 12 m eV (dashed curves). The fraction of population excited at 1 ps after the maximum pulse intensity is shown as a function of A_p in (b).

To include realistic estimates of these parameters, we take experim entally determ ined values of coherence tim es for a typical sample [8, 9]. Four-wave-mixing measurem ents provide a value for the hom ogeneous broadening corresponding to an electron-electron scattering time of the order 320 fs. LO-phonon em ission tim es are estim ated to be between 1-4 ps. As a conservative estim ate we take 1 = 1 ps and calculate the system response to a 100 fs (FW HM) pulse tuned to the 1! 2 transition at E = 100 meV, and allow for a detuning of up to 12 meV. In Figs. 3a, b we show the population redistributions due to these parameters. Although complete inversions are suppressed, we estim ate that up to 70-80% of the initial distribution can be coherently excited to the upper level with a resonant -pulse: Fig. 3a (i). E ects of pulse area can still be seen in the population 1 ps after the maximum of the pulse intensity. However the question rem ains as to whether these density ops can be detected experimentally. We now consider two possible scenarios.

Following the interband example [5], we calculate cross-correlation functions comparing changes in pulse modi cation due to transmission through unexcited and weakly excited samples. With the induced current density written in the standard form: $J_t = (2e=L^2)^{-1}_{jj^0p} v_{jj^0} hj^0 p j^0_{t} jjpi$, we can use Eq. (1) to express the induced current through n_t . The absorbed power, $P_t = \overline{J_t E_t}$ where the overline means the average

over the period, is written in the form :

The transm itted intensity of a single pulse is thus given by: $I_s = I_t P_t$, where $I_t / \not E_t \not f$. I_d , the transm itted intensity of an identical pulse after weak excitation of the sample by a prepulse, is similarly extracted from Eqs.




FIG. 4: D i erential cross-correlations, shifted vertically for clarity, for di erent pulse areas (num bers to the left of peaks) as a function of reference time delay, $_{\rm ref}$. Inset: Tem poral absorption (dotted curve) and density variation (solid curve) for the pulse with area $A_{\rm p}=1.25$.

(7) (10) using the two-pulse form -factor, w_t ! $w_t^{\text{pre}} + w_t$ where = $E = E_{\text{pre}}$ is the ratio of the maximum of the electric eld of the pulse and prepulse. The cross-correlation is thus:

where I_r (t $_{\rm ref}$) is the intensity of a reference pulse (we take I_r (t $_{\rm ref}$) / $E_t \hat{f}$). The interval between pulse and prepulse is kept xed at 600 fs allowing for no coherent interaction between pulses. The prepulse area is xed at $A_p^{(pre)} = 0.25$. The intensity (area) of the pulse and hence reference pulse is varied and the cross-correlation (11) calculated. The results are shown in Fig. 4. The appearance of zero crossings in the cross-correlation, which m ove to shorter time-delays with increasing pulse intensity, is exactly the behaviour expected due to Rabi ops. These crossings which occur due to the dependence of the cross-correlation signal on the tem poral derivative of the excitation density during the pulse, show that the system has been driven through a density maximum – a partial Rabi op.

In addition to this cross-correlation scheme, we envisage detection based on the charge oscillations of a Rabi opping population in a non-sym metric QW with dipole moments d_1 and d_2 . The temporal dependence of the induced dipole moment, $n_{1t}d_1 + n_{2t}d_2 / (1 \quad d_2=d_1) \quad n_t$, connects the temporal population dynamics, n_t , with the induced oscillations of the electric eld. The response can be measured by the method employed in [8], as well as by the emission of THz radiation. We note that the experimental method [11] used for the detection of THz radiation under interband excitation was carried out with carrier densities comparable to those we have considered.

Our calculations are based on a few assumptions. Since the Coloumb renormalisation of the intersubband absorption (due to depolarisation and exchange e ects) is weak in low-doped QW s [9, 13], we have adopted a single-particle approach. All hom ogeneous relaxation and dephasing mechanisms including electron-electron scattering and LO -phonon em ission have been considered phenom enologically with inhom ogeneous broadening included in the long-scale lim it. We expect that m icroscopic considerations based on many-body calculations of the various dam ping processes, taking into account inplane inhom ogeneities, m ay slightly m odify the nonlinear response. However, we do not expect large departures from this simple model for the low-density regime we have considered. Due to the prism geometry we have assummed, the nite length of the pulse, L, must be taken into account. For typical experim ental param eters we estim ate that L 15 m, thus setting a limit on the sam ple area, and hence am plitude of response we can describe. However, we note that the tem poral dynam ics we have described are not changed as L typically exceeds the characteristic kinetic lengths, $\overline{v}_{1;2}$ and \overline{v}_{r} , where \overline{v} is the characteristic in-plane velocity.

In conclusion, we have developed a simple description of R abioscillations between subband levels in low-doped QW s. We have considered the population dynamics of a two-level system under ultrafast mid-IR radiation in a non-M arkovian quantum kinetic model. Our calculations, based on realistic pulse and m aterial parameters, show that coherent m anipulation of the order of 10^6 electrons (depending on area of excitation) should be possible under relatively low-power excitations.
