Critical equation of state of random ly dilute Ising system s

Abstract

We determ ine the critical equation of state of three-dimensional random by dilute Ising systems, i.e. of the random-exchange Ising universality class. We rst consider the small-magnetization expansion of the Helmholtz free energy in the high-temperature phase. Then, we apply a systematic approximation scheme of the equation of state in the whole critical regime, that is based on polynomial parametric representations matching the small-magnetization of the Helmholtz free energy and satisfying a global stationarity condition. These results allow us to estimate several universal amplitude ratios, such as the ratio $A^+ = A$ of the specion-heat amplitudes. Our best estimate $A^+ = A = 1:6(3)$ is in good agreement with experimental results on dilute uniaxial antiferromagnets.

I. IN TRODUCTION.

The critical properties of random by dilute Ising systems have been much investigated experimentally and theoretically, see, e.g., Refs. [1{5] for reviews. The typical example is the ferrom agnetic random Ising model (RIM) with Hamiltonian

where J > 0, the rst sum extends over all nearest-neighbor sites, $s_i =$ spin variables, and i are uncorrelated quenched random variables, which are equal to one with probability p (the spin concentration) and zero with probability 1 p (the impurity concentration). Considerable work has been dedicated to the identication of the universal critical behavior of the R IM, and in particular to the determ ination of the critical exponents, which have been computed with great accuracy in experiments and in theoretical works. On the other hand, much less is known about the critical equation of state and the corresponding universal amplitude ratios. From the experimental side, this is essentially due to the fact that typical experim ental realizations of the R IM are uniaxial antiferrom agnets such as $Fe_xZn_1 \ _xF_2$ and $Mn_xZn_1 \ _xF_2$ m aterials, which are usually modeled by the Hamiltonian (1.1) with J < 0. For H = 0, there is a simple mapping between the ferrom agnetic and the antiferrom agnetic model, so that the critical behavior of the antiferrom agnets can still be obtained from that of the ferrom agnetic R $\mathbb{I}M$. The situation is more complex for \mathbb{H} Θ 0. The RIM (1.1) with H \(\frac{1}{2}\) 0 corresponds to an antiferrom agnet with a staggered magnetic eld that cannot be realized experim entally. Conversely, antiferrom agnets in a uniform m agnetic eld have a di erent critical behavior and belong to the sam e universality class of the ferrom agnetic random - eld Ising model [6]. For these reasons the equation of state of the R IM is not relevant for dilute uniaxial antiferrom agnets. However, from the equation of state one can derive amplitude ratios involving quantities de ned in the high-and lowtem perature phase that can be measured experimentally, see, eq., Ref. [3]. For example, the ratio A + = A of the speci c-heat am plitudes in the high-and low -tem perature phase has been determined: $A^+ = A = 1.6(3)$ (Ref. [7]), and $A^+ = A = 1.55(15)$ (Ref. [3]). On the theoretical side, only a few works, based on eld-theoretical (FT) perturbative expansions, have attempted to determine other universal quantities beside the critical exponents [8{12], obtaining rather imprecise results. For example, these calculation have not even been able to determ ine reliably the sign of the ratio $A^+ = A$. A ctually, -expansion calculations [9,10] favor a negative value, in clear disagreem ent with experim ents.

In this paper we determ ine the equation of state of the R IM in the critical region, that is the relation among the external eld H , the reduced temperature t $(T T_c)=T_c$, and the magnetization

where the overline indicates the average over the random variables $_{\rm i}$, and h i indicates the sample average at $_{\rm i}$ xed disorder. It can be written in the usual form as

where x and f (x) are normalized so that x = 1 corresponds to the coexistence curve, hence f (1) = 0, and f (0) = 1. In order to determine the critical equation of state in the whole critical region, we use an approximation scheme that has already been applied with success to the pure Ising model in three [13{15}] and in two dimensions [16]. We not consider the expansion of the equation of state in terms of the magnetization in the high-tem perature phase. The not few nontrivial coexients can be determined either from Monte Carlo simulations of the RIM or from the analysis of FT perturbative expansions. These results are then used to construct approximations that are valid in the whole critical region and that allow us to determine several universal amplitude ratios. For example, we anticipate our best estimate of the specion-heat amplitude ratio

which compares very well with the experimental determinations in dilute uniaxial antiferromagnets [7,3].

The paper is organized as follows. In Sec. II we discuss the general properties of the critical equation of state. In Sec. III we consider its small-magnetization expansion in the high-tem perature phase, reporting estimates of the rst few nontrivial terms, obtained by M onte Carlo simulations and FT methods. These results are used in Sec. IV to construct approximate polynomial parametric representations that are valid in the whole critical region and that allow us to achieve a rather accurate determination of the scaling function f(x). Finally, in Sec. V we determine several universal amplitude ratios, such as the speciotheat amplitude ratio $A^+ = A$. In App. A we report the denitions of the thermodynamic quantities that are considered in the paper. In App. B we discuss the correspondence between the R IM correlation functions and the correlation functions of the corresponding translation—invariant eld theory that is obtained by using the standard replicatrick. App. C reports some details on the six-loop FT calculation of the universal amplitude ratio R^+ .

II. THE CRITICAL EQUATION OF STATE

The equation of state relates the magnetization M, the magnetic eld H, and the reduced temperature t (T T_c)= T_c . In the neighborhood of the critical point t = 0, H = 0, it can be written in the scaling form

where B_c and B are the amplitudes of the magnetization on the critical isotherm and on the coexistence curve, see App.A. A coording to these normalizations, the coexistence curve corresponds to x = 1, and the universal function f(x) satisfies f(1) = 0 and f(0) = 1. The apparently most precise estimates of the critical exponents have been recently obtained by M onte Carlo simulations of the RIM: Ref. [17] obtains = 0.683(3) and = 0.035(2), while Ref. [18] reports = 0.6837(53) and = 0.0374(45). The FT estimates = 0.678(10) and = 0.030(3), obtained by analyzing six-loop xed-dimension series [19], are in good

agreement [20]. The other exponents , , and can be determined using scaling and hyperscaling relations.

The equation of state is analytic for f j> 0, implying that f(x) is regular everywhere for x > 1. In particular, f(x) has a regular expansion in powers of x around x = 0

At the coexistence curve, i.e., for x : 1, f(x) is expected to have an essential singularity [21], so that it can be asymptotically expanded as

The free energy of a dilute ferrom agnet is nonanalytic at H = 0 for all tem peratures below the transition tem perature of the pure system [22], which is larger than the critical tem perature of the dilute one. Therefore, at variance with pure systems, the equation of state of the R IM is also nonanalytic for t > 0 and H = 0. However, as argued in Ref. [23], these singularities are very weak and all derivatives remain nite at H = 0, as it happens at the coexistence curve. This allows us to write down an asymptotic large-x expansion of the form

It is useful to rewrite the equation of state in terms of a variable proportional to M $\,$ t , although in this case we must distinguish between $\,$ t> 0 and $\,$ t< 0. For t> 0 we de ne

The constants C and C_4^+ are the amplitudes appearing in the critical behavior of the two- and four-point susceptibilities and $_4$ respectively, see App.A. With the chosen normalizations [4],

The functions F(z) and (u) are clearly related to f(x). Indeed,

where $z_0 = (R_4^+)^{1=2}$ is a universal constant, see Sec. V.

In order to determ ine the critical equation of state, we rst consider its small-magnetization expansion. Then, we construct parametric representations of the critical equation of state based on polynomial approximations, which are valid in the whole critical region. This method have already been applied to the Ising universality class in three [13{15}] and two dimensions [16], and to the three-dimensional X Y and Heisenberg universality classes [24,25].

III. SM ALL-M AGNETIZATION EXPANSION IN THE HIGH-TEMPERATURE PHASE

A . Sm all-m agnetization expansion of the Helm holtz free energy

In the high-tem perature phase the quenched H elm holtz free energy A (t;M) adm its an expansion around M = 0:

and therefore the expansion (3.1) is strictly related to the expansion of the function F (z), cf. Eq. (2.6).

In the critical lim it the coe cients G $_{2j}$ of the expansion (3.1) are universal. They can be determined from the high-tem perature critical lim it of combinations of zero-m om entum connected correlation functions averaged over the random dilution

For the purpose of determ ining the small-magnetization expansion of the R \mathbb{M} equation of state, it is convenient to rewrite the Helmholtz free energy of the R \mathbb{M} , cf. Eq. (3.1), in the equivalent form

Some of these universal constants have been recently estimated by means of a Monte Carlo simulation [17], obtaining

B.Field-theoretical approach

One may estimate the universal quantities G_{2j} and r_{2j} by FT methods. The FT approach is based on an elective Landau-Ginzburg-Wilson Hamiltonian [26] that can be obtained by using the replicamethod,

where $'_{\rm i}$ is an N-component eld. The critical behavior of the RIM is expected to be described by the Hamiltonian H $_{\rm i}$ 4 for $u_0<0$ and in the limit N ! 0. Conventional FT

com putational schem es show that the $\,$ xed point corresponding to the pure Ising model is unstable and that the renormalization-group $\,$ ow $\,$ moves towards another stable $\,$ xed point describing the critical behavior of the R IM $\,$.

The most precise FT results for the critical exponents have been obtained in the fram e-work of the perturbative xed-dimension expansion in terms of zero-momentum couplings. The corresponding Callan-Symanzik -functions and the renormalization-group functions associated with the critical exponents have been computed to six loops [19,27].

The Helm holtz free energy A_{4} associated with the Hamiltonian (3.9) can be written as [28,29]

etc... It is worth noting that the other coe cients appearing in the small-magnetization expansion of the Helmholtz free energy (3.10), i.e. g_{41} , g_{61} , g_{62} , etc..., can be related to dilution averages of products of single-sample n-point correlation functions, as shown in App.B.

The quartic coupling G_4 can be estimated from the position of the R M xed point in the u, v plane, i.e. from the common zero of their —functions. The analysis of the six—loop perturbative series gives results somewhat dependent on the resummation method [19], see also the ve—loop analysis of Ref. [30]. Combining all results together, one nds 36:5 $^{<}$ G $_4$ $^{<}$ 39:5, which can be summarized as G_4 = 38:0(1:5). Such a result is not consistent with the M onte Carlo estimate (3.8), obtained by estimating the limit given in Eq. (3.4). But, as discussed in Ref. [17], the quantitative consequences for the determination of the critical exponents are very small, since the renormalization—group functions corresponding to the critical exponents turn out to be little sensitive to the correct position of the xed point [31] (along the Ising-to-R M renormalization—group trajectory, see also Ref. [32]).

The universal constants G_6 and $r_6 = G_6 = G_4^2$ have been estimated in Ref. [29] by analyzing the corresponding four-loop series with the Pade-Borelm ethod. These analyses provide the estimate $r_6 = 1:09$. We have reanalyzed this series, inding that, unlike critical exponents, r_6 is rather sensitive to the position of the execution of the model of the mode

expansion of r_8 $G_8=G_4^3$ to three loops. This requires the computation of the 8-point one-particle irreducible zero-momentum correlation function. At three loops this calculation requires the evaluation of 42 Feynm an diagram s. For this purpose we have used the general algorithm of Ref. [33]. The expansion of r_8 is

where the zero-m om entum quartic couplings u and v are normalized so that $u=u_0$ -m and $v=v_0$ -m at tree level (see App.C for precise de nitions). We have checked that Eq. (3.12) correctly reproduces the known series for the O (N) models [34] with N = 0;1 in the appropriate limits. Unfortunately, the analysis of the expansion (3.12) provides only a very rough estimate [35], $r_8=15(15)$. We will obtain a much better estimate of r_8 in Sec. IVB, from the results for the equation of state.

IV.APPROXIMATE REPRESENTATIONS OF THE CRITICAL EQUATION OF STATE

A . Polynom ial param etric representations

In order to obtain approxim at expressions for the equation of state, we parametrize the therm odynamic variables in terms of two parameters R and , implementing all expected scaling and analytic properties. Explicitly, we write [36]

where h_0 and m_0 are normalization constants. The variable R is nonnegative and measures the distance from the critical point in the (t;H) plane; the critical behavior is obtained for R! 0. The variable—parametrizes the displacements along the lines of constant R. The line—0 corresponds to the high-tem perature phase t>0 and H=0; the line—1 to the critical isotherm t=0; = 0, where 0 is the smallest positive zero of h(), to the coexistence curve T < T_c and H! 0. Of course, one should have 0 > 1 and h() > 0 for 0 < < 0. The function h() must be analytic in the physical interval 0 < 0 in order to satisfy the requirements of regularity of the equation of state (G ri ths' analyticity). Note that the mapping (4.1) is not invertible when its Jacobian vanishes [4], which occurs for $\frac{2}{1} = 1 = (1 - 2)$. Thus, a parametric representation is acceptable only if $\frac{1}{0} < \frac{1}{1}$. The function h() must be odd in , to guarantee that the equation of state has an expansion in odd powers of M j in the high-tem perature phase for M j! 0. Moreover, it can be normalized so that h() = +0(3).

The scaling functions f(x) and F(z) can be expressed in term s of . The scaling function f(x) is obtained from

where can be related to m_0 , h_0 , C^+ , and C_4^+ by using Eqs. (2.6) and (4.1).

Eq. (4.1) and the normalization condition h() for ! 0 do not completely x the function h(). Indeed, one can rewrite the relation between x and y in the form

Thus, given f(x), the value of h(1) can be arbitrarily chosen to completely x h(). One may x this arbitrariness by choosing arbitrarily the parameter in the expression (4.3). We approximate h() with polynomials, i.e., we set

This approximation scheme turned out to be elective in the case of pure Ising systems [13,14]. If we require the approximate parametric representation to give the correct (k-1) universal ratios r_6 , r_8 , \ldots , r_{2k+2} , we obtain

In the exact param etric representation, the coe cient h_3 can be chosen arbitrarily. This is no longer true when we use our truncated function h(), and the related approximate function $f_{\rm approx}^{(k)}$ (x; h_3) depends on h_3 . We must thus a particular value for this parameter. In order to optimize this choice, we employ a variational procedure [14], requiring the approximate function $f_{\rm approx}^{(k)}$ (x; h_3) to have the smallest possible dependence on h_3 . This is achieved by setting $h_3 = h_{3;k}$, where $h_{3;k}$ is a solution of the global stationarity condition

for all x. The existence of such a value of $h_{3;k}$ for each k is a nontrivial mathematical result which was proved in Ref. [14]. This procedure represents a systematic approximation scheme, which is only limited by the number of known terms in the small-magnetization expansion of the Helmholtz free energy. Note, for k=1, the so-called linear model, Eq. (4.9) gives

which was considered as the optimal value of h_3 for the Ising equation of state [37].

B.Results

We apply them ethod outlined in the preceding section, using the M onte C arlo estimates [17] = 0:683(3), = 0:035(2), g = 0:90(15) as input parameters. We obtain two dierent approximations corresponding to k = 1 and k = 2. Using the central values of the input parameters, we have

that provides the optim allinear model, and

The relatively small value of c_1 supports the electiveness of the approximation scheme. In Table I we report results concerning the behavior of the scaling function f(x), F(z),




FIG.1. The scaling function f(x).

and (u) for H = 0 and on the critical isotherm, cf. Eqs. (2.3), (2.4), (2.5), (2.8), (2.9), (2.10). The errors reported there are only related to the uncertainty on the corresponding input parameters. We consider the k = 2 results as our best estimates. Of course, the corresponding errors do not take into account the system atic error due to the approximation scheme. Nevertheless, on the basis of the preceding applications [14{16}] to the three- and two-dimensional Ising universality class, we believe that the k = 2 approximation already provides a reliable estimate, and that one may take the dierence with the k = 1 result as indicative estimate of (or bound on) the systematic error. For comparison, the last column reports the corresponding estimates for the Ising universality class, taken from Ref. [15]. In Fig. 1 we show the scaling function f(x), as obtained from the k = 1;2 approximations of h(), using the central values of the input parameters. The dierence between the two curves is rather small in the region 1 x < 1. For larger values of x some dierences are observed: they are essentially due to the small dierence (approximately 10%) in the corresponding values of \mathbf{f}_0^0 .

V.UNIVERSAL AMPLITUDE RATIOS

Universalam plitude ratios characterize the critical behavior of them odynam ic quantities that do not depend on the normalizations of the external (magnetic) eld, of the order parameter (magnetization), and of the temperature. From the scaling function f (x) one may derive many universalam plitude ratios involving quantities de ned at zero momentum (i.e. integrated in the volume), such as the specic heat, the magnetic susceptibility, etc.... For example, one can obtain estimates for the specicheat amplitude ratio $A^+=A^-$, the succeptibility amplitude ratio $C^+=C^-$, etc.... Then, using the results for G_4 and the relation

where C_4^+ , C^+ , and f^+ are respectively the amplitudes of the zero-momentum connected four-point correlation, the susceptibility, and the second-moment correlation length (see App. A for notations), we can also determine universal ratios involving the correlation-length amplitude f^+ .

In Table II we report estim ates of several am plitude ratios, as derived by using the approxim ate polynom ial representations of the equation of state for k=1;2. A gain, the errors reported there are only related to the uncertainty on the corresponding input param eters. Note that, in the most important case of $A^+\!=\!\!A$, the k=2 estimate includes the k=1 result within its error. As discussed in Sec. IV B, we consider the k=2 result as our best estimate for each quantity. As an indicative estimate of the total uncertainty, we take the maximum between the error induced by the input parameters and the dierence with the k=1 result. This would lead to the nal estimates $A^+\!=\!A=1:6(3)$, $C^+\!=\!C=5:5(1:0)$, $R^+_c=0:08(3)$, $R^+_4=12(2)$, R=2:1(3) and $G^{1=3}_4R^+=0:99(1)$.

The result for R^+ is in substantial agreement with the rather precise M onte C arlo estimate [17] $R^+=0.2885$ (15), providing support to our approximation of the equation of state. We have also obtained another independent estimate of the ratio R^+ by using the FT xed-dimension approach in terms of zero-momentum renormalized coulings. As discussed in detail in App. C we have extended the ve-loop calculation of Ref. [12] to six loops. The analysis of the perturbative expansions gives the estimate $R^+=0.290$ (10), which is in good agreement with the results from the equation of state and from M onte C arlo simulations.

The comparison with experiments on uniaxial antiferrom agnets, see, e.g., Ref. [3] for a review, is essentially restricted to the specion-heat ratio $A^+ = A$. Our best estimate $A^+ = A = 1.6$ (3) is in good agreement with the experimental result $A^+ = A = 1.6$ (3) reported in Ref. [7], and $A^+ = A = 1.55$ (15) reported in Ref. [8]. Earlier FT studies in the framework of and xed-dimension expansions [9{11] provided rather imprecise results. A ctually, they favored a negative value, in substantial disagreement with experiments.

O ther experim ental results concern the staggered magnetic susceptibility and the correlation length, see, e.g., Refs. [88,3], which are determined from neutron-scattering experiments. As noticed in Ref. [39], the two-point correlation function measured in these experiments does not coincide with

Let us sum marize the available numerical estimates for the above-reported quantities. The M onte Carlo simulations reported in Ref. [17] provided the results: $G_4 = 433(2)$, $G_{22} =$ 6:1(1), $r_6 = 0:90(15)$, $C_{42} = G_{42} = (G_4G_{22}) = 0:12(5)$, and $C_{222} = G_{22} = 0:45(15)$. For the six-point couplings, we obtain correspondigly $G_6 = 1:7(3)$ 10^3 , $G_{42} = 32(13)$, $G_{222} =$ 17(6). The available FT estim ates are more imprecise. For the four-point couplings, Ref. [19] applied dierent resum mation methods to the six-loop—functions, obtaining estimates that can be sum marized by $G_4 = 38.0(1.5)$, $G_{22} = 4.5(6)$. These estimates dier signicantly from the M onte C arlo ones, a discrepancy that is probably due to the non-B orel sum m ability of the perturbative series [40]. Estimates of G6 can be obtained from the results for r6 reported in Sec. IIIB. By using the M onte Carlo estimate of G_4 , we obtain $G_6 = 2100^{+200}_{-900}$. Results less dependent on the location of the xed point can be obtained by multiplying the estimate of r_6 at the FT (resp. M onte Carlo) xed point for the corresponding FT (resp. M onte Carlo) estimate of G_4 . At the FT xed point G_4 38 and $r_6 = 1:1(1)$ so that $G_6 = 1.6(2)$ 10^3 , while at the M onte Carlo xed point $G_4 = 43.3(2)$ and $r_6 = 0.6(3)$ that im plies $G_6 = 1:1(5)$ 10^3 . Taking as nalestim at that derived by using the FT estimate of G₄, we have G₆ = 1600^{+200}_{500} , where the error is such to include also the estimate at the M onte Carlo xed point. The results are only indicative since the estim ates change signi cantly with the order and with the Pade approxim ant. Comparing with the Monte Carlo results reported above we observe that eld theory (at four loops) provides only the order of magnitude, but is unable to be quantitatively predictive. Finally, we consider r_8 and G_8 . As discussed in Sec. IIIB (see also Ref. [35]), the perturbative three-loop expansion of r_8 gives only an upper bound. A much more precise estimate of r_8 has been derived in Sec. IV B, $r_8 = 1.5(5)$, which implies $G_8 = 12(4)$
