## Dicke E ect in the Tunnel Current through two Double Quantum Dots

We calculate the stationary current through two double quantum dots which are interacting via a common phonon environment. Numerical and analytical solutions of a master equation in the stationary limit show that the current can be increased as well as decreased due to a dissipation mediated interaction. This elect is closely related to collective, spontaneous emission of phonons (Dicke super- and subradiance elect), and the generation of a bross-coherence' with entanglement of charges in singlet or triplet states between the dots. Furthermore, we discuss an inelastic burrent switch' mechanism by which one double dot controls the current of the other.

### I. INTRODUCTION

The interaction with a dissipative environment can considerably modify the physics of very small systems which are described by a few quantum mechanical states only. One may think of an excited atom that decays via the emission of a photon due to the coupling to the radiation eld.<sup>2</sup> The in uence of the environm ent becomes even more important if not only a single system is coupled to it but many. This introduces an indirect interaction between the otherwise independent systems which can result in an entanglement and collective e ects of the small systems. In the case of identical excited atoms, the interaction to the common radiation eld strongly a ects the emission characteristics and leads to a collective spontaneous em ission, the so-called superradiance, as rst pointed out by R.H.Dicke<sup>3{5</sup> nearly half a century ago.

The in uence of a dissipative environment on a single two-level system, the smallest non-trivial quantum system, has been studied extensively with the spin-bosonm odel where the environment is modeled by a continuum of harm onic oscillators. Especially useful for the experim ental realization of two level systems are coupled sem iconductor quantum dots as these allow tuning of the param eters over a wide range. 6{10 M oreover, in these systems transport spectroscopy is possible by connection with leads<sup>8,10{22</sup>. The dissipative environment is given by the phonons of the sample and governs the inelastic current through the system .8,10,23{28 The electron spin<sup>29{32</sup> or the electron charge<sup>22,33</sup> in quantum dots have also been suggested to provide a controllable realization of scalable qubits. 29,30,34{37 A rrays of double quantum dots<sup>38</sup> correspond to charge qubit 'registers', and simple toy'm odels of N coupled two-level systems have been used to study collective decoherence e ects in qubit registers. 39{41 Furthern ore, controllable two-level system swith Cooperpairs tunneling to and from a superconducting box have been realized experim entally. 42,43

Coherent e ects in small clusters of two level systems caused by the coupling to a common environment have

been realized mainly in the eld of quantum optics. In ion laser traps, D icke sub- and superradiance has been measured by DeVoe and Brewer<sup>44</sup> in the spontaneous em ission rate of photons from two ions as a function of the ion-ion distance. Furthermore, entanglement in linear ion-traps can be generated by the coupling of (few-level) ions to a common single bosonicmode, the center-of-mass oscillator (vibration) mode<sup>45 (47)</sup>. Even the generation of entangled light from white noise<sup>48</sup> has been suggested.

The appearance of collective quantum opticale ects in m esoscopic transport has re-gained considerable interest quite recently. Shahbazyan and Raikh $^{49}$  rst predicted the Dicke (spectral function) e ect $^{50}$  to appear in resonant tunneling through two in purities, which was later generalized to scattering properties in a strong magnetic eld $^{51}$ . The Dicke e ect was predicted theoretically in bum ped', transient superradiance of quantum dot arrays coupled to electron reservoirs $^{52}$ , and in the AC conductivity of dirty multi-channel quantum wires in a strong magnetic eld. $^{53}$ 

In this work, we focus on coherent e ects in mesoscopic few level system s. As a realization, we choose two nearby but otherwise independent double quantum dots coupled to the same phonon environment. We study the in uence of the resulting indirect interaction on the transport properties and calculate the stationary current. Signatures of 'super'- and sub-radiance of phonons are predicted which show up as an increase or a decrease of the stationary electron current. W e dem on strate that this effect is directly related to the creation of charge wave function entanglement between the two double dots, which appears in a preferred formation of either a (charge) triplet or singlet con guration, depending on the internal level splittings and/or the tunnel couplings to the external electron leads in both sub-systems. Generation of entanglem ent via phonons becom es attractive in the light of recent investigations of single-electron tunneling through individual molecules 54 (58, or quantum dots in freestanding<sup>59{62</sup> and movable<sup>63{66</sup> nano-structures, in both of which vibration properties on the nanoscale seem to play a big role.

The outline of the paper is as follows. In section II we

introduce the m odeland our m ethod. Current supermadiance is discussed in section III. Section IV presents current subradiance and the inelastic current 'sw itch' m echanism . Finally, we conclude in section V .

#### II. MODEL AND METHOD




FIG. 1: A:N=2 tharge qubit register with two double quantum dots coupled to independent electron leads. B:en-ergy diagram of one individual double dot.

Our model is a system ('register') of two double quantum dots (DQDs), each of which consist of two individual quantum dots (called 'left' and 'right' in the following). Both double dots are coupled to independent left and right leads as depicted in Fig. 1 A .

We concentrate on boson-mediated collective e ects between the DQDs originating from the coupling of the whole system to a common dissipative, bosonic bath that will be specified below. In the following we completely neglect static tunnel coupling between the individual DQDs and, more important, inter-DQDC oulomb correlations. Although this is a severe limitation for the general applicability of the model, it still grasps the essential physics of dissipation induced entanglement. However, one might envisage congurations with intradot Coulomb matrix elements much larger than interdot matrix elements.

In this paper, we choose the simplest possible description of an environment coupling in close analogy to the standard spin-boson Hamiltonian. The results of this model for the tunnel current through one double dot are in relatively good agreement with experimental observations  $^{22,23}$ . The role of o-diagonal terms in a single DQD has been discussed recently  $^{67}$ .

## A. Ham iltonian

The Ham iltonian and the subsequent derivation of the master equation is given for the general case of N double quantum dots. We study the stationary tunnel current through the dots with all lead chemical potentials such that electrons can only ow from the left to the right. Furtherm ore, we restrict ourselves to the strong C oulom b blockade regim e in each individual double dot where only one additional electron is allowed on either the left or the right dot. The Hilbert space of the i-th double dot then is spanned by the three m any-body states L; ii (one additional electron in the i-th left dot at energy "L;i), R; ii (one additional electron in the i-th right dot at energy "R;i), and D;ii (no additional electron in either of the dots). For N = 1 this has been proven  $^{12,23}$  to be a valid description of non-linear transport experim ents in double quantum dots<sup>8,10</sup>.

Introducing the operators

the total H am iltonian can be written as

Here, the electrons in mode k (1) with energy  $\mathbf{w}_{k\,(1)}^{L\,(R\,)}$  in the left (right) leads pertaining to DQD i are described by creation operators  $\mathbf{c}_{k,i}^{y}$  ( $\mathbf{d}_{1,i}^{y}$ ), and the coupling matrix elements to the leads are denoted by  $\mathbf{V}_{k,i}^{L\,=R}$ . A boson in mode q with energy  $\mathbf{1}_{q}$  is created by the operator  $\mathbf{a}_{q}^{y}$ . As in the standard spin-boson model, we assume a simplied coupling to the quantum dots which is purely diagonal with matrix element  $\mathbf{q}_{;i}$  for mode q to the i-th double dot.

So far, no further assum ptions have been m ade with respect to the speci c realization of the DQDs and the dissipative bath. Nevertheless, the system we have in m ind are lateral or vertical double dots, where the primary bosonic coupling has been shown due to phonons of the sem iconductor substrate. The m icroscopic details determ ine the tunnel matrix elements  $T_{\rm c;i}$ ,  $V_{\rm k;i}^{\rm L=R}$ , and the electron-phonon coupling constants  $_{\rm g;i}$ .

## B. Density matrix

In the following, we employ a master equation description for the time evolution of the register within the Bom-Markov approximation, which takes into account the interactions with the leads and the bosonic environment up to second order. A Itematively, electron-phonon interactions can be treated exactly by a polaron transformation  $^{22,23}$  and perturbatively in the tunnelmatrix elements  $T_{\rm c;i}$ . For  $T_{\rm c;i} < J^{\rm L}_{\rm Li}$   $J^{\rm L}_{\rm R}_{\rm i}$  j and small coupling to the bosonic bath, the results of both methods practically coincide  $^{25}$ .

The time derivative of the reduced density matrix (t) of the double quantum dots is given by

where the tilde indicates the interaction picture, H  $_{\rm e}$  (H  $_{\rm p}$ ) denotes the interactions between the double dots and the leads (the phonons), and R  $_{\rm 0;e}$  (R  $_{\rm 0;p}$ ) is the density m atrix of the leads (the phonons). E quation (3) is the sum of an electron and a phonon part since we neglect correlations between leads and phonons.

The trace over the equilibrium electron reservoirs,  $Tr_{R\,es,e}$ , results in Ferm i functions of the leads. As we are interested in large source-drain voltages between the left and the right leads, the Ferm i functions of the left leads can be set to one and those of the right leads to zero. Moreover, the energy dependence of the tunnel rates

is neglected.

## 1. Electron-phonon interaction

In the following, we consider identical electron-phonon interaction in the D Q D s,

Depending on the relative position of the quantum dots (lateral, vertical), the electron wave functions in the dots, and the geometry of the phonon substrate (bulk,  ${\rm slab}^{27}$ , sheet etc.), the q;i will never be exactly identical in real situations. Therefore, Eq. (5) can only be regarded as an idealized lim it of, e.g., a phonon resonator or a situation where the distance between di erent double dots is small as compared to the relevant phonon wavelengths.

that results from the trace over the bosonic degrees of freedom . Here,  $\ =\ 1=k_B$  T denotes the inverse phonon bath temperature, and the spectral function  $\ \ \,$  (!) of the bosonic environment is denoted as

For the calculations, we use the spectral function of bulk acoustic phonons with piezoelectric interaction to electrons in lateral quantum  $dots^{23,25}$ ,

where g is the dimensionless interaction strength,  $!_{\,\rm c}$  the cut-o frequency and the frequency  $!_{\,\rm d}$  is determined by the ratio of the the sound velocity to the distance between two quantum dots.

In the following, integrals over K (t) are required as

with the hybridization energy  $_{i}=(\mbox{"}_{i}^{2}+4T_{\text{c};i}^{2})^{1=2}$  and the energy bias  $\mbox{"}_{i}=\mbox{"}_{L\,;i}$   $\mbox{"}_{k\,;i}$  in the i-th dot. The integrals are calculated neglecting the principal values  $^{22}$ . ## 2. Master equation

Inserting the traces over the electron reservoirs and the bosonic bath into Eq. (3) and transform ing back to Schrodinger picture yields a master equation for the reduced density matrix of the totalDQD register,

From Eq. (9) it is obvious that the in uence of the bosonic bath enters only via the spectral functions (!) as de ned in Eq. (7). All m icroscopic properties of the phonons and their interaction mechanism to the electrons in the quantum dots are described by these functions.

Furtherm ore, we point out that the mixed term  $si \in j$  in Eq. (10) are responsible for the collective e ects to be discussed in the following. Without these terms, the master equation would merely describe an ensemble of N independent DQDs. In that case, an initially factorized density matrix of the total system would always remain factorized and no correlations could build up. The terms  $i \in j$  introduce correlations between the dierent double dots, the origin of which lies in the coupling to the same bosonic environment.

### III. CURRENT SUPERRADIANCE

We restrict ourselves to the stationary case where the time derivative of the density matrix, \_(t), vanishes. Then, Eq. (10) reduces to a linear system of equations which can be easily solved numerically. Results for a single double quantum dot, N = 1, can be obtained analytically and are given for two expectation values below, Eq. (17). For N > 1, the dimension of the density matrix grows as  $9^N$  (although not all of the matrix elements are required) whence analytical solutions become very cumbersome. For the rest of this paper, we restrict ourselves to the case of two double dots (N = 2), called DQD 1 and DQD 2 in the following.

## A. Stationary current

The total electron current is  $\sin p \ln p$  given by the sum of the currents through the individual DQDs, as electrons cannot tunnel between dierent double dots. The current operator of DQD is

The set of linear equations corresponding to Eq. (10) for N=2 is given in appendix A, Eq. (A1). From the num erical solution of Eq. (A1) we not the stationary current through two double quantum dots as a function of the




FIG. 2: Total current through two double quantum dots as a function of the bias " $_1$ . The parameters are  $T_{\rm c;1}=T_{\rm c;2}=3$  eV ,  $_{\rm L;1}=_{\rm R;1}=_{\rm L;2}=_{\rm R;2}=0.15$  eV , and for the spectral function g=0.01, T=23m K , ! $_{\rm d}=10$  eV and ! $_{\rm c}=1m$  eV . These values are used throughout the whole article if not stated otherwise.

bias " $_1$  in the rst double dot while the bias " $_2$  in the second is kept constant, cf. Fig. 2. The overall shape of the current is very similar to the case of one individual double quantum  $\det^{23,25}$ , with its strong elastic peak around " $_1$  = 0 and a broad inelastic shoulder for " $_1$  > 0. The interesting new feature here is the peak at the resonance " $_1$  = " $_2$  which is due to collective e ects to be analyzed now.

## B. Cross coherences

The e ective interaction between the two DQDs results from the simultaneous coupling of both double dots to the same phonon environment. It appears in the master equation (10) as the mixed terms if j in the sum. In the explicit form of the master equation (A1), the effective interaction is connected to six matrix elements only (and their complex conjugates). These elements are RLLL, LRLL, RRLR and RRRL, allofwhich enter the expression for the current, Eq. (13), and the two bross coherence'm atrix elements

Therefore, we approximate the collective elects caused by the elective interaction starting from the solution of the non-interacting master equation, without the mixed terms if j, and assume that only those matrix elements mentioned above are a ected by the interaction.

In the non-interacting case, the cross coherence is  $\sin -$  ply the product of the corresponding matrix elements of independent double dots,

In the inelastic regime,  $T_c$  ", of the non-interacting case, the cross coherences  $p_1^yp_2$  and  $p_1p_2$  tend to zero as can be seen from Eq. (17). Moreover, we neglect the imaginary part of the cross coherences in the interacting case. Then, the change in the current through DQD 1 due to collective e ects can be approximated by




FIG. 3: Real parts of the cross coherences from the master equation (10) as functions of the bias in the rst double dot ( $^{11}$ <sub>2</sub> = 30 eV and the other parameters agree with Fig. 2). The inset compares the approximation for Re  $p_1^y p_2$ , Eq. (20) (dotted line), with the solution of the master eq. (solid line).

Correspondingly, the change I $_2$  of the current through the second double dot DQD 2 is obtained from I $_1$  by exchanging the subscripts 1 and 2. Hence, the alteration in the current is proportional to the real parts of the cross coherences  $p_1^yp_2$  and  $p_1p_2$  between the two DQDs, which con rms the collective character of the elect. This result is corroborated by plotting the real parts of the cross coherences as a function of  $\mathbf{I}_1$ , cf. Fig. 3. One recognizes that  $p_1^yp_2$  is peaked around  $\mathbf{I}_1 = \mathbf{I}_2$ , whereas  $p_1p_2$  has a peak at  $\mathbf{I}_1 = \mathbf{I}_2$ . The increase of the current at  $\mathbf{I}_1 = \mathbf{I}_2$  is therefore due to the maximum of the rst correlation  $p_1^yp_2$ .

If we neglect the changes of all other elements of the density matrix that are caused by the elective interaction between the two DQDs, the real part of the cross coherence  $p_1^y p_2$  can be approximated around the resonance " $_1 =$ " $_2$  as

One recognizes that  $p_1^yp_2$  is Lorentzian shaped as a function of the energy di erence  $"_1$   $"_2$ . The result of Eq. (20) with  $hp_ji$  and  $hn_{L;j}i$  as given in Eq. (17) is in good agreement with the numerical solution of the master equation (10) (inset of Fig. 3).

Next, we insert the result for the cross coherence in Eq. (19) and nd for the change of the tunnel current due

to interaction e ects between the two double quantum dots around the resonance  $\mathbf{u}_1 = \mathbf{u}_2$ :

A gain, the change in the current through the second double dot,  $I_2$ , is obtained by exchanging the subscripts. This approximation overestimates the actual change in the current for the parameters chosen in the previous section but provides a good qualitative description for the e ect of the enhanced tunnel current. A comparison between this result and the numerical solution is given below.

## C. Singlet and triplet states

The collective e ects in the two double quantum dots are connected with the cross coherence function  $\ p_1^y p_2$  , Eq.(15). For the 'two-qubit register' one can easily prove the operator identity

## D. Dicke e ect

Superradiance emerges in the collective spontaneous em ission from an ensemble of identical two-level atoms. If N excited atoms are concentrated in a region smaller than the wavelength of the emitted radiation, they do not decay independently anymore. Instead, the radiation has a higher intensity and takes place in a shorter time interval than for an ensemble of independent atoms due to the coupling of all atoms to the common radiation eld.

Let us now consider the case N=2 and calculate (sim ilar to the original work of Dicke<sup>3</sup>) the decay rate of two initially excited atom s with dipole moments  $\hat{d}_1$  and  $\hat{d}_2$ ) at position  $r_1$  and  $r_2$  due to the interaction with light,

where Q =  $!_0$ =c,  $!_0$  is the transition frequency between the upper and lower level, and c denotes the speed of light. The interference of the two interaction contributions  $\hat{d}_1 e^{i(Q r_1)}$  and  $\hat{d}_2 e^{i(Q r_2)}$  leads to a splitting of the spontaneous decay into a fast, 'superradiant', decay channel (  $_+$  (Q )), and a slow, 'subradiant' decay channel (  $_-$  (Q )). This splitting is called D icke-e ect'.

Loosely speaking, the two signs correspond to the two di erent relative orientations of the dipole moments of the two atoms. More precisely, from the four possible states in the Hilbert space of two two (level systems,  $H_2 = C^2$   $C^2$ , one can form singlet and triplet states

according to  $\mathfrak{F}_0$  i =  $\frac{1}{r_2}$  (j"#i j#"i),  $\mathfrak{F}_r$  i = j""i,  $\mathfrak{F}_0$  i =  $\frac{1}{r_2}$  (j"#i+ j#"i), and  $\mathfrak{F}$  i = j##i. The superradiant decay channel occurs via the triplet and the subradiant decay via the singlet states<sup>3,68</sup>. In the extreme Dicke' lim it where the second phase factor is close to unity, exp [iQ ( $r_2$   $\mathfrak{F}_1$ )] 1, it follows that (Q) = 0 and  $\mathfrak{F}_1$  (Q) = 2 (Q) where (Q) is the decay rate of one single atom. This lim it is theoretically achieved if  $\mathfrak{F}_2$  ( $\mathfrak{F}_2$   $\mathfrak{F}_1$ )j 1 for all wave vectors Q, i.e. the distance between the two atoms is much smaller than the wave length of the light.

We mention that in practice, this pure' limit, where the subradiant rate is zero and the superradiant rate is just twice the rate for an individual atom, is never reached. In a recent experimental realization of sub- and superradiance from two laser-trapped ions, DeVoe and Brewer^4 measured the spontaneous emission rate of photons as a function of the ion-ion distance in a laser trap of planar geometry which was strong enough to bring the ions (Ba $^+_{138}$ ) to a distance of the order of 1 m of each other.

In contrast to a two level atom, a third state 10 i exists in the double quantum dot as the additional electron can tunnel into the leads.

The use of triplet and singlet states as de ned in Eq. (23) allows us to nd an analytical result for the stationary current that quantitatively coincides with the exact num erical solution extremely well. We consider the rate equation for the probabilities of the corresponding nine states and take into account the doubling of the inelastic rates due to the Dicke ect in the triplet channel,




FIG. 4: Enhancement of the tunnel current I<sub>1</sub> at the resonance  $"_1 = "_2 = 30$  eV as a function of the dimensionless electron phonon coupling constant g, Eq. (8). The additional current vanishes at g 0.02 when the tunnel rates to the double dot and between the dots become equal, = . The inset shows the difference in probabilities for triplet and singlet.

Here, identical tunnel rates to all four leads have been assum ed,  $_{\rm L}$ ;  $_{\rm l}$ =  $_{\rm R}$ ;  $_{\rm l}$ =  $_{\rm L}$ ;  $_{\rm l}$ =  $_{\rm R}$ ;  $_{\rm l}$ =  $_{\rm R}$ ; and  $_{\rm L0}$  denotes the probability to nd the rst double dot in state  $_{\rm L}$ i and the second in state  $_{\rm l}$ i. Electrons can also tunnel into and out of the singlet state due to the coupling to the leads which is not possible in the original Dicke model. In the stationary case, the Eq. (27) can be easily solved. For the current through one of the two double dots we obtain

This can be compared with the tunnel current through one independent double dot,  ${\bf I}_1^0$  obtained by a similar rate equation,

The di erence I  $_1$  = I $_1$   $_1^0$  represents the additional current due to the D icke e ect and is shown in Fig. 4 as a function of the dimensionless coupling strength g to the bosonic environment, together with a comparison to the I  $_1$  as obtained from the numerical solution of Eq. (10). Both results agree very well, indicating that it is indeed the D icke e ect that leads to the increase in the tunnel current. In addition, we show (inset of Fig. 4) the dierence between triplet and singlet occupation probability that follow from the Eq. (27) as

This is in excellent agreement with the numerical results and underlines that the change in the tunnel current due

to collective e ects is proportional to  $p_{T_0}$   $\ p_{t_0}$ , as already discussed above. This demonstrates that the e ect of superradiance ampli es the tunneling of electrons from the left to the right dots resulting in an enhanced current through the two double quantum dots.

## IV. CURRENT SUBRADIANCE AND IN ELASTIC SW ITCH

The close analogy with the Dicke e ect suggests the existence of not only current super, but also current subradiance in the register. In the subradiant regime, the two DQDs form a singlet state where the tunneling from the left to the right quantum dots is diminished, resulting in a weaker tunnel current through the dots.

### A. Current antiresonance




FIG. 5: Transition from an increased to a decreased current through the rst double quantum dot for di erent tunnel rates  $_{\rm R}$ ;2 (in eV) and  $^{\rm u}_{\rm 2}=30$  eV. The left inset shows schem atically the set-up for  $_{\rm R}$ ;2 = 0 and the right inset gives the di erence of triplet and singlet for the same case.

Subradiance occurs in our system in a slightly changed set-up where electrons in the second double dot are prevented from tunneling into the right lead,  $R_{i,2} = 0$ , as indicated in the inset of Fig. 5. Then, the additional electron is trapped and no current can ow through the second double dot. Nevertheless, this electron can a ect the tunnel current through the rst double dot: Instead of a maximum, we now nd a minimum at the resonance  $"_1 = "_2$ . Fig. 5 shows how the positive peak in the current  $I_1$  develops into a m in im um as the tunneling rate  $R_{:2}$  is decreased to zero. This minimum is indeed related to an increased probability of nding the two dots in the singlet state  $\mathfrak{F}_0$  i rather than in the triplet state  $\mathfrak{F}_0$  i, as can be seen from the inset of Fig. 5. Thus, in this regime the e ect of subradiance dom inates, leading to a decreased current.

This behavior is again consistent with the approximation Eq. (20) for the cross coherence  $p_1^yp_2$ . Taking into account the dierent non-interacting matrix elements in the two double dots,  $hn_{\rm L}, i \in hn_{\rm L}, 2i$  and  $hp_1 i \in hp_2 i$  due to  $_{\rm R}, i \in _{\rm R}, 2$ , we not a negative cross coherence at the resonance from Eq. (20). This corresponds to an increased probability for the singlet state and according to Eq. (21) to a negative peak in the tunnel current, in agreement with our numerical solution.

## B. Inelastic current switch

Up to now, we have regarded the cross coherence  $p_1^yp_2$  and its e ects on the current only at the resonance  $\textbf{\textit{"}}_1=\textbf{\textit{"}}_2$ . However, it was already pointed out in section IIIB that another cross coherence,  $p_1p_2$ , exhibits a resonance if the bias in one dot equals the negative bias in the other dot,  $\textbf{\textit{"}}_1=\textbf{\textit{"}}_2$  (cp. Fig. 3). This case is considered in the following.




FIG. 6: Tunnel current through the second double dot which is blocked due to a negative bias,  $\mathbf{u}_2 = 50$  eV, as depicted in the inset (g=0:015). The approximation for I<sub>2</sub>, Eq. (31) (dashed line), agrees well with the result of the master equation (10) (solid line { the nite o set of which is the tail of the elastic current at  $\mathbf{u}_2 = 0$ ).

We use a xed negative bias  $"_2 < 0$  in the second double dot as indicated in the inset of Fig. 6. Consequently,

electrons cannot tunnel from the left to the right dot such that the second double dot is blocked and no current can ow through it. The presence of the rst double dot, though, lifts this blockade and enables a current through the second double dot if the resonance condition " $_1$  = " $_2$  is fullled. The current  $I_2$  is shown in Fig. 6 as a function of the bias in the rst double dot, " $_1$ . Due to the coupling to the common phonon environment, energy is transferred from the rst to the second double dot, allowing electrons to tunnel from the left to the right in the second double dot. At the same time, the current through the rst double dot is decreased (not shown here).

We can approximate the current through the second double dot around " $_1$  = " $_2$  taking into account only  $p_1p_2$  in Eq. (19). A similar calculation as for  $p_1^yp_2$ , Eq. (20), gives

with =  $_1$  =  $_2$  evaluated at the resonance, where both systems are identical except of the bias. This approximation again is in good agreement with the numerical solution of Eq. (10), as can be seen from Fig. 6.

Our results suggest that the current through one of the DQDs can be switched on and o by appropriate manipulation of the other one. We emphasize that this mechanism is mediated by the dissipative phonon environment and not the Coulomb interaction between the charges. As this e ect is very sensitive to the energy bias, it allows to detect a certain energy bias in one double dot by

observing the current through the other double dot.

### V. CONCLUSION

In this work, we have investigated collective e ects in two double quantum dots. An indirect interaction arises between the two double dots due to the coupling to the sam e phonon environment. We predict that the Dicke e ect causes a considerable increase or decrease of the tunnel current, depending on the choice of the param eters. The occurrence of the Dicke e ect in the transport through m esoscopic system s has already been pointed out by Shahbazyan and Raikh<sup>49</sup>. In their system, the coupling to the same lead is responsible for collective e ects. U sually, the Dicke e ect manifests itself in a dynamic process like the spontaneous em ission of an ensemble of identical atom  $s^{44,69}$  . Transport through double quantum dots, however, allows to study a time independent form of the Dicke e ect. Moreover, we have demonstrated that the change of the tunnel current is connected with an entanglem ent of the di erent double dots. This opens the possibility to realize and to measure specic entangled states of two double dots. In particular, one can switch from a predom inant triplet superposition of the two double dots connected with an increased tunnel current to a predom inate singlet state leading to a reduced current.

The results discussed here were derived for the ideal case of an identical electron-phonon coupling in both double quantum dots. Furtherm ore, the Coulomb interaction between the two double dots has not been considered here. In a real experiment, these assumption will never be perfectly fulled and would lead to deviations

We have derived the master equation for the general case of N double dots but only focused on N = 2 which is the sim plest case where collective e ects occur. In general, one of the main characteristic features of superradiance is the quadratic increase of the e ect with increasing number of coupled systems. For the spontaneous collective emission from N excited two levelatoms, this means that the maximum of the intensity of the emitted radiation increases with the square number of systems, N  $^2$ , while the time in which the decay takes place decreases inversely to the number of systems, 1=N . Therefore, we expect that the collective e ects as presented here become even more pronounced ifmore than two double dots are indirectly coupled by the common phonons.

# APPENDIX A:MASTER EQUATION FOR TW O DOUBLE QUANTUM DOTS

The dimension of the density matrix for N double quantum dots is equal to  $9^N$  such that the master equation (10) corresponds to 81 coupled di erential equations for N = 2. It is, however, not necessary to solve all 81 equations as we study the current which requires the knowledge of only six matrix elements, cp. Eq. (13). The smallest closed subset of equations, containing the equations for those six elements consists of 25 equations.

The m ixed terms in the master equation (10), i for j, describing the indirect interaction between the two DQDs due to the coupling to the same phonons, are marked in the following with an additional prefactor q. Setting  $q\!=\!0$  results in the master equation for two completely independent double dots coupled to independent phonons. The interacting case corresponds to  $q\!=\!1$ . Note that the elements of the density matrix are expressed with respect to the basis fj.i; Ri; Dig for each double dot. Due to the tunneling of electrons between the left and right quantum dot, these states are no eigenstates of the unperturbed H am iltonian. Finally, the master equation for the elements of the density matrix reads
