Prelim inary Preparations: Scattering Problem of Double-layered Sphere Containing Left-handed Media

In this paper, we present M ie coe cients of double-layered sphere and consider the scattering problem, including the topics on eld distribution, electrom agnetic cross section, extinction spectra as well as some potential peculiar properties arising from the presence of left-handed media. The form ulation presented here can be easily generalized to cases of multiple-layered spheres.

I. IN TRODUCTION

M ore recently, a kind of articial composite media (the so-called left-handed media) having a frequency band where the e ective perm ittivity (") and the e ective perm eability () are simultaneously negative attracts attention of m any researchers in various elds such as materials science, condensed matter physics, optics and electromagnetism [1{5]. Veselago rst considered this peculiar medium and showed that it possesses a negative index of refraction [6]. It follows from the M axwell's equations that in this medium the P oynting vector and wave vector of electrom agnetic wave would be antiparallel, i. e., the vector k, the electric eld E and the magnetic eld H form a left-handed system; thus Veselago referred to such materials as \left-handed", and correspondingly, the ordinary medium in which k, E and H form a right-handed system may be termed the \right-handed"medium. Other authors callthis class of m aterials \negative-index m edia (N IM)", \double negative m edia (D N M)" [5] and V exelago's m edia. It is readily veri ed that in such media having both "and negative, there exist a number of peculiar electrom agnetic properties, for instance, many dramatically dierent propagation characteristics stem from the sign change of the group velocity, including reversals of both the Doppler shift and the Cherenkov radiation, anomalous refraction, modied spontaneous em ission rates and even reversals of radiation pressure to radiation tension [2]. In experim ents, this articial negative electric perm ittivity m edia m ay be obtained by using the array of long m etallic wires (ALM W s), which simulates the plasm a behavior at microwave frequencies, and the articial negative magnetic permeability media may be built up by using small resonant metallic particles, e. q., the split ring resonators (SRRs), with very high magnetic polarizability

The extinction properties of a sphere (single-layered) with negative perm ittivity and perm eability is investigated by Ruppin. Since recently W and and A sher developed a novel method to fabricate nanocomposite SiO $_2$ spheres (100 nm) containing hom ogeneously dispersed Ag quantum dots (2 5 nm) [10], which may has potential applications to design and fabrication of photonic crystals, it is believed that the absorption and transmittance of double-layered sphere deserves consideration. In this paper, both the M is coexients and the electromagnetic eld distributions in the two-layered sphere containing left-handed media irradiated by a planar electromagnetic wave are presented.

In what follows we treat the M ie coe cients of double-layered sphere irradiated by a plane wave.

A.De nitions

We consider a double-layered sphere with interior radius a_1 and external radius a_2 having relative perm ittivity (perm eability) a_1 (a_1) and a_2 (a_2), respectively, placed in a medium having the relative perm ittivity a_1 and perm eability a_2 . Suppose that the double-layered sphere irradiated by the following plane wave with the electric amplitude a_1 along the 2-direction of Cartesian coordinate system [11]

Note that here in order to obtain m $_{\rm eln}^{(3)}$ and $n_{\rm oln}^{(3)}$, the spherical Bessel functions j_n in the spherical vector function m $_{\rm eln}^{(1)}$ and $n_{\rm oln}^{(1)}$ is replaced by the Hankel functions $h_n^{(1)}$, namely, the explicit expressions for m $_{\rm eln}^{(3)}$ and $n_{\rm oln}^{(3)}$ can also be obtained from (2.6), so long as we replace the spherical Bessel functions j_n in (2.6) with the H ankel functions $h_n^{(1)}$. Thus in this case the extinction cross section of the two-layered sphere containing left-handed media is rather large. (ii) If the following conditions $h_n^{(1)}(N_{2-1})=0$, $h_n^{(1)}(N_{2-1})=0$, $h_n^{(1)}(N_{2-2})=j_n(2)$, $h_n^{(1)}(N_{2-2})=[j_n(2)]^0$, $N_2=2=2=2=1$ and $N_2=1$ are satisfied, then it is easily verified that

Thus in this case the extinction cross section of the two-layered sphere containing left-handed media is negligibly small.

(iii) The case with $N_1 = 1 = 1 = 1$, $N_2 = 2 = 2 = 0$, $N_0 = 0 = 0 = +1$ is of physical interest, which deserves consideration by using the M ie coexcients presented above.

Based on the calculation of Mie coe cients, one can treat the scattering problem of double-layered sphere irradiated by a plane wave. The scattering and absorption properties of double-layered sphere containing left-handed media can thus be discussed in detail, which are now under consideration and will be submitted elsewhere for the publication.
