Spin-dependent R abioscillations in single quantum dot

U ltrafast optical pump of exciton resonance in single quantum dot by an elliptically polarized laser pulse is described by the non-M arkov balance equations. Population and spin dynam ics are investigated and spin-dependent R abioscillations are considered for the case of a at quantum dot, with the lateral size greater than the height. The following peculiarities of tem poral evolution have been found: a) a beating of R abioscillations under an elliptically polarized pump and b) quenching of spin orientation due to a spin-orbit splitting e ect.

Investigations of excitonic excitations in a single quantum dot (SQD) have been started in the past decade (see recent Refs. in [1]). The Rabi oscillations and spinrelated e ects in a QD ensemble have also been investigated, see [2] and [3] respectively. Recently the Rabi oscillations of electron population has been reported in SQD excited by ultrashort laser pulse [4, 5]. Due to this, an examination of the spin-dependent ultrafast response in SQD is now tim ely. In this paper, we consider the spindependent coherent dynamics of an exciton in a SQD under ultrafast interband pump by elliptically polarized radiation.

A temporal evolution of the exciton is described by the 2 2 spin-dependent density matrices written in the basis of the vacuum and excited excitonic states. These density matrices are governed by the balance equations with a non-M arkov generation rate which is dependent on the population redistribution. For the simplest case of a weak spin-orbit interaction, allowing the only interband transitions between the same spin states, a + or circular polarized pump can only excite spin-down or spin-up states. Since a temporal response under an elliptically polarized pump can be considered as a superposition of Rabioscillations under polarized pumps with dierent intensities, a beating of Rabioscillations takes place. For the more complicated case involving spin-orbit interaction in c-band, one can obtain a quenching of spin orientation in a SQD even under the circular polarized pump. Below, we have considered these phenomena in the framework of a at QD model, with the lateral size greater than the height, and have estim ated the maxim al degree of spin orientation.

W e consider the coherent dynam ics of a Q D under resonant interband excitation described by the perturbation operator [$H_t \exp(i!t) + H \infty$:]. The averaged over period, 2 =!, density matrix, $\hat{R_t}$, obeys the following quantum kinetic equation (see evaluation in [6, 7]):

where ! + 0 and $\hat{S}_t = \exp(i\hat{H}t=h)$ describes evolution of QD with the H am iltonian \hat{H} . The transitions between the spin-degenerate c-band and v-band states are described by the matrix

Here we consider the interband photogeneration caused by the electric eld E [e exp(i!t)+ cx:]w_t, with the unit complex polarization vector e, and w_t = exp[$(t=_p)^2$] is the G aussian form -factor of the pulse, $_p$ stands for the pulse duration. The polarization-dependent m atrix $\hat{g}_e = (e \ \hat{v}_{cv})$ is written through the interband velocity m atrix element, \hat{v}_{cv} , and \hat{g}_e is the non-Herm itian m atrix because e for e.

Below, we shall restrict our consideration to the vicinity of the excitonic resonance when \hat{R}_t can be replaced by the diagonal matrix $\hat{P}_{o,t} = 0$ with 2 2 matrices $\hat{P}_{o,t}$ and $\hat{P}_{o,t}$ describing the excited (e-) and vacuum (o-) states respectively. In agreement with the experimental conditions [5], we have neglected here the two-photon biexcitonic resonance, see [2, 8] and Refs. therein. Thus, we transform Eqs.(1,2) into the following form:

where h ! is the detuning energy with respect to the exciton peak energy. Adding these Eqs. we obtain that $^{e_{t}}$ + $^{o_{t}}$ is a time-independent matrix which is determined through initial conditions (see below).

To calculate the matrix \hat{g}_e we neglect the Coulomb renorm alization of the interband velocity matrix element and consider

Here v_{jj^0} is the 8 8 interband velocity matrix and x is the in-plane vector. For the at QD model, we write the overlap integral in (3) through the in-plane envelope functions $_{jx}$. Here we have replaced the transverse contribution to the overlap integral by unit considering transitions between top v-band states and bottom c-band states. N eglecting the nonparabolic (/ p^3) contributions, we describe the v-band states by $\binom{h}{x}$ j i, where $\binom{h}{x}$ takes into account the heavy-light hole m ix [6] and j i corresponds to the degenerate spin state directed along OZ with the spin numbers = 1. Taking into account noticeable spin-orbit e ects in c-band we write the eigenstate problem for spinor $\binom{c}{x}$ as follows:

where ^ are the Paulim atrices, m is the electron e ective m ass, and the characteristic spin velocity v_s is along the growth axis, 0 Z [6, 9].

We shall restrict our consideration to the case of weak spin-orbit e ect, performing the unitary transformation $_{x}^{(c)} = \exp[$ im ([y x])=h]'_x. Taking into account / v_{s}^{2} contributions only, we obtain the Schrödinger equation in the form :

We consider this equation with the zero boundary condition $r_{xj}^{(c)} = 0$; the curve is bounded by a at QD with the area S. Note that the momentum operator here, $p = x \models h$, is along OZ, so that the spinor r_x is proportional to the above introduced spinor j i.

Next, using the two-levelbasis including the low erelectron states with = 1 and the upper hole states with 0 = 1, we obtain the only non-zero m atrix elements (2) for the transitions je;1i ! je;1i and je; 1i ! je; 1i; see sim ilar selection rules in [6, 10]. For the case of elliptically polarized excitation described by e = $_{+}$ e + e , where e are the polarization vectors for circularwaves and are com plex num bers (m oreover j + j + j j = 1), we obtain the matrix g_{e} in the form :

The non-zero coe cients here are written through

where P is the K ane velocity. The overlap integral here have been calculated for the cases of circular and square QDs when the num erical coe cient is equal to 0.11 and 0.32 respectively. A suppression of them atrix element (7) with increasing v_s also takes place for the conic QD case [11].

We describe the coherent dynam ics by the use of the diagonal population numbers for the excited and ground states, $n_{e;t} = he; j_{e;t} j_{e;t} j_{e;t}$ i and $n_{o;t} = ho; j_{o;t} j_{o;t} j_{t}$; i.

The system (3) is transformed into the independent equations for the states with = 1:

Here we have introduced the kernel $_{tt^0} = w_t w_{t^0} \cos ! (t t^0)$, and $_r = 2 (eE = h!)^2 j_r j_p^2$ is the characteristic photogeneration rate. Since $n_{e; lt} + n_{o; lt}$ are independent of time, and the oscillation strengths for transitions are proportional to j = j, we use the phenom enological conditions in the form

which is in pagreement with the particle conservation requirement $(n_{e t} + n_{o t}) = 1$. Using Eqs.(9), we obtain the closed equation for the population di erences, $n_{t} = n_{o; tt} \quad n_{e; tt}$, in the form :

with the initial conditions $n_{t!} = j f$ which are obtained from Eq.(10) and $n_{e; t!} = 0$.

The concentration of photoexcited electrons is given by $n_t = n_{e;t} + n_{e;t}$ while the spin orientation, S_t , is determined as follows $S_t = \frac{1}{2} h_{e;t}$; j^je; in $e_{e;t}$. The only z-component of spin appears to be non-zero and

where $k = \begin{bmatrix} R \\ dx \\ x \end{bmatrix}^{(c)+}_{x} z \\ x \end{bmatrix}^{(c)}_{x}$ and is the coe cient from Eq.(8). The spin orientation is proportional to the redistribution between the spin states, n_t , and the factor k decreases with increasing v_s .

For the resonant excitation case, ! = 0, the kernel in Eq.(11) is not dependent on t t^0 , one obtains the second-order di erential equation

with the use of an additional initial condition $[w_t^{-1}dn_t = dt]_{t!} = 0$. The solution of Eq.(13) takes the form :

where $A = p_{rp}$ is the excitation amplitude and $j = (1 \ s)=2$ with the degree of circular polarization $s = j_+ j_- j_- j_-$.

In Fig.1 we plot the tem poral evolution of n_t and n_t for the cases of circular, elliptical (with s = 1=2), and linear polarized pumps under the resonant excitation condition ! = 0. Note that $n_t = n_t$ and $n_t = 0$ for the

cases of circular and linear polarized pumps respectively. For the -pulse excitation case (if A =), one obtains monotonic increase of n_t with $n_{t! \ 1} = 1$ for the circular pump. The spin redistribution, $n_t < 0$, varies with t = p in a similar manner. As the excitation amplitude increases, the temporal evolution becomes oscillatory, as shown in Fig.lb for A = 3.5. These dependencies have di erent periods, for the circular, linear, and elliptically polarized pumps.

Next we consider the detuning e ect by calculating the solution of Eq.(11) numerically. In Fig.2 we plot the tem poral evolution of n_t and n_t under dierent ! p. The detuning results in suppression of both the Rabi op after the pulse and the am plitude of oscillations if A > . The characteristics of the tem poral response for dierent polarizations of pump do not change in comparison with the resonant case.

The oscillations of Rabi opping population, n $n_{t! 1}$, and the redistribution between the spin states, $n \quad n_{t! 1}$, are shown in Fig.3 for the resonant excitation case. The harm onic dependencies with periods A = 2 and $A = 2^{1} 2$ take place for the circular and linear polarized pumps respectively. By contrast, one can see a beating ofn and n with A under the elliptically po-

larized pump. Moreover, the spin orientation m ay change a sign for this case; once again, n = n and n = 0 for the circular and linear polarized cases respectively.

Let us discuss the assumptions used in the above calculations. The main restriction is the consideration of the vicinity of the excitonic resonance without the contribution of two-photon biexcitonic resonance. Here we have applied the phenom enological initial conditions for Eq.(11). This is valid if h ! and h= $_{\rm p}$ are smaller than the exciton-biexciton splitting energy (around 3m eV in InG aA s QD s) while a more detailed many-particle consideration is required for greater h ! and/or h= $_{\rm p}$. We also have described the coherent response neglecting relaxation because $_{\rm p}$ is shorter than the relaxation times. Next, the non-M arkov equation (1) describes the interband generation of electron-hole pairs to second order accuracy, i.e. we have supposed that the energy jeft $v_{\rm p}$ =! is much lower than the energy gap. Finally, the sim ple m odelofQD has been used in order to obtain Eqs.(8,12) and m ore complicated num erical calculations, e.g. sim ilar to [12], have to be perform ed in order to improve these sim ple form ulas.

In conclusion, we have considered the peculiarities of R abioscillations in a single quantum dot due to the spindependent ultrafast excitation by an elliptically polarized pulse. For the simple model of SQD with the spinip transitions forbidden we have found both the beating of R abi oscillations under an elliptically polarized pump and the quenching of spin orientation due to spin-orbit splitting e ect. A more detailed treatment of these effects requires the consideration of complicated selection rules and to describe the exciton-biexciton resonance in the fram ework of a many-particle approach. W hat this paper does, however, is to determ ine the conditions for observation of the peculiarities mentioned.
