# Spin-dependent $R$ abioscillations in single quantum dot

#### Abstract

U ltrafast optical pum $p$ of exciton resonance in single quantum dot by an elliptically polarized laser pulse is described by the non-M arkov balance equations. Population and spin dynam ics are investigated and spin-dependent R abioscillations are considered for the case of a at quantum dot, w ith the lateral size greater than the height. T he follow ing peculiarities of tem poral evolution have been found: a) a beating of $R$ abioscillations under an elliptically polarized pum $p$ and b) quenching of spin orientation due to a spin-orbit splitting e ect.

Investigations of exciton ic excitations in a single quantum $\operatorname{dot}$ (SQD) have been started in the past decade (see recent R efs. in $\left[\begin{array}{ll}{[1]} \\ ]\end{array}\right)$. T he R abioscillations and spinrelated e ects in a QD ensemble have also been inves-
 oscillations of electron population has_been reported in SQ D excited by ultrashort laser pulse [ [-4, 'IT1. D ue to this, an exam ination of the spin-dependent ultrafast response in $S Q D$ is now tim ely. In this paper, we consider the spindependent coherent dynam ics of an exciton in a SQD under ultrafast interband pum $p$ by elliptically polarized radiation.

A tem poral evolution of the exciton is described by the 22 spin-dependent density $m$ atrioes $w$ ritten in the basis of the vacuum and excited excitonic states. These density $m$ atrioes are govemed by the balance equations w th a non -M arkov generation ratew hich is dependent on the population redistribution. For the sim plest case of a weak spin-orbit interaction, allow ing the only interband transitions betw een the sam e spin states, $a+$ or circular polarized pum $p$ can only excite spin-dow $n$ or spin-up states. Since a tem poral response under an elliptically polarized pum p can be considered as a supenposition of Rabi oscillations under polarized pum ps with di erent intensities, a beating of R abi oscillations takes place. For the $m$ ore com plicated case involving spin-orbit interaction in ctband, one can obtain a quenching of spin orientation in a SQD even under the circular polarized pum p. Below, we have considered these phenom ena in the fram ew ork of a at QD m odel, w ith the lateral size greater than the height, and have estim ated the $m$ axim al degree of spin orientation.

W e consider the coherent dynam ics of QD under resonant interband excitation described by the perturbation operator [ $\left.\mathrm{Fi}_{\mathrm{t}} \exp (\mathrm{i}!\mathrm{t})+\mathrm{H}: \mathrm{c}:\right]$. The averaged over period, $2=$ !, density $m$ atrix, $\hat{\mathrm{R}_{\mathrm{t}}}$, obeys the follow ing quantum kinetic equation (see evaluation in $\overline{[G}, \bar{\prime}, \overline{1} 1])$ :

where $!+0$ and $\hat{S_{t}}=\exp (i \hat{H} t=h)$ describes evolution of QD w th the $H$ am iltonian $\hat{H}$. The transitions betw een the spin-degenerate $c-b$ and and v -band states are described by the $m$ atrix

H ere we consider the interband photogeneration caused by the electric $e l d \mathrm{E}[\mathrm{exp}(\mathrm{i}!\mathrm{t})+\mathrm{c}: \mathrm{c}:] \mathrm{w}_{\mathrm{t}}, \mathrm{w}$ ith the unit complex polarization vector $e$, and $w_{t}=\exp \left[(t=p)^{2}\right]$ is the Gaussian form-factor of the pulse, $p$ stands for the pulse duration. T he polarization-dependent $m$ atrix $g_{\mathrm{e}}=\left(\mathrm{e} \hat{v}_{\mathrm{cv}}\right)$ is written through the interband velocity $m$ atrix elem ent, $\hat{v}_{c v}$, and $g_{e}$ is the non $H$ erm itian $m$ atrix because e e.

Below, we shall restrict our consideration to the vicinty of the excitonic resonance when $\hat{R_{t}}$ can be replaced by the diagonalmatrix $\hat{e}_{0}^{\hat{e}_{\text {et }}} 0_{\hat{o}_{0, t}}^{0}$ with $2 \quad 2 \mathrm{~m}$ atrioes $\hat{e}_{e, t}$ and $\hat{o}_{o, t}$ describing the excited (e-) and vacuum (o-) states respectively. In agreem ent $w$ ith the experim ental conditions [ $[\underline{1} 1]$ ], we have neglected here the tw o-photon

where $h$ ! is the detuning energy $w$ ith respect to the exciton peak energy. A dding these Eqs. we obtain that $\hat{e}_{\text {et }}+\hat{o}_{o t}$ is a tim e-independent $m$ atrix which is deter$m$ ined through initial conditions (see below).

To calculate the $m$ atrix $g_{e}$ we neglect the Coulomb renom alization of the interband velocity $m$ atrix elem ent and consider

the overlap integral in (3) through the in-plane envelope functions jx . H ere we have replaced the transverse contribution to the overlap integral by unit considering transitions betw een top $v-b$ and states and bottom $\mathrm{c}-b$ and states. N eglecting the nonparabolic (/ $\mathrm{p}^{3}$ ) contributions, we describe the $v$-band states by ${ }_{x}^{\prime(h)} j i$, where ${ }_{x}^{(h)}$ takes into account the heavy-light hole $m$ ix [ [G] and $j$ i corresponds to the degenerate spin state directed along 0 Z w th the spin numbers $=1$. Taking into account noticeable spin-orbit e ects in chband we w rite the eigen-

$w$ here ^ are the $P$ aulim atrioes, $m$ is the electron e ective m ass, and the characteristic spin velocity $\mathrm{v}_{\mathrm{s}}$ is along the grow th axis, O Z [G, ', '91].

W e shall restrict our consideration to the case of w eak spin-orbit e ect, perform ing the unitary transform ation

W e consider this equation $w$ ith the zero boundary condition ${ }_{x j}^{(c)}=0$; the curve is bounded by a at $Q D$ $w$ th the area $S . N$ ote that them om entum operator here, $[\hat{0} \mathrm{x}]=\mathrm{h}$, is along O Z , so that the spinor' x is proportional to the above introduced spinor $j$ i.

N ext, using the tw o-levelbasis including the low er electron states w th $=1$ and the upper hole states w ith

where $P$ is the $K$ ane velocity. The overlap integral here have been calculated for the cases of circular and square QDswhen the num ericalcoe cient is equal to 0.11 and 0.32 respectively. A suppression of them atrix elem ent (7) $w$ th increasing $v_{s}$ also takes place for the conic $Q D$ case [111].
W e describe the coherent dynam ics by the use of the diagonalpopulation num bers for the excited and ground

Here we have introduced the kemel $\mathrm{tt}^{\circ}=$ $w_{t} W_{t}{ }^{0} \cos !\left(t \quad t^{0}\right)$, and $r=2(e E=h!)^{2} j_{3} \jmath_{p}$ is the characteristic photogeneration rate. Since $n_{e ; ~ 1 t ~}+n_{0}$; it are independent of time, and the oscillation strengths for transitions are proportional to $j f$, we use the phenom enological conditions in the form

where $k={ }^{R} d x{ }_{x}^{(c)+} \hat{z}_{z}{ }_{x}^{(c)}$ and is the coe cient from Eq.(8). The spin orientation is proportional to the redistribution betw een the spin states, $n_{t}$, and the factor $k$ decreases $w$ ith increasing $v_{s}$.

For the resonant excitation case, ! = 0, the kemel in Eq.(11) is not dependent on $t \quad t^{0}$, one obtains the second-order di erential equation

In $F$ ig. 1 we plot the tem poral evolution of $n_{t}$ and $n_{t}$ for the cases of circular, elliptical (w ith $s=1=2$ ), and linear polarized pum ps under the resonant excitation condition ! $=0$. N ote that $n_{t}=n_{t}$ and $n_{t}=0$ for the

cases of circular and linear polarized pum ps respectively. For the pulse excitation case (if $A=$ ), one obtains $m$ onotonic increase of $n_{t} w$ ith $n_{t!1}=1$ for the circular pump. The spin redistribution, $n_{t}<0$, varies $w$ ith $t=p$ in a sim ilar $m$ anner. As the excitation am plitude increases, the tem poralevolution becom es oscillatory, as shown in $F$ ig. 1 b for $A=3: 5$. T hese dependencies have di erent periods, for the circular, linear, and elliptically polarized pum ps.

N ext we consider the detuning e ect by calculating the solution ofEq.(11) num erically. In Fig 2 we plot the tem poral evolution of $n_{t}$ and $n_{t}$ under di erent ! $p$. The detuning results in suppression ofboth the R abi op after the pulse and the am plitude ofoscillations ifA $>$. $T$ he characteristics of the tem poral response for di erent polarizations of pum $p$ do not change in com parison $w$ ith the resonant case.

The oscillations of Rabi opping population, $n$ $n_{t!1}$, and the redistribution betw een the spin states,
 citation case. T he harm onic dependencies w ith periods $A=2$ and $A=2^{\overline{2}}$ take place for the circular and linear polarized pum ps respectively. B y contrast, one can see a beating ofn and $n$ w ith A under the elliptically po-

larized pum p. M oreover, the spin orientation $m$ ay change a sign for this case; once again, $n=n$ and $n=0$ for the circular and linear polarized cases respectively.

Let us discuss the assum ptions used in the above calculations. The $m$ ain restriction is the consideration of the vicinity of the excitonic resonance w thout the contribution of two-photon biexcitonic resonance. H ere we have applied the phenom enological initial conditions for Eq.(11). This is valid if $h!$ and $h=p$ are smaller than the exciton-biexcition splitting energy (around 3 meV in InG aA s Q D s) while a m ore detailed many-particle consideration is required for greater $h$ ! and/or $h={ }_{p}$. We also have described the coherent response neglecting re-
laxation because p is shorter than the relaxation tim es. $N$ ext, the non $M$ arkov equation (1) describes the interband generation ofelectron-hole pairs to second order accuracy, i.e. we have supposed that the energy je $\mathcal{j} \mathrm{v}_{\text {? }}=$ ! is much lower than the energy gap. Finally, the sim ple m odelofQ D has been used in order to obtain Eqs. $(8,12)$ and $m$ ore com plicated num erical calculations, e.g. sim ilar to [1] ], have to be perform ed in order to im prove these simple form ulas.

In conclusion, we have considered the peculiarities of Rabioscillations in a single quantum dot due to the spindependent ultrafast excitation by an elliptically polarized pulse. For the sim ple $m$ odel of SQD w ith the spinip transitions forbidden we have found both the beating of Rabioscillations under an elliptically polarized pum $p$ and the quenching of spin orientation due to spin-orbit splitting e ect. A m ore detailed treatm ent of these effects requires the consideration of com plicated selection rules and to describe the exciton-biexciton resonance in the fram ew ork of a $m$ any-particle approach. W hat this paper does, how ever, is to determ ine the conditions for observation of the peculiarities $m$ entioned.
