We report a new algorithm to generate Laplacian G rowth Patterns using iterated conformal maps. The di culty of growing a complete layer with local width proportional to the gradient of the Laplacian eld is overcome. The resulting growth patterns are compared to those obtained by the best algorithm s of direct num erical solutions. The fractal dimension of the patterns is discussed.

Laplacian G row th Patterns are obtained when the boundary of a 2-dimensional domain is grown at a rate proportional to the gradient of a Laplacian eld P [1]. The classic examples of such patterns appear in viscous

ngering in constrained geom etries (like Hele-Shaw cells or porous media). Here a less viscous uid (inside the domain bounded by ) displaces a more viscous uid which is outside the domain. The eld P is the pressure, and D arcy's law determ ines the velocity v to be proportional to r P. Using the incom pressibility constraint outside the dom ain  $r^2 P = 0$ , and each point of is advanced at a rate proportional to r P [2, 3]. Thus in num erical algorithm s [4] one needs at each tim e step to add on a whole layer to the pattern with a local width proportional to 'r P j. The boundary conditions are such that in radial geometry as r! 1 the ux is  $rP = const \hat{r}=r.0$  n the one usually solves the problem with the conboundarv where dition P =is the surface tension and the local curvature of [3]. W ithout this (or som e other) ultraviolet regularization Laplacian G rowth reaches a singularity (in the form of a cusp) in nite time [5]. In this Letter we present a new algorithm to grow such patterns using iterated conformalmaps. The basic method was introduced [6] in the context of Di usion Limited Aggregation (DLA) [7] where it was successfully employed to solve a number of outstanding problems in the theory of DLA [8, 9], its fractal dimension [10, 11] and its multifractal properties [12, 13, 14].

At the heart of the m ethod stands the elementary m ap ; which transform s the unit circle to a circle with a \bum p" of linear size around the point  $w = e^i \cdot W e$ em plby the elementary m ap [6]

This map grows a sem i-circular bump with two branch points at the angular positions , where

$$= \tan^{-1} \frac{2^{p-1}}{1} : \qquad (2)$$

By iterating this fundam entalm ap with random ly chosen angles  $_{n}$  and the bump sizes  $_{n}$  chosen such as to obtain

equal size particles on the cluster,

$$n = \frac{0}{(n \ 1)^0 (e^{i_n})^2};$$

one can easily grow a DLA pattern. On the other hand, the direct application to the closely related problem of viscous ngering remained unaccomplished due to technical di culties that have been now sum ounted, as we report below.

We are interested in (n) (w) which conform ally maps the exterior of the unit circle  $e^i$  in the mathematical w {plane onto the complement of the Laplacian pattern in the physical z{plane. As in previous work the map (n) (w) is obtained by iteration of fundamental maps

 $j_{j,j}$  (w). The superscript n denotes n grow th steps. The gradient of the Laplacian eld r P (z (s)) is

$$p (z(s)) j = \frac{1}{(n)^{0} (e^{i})}; \quad z(s) = (n) (e^{i}) : (3)$$

Here s is an arc-length param etrization of the boundary. Contrary to DLA which is grown serial, i.e. particle by particle, in Laplacian growth for the problem of viscous ngering we need to grow in parallel, i.e. layer by layer. Nevertheless the map (n) (w) is still constructed recursively. Suppose that we completed the last layer at grow th step m, i.e. (m) (w) is known, and we want to nd the m ap (m + p) (w) which m aps the exterior of the unit circle to the exterior of the pattern after the addition of one more layer whose local width is proportional to jr P (z (s)) j. The num ber p of growth events should be arranged precisely such as to add the aforem entioned layer. To grow a full layer of non-overlapping bum ps using the elementary map (1) is di cult because the series of sizes  $f_{m+k}g_{k=1}^{p}$  and of positions  $f_{m+k}g_{k=1}^{p}$  depend on each other.

Consider then the (m + k)th step of growth that we implement at the angle  $_{m+k}$ . Due to the reparam terization during the p growth steps k = 1;2;:::pwe need rst to nd an angle  $_{m+k}$  according to the following rule. For a given position, the size has to be such that its image under the map  $_{m+k-1}^{(m+k-1)}$  is proportional to the local eld  $_{m}^{(m)^0} e^{i\tilde{r}_{m+k}}$ , i.e.

$$m + k = \frac{0}{(m + k - 1)^{0} (e^{i m + k})^{2}} = 0 m e^{i m + k}$$

here  $\tilde{m}_{k+k}$  is de ned through

On the other hand, the position has to be such that the new bump on the cluster precisely touches the previously grown one, i.e. the image of one of its branch points has to be equal to the image of the corresponding branch point of the previous bump. When growing the layer in a mathematically positive direction this means that

Note that  $_n$  only depends on the size  $_n$  and not on the position, because it is a property of the un-rotated fundam entalm ap, namely its branch points. By use of the inverse fundam entalm ap equation (5) simpli es to

where  $m_{m+k}, 0$  is the fundam ental m ap which depends only on the size of the bum  $p = \frac{p}{m+k}$ . This can be further simpli ed to get an equation for m+k

$$e^{i_{m+k}} = \frac{e^{i_{(m+k-1)} + k-1}}{e^{i_{m+k}} i_{(m+k-1)}};$$

where the right hand side depends only on the previous bump  $(m + k \ 1)$  and the size of the new particle (m + k). Thus we can compute  $_{m+k}$  from equation (7) once we know the size of the bump.

To accomplish the goal of growing a full layer we now need to estimate the size of the bum p  $_{m+k}$  and from there compute the position  $_{m+k}$  according to equation (7). This will exactly close the gap between successive bumps in the layer. In estimating  $_{m+k}$  we use the fact that the bumps are minute on the scale of the grow th pattern. Therefore the eld does not vary signi cantly from bump to bump. Thus we set the value of  $_{m+k}$  to

$$m+k = \frac{0}{(m+k-1)^{0} (e^{i_{m+k-1}})^{2}} = m e^{i_{m+k-1}^{2}}$$

In other words, we estimate m+k for the unknown position m+k at the position of the last bum p m+k 1. Note that with equation (7) we are guaranteed to have a full cover of the layer independently of the estimate of m+k. Only the very last bum p m ay not  $\$  t" in, and is therefore not grow n.

In order to avoid a bias in the growth pattern we alternate the direction of lling the layer from clockwise to anti-clockwise and vice versa. Furtherm ore we choose the position of the rst bump of a given layer random ly on the unit circle. Thirdly, to avoid growing very many very small particles in the fjords, we introduce a cut-o




FIG. 1: V iscous ngering pattern obtained through 100 000 growth events. The interm ediate steps of growth are also shown. Every drawn interm ediate pattern is an actual conform al map of the unit circle, with the last one being  $(100\ 000)$  (e<sup>i</sup>).

 $_{\rm cut}$  for  $_{\rm n}$ . That means that if a bump is about to be grown with a smaller  $_{\rm n}$  then we just avoid growing it and proceed to a position which is  $_{\rm cut}$  further down the unit circle. The results of our algorithm were checked to be independent of  $_{\rm cut}$  in the range 10  $^6$   $_{\rm cut}$  10  $^{10}$ . The results shown in this Letter are for the lowest cut-o  $_{\rm cut}$  = 10  $^{10}$ .

F inally, the conform alm ap at the end of the grow th of the layer can be written as




FIG.2: V iscous ngering pattern obtained by direct num erical solution, see [4].

$$(1)^{(m+p)}(!) = (m)^{(m)} ::: _{m+p,m+p}(!); (9)$$

where stands for a functional composition. In Fig. 1 we present  $^{(100\ 000)}$  (!) which is a growth pattern with 100 000 grow th events, including the interm ediate stages of grow th. The growth patterns is very similar to those obtained by direct num erical simulations of viscous n-gering in a radial geom etry. For comparison we show in Fig. 2 the pattern obtained by direct num erical solution [4].

O ne advantage of the present approach is that the conform alm ap  $^{(n)}(!)$  is given explicitly in terms of an iteration of analytically known fundam entalm aps, providing us with an analytic control on the grown clusters. The map  $^{(n)}(!)$  adm its a Laurent expansion

The coe cient of the linear term is the Laplace radius. De ning the radius of the minimal circle that contains

the growth pattern by  $R_{\,n}\,\text{,}$  one has the rigorous result that

$$R_n = F_1^{(n)} = R_n = 4$$

It is therefore natural to de ne the fractal dimension of the cluster by the radius-area scaling relation

$$F_{1}^{(n)} S^{1=D}$$

where S  $^{(n)}$  is the area of the cluster,

$$S^{(n)} = \int_{j=1}^{X^{n}} j^{(j-1)^{0}} (e^{j})^{2} :$$

On the other hand  $F_1^{(n)}$  is given analytically by




FIG.3: Double logarithm ic plot of the area  $S^{(n)}$  vs.  $F_1^{(n)}$

$$F_{1}^{(n)} = \frac{Y^{n} p}{(1 + k)}; \qquad (14)$$

and therefore can be determ ined very accurately. In Fig. 3 we plot the area S <sup>(n)</sup> in double logarithm ic plot against  $F_1^{(n)}$ . The local slope is the apparent dimension at that cluster size. It appears that the dimension asymptotes to the value indicated by the straight line which is D = 1:7.

A few comments are in order. First, our algorithm does not employ surface tension; rather, we have a typical length scale  $_0$  that removes the putative singularities. The boundary conditions for the Laplacian eld are still zero on the cluster. The apparent correspondence of our patterns with those grown with surface tension regularization points out in favor of universality with respect

to the method of ultra-violet regularization. Second, one m ay worry that growing sem i-circular bum psm eans that the elementary step has both length and height proportional to jr P j and not just height. Since our elem entary grow th events are so sm all in spatial extent this does not appear to be a real worry. Lastly, in previous work [15, 16, 17] the technical di culty of growing a complete layer was circum vented by constructing a fam ily of m odels which included Laplacian growth only as a limiting m odel. This fam ily of m odels achieved a partial coverage 0:65 of every layer of grow th, with C = 1 being Par-С allel Laplacian grow th which could be considered only as an extrapolation of lower values of C. Assuming monotonicity of geometric properties as a function of C, the extrapolation procedure indicated strongly that viscous

ngering were not in the sam e universality class as DLA, having an extrapolated dimension D = 2. The present algorithm which achieves directly the lim it C = 1 appears at odds with the extrapolation procedure. The direct m easurement of the dimension is in close correspondence with DLA whose dimension is 1:713 0:03 [11]. At present it is not clear whether the contradiction is due to a non-monotonicity as a function of C, W hether the clusters have not reached their asymptotic properties or whether there is another reason that will be illum inated by further research.

At any rate it is hoped that the availability of a direct procedure to grow viscous ngering patterns by iterated conform alm aps will help to achieve a theoretical understanding of this problem on the same level of the understanding of DLA.
