D issipative dynam ics of an extended m agnetic nanostructure : Spin necklace in a m etallic environm ent

We study theoretically the dynamics of an \xxz" spin necklace coupled to a conduction electron sea, a model system for a nanostructure in a dissipative environment. We extract the long-time behavior via a mapping to a multichannel C oulom b gas problem followed by a scaling analysis. The strong quantum uctuations of the necklace cause a nontrivial dependence of couplings on system size which we extract via an analysis involving the \boundary condition changing operator", and con rm via a detailed num erical evaluation of one case.


The dissipative dynam ics of a magnetic nanostructure is important from both technological and fundam ental points of view. For example, m agnetic recording involves the polarization of sm all dom ains, whose stability over long times is crucial. Tunnelling of isolated magnetic particles has been extensively studied [1] [2]. W e shall be interested here in the new physics brought by coupling to a conduction electron bath. There are two e ects. Exchange of spin between the conduction electron system and the nanostructure changes the magnetic state of the nanostructure, leading e ectively to a tunneling process. On the other hand, dissipation from the particle-hole excitations of the m etal suppresses tunnelling [3]. A nite cluster of spins coupled to a conduction electron bath is thus a model system for examining generalissues of quantum coherence and dissipation in a system with many degrees of freedom . A lso, recent experim ental advances in atom manipulation [4] [5] mean that clusters of atom s (eq. quantum corrals) can now be placed in controllable arrays on suitably chosen solid surfaces, so it seems likely that in the near future controlled magnetic nano-arrays m ay be constructed and studied.

In the case of a single spin in a metal, the interplay between tunnelling and dissipation gives rise to the logarithm ic renorm alizations characteristic of the oneimpurity Kondo e ect [6]. While the two [7] [8] and three [9] impurity K ondo problems have been studied, there is less known about the behavior of system s containing larger numbers of spins. The subject has been recently studied in the context of the \G ri ths phase" scenario for the non-Ferm i-liquid physics apparently observed in certain heavy ferm ion' metals [10]. To study this physics, Castro-N eto and Jones [8] considered a cluster of N magnetic impurities, coupled strongly to each other and weakly to a conduction electron bath. They presented a series of qualitative argum ents and approximate mappings from which they concluded that the system could undergo a more or less conventional K ondo screening (which they term ed a \cluster K ondo e ect"), at an N dependent tem perature which they estim ated. The qualitative nature of the treatment suggests how ever that further analysis would be useful. One of us,

with M orr and Schm alian [11], treated a similar problem of N coupled m om ents from a functional integral point of view. In the Ising case, orthogonality e ects were found to suppress tunnelling in all but the smallest nanostructures, while no de nitive results were obtained in the continuous symmetry case.

In this paper we attack the problem from a di erent point of view. We identify a speci c nanostructure, the

nite-size spin necklace depicted in Fig.1. There are three m otivations for this choice of cluster. First, it is (as can well be seen) amenable to a detailed analysis. Second, it exhibits large (but tractable) quantum uctuations whereas in other works [8] [11] the quantum uctuations within the cluster are not taken into account. Third, we can treat the continuous symmetry case as well.

The Ham iltonian describing the physics of interest is

with R_j the position of spin j. Here each spin value is $S_j = 1=2$ and $S_N = S_0$. We restrict to the case of $K_z > f_{2}$; so the ground state of $H_{necklace}$ is not ferrom agnetic. We further specialize to N odd so the ground state is characterized by a spin quantum number $S^{z} = 1=2.$ For $K_{2} < 0$ the totalm om entum of each of the $S^{z} = 1=2$ states is zero and the ground state is twofold degenerate. For $K_{2} > 0$ the ground state also has non-zero totalm om entum P = Pj; =1 im plying four-fold degeneracy. In this paper we focus on the lim it in which the K ondo coupling, J, of the cluster to the conduction electrons is weak enough and the tem peratures of interest low enough, that it is su cient to consider only those spin ip processes that couple the degenerate ground states of the cluster. We expect that stronger couplings, im plying m ixing of higher energy states of the cluster, give rise to qualitatively similar physics. This case will be considered in a future paper [12].

If $H_{coupling}^{?} = 0$, then the z component of the cluster spin is a good quantum number. The cluster remains in a de nite spin state, the conduction electrons just feel a potential due to the longitudinal coupling J_z , and the H am iltonian $H_0 = H_{necklace} + H_{cond} + H_{coupling}^{z}$ is easily diagonalized. For non-zero J_r the problem is no longer trivially solvable. To study it, we use a perturbative expansion in J_r to establish a mapping onto a C oulom b gas, following the approach introduced by A nderson and Yuval [6]. Let $j \star i$ denote the ground state of H_0 when the cluster is in the $S^z = +1=2$ state, $j \star i$ and consider the ground-state-to-ground-state am plitude (altematively the partition function in the imaginary time form ulation) given in the interaction representation by

The expressions above are similar to the ones introduced in the context of the X-ray [13] [14] and the K ondo problem [6], but with new features arising from the spatially extended nature of the magnetic object. The most in – portant of these new features are the space dependence of F, arising from processes in which an electron is created at one site and destroyed at another, and a nontrivial dependence of matrix elements such as $h^* jS_i^+ \not \Rightarrow i$ on necklace size and symmetry. We discuss these in turn.

Following Ref. [13] we express F as the product of open line part g = F = hSi and a closed loop part hSi

é which may be computed by an expansion in J_z . The crucial object in this expansion is the G reen's functions G (r;t) of H_{cond}. We require the long time lim it (t R=v_F with R the radius of the necklace) in which G (r;t) ! FG (r)=it : for a spherical Fermi surface G (r) = 2 sin (k_F r)=v_F r. In order to obtain a closed form for g we exploit the speci c geometry of the necklace. We parametrize the positions of the spins by the azim uthal angle j = 2 j=N; $j \ge [D;N$ 1]. Using R_{k1} = 2R sin ($_{k1}=2$), where $_{k1}$ k 1, G (R_{k1}) ! G ($_{k1}$). We nally de ne the one-dimensional Fourier transform

where we choose $m = \frac{N-1}{2}; :::0; :::^{N-1} = 1$ to make the symmetry of the problem most apparent: $G_m = G_m$. U sing the m basis and de ning $V = 2_2 Jh^* jS_i^z j^* i$,

where c is the short-time cut-o separating two spin- ips and we have neglected terms of (J_z^3) in the exponent.

We now consider the matrix elements. We rst note that if $K_{?} > 0$ then the neck lace ground states $j^{*}i, j^{*}i$ have a nonvanishing momentum $P_{*,+}$ and the matrix element depends on the momentum transfer: $h^{*}jS_{j}^{+}j^{+}i=h^{*}jS_{0}^{+}j^{+}iexp[iQ j]$ where $Q = (P_{+} P_{*})$. When $K_{?} > 0$, the absolute value of the matrix element decays faster with N when $P_{*} = P_{+}$. For $K_{?} > 0$ when $P_{*} = P_{+}$ and for $K_{?} < 0$ we nd, de ning 1,



For $\chi_z j$ $\chi_? j$ in terms of the Jordan-W igner ferm ion representation [17], the states \sharp i and \sharp i have di erent boundary conditions, one periodic and the other antiperiodic. Considering the low energy form of the Ham iltonian given by the Luttinger (massless) model and adopting the \boundary-condition changing operator" form alism [15] [16] we nd

which we verify by a detailed numerical analysis (see Fig.2) of the exact lattice solution for the $K_z = 0$ case (xx model [17]) for which = 1=4.

We not that M j is equal to $j_{0}j$ (obtained when k is closest (= 0) to the Fermi point) and when plotted against N, the two plots overlap.

For the Ising case (K $_z = 1$) for K $_z > 0$; the energy is m inimized by having alternating up and down spins, but N being odd there is one frustrated bond with N possible locations for each of S^z = $\frac{1}{2}$ and $\frac{1}{2}$. A perturbative analysis around this 2N fold degenerate point yields

The results for indicate that it is much easier than one might guess, to ip a large cluster between its two ground states. Quantum uctuations, which for example in the Ising regime delocalize the frustrated bond, bring about dram atic enhancement in the tunnelling caused by one spin ip by a conduction electron. By distributing $S^{z} = 1=2$ over N sites, they also decrease the expectation value of S_{j}^{z} , thereby reducing the potential felt by the conduction electrons at each spin site.

We are now in a position to present our result for the ground-state-to-ground-state amplitude for the spin necklace embedded in a conduction bath,

Note that since G_m^2 G_m^2 N, the two terms in T_m are of the same order in N and its leading behavior is given by the term linear in $J_z = G_m^2$ sum ed 1). In the corresponding expression obtained in Ref. [11] it was assumed that only one channel was important and in the expression for T_m , the term linear in J_z was overlooked. The above expression of a multicom ponent C oulom b gas model in which each spin

ip event (C oulom b gas charge) is labelled by the channel (m value) of the electron-hole pair created. H igher order term s in the expansion in J_2 may be treated similarly, but compact expressions cannot be obtained because (as noted in a related context [18]) in the multi-channel case, the higher order term s do not combine into the C auchy determ inant form [6]. However we may de ne a scaling procedure as usual [19] by elim inating close-pair spin ips of the same channel. To the leading order the di erent channels are not coupled, and standard arguments show that near the weak coupling xed point, the partition function retains the form Eq.(19) but with parameters "m (c) which evolve according to





Fig.3 Plot showing the ow for each channel, near the weak coupling xed point. The heavy solid line is the separatrix $"_m = u_m = 2$. The shaded oval region show s the generic initial conditions for the xx sym m etry. The dotted circle shows the generic initial conditions for the Ising limit. The striped region near $u_m = 0$ is the range of initial conditions for `im perfect' neck laces.

with initial conditions given by Eq.(21) and (22). The ow implied by Eq.(23) and (24) is shown in Fig.3.

For each channel the ow is to the no- ip xed line $(u_m = 0)$ if $"_m < u_h = 2$ and towards the strongly

coupled (rapidly ipping) regime (with $m = u_m = 2$) if "_m > u_n = 2. Scaling am pli es the di erences between channels. For example, in the K $_{?}$ < 0 case of the xx model, the initial condition is u_m^ρ = J? $_F\,G_{\,m}$ =N $^{1=4}$ and \textbf{m}_{m}^{0} = 2J_{z} $_{F}\,\text{G}_{m}$ =N . For large N , \textbf{m}_{m}^{0} is thus param etrically sm aller than u_m^0 ; all initial conditions are near the vertical axis and the dom inant channels are those with the largest $G_{\,m}$. Representative results are shown in Fig.4. Note that for the ideal ring studied here, $G_m = G_m$. We see that all channels with $m < N k_F = 2$ couple with roughly equal strength, but generically there is one largest pair, so after a transient m any channel regime, the asymptotic behavior is of the two-channel K ondo problem . Exceptions can occur, and in particular for k_F . 2 = N, the m = 0 channel dom in a tes. The sam e generic behavior occurs in other cases we have studied, but we note that in the Ising regime the J_z and J_z ? 1=N, so the initial conditions are couplings are both shifted as indicated in Fig.3.

To sum marize: we have shown that the generic longtime dynam ics of a spin neck lace coupled to a conduction electron bath is of the two-channel K ondo class. We em – phasize that generic deviations from perfect translation invariance break the two-channel sym metry. A key feature of the model is the large quantum uctuations characteristic of the isolated neck lace: these ensure that the dom inant spin ip am plitude between the ground states of the spin neck lace decays only as a power of the system size (N with 0 < 1) and that the static eld exerted by the neck lace on the conduction bath is sm all, of order 1=N; so \orthogonality" e ects do not dom inate. To explore the changes occurring as quantum

uctuations are reduced, we consider a necklace in the extrem e Ising limit (K_z K_{2}) and with one weak link (K_z⁰¹! K_z(1)) which acts to localize the frustrated bond. A detailed discussion and extension to other cases will be published elsewhere [12]. Here we note that although the residual rejection symmetry allows two chan-

nelbehavior, the spin ip amplitude changes from 1=Nto exp[N ln($K_{2} = K_{z}$)] (moving the initial condition much closer to the $u_{m} = 0$ axis of Fig.3). More im – portantly, because the frustrated bond is localized, the quadratic, \orthogonality" term in "m (Eq.(21)) becomes

 J_z^2N , moving the initial condition substantially to the left (independent of the sign of J_z); and, for large enough N, into the stable (no asym ptotic ip) region.

Extensions of the present work include a treatment of systems with open boundary conditions, and of other nanostructures. We expect generically that internal quantum uctuations of a nanoscale object (neglected in m any treatments, Ref. [8] and [11] for example) will have a dramatic elect on the long time dynamics.
