Fate of the Peak E ect in a Type-II Superconductor: Multicriticality in the Bragg-G lass Transition

We have used small-angle-neutron-scattering (SANS) and acm agnetic susceptibility to investigate the global magnetic eld H vs tem perature T phase diagram of a single crystal N b in which a rstorder transition of Bragg-glass melting (disordering), a peak e ect, and surface superconductivity are all observable. It was found that the disappearance of the peak e ect is directly related to a multicritical behavior in the Bragg-glass transition. Four characteristic phase boundary lines have been identied on the H T plane: a rst-order line at high elds, a mean-eld-like continuous transition line at low elds, and two continuous transition line associated with the onset of surface and bulk superconductivity. All four lines are found to meet at a multicritical point.

An outstanding question concerning the Abrikosov vortex state of type-II superconductors is whether a genuine order-disorder transition can still occur in vortex m atter even though true crystalline order cannot be attained due to random pinning by in purities [1]. There are convincing theoretical arguments [2, 3, 4, 5] and numerical evidence [6] suggesting that, instead of a true vortex crystal, a novelB ragg glass phase with quasi-longrange order can exist in bulk sam ples with weak random pinning; hence a true order-disorder transition can occur when the topological order of the B ragg glass is destroyed, by therm al uctuations and/or random pinning.

However, it is still controversial as to whether a Bragg glassmelting (or disordering) transition is the underlying mechanism of the well-known anomaly of \peak e ect" in weak-pinning type-II superconductors [7]. Recent neutron scattering experiments on Nb [8], and V₃Si [9], as well as STM studies of 2H-NbSe₂ [10] all suggested a disordering transition at the peak e ect, and the phase transition appears to be rst order [8]. How ever, it has been reported that som e sam ples of sim ilar quality, e.g., having only weak pointlike pinning centers, do not show a peak e ect, nor a disordering phase transition [11]. This raises an obvious, but intriguing, question: Is the fate of the peak e ect, i.e. appearing or disappearing, related to a multicritical behavior in the phase transition into the Bragg glass? In this Letter, we report the st direct evidence that the disappearance of the peak e ect is related to a multicritical point on the Bragg-glass phase boundary.

O ur experim ent was carried out using the 30m SANS instrum ents NG 7 and NG 3 at the NIST C enter for N eutron R esearch on a Nb single crystal (99.998% in purity) in which both the peak e ect and the rst-order B raggglass melting (disordering) transition were observed at the same temperatures [8]. The sample has a zero-eld $T_c = 9.16$ K, and an estim ated G inzburg-Landau param – eter $_1(0) = 2.0$. The mean wavelength of the incident neutron beam was = 6.0 A and the wavelength spread 11 % (FW HM). The experimental conguration is shown in the inset of Fig.1 (a). A cadmium mask was used such that only the central portion of the sample was exposed to the incoming neutron beam. The scattered neutrons were captured by a 2D detector of 128x128 pixels (the pixel size is 0.5 cm by 0.5 cm) 15.3 m away from the sam – ple. The dc magnetic eld was applied in the direction of the incoming neutron beam using a horizontal super-conducting magnet. A coil was wound on the sam ple to allow in situ ac magnetic susceptibility measurements.

Fig.1(a) shows the SANS data at H = 3.0 kOe. The Gaussian width data are obtained from thing the measured (Bragg) intensity vs. azim uthal angle to six G aussian peaks evenly spaced 60° apart. It is clear that the azim uthalwidths, a measure of orientational disorder in the vortex array, are strongly history dependent. Supercooling and superheating e ects are observed for eldcooling (FC) and eld-cooled-warming (FCW) paths, respectively. As reported previously [8], the disordered phase at T > T_p and the ordered phase at T < T_p are of their respective therm odynam ic ground states. The abrupt change in the structure factor S (q) at the peak e ect T_p depicts a symmetry-breaking phase transition from a vortex matter with short-range order to a Bragg glass with quasi-long range order [8]. The phase transition is rst order as evidenced by the strong therm al hysteresis in S (q). Compared to that at higher elds, the m etastability region for H = 3.0 kO e is sm aller butstill pronounced.

W e found that the therm allysteresis of S (q) observed in SANS is strongly eld dependent, and the m etastability region disappears completely at low elds. Fig.1 (b) shows the azimuthal width data for H = 2.0 kO e. For comparison, the real part ⁰(T) of the ac magnetic susceptibility is also shown in Fig.1 (b). The dip in

 $^{0}(T)$ is a well-established signature of the peak e ect [12, 13, 14]. The history dependence of B ragg-peak width is detectable only within 0.1 K of the peak-e ect tem perature $T_{\rm p}$.

A sim ilar trend is observable in the history dependence of the radial widths of the B ragg peaks, as shown in F ig 2, obtained by tting a single Gaussian function to the qdependence of the SANS intensity. At 3.0 kOe, there is a pronounced therm al hysteresis in the radial widths. At 2.0 kO e, how ever, the hysteresis is barely discernable. At an even lower eld of 1.0 kO e (data not shown), the therm all hysteresis in S (q) is undetectable. At H = 1.0k0 e, a very sharp peak e ect (the onset-to-end width = 40 m K) is still present. Thus we believe the phase transition at 1.0 kO e is still rst-order but the m etastability region is too narrow to be resolved in SANS (the tem perature resolution in SANS 50 m K). Nevertheless, the diminishing hysteresis in the Bragg-glass transition in the low - eld regim e suggests that the phase transition is becoming continuous and mean-eld-like.

The fact that the transition into the B ragg glass is rst order at high elds, but continuous (m ean-eld-like) at low elds strongly suggests the existence of a multicritical point on the phase boundary bordering the B ragg-glass on the H T phase diagram. We show below that this multicritical behavior is directly related to the appearance and the disappearance of the peak e ect.

Fig.3 shows a three-dimensional plot of the $^{0}(T)$ as a function of temperature and magnetic eld in the eld range of 0 - 5.12 kOe. At high elds, there is a pronounced peak e ect, a characteristic dip in $^{0}(T)$. With decreasing eld, the peak e ect becomes narrower and smaller. For H < 0.8 kOe, there is only a single kink in

 0 (T) corresponding to the m ean- eld transition $\rm H_{c2}$ (T). A coording to the 0 (T) data in Fig.3, there is no reentrant peak e ect at low elds, in contrast to that in 2H-NbSg [15] and YBCO [16]. The peak e ect sim ply vanishes here.

At higher tem peratures above the peak-e ect tem peratures $T_p \ (H) \ (or H_p \ (T), used interchangeably), there is a smooth step in <math display="inline">^0 \ (T)$. This step, $T_{c3} \ (H) \ (or H_{c3} \ (T)), dened in Fig.1 (b), is the onset of surface superconductivity. The separation between <math display="inline">T_p \ and \ T_{c3} \ grows \ largerw$ ith increasing magnetic eld. Upon cooling, below $T_{c3} \ (H)$ and towards $T_p \ (H)$, the screening e ect in 4 $^0 \ (T)$ increases gradually. Nevertheless, a less well-de ned characteristic tem perature $T_{c2} \ (H)$ can be identieed to mark the onset of bulk superconductivity [see Fig.1 (b) for definition]. Note that the notation $T_{c2} \ (H)$ is used for $H > 0.8 \ kO \ e, while H_{c2} \ (T)$ is used for $H < 0.8 \ kO \ e.$


Figure 4: The phase diagram of a weak-pinning Nb crystal for the H_{dc} jj < 111 > crystallographic direction. The upper solid circles (the crosses correspond to measurements using $H_{ac} = 1.7$ Oe, see Fig.3 captions) are the peak of the peak e ect and the rst-order transition line; the lower ones are the mean-eld transition. The open diamonds (two sets are for two values of acelds, see Fig.3) are H_{c3} . The multicritical point is indicated by the large lled circle. The H_{c1} data (triangle) are estimated from the rst-penetration in the ac susceptibility data. All lines are hand drawn as guides for eyes.

The results of Fig.3 are sum marized in a new phase diagram of B ragg glass superconductivity in Nb as shown in Fig.4. The measured ratio of H $_{c3}$ =H $_{c2}$ at low tem peratures is about 1.60, slightly sm aller than the expected value of 1.695 by Saint-Jam es and de G ennes [17]. This is likely due to the nonideal cylinder surface being not exactly parallel to the eld. The crossing of H_{c3} (T) and H_{c2} (T) lines below T_c was observed previously [18, 19], and has been interpreted as due to a depressed BCS gap function near the surface [20].

The most striking aspect of Fig.4 is that all four lines, H_p(T), T_{c2}(H), H_{c2}(T), and H_{c3}(T), meet at a multicritical point (M CP). To determ ine the nature of a M CP, one needs to know how many of these lines are secondorder phase transitions. In the theory of Saint-Jam es and de G ennes [17], T_{c3}(H) is a continuous phase transition. For H < 0.8 kO e, the linear tem perature dependence of H_{c2}(T) follows the expected behavior of a G inzburg-Landau m ean- eld transition line [21]. This is a line of continuous phase transitions from the norm al state directly into an ordered A brikosov B ragg-glass phase. For H > 0.8 kO e, the peak e ect T_p(H) traces out a line of

rst-order transitions. A cross this line, the therm al hysteresis in the structural factor S (q) of the vortex m atter can be observed, especially striking at high elds.

The nature of the $T_{\rm c2}$ (H) line is less clear. The vortex m atter is liquidlike structurally in the shaded part of the phase diagram . W hether this disordered vortex m atter is a distict therm odynam ic phase from the norm al state is still being debated (see [7] and references therein). If $T_{\rm c2}$ (H) is a true second-order phase transition, e.g., as in a vortex glass transition [22], the M CP in F ig. 4 would appear to be a tricritical point. On the other hand, we found that the m easured slopes of the four phase boundaries near the M CP cannot satisfy the requirements [23] in posed on a tricritical point by therm odynam ics, but are consistent with those for a bicritical point. This leads to an important conclusion that only one of the two lines, $T_{\rm c2}$ (H) or H $_{\rm c3}$ (T), can be related to the M CP.

For T_{c2} (H) to be a second-order line for the bicritical point, its slope has to be larger (in m agnitude) than that of H $_{c2}$ (T), such that the therm odynam ics rule [24] that no phase can occupy m ore than 180° of the phase space around a M CP is satis ed. However, this is not observed in our data as shown in Fig. 4. For the H $_{c3}$ (T) line to be the relevant one, the ratio of speci c-heat jump at H $_{c2}$ (T) over that at H $_{c3}$ (T) should be 43.6. W hile this large ratio is consistent with the existing speci c-heat data on Nb [25], presently there are no reliable speci c-heat data near a crossing point of H $_{c2}$ (T) and H $_{c3}$ (T) to allow us to m ake a quantitative com parison.

W e should point out that a similar critical point has also been observed in platelet geometries such as M gB₂ [26, 27] crystals for which H_{c3} (T) is not expected to play a role in the critical point. In high-T_c YBCO, a disappearance of the rst-order transition was also observed in the low – eld regime, and was interpreted as a critical end point [28]. If our critical point in Fig. 4 is also interpreted as a critical end point, T_{c2} (H) would not be a true phase transition, and the meeting of H_{c3} (T) at the M CP would be purely coincidental.

In sum m ary, we found that, in a Nb crystal in which a

peak e ect in acm agnetic susceptibility and a rst-order melting (disordering) transition in SANS were found to coincide previously, both e ects disappear at a low eld. It is suggested that the appearance or absence of a peak e ect in a type-II superconductor m ay be directly correlated with a multicritical point (MCP) on the B ragg glass phase boundary. The existence of a MCP, at which the peak e ect vanishes, suggests that the origin of the peak e ect is related to a second-order phase transition at a higher temperature. In the sam ple studied, it appears that the MCP m ay be related to surface superconductivity.

Note that two values of ac elds were used in the measurements. For H_{dc} < 3.0 kOe, H_{ac} = 1.7 Oe and f = 1.0 kHz and for H_{dc} > 3.0 kOe, H_{ac} = 7.0 Oe and f = 1.0 kHz. The solid and dashed lines are guides to eyes. For the ac elds used, T_p is independent of the ac eld am plitude [12].




