NEW FEATURES OF THE PHASE TRANSITION TO SUPERCONDUCTING STATE IN THIN FILM S

Abstract

The Halperin-Lubensky-Ma (HLM) e ect of a uctuation-induced change of the order of phase transition in thin lm s of type I superconductors with relatively small G inzburg-Landau number is considered. Numerical data for the free energy, the order parameter jump, the latent heat, and the speci c heat of W, Al and In are presented to reveal the in uence of lm thickness and material parameters on the properties of the phase transition. We demonstrate for the rst time that in contrast to the usual notion the HLM e ect occurs in the most distinct way in superconducting lm swith high critical magnetic eld H _{c0} rather than in materials with small . The possibility for an experimental observation of the uctuation change of the order of superconducting lm s is discussed.

1. Introduction

O ur paper is intended to clarify the best conditions for an experimental observation of the Halperin-Lubensky-Mae ect (HLM) [1, 2] of a uctuation-induced rst-order phase transition from normal to Meissner phase in a zero external magnetic eld for thin $\ln s$ of type I superconductors [3, 4, 5]. For this purpose we present new theoretical results about the therm odynamics of the phase transition from normal to superconducting state in a zero external magnetic eld.

The HLM e ect is predicted theoretically [1] to occur in pure [2, 4, 6] and disordered [7, 8, 9] bulk, (three-dimensional – 3D), and 2D [10] superconductors, as well as in quasi-2D superconducting $\ln s$ [3, 5] but up to now it has not been observed in experiments. The calculated e ect is very sm all in 3D superconductors and is not possible to be detected even

for a high purity of the sample and perfection of the crystal lattice [1, 2, 4]. Recently, it has been shown [3, 5] that in thin (quasi-2D) Im s the HLM e ect is much stronger than in 3D samples and could be observed by available experimental techniques if the type of superconductor and Im thickness are properly chosen for the experiments; for a review, see also, Refs. [11, 12]. This result gives an opportunity to search for the e ect in suitable superconducting Im s.

The HLM e ect appears as a result of the interaction between the superconducting order parameter (x) and the vector potential A'(x) of the magnetic induction in the G inzburg-Landau (G L) free energy of a superconductor. A coording to the theoretical paradigm introduced for the rst time in the scalar electrodynam ics by C olem an and W einberg (CW) [13], this e ect should occur in all physical systems described by A belian-H iggs m odels where a scalar gauge eld (like in superconductors) interacts in a gauge invariant way with another vector gauge eld (like the vector potential A' in superconductors). In addition to the mentioned examples of superconductors and scalar electrodynam ics, the same type of interaction plays an important role in the nem atic-smectic A phase transition in liquid crystals [14, 15, 16] and phase transitions in the early universe [17]. HLM e ect m ay be also relevant to quantum phase transitions in superconductors [18, 19, 20] and itinerant ferrom agnets [21].

On the other side, there are certain theoretical investigations, based on M onte C arlo simulations [22] and the so-called \dualm odel" [23] which do not con m the uctuation-change of the order of the phase transition (see also R efs. [12]). That is why, extensive experiments intended to verify the existence of the e ect were made in liquid crystals; see, e.g., R efs. [12]. But in liquid crystals the weakly- rst order phase transition predicted by C W and HLM can be obscured by similar e ects due to the strong crystal anisotropy, while the recent result [3] about the considerable enhancement of HLM e ect in suitable superconducting Im s can be used for more reliable experiments. For this aim we need to not the best material parameters and the most suitable. In thickness, having in mind some purely experimental problems that may appear.

Recently, we partly solved the problem for Al $\ln s$ [5] nevertheless additional theoretical investigations should be done. In this paper we shall present some new theoretical predictions for Al $\ln s$ as well as new numerical data for thin $\ln s$ of W and In. The choice of this element superconductors is made for their relatively small GL number = (=), which allows a more distinct appearance of the HLM e ect in both bulk and thin $\ln s$ superconductors [1, 3, 5]; here is the London penetration depth and is the coherence length [24].

W e focus our attention on num erical data for the behavior of the free energy and directly m easurable therm odynam ic quantities like the order param eter jump, the latent heat, and the speci c heat. A surprising result of our analysis of the data for W, Al, and In is that the HLM e ect in thin lms is stronger in case of relatively high zero-tem perature critical magnetic eld H $_{c0}$ rather than for relatively sm all GL number, as claim ed in preceding

papers [1, 2, 3, 4, 5].

Our investigation is based on the theoretical results from preceding papers [1, 3, 4, 5]. In Sec. 2 we shall outline the theoretical fram ework of our study. In Sec. 3 we present our analysis of thin Im s of tungsten (W), alum inium (Al), and indium (In) and a discussion of the results with a special emphasis on their application to experiments. In Sec. 4 we summarize our ndings.

2. Theoretical basis

Our investigation is based on the G inzburg-Landau free energy [24] of a D-dimensional superconductor with volume $V = (L_1::L_D)$ given by

where $a = {}_{0}$ (T T_{c0}) and b > 0, are the Landau parameters, e = jej is the electron charge, (x) is the order parameter, and A (x) is the vector potential of the magnetic eld.

The critical temperature T_{c0} corresponds to the second order phase transition which occurs in a zero external magnetic eld when the uctuations, '(x) and K(x), of both elds (x) and K(x) are neglected. U sually, this case is considered in the low-temperature superconductors, where the eld of the superconducting uctuations '(x) on the therm odynamics is very smalland practically uninteresting, and the same has been supposed for them agnetic uctuations K(x) before the appearance of HLM paper [1]. In our study the superconducting uctuations are ignored as negligibly small which is a suitable approximation in type I superconductors where . But we take into account the magnetic uctuations to a full extent. Then the norm al-to-superconducting phase transition in a zero external magnetic eld turns out of rst order at an equilibrium phase transition temperature T_{eq} that is di erent from T_{c0} . So, our task will be to point the type of superconductors, where this picture may be valid and investigate the properties of the rst order phase transition.

W e shall follow the theoretical approach described in details in preceding papers [1, 2, 3, 5], where an elective free energy F_e () of the type I superconducting in was obtained [5]. There we also neglected the superconducting uctuations and did the calculation of the mean-eld value of the uniform (x-independent) superconducting order parameter in a self-consistent way after taking into account the magnetic uctuations through an exact integration out of the eld A(x) in the partition function of the superconductor. As the external magnetic eld is equal to zero the regular part $A_0 = (A - A)$ of A related to it can be set equal to zero, too. Then A = A, therefore, we consider the net elect of the magnetic uctuations.

Having in m ind that in type I superconductors a stable vortex phase cannot occur, we again can assume that the order parameter that describes the uniform M eissner phase in the bulk of the superconducting lm is x-independent. Our investigation is based on the quasi-m acroscopic GL theory so we must consider lm s of thickness L_0 a₀, where

 a_0 is the lattice constant. In such In s the surface energy can be ignored and one can use periodic boundary conditions without a substantial departure from the real situation. In this way, the surface e ects as a source of a spatial dependence of the order parameter are also eliminated.

Following [1, 2, 3, 4, 5] we present the elective free energy density $f() = F_e() = V$ of a 3D superconducting slab of volume $V = (L_1 L_2 L_0)$ and thickness L_0 in the form :

Here $' = (j \neq j_0)$ is the dimensionless order parameter defined with the help of the zero-tem perature value $j_0 j = j$ (T = 0) $j = (_0 T_{c0} = b)^{1=2}$ of $j_0 t_0 = (T T_{c0}) = T_{c0}$, $= (_0 = _0)^2$ is given by the zero-tem perature value $_0 = (\sim^2 = 4m _0 T_{c0})^{1=2}$ of and $_0 = (b = _0 _0 T_{c0})^{1=2}$ is the zero-tem perature penetration depth; $(_0 = 8 e^2 = m c^2)$. We also use the notations: $(T) = _0 = j_0 f^{1=2}$ and $(T) = = f_0 f^{1=2}$. The critical magnetic eld at T = 0 is given by [24] $H_{c0} = _0 T_{c0} (4 = b)^{1=2}$. The relations of H_{c0} and $_0$ with b and $_0$, respectively, can be used together with the experimental data for H_{c0} and $_0$ in concrete superconducting substances in order to calculate the parameters b and $_0$.

The equilibrium order parameter $\prime_0 > 0$ corresponding to the M eissner phase can be easily obtained from the equation $0 f(\prime) = 0' = 0$ and Eq. (2):

The logarithm ic divergence in Eq. (4) has no chance to occur because \prime_0 is always positive and does not tend to zero.

We shall use the notations from Ref. [5] for the entropy jump s and the speci c heat jump C at the equilibrium phase transition point T_{eq} of rst order corresponding to a zero external magnetic eld. Here we shall give the previously calculated results for the leading terms in these quantities (term s of higher order are neglected as sm all), namely,

The latent heat of the phase transition is given by $Q = T_{eq}$ s and Eq. (4). Since the tem peratures T_{eq} and T_{c0} have very close values, the di erence between the values of Q,

s, and C at T_{c0} and T_{eq} , respectively, can also be ignored, for example, j C (T_{eq}) C (T_{c0}) \neq C (T_{c0}) \neq C (T_{c0}) 1 and we can use either C (T_{c0}) or C (T_{eq}) [5]. Here the jumps s, C, and Q are all taken at the equilibrium phase transition value T_{eq} but we shall not supply them with the subscript \eq" as we do for other quantities.

Eqs. (2) – (6) are valid for thin $\ln s$ (a₀) L_0 (1) in a zero external magnetic eld H and for negligibly small - uctuations which means that they are applicable for low-tem perature nonm agnetic superconductors ($T_{c0} < 20$ K). Because in experiments the external magnetic eld cannot be completely eliminated, vortex states may occur for $H = \frac{1}{2} \frac{1}{2} > 0$ below T_{c0} in type II superconducting Im s and this will obscure the HLM e ect. $T_c = T_c (H)$ Note, that the magnetic eld H generates additional entropy jump at the phase transition point $T_{c}(H)$ and this e ect can hardly be separated from the entropy jump (5) caused by the magnetic uctuations in the close vicinity of T_{c0} . Therefore, in experiments intended to a search of the HLM e ect we must choose type I superconductors. The second important point is connected with the value of the square \prime^2_{eq} which is proportional to the supercon- $\prime_{
m eq}^2$ [24]) and to the equilibrium jumps s and Q. In 3D ducting current (js j2, superconductors the ratio (Q = C) depends on H_{c0}^2 c ⁶, where c 10^{16} denotes the extrem ely sm all G inzburg-Levanyuk critical region [11] of low -tem perature superconductors [1]. Therefore, the latent heat in these 3D superconductors can hardly be observed in experiments. But in thin Ims the substantial dependence of the entropy s and the specic heat C is on the critical magnetic eld H_{c0}^2 , as shown by Eqs. (5) - (6) and the analysis in Sec. 3.

The equations (2) and (4) corresponding to quasi-2D $\,$ In s are quite di erent from the respective equations [1, 2] for bulk (3D –) superconductors but it is easily seen that the relatively large values of the order parameter jump '² in thin $\,$ In s again correspond to relatively small values of the GL parameter $\,$. That is why we consider element superconductors with small values of $\,$ and study the e ect of this parameter, the critical magnetic eld H _{c0} and the $\,$ In thickness L₀ on the properties of the uctuation-induced rst order phase transition.

Theoretical results we have used in this Section for quasi-2D superconducting $\ln s$ are consistent with the theory [25] of 2D -3D crossover phenom ena near phase transition points and the 2D -3D crossover theory [26, 27] of the HLM e ect; see also Ref. [28].

3. Results and discussion

W e use experimental data for T_{c0} , H_{c0} , $_0$ and for W, Al, and In published in Ref. [29] (see Table 1). In some cases the GL parameter can be calculated with the help of the relation $= (_{0} = _{0})$ and the available data for $_{0}$ and $_{0}$. In other cases it is more convenient to use the following representation of the zero-tem perature penetration depth:

Eqs. (7) and (8) are obtained from the form ulae given after Eq. (3). Besides we calculate the parameter $C = C L_0$ with the help of Eq. (3) and the data in Table 1.

Note, that the experimental data vary within 5-10% depending on the experimental technique used in measurements. Moreover, these data correspond to bulk samples and may dier within 10-20% from those for very thin $\ln s$ (L₀ < 10² m). However, these variations in the experimental data do not essentially a ect our results.

The order parameter profe for Al lms of different thicknesses is shown in Fig. 1. It is readily seen that the behavior of the function \prime_0 (t₀) corresponds to a well established phase transition of rst order. The vertical dashed lines in Fig. 1 indicate the respective values of t_{eq} = t₀ (T_{eq}), at which the equilibrium phase transition occurs as well as the equilibrium jmp \prime_0 (T_{eq}) = \prime_{eq} for different thicknesses of the lm. The parts of the \prime_0 (t₀)-curves which extend up to t₀ > t_{eq} describe the m etastable (overheated) M eissner states which can appear under certain experimental circum stances (see in Fig. 1 the parts of the curves on the rhs. of the dashed lines). The value of \prime_{eq} and the m etastable region decrease with the increase of the lm thickness, which shows that the rst order of the phase transition is better pronounced in thinner lm s and that con rm s a conclusion in Ref. [20].

These results are con med by the behavior of the free energy as a function of t_0 . We used Eqs. (2) and (4) for the calculation of the equilibrium free energy f ['_0(t_0)]. The free energy for Al lm s with dimension correspond to the intersection of the f ('_0)-curves with the t_0 -axis. It is

obvious from Fig.2 that the tem perature dom ain of overheated M eissner states decreases with the increase of the thickness L_0 .

The shape of the equilibrium order parameter \prime_0 in a broad vicinity of the equilibrium phase transition of thin lm s (L₀ = 0.05 m) of W, Al, and In was found from Eq. (4). The result is shown in Fig. 3. The vertical dashed lines in Fig. 3 again indicate the respective values of t_{eq} = t₀ (T_{eq}), at which the equilibrium phase transition occurs as well as the equilibrium jump \prime_0 (T_{eq}) = \prime_{eq} in the di erent superconductors.

The order parameter jump at the phase transition point of In (the In curve is marked by points in Fig. 3) is relatively sm aller than for W, and A l, where the G L param eter has much lower values. The same is valid for the metastability domains; see the parts of the curves in Fig. 3 on the left of the vertical dashed lines. It is obvious from Fig. 3 and Table 2 that the equilibrium jump of the reduced order parameter 'eq of W has a slightly smaller value than that of Alalthough the GL number for W has a ten times lower value compared with of Al. Note, that in Fig 3 we show the jump of $'_{eq}$, but the important quantity is $j_{aq} = j_0 J_{eq}$. Using the data for $L_0 = 0.05$ m from Tables 1 and 2 we nd for j_{eq} 10^{11} for Al, 0.05 10^{11} for In, and 0.02 10^{11} for W. This the following values: 0:1 result shows that the value of the critical led H $_{c0}$ is also in portant and should be taken into account together with the sm allness of GL number when the maxim al values of the order param eter jum p are boked for. Thus the value of the order param eter jum p at the uctuation-induced phase transition is maxim alprovided sm all values of the GL param eter are combined with relatively large values of the critical eld H $_{c0}$. In our case A lhas the optim al values of these two param eters.

The data in Table 2 show that the shift of the phase transition temperature is very small and can be neglected in all calculations and experiments based on them . The values for $'_{eq}$ for dimension L_0 and those for j $_0$ j given in Table 1 con rm the conclusion which we have made for lm s of A_1 . In, and W = 10.05 m. The latent heat Q has maximal values for lm, where the critical eld is the highest for the considered materials.

4.Conclusion

In contrast to our initial expectations that $\ln s m$ ade of superconductors with extrem ely small GL parameter such as Al and, in particular, W will be the best candidates for an experimental search of the HLM e ect, our careful analysis de nitely gives som ewhat dierent answer. The Al $\ln s$ still remain a good candidate for transport experiments through which the jump of the order parameter at the phase transition point could be measured but surprisingly the W $\ln s$ turn out inconvenient for the same reason because of their very low critical eld H co. Although In has ten times higher GL number than Al, the In $\ln s$ can be used on an equal footing with the Al $\ln s$ in experiments intended to prove the order parameter jump. Here the choice of one of these materials may depend on other features of experimental convenience. As far as caloric experiments are concerned, the In $\ln s$ seem the best candidate for their high latent heat.

We have presented the theoretical justication and predictions intended to support experiments on the observation of magnetic uctuations and HLM elect near the normal-to superconducting transition in a zero external magnetic eld. Besides, we have demonstrated for the stime that the experiments can be most successfully performed in type I superconductors with relatively high critical magnetic elds.
