# Ferm ion pairing in Bose{Ferm im ixtures

## Abstract

An elective interaction between fem ions in a Bose{Ferm imixture is derived. It is induced by density uctuations of the bosonic background. The contributions from states containing both one and two virtual phonons are taken into account self{consistently. The time dependence of the elective interaction has been removed by assuming that the velocity of the ferm ions at the Ferm i surface is much larger than the sound velocity in the Bose gas. This assumption is more appropriate for the actual experimental situations than the usual approximation of neglecting retardation elects. The elective interaction turns out to be attractive and, as a consequence, can give rise to a superconducting phase in the Ferm i component of the mixture. The ferm ions are considered in only one magnetic state, so that pairing can be elective only in odd{l channels. It has been found that the onset of the superconducting phase can occur at tem peratures (> 100 nK ) of the sam election spectrum is a small fraction ( 1% ) of the Ferm i energy.

#### I. IN TRODUCTION

E ective fem ion {fem ion interactions induced by the exchange of virtual phonons in fem ion {boson m ixtures were already studied in the 1960s, in connection with dilute solutions of <sup>3</sup>H e in super uid <sup>4</sup>H e, see e.g. Ref. [1]. Recently, a renewed interest in this subject has arisen, following the actual availability of trapped atom ic gases at a tem perature su – ciently low to exhibit quantum properties. In particular, physical situations are reproduced, in which a highly condensed Bose gas is m ixed with an alm ost degenerate Ferm i gas and the interaction between these two gases can be studied at various values of tem perature and density [2, 3, 4, 5]. On the theoretical side, particular attention has been devoted to the possibility of the onset of a supercoducting phase in the Ferm i com ponent of the m ixture [6, 7, 8, 9]. For the ferm ion gases used in experiments the bare interactom ic potential is repulsive. Then, the necessary attractive interaction between two ferm ions should be provided by the exchange of virtual phonons, through a mechanism sim ilar to that responsible for the superconductivity phenom enon in m etals. Investigations of the physical conditions for a a Cooper instability in the s{wave and p{wave channels have recently been perform ed [6, 7, 8, 9].

For a bare ferm ion {boson interaction with zero{range, the induced ferm ion {ferm ion interaction is essentially proportional to the correlator of density uctuations of the bosonic background. In the references [1, 6, 7, 8, 9], the density uctuations have been calculated taking into account only single{ phonon interm ediate states. In the present paper the contribution from two{phonon interm ediate states is also included. This does not simply am ount to an improvement of the approximation scheme, because two{phonon and one{ phonon states occur on the same basis in the evaluation of the elective ferm ion {ferm ion interaction, at low est order in the ferm ion{boson coupling constant. M oreover, when the fractions of condensed and non{condensed com ponents of the boson gas are com parable, the one{phonon and two{phonon contributions turn out to be of the same order of m agnitude.

The induced interaction between ferm ions is given by the boson density {density correlator, evaluated for the time interval between two successive ferm ion {boson interactions. In order to simplify calculations, di erent approximations can be introduced to eliminate this time dependence. In Refs. [1, 6, 7, 8, 9] retardation elects have been neglected, always by setting the frequency to zero in the time {Fourier transform of the correlator. For a degenerate Ferm i gas, this approximation can be justiled if the Ferm i velocity is much lower than the sound velocity in the Bose gas. In the present approach the opposite approximation is used: the correlator is taken at equal times, i.e. the induced interaction between two ferm ions is mediated by the static correlation function for boson density uctuations. This approximation is more appropriate for the physical conditions obtained in the mixtures of trapped Bose{Ferm i atom s produced in the laboratory [2, 3, 4, 5]. For these mixtures the density of the degenerate Ferm i gas is a relevant fraction of the density of the Bose gas.

The aim of the present work is to assess the possible occurrence of a superconducting phase in the Ferm i component of an ultracold mixture of Bose (Ferm i gases, for values of density and temperature obtained in actual experiments, and to give an estimate of the gap in the spectrum of excitation energies. A lthough all the experiments have been performed with harm onic (oscillator traps, a spatially hom ogeneous system is considered. In this case, calculations are considerably simplified and compact analytical expressions can be derived.

At the densities considered in the experiments, for the two species of gases we can assume that the interactions have a short range and mainly occur in the s{wave channel.

M oreover, according to the experimental situations, both the Ferm i and Bose atoms are considered in only one internal state. In this case, the Pauliprinciple allow sus to neglect the bare interaction between ferm ions, at least in a mean { eld treatment. In fact, in the zero { range limit for the interaction, the contributions from the direct (Hartree) and exchange (Fock) terms of the mean { eld cancel each {other exactly, while short range correlations should not play an important role for a su ciently dilute Ferm i gas, i.e. for a  $_{\rm FF}^3$  n<sub>F</sub> << 1 where  $a_{\rm FF}$  is the scattering length and  $n_{\rm F}$  is the ferm ion density. Concerning the Cooper condensation, it can occur only for odd values of the orbital angularm om entum for a spin { aligned couple of ferm ions, so that there is no contribution from a s{wave interaction.

Experiments have been performed with gases, which show repulsive boson (boson interactions [3, 5], this ensures the stability of the mixture towards separation of the two species of gases allowing us to study mixtures with a su ciently high number of atoms. Moreover, the interaction between a fermion and a boson in the mixture  ${}^{40}$ K ( ${}^{87}$ Rb of the F lorence experiment [5] is strongly attractive, thus the induced fermion (fermion interaction can be very elective to bind fermions in correlated pairs. The calculations are performed on a general ground, however, when more phenom enological aspects are concerned, they mostly refer to the physical environment of R ef. [5].

### II. FORMALISM

In this section the e ective interaction between two ferm ions, m ediated by density uctuations of the Bose gas, and the equation for the energy gap in the excitation spectrum of the Ferm i gas are derived. The calculations are performed by means of functional methods thoroughly, since both the properties of the Bose condensate and the induced ferm ion {ferm ion interaction can be directly obtained in the same scheme (for a introduction to functional methods see e.g. Ref. [10, 11]).

#### A. E ective interaction

The starting point is the functional { integral expression for the grand { canonical partition function of the Bose { Ferm im ixture, that reads

The integration is performed over the complex eld (x; ) (bosons) and the Grassman eld

(x; ) (ferm ions), which are respectively periodic and anti{periodic in the imaginary{time interval (0; = 1=T) (units such that  $h = c = k_B = 1$  are used). Since we dealwith spin{polarized particles, (x; ) and (x; ) are one{component elds. The action functional has been written as the sum of three term s: the action for the boson eld

Here  $_{\rm B}$  and  $_{\rm F}$  denote the boson and ferm ion chem ical potentials respectively. In writing the action functional, the usual zero {range approximation for the interactions between atoms has been adopted [6, 7, 8, 9]. The corresponding coupling constants are dened as follows: = 4  $a_{\rm BB} = m_{\rm B}$  and = 2  $a_{\rm BF} = m_{\rm R}$ , where  $a_{\rm BB}$  and  $a_{\rm BF}$  are the boson {boson and ferm ion { boson scattering lengths respectively, and  $m_{\rm R} = m_{\rm B}m_{\rm F} = (m_{\rm B} + m_{\rm F})$  is the reduced m ass for a boson of m ass  $m_{\rm B}$  and a ferm ion of m ass  $m_{\rm F}$ . Finally, according to the previous remarks, in Eq. (3) the ferm ion interaction has been om itted.

The Bose gas is treated within the G aussian approximation, i.e. all terms of order higher than second in the uctuations of the boson eld about the uniform and constant condensate amplitude are neglected. This corresponds to the Bogoliubov approximation for a simple Bose gas. For a weakly interacting gas,  $n_B a_{BB}^3 << 1$  ( $n_B$  is the boson density) and at low temperatures, this approximation is well justified [12]. The rest step consists in evaluating the condensate amplitude about which the perturbative expansion can be performed. The standard m ethods employed for a simple Bose gas [10, 11] are extended to a fermion (boson mixture. First the action functional is integrated over the fermion elds, then, a uniform and constant boson eld (x; ) = ', which makes the action stationary, is searched for. The integration over the fermion in the functional integral. This gives the two following contributions to the action functional

where the trace operation implies integration over the continuous variables x; . Here  $G_0^{-1}$  (x x<sup>0</sup>; <sup>0</sup>) is the inverse of the G reen function for free fermions. The rst variation of the action functional takes the contribution

from the second term of Eq. (5). The quantity G  $(x;x^0;;)^0$  is the Green function for ferm ions interacting with the scalar eld (x;). Adding the contributions coming from the boson term of the action, for the density of the zero {m om entum B ose condensate,  $n_B^0 = \prime^2$ , the following equation is obtained

This equation has been derived assuming, without loss of generality, that the quantity ' is real. We can see that the e ect of the interaction with the Ferm i gas simply amounts to replacing the chemical potential  $_{\rm B}$  with the electric value  $_{\rm B}$   $n_{\rm F}$ .

The next step is the introduction of the change of variables  $^{0} = '$  in the term s  $S_{B}(;)$  and  $S_{I}(;;;)$  of the action functional. The term with '<sup>2</sup> represents the interaction of the ferm ions with the condensate m ean { eld,  $n_{B}^{0}$  and can be added to the chem ical potential  $_{F}$  in  $S_{F}(;)$ . The term s containing products of m ore than two am - plitudes  $^{0}$ , are neglected according to the Bogoliubov approximation. Thus, the action for

the uctuations of the boson eld is given by

In order to obtain an elective interaction for the ferm ions, the integration over the uctuations  $^{0}$  and  $^{0}$  should be performed. The result is an elective action containing only the ferm ionic elds and

The term  $\ln (\det \beta_0^{-1})$  together with the action evaluated at the stationary point  $^0 = 0$ , give the grand potential in the Bogoliubov approximation for a Bose gas with the elective chemical potential  $_{\rm B}$   $n_{\rm F}$ .

The last two terms on right hand side of Eq. (8) represent an elective interaction among fermions. When expanded in powers of the fermion elds, both terms give rise to n {body forces. Only terms containing up to four elds are taken into account, so both states with more than two virtual phonons in the boson {density uctuations and n {body forces among fermions, with n greater than two, are neglected. We expect this to be a reasonable approximation for su ciently dilute gases. According to this approximation, the boson

G reen function is replaced with the B ogoliubov propagator,  $\hat{B} = \hat{B}_0$  in the source term, and term s up to second order are retained in the expansion

The space {Fourier transform of the contribution from the source term of Eq. (8) to the extive interaction between ferm ions is given by

where  $D_0^{(ij)}$  are the elements of the 2 2 m atrix  $\hat{B}_0$ ; for their explicit expressions see, e.g., Ref. [12] (the denition of  $\hat{B}_0$  used here diers from that of Ref. [12] by an overall minus sign). Concerning the contributions from the expansion of Eq. (9), the term with n = 1represents the mean eld acting on the fermions due to the noncondensate fraction of the Bose gas. This term can be added to the chemical potential of the fermions, giving together with the analogous term of Eq. (8) the elective chemical potential  $_F = _F n_B$  for the fermions. The space{Fourier transform of the contribution from the term with n = 2 reads

This term is the contribution to the elective interaction from states containing two virtual phonons.

A rough estimate of the terms of Eq. (9) corresponding to the exchange of n > 2virtual phonons between ferm ions can be done by means of the following considerations. The expansion of Eq. (9) contains correlations of the boson density uctuations of higher and higher order when n increases. A coording to the basic assumption m ade in this paper, the correlations will be evaluated at equal times. In this case, we should expect that the contribution of a term of the series with respect to that of the previous term, contains an extra power of  $n_B^0$ . Here,  $n_B^0$  is the density of the noncondensate bosons. In addition, when n increases by a unit, the e ective action of Eq. (8) contains an additional integration on the time, which gives a multiplicative factor of the order of magnitude as . Thus, we can interpret the right hand side of Eq. (9) as a perturbative expansion in powers of the adim ensional parameter  $n_B^0 = T$ . Sim ilar considerations can be done for the term s neglected in the perturbative expansion of the last term of Eq. (9). At the densities and tem peratures considered in this paper the parameter  $j n_B^0 = T j$  takes a value of 0.15. Since the order parameter of the superconducting phase, in the approach of this paper turns out to be not critically dependent on the ferm ion  $\{ferm ion | ferm ion (see Eq. (23) of Sec. III),$ corrections to the elective ferm ion {ferm ion interaction coming from terms of order higher than second will be neglected in order to simplify calculations.

#### B. Pairing eld

The e ective interaction obtained involves ferm ions at two di erent times. The approximations which can be introduced in order to get rid of the retardation e ects and simplify calculations, will be discussed later. Now, the equations for the eld representing the pairing of two fermions, are derived.

W ith the approximations discussed above, the partition function of Eq. (1) assumes the following factorized form

where  $_{\rm B}$  is the grand potential of the Bose gas, while the ferm ion e ective action of Eq. (8) becomes

The pairing eld is identied with the composite eld which makes the eld value of  $S_{eff}(;)$  stationary. This can be determined by means of a Stratonovich (Hubbard transformation [13, 14] introducing auxiliary elds for the couples and , and by equating to zero the rst variation of the resulting elds ective action with respect to the auxiliary elds. A fler the transformation, the exponential in the integral of Eq. (12) is replaced by

In the functionals containing the coupling between ferm ions and auxiliary elds, only the parts of and which are antisymmetric under the permutation 1 \$ 2 survive. This rejects the prescription of the Pauli principle for ferm ions in the same spin state.

The integration over the ferm ionic elds can be form ally perform ed, giving the following action for the auxiliary elds

The equation for the pairing eld can be obtained by equating to zero the functional derivative of S (; ) with respect to either or , equivalently. It reads

where  $G^{(12)}(k_2;k_1; 0)$  is the anom alous propagator for ferm ions interacting with the pairing eld <sup>b</sup> (see, e.g., Ref. [12]). Because of time{translation invariance both the pairing eld and the ferm ion propagator depend only on the di erence of times.

It is convenient to introduce the center of mass momentum  $P = k + k^0 = k_1 + k_2$ , thus, for a given value of P, an equation containing only one integration variable, k, can be obtained. The solutions of Eq. (16) with P  $\leftarrow$  0, correspond to a breaking of the space{translational symmetry, i.e. the LOFF phase [15]. Here, only solutions with vanishing center of mass momentum are considered. In this case, the pairing eld and the anom alous propagator depend on only one momentum,  $k = k^0$  and  $k_1 = k_2$ , respectively. The propagator  $G^{(12)}(k_1; 0)$  is given by the Fourier series

where  $!_n$  are the M atsubara frequencies for ferm ions and  $^2_{k_1} = (k_1^2 = 2m_F _F)^2$ .

Now, two di erent paths of approximation which allow us to neglect the time (or frequency) dependence of the pairing eld, are discussed. Generally, for evaluating the time behavior of a propagator we should make an analytical continuation to realtimes (i ! t) or, equivalently to real frequencies ( $i!_n ! !$ ). However, for the two cases that will be envisaged, we can directly refer to the equations just derived. Both approximations are based on the comparison of the characteristic times of propagation for fermions and for bosons. For a quasi degenerate Ferm i gas only the particles with momentallying about the Ferm i surface partecipate in the pairing process. Then, for a given momentum q, the fermion time (scale can be estimated as  $t_F = 1 = v_F q$ . W hile for bosons, the quantity  $t_B = 1 = c_s q$ , where  $c_s$  is the sound velocity in the Bose gas, can be assumed to give an estimate of the characteristic time. The comparison between the two time (scales reduces to compare the velocities  $v_F$  and  $c_s$ . The case, when  $c_s >> v_F$ , is examined rst. This is the assumption

usually made when studying boson { induced interactions between ferm ions for Bose { Ferm i m ixtures. For  $c_s >> v_F$  retardation e ects on the induced interaction can be neglected, i.e. only the ! = 0 component of the time {Fourier transform of the boson propagators in Eqs. (10) and (11) is retained. A lso, the ferm ion propagator  $G^{(12)}$  (k; <sup>0</sup>) can be evaluated at equal times (= 0). The pairing eld in turn becomes an instantaneous function of the  $^{0}) = (k)$  ( <sup>0</sup>). The equation obeyed by the pairing eld is time di erence, (k; the usual gap equation of the BCS theory. The second approximation is the opposite of that just discussed: the Ferm i velocity can be assumed to be much larger than the sound velocity. Then, the propagator  $G^{(12)}$  (k; <sup>0</sup>) is a fast changing function of time with respect to the boson propagators, so that in Eq. (16) the static limit of the elective interaction can be taken. In this case, the boson {induced interaction is the space {Fourier transform  $^2$ ) of the static correlation function for density uctuations. In the following (times calculations, this second approximation will be adopted, since it is closer to the physical situations realized in experiments. Thus, in the frequency representation, the equation (16) for the pairing eld with P = 0, is given by the following expression

W hen evaluating the energy gap in the spectrum of elementary excitations, an analytical continuation of this equation to real frequencies should be made, in order to determ ine the real poles of the ferm ion G reen function. However, for assessing the occurrence of a superconducting phase and for evaluating the order of magnitude of the energy gap, it is su cient to take into account only the ! = 0 component of the pairing eld, (k). This quantity satis es the equation

Here  $V_{eff}$  (k  $k_1$ ) denotes the elective interaction at equal times, its explicit expression, with  $q = \frac{1}{3}$   $k_1$  j is

The rst term on right hand side of Eq. (20) is the contribution from states containing one virtual phonon, and it comes from the correlations of the products of the condendate and noncondensate am plitudes taken at two di erent space points. The second term is the contribution from states containing two virtual phonons, and it is related to the noncondensate {density correlations.

A few remarks should be made. First, according to the Pauli principle, the pairing eld should be an odd function of k in order to change sign under the permutation of the two

correlated ferm ions. This excludes contributions to the pairing eld from interactions acting only in the s{wave channel. So that, as previously remarked, the bare ferm ion {ferm ion interaction can be completely neglected in the present scheme. In addition, the function  $V_{eff}(q)$  has a simple pole, when q ! 0. However, this is a ctitious pole, since, if the the integrals in Eq. (20) are replaced by a sum over the momenta, the boson states with vanishing momentum should be excluded. A ctually, this restriction may be om itted, because it a ects the integrand of Eq. (19) only at a single point and the integration gives a nite result. Finally, it is worth noting that  $V_{eff}(q)$  does not represent a usual two {body potential, since an integration over the time is absent.

In order to solve Eq. (19) it is convenient to expand (k) in spherical harm onics

W ith this approximation, the di erent m {components turn out to be uncoupled and all equal; in addition, they can be assumed to be real and positive, without loss of generality. The quantity  $^{2}$  (k) represents the averaged energy gap in the quasiparticle spectrum of the superconducting phase.

The equations for the partial waves of the pairing eld,

They are bounded quantities for  $k = k_1$ , in spite of the occurence of a pole when the argument of  $V_{eff}$  (q) vanishes.

## III. RESULTS

The tem perature, density and relative concentrations of the gasm ixture are assumed such that a relevant fraction of the Bose gas is in the condensate phase and the Ferm i gas is still quite degenerate. To be more speci c, we refer to the experimental environment described in Ref. [5], where a mixture of <sup>87</sup>Rb (bosons) and <sup>40</sup>K (ferm ions) atoms, with a relevant ratio between the ferm ion and boson densities,  $n_F = n_B = 0.5$ , has been studied. For the hom ogeneous boson gas, a value  $T_c = 110$  nK for the critical temperature of condensation has been chosen, in order to reproduce values of temperature and condensate fraction close to those reported in Ref. [5]. The corresponding boson density is  $n_B = 1.45 = 10^{13}$  cm<sup>-3</sup>. This is a reasonable value for the average boson density obtained in the experiment of

Ref. [5]. M oreover, for the boson {boson and boson { ferm ion scattering lengths, the values  $a_{BB} = 113a_0$  and  $a_{BF} =$  $330a_0$  are used, where  $a_0$  is the Bohr radius. The range of the  $n_{B}^{0} = n_{B}$ condensate fractions considered in the present calculations is 0:4 0:8, and the corresponding interval of tem peratures is 46n K 87nK.W ith these values of the Т relevant parameters, the ratio between the Ferm i velocity, de ned as  $v_{\rm F}$  =  $2 = m_F$ , and  $n_B^0 = m_B$ , turns out to be about 20. This value of the sound velocity in the Bose gas,  $c_s =$  $v_{\rm F} = c_{\rm s}$  is su ciently large to justify the approximation of Eq. (20) to the electric interaction. M oreover, the Ferm item perature corresponding to the density n<sub>F</sub>  $0:5n_{\rm B}$ ,  $T_{\rm F}$ 320n K , is high enough with respect to the tem peratures in the interval considered, so that the Pauli principle is still operating.

The results for the elective interaction are discussed rst. A simple inspection of Eq. (20) shows that the contributions from states with one virtual phonon and from states with two virtual phonons, approach the values  ${}^{2}n_{B}^{0}$  and  ${}^{2}n_{B}^{0}$ , respectively, when  $q \leq 1$ .

In Fig. 1 the elective interaction of Eq. (20) is shown togheter with the separate contributions from one{phonon and two{phonon states, for  $n_B^0 = n_B = 0.6$ . We can see that the two contributions are of the same order of magnitude for  $q = 0.5 r_{0F}^{-1}$ , with  $r_{0F}$  denoting the mean spacing of the Fermi atom s, and that the asymptotic values are practically reached already at  $q = 1.5 r_{0F}^{-1}$ . This suggests that the contribution from states containing two virtual phonons cannot be neglected, unless the condensate depletion is very sm all.

In Fig.2 the elective interaction is displayed for three dimensional error values of the condensate fraction. From Fig.2 we can see that, in the considered range of  $n_B^0 = n_B$ , for a like value of the boson density the magnitude of the elective interaction increases with the condensate

depletion, or, equivalently, with the tem perature. This is due to the fact that the increase with the noncondensate fraction of the two{phonon contribution, overcom es the decrease with  $n_B^0$  of the one{phonon contribution. However, for higher values of the condensate depletion, the increase of  $V_{\rm eff}$  (q) results considerably quenched.

Concerning the solutions of the gap equation (22), it should instible remarked that the fast approach of the elective interaction to an almost constant value makes the odd components  $V_1(k;k_1)$  vanish rapidly at high momenta. As a consequence, for evaluating the integral of Eq. (22) it is not necessary to introduce any cut{o on high values of  $k_1$ . The explicit solutions of Eq. (22) display two general features for the physical situations considered: they give, for all values of 1, a small energy gap, with respect to the elective chemical potential of the of the fermions,  $_1(k) = _F$  10<sup>2</sup>, and they give a non-vanishing energy gap only for a single value of 1 at a time, without any coupling to the remaining components. The latter feature can be better understood by observing that, for small values of  $_1(k)$ , the most relevant contribution to the integral of Eq. (22) comes from a small domain about the elective Ferm imomentum,  $k_F = \frac{P}{2} \frac{P}{F} \frac{m}{F}$ . This allows us to approximate all the quantities in the integrand, apart from  $_{k_1}$ , by the values that they take at  $k_1 = k_F$ . Thus, Eq. (22) turns into the following closed equation for each value of k

It is easy to see that Eq. (23) can have nontrivial solutions only when  $1^{0} = 0$  for  $1^{0} \in 1$ . In addition, it is worth noting that the energy gaps given by Eq. (23) represent a very satisfactory approximation to the num erical solutions of Eq. (22).

The solutions of Eq. (22) indicate that transitions to di erent superconducting phases could occur. Each phase is characterized by a nonisotropic pairing eld, whose angular dependence is given by a speci c spherical harm onic. The corresponding energy gap contains only one term  $_1(k)$ .

In Fig.3 the energy gap is displayed for three di erent values of lat a xed condensate fraction (or tem perature). The fast decrease of the energy gap with increasing lcorresponds to the analogous behavior of the elective interaction. W hile the peak shown by  $_1(k)$  about  $k = k_F$  is due to the sharp increase of the elective interaction when the transferred momentum appoaches zero. This can be directly seen from the approximate equation (23).

The behavior with the condensate fraction, of the energy gap for l = 1 is reported in F ig. 4. All l{channels show a similar behavior. We see that, when  $n_B^0$  decreases, or, equivalently, the tem perature increases, the gap  $_1$  (k) increases for all values of k. This feature essentially rejects the analogous behavior of the elective {interaction strength. However, the ferm ion gas becomes less and less degenerate when the tem perature increases, so that, the corresponding decrease of the elective Ferm imomentum tends to counterbalance the election of the elective interaction. A ctually, explicit calculations show that, for T 100nK corresponding to  $n_B^0 = n_B$  0.2, the gap  $_1$  (k) reverses its initial behavior. It should be observed that the approximation scheme proposed in this paper does not keep its validity for higher tem peratures. In any case, the results of the present approach show that a superconducting phase in the p{wave channel can be achieved at tem peratures > 100nK . In Ref. [B] a critical tem perature of  $10^2$  nK was indicated for p{wave pairing in a mixture of <sup>6</sup>Li and <sup>87</sup>Rb.

For thism ixture calculations perform ed within the present scheme and with the same values of parameters as in Ref. [8], show that the behavior of the energy gap qualitatively does not dier from that of Fig. 4. The deep discrepancy between the results of the present work and those of Ref. [8] should be ascribed to the fact that in the two approaches two opposite approximations have been used for the time dependence of the elective interaction. These approximations have already been discussed in Sec. IIB.

## IV. SUMMARY AND CONCLUSIONS

In a mixture of ultracold Ferm iand Bose gases, an interaction between ferm ions is induced by the exchange of elementary excitations of the Bose gas. Due to this supplementary interaction, a superconducting phase can appear in the Ferm i component of the mixture. The mechanism is analogous to that accounting for superconductivity in ordinary metals. In this paper, a procedure to determ ine the induced interaction and to assess the possibility of a phase transition has been proposed. For simplicity, a spatially hom ogeneous system has been considered. Both the gases have essentially been treated within a mean eld approximation appropriate for the physical conditions realized in recent experiments: the values of temperature and densities are such that the Bogoliubov approximation for the Bose gas can be justified and the Ferm i gas can be considered degenerate. Moreover, since the experiments concern gases con ned by means of magnetic traps, in the present approach the atom s of both species have been considered completely polarized. This circum stance has allowed the bare ferm ion interaction to be neglected.

The same form alism, based on functional methods, has been used in all stages of the calculation. This allows us to introduce the various approximations to the elective interaction between ferm ions in a self{consistent way. In particular, the inclusion of the contributions from states containing two virtual phonons and the static approximation to its time dependence. This is more appropriate for the physical situations of actual experiments than the usual instantaneous approximation. Both terms of the interaction, with one and two virtual phonons, are attractive and of the same order of magnitude. They can give rise to the pairing of correlated couples of fermions with di erent values of the center of mass momentum. In this paper, only the pairing eld with vanishing center of mass momentum has been considered, thus preserving the invariance of the system under space translations. Since the paired fermions lie in the same magnetic state, the pairing eld is constrained to be an odd function of their relative momentum. Then, it contains only odd{l components, when expanded in spherical harm onics. A particular feature of the corresponding gap equations is that they show solutions with only one non vanishing partial wave at a time. Then, di erent nonisotropic phases may occur in the Ferm i component of the mixture, with the pairing

elds decreasing their strength when their multipolarity increases. It is worth noting that the energy gaps increase with the tem perature until a value of T 100nK, corresponding to a high depletion of the Bose condensate  $n_B^0 = n_B$  02. The approximations introduced in the present approach become less reliable for higher values of the tem perature, for the values of boson and ferm ion densities assumed here. Nevertheless, we can expect that a superconducting phase can occur in a Bose{Ferm imixture at T > 100nK. This value is a relevant fraction of the Ferm item perature.
