Dynam ics of a classical gas including dissipative and mean eld e ects

By means of a scaling ansatz, we investigate an approxim ated solution of the Boltzm ann-V lasov equation for a classical gas. W ithin this framework, we derive the frequencies and the damping of the collective oscillations of a harm onically trapped gas and we investigate its expansion after release of the trap. The method is well suited to studying the collisional e ects taking place in the system and in particular to discussing the crossover between the hydrodynam ic and the collisionless regimes. An explicit link between the relaxation tim es relevant for the dam ping of the collective oscillations and for the expansion is established.

The favored signature of Bose-Einstein condensation in weakly interacting gases is the tim e-of-ight expansion [1]. In this technique, the asym m etric trapping potential is switched o and the evolution of the spatial density is monitored. After long time expansion, the observed inversion of the aspect ratio re ects the an isotropy of the initial con nem ent. In an ideal Bose-E instein condensate (BEC), this e ect is a direct consequence of the Heisenberg uncertainty constraint on the condensate wave function. For an interacting BEC, the inversion is also produced by the anisotropy of the pressure gradients caused by the hydrodynam ic forces. The changes in the shape of the expanding gas can be characterized by scaling factors, which provide an easy quantitative tool for the analysis of on-going BEC experiments. The set of equations for those factors have been derived in m any papers [2,3]. A similar e ect has also been predicted for a Fermigas in its super uid phase [4]. Strong anisotropy has been recently measured in the expansion of a highly degenerate Fermigas [5] close to a Feshbach resonance. Resonance scattering can also give rise to anisotropic expansion in the norm alphase as proven in the experiments of [6,7]carried out in a less degenerate regime. Som e recent experim ents on bosonic atom s above the critical tem perature have also reached the collisional regim e investigating both the oscillations of the low lying quadrupole mode and the expansion in asymmetric traps [8,9].

So far analytic calculations for the expansion of a classical gas have been limited to either the ballistic or to the hydrodynam ic regime [3]. As a consequence, it is important to generalize such calculations to all intermediate collisional regimes. This is precisely the main purpose of this paper. We begin by an outline of the theoretical description of the thermal gas based on the Boltzm ann-V lasov equation. Our approach relies on an approxi-

m ated solution to this equation by means of a scaling ansatz. This solution is used throughout the paper to investigate two kinds of related problem s: the lowest collective oscillation modes and the tim e-of- ight expansion when the con nem ent is released.

The Boltzmann-V lasov (BV) kinetic equation for the phase space distribution f(t;r;v) takes the form :

where U_h is the trapping potential chosen of harm onic form : U_h (r) = $\frac{m}{2}$ $\frac{1}{2}r_i^2$. Interparticle interactions enter Eq. (1) in two di erent ways [10]. On the one hand, they modify the e ective potential through the mean eld term U_{m f} which a ects the stream ing part of the Boltzm ann kinetic equation. The mean eld potential $U_{m\,f}$ is equal to 2gn for bosons and gn for two ferm ion species [11], where the coupling constant $q = 4 \sim a = m$ is xed by the s-wave scattering length a. The mean eld term is linear in a and is non dissipative. On the other hand, two body interaction determ ines the collision integral $I_{coll}[f]$ which is quadratic in the scattering length, and describes dissipative processes. Eq. (1) is valid in the sem i-classical lim it, namely when the therm all energy is large compared with the separation between the energy eigenvalues of the potential [12,13].

In this paper, we will treat the collision integral within the relaxation time approximation. This model should su ce to capture the essential physics of the problem. We consequently write:

where is the relaxation time related to the average time between collisions, and f_{le} is the local equilibrium density in phase space. As a consequence, f_{le} has a spherical symmetry in velocity space, i.e. it depends on the velocity through $[v \quad u(r)^{2}]$ where u(r) is the local velocity eld.

The dynam ics of the gas will be described by the following scaling ansatz for the non equilibrium distribution function:

where f_0 is the equilibrium distribution function which satis es the equation $(I_{coll}[f_0] = 0)$:

The dependence on time of f is contained in the dimensionless scaling parameters b_i and $_i$. The parameters b_i gives the dilatation along the ith direction, while $_i$ gives the e ective temperature in the same direction. Such an ansatz generalizes the one used in [14]. We recall that in this method the shape of the cloud does not explicitly enter the equations. This is the reason why the solutions are equally valid for a dilute Bose gas above the critical temperature, a dilute Ferm igas in its norm alphase, and a classical gas.

Follow ing R ef. [14], one can derive the set of equations for the scaling parameters b_i and i (see Appendix A):

where the dimensionless parameter = $hU_m fi_0 = (hU_m fi_0 + 2m hv^2 i_0 = 3)$ accounts for the mean eld interaction [15] and = $i_1 i=3$ is the average temperature, for a classical gas $hv^2 i_0 = 3k_B T = m$. The parameter is expected to be small for dilute gases (na³ 1) since the ratio $U_m f = k_B T$ scales as $(na^3)^{1=3}$ (n $\frac{3}{db})^{2=3}$, where db is the de B roglie wavelength and n the mean density [14]. Eq. (6) shows that the dissipation occurs when the temperature is not isotropic and the relaxation time has a nite value.

Eqs (5) and (6) are the main result of this paper. The collision less regime is obtained by taking $_0 = 1$. In this lim it, we have the simple relation $_i = b_i^{2}$ between the scaling parameters, and we recover the equations derived in [14]. In the opposite lim it (hydrodynamic regime), b-calequilibrium is always ensured because of the high collision rate. As a consequence, we have $_i = -\frac{2}{j}b_j^{2=3}$ and the Eqs (5) and (6) can be recast in the form :

For = 0 (no mean eld), we recover the equations rst derived in [3]. Note that in both the collisionless and the hydrodynam ic regimes, the collisional term does not contribute since there is no dissipation in these limits. We next focus our attention on the intermediate regimes where the collision term enters explicitly the equations of motion.

Let us rst study the breathing mode in the case of spherical harm onic trapping with angular frequency $!_0$. In this case, we nd a solution with $b_i = b$ and $_i = b^2$. For such a solution the collision term identically vanishes in all interm ediate collisional regimes. Our approach can be readily generalized to lower dimensions leading to the frequency $!_0 (4 + (d 2))^{1=2}$ for the monopole mode [14], where d is the dimension of space. In two dimensions the mean eld does not a ect the frequency of the monopole. This comes out from the fact that in this case the ansatz is an exact solution of the BV equations, as already stressed in Ref. [16].

We now consider a sample of atom s con ned in a threedimensional cylindrically symmetric harmonic potential. We denote by $= !_{z}=!_{?}$ the ratio between the axial and radial angular frequencies. Expanding Eqs. (5) and (6) around equilibrium ($b_{i} = i = 1$) we get a linear and closed set of equations which can be solved by looking for solutions of the type $e^{i!t}$. The associated determinant yields the dispersion law:

where A [!] = !² (!² !²_{cl}) (!² !²_{cl}), B [!] = ! (!² !²_{hd}) (!² !²_{hd}), C [!] = ! (!² !²_{cl}) and D [!] = (!² !²_{hd}) and 0 is the value of the relaxation time calculated at equilibrium and

is the parameter accounting for the mean eld Here e ects and (cl) and (hd) refer to the collisionless and hydrodynam ics regim es respectively. The solution of Eq. (8) interpolates the frequencies of the low lying modes for all collisional regimes ranging from the collisionless to the hydrodynam ic. A sthe con nem ent is cylindrically symmetric around the zaxis, we can label the modes by their angular azim uthal num ber M . The st factor of the lh.s. of Eq. (8) gives the frequencies of the two M = 0 m odes, while the second factor gives that of the quadrupole (M = 2) mode. The roots of A and C have already been obtained in [14], and correspond to the frequencies of the low lying modes of a collision less gas in presence of mean eld. Eq. (8) for = 0 has been derived in Ref. [17] and the corresponding frequencies have been investigated experimentally [8]. For = 1, corresponding to $hgn_0 i_0$ $hv^2 i_0$, we nd $!_{cl}^2 = !_{hd}^2$, $!_{cl}^2 = !_{bd}^2$, and the frequencies coincide with the ones predicted for a Bose-E instein condensate in the Thom as-Ferm i regim e [18].

So far, we have not given the explicit link between the relaxation time entering Eq. (8) and the collision rate. Following Ref. [17], we can establish this link for a classical gas by means of a G aussian ansatz for the equilibrium distribution function f (r;v;t). One obtains $_0 = 5=(4)$ where = 2(2) $^{1=2}n_{m\,ax}$ v_{th} is the classical collision rate where v_{th} = $(k_B T = m)^{1=2}$ is the thermal velocity, $n_{m\,ax}$ is the peak density and is the cross section which is assumed to be velocity independent. For bosons the link between the scattering length and the cross section is $= 8 a^2$ whereas for two fermions species one has $= 4 a^2$.

W e now establish the set of equations that describe the tim e-of- ight expansion. In the collision less regim ewhere the m ean free path is very large with respect to the size of the trapped cloud and in the absence of m ean eld contribution, we readily obtain the exact equations $b_i = !_i^2 = b_i^3$ which adm it the solutions b_i (t) = $(1 + !_i^2 t^2)^{1=2}$, leading to isotropic density and velocity distributions after long tim e expansion.

W hen the e ect of collisions is in portant the physics of the expansion changes dram atically. As an example, the radial directions of a cigar-shaped cloud expand faster than the longitudinal one nally resulting in an anisotropic velocity distribution. So far, an analytic approach has been proposed only in the full hydrodynam ic regime β]. How ever, this approach assumes that the hydrodynam ic equations are alw ays valid during the expansion. In general, this cannot be the case since the density decreases during the expansion reducing the e ect of collisions. A lternatively, the expansion of an interacting B ose above T_c gas has been investigated by means of a M onte C arbo simulation [19].

In our approach, we provide an interpolation between the two opposite collisionless and hydrodynam ic regim es using the scaling form alism. The decrease of the collision rate during the expansion yields a non constant relaxation time (b_i ; $_i$) that depends explicitly on the scaling parameters and rejects the changes of the density and the temperature during the expansion. As a result, the expansion is described by the following set of 6 non-linear equations

The dependence of the relaxation time on the scaling parameters is obtained by noticing that the collision rate 1-2

scales as nT $^{1=2}$. Using the scaling transform ation n ! $n_0 \begin{pmatrix} & \\ & \\ & \\ \end{pmatrix} b_j \end{pmatrix}^{-1}$ and T ! T_0 , where n_0 and T_0 are the initial density and temperature respectively, we deduce

where $_0$ is the average time of collision at equilibrium [20]. Since both the results (8) for the dispersion of the linear oscillations and Eqs. (9) and (10) for the expansion have been derived starting from the same scaling equations (5) and (6) the relaxation time $_0$ entering the two processes is the same. As a consequence, the combined investigation of the expansion and of the quadrupole oscillations can provide a useful check of the consistency of the approach and, possibly, useful constraints on the value of the cross section.




FIG.1. A spect ratio as a function of the normalized time $!_{2}$ t for di erent collisional regimes (initial aspect ratio = 0:1): collisionless (dashed line, $_{0}$! 1), interm ediate collisional regime (solid line, $!_{2} = 0$ = 0:1), hydrodynamic regime (dotted line, $_{0}$! 0).

The time evolution of the aspect ratio R_2 (t)= R_z (t) = $b_{?}$ (t)= b_{z} (t) in the absence of mean eld is depicted on Fig. 1 for di erent values of the product $!_{?}_{0}$ and for an initial aspect ratio = 0:1. In the collision less regime $(_0 = 1)$, the aspect ratio tends asymptotically to unity re ecting the isotropy of the initial velocity distribution. For other collisional regim es, the asym ptotic aspect ratio is larger that one as a consequence of collisions during the expansion. We nd a continuous transition from the collisionless to the hydrodynam ic prediction as we decrease 0 from in nity to zero. We then conclude that in general the expansion cannot be described with either the hydrodynam ic or the collisionless prediction [21], but requires a full solution of our equations (9). Sim ilar conditions have been already encountered experim entally for classicalor alm ost classical gases [9]. W e also notice that it is very in portant to take into account the tim e dependence of the relaxation time, accounted for by the scaling law (10). For example by simply using $= _0$ during the whole expansion, the curve $!_{?} = 0:1$ of Fig. 1 (solid line) would be shifted upward and the resulting prediction would result much closer to the hydrodynam ic curve (dotted line).

Let us nally comment on the e ect of quantum statistics on the calculation of the relaxation time. For a Bose gas at temperature above T_c the problem has been investigated in [22] where it has been shown that statistical e ects do not play a signi cant role. In contrast, the relaxation time in a harmonically trapped dilute Ferm i gases has been shown to be strongly a ected by Pauli blocking at low temperature [23]. The e ects of collisions in a strongly interacting Ferm i gas, including the unitarity limit, have been recently addressed in [24].

APPENDIX A: EQUATIONS

W e m ake the following ansatz for the non equilibrium distribution function: $f(r;v;t) = f_0(R(t);V(t))$ with $R_i = r_i = b_i, V_i = (v_i \quad b_i r_i = b_i)_i^{1-2}$ and $= jb_j^{1-j}_j^{1-2}$. The dependence on time is contained through the param - eters b_i and $_i$. Following [14], we substitute this ansatz into Eq. (4) and use the equation for the equilibrium distribution f_0 . We nd

tion in phase space, we calculate the average moment of R_iV_i, namely R_iV_i [Eq:(A1)]d³Rd³V=N. This leads to Eq. (5). Note that this equation is not a ected by the collision integral since the quantity R_iV_i is conserved by collisions.

To derive Eq. (6), we consider instead the average moment of V_i^2 . This yields:

where T_0 is the equilibrium temperature. Dierently from (5), Eq. (A2) depends explicitly on the collision integral. In order to calculate the rhsofEq. (A2), we use the relaxation time approximation: $I = (f \quad f_e) = _0$. The rst term gives: $V_i^2 f d^3 R d^3 V = N \quad k_B T_0 = m$. To obtain a relation among the scaling parameters one uses the identity $hv^2i = hv^2i_{le}$, from which we deduce $= {}_i i=3$. The contribution of the local equilibrium term to the second term is obtained by noticing that, at local equilibrium, ${}_i^{le} = : V_i^2 f_{le} d^3 R d^3 V = V_i^2 f_0 (R; V) d^3 R d^3 V = N \quad k_B T_0 = (m i)$. Hence Eq.

(A2) can be recast in the form (6).
