# Charge $F$ luctuations for a C oulom b F luid in a D isk on a P seudosphere

#### Abstract

The classical (i.e. non-quantum ) equilibrium statistical mechanics of a C oulomb uid living on a pseudosphere (an in nite surface of constant negative curvature) is considered. The Coulomb uid occupies a large disk communicating with a reservoir (grand-canonical ensemble). The total charge $Q$ on the disk uctuates. In a macroscopic description, the charge correlations near the boundary circle can be described as correlations of a surface charge density. In a $m$ acroscopic approach, the variance of $Q$ and the correlation function of are com puted; they are universal. These $m$ acroscopic results are show $n$ to be valid for tw o solvable $m$ icroscopic $m$ odels, in the lim it when the $m$ icroscopic thickness of the surface charge density goes to zero.

## 1 IN T R O D U C T IO N

$T$ his paper is dedicated to $E$ liott Lieb on the occasion of his 70th birthday. It is a variation on a them e to which Elliott has brought m a jor contributions. [1, 2]

H ow statistical m echanics is a ected by the curvature of space $m$ ight be of som e interest in general relativity, and also is an am using problem per se. A simple case is a two-dim ensional system living on a pseudosphere, i.e. a surface of constant negative curvature. U nlike the sphere, the pseudosphere has an in nite area, and therefore, on a pseudosphere, one can consider the therm odynam ic lim it of som e system while keeping a given curvature. A special feature is that, for a large dom ain, the neighborhood of the boundary has an area of the sam e order ofm agnitude as the whole area of this dom ain; this feature $m$ akes the approach to the therm odynam ic lim it rather di erent to what happens in a at space.

M ore speci cally, the present paper deals w th a tw o-dim ensionalclassical (i.e. non-quantum ) Coulomb uid living on a pseudosphere. This is a system of charged particles interacting by C oulomb's law, w ith this law de ned on the pseudosphere, i.e. as the solution of the P oisson equation written w ith the pseudosphere metric. The Coulomb uid is assum ed to be in equilibrium and con ned in a large disk drawn on the pseudosphere. T he grand-canonicalensemble is used: the uid can freely exchange particles $w$ ith a reservoir. $T$ hus, the total charge $\mathrm{Q} m$ ay uctuate. Furtherm ore, there are charge correlations w hich, near the circle boundary of the disk, can be described as correlations of a surface charge density. The aim sof the present paper are to com pute the variance of $Q$ and the two-point correlation function of. It willbe show $n$ that these quantities are universal (i.e. independent of the $m$ icroscopic nature of the uid). These universal results $w$ ill be checked on two exactly solvable models: the two-com ponent plasm a, $m$ ade of two species of particles of opposite signs, and the one-com ponent plasm a, $m$ ade of one species of particles in a neutralizing background.

These problem s have already been studied and solved in a at space. For a nite twodim ensional Coulomb uid in a plane, the total charge $Q$ essentially does not uctuate [3]. Furtherm ore, in the case of a large disk of radius $R$ centered at the origin, the surface charge correlation function [4] is given by the universal expression

where is the inverse tem perature, (') the surface charge density on the boundary circle at the point of polar angle', and $<:::>^{T}$ is a truncated statistical average. These results have been checked on exactly solvable m odels. [3,5]

H ere, the sam e problem s are considered, now on a pseudosphere. In Section 2, som e basic properties of the pseudosphere and ofC oulom.b's law on it are recalled. In Section 3, m acroscopic electrostatics on a pseudosphere is used for determ ining the variance of the total charge $Q$ and the correlation function of the surface charge density. In Section 4, the results are checked on a solvable $m$ odel, the two-com ponent plasm a at a special tem perature. In Section 5, the results are checked again on another solvable $m$ odel, the one-com ponent plasm a at a special tem perature.

## 2 PSEUDOSPHEREAND COULOM B'S LAW

Let us recalla few properties of the surface of constant negative curvature called a pseudosphere. Such a surface is a tw o-dim ensionalm anifold, the entirety ofw hich cannot be em bedded in three-
dim ensionalE uclidean space. Its properties are de ned by its m etric. Several sets of coordinates are com m only used.

The one which renders explicit the resem blance $w$ th the sphere is ( $;^{\prime}$ ) w ith $2[0 ; 1$ [and ' 2 ] ; ], the $m$ etric being

where $1=a^{2}$ is the $G$ aussian curvature (instead of $1=R^{2}$ for a sphere of radius $R$ ). T he geodesic distance s betw een two points at ( $;^{\prime}$ ) and ( $;^{\prime}{ }^{0}$ ) is given by

$T$ he set of points at a geodesic distance from the origin less than or equal to $R=a 0 \mathrm{w}$ ill be called a disk of radius R . Its boundary willbe called a circle of radius R . Its circum ference is

It is rem arkable that, for a large radius, both the circum ference and the area are proportional to $\exp 0$ : the neighborhood of the boundary circle has an area of the sam e order ofm agnitude as the whole area!

A nother often used set of coordinates is $\left(r^{\prime}{ }^{\prime}\right)$ w th $r=(2 a)=\tanh (=2)$. Then, the $m$ etric is

W hen these coordinates are used, the whole (in nite) pseudospherem aps on a disk of radius $2 a$, the $P$ oincare disk.

### 3.1 Two Problem s in M acroscopic E lectrostatics

Here are two problem s, the solution of which will be needed in the follow ing. On the pseudosphere, an ideal conductor lls the disk of radius $R=a 0$ centered at the origin.

C apacitance. The rst problem, a very simple one, is: $W$ hat is the capacitance of this disk? If the disk carries a charge $Q$, this charge uniform ly spreads on its circum ference and, by Newton's theorem (which can be easily shown to be valid on a pseudosphere), generates on the whole disk the constant electric potential $Q v(R)=Q \ln \tanh \left({ }_{0}=2\right)$. Therefore, the capacitance is

In the large-disk lim it $0!1, C \quad \exp (0)=2$.
A Point Charge in the P resence of the $D$ isk. The second problem is: A unit point charge is located, outside the disk, at point ( $\left.{ }^{0} ;^{\prime}=0\right)$. The disk is grounded (ie. kept at zero potential). W hat is the electric potential $\left(;^{\prime} ;{ }^{0}\right.$ ) at some point ( $;^{\prime}$ ), outside the disk? The $m$ ethod of im ages, which can be used for a at disk, does not seem to work on a pseudosphere, and a Fourier expansion will be used.
$T$ he potential due to the unit point charge alone is (2.11). Expressing th is potential in term s of cosh (s=a), using (2.2), and expanding as a Fourier series in' (in the case $<{ }^{0}$ which su ces for our purpose) gives

where 0 is related to 0 by the analog of (2.7).

### 3.2 C harge F luctuations

The disk of radius $R=a 0$ centered at the origin is led with a C oulom b uid. It can freely exchange charges w ith a reservoir located at in nity (grand canonicalensem ble). Ifm acroscop ic electrostatics is applicable, what is the variance of the charge $Q$ carried by the disk?

The sam e reasoning as in the at space case [3], using linear response theory, gives for the variance

### 3.3 Surface C harge C orrelations

In three dim ensions, $m$ acroscopic electrostatics deals $w$ ith volum e charge densities and surface charge densities. In the present case of a two-dim ensional system (a disk), the analog of the surface charge density actually is a charge per unit length on the boundary circle; we shall nevertheless still call it a surface charge density ( ${ }^{\prime}$ ). Ifm acroscopic electrostatics is applicable, what is the two-point correlation function of ( ${ }^{\prime}$ )?

The sam e reasoning as in the case of a at space [4], using linear response theory, gives for the two-point correlation function

In the at-space lim it a! 1 , 0 ! 0 , for a xed value of $R=a 0$, it can be checked that (1.1) is recovered. M ore interestingly, in the opposite lim it of a radius R large com pared to the \curvature radius" a, i.e. when $0!1$ and $0!0$, (3.11) takes a sim pler form. Indeed, after a Jacobi im aginary transform ation $[6,7]$, the 1 function can be expressed as the series

If $0<j j<\quad$, in the smallolim it ( $0 \quad 2 e^{0}$ ), the rst two leading term $s$ of the series (3.12) are $n=0$ and $n=1$. When only these term $s$ are kept, to rst order in their ratio exp ( j jo), (3.11) becom es

## 4 TW O-COM PONENT PLASMA ON A PSEUDOSPHERE

The total charge uctuation and the surface charge correlation have been obtained under the assum ption that $m$ acroscopic electrostatics is valid. In the large-disk lim it $R \quad a$, these results (3.5) and (3.13) will now be checked on two solvable $m$ icroscopic m odels. Such checks are welcom e, because a tw o-dim ensional case when $m$ acroscopic electrostatics is not valid, unexpectedly at rst sight, is know $n$ : the charge uctuations in a short-circuited circular condenser [3].
$M$ acroscopic electrostatics uses the concept of surface charge density. A ctually, in a m icroscopic model, this \surface density" will have som e microscopic thickness, and for macroscopic electrostatics to be valid, it is necessary that this thickness be negligible com pared to the $m$ acroscopic lengths. The $m$ icroscopic $m$ odel which $w i l l$ be used in the present section is the two-com ponent plasm a at a special tem perature. Its $m$ icroscopic scale is characterized by a fugacity , w th the dimension (length) ${ }^{2}$. In a disk of radius $R$ on a pseudosphere $w$ ith the \radius of curvature" $a$, there are two dim ensionless param eters involving $: \quad a^{2}$ and $R^{2}$. N ecessary conditions form acroscopic electrostatics to be valid is that both these param eters be large com pared to 1. H ere, for sim plicity, the disk is assum ed to be large ( $\mathbb{R} \quad$ a).

### 4.1 R eview of the $G$ eneral Form alism

The tw o-com ponent plasm a is a system of tw o species of particles, of charges 1. At the special inverse tem perature $=2$, the m odel is exactly solvable in di erent geom etries, in particular on a pseudosphere [9]. For the sake of com pleteness, the $m$ ethod of solution is brie $y$ revisited, in a form sim pler than in the original papers, by a generalization of what has been done in the case of a one-com ponent plasm a [8].

In term s of the coordinates ( $r$;') (the P oincare disk representation), the C oulom b interaction (2.11) betw een two unit point charges at $r_{i}$ and $r_{j}$ is

where $z_{j}$ is the com plex coordinate of particle $j$ (and $z_{j}$ its complex conjugate): $z_{j}=r_{j} \mathrm{e}^{\mathrm{i}^{j}}$. The interaction (4.1) happens to be the Coulombinteraction in a at disk of radius 2 a w ith ideal conductor walls at zero potential. Therefore, one can use the techniques which have been developed $[10,11]$ for dealing $w$ ith ideal conductor $w$ alls.

A lthough the integrals in the grand partition function (4.8) diverge (as the separation betw een a positive particle and a negative one goes to zero), this grand partition function can be form ally $m$ anipulated for providing nite correlation functions.

It will now be shown that the grand canonical partition function can be expressed as one determ inant of an in nite $m$ atrix, continuous in coordinate space. $F$ irst, one considers the functional integral

In the present case of a system on a pseudosphere, it is convenient to keep the sam e de nition ofm.

## 5 ONE-COMPONENTPLASMAON A PSEUDOSPHERE

The m acroscopic results (3.5) and (3.13) will now be checked on another solvable model, the one-com ponent plasm $a$. $T$ his is a system of one species ofparticles, ofcharges +1 , em bedded in a uniform background carrying the negative charge density $\quad n_{0}$. At the inverse tem perature $=2$, the system is exactly solvable in a variety of geom etries, in particular for a large disk of radius $\mathrm{R}=\mathrm{a}_{0}$ on a pseudosphere [8]. A grand canonical ensemble is used. For the grand partition function to be convergent, it is necessary to de ne it $w$ ith a xed value[2] of the background charge density $n_{0}$; the fugacity controls the num ber ofparticles. Thus, in general, the system is not globally neutral, except for a particular choige of the fugacity.

In the bulk the properties of the system are controlled by the background: the particle num ber density aw ay from the boundary is $n_{b}$. H ow ever, near the boundary, the particle density di ers from $n_{b}$, and, since on a pseudosphere the neighborhood of the boundary has an area of the sam e order ofm agnitude as the whole area, this neighborhood gives an im portant contribution to the total num ber of particles and thus to the total charge of the system .

Them acroscopic results (3.5) and (3.13) are expected to be valid only when the m icroscopic thickness of the surface charge density goes to zero. H ow to reach this regim e in the ost general way by varying both param eters $n_{b}$ and has not been clear to us. H ere we content ourselves by considering the lim it ! 1 for a xed value of $n_{b}$. In this lim it, the total charge of the system is expected to becom e in nite and to be carried by an in nitely thin surface layer.

In (5.1), $r=(2 a)=\tanh (=2)$. O nly the case large ( $r$ close to the boundary of the disk) will be needed. Then $1 \quad\left[r=(2 a)^{3} 4 e a^{3}[r=2 a]^{\prime} \exp \left(2^{\prime} e\right)\right.$. Let us assum $e$ that the relevant values of $\mathrm{J}^{\prime}$ jare sm all com pared to 1 . Then the sum on ' can be replaced by an integral on $x=4$ 'e ${ }^{0}$. This gives for the density as a function of the distance (in units of a) from the boundary $=0$

### 5.2 Charge uctuations

For the one-com ponent plasm a the charge uctuations are identical (for particles of charge +1 ) to the particle number uctuations hQ ${ }^{2} i^{T}=h N^{2} i^{T}$, since the background charge does not uctuate. The charge uctuations can be obtained either by integrating the correlation function (see eq. (5.4)) or by using the therm odynam ic relation

For any nite value of and $n_{b}$ the integral in the last equation is di erent from 1 , thus the predictions of $m$ acroscopic electrostatics are not satis ed. $T$ his is indeed expected since in generalwe are out of the validity dom ain of $m$ acroscopic electrostatics. A s explained above, we expect the results from m acroscopic electrostatics to be valid only if the thickness of the layer of charge near the boundary is negligible com pared to the $m$ acroscopic lengths: the radius of the disk $R$ and the radius of curvature a. For the two-com ponent plasm a the thickness $T$ of this layer is of order of the inverse of the fugacity $\mathrm{m}^{1}=(4 \mathrm{a})^{1}$. For the one-com ponent plasm a we shall show that the situation is som ehow di erent.

Thus, before proceeding to study the charge uctuations in the large-fiugacity lim it, let us study rst how the thickness $T$ of the charged layer near the boundary depends on $g$ in this lim 辻, since the situation is not as simple as it is for the two-com ponent plasm a. W e w ill show that indeed $T$ vanishes when $g!1$.

For sim plicity let us consider the case when $=1$. In units of a the thidkness of the charged layer can be de ned as the rst $m$ om ent of the density pro le properly norm alized

N ow we will proceed to prove that, in the lim itg 1, the charge variance (5.8) is equal to the prediction ofm acroscopic electrostatics (3.5). To be as general as possible we consider again any value of. O ne can easily prove that the integrand in Eq. (5.8) is maxim um when $x=x_{m}$ where $x_{m}$ is now given by $g=x_{m}=\left(; x_{m}\right)$ for any value of. D oing the change of variable $x!x \quad x_{n}$ in the integral (5.8) and replacing $g$ by its expression in term of $x_{m}$ gives

### 5.3 Surface C harge C orrelations

U nder the assum ption that the relevant values of $\dot{\jmath}$ jare $s m$ all com pared to 1 , the sam em anipulations as the ones leading to (5.5) give

( ; x) behaves as the rst term $x{ }^{1} e^{x}$ of its asym ptotic expansion [13] and the denom inator in the integrand becom es $1+$ ge ${ }^{x}=x$. Let us look for a zero of this denom inator at $x=i+x_{m}$. $T$ he equation for $x_{m}$ is (i $\left.+x_{m}\right) e^{x_{m}}=g$, which becom es, in the large-g lim it, $x_{m} e^{x_{m}}=g$. Thus, $x_{m}$ is large and real and the assum ption that the pole has a large realpart is a posterioriveri ed. $T$ he sam e reasoning gives other poles at $x=(2 n+1) i+x_{m}, n 2 Z$. The residue of the pole at $x=i+x_{m}$ is easily found to have a m odulusbehaving as exp [ $\left.x_{n}\left(e+e^{0}\right)=2\right] \exp \left[\quad e^{0 \prime}=4\right]$.

Let I be the integral in (522). I is a part of an integral in the complex plane, along a contour C : C follow s the positive real axis from 0 to +1 , a large quarter of circle from +1 to + il , and com es back to the origin along the im aginary axis from $+i 1$ to 0 . The contribution from the large quarter of circle at in nity is easily seen to vanish, and therefore the contour integral is I $I^{0} w$ ith $I^{0}$ the integralw ith $x=$ iy pure im aginary varying from 0 to il :

$T$ he theorem of residues says that $I=I^{0}+2$ i sum of the residues of the poles inside $C$. $I^{0}$ is negligible (by a factor $1=x_{m}$ ) com pared to the residue of the pole at $i+x_{m}$. The residues of the other poles have a factor $\exp \left[(2 n+1) e^{0 \prime}=4\right] ; n>1$ which $m$ akes them also negligible. A sim ilar reasoning holds in the case' $<0$, and nally

## 6 C ONCLUSION

The charge uctuations for a two-dim ensional classical Coulomb uid are drastically changed by the introduction of a negative curvature of space.

In the case of a at disk com municating with a reservoir (grand-canonical ensemble), the totalcharge $Q$ essentially does not uctuate (bringing an additionalcharged particle from in nity would cost an in nite energy). In the $m$ acroscopic lim it, one can de ne a surface charge density
(charge per unit length on the boundary circle). T he two-point correlation function of has an algebraic only decay (1.1), behaving as the inverse square distance betw een the two points (w hile the charge correlation function in the bulk has a faster than algebraic decay).

In the case of a disk on a pseudosphere (an in nite surface of constant negative curvature), in the $m$ acroscopic $l i m$ it, the total charge $Q$ does uctuate $w$ ith the variance (3.4). Furtherm ore the two-point correlation function of the surface charge density has a fast (exponential) decay (3.13) as a function of the angular distance j jbetw een the tw o points.
$T$ his change of behavior of the surface charge correlation is related to the well-known fact that a negative curvature acts as a $m$ ass in the eld equations. T he curvature replaces the at logarithm ic C oulom b potential by the potential (2.11) which has an exponential decay at large distance s. For a at disk, the algebraic decay of the two-point surface charge correlation is due to these eld lines which connect the two points through the vacuum outside the disk. On a pseudosphere, these eld lines outside the disk nevertheless carry an exponentially decaying interaction.

For retrieving the $m$ acroscopic lim it from $m$ icroscopic $m$ odels, it is necessary that the thidkness $T$ of the surface charge density be negligible com pared to the $m$ acroscopic length scales. On a pseudosphere $w$ ith a radius of curvature $a$, in a disk of radius $R$, we have considered only the case R a. Them acroscopic behavior is expected to hold only when a T. The two exactly solvable $m$ icroscopic $m$ odels which have been considered do exhibit the expected macroscopic features when this condition is satis ed.
