Ensemble dependence in the Random transverse-eld Ising chain.

In a disordered system one can either consider a m icrocanonical ensem ble, where there is a precise constraint on the random variables, or a canonical ensem ble where the variables are chosen according to a distribution without constraints. We address the question as to whether critical exponents in these two cases can dier through a detailed study of the random transverse-eld Ising chain. We not that the exponents are the same in both ensembles, though some critical am plitudes vanish in the m icrocanonical ensemble for correlations which span the whole system and are particularly sensitive to the constraint. This can appear as a dierent exponent. We expect that this apparent dependence of exponents on ensemble is related to the integrability of the model, and would not occur in non-integrable models.

In the study of the critical behavior of disordered systems, it is usual to pick the random variables from some distribution. This allows sample-to-sample uctuations in the sum of the interactions (e.g. nearest neighbor) of order $\sqrt[6]{N}$. We will call this the canonical ensemble of disorder, by analogy with the canonical ensemble of statisticalm echanics which allows uctuations in the energy. It is sometimes of interest to complete this analogy and de neam icrocanonicalensem ble of the disorder in which there is a strict constraint, for example by xing exactly the sum of the (e.g. nearest neighbor) interactions in each sample. Our experience from conventional statisticalmechanics tells us that in the thermodynamic limit the choice of ensem bles does not matter but it is not very clear that this is also true for random system s, especially for the case of quantum phase transitions.

In this paper we will study the simplest disordered model with a quantum phase transition, the random transverse-eld Ising chain $(RTFIC)^{1,2}$ with the Ham iltonian:

where $J_i > 0$ and $h_i > 0$ are random variables chosen from distributions (h) and (J) with averages $[\ln h]_{av}$; $[\ln J]_{av}$ and variances var($\ln h$); var($\ln J$). We use free boundary conditions, so the sum for the J_i stops at L 1.

Let us de ne the two ensembles, m icrocanonical and canonical, precisely for this model. For the canonical ensemble the h_i and J_i are chosen random ly. A parameter which characterizes the deviation from criticality is where

For the m icrocanonical ensemble we constrain the h_i and

 J_i such that the parameter

is set to a prescribed value for each sample. The last term in the numerator, which is not necessary to get the asymptotic behavior, corrects for there being one more h_i than J_i with free boundary conditions. It ensures that = [$\frac{1}{2V}$ even for a nite system. In the canonical ensemble, the uctuations in from sample to sample are 0 (1= L). It is known that a phase transition occurs in this model at = 0. All our numerical results in the paper will be at the critical point.

Pagn and i et al.³ have argued that it is precisely the O(1=L) uctuations which lead to the bound on the nite size correlation length exponent^{4,5,6} 2=d. Further, they argue that exponents in the microcanonical ensem ble need not satisfy this bound. In addition, Igloi and Rieger⁷ claim that the exponents of the RTFIC can depend on the choice of ensemble. In this paper our main goal is to investigate these claims through a detailed study of the zero-tem perature critical properties of the RTFIC.

Using the Jordan-W igner transform ation, the Ham iltonian of the RTFIC can be mapped to a free-ferm ion problem and this mapping is particularly useful in the context of num erical com putations. It can be shown that various physical quantities can be expressed in a straightforward way in term sof the eigenvalues and eigenstates of the free H am iltonian, which are easy to evaluate num erically. These have been discussed by several authors in earlier papers^{7,8} and we will not repeat the derivations here but will use those results in our num erical calculations. In this paper we look at the surface and bulk m agnetizations, the end-to-end correlation function and the energy gap. For the surface m agnetization, the free ferm ion method leads to a simple form and it is possible to obtain som e detailed results analytically. We rst discuss this in Sec. II and then present num erical results for various other quantities in Secs. III and IV. Our conclusions are sum m arized in Sec.V.

II. SURFACE MAGNETIZATION

The simplest quantity to calculate is the surface m agnetization, m^s, which is dened with free boundary conditions in which we x^z at one end, i = L say, to be + 1. The surface magnetization is then the expectation value of ^z at the other end (i = 1). This is equivalent to deleting the transverse eld on site L, so ^z_L commutes with the H am iltonian and the ground state is exactly doubly degenerate, and calculating the expectation value of ^z_L in the ground state with ^z_L = 1. Let us denote this state by fli and so

This has a simple form 7,9 , namely:

Igloi and Rieger⁷ used this to num erically compute the distributions of $B = \log (m^s)$, $P_c(B)$ and $P_{mc}(B)$, in the two ensembles.

However it is also possible to obtain the distribution functions analytically¹⁰ for L ! 1 and we rederive those results here. First consider the canonical case. Let $x_1 = (h_1=J_1)^2$. Then from Eq. (5) we get

The above approximation is good most of the time since B_L is expected to be order $L^{1=2}$. For small B_L we notice that the increment in B_L is always positive and so B_L can never become negative. This and Eq. (6) means that B_L can be electively described by a biased random walk (in which L is the time variable) with a relating wall at the origin. It is convenient to introduce a scaled length variable

in term s of which the probability distribution P $^{\rm c}$ (B ;L) can be written as

Then in the continuum lim it, it is easy to see that $\mathbb{P}^{\mathbb{P}}(\mathbb{B}; \mathbb{Y})$ satis es the following equation:

where is given by Eq. (2). The rejecting boundary condition is in posed by requiring the current at the origin B = 0 to be zero, thus $\left[\frac{\partial P}{\partial B} - 2P'\right]_{B=0} = 0$. This problem is mathematically equivalent to B rownian motion in a gravitational eld and its solution, for identical boundary conditions, is discussed in Ref. 11. With the initial condition P'(B; L = 0) = (B) we not that the solution of the above equation is¹⁰:

where erfc is the complem entary error function.

For the microcanonical ensemble the distribution $P^{mc}(B;L)$ can be found using the result that it is related to $P^{c}(B;L)$ through the general transform ation Eq. (A 6). One then gets¹⁰:

Note that $P^{\circ}(B;L)$ is a function of the two scaling variables $b = B = {}^{d=2}$ and ${}^{i=2}$, and similarly $P^{m \circ}(B;L)$ is a function of ${}^{i=2}$ as well as b. A coording to nite size scaling, the scaling variable associated with the deviation from criticality (or here) should be proportional to $L^{1=}$. Hence Eqs. (10) and (11) show that the true correlation length, as determined from nite size scaling, is = 2.

Now that we have the complete distributions for B =

ln (m^s) we can calculate the m ean surface m agnetization. Even though we nd that $[\ln(m^s)]_{av}$ $I^{1=2}$ in both ensembles, the behaviour of the m ean of m^s (rather than its log) is quite di erent in the two ensembles. This is because m^s = e^B and so the m ain contribution to m^s comes from the behaviour of P (B) at small B (i.e. from rare samples with m^s 1). For large L we nd the following asymptotic forms for the mean m agnetization. In the canonical case:

For i=2 1, Eq. (12) gives $[m^{s}]_{av}^{c} \exp(i_{c})$ where $_{c} = 1 = {}^{2}$, in agreement with = 2 deduced earlier. However, for the microcanonical distribution with 1, we have $[m^{s}]_{av}^{m,c} \exp(i_{m,c})$ with $_{m,c} = 1 = .$ This looks like an apparent correlation length exponent of 1 rather than 2. However, it is worth investigating the origin of this discrepancy between the apparent exponents in the two ensembles. For both ensembles the

(or) $L^{1=2}$. In the canonical ensem – scaling variable is ble, the distribution in Eq. (10) has a constant weight at B = 0, which leads to the expected $c = 1 = 2^{2}$. However, for the microcanonical ensemble, there is a \hole" in the distribution for B < 2 '. The average is dominated by the part of the distribution with the sm allest B, so this di erence in the distributions for small B accounts for the di erence in the behavior of the average. Since the weight of the distribution for the microcanonical ensem ble vanishes at sm all B, we argue that the am plitude of the expected $1 = 2^{2}$ divergence of the correlation length for $[m \, {}^{s} J^{m \, c}_{av}$ is zero, and that the resulting behavior, 1= , is really a correction to scaling. In the rest of this paper we shall reinforce the conclusion that = 2 in both ensem bles but with the leading am plitude vanishing, in the m icrocanonical case, for certain quantities which are particularly sensitive to the microcanonical constraint. This point of view is di erent from that of Igloi and Rieger who argue that is dierent for the two ensembles.

For L ! 1 and (or)< 0, we get $[m_s]_{av} = 2$ in both ensembles, giving a magnetic exponent = 1. At the critical point we nd that the mean magnetization decays with system size as:

From nite size scaling we expect a decay L = whereis the correlation length exponent. While this might suggest that = 2 in the canonical ensemble and = 1 in the microcanonical case, we feel, as discussed above, that a more consistent picture is that the am plitude of the leading divergence of the correlation length appropriate to $[m^{s}]_{av}^{mc}$ vanishes for the microcanonical ensemble and that the true exponent is = 2 in both cases.

III. BULK MAGNETIZATION

In the previous section we saw that the correlation length exponent for the surface m agnetization seems, at rst glance, to be di erent in the canonical and m icrocanonical ensembles, but we argued that the correct interpretation is that the exponents are the same, = 2, but the amplitude of the expected divergence of certain quantities is actually zero for the microcanonical ensem ble. In this section we strengthen this argument by investigating the magnetization in the bulk of the sample, when a spin at the end is xed. We see the same ex-= 2 in both ensembles, clearly indicating that ponent a correlation length with a = 2 divergence does exist for the microcanonical ensemble. Its absence in the surface m agnetization presum ably indicates that the leading am plitude vanishes for this quantity.

W e again consider an open chain with the spin at one end xed to $\frac{1}{L} = 1$ and look at the magnetization at the




FIG.1: Mean of the bulk magnetization, as dened Eq. (16), for dierent system sizes, evaluated in the two ensembles. The expected slope from nite size scaling is = '0.191.

middle of the chain

U sing the free ferm ion m ethod this can be expressed as the determ inant of a m atrix whose elements are expressed in terms of eigenstates of a quadratic H am iltonian. W e evaluate this num erically and compute both the m ean of the bulk m agnetization and also its distribution in the two di erent ensembles. Here we will only exam ine the data at the critical point.

Since the spin at one end is xed, there are equal num – bers of h_i and J_i , so the de nition of in Eq. (3) is slightly modi ed, which leads to the condition

for criticality (i.e. = 0) in the m icrocanonical ensemble. We set J = 1 and allow h to take values 2 and 1=2. In the canonical case each h_i takes one of its two values with equal probability. In the m icrocanonical case exactly half of the sites, chosen at random, are assigned h = 2 and the other half are assigned h = 1=2, which clearly satis es Eq. (17).

The numerical results for the decay of the mean magnetization with system size are shown in Fig. 1. The mean is seen to behave similarly in both ensembles and the system size decay is consistent with the form expected from nite-size scaling $[m]_{av}$ L = with = $(3 \quad 5^{d=2})=2$ and = 2, so that = '0:191.

We now look at the distribution of m. We use the variable b = $\ln (m) = L^{1=2}$ since this has good scaling properties. The details of the distributions of m, show n




FIG. 2: The distribution of the bulk-magnetization for different system sizes for the canonical ensemble.




FIG.3: The distribution of the bulk-m agnetization for different system sizes for the microcanonical ensemble.




FIG. 4: Comparison of the distributions of the bulkmagnetization in the two ensembles for a chain of length L = 201.0 n this log-log plot they appear to have the same slope at small values of the argument. However, at large argument, the microcanonical distribution falls of aster.

in Figs.2, 3, and 4, are di erent in the two ensembles; in particular the microcanonical distribution falls of faster at large argument. However, as can be seen in Fig.4, the behaviour at small values of the argument is the same in both ensembles, which leads to the same asymptotic behaviour for $[m]_{\rm av}$.

Thus, unlike the surface m agnetization, the bulk m agnetization shows the same critical behaviour in both ensembles. In particular, the results of this section indicate that there is a correlation length which diverges with exponent = 2 in the m icrocanonical ensemble. It is not seen in the surface m agnetization m^s, for which the correlation length diverges less strongly with an exponent

= 1, but this must simply indicate that the amplitude of the = 2 divergence vanishes for m^{s} .

IV. END-TO-END CORRELATIONS AND GAPS

In this section we investigate num erically the energy gap and the end-to-end correlation function

in the canonical and m icrocanonical ensembles to com - pare the results of the two ensembles with each other and with analytical results² for the canonical ensemble.

W e take the following rectangular distribution for the bonds and elds at the critical point

From this it follows that

where ' is de ned in Eq. (7). We use free boundary conditions without constraining either of the end spins. From Eqs. (3) and (20) the condition for criticality in the m icrocanonical ensemble is




FIG. 5: P lot of the m ean values of the end-to-end correlation function $C_{1,L}$ and the energy gap for both the canonical and m icrocanonical ensembles. In the canonical case, the ts are close to those predicted analytically and given in Eqs. (23) and (24). For m icrocanonical ensemble, the lines are just guides to the eye.

W e initially generate the h_i and J_i in an unconstrained way, as for the canonical ensemble, but then rescale h_i by an appropriate factor so that the above condition is satis ed.

The distributions of C $_{\rm 1L}$ and $\,$ were studied earlier by F isher and Y oung 2 and we sum m arize som e of their m ain results for L $\,!\,$ 1 :

In Fig. 5 we compare the system size dependence of the average correlation function and the gap in the two ensembles. For the canonical case, the data agree well with the analytic predictions in Eqs. (23) and (24), as was also found in Ref. 2. However, if we t the data for the gap to Eq. (24) adjusting only the overall am plitude the 2 is 150 which is very high. Hence there must be system atic corrections to Eq. (24) which are larger for the sizes studied than the, very sm all, statistical errors.

For the microcanonical ensemble, the data for both $[C_{1L}]_{av}^{m\ c}$ and $[]_{av}^{m\ c}$ in Fig.5 appear to decay as stretched exponentials, and we will discuss that below.

Interestingly, the value of $[C_{1L}]_{uv}$ is found to be close to $[m_1^s m_L^s]_{uv}$, where m_1^s (m_L^s) is the surface m agnetization at site 1 (L) with the spin at site L (1) xed. This can be




FIG.6: Plot of the mean correlation function $[C_{1,L}]_{kv}^{c}$ versus system size compared with $[m_{1}^{s}m_{L}^{c}]_{kv}^{c}$ and $([m_{1}^{s}]_{kv}^{c})^{2}$, for the canonical ensemble. The $([m_{1}^{s}]_{kv}^{c})^{2}$ data falls as 1=L as expected from Eq.(14).




FIG.7: Plot of the mean correlation function $[C_{1;L}]_{\rm dv}^{\rm mc}$ versus system size compared with $[m_1^{\rm s}m_2^{\rm s}]_{\rm dv}^{\rm mc}$ and $([m_1^{\rm s}m_{\rm dv}^{\rm mc})^2$, for the microcanonical ensemble. The data for $([m_1^{\rm s}m_{\rm dv}^{\rm mc})^2$ decays as $1=L^2$ as expected from Eq.(15).

seen in F igs. 6 and 7 where we plot both these quantities, as well as $[m_1^s]_{av}^2$, for di erent system sizes. Especially in the canonical case, $[C_{1L}]_{av}$ and $[m_1^sm_L^s]_{av}$ are almost indistinguishable. Note that for the microcanonical, but not the canonical, ensemble $[m_1^s]_{av}^2$ is much greater than $[m_1^sm_L^s]_{av}$. The reason for this is that $[m_1^s]_{av}$ is dom inated by a few rare sam pleswhere the bonds are bigger than the elds at the free end (and hence, for the microcanonical)




FIG. 8: Plot of $[m_1^{s}m_L^{s}]_{av}^{m^{c}}$ against L for di erent system sizes, for the m icrocanonical ensemble. A best t to the form $aL^{p}e^{bL^{1=3}}$ with p = 0.44 ($^{2} = 3.9$) is shown. The inset plots 2 against p.

ensemble, must be less than the elds at the other end because of the constraint). Hence for these samples m $_{\rm L}^{\rm s}$ is sm aller than typical in the microcanonical ensemble.

Since $[C_{1L}]_{av}$ and $[m_1^s m_{L}^s]_{av}$ behave similarly we can obtain a better estim ate for the decay law in the microcanonical case. This is because $m_1^{s}m_L^{s}$ can be obtained directly from Eq. (5) and thus be accurately computed num erically for bigger systems. We assume the same form as in the exact result for the gap in the canonicalcase, Eq. (24), i.e. $aL^{p} exp(bL)$, and take = 1=3 the same value as in Eq. (24). The data shown in Fig. 8 is tted to aL $^{\rm p}$ exp ($bL^{1=3}$) by varying a and b for several (xed) values of p. Them in im um ² of 3.9, which is quite acceptable for three degrees of freedom, is obtained for p' 0:44. It we assume that p = 1=6, as for the canonical case, then $^2 = 1380$ which is extremely high. However, we noted for the canonical case, that there appear to be corrections to the scaling form in Eq. (24). Hence we cannot rule out the possibility that p = 1=6 also for the m icrocanonical ensemble.

From Figs. 5 and 7, it seems plausible that $[m_1^{s}m_L^{s}]_{av}^{mc}$; $[C_{1L}]_{av}^{mc}$ and $[]_{av}^{mc}$ all vary in the same way in the microcanonical ensemble. If this is so then the data for the gap is consistent with the stretched exponential form $aL^{1=6} exp(bL^{1=3})$, for both canonical and microcanonical ensembles, though there are some system atic corrections to this for the range of sizes that can be studied. This is known to be exact for the canonical ensemble, see Eq. (24). It would be interesting to see if the dependence of gap on system size could be determined analytically for the microcanonical ensemble using random walk arguments.




FIG.9: D istribution of $[ln() ln(C_{1L}) + 1] = (2L)^{1-2}$ for the canonical case. The analytic form, deduced from Eq. (25), is a Gaussian with variance unity. This is shown by the solid line.




FIG.10: Distribution of [n () h (C $_{1L}$)+1]=(2L) $^{1=2}$ for the microcanonical case. Equations (22) and (25) predict that ln () ln (C $_{1L}$)+1 should be identically zero in the therm odynam ic lim it. The data seem s to be tending tow ards this for large L.

The distribution of the di erence $\ln()$ $\ln(C_{1L}) + 1$ is plotted in Figs. 9 and 10. In the canonical case, Eqs. (25)

and (20) predict a G aussian distribution with zero m ean and standard deviation $\stackrel{P}{2L}$ for large L. Fig. 9 shows that this works very well for the full range of sizes studied num erically. Equations (22) and (25) predict that $\ln() \quad \ln(C_{1L}) + 1$ should be identically zero in the m icrocanonical ensemble for L ! 1 and hence its distribution should be a delta function at the origin. Indeed the distribution in Fig. 10 is narrow and sharply peaked at zero with a width which deceases as L increases, con-




FIG.11: Probability distributions of C_{1L} and $m_1^*m_L^*$ for system sizes L = 32 and 128 for the canonical ensemble.




FIG.12: Probability distributions of C_{1L} and $m_1^s m_L^s$ for system sizes L = 32 and 128 for the microcanonical ensemble.

sistent with these expectations.

F in ally we look at the distributions of C_{1L} and $m_1^{s} m_L^{s}$. $\ln (C_{11}) = L^{1=2}$ and The scaling variables are² = d = $\ln (m_1^s m_L^s) = L^{1=2}$ and relevant plots are shown in Figs. 11 and 12 for the canonical and m icrocanonical ensem bles respectively. We see that in the canonical case the overall distributions of and d are di erent at large argum ents, but they m atch very accurately at sm all values of the argum ent leading to the sam e behavior for the averages $[C_{1L}]_{av}^{c}$ and $[m_{1}^{s}m_{L}^{s}]_{av}^{c}$ shown in Fig. 6. In the m icrocanonical case, the overall distributions are quite sim ilar but the agreem ent at sm all values of the argum ent is not as good as in the canonical case. This leads to a greater di erence, shown in Fig. 7 between the averages [C_{1L} I_{av}^{mc} and [m $_{1}^{s}m_{L}^{s}$ I_{av}^{mc} than in the canonical case.

To sum marize this section, for the canonical ensemble, the end-to-end correlation function $[C_{1L}]_{av}$ falls o at criticality with a power of L, as predicted analytically, Eq. (23). However, for the microcanonical ensemble it falls o much faster, as a stretched exponential function of distance. The average gap, []_{av} falls o with a stretched exponential form at criticality in both ensembles, with probably the same dependence on L.

V. DISCUSSION

In this paper we have looked numerically at the nite size dependence of various quantities for the random transverse eld Ising chain (RTFIC) at criticality, for both the canonical and m icrocanonical ensembles of disorder. For quantities that span the system, m^s and C_{1L} , nite size scaling appears, at rst glance, to indicate di erent correlation length exponents for the two ensembles: = 2 for canonical and = 1 for the m icrocanonical. How ever, in contrast to Igloi and R ieger⁷, we conclude that the correct interpretation is that the true scaling exponent is the same for the two ensembles,

= 2, but that the amplitude for the leading = 2 piece is zero, in the microcanonical ensemble, for quantities that span the system and are thus sensitive to the microcanonical constraint. Our reasons for this are two-fold:

- 1. For the quantity we calculated that does not span the system, the \buk" m agnetization m, the sam e correlation length exponent = 2 was found for both ensembles, indicating that there is a correlation length in the microcanonical ensemble which diverges with the larger exponent = 2. Hence, if this is not seen for quantities which span the system, the explanation must be that the am plitude is zero, not that this larger length scale does not exist.
- 2. The analytical expressions for the distribution of the surface magnetization m^s, rst obtained by Fisher¹⁰, show that the scaling variable is $L^{1=2}$ (canonical) and $L^{1=2}$ (microcanonical) demonstrating that the true correlation length exponent is = 2 in both cases.

Our interpretation of the data in plies that the inequality 4,5 2=d is satis ed (as an equality) for the RTFIC, in contrast to the conclusion of Pazm and iet al.³.

We have also looked at the energy gap between the ground state and rst excited state at criticality. For both the canonical and microcanonical ensembles, a stretched exponential decay describes the data. For the canonical case, the exponent (the power of L in the exponential) is exactly² 1/3, and our num erical data are consistent with = 1=3 for the microcanonical case too.

The present m odel, the RTFIC, is integrable and thus relatively simple. In particular, the existence of the sim – ple analytical expression for the surface m agnetization m^{s} , Eq.(5), is surely related to the integrable nature of the model. Furthermore, the microcanonical constraint $h_i = \int_{i}^{\infty} J_i$ enters directly in this expression. Thus one can plausibly see how the constraint might a ect quantities which span the system and cause am plitudes for these quantities to vanish. However, for non-integrable models, including models in higher dimensions, one would not expect the m icrocanonical constraint to enter in a direct way even for quantities which span the whole system. Thus it seems unlikely to us that there would be even an apparent di erence in the critical behavior of nonintegrable models in the two ensembles. We also note that the microcanonical and canonical ensembles of disorder have been investigated for nite-T transitions in random systems by Aharony et al.¹² They nd no difference asymptotically between the critical behavior and

nite-size e ects of the canonical and m icrocanonical ensem bles (which they term grand canonical and canonical respectively).
