Magnetic Interactions in Transition-MetalOxides

A bstract

The correct understanding of the nature and dynam ics of interatom ic magnetic interactions in solids is fundam entally important. In addition to that it allows to address and solve many practical questions such as stability of equilibrium maqnetic structures, designing of magnetic phase diagrams, the low-tem perature spin dynam ics, etc. The magnetic transition temperature is also related with the behavior of interatom ic magnetic interactions. One of the most interesting classes of m agnetic com pounds, which exhibits the rich variety of the above-m entioned properties in the transition-m etal oxides. There is no doubts that all these properties are related with details of the electronic structure. In the spin-density-functional theory (SDFT), underlying many modern st-principles electronic structure methods, there is a certain num ber of fundam ental theorem s, which in principles provides a solid theoretical basis for the analysis of the interatom ic magnetic interactions. One of them is the magnetic force theorem, which connects the total energy change with the change of single-particle energies obtained from solution of the Kohn-Sham equations for the ground state. The basic problem is that in practical im plem entations SDFT is always supplem ented with additional approxim ations, such as local-spin-density approximation (LSDA), LSDA + Hubbard U, etc., which are not always adequate for the transition-m etal oxides. Therefore, there is not perfect m ethods, and the electronic structure we typically have to deal with is always approximate. The main purpose of this article, is to show how this, sometimes very limited information about the electronic structure extracted from the conventional calculations can be used for the solution of several practical questions, accum ulated in the eld of magnetism of the transition-metal oxides. This point will be illustrated for colossalm agnetoresistive m anganites, double perovskites, and m agnetic pyroch bres. We will review both successes and traps existing in the rst-principle electronic structure calculations, and make connections with the models which capture the basic physics of the considered com pounds. Particularly, we will show what kind of problem s can be solved by adding the Hubbard U term on the top of the LSDA description. It is by no means a panacea from all existing problem sof LSDA, and one should clearly distinguish the cases when U is indeed indispensable, play a m inor role, or m ay even lead to the system atic error.

1 Introduction

The rst-principles electronic structure calculations play a very important role in the exploration of magnetism. They have been successfully applied for various types of metallic compounds. The transition-metaloxides (TMO), however, take a very special place in this classi cation and typically regarded as a counter-example where the rst-principles calculations either experience serious di culties or simply do not work. Such an extrem e point of view has of course a very serious background because most of modern computational techniques are based on the spin-densityfunctional theory (SDFT), designed for the ground state, which is typically supplemented with the local-spin density approximation (LSDA) for the exchange-correlation interactions. The latter is based on the hom ogeneous electron gas theory, and therefore is very dimentified on the localized-orbital limit, which was originally adopted for the description of TMO [1, 2, 3, 4].

Therefore, traditionally there was a big gap in the understanding of interactom icm agnetic interactions in TMO basing on these model arguments and the rst-principles electronic structure calculations [5, 6], which appeared only in the middle of 1980s and were regarded as very challenging at that time.

Since then, two di erent standpoints have certainly becam e closer. It is true that due to complexity of the problem of exchange and correlations, even now there is no perfect computational methods for the transitionmetal oxides. However, it also becomes increasingly clear that the model analysis of the problem should use results of rst-principles electronic structure calculations, at least as a starting point. In many cases, a puzzling behavior attributed to the fanciful correlation e ects can be naturally explained by details of the realistic electronic structure.

The purpose of this article is to make a link between general form ulation of SDFT and models of interatom ic magnetic interactions for TMO. We will try to show that even in the present form the electronic structure calculations can play a very important role in the understanding of magnetic properties of various TMO, despite many limitations inherent to LSDA and some of its re nem ents.

In Sec. 2 we will sum marize main results of SDFT and form ulate the

m agnetic force theorem which presents the basis for the analysis of m agnetic interactions in solids. The connection of this theorem with some canonical models for interatom ic magnetic interactions will be illustrated in Sec. 3. In Sec. 4 we will present a critical analysis of interatom ic magnetic interactions in M nO basing on several available methods of electronic structure calculations. In Sec. 5 we will consider some practical problem s related with the colossal magnetoresistive (CMR) manganites, double perovskites $Sr_2FeM O_6$ (M = M o and Re), and magnetic pyrochlores $A_2M O_2O_7$ (A = Y, Gd, and Nd).

The insulating character of m any TMO presents one of the m ost interesting and controversial problem s. Particularly, it is well known that LSDA frequently underestim ates or even fails to reproduce the energy gap, which is formally the excited state property. Is it possible that even in this case, it can provide a physically meaningful description for the param eters of the ground state, such as the interatom ic magnetic interactions? In this context, we will consider the role played by the on-site C oulom b interaction U on the top of the LSDA electronic structure and argue that one should clearly distinguish the behavior of band insulators, which is governed by the double exchange (DE) physics [2, 7], and in principle can be accounted for by itinerant models, in the spirit of LSDA, from the behavior of M ott insulators, where the C oulom b U is indeed indispensable in order to suppress (in this case) spurious DE interactions and unveil the com pletely di erent physical behavior governed by the superexchange (SE) interactions [3, 4, 8]. A brief sum m ary and perspectives will be outlined in Sec.6.

2 Theory of magnetic interactions in solids

2.1 Spin-Density-Functional Theory

The modern way to approach the problem of interatom ic magnetic interactions in solids is based on the SDFT [9], which states that the magnetic ground state of the N -electron system can be obtained by minimizing the Hohenberg-Kohn total energy functional

 $(T_0 [m] being the kinetic energy of a non-interaction electron system and <math>E_{XC} [m] being the exchange-correlation energy) with respect to the spin-magnetization density m (r).¹$

The direct implementation of the SDFT is hampered by the fact that the functional dependencies T_0 [m] and E_{XC} [m] are generally unknown. In the case of T_0 [m], the problem is resolved by introducing an auxiliary system of one-electron orbitals f_i(r)g, and requesting the kinetic energy (in Rydberg units),

(being the vector of Pauli matrices), and the total energy to coincide with the same parameters of the real many-electron system in the ground state. Then, the minimization of E [m] with respect to m (r) is equivalent to the self-consistent solution of single-particle K ohn-Sham (K S) equations for f $_i(r)g$:

where the e ective magnetic eld is given by

The exchange-correlation energy functional, $E_{\rm XC}$ [m], is typically taken in an approximate form. Several possible approximations along this line are listed below.

The local-spin-density approximation. In this case, the explicit dependence of $E_{\rm XC}$ on m (r) and the electron density n (r),

is borrowed from the theory of hom ogeneous electron gas. Conceptually, LSDA is similar to the Stoner theory of band magnetism [10]. Due to the rotational invariance of the hom ogeneous electron gas, $E_{\rm XC}$ depends only on the absolute value of m(r).

The local-density approximation plus Hubbard U (LDA+U) approach [11, 12, 13]. This is a sem i-empirical approach, the main idea of which is to cure some shortcom ings of the LSDA description for the localized electron states by replacing corresponding part of $E_{\rm XC}$ [n;m] in LSDA by the energy of on-site C oulom b interactions, in an analogy with the multi-orbital Hubbard model. The latter is typically taken in the mean-eld Hartree-Fock form:

where U₁₃₂₄ h₁₃ $j_{r_{12}}^{1}$ j₂₄ i are the matrix elements of the on-site C oulom b interactions, which are assumed to be renormalized from the bare atom ic values by interactions with other (itinerant) electrons and by correlation e ects in solids. The electron and spin-magnetization densities for the localized states are represented by corresponding elements of the density matrix $h = kn_{12}k$ in the basis of atom ic-like orbitals f g at the site . Because of this construction, the LDA + U approach is basis-dependent and typically in plemented in the linear mu n-tin orbitalm ethod [14].

The optim ized e ective potential (O EP) m ethod [15,16] is an attempt of exact num erical solution of the KS problem, which does not rely on the local-spin-density approximation for $E_{\rm XC}$ [n;m]. In this case, the eigenfunctions f_i(r)g and eigenvalues f"_ig obtained from the KS equations (3) with some trial potential are used as an input for total energy calculations beyond the hom ogeneous electron gas lim it.² The parameters of such potential are requested to m inim ize the total energy.

 $^{^2}$ O f course, practical implementations of the OEP scheme require some approximations for the exchange-correlation energy. Typically, it is either Hartree-Fock or the the random -phase approximation, underlying the GW method [17]).

2.2 M agnetic Force Theorem

The basic idea behind analysis of interatom ic magnetic interactions in solids is to evaluate the total energy change $E = E [\hat{R} e_{GS}] E [e_{GS}]$ caused by small non-uniform rotations of the spin-magnetization density near the ground state, where $e_{GS}(r) = m_{GS}(r) = jn_{GS}(r) j$ is the direction of the spin-magnetization in the ground state and \hat{R} is the three-dimensional rotation by the (small) angle (r), which depends on the position r in the real space:

Thus, characterizes the local stability of the magnetic ground state with respect to non-uniform rotations of the spin-magnetization density.

Very generally, the problem can be solved by minimizing the constrained total energy functional:

where the constraining eld h (r) plays the role of Lagrange multipliers and enforces the requested distribution of the spin-m agnetization density in the real space.

The magnetic force theorem states in this respect: in the second order of (r) the total energy change is solely determ ined by the change of the KS single-particle energies [18],

The eigenvalues " $_{i}$ \hat{R} B; \hat{R} m $_{GS}$, corresponding to the rotated e ective eld \hat{R} B and the ground state spin-m agnetization density \hat{R} m $_{GS}$, can be expressed in terms of expectation values of the KS H am iltonian,

with f_{i} [R m _{GS}]g yielding R m _{GS} after substitution into Eq. (2).

The theorem can be reformulated in a dierent way: the e ect of the longitudinal change of m (r) on T_0 [m] and $E_{\rm XC}$ [m] caused by the self-consistent solution of the KS equations (3) with the external magnetic eld h (r) is cancelled out in the second order of (r).

The theorem can be proven rather generally provided that the exchange-correlation energy functional obeys the following condition [18]:

In LSDA, it immediately follows from Eq. (4). More generally, Eq. (6) can be regarded as the fundam ental gauge-symmetry constraint, which should be superimposed on the admissible form of the exchange-correlation energy functionals [19].³

The magnetic force theorem has very important consequences:

G enerally, the KS eigenvalues f"g have no physical meaning and cannot be compared with the true single-particle excitations (that is typically the case for many spectroscopic applications). In this respect, the magnetic excitations present a pleasant exception, thanks to the magnetic force theorem .

In principle, the know ledge of the e ective K S potential alone is sufcient to calculate the total energy di erence. It allows to get rid of heavy total energy calculations (particularly, for the OEP m ethod) without any loss of the accuracy.

2.3 Practical Im plem entations of the M agnetic Force Theorem

In most cases, practical applications of the magnetic force theorem are based on relaxed constraint conditions in comparison with the ones given by Eq. (5). Namely, the second condition requesting the KS eigenvalues to correspond the rotated spin magnetization density is typically dropped and " $_{1}$ \hat{R} B; \hat{R} m $_{GS}$ is replaced by " $_{1}$ \hat{R} B obtained from the KS equations (3) with the rotated eld \hat{R} B. This considerably facilitates the calculations, though at the cost of a system atic error, which was recently discussed by Bruno [20].⁴ W e will return to this problem in Sec. 5.1.4 where will give

³ Since m (r) is given by Eq. (2), the three-dimensional rotation m (r)! $\clubsuit_{(r)}m$ (r) is equivalent to the unitary transformation of the KS orbitals $_{i}(r)! \oiint_{S}[(r)]_{i}(r)$, where $\oiint_{S}[(r)] = \exp \frac{i}{2}$ (r) is the 2 2 rotation matrix in the spin subspace. som e estim ates of this error and discuss som e physical implications which m ay be related with the additional rotation of the spin-m agnetization density for the transition-m etal oxides. In this section we will review som e practical schemes of calculations, which ignore these e ects. Basically, they are two.

The rst one is based on the perturbation theory expansion for the G reen function [21]

on the majority (") and minority (#) spin states (Tr_s being the trace over the spin indices). In the second order of (r), the total energy change can be mapped onto the Heisenberg model

The parameters of this model are given by $[21]^5$

where $"_{F}$ is the Fermi energy corresponding to the highest occupied KS orbital. A llpractical calculations along this line are typically perform ed on a

at the input of the KS equations (3) the direction of the spin-m agnetization is consistent with the direction of the e ective eld. However, the direction of the new magnetization obtained after the rst iteration can be canted o the initial distribution prescribed by the matrix \mathbf{P} . This is precisely the source of the error, and strictly speaking the magnetic force theorem cannot be proven for this relaxed constrained condition. In order to correct this error, B runo [20] explicitly considered the constraining eld h (r), which can be estimated using the response-type arguments. This eld does not explicitly contribute to the expression (5) for the total energy_h change. However, it does modify the KS orbitals f_{ig}, which should be used in order to evaluate "_i \mathbf{P} B; \mathbf{P} m_{GS}. A through the analysis undertaken by B runo is certainly valid and the noting is in portant, we believe that there is some confusion with the term inology, because the magnetic force theorem itself is correct, as long as it is form ulated in the form of Eq. (5) [18]. The main criticism by B runo [20] is devoted to the practical implementations of this theorem.

discrete lattice, assuming that all space is divided into atom ic regions specied by the site indices f g, so that the angles (r) depend only on , and neglecting the elects caused by rotations of the spin-magnetization density on the intra-atom ic scale.⁶ In the discrete version, $G^{",\#}(r;r^0;")$ is expanded in the basis of atom ic-like orbitals f g centered at dierent atom ic sites (for example, in the nearly-orthogonal LM TO representation [14]). The integral over atom ic regions around and 0 , $J {}_{0}={}^{\mathbb{R}} dr^{\mathbb{R}} \circ dr^0 J(r;r^0)$, denes conventional parameters of interatom ic magnetic interactions in the real space.

The main idea of the second approach is to calculate the energy of the collective spin excitation corresponding to the frozen spin wave with the vector q. The method, which is called the frozen (or adiabatic) spin-wave approximation is designed for the discrete lattice [23]. In this context, the adiabaticity means that the directions of the spin-magnetization can be regarded as the "slow" variables, so that for each conguration specified by \hat{R} the "fast" electronic degrees of freedom have enough time to follow this directional distribution of the spin-magnetization density. The rotation matrix \hat{R} is requested to transform the collinear distribution of the spin magnetization of the spin magnetic moments in the ground state, $m = {}^{R} dr m_{GS}(r)$, to the spin spiral: $m ! (\cos q \sin ; \sin q \sin ; \cos) jn j$. If m j j r, the rotation angles are given by

(being the cone-angle of the spin wave). The KS equations for the spinspiral conguration of the elective eld \hat{R} B can be solved by employing the generalized Bloch transformation [24]. This gives the total energy change E (q;) corresponding to the "excited" spin-spiral conguration with the vector q. In the the second order of , this energy change can be mapped onto the Heisenberg model. The mapping provides parameters of magnetic interactions in the reciprocal space, J_q , which can be Fourier transformed to the real space.

⁶ The non-collinear distribution of the spin-m agnetization density on the intra-atom ic scale is an interesting and so far very imperfectly understood phenom enon [22].

The application of Eq. (8) goes far beyond the standard electronic structure calculations. It is rather general, and m any canonical expressions for m agnetic interactions in solids can be derived starting with Eq. (8). Here we would like to illustrate this idea by considering two m odel examples.

3.1 Double Exchange and Superexchange Interactions in Half-M etallic Ferrom agnetic State

Consider the ferrom agnetic (FM) chain of atom s, described by the H am iltonian




Figure 1: Schem atic density of states for the half-m etallic ferrom agnetic chain.

which is an analog of the K S H am iltonian (3) on the discrete lattice, where matrix elements of the kinetic energy t_0 (the transfer integrals) are restricted by the nearest neighbors, and B is the electrone eld polarizing the conduction electrons parallel to the z axis. The half-m etallic behavior in plies that $t_0 < B$ and the electron density n < 1 (which corresponds to the partial population of the "-spin band in Fig. 1). The problem can

be easily solved analytically, and by expanding $G^{\#}_{0}$ (") in Eq. (8) up to the second order of t_{0} =B one can obtain the following contributions to the nearest-neighbor (NN) exchange coupling [25]:

 J^D is the FM double exchange interaction, which is proportional to t_0 . J^S is the antiferrom agnetic (AFM) superexchange interaction. For the half-

led band at n=1 the system is insulating. Then, $J^{D} = 0$, while Eq. (10) leads to the standard expression for the SE interaction at the half-lling: $J^{S} = \frac{t_{0}^{2}}{2B}$ [4].

More generally, J^{D} and J^{S} can be expressed through the moments of local density of states, and J^{D} is the measure of the kinetic energy of the fully spin-polarized half-metallic states [26]. O riginally, the concept of the double exchange was introduced for the metallic phase of CMR manganites [7]. However, the phenom enon appears to be more generic and one of the most interesting recent suggestions was that the same mechanism can operate in the insulating state, provided that the system is a band insulator [26]. This substantially modiles the original view on the problem and combine two seem ingly orthogonal concepts, one of which is the DE physics and the other one is the insulating behavior of som e CMR manganites. We will return to this problem in Sec. 5.1.

3.2 Superexchange Interaction via 0 xygen States




Figure 2: Positions of atom ic levels illustrating the superexchange interaction between transition-m etal sites m ediated by the oxygen states.

Consider the interaction between two magnetic (transition-metal) site, which is mediated by the non-magnetic oxygen states (Fig. 2, the situation is rather common for the insulating transition-metal oxides). It is assumed that the splitting between the "- and #-spin states of the transition metal sites is 2B. describes the relative position of the oxygen states relative to the transition-metal states (the so-called charge-transfer energy). It is further assumed that the occupied states are T_1 ("), T_2 (#), and O (",#), and the unoccupied states are T_1 (#) and T_2 ("). 2B and are the largest parameters in the problem, so that the transfer interactions t between the transition-metal oxygen sites can be treated as a perturbation starting with the atom ic limit. Corresponding matrix elements of the G reen function connecting the sites T_1 and T_2 are given by

Then, using Eq. (8) one can obtain the well-known expression for the SE interactions m ediated by the oxygen states [27]:⁷

which describes the shift of the poles of the G reen function (11) of the occupied states, located at "= B and "= B , due to the interaction with the unoccupied states located at "= B.

Considered examples of DE and SE interactions show that Eq. (8) is rather universal and can be regarded as the starting point for the general analysis of interatom ic magnetic interactions in solids. The applications can be very wide and cover, for example, the theory of RKKY interactions [28], the elects of the interatom ic C oulom b interactions on the SE coupling [29], etc.

This means that in the case of superexchange, the mapping of the total energy change onto the Heisenberg model is universal. This is not a general rule, and other types of magnetic interactions do depend on the state in which they are calculated. This dependence is related with the change of electronic structure which enters the expression for the magnetic interactions (8) through the matrix elements of the G reen function. As we will see in Sec. 5.1, the form of the DE interactions strongly depends on the magnetic state and this dependence plays a crucial role in the physics of CMR magnetics.

4 Electronic Structure of M nO from the view point of Interatom ic M agnetic Interactions

The m anganese m onoxide provides an excellent opportunity to test available m ethods of electronic structure calculations for the transition-m etal oxides. W hile num erous spectroscopic techniques deal m ainly with the excited state properties, which cannot be compared directly with results of electronic structure calculations designed for the ground state, the interatom ic m agnetic interactions are the ground-state properties and, in principle, should be accounted for by these calculations.

The interatom ic magnetic interactions in M nO are well studied experimentally. The magnetic behavior of M nO can be described by the simple Heisenberg model including rst (J_1 = 4:8 m eV) and second (J_2 = 5:6 m eV) neighbor interactions [30].⁸ Since M nO is a wide-gap insulator, it is clear that both interactions originate from the superexchange mechanism [4, 5].

O ne can easily design the proper m odel for the electronic structure of M nO using the following arguments [18]. Since the electronic conguration of the M n atom s in M nO is close to $3d_{\pi}^{5}3d_{\#}^{0}$, both from the view point of the m odel valence arguments and the electronic structure calculations, the distribution of the spin-m agnetization density near M n sites is nearly spherical. Therefore, the only parameter of the electronic structure calculating between occupied $3d_{\pi}$ and unoccupied $3d_{\#}$ states. Another important parameter of the relative position of the $3d_{\#}$ and the oxygen 2p states. Then, using an analogy with the m odel for SE interactions considered in Sec. 3.2, one can try to parameterize the elective K S potential in terms of B and

(basically in the spirit of LDA + U for the half-led 3d shell), and to nd these two parameters by tting two experimental parameters of interatom ic magnetic interactions, J_1 and J_2 , provided that the kinetic and non-magnetic parts of the elective KS Hamiltonian are well described on

the level of LDA.




Figure 3: Electronic structure of M nO, which to the experimental parameters of magnetic interactions together with results of rst-principles calculations in LSDA, OEP, and LDA+U.

The tting, which is very straightforward in the nearly-orthogonal LM TO basis [14, 18], yields the following parameters: B' 5:3 eV and '10:7 eV.⁹ The corresponding density of states is shown in Fig. 3, together with results of the LSDA, LDA+U, and OEP calculations.¹⁰ Corresponding parameters of magnetic interactions are listed in Table 1. Unfortunately, none of the existing techniques can treat the problem of in-

teratom ic magnetic interactions in M nO properly. Nevertheless, the analysis of the electronic structures shown in Fig. 3 allows us to elucidate the basic problem s of the existing methods which lead to substantial overestimation of J_1 and J_2 [18].

LSDA underestim ates both B and . In this sense, the overestim ation of interatom ic m agnetic interactions is directly related with the underestim ation of the band gap. However, the occupied part of the spectrum is reproduced reasonably well by the LSDA calculations.

LDA+U underestimates . This is a very serious problem inherent not only to LDA+U but also to some subsequent methodological developments for the strongly correlated systems like LDA+DMFT approach [31], which provides a solid basis for the description of C oulom b interactions at the transition-metal sites, but ignore other parameters of electronic structure, which may play an important role for TMO.

The relative position of the 3d and 2p states is well reproduced by the OEP method. However, the width of the unoccupied 3d band is strongly overestim ated. This might be related with the local form of the electron potential in the OEP approach. As the result, the parameters of interatom icm agnetic interactions are strongly overestim ated.

Thus, the quantitative description of interatom icm agnetic interactions in TMO by the rst-principle electronic structure calculations is largely unresolved and challenging problem. The analysis of MnO suggests that one possible direction along this line could be to borrow the form of the oneelectron potential from the LDA+U approach and try to optim ize param – eters of this potential by using the ideas of variational OEP m ethod [18]. In any case, the developm ent of the rst-principle techniques, which could address the problem of electronic structure and m agnetic interactions in TMO on a more superior level is certainly a very important direction for the future.

However, even in the present form, the electronic structure calculations m ay have a signi cant im pact on our understanding of the physical properties of TMO. In the next section we would like to illustrate how this, som etim es rather limited inform ation extracted from the conventional electronic structure calculations can be used for the analysis of m any im portant questions accumulated in the eld m agnetism of TMO.

5 Applications for Transition-M etalO xides

5.1 Double Exchange Interactions in CMR M anganites




Figure 4: M agnetic phase diagram of $Nd_1 \times Sr_x M nO_3$ (from Ref. [32]). Dierent phases are denoted as follows: PM - paramagnetic, FM - ferrom agnetic, and AFM - antiferromagnetic, consisting of the FM layers (A), simple chains (C), and zigzag chains (CE).

One of the most famous groups of oxide materials, which was in the focus of enorm ous experim ental and theoretical attention for m any years, is perovskite m anganese oxides (or simply { the m anganites) with the chem ical form ulas $R_1 x D_x M nO_3$ (cubic type), $R_1 x D_{1+x} M nO_4$ (layered type), and R₂ 2xD 1+2xM n₂O 7 (double-layered type; R and D being trivalent rareearth and divalent alkaline-earth ions, respectively). The manganites are known for the colossal magnetoresistance e ect, that is gigantic suppression of the resistivity by the external magnetic eld. A nother important feature of these compounds is the rich magnetic phase diagram (Fig. 4) Typically, the CMR e ect occurs at the boundary of either FM and PM, or FM and AFM phases. In this sense, the understanding of the magnetic phase diagram is directly related with the understanding of the CMR effect. There is a large number of modern review articles devoted to these compounds [26, 33, 34, 35], which covers a lot of experimental inform ation as well as the theoretical views on the problem. In this section we would like to illustrate, as we believe, the main idea behind the magnetic phase diagram and the CMR e ect itself from the view point of electronic

structure calculations and the general theory of interatom ic m agnetic interactions presented in Sec. 2. We will concentrate on the doping range $\times 0.3.^{11}$

A coording to the form al valence arguments, the 3d states of M n in $R_{1,x}D_xMnO_3$ are led by the (4 x) electrons, which are subjected to the strong H und's rule coupling. Therefore, the intra-atom ic exchange splitting between the "- and #-spin 3d states can be regarded as the largest parameter in the problem. The 3d states are further split by the cubic crystal- eld into the low er-lying t_{2g} and higher-lying e_g levels, yielding the form allelectronic conguration t_{2g}^3 , e_{g}^1 , ${}^xt_{2g\#}^0e_{g\#}^0$. The band dispersion, caused by the interatom ic hopping interactions involving t_{2g} and e_g orbitals is typically smaller than the intra-atom ic exchange and crystal- eld splittings. The hoppings are mediated by the oxygen 2p states, and in the undistorted cubic lattice are allowed only between orbitals of the same, either t_{2g} or e_g , symmetry. The strengths of the M n (e_g)-O (2p) and M n (t_{2g})-O (2p) interactions are controlled by the Slater-K oster parameters, correspondingly pd and pd . Since jpd \Rightarrow jpd j the t_{2g} band is typically narrower than the e_g one [36].

¹¹The magnetic phase diagram at small x is signi cantly a ected by the Jahn-Teller e ect. This is certainly an interesting and not completely understood problem (see, e.g., Ref. [26]). However, the physics is rather di erent from a more canonical double exchange regime realized for x 0:3.

Thus, the t_{2g} states will be half-lied and according to Sec. 3.1 contribute only to the AFM SE interactions. The e_g states are partially occupied and therefore will contribute to both FM DE and AFM SE interactions, whose ratio will depend on x.

W hat is the relevance of this picture to the magnetic phase diagram of perovskite manganites? In order to get a very rough idea about this problem, let us simply count the number of FM (z_{FM}) and AFM (z_{AFM}) bonds form ed by the M n sites in each of the magnetic phases shown in Fig. 4 (Table 2). The FM interactions prevail at smaller x. How ever, fur-

ther increase of x leads to the gradual change of the character of m agnetic interactions towards the antiferrom agnetism, which is rejected in the increase of the number of AFM bonds. Therefore, it seems reasonable to link this phase diagram with some kind of competition between FM and AFM interactions.

In order to further proceed with this picture, we need to address the following questions.

- 1. W hich m echanism stabilizes the anisotropic AFM A and C structures in the m etallic regim e?¹² N ote, that according to the canonical DE m odel [7], the m etallic antiferrom agnetism is unstable with respect to a spin-canting.
- 2. W hat is so special about the CE phase? W hy does it exist only in

the narrow window of x close to x=0.5 and perturbs the m onotonous change of z_{FM} and z_{AFM} shown in Table 2? W hy is it insulator?


3. Quantitative description of the doping-dependance of the magnetic phase diagram.

5.1.1 Basic D etails of the E lectronic Structure

The key factor factor, which allows to resolve the questions sum marized in parts 1 and 2 is the strong dependance of the electronic structure of the e_{a} states on the magnetic structure [37, 38, 39]. The e ect can be estimated in the LSDA by considering the distribution of the eq states in the hypothetical virtual-crystal alloy $La_{1=2}Ba_{1=2}M$ nO 3 (Fig. 5). In this calculations, the crystal structure of $La_{1=2}Ba_{1=2}M$ nO 3 was rigidly xed to be the cubic one. Hence, Fig. 5 shows the pure response of the electronic structure of the $e_{\!g}$ states to the change of the magnetic structure. Even in ${\tt LSDA}$, which typically underestimates the intra-atom ic splitting between the "and #-spin states [40], the e ect is very strong and the electronic structure changes dram atically upon switching between FM, A-, and C-type AFM phases. Furtherm ore, the anisotropic AFM ordering has dierent e ect on di erent e_{α} orbitals. For example, in the A-type AFM structure, the main bbes of the x^2-y^2 and $3z^2-r^2$ orbitals are aligned correspondingly along FM and AFM bonds. Since the hopping interactions are penalized in the case of the AFM coupling, the A-type AFM arrangement will shrink mainly the $3z^2 - r^2$ band. The e ect is reversed in the C-type AFM state, which is associated with the narrow ing of the x^2-y^2 band. Thus, the LSDA calculations clearly demonstrate how the anisotropy of the A - and C - type AFM structures interplays with the anisotropy of the spacial distribution of the x^2-y^2 and $3z^2-r^2$ orbitals.




Figure 6: Right panel. Two-dimensional zigzag antiferrom agnetic ordering realized in $La_{1=2}Sr_{3=2}M$ nO₄, resulting in two dimensional zigzag antiferrom agnetic ordering realized in $La_{1=2}Sr_{3=2}M$ nO₄, resulting in two dimensional zigzag antiferrom agnetic ordering (A and B, typically referred to the "charge ordering") and the orbital ordering (the alternation of partially populated $3x^2-r^2$ and $3y^2-r^2$ orbitals at the A sites). Left panel. Corresponding distribution of the M n (e_q) states at the sites A and B in LSDA. The Fermi level is at zero.

The AFM CE phase presents the most striking example of such intemplay between spin and orbital degrees of freedom : the zigzag AFM arrangement appears to be su cient to explain the insulating behavior of this phase (even in LSDA). Therefore, the CE phase can be regarded as a band insulator, which is related with the very peculiar form of the AFM spin ordering (Fig. 6) [41].

The magnetic-state dependence of the electronic structure of the eq

states is the m ain m icroscopic m echanism, which stands behind the rich variety of the m agnetic structures observed in perovskite m anganites. In some sense, these systems show certain tendency to the self-organization, the m ain idea of which can be accumulated in the following formula: the anisotropic AFM ordering breaks the cubic symmetry of the crystal and leads to the strong anisotropy of the electronic structure.¹³ T his anisotropy will be relected in the anisotropy of interatom icm agnetic interactions (8), which depend on the electronic structure through the m atrix elements of the G reen function. In m any cases, the response of interatom icm agnetic interactions to the change of the m agnetic structure appears to be su cient

to explain the local stability of this magnetic state, and the total energy of such systems will have many local minima corresponding to di erent magnetic phases.

5.1.2 M in im al M odel for C M R M anganites

The sem i-quantitative model for CMR manganites can be constructed by using the following arguments.

The model should be based on the realistic electronic structure for the e_g states and take into account strong dependence of this electronic structure on the magnetic structure. The proper model for the electronic structure can be obtained by doing the tight-binding parametrization of LDA bands [36, 43]. However, for many applications one can use even cruder approximation and consider only the NN hoppings between Mn sites, parameterized according to Slater and Koster [44]:

where t \cdot kt^{LL₀} k is the 2 2 m atrix in the basis of two e_g orbitals x²-y² (L,L^Q=1) and 3z²-r² (L,L^Q=2), and n is the primitive translation in the cubic lattice parallel to the x (=1), y (=2), or z (=3) axis. The anisotropy of the x²-y² and 3z²-r² orbitals is relected in the anisotropy of transfer interactions. The parameter t₀/ (pd)² is chosen to reproduce the e_g bandwidth in LDA (t₀' 0:7 eV [26], and thereafter used as the energy unit).

The e ect of the magnetic structure on the electronic structure is typically included after transform ation to the local coordinate fram e, speci ed by the directions fe g of the spin magnetic moments

and taking the limit of in nite intra-atom ic exchange splitting. This yields the well-known DE Ham iltonian [45]:

describes modulations of transfer interactions caused by deviations from the FM spin alignment. 14


 H^D or is proportional to t_0 , and similar to the DE term considered in Sec. 3.1, describes the FM interactions in the system s, which are now generalized to the case of arbitrary spin arrangement. This term is combined with the energy of phenomenological AFM SE interactions:

where $J^{S} < 0$ is restricted by the nearest neighbors and contains contributions of both t_{2g} and e_{g} states. Using an analogy with the SE m odel considered in Sec. 3.2, it is assumed that the exchange constant J^{S} does not depend on the magnetic state, and all such dependencies come exclusively from the DE term.

The combination of H $^{\rm D}$ $_{\circ}$ and H $^{\rm S}$ $_{\circ}$ constitutes the m inim alm odel, which explains the origin of the main magnetic structures observed in doped m anganites.¹⁵ An example of theoretical phase diagram is shown in Fig. 7 [37, 38, 50]. The position and the order of the main magnetic phases

with respect to the hole-doping has clear similarity with the experimental phase diagram (Fig. 4).¹⁶

The origin of the CE-type AFM phase requires special comment, because canonically it was attributed to the charge ordering of the M n^{3+} and M n^{4+} ions [1], and this point of view was dominating form any years. The modern view on the problem is that CE is the regular magnetic phase, whose properties can be understood in the degenerate DE model similar

to other magnetic states [26, 35, 39]. The insulating behavior of this phase is related with the topology of one-dimensional zigzag FM chains.¹⁷ This also explains why the CE phase exists in the very narrow region close to x=0.5, i.e. when the Ferm ienergy falls into the band gap. M ore generally, any periodic one-dimensional zigzag object composed of the eg orbitals will behave as a band insulator at certain commensurate values of the electron density [26, 51].

5.1.3 Implication to the CMRE ect

The magnetic origin of the CE phase has many implications to the CMR e ect and readily explains why the insulating state of som emanganites can be easily destroyed by the external magnetic eld. However, it would not be right to say that CMR is exclusively related with the existence of the CE phase. It is a more general phenom enon inherent to the DE physics. Below we will consider two such possibility.

1. A coording to the form of the DE H am iltonian (12), the transfer interactions are forbidden between antiferrom agnetically coupled sites. Therefore, from the view point of transport properties, the A-type AFM phase behaves as an insulator in the z-directions and as a metal in the xy-plane. The A state can be continuously transformed to the spin-canted state [38] by applying the external magnetic eld. The spin-canting unblocks the hopping interactions and gradually decreases the resistivity along z. This is the basic idea of the so-called "spin-valve" elect, observed in the A-type AFM Nd_{0.45}Sr_{0.55}M nO₃ [52].

The unique aspect of the CE phase is that it has a band gap, and therefore is insulating in all the directions, including the direction of propagation of the FM zigzag chains. This predeterm ines rather distinguished behavior of the CE phase in the magnetic eld. As it was pointed out before, the stability of the CE phase is directly related with the existence of the band gap. Sim ilar to the A-type AFM phase, the external magnetic eld leads to the canting of spins also in the CE phase. The basic di erence is that

starting with certain angle such canting will close the band gap.¹⁸ Then, the CE phase will become unstable and the system will abruptly transform to the metallic FM phase, which is favored by the magnetic eld. The phenomenon is well know as the "melting of the charge-ordered state", which accompanied by the abrupt drop of the resistivity [34].

2. Typical theories of the second type are based on the following observations [53]:¹⁹

The total energy of the DE model may have several local minimal corresponding to di erent FM and AFM phases, which may exist in the same range of the hole-doping. This also implies the rst-order character of the phase boundaries [50]. The concrete example is the region close to x=0.5 shown in Fig. 7.

Som e of these phases are insulating due to the special (zigzag) geom - etry of the AFM pattern.




Figure 8: Schematic view on the percolative scenario of the CMR e ect. Top: Local m inim a of the double exchange energy corresponding to the insulating CE and m etallic FM phases. The relative position of these m inim a is controlled by the magnetic eld H. Bottom: m ixed-phase state realized at the nite temperature. The magnetic eld increases the am ount of the FM phase, and above the percolation threshold forms the conducting FM path.

The situation is schem atically illustrated in Fig. 8. At T = 0 and without eld, the system is trapped in the insulating CE-type AFM ground state. The next m inimum, corresponding to the FM metallic state should be boated within the energy range accessible by the external magnetic eld. At the nite temperature and neglecting interactions between di erent phases, the system will be represented by the mixture of these two states, due to the con guration mixture entropy.²⁰ The relative am ount of these states will depend on the temperature T and the magnetic eld H. The latter controls the relative position of the CE and FM minima. W ithout eld, the CE phase will dominate, while the FM phase will form metallic islands in the insulating sea. The application of the magnetic eld will increase the am ount of the FM phase. At som e point, which is called the percolation threshold, the FM islands becom e connected by form ing the

conducting FM paths throughout the spacem en. This will correspond to the sharp drop of the resistivity.

Since m any interesting (and, presum ably, the m ost practical) phenom – ena ofperovskite m anganites are related with the existence of zigzag AFM structures, it is very important to understand the behavior of these structures, and especially the way how they will evolve with the tem perature, in the magnetic eld, or upon the change of the crystal structure. W e would like to close this section by listing som e interesting and not com pletely resolved problem s in this direction.

The existence of two transition tem peratures, T_N and T_{CO} , which are typically attributed to the onset of N eel AFM and charge ordering, respectively. In reality, both transitions are probably magnetic and T_N corresponds to the order-disorder transition which takes place only between FM zigzag chains and largely preserves the coherent motion of spins within the chains, while T_{CO} corresponds to the transition to the totally disordered PM state [55].

Appearance of incommensurate charge and orbital superstructures just below T_{CO} [56].

E ects of cation disorder and appearance of new zigzag superlattices upon articial ordering of R and D elements in some three-dimensional manganites [57].

5.1.4 Role of Rare-earth, A lkaline-earth, and O xygen and States

In this section we will brie y discuss the in uence of the R, D, and oxygen states on the interatom icm agnetic interactions in R₁ _xD _xM nO₃ in the context of revisions in the form of these interactions, which were recently considered by B runo [20]. We will concentrate on the behavior of the cubic FM phase of the virtual-crystal alloy $La_{0.7}Ba_{0.3}M$ nO₃, and treat the problem of interatom icm agnetic interactions using the frozen spin wave approximation supplemented with the LSDA ²¹. In the FM phase, the magnetic M n sites polarize neighboring La/Ba and oxygen sites. The typical distribution of the magnetic moments amongst different sites is $M_n = 3.48$, La=Ba=0.08, and O=0.05 B. Our main concern will be the role played by La=Ba and O in the spin dynam ics of $La_1 x Ba_x M nO_3$.

We assume that the cone-angle of the spin wave does not depend on the atom ic site: . The phase of the spin wave is modulated as q with running over all Mn, O, and La/Ba sites. Then, for each q we calculate the second derivative of the total energy with respect to using the magnetic force theorem. The derivative can be also used to estimate the magnon spectrum in the FM state:

(being the FM moment). We consider two possibility:




Figure 9: Typical situation realized in frozen spin wave calculations for q = (0;0;). f g is the constrained distribution of the magnetic m om ents. f ${}^{0}g$ is the distribution of magnetic m om ents obtained after solution of K ohn-Sham equations with the rotated e ective elds. G enerally, the spins f ${}^{0}g$ are canted towards the ground state con guration by the angle , and have the components f ${}^{2}g$, which are perpendicular to f g. The constraining elds fh ${}^{2}g$ are included in order to compensate f ${}^{2}g$.

R igid constraint, obtained by rotating the KS e ective eld and enforcing the directions of the spin magnetic moments at each site to follow exactly the form of the spin wave. The latter is achieved by applying the perpendicular constraining elds fh[?]g (Fig. 9), which can

be estimated using the response-type arguments [20]. The elds fh[?] g a ect the KS orbitals f $_{i}$ g, and through the change of these orbitals, correct the form of the spin-magnetization density (2). However, they do not contribute explicitly to the total energy change (5).




Figure 10: Results of frozen spin wave calculations for $La_{0.7}Ba_{0.3}M nO_3$: second derivatives of the total energy (which specify the form of the magnon dispersion) obtained by rotating the Kohn-Sham e ective elds (relaxed constraint) and by applying additional perpendicular constraining elds fh² g (rigid constraint) at all sites and the M n sites on ly; the parasitic canting of the magnetic moments in the relaxed constraint calculations; and the perpendicular magnetic eld applied in order to compensate this canting. Symbols show the calculated points, and the solid lines are results of an interpolation.

Results of these calculations are shown in Fig. 10. The magnon dispersion has a characteristic form, which is manifested in the pronounced softening at the Brillouin zone boundaries $[58]^{22}$. The origin of this softening is related with the behavior of interatom ic magnetic interactions, and can be

understood on the basis of realistic electronic structure calculations [25]. It has a direct in plication to the stability of the FM state and the form of the magnetic phase diagram versus the hole-doping [26].

In this section, our main concern will be a little bit di erent. As it is seen in Fig. 10, the application of the constraining elds fh[?] g can signif-

icantly a ect the magnon dispersion. For example, around (;0;0), !q's calculated using two di erent schemes can di er by factor two. The most interesting question is where this di erence comes from. The simple rotation of the KS elective elds by the angle causes the parasitic canting of spins of the constrained directions by the angles f g, which are proportional to if the latter is small (see Fig. 9). How ever, this canting can be very di erent at di erent magnetic sites. Indeed, is of the order of at the La/Ba and oxygen sites, and alm ost negligible at the Mn sites. Therefore, the elds fh[?]g, which are introduced in order to correct this canting will be the largest at the La/Ba and oxygen sites, and end oxygen sites, and the smallest at the Mn sites. An attempt to apply h[?] only at the Mn sites has a negligible elect on the magnon dispersion. These results rise several important questions, which still need to be understood.

There is a large intrinsic uncertainty in the behavior of spin magnetization at the La/Ba and oxygen sites, and especially in the form, in which these sites contribute to the spin dynam ics of $La_{1,x}Ba_{x}M$ nO 3 and similar compounds. The problem may be directly related with the de nition of the adiabaticity concept, underlying the frozen spin wave approach. A ccording to this concept, the magnetic system s have two characteristic time scales. The spin directions are typically regarded as the slow variables, while the internal electronic degrees of freedom are the fast ones, which self-consistently follow the instantaneous orientational distribution of the spin-m agnetization density. From this point of view, the La/Ba and oxygen sites have clearly a dual character. On the one hand, neither of them can be regarded as the source of magnetism in these system s. On the other hand, both of them carry a signi cant weight of the spin-m agnetization density, mainly due to the hybridization with the magnetic M n sites. Then, how the La/Ba and oxygen states shall be treated? In principle, one may have several possibilities.

1. The La/Ba and oxygen sites are magnetic and shell be treated on the same level as the Mn sites, by applying independent constraint conditions for the slow-varying directions of the La/Ba and oxygen spins. This would correspond to the appearance of additionalm agnon branches in the frozen spin wave calculations. C learly, this scenario can be sorted out from the beginning, because both La/Ba and oxygen m om ents are induced by the hybridization with the M n sites and cannot be totally independent from the latter.

- 2. The contribution of La/Ba and oxygen states is purely electronic, which implies that these degrees of freedom are "fast" and selfconsistently follow the distribution of the spin magnetic moments at the Mn sites. This would roughly correspond to the relaxed constraint conditions in the spin-wave calculations shown in Fig. 10.
- 3. An intermediate situation when the electronic degrees of freedom at the La/Ba and oxygen sites are not "su ciently fast" so that the magnon dispersion shall be averaged over several intermediate con gurations of the La/Ba and oxygen spins. This is the most interesting scenario, which is how ever only a speculation. If true, the magnon dispersion in FM manganites should have an intrinsic bandwidth, which should be of the same order of magnitude as the di erence between "rigid" and "relaxed" calculations shown in Fig.10. In fact, the strong magnon broadening has been observed experimentally in several FM manganites [58], though it is of course premature to make a direct connection between this broadening and the behavior of La/Ba and oxygen states considered in this section.

The non-collinear distribution of magneticm oments at the La/Ba and oxygen sites can interfere with other (extrinsic) factors, such as random ness e ects caused by the cation disorder. Then, the chemical disorder may lead to the orientational spin disorder at the La/Ba and oxygen sites, which may also contribute to the magnon broadening associated with the random ness [59].

5.2 Double Perovskites

O rdered double perovskites, like $Sr_2FeM \circ O_6$ and $Sr_2FeR \circ O_6$, is another interesting class of compounds [60]. They exhibit fairly large magnetoresistance e ect, which coexists with relatively high magnetic transition tem perature (415 and 401 K for $Sr_2FeM \circ O_6$ and $Sr_2FeR \circ O_6$, respectively). The latter factor presents a great advantage over CMR manganites, and opens a way to technological applications of these compounds in devices operating at the room temperature.




Figure 11: Positions of Fe, Mo, and oxygen sites in ordered double perovskite Sr_2 FeMoO₆. A rrows show the main magnetic interactions responsible for properties of this compound.

At the st sight, the double perovskites crystallize in a simple crystal structure. It can be regarded as the cubic $SrFeO_3$, in which every second Fe is replaced by M o or Re (Fig. 11). However, there are two fundamental

problem s:

- 1. Anti-site defects. Typically, certain percent of atom s from the nom inally Fe sublattice interchanges with the sam e am ount of atom s from the M o sublattice. The number of such defects in the best available single-crystalline samples of Sr_2FeM oO $_6$ is about 8% [61].
- 2. Fine details of the crystal structure. Typically, the inform ation about directions and m agnitudes of the oxygen displacement is either un-known or rather controversial.

The extraordinary properties of Sr_2FeM oO $_6$ and Sr_2FeReO_6 are usually attributed to the half-m etallic electronic structure expected in the FM state. In this sense, the double perovskites are typically considered as an example of relatively simple and well established physics.

In this section, we will discuss the behavior of interatom ic magnetic interactions in $Sr_2FeM \circ O_6$ and argue that this point of view must be largely revised. Particularly, we will show that the half-m etallic electronic structure is incompatible with stability of the FM ground state. Therefore, there should be some additional mechanism which stabilizes the FM state and presum ably destroys the half-m etallic character of the electronic structure. We propose that the unique properties of the double perovskites are directly related with the above-m entioned defects and uncertainties of the crystal structure [62].²³




Figure 12: Local densities of states corresponding to the ferrom agnetic (left) antiferrom agnetic (right) alignment of Fe spins in ordered Sr_2FeM oO $_6$, in LSDA. The Ferm i level is at zero.

A rough idea about the problem can be obtained from rather simple considerations of the electronic structure of Sr_2FeM oO ₆ (Fig. 12), which suggests that similar to the CMR manganites there are two competing interactions which de ne the form of the magnetic ground state in this compound.

- 1. It is true that the electronic structure of the hypothetical FM phase of Sr_2FeM oO ₆ is half m etallic: the Ferm i level crosses the hybrid t_{2g} band in the #-spin channel and falls in the gap between $Fe(e_g)$ and M o (t_{2g}) bands in the "-spin channel. The partly- lled #-spin t_{2g} band w ill generally be the source of FM interactions, due to the double exchange m echanism considered in Sec. 3.1, which w ill be som ew hat m odi ed by the fact that the transfer interactions between spin-polarized $Fe(t_{2g})$ orbitals are indirect and operate via nonm agnetic M o (t_{2g}) states [63]. This interaction w ill also polarizes the M o (t_{2g}) states antiferrom agnetically w ith respect to the Fe sublattice.
- 2. The half-led $Fe(e_g)$ states should generally contribute to AFM interactions. Typically, this contribution is expected to be small, because in the double-perovskite structure, the neighboring Fe sites are separated by the long 0 M o-O paths. A very rough idea about the strength of these interactions can be obtained from the comparison of densities of the Fe(e_g) states in the FM and (type-II [6]) AFM phases: if these interaction were weak, the bandwidth would not depend on the magnetic state. However, the direct calculations show the opposite trend and the Fe(e_g) band considerably shrinks in the case of the AFM alignment.

A simple estimate of the relative strength of the FM and AFM contributions, irrespective on their decom position onto the interatom icm agnetic interactions, can be obtained from the one-electron (band) energies

(N being the total density of states) calculated separately for the e_g and t_{2g} bands in the FM and AFM phases. These energies are listed in Table 3.²⁴ O ne can clearly see that in the AFM state, the energy loss associated with

the hybrid t_{2g} band is totally compensated by the energy gain associated with the Fe(e_g) band. This example shows that the problem is indeed very subtle and the half-m etallic electronic structure obtained in the FM state does not necessary guarantee that this state will be locally stable and realized as the ground state. It does not explain the high value of the m agnetic transition tem perature either.

The conclusion is supported by direct calculations of interatom icm agnetic interactions using both frozen spin wave and G reen's function m ethods.




Figure 13: Results of frozen spin wave calculations for ordered $Sr_2FeM \circ O_6$ (see Fig. 10 for details).

1. The FM state appears to be unstable with respect to the non-collinear spin-spiral alignment realized at certain q's, for which $\frac{d^2}{d^2} E(q;)j_{=0} < 0$ (Fig. 13). The second derivative of the total energy was calculated using several di erent approximations, similar to the analysis of the spin-wave dispersion of $La_{0:7}Sr_{0:3}M$ nO₃ undertaken in Sec. 5.1.4: by in posing the rigid constraint on the directions of spin magnetic moments at all sites of Sr_2FeM oO₆, and only at the Fe and M o ones. Similar to the $La_{0:7}Sr_{0:3}M$ nO₃ case, the main e ect of the constraining elds fh[?] g is associated with the Sr and oxygen sites, whereas the contributions of the Fe and M o sites are negligible. The "rigid constraint" can be regarded as the most consistent check for the local stability of the FM state, when

the application of the magnetic force theorem is strictly justiled and the second derivative of the total energy can be rigorously expressed through the change of the KS single-particle energies. Fig. 13 shows that it may correct to a certain extent the values of the second derivatives at the Brillouin zone boundary. However, it does not change the principal conclusion and the FM state remains unstable in the large portion of the Brillouin zone [62].²⁵

2. The second derivatives of the total energy can be mapped onto the H eisenberg model $\frac{d^2}{d^2}$ E (q;)j₌₀=J₀ J_q. The mapping gives us parameters of magnetic interactions in the reciprocal space fJ_qg, which can be further transformed to the real space. The real-space parameters, listed in Table 4, provide a complementary piece of information which allows to rationalize results of frozen spin wave calculations and present them in terms of competition between FM NN and AFM next-NN interactions in the Fe sublattice (correspondingly J₁ and J₂ in Table 4). The AFM interaction J₂ clearly dom inates and readily explains why the FM state becomes unstable.²⁶ An additional piece of information can be obtained from G reen's function calculations, which allow to estimate the direct Fe-M o interaction

 $J_{Fe~Mo}$. However, this interaction is not particularly strong and does not alter the main conclusion about stability of the FM state.²⁷

3. If the FM state is unstable, what is the true magnetic ground state of the ordered Sr₂FeM oO₆? The question is not simple, because the AFM phase appears to be also unstable, as it is expected for small concentrations of (t_{2g}) carriers moving in the AFM background of localized (e_g) spins and interacting with the latter via the strong intra-atom ic H und's coupling [7]. This fact is also related with the magnetic-state dependence of interatom ic magnetic interactions, which leads to the reversed inequality $J_1 > jJ_2 j$ for parameters calculated in the AFM state (Table 4). Therefore, the true ground state of the chemically ordered Sr_2FeM oO₆ should lie in-between the FM and AFM states. The character of interatom ic magnetic interactions suggests that probably it is a spin-spiral with q jj[111].

The FM ordering can be stabilized by the anti-site defects or the local lattice distortions [62]. However, both mechanisms will destroy the halfmetallic character of the electronic structure of Sr_2FeM oO₆. This is an irony of the situation. From the electronic structure point of view, the most e cient way to stabilize the ferrom agnetism is to create holes in the "-spin Fe(e_g) band, by shifting the Ferm i level to the lower energy part of the spectrum, and thereby activate a very elective channel for the FM DE interactions associated with the e_g states, similar to the CMR manganites.

Let us give a rough estim ate for this e ect. The width of the $Fe(e_g)$

band (W) in Sr₂FeM oO₆ is about 2 eV (Fig. 12), which is approximately two times smaller than the typicale_g bandwidth in FM manganites. Therefore, the DE and SE interactions in Sr₂FeM oO₆, being proportional to W and W², will be correspondingly two and four times smaller in comparison with the same interactions in manganites. The latter can be estimated as J^D ' 80 and J^S ' 70 m eV, respectively [26]. Therefore, the partial depopulation of the "-spin Fe(e_g) band in Sr₂FeM oO₆ leads the follow ing estimate for next-nearest-neighbor coupling: $J_2 ' \frac{1}{2}J^D + \frac{1}{4}J^S ' 20 \text{ meV}$, which easily explains the appearance of ferrorm agnetism in this compound.

Thus, the half-m etallic electronic structure realized in the FM state of the ordered double perovskites is a spurious e ect since it is largely incom patible with stability of this FM state. It also implies that the 100% ordered double perovskites cannot be ferrom agnetic. The latter observation is qualitatively consistent with the behavior of $Sr_2FeW O_6$, where alm ost perfect ordering of Fe and W coexists with an AFM ground state [64].²⁸

The quantitative theory of ferrom agnetism in $Sr_2FeM \circ O_6$ and $Sr_2FeR \circ O_6$ is still missing. The exceptionally high value of the Curie tem – perature is one of the main puzzles, which is probably related with the extrinsic inhom ogeneities (anti-site defects, local lattice distortions, grain boundaries) existing in the samples. The magneto-resistive behavior is based on the percolative scenario, and is not necessary related with the halfm etallic character of the electronic structure. The main di erence from CMR manganites is that neither FM nor AFM states are locally stable and cannot be the total energy minim a in the case of double perovskites. Therefore, the extrinsic inhom ogeneity seems to be indispensable in order to stabilize the FM islands and form the two-pase state similar to the one depicted in Fig. 8.²⁹ Then, the negative magneto-resistance may occur if the size of these islands can be easily controlled by the external magnetic eld.

F inally, our analysis was based on the electronic structure obtained in LSDA, which may be imperfect. The role of C oulom b correlations on the


top of LSDA is rather unclear. It is also unclear whether the C oulom b correlations alone can stabilize the FM state. On the one hand, the on-site U enters the denom inator for the SE interactions and therefore suppress the AFM contribution associated with the $Fe(e_g)$ states. On the other hand, it may change the relative position of the Fe and M o states and thereby suppress the FM DE interactions associated with the hybrid t_{2g} band [62]. We expect that the LSDA band structure depicts the main problem s of the double perovskites, though the concrete details may depend on the C oulom b correlations on the top of this picture.

5.3 $A_2M \circ_2 \circ_7$ (A = Y, Gd, and Nd) Pyrochlores

Pyroch lores with the chem ical form ula $A_2M \circ_2 \circ_7$ (A being the divalent elem ent) is one of the rare examples of magnetic oxides on the basis of 4d elements.³⁰ The magnetic phase diagram of $A_2M \circ_2 \circ_7$ is controlled by the averaged ionic radius hr_A i of the A-sites. This dependence is very puzzling (Fig. 14) [66, 67, 68, 69]. Large $hr_A i (> R_c 1.047)$ stabilizes the ferrom agnetic (FM) ground state. Typical examples of the FM pyrochlores are $Nd_2Mo_2O_7$ and $Gd_2Mo_2O_7$. The Curie tem perature (T_C) is of the order of 80 K and slowly increases with hr_A i. Smaller hr_A i (< R_c) give rise to the spin-glass (SG) behavior. The characteristic transition temperature to the SG state is of the order of 20 K. The canonical example of the SG com pounds is $Y_2M \circ_2 \circ_7$ [70]. Intuitively, it is clear that such a behavior should be related with the change of the NN exchange coupling, which becomes antiferrom agnetic in the SG region. The pyrochlore lattice supplem ented with the AFM exchange interactions presents a typical example of geom etrically frustrated systems with an in nitely degenerate magnetic ground state [71], which probably predeterm ines the SG behavior.³¹ The FM -SG transition in Mo pyrochlores is closely related with the metal-insulator transition. All compounds which reveal the SG behavior are small-gap insulators. However, the opposite statement is generally incorrect and

in di erent com pounds the ferrom agnetism is known to coexist with the m etallic as well as the insulating behavior [69]. In this section we will try to understand which param eter of the crystal structure controls the sign of the NN m agnetic interactions, and which part of the electronic structure is responsible for the FM and AFM interactions in these com pounds.

5.3.1 M ain D etails of C rystal and E lectronic Structure

The pyrochlores $A_2M o_2O_7$ crystallize in a face-centered cubic structure with the space group Fm $\overline{3}d$, in which A and M o occupy correspondingly 16d and 16c positions, and form interpenetrating sublattices of corner-sharing tetrahedra. There is only one internal parameter which m ay control the properties of $A_2M o_2O_7$. That is the coordinate u of the O 48f sites.




Figure 15: Positions of the Mo and O 48f sites in the pyrochlore lattice.

The single M o tetrahedron is shown in Fig. 15. Four M o sites are located at $_1 = (0;0;0)$, $_2 = (0;\frac{1}{4};\frac{1}{4})$, $_3 = (\frac{1}{4};0;\frac{1}{4})$, and $_4 = (\frac{1}{4};\frac{1}{4};0)$, in units of cubic lattice parameter a. Each M o site has sixfold 0 48f coordination. The oxygen atom s specify the local coordinate fram e around each M o site.

where ; = x, y, or z. $u = \frac{5}{16}$ corresponds to the perfect octahedral environment, while $u > \frac{5}{16}$ gives rise to an additional trigonal contraction of the local coordinate frame. Sim ilar matrices associated with the sites 2, 3, and 4 can be obtained by the 180 rotations of \Re_1 around x, y, and z, respectively.





Figure 16: Total and partial densities of states of $N d_2 M o_2 O_7$ in the local-spin-density approximation. The $M o(t_{2g})$ states are located near the Fermi level (chosen as zero of energy). The $M o(e_g)$ states emerge around 4 eV.

Structural parameters of $A_2M \circ_2 \circ_7$ (taken from Refs. [66, 67, 68, 69, 70]) are listed in Table 5. Corresponding densities of states, obtained in LSDA are shown in Figs. 16 and 17.

In the local coordinate frame, the Mo(4d) orbitals are split into the triply-degenerate t_{2g} and doubly-degenerate e_g states. Twelve t_{2g} bands are located near the Ferm i level and well separated from the rest of the spectrum. Interestingly enough that all three compounds $A_2M o_2O_7$ (A = Y, G d, and N d) are ferrom agnetic, even in LSD A, that is rather unusual for the 4d oxides, perhaps except the well know example of SrR uO₃ [73]. The trigonal distortion and the di erent hybridization with the O (2p) states

w ill further split the M $o(t_{2g})$ states into the one-dimensional a_{1g} and twodimensional e_g^0 representations.³² The crystal structure a ects the M $o(t_{2g})$ bandwidth via two mechanisms (see Table 5).

- The Mo-O-Mo angle, which decreases in the direction Nd! Gd! Y. Therefore, the interactions between Mo(t_{2g}) orbitals which are mediated by the O (2p) states will also decrease.
- 2. The lattice parameter a and the Mo-Mo distance, which decrease in the direction Nd! Gd! Y by 2.6%. This will increase the direct interactions between extended Mo(4d) orbitals.

Generally, these two e ects act in the opposite directions and partly com -

pensate each other. For example, the width of the e_g^0 band is practically the same for all three compounds (Fig. 17). On the other hand, the a_{1g} orbitals, whose lobes are them ost distant from all neighboring oxygen sites are mainly a ected by the second mechanism, and the a_{1g} bandwidth will increase in the direction N d! G d! Y.Aswewillsee below, this e ect plays a crucial role in the stabilization of AFM interactions in Y₂M o₂O₇, which predeterm ines SG behavior.

Thus, despite an apparent complexity of the crystal structure, the pyroch lores A $_2$ M o $_2$ O $_7$ present a rather simple example of the electronic structure and in order to understand the nature of fascinating electronic and magnetic properties of these compounds, we need to concentrate on the behavior of twelve well isolated M o (t_{2g}) bands.³³

In this section we consider results of model Hartree-Fock calculations [75], which combine ne details of the electronic structure for these bands, extracted from LSDA, and the on-site C oulom b interactions among the M o (4d) electrons, treated in the most general rotationally invariant form [13].³⁴

5.3.2 E ects of C rystal Structure and O n-Site C oulom b Interactions on the Interatom ic E xchange C oupling




Figure 18: The band gap as a function of Coulom b U. For U 2:0 eV there is an overlap between bands, corresponding to the negative value of the band gap, while U 2:5 eV opens the real gap.




Figure 19: D istribution of the M o(4d) states obtained in m odel H artree Fock calculations for U = 3.0 eV.

A coording to the LSDA calculations for the FM state (Fig. 17), the "-spin a_{1g} band is fully occupied and the Ferm i level crosses the doubly-degenerate e_g^0 band. Therefore, it is clear that at some point the C oulom b U will split the e_g^0 band and form an insulating state with the spontaneously broken F m 3d symmetry. Such situation occurs between U = 2.0 and 2.5 eV for all considered compounds (Fig. 18). Typical densities of states in the insulating phase are shown in Fig. 19.

³⁴ The on-site C oulom b interactions are specified by three radial Slater integrals, F^0 , F^0 , and F^0 . Equivalently, one can introduce parameters of the averaged C oulom b interaction, $U = F^0$, the intra-atom ic exchange coupling, $J = \frac{1}{14}$ ($F^2 + F^4$), and the non-sphericity of C oulom b interactions between orbitals with the same spin, $B = \frac{1}{441}$ ($9F^2 - 5F^4$). J' 0.5 eV is taken from the constraint-LSDA calculations [12]. B can be estimated from J using the ratio $F^4 = F^2$ ' 0.63, which holds for the Slater integrals in the atom ic limit. This yields B' 0.06 eV. The C oulom b U is treated as the parameter in order to consider different scenarios, covering both m etallic and insulating behavior of A_2 M o_2 O₇. The constraint-LSDA calculations for M o compounds yield U 3.0 eV [12]. This value can be further reduced by allowing for the (proper)




Figure 20: O rbital ordering in N d₂M o₂O $_7$ for U = 1:5 eV.




Figure 21:0 rbital ordering in $Y_2M o_2O_7$ for U = 3.0 eV. Left panel: ferrom agnetic phase. Two orbital sublattices are shown by black and gray colors. Right panel: antiferrom agnetic phase. Two spin sublattices are show by black and gray colors.

The insulating behavior is accompanied by the change of the orbital ordering (the distribution of the M o (4d) electron densities). In the m etallic state, it com es exclusively from the local trigonal distortions of the oxygen octahedra and represents the alternating a_{1q} orbital densities in the background of degenerate e_{a}^{0} orbitals (Fig. 20). In the insulating state, the orbital ordering is determ ined not only by the local trigonal distortions, but also by the form of SE interactions between NN M o sites, and tends to m in in ize the energy of these interactions [8]. Two typical examples for the FM and AFM (obtained after the ip of magnetic moments at the sites 2 and 3) phases are shown in Fig. 21. As expected for the FM spin ordering [8], the e_{α}^{0} orbitals tend to order "antiferrom agnetically" and form two M o sublattices. C learly, this orbital ordering breaks the F m $\overline{3}$ d sym m etry: if the sites belonging to the same sublattice can still be transformed to each other using the symmetry operations of the Fm 3d group, the sites belonging to di erent sublattices { cannot. This will generally lead to the anisotropy of electronic properties, including the NN m agnetic interactions. The AFM spin ordering coexists with the FM orbital ordering. It breaks the F m 3d sym metry in the spin sector, but not in the orbitals one.




Figure 22: Nearest-neighbor exchange interactions calculated in the ferrom agnetic state. The orbital ordering realized for large U breaks the Fm $\overline{3}$ d symmetry, that leads to the inequality $J_{12} = J_{13} \in J_{14}$. Two such parameters, J_{12} and J_{14} , are shown by dark and light symbols, respectively.

Results for NN m agnetic interactions are shown in Fig. 22, as a function

 e_g electrons to participate in the screening of on-site C oulom b interactions of the t_{2g} electrons [76].

- 1. J o, which are ferrom agnetic for small U, exhibit a sharp drop at the point of transition into the insulating state.
- 2. There is a signi cant di erence between Nd/Gd and Y based com pounds: in the case of Y, the exchange param eters are alm ost rigidly shifted towards negative values, so that the NN coupling become anti-ferrom agnetic in the insulating phase, while it remains ferrom agnetic in the case of Nd and Gd.




Figure 23: Contributions of a_{1g} and e_g^0 orbitals (com ing from the t_{2g} m anifold in the local coordinate fram e) to the exchange constant J_{14} .

The behavior can be easily understood by considering partial a_{1g} and e_g^0 contributions to the NN exchange coupling, calculated after transform ation to the local coordinate frame at each site of the system (Fig. 23). Large FM $e_g^0 - e_g^0$ interaction in the metallic regime is related with the double exchange (DE) mechanism, which is the measure of the kinetic energy for the itinerant "-spin e_g^0 electrons. As long as the system is metallic, the DE interactions are not sensitive to the value of U, and the FM coupling will prevail. In the insulating state, the e_g^0 electrons are localized at the atom ic orbitals. This reduces the kinetic energy and suppresses the DE interactions, that explain the sharp drop of J \circ (Fig. 22).

The main dierence between Y and Nd/Gd based compounds is related

with the a_{1g} - a_{1g} interaction. Since the "-spin a_{1g} band is fully occupied and the #-spin band is empty, this interaction is antiferrom agnetic due to the superexchange mechanism. Since the SE coupling is proportional to the square of the a_{1g} bandwidth, this interaction will be the largest in the case of Y, that explains the AFM character of the total exchange coupling realized in this compound for large U.

This example clearly shows at the importance of Coulomb U in the problem interatom ic magnetic interactions of M ott insulators: it is absolutely indispensable in order to open the gap between occupied and unoccupied states, and suppress the FM DE interactions. Only in this case the total coupling between neighboring M o sites can become antiferrom agnetic, which is a necessary precondition for the SG behavior. On the contrary, the metallic state of M o pyrochlores will always coexist with the ferrom agnetism. Therefore, it is not right to say that the energy gap is not a ground-state property and therefore does not need to be present in the Kohn-Sham quasi-particle spectrum of the SDFT. The present example

shows exactly the opposite: the energy gap m ay determ ine not only the value, but also the sign of interatom ic m agnetic interactions, which are the ground-state properties.

6 Concluding Remarks

In this review we tried to formulate some fram ework for the analysis of interatom ic magnetic interactions in the transition-metal oxides and give some hints and ideas illustrating how this analysis should be generally done or at least started with on the basis of realistic electronic structure calculations. It is based on the fundamental magnetic force theorem, which allow sto connect the problem of interatom icm agnetic interactions in solids with the (generally auxiliary) single-particle spectrum obtained from the solution of K ohn-Sham equations in the spin-density-functional theory for the ground state.

The straightforward application of this theorem is seriously ham pered by the fact that in realistic calculations, SD FT is supplemented with some approximations, which are not always adequate for TM 0. Nevertheless, in many cases the electronic structure calculations can provide the basic idea or at least some useful input information for the analysis of interatom ic magnetic interactions in TM 0, which (perhaps with some imaginations!) can be transformed to a realistic sem i-quantitative model. This point of view was illustrated for a number of popular now adays compounds, such as CM R manganites, double perovskites $Sr_2FeM O_6$ (M = M o, Re), and pyrochlores $A_2M o_2O_7$ (A = Y, G d, and N d).

It would be unfair to say that this strategy is universal and can be directly applied to all possible types of TMO. In some sense, we were lucky that the realistic information about the electronic structure of the considered compounds can be obtained already on the level of LSDA:

It gives a rough idea about the com petition of double exchange and superexchange interactions in CMR manganites and double perovskites.

It allows to identify the electronic states, which are mainly responsible for the physics of Mo-pyrochlores and well separated from the rest of the spectrum, so that the next step connecting the LSDA calculations with the degenerate Hubbard model becomes basically a matter of routine.

Unfortunately, such a generalization is not always possible and there is a wide class of magnetic TMO, which still presents a very challenging problem for the rst-principles electronic structure calculations. This group includes many nickelates and cuprates. These systems are especially complicated because of two reasons:

For many of them, the standard LSDA calculations erroneously lead to the nonmagnetic ground state (the most famous example is La_2CuO_4 [77]). Therefore, it is dicult to make any conjectures basing on the LSDA.

All these compounds are of the charge-transfer type. In this case, the sem i-empirical LDA + U calculations may not be very reliable either.

In order to proceed with the realistic description of electronic and m agnetic properties of these m aterials, the developm ent of new m ethods of electronic structure calculations, which would go beyond LSDA and get rid of several em pirical features of the LDA + U approach is a very im portant task.
