## G auge invariant dressed holon and spinon in doped cuprates

We develop a partial charge-spin separation ferm ion-spin theory in plemented the gauge invariant dressed holon and spinon. In this novel approach, the physical electron is decoupled as the gauge invariant dressed holon and spinon, with the dressed holon behaviors like a spinful ferm ion, and represents the charge degree of freedom together with the phase part of the spin degree of freedom, while the dressed spinon is a hard-core boson, and represents the am plitude part of the spin degree of freedom, then the electron single occupancy local constraint is satisfied. Within this approach, the charge transport and spin response of the underdoped cuprates is studied. It is shown that the charge transport is mainly governed by the scattering from the dressed holons due to the dressed spinon uctuation, while the scattering from the dressed spinons due to the dressed holon uctuation dom inates the spin response.

Very soon after the discovery of the high-tem perature superconductivity (HTSC) in doped cuprates, Anderson proposed a scenario of HTSC based on the charge-spin separation in the two-dimension  $(2D)^1$ , where the internal degrees of freedom of the electron are decoupled as the charge and spin degrees of freedom, while the elementary excitations are not quasi-particles but collective m odes for the charge and spin degrees of freedom, i.e., the holon and spinon, then these holon and spinon m ight be responsible for the experimentally observed nonconventional behavior of doped cuprates. M any unusual features of doped cuprates are extensively studied following this line within the 2D t-J type m odel.

The decoupling of the charge and spin degrees of freedom of electron is undoubtedly correct in the one-dimensional (1D) interacting electron system  $s^2$ . In particular, the typical behavior of the non-Ferm i-liquid, i.e., the absence of the quasi-particle propagation and charge-spin separation, has been dem on strated theoretically within the 1D t-J m odel<sup>3</sup>. M oreover, the holon and spinon as the real elementary excitations in 1D cuprates has been observed directly by the angle-resolved photoem ission spectroscopy (ARPES) experiment<sup>4</sup>. However, the case in 2D is very complex since there are m any competing degrees of freedom  $^5$  . As a consequence, both experim ental investigation and theoretical understanding are extremely di cult. Among the unusual features of doped cuprates, a hallmark is the charge transport<sup>5;6</sup>, where the conductivity shows a non-D rude behavior at low energies, and is carried by x holes, with x is the hole doping concentration, while the resistivity exhibits a linear tem perature behavior over a wide range of tem peratures. This is strong experimental evidence supporting the notion of the charge-spin separation, since not even conventional electron-electron scattering would show the striking linear rise of scattering rate above the Debye frequency, and if there is no the charge-spin separation, the phonons should a ect these properties. Furtherm ore, a com pelling evidence for the charge-spin separation in doped cuprates has been found from the experim ental test of the Wiedem ann-Franzlaw, where a clear departure from the universal Wiedem ann-Franzlaw for the typical Fermi-liquid behavior is observed<sup>8</sup>. In this case, a form al theory in plem ented the gauge invariant holon and spinon, i.e., the issue of whether the holon and spinon are real, is centrally in portant, since we must squarely face if there is to be a m eaningful discussion of theories based on the charge-spin separation<sup>9</sup>. In this paper, we propose a partial charge-spin separation ferm ion-spin theory, and show that if the local single occupancy constraint is treated properly, then the electron operator can be decoupled by introducing the dressed holon and spinon. These dressed holon and spinon are gauge invariant, i.e., they are real in 2D.

We begin with the t-t<sup>0</sup>-J model de ned on a square lattice as,

supplemented by the single occupancy local constraint  $C_i^y C_i$  1, where  $\hat{z}_i \circ \hat{y}_i \circ \hat{z}_i \circ \hat{z}_i$ 

electron local constraint  $C_i^{Y} C_i = 1$   $h_i^{Y} h_i$  1 is satisfied, with  $n_i = h_i^{Y} h_i$  is the holon number at site i, equal to 1 or 0. In this form alism, the charge and spin degrees of freedom of electron may be separated at the mean eld (MF) level, where the elementary charge and spin excitations are called the holon and spinon, respectively. We call such holon and spinon as bare holon and spinon, respectively, since an extra U (1) gauge degree of freedom related with the local constraint  $a_i^{Y} a_i = 1$  appears, i.e., the CP<sup>1</sup> representation is invariant under a local U (1) gauge transform ation  $h_i$  !  $h_i e^{i_i}$ ,  $a_i$  !  $a_i e^{i_i}$ , and then all physical quantities should be invariant with respect to this transform ation. Thus both bare holon  $h_i$  and bare spinon  $a_i$  are not gauge invariant, and they are strongly coupled by this U (1) gauge eld uctuations. In other words, these bare holon and spinon are not real.

How ever, the CP<sup>1</sup> boson  $a_i$  with the constraint can be m apped exactly onto the pseudospin representation de ned with an additional phase factor. This is because that the empty and doubly occupied spin states have been ruled out due to the constraint  $a_{i^{''}}^{y}a_{i^{''}} + a_{i^{\#}}^{y}a_{i^{\#}} = 1$ , and only the spin-up and spin-down singly occupied spin states are allowed, thus the original four-dimensional representation space is reduced to a 2D space. Due to the sym metry of the spin-up and spin-down states, joccupied in  $= \begin{bmatrix} 1 \\ 0 \\ 1 \end{bmatrix}$  and jem ptyi<sup>''</sup> =  $\begin{bmatrix} 0 \\ 1 \end{bmatrix}$  are singly-occupied and empty spin-up, while joccupied if  $= \begin{bmatrix} 0 \\ 1 \end{bmatrix}$  are singly-occupied and empty spin-up. In this

case, the constrained CP $^1$  boson operators  $a_i$  can be represented in this reduced 2D space as,

with S is the S<sup>z</sup> low ering operator, while S<sup>+</sup> is the S<sup>z</sup> raising operator, and then the local constraint  $i'' a_i^y a_i = S_i^+ S_i^- + S_i^- S_i^+ = 1$  is exactly satisfied. Obviously, the bare spinon contains both phase and am plitude parts, and the phase part is described by the phase factor  $e^{i_i}$ , while the am plitude part is described by the spin operator  $S_i$ . In this case, the electron CP<sup>1</sup> decoupling form with the constraint can be expressed as  $C_{i''} = h_i^y e^{i_i} i'' S_i^-$  and  $C_{i\#} = h_i^y e^{i_i} i'' S_i^+$ , while the localU (1) gauge transform ation is replaced as  $h_i ! h_i e^{i_i}$ ,  $i_i ! i_i + i_i$ . Furtherm ore, the phase factor of the bare spinon  $e^{i_i}$  can be incorporated into the bare holon, then we obtain a new ferm ion-spin transform ation as,

with the spinful ferm ion operator  $h_i = e^{i} i h_i$  describes the charge degree of freedom together with the phase part of the spin degree of freedom (dressed holon), while the spin operator S describes the amplitude part of the spin degree of freedom (dressed spinon). In this case, only the amplitude part of the spin degree of freedom is separated from the electron operator, and thus the partial charge-spin separation is in plan ented in the electron decoupling form (3). These dressed holon and spinon are invariant under the local U (1) gauge transform ation, and therefore all physical quantities from the dressed holon or dressed spinon also are invariant with respect to this gauge transform ation. In this sense, these dressed holon and spinon are real as the new elementary particle excitations in the low-dimensional solid. This gauge invariant dressed holon is a magnetic dressing. In other words, the gauge invariant dressed holon carries som e spinon messages, i.e., it shares som e e ects of the spinon con guration rearrangem ents due to the presence of the hole itself. We emphasize that the present dressed holon  $h_i$  is a spinless ferm ion  $h_i$  (bare holon) incorporated a spinon cloud (magnetic ux), although in common sense  $h_i$  is not an real spinful ferm ion, its behaviors like a spinful ferm ion. In correspondence with these special physical properties, we nd that  $h_i^y h_i = h_i^y e^{i} e^{i} h_i = h_i^y h_i$ , which guarantees that the electron on-site local constraint,  $C_{i}^{y}C_{i} =$  $S_i^+ h_{i''} h_{j''} S_i^+ + S_i^- h_{i\#} h_{i\#}^{y} S_i^+ = h_i h_i^{y} (S_i^+ S_i^- + S_i^- S_i^+) = 1$   $h_i^{y} h_i^- = 1$ , is always satised in analytical calculations. M oreover the double spinful ferm ion occupancy,  $h_i^y h_i^y = e^{i \cdot i} h_i^y h_i^y e^{i \cdot i} = 0$ ,  $h_i h_i = e^{i \cdot i} h_i h_i e^{i \cdot i} = 0$ , are ruled out autom atically. Since the spinless ferm ion  $h_i$  and spin operators  $S_i^+$  and  $S_i^-$  obey the anticommutation relation and Pauli spin algebra, respectively, it then is easy to show that the spinful ferm ion  $h_i$  also obey the same anticom mutation relation as the spinless ferm ion hi. In this partial charge-spin separation ferm ion-spin representation, the t-t<sup>0</sup>-J m odel (1) can be rew ritten as,

The spirit of the present partial charge-spin separation ferm ion-spin theory is very similar to these of the bosonization in 1D interacting electron system<sup>2</sup>, where the electron operators are mapped onto the boson (electron density) representation, and then the recast H am iltonian is exactly solvable.

A lithough the choice  $CP^1$  representation is convenient, so long as  $h_i^y h_i = 1$ ,  $C_i^y C_i = 0$ , no matter what the values of  $S_i^+ S_i^-$  and  $S_i^- S_i^+$  are, therefore it means that a "spin" even to an empty site has been assigned. It has been shown<sup>10</sup> that this defect can be cured by the projection operator P<sub>i</sub>, i.e., the constrained electron operator can be mapped exactly using the ferm ion-spin transform ation de ned with the additional projection operator Pi as  $C_{i''} = P_i h_{i''}^{i'} S_i P_i^{j'}$  and  $C_{i''} = P_i h_{i''}^{j} S_i^{+} P_i^{j'}$ . How ever, this projection operator is cum bersom e to handle, and we will drop it in the actual calculations. It also has been show  $n^{10;11}$  that such treatm ent leads to errors of the order x in counting the num ber of spin states, which is negligible for small dopings. M oreover, the electron local constraint still is exactly obeyed even in the MF approximation (MFA), and therefore the essential physics of the gauge invariant dressed holon and spinon also are kept. This is because that the constrained electron operator  $C_i$  in the t-J type m odel also can be m apped onto the slave-ferm ion form ulism <sup>11</sup> as  $C_i = h_i^y b_i$  with the local constraint  $h_i^y h_i + \frac{1}{2}$  $b_i^y b_i = 1.W e can solve$ this constraint by rewriting the boson operators  $b_i$  in terms of the CP<sup>1</sup> boson operators  $a_i$  as  $b_i = a_i$  1  $h_i^y h_i$ supplemented by the local constraint  $a_i^y a_i = 1.As m$  entioned above, the CP<sup>1</sup> boson operators  $a_{i''}$  and  $a_{i\#}$  with the local constraint can be identied with the pseudospin lowering and raising operators, respectively, de ned with an additional phase factor, therefore the projection operator is approximately related to the holon number operator  $1 \quad h_i^y h_i = 1 \quad h_i^y h_i$ , and its main role is to remove the spurious spin when there is a holon at the site by P<sub>i</sub> i.

In the Ferm i-liquid, the electron carried both charge and spin degrees of freedom moves almost freely since the weak electron-electron interaction in the system, where both am plitude and phase parts of the spin degree of freedom are delocalized. However, in the doped M ott insulator, our present study indicates that the electron operator can be decoupled as the dressed holon and spinon, with the dressed spinon represents the bare spinon's am plitude part, and is localized, while the dressed holon represents the bare holon together with the bare spinon's phase part, and then can move almost freely in the background of the dressed spinon uctuation. The present decoupling scheme seems to have been con med in the doped 1D M ott insulator, where although the charge and spin degrees of freedom are manifested them self by the excitations of charge-density wave and spin-density wave, respectively<sup>2</sup>. These charge-density wave and spin-density wave are described in terms of the density-density correlation function and spin-spin correlation, respectively, and both density operator and spin operator are gauge invariant.

As an application of the present theory, we discuss the charge transport and spin response of the underdoped cuprates. The one-particle dressed holon and spinon two-time G reen's functions are de ned as,

respectively. Since the dressed spinon operators obey the Pauli algebra, then our goal is to evaluate the dressed holon and spinon G reen's functions directly for the ferm ion and spin operators in terms of equation of motion method. In the framework of equation of motion, the time-Fourier transform of the two-time G reen's function  $G(!) = hA; A^{y}ii_{!}$  satisfies the equation<sup>12</sup>,  $!hA; A^{y}ii_{!} = hA; A^{y}ii + hA; H]; A^{y}ii_{!}$ . If we denote the orthogonal operator L as A; H = A if with  $hL; A^{y}ii = 0$ , then the full G reen's function can be expressed as,

It has been shown from the experiments<sup>13</sup> that the antiferrom agnetic (AF) long-range-order (AFLRO) in the undoped cuprates is destroyed by hole doping of the order 0.024, therefore there is no AFLRO in the underdoped regime 0.025 x < 0.15, i.e.,  $hS_1^z i = 0$ . In this case, a MF theory<sup>14</sup> of the t-J model has been discussed within the K ondo-Y am a ji decoupling scheme<sup>15</sup>. In the present partial charge-spin separation theoretical fram ework, the external electronic eld can only be coupled to the gauge invariant dressed holons, but the strong correlation between dressed holons and spinons still is considered self-consistently through the dressed spinon's order parameters entering in the dressed holon's propagator. where  ${}_{s}^{2}(k) = [\sin^{2} k_{x} (_{1}t 2_{2}t^{0} \cos k_{y})^{2} + \sin^{2} k_{y} (_{1}t 2_{2}t^{0} \cos k_{x})^{2}]=4$  and the dressed holon spectral function A  $^{(h)}(k;!) = 2\text{Im g}(k;!)$ . The results of the resistivity as a function of tem perature at x = 0.03 (solid line), x = 0.04 (dashed line), x = 0.05 (dotted line), and x = 0.06 (dash-dotted line) for t=J = 2.5 and t^{0}=t = 0.15 are plotted in Fig. 1 in comparison with the experimental data<sup>6</sup> taken from La<sub>2 x</sub> Sr<sub>x</sub>CuO<sub>4</sub> (inset). It is shown obviously that the resistivity is characterized by a crossover from the moderate temperature metallic-like behavior to low temperature insulating-like behavior in the heavily underdoped regime, and a temperature linear dependence with deviations at low temperatures in the moderate underdoped regime. But even in the heavily underdoped regime, the resistivity exhibits the metallic-like behavior over a wide range of temperatures, which are in agreement with the experiments<sup>6</sup>.




FIG.1. The electron resistivity as a function of tem perature at x = 0.03 (solid line), x = 0.04 (dashed line), x = 0.05 (dotted line), and x = 0.06 (dash-dotted line) with t=J = 2.5 and t<sup>0</sup>=t = 0.15. Inset: the experimental result of La<sub>2</sub> x Sr<sub>x</sub>CuO<sub>4</sub> taken from Ref.<sup>6</sup>.

The doped holes into the M ott insulator can be considered as a competition between the kinetic energy (xt) and m agnetic energy (J). The magnetic energy J favors the magnetic order for spins and results in "frustration" of the kinetic energy, while the kinetic energy xt favors delocalization of holes and tends to destroy the magnetic order. In the present partial charge-spin separation ferm ion-spin theory, the scattering of dressed holons dom inates the charge transport. The dressed holon scattering rate is obtained from the dressed holon self-energy by considering the dressed holon-spinon interaction, while this dressed holon self-energy from the dressed spinon pair bubble characterizes

the competition between the kinetic energy and magnetic energy, therefore the striking behavior in the resistivity is intriguingly related with this competition. In the heavily underdoped regime, the dressed holon kinetic energy is much smaller than the dressed spinon magnetic energy in lower temperatures, therefore the dressed holons are localized, and scattering rate from the dressed holon self-energy is severely reduced, this leads to the insulating-like behavior in the resistivity. With increasing temperatures, the dressed holon kinetic energy is increased, while the dressed spinon magnetic energy is decreased. In the region where the dressed holon kinetic energy is larger than the dressed spinon magnetic energy at moderate temperatures, the dressed holons move alm ost freely, and then the dressed holon scattering would give rise to the metallic-like behavior in the resistivity.

Now we discuss the dynamical spin response. In the present partial charge-spin separation ferm ion-spin theory, the spin uctuation couples only to dressed spinons, but the elect of dressed holons on dressed spinons has been considered through the dressed holon's order parameters entering in the dressed spinon propagator. In this case, we can obtain the dynamical spin structure factor  $S(k;!) = 2[l + n_B(!)] \text{Im } D(k;!)$  as,

with Im  $_{s}^{(2)}(k;!)$  and Re  $_{s}^{(2)}(k;!)$  are corresponding in aginary part and real part of the dressed spinon self-energy function  $_{s}^{(2)}(k;!)$ .




FIG.2. The dynamical spin structure factor spectrum in the  $(k_x;k_y)$  plane at x = 0.06 in T = 0.05J and ! = 0.05J with t=J = 2.5 and t<sup>0</sup>=t = 0.15.

We plot the dynamical spin structure factor spectrum S (k;!) in the  $(k_x;k_y)$  plane at x = 0.06 with T = 0.05J and ! = 0.05J for t=J = 2.5 and t<sup>0</sup>=t = 0.15 in Fig. 2. It is shown that with dopings, there is a commensurate-




FIG.3. The doping dependence of the incom mensurability (x). In set: the experimental result of La $_2$  x Sr<sub>x</sub> CuO 4 taken from R ef<sup>17</sup>.

incommensurate (IC) transition in the spin uctuation geometry, where all IC peaks lie on a circle of radius of . A lthough some IC satellite diagonal peaks appear, the main weight of the IC peaks is in the parallel direction, and these parallel peaks are located at [(1 )=2;1=2] and [l=2;(1 )=2] (hereafter we use the units of [2 ;2 ]). The present dynamical spin structure factor spectrum S (k;!) has been used to extract the doping dependence of the incommensurability (x), which is de ned as the deviation of the peak position from AF wave vector position, and the result is shown in Fig. 3 in comparison with the experimental result<sup>17</sup> taken from  $La_{2x} Sr_x CuO_4$  (inset). Our results show that (x) increases progressively with the hole concentration at lower dopings, but saturates at higher dopings, which are qualitatively consistent with the experimental observations<sup>17</sup>.

Our results also show that the e ect of dressed holons on the dressed spinon part is critical in determining the characteristic feature of the IC magnetic correlation. This can be understood from the properties of the dressed spinon

excitation spectrum  $E_{k}^{2} = !_{k}^{2} + Re_{s}^{(2)}$  (k;  $E_{k}$ ). During the calculation of the dynam ical spin structure factor spectrum Re  $_{\rm s}^{(2)}$  (k ;!)]<sup>2</sup> 0 at the critical wave vectors k in low energies, S(k;!), we nd when  $W(k;!) = [!^2]$ ! <sup>2</sup> k the IC peaks appear, then the weight of the IC peaks is dom inated by the inverse of the im aginary part of the dressed spinon self-energy 1=Im  $\frac{^{(2)}}{s}$  (k;!). In this case, the positions of the IC peaks are determined by both functions W (k;!) and Im  $s^{(2)}(k;!)$ , where the zero points of W (k;!) (then the critical wave vectors k) is doping dependence. Near the half- lling, the zero point of W (k;!) boates at the AF wave vector [1=2;1=2], so the commensurate AF peak appears there. With doping, the holes disturb the AF background. As a result of self-consistent motion of dressed holons and spinons, the IC magnetic correlation is developed beyond certain critical doping. As seen from S (k;!), the physics is dom inated by the dressed spinon self-energy renorm alization due to dressed holon pair bubble. In this sense, the mobile dressed holons are the key factor leading to the IC magnetic correlation, i.e., the mechanism of the IC type of structure in doped cuprates away from the half- lling is most likely related to the dressed holon motion. This is why the position of the IC peaks can be determined in the present study within the t-t<sup>0</sup>-J model, while the dressed spinon energy dependence is ascribed purely to the self-energy e ects which arise from the dressed holon-spinon interaction.

In sum mary, we have developed a partial charge-spin separation ferm ion-spin theory to study the physical property of doped cuprates. In this novel approach, the electron operator is decoupled as the dressed holon and spinon, with the dressed holon keeps track of the charge degree of freedom together with the phase part of the spin degree of freedom, while the dressed spinon keeps track of the amplitude part of the spin degree of freedom, then the electron single occupancy local constraint is satis ed even in M FA . The dressed holon is a magnetic dressing, and then its behaviors like a spinful ferm ion, while the dressed spinon is neither boson nor ferm ion, but a hard-core boson. Moreover, both dressed holon and spinon are gauge invariant, and in this sense, they are realas the new elementary particle excitations in the low-dimensional solid. Within the t $t^0$ -J m odel, we have studied the charge transport and spin response of the underdoped cuprates, and results are qualitatively consistent with the experim ental observations. These results also are qualitatively consistent with the previous results<sup>18</sup> based on the ferm ion-spin theory<sup>10</sup>, where the phase factor  $e^{i_{\perp}}$  described the phase part of the spin degree of freedom was not considered. Our results also show that the charge transport is mainly governed by the scattering from the dressed holons due to the dressed spinon uctuation, while the scattering from the dressed spinons due to the dressed holon uctuation dom inates the spin response. In this case, the charge transport and spin response are alm ost independent, and the perturbations that interact primarily with charge do not much a ect spin, therefore the notion of the partial charge-spin separation naturally accounts for the qualitative features of doped cuprates.

The present partial charge-spin separation ferm ion-spin theory also indicates that the kinetic energy (t) term in the t-J type m odel gives the dressed holon and spinon dynam ics in the doped regim e without AFLRO, while the m agnetic energy (J) term is only to form an adequate dressed spinon con guration. A lthough the projection operator has been dropped in the actual calculations, leading to an overcounting the number of spin states, the calculated results show that it does not matter in the low-energy sector<sup>7</sup>, this is because that the e ect of the kinetic energy on the spinon con guration has been considered self-consistently in the partial charge-spin separation ferm ion-spin theory.

Intespective of the coupling mechanism responsible for HTSC in doped cuprates, the superconducting state is characterized by the electron C coper pairs<sup>19</sup>. It has been show n<sup>20</sup> from ARPES that in the real space the gap function and pairing force have a range of one lattice spacing. In this case, the superconducting order parameter for the electron pair can be expressed in the present theory as  $h_{i} = h_{i}^{Y}C_{i+}^{Y}$  and  $h_{i+} + h_{i+}^{*}S_{i}^{+}S_{i+}$ ,  $h_{i\#}h_{i+} + S_{i}^{+}S_{i+}$ ,  $h_{i\#}h_{i+} + S_{i+}^{+}S_{i+}$ ,  $h_{i\#}h_{i+} + S_{i+}^{+}S_{i+}$ ,  $h_{i\#}h_{i+} + S_{i+}^{+}S_{i+}$ ,  $h_{i\#}h_{i+} + S_{i+}^{+}S_{i+}^{+}$ ,  $h_{i\#}h_{i+} + S_{i+}^{+}S_{i+}^{$
