E ects of Pauli param agnetism on superconducting vortex phase diagram in strong elds

The G inzburg-Landau (G L) functional and the resultant phase diagram of quasi two-dimensional superconductors in strong—elds perpendicular to the layers, where the Pauli param agnetic depairing is not negligible, are exam ined in details by assuming the weak coupling BCS model with a $d_{x^2-y^2}$ -like pairing. It is found that the temperature at which themean—eld (MF) transition at H_{c2} changes into a discontinuous one lies much above another temperature at which a line $H_{\rm FFLO}$ (T) of transition to a helical FFLO—like vortex solid may begin to appear. In addition to MF results, details of a real phase diagram near H_{c2} (T)—line are examined based on a theoretical argument and Monte Carlo simulations, and it is found that the MF discontinuous transition is changed due to the uctuation into a crossover which is nearly discontinuous in systems with weak enough—uctuation. These results are consistent both with the MF discontinuous behavior and a suggestion of $H_{\rm FFLO}$ (T) in the heavy ferm ion superconductor CeC oIn5 with weak—uctuation and with their absence in cuprate and organic superconductors with strong—uctuation.

I. IN TRODUCTION

Traditionally, e ects of Pauli param agnetism on superconductors with a spin-singlet Cooper-pairing have been discussed by simply focusing on two energy scales [1, 2]; the superconducting (SC) condensation energy and the Zeem an energy preventing the singlet pairing. This is a reasonable explanation on the rst order transition (FOT) in an exceptional case with no orbital depairing creating eld-induced vortices, i.e., a thin-lm superconductor in parallel elds [3]. Further, there is also a possibility of a structural transition within the Meissner phase into the so-called FFLO state [4,5] with a periodic modulation, induced by the spin (param agnetic) depairing, of the SC order param eter. However, the orbital depairing e ects, i.e., the eld-induced vortices, are inevitably present in most of cases of a bulk type II superconductor under a strong eld, including a layered m aterial under a eld parallel to the superconducting layers [7]. Hence, we encounter quite a di erent issue from that in the works [1, 2, 4, 5, 6], that is, e ects of the spin depairing on the vortex state which has no Meissner response. Since the number of vortices is determined only by the magnetic eld strength and system sizes, treating the orbital depairing as a perturbation for the case with no orbital depairing is not valid.

At present, it is well understood [8, 9] that, in lower elds where the spin depairing is negligible, the H -T phase diagram for the vortex states is drastically changed by including the SC uctuation neglected in the mean eld (MF) approximation. A typical one among such drastic uctuation elects is the fact that the second order MF transition at H $_{\rm C2}$ is not realized as a consequence of the uctuation and gives way to a weak rst order transition lying below H $_{\rm C2}$ between the vortex solid and

the vortex liquid region which needs not be distinguished from the normal state. At least theoretically, it is important to extend this issue to the strong eld region in which the spin depairing is not negligible and the MF transition at H $_{\rm c2}$ m ay be discontinuous.

Through previous MF works on the vortex states of superconductors with param agnetic depairing [10, 11, 12], however, one notices that even the H-T phase diagram in the MF approximation is an unsettled issue. For instance, a FOT induced by the spin depairing was expected through a calculation in dirty limit [12], to the best of our know ledge, contrary to the experim ental facts. Further, even in pure (clean) lim it, there are no consensus on the MF phase diagram. In strong elds of our interest, any Meissner phase (i.e., any phase occurring with no orbital depairing) is not possible, and we expect just som e vortex solids, such as the ordinary solid consisting of straight vortex lines and an, if any, FFLOlike solid state with a periodic modulation along the applied eld, as SC ground states in clean lim it with no defects leading to a vortex-pinning. Let us call a transition curve between the above-m entioned two vortex solid states as H $_{\rm FFLO}$ (T). In ref.[10], the transition at H $_{\rm FFLO}$ was argued to be of rst order with no detailed calculation, while it was obtained as a second order one in ref.[11] where the orbital depairing represented by the gauge-invariant gradient is treated perturbatively. Further, the temperature T at which the MF transition at H_{c2} changes into a discontinuous one was concluded there [11] to lie much below another temperature T_{FFLO} at which H_{FFLO} (T) and H_{C2} (T) branch. In addition, the H FFLO (T)-line is often suggested to be insensitive to T. We note that all of con icting results raised above were obtained in the same model, i.e., the simplest weakcoupling BCS model.

In the present paper, we consider the SC phase diagram of quasi two-dim ensional (2D) superconductors with a singlet d-wave pairing under a high eld perpendicular to the SC layers where both the orbital-and spindepairings are not negligible. In Sec.II, a M F calculation for the weak-coupling BCS model is rst performed by focusing prim arily on the region where the SC order param eter is described within the lowest Landau level (LLL or N = 0 LL). We demonstrate by treating the two depairing e ects on the sam e footing that most of the previous MF results mentioned above may be signicantly changed. Our analysis is dierent from that in ref.[11] in that the gauge-invariant gradient is fully incorporated. This nonperturbative inclusion of the orbital depairing should become important upon cooling and with increasing eld, although, instead, multiple num erical integrals have to be performed to accomplish it. Further, bearing a comparison with data in real systems in mind, a weak im purity scattering should be incorporated because the ${
m H}_{
m FFLO}$ (T) line which may appear in high H and low T is found to be quite sensitive to the impurity strength. Consequently, the MF phase diagram is determined by a competition among the two depairing e ects and the impurity strength. We not that the tem perature T always lies above other two characteristic tem peratures T_{FFLO} and Tnext below which the vortex solid will be described by the next lowest Landau level (N = 1 LL). In addition to these studies of the MF phase diagram, linear response and elastic properties in a possible helical FFLO -like vortex solid will be examined to give a result useful for search of such a helical solid state.

Next, in Sec.III, we address e ects of the SC uctuation on the phase diagram by neglecting vortex pinning e ects. W e notice that a theoretical consideration on the uctuation e ects on the orderings in vortex states below H_{c2} is una ected by a change of the GL m odel brought by the presence of the spin depairing and naturally leads to the conjecture that the FOT obtained in the MF approximation (MF-FOT) at H_{c2} will not occur as a true FOT in real system s. A ctually, otherwise, the high eld portion of the H-T phase diagram would not become compatible with its low eld portion in which the absence of the second order MF transition at H $_{c2}$ is well-established [8, 9]. The only transition in the case with no pinning disorder should be the melting transition of a vortex solid. In the present case with a MF-FOT, however, the GL model needs to have higher order (nonlinear) terms other than the quartic term, and this fact makes an analytic study m ore involved. For this reason, we have chosen to perform Monte Carlo simulations on a GL model justi ed through our microscopic analysis in order to exam ine the true phase diagram. Our simulation results are consistent with the above-mentioned conjecture that the MF-FOT at H_{c2} is changed due to the uctuation into a crossover of which the width is narrower in system swith weaker uctuation. Together with the impurity-induced

disappearance of the M F-F0 T, this uctuation-induced broadening of the sharp behavior re-ecting the M F-F0 T explains why the nearly discontinuous behavior at H $_{\rm c2}$ has not been observed so far in, except the recent observations in CeCoIn $_{\rm 5}$ [13, 14, 15, 16, 17], most of bulk type II superconductors with a spin-singlet pairing. On the other hand, we-nd that, in spite of the absence of the genuine F0 T at H $_{\rm c2}$, a hysteresis may appear near H $_{\rm c2}$ in simulations for cases with weaker uctuation (or equivalently, at very low temperatures) as a result of an incomplete relaxation at nite time scales.

Finally in Sec.IV, experimental facts in $C \in CoIn_5$ under H k c and other materials are discussed based on the results obtained in Sec.II and III. It is conjectured there that the SC uctuation makes the H $_{\rm FFLO}$ (T)-line and the FOT-like behavior at H $_{\rm c2}$ unobservable in strongly uctuating systems such as organic materials. Further, it is also pointed out there that, although microscopic results in Sec.II are not applicable to the H ? c case in C eC oIn_5 , recent specic heat data [13, 18] can be understood within our results in Sec.III.

We use the unit $h = c = k_B = 1$ throughout the manuscript.

II.M EAN FIELD ANALYSIS

Following K lem m et al.[19], we start from a BCS ham iltonian for a quasi 2D superconductor under a nonzero magnetic eld perpendicular to the basal plane

where the gauge eld A has no out-of-plane component, $I = {}_{0}H$ is Zeem an energy, and m is the elective mass

of a quasi-particle. The strength of the param agnetic depairing is measured by $_{0}H_{c2}^{orb}(0)=2$ T_{c0} corresponding to the Makiparam eter except a num erical factor, where H orb (T) is the MF transition curve in the case neglecting both the param agnetic depairing and impurity e ects, and T_{c0} is the zero eld (H = 0) transition temperature in the pure lim it. Throughout the num erical calculations in this and next sections, we will choose $_{0}$ H $_{\mathrm{c2}}^{\mathrm{orb}}$ (0)=2 $_{\mathrm{c0}}$ to be 0.8 by bearing a comparison with observations in CeCoIn₅ in mind (see sec.IV). where H.c. denotes Herm itian conjugate. We use the fam iliar quasi-classical approximation for the singleparticle propagator

Here, the G reen's function in zero eld, $G_{"}^{H=0}$ (r), is given as the Fourier transform of the expression

where "denotes the M atsubara frequency " $_{\rm n}=2$ T (n + 1=2) in this paper, " $_{\rm m}=$ "+ s $_{\rm m}=$ (2) i I, and s = sgn ("). Since we take account of the param agnetic depairing suppressing the M F upper critical eld, the use of the quasiclassical approximation, valid if $k_{\rm F}$ r $_{\rm H}$ 1, needs not to be questioned, where $k_{\rm F}$ is the Fermimon entum, and r $_{\rm H}=(2\,\dot{\rm p}\,\dot{\rm H})^{-1=2}$ is the magnetic length. According to the familiar Stratonovich-Hubbard procedure to introduce the pair—eld , we can construct a GL functional. Throughout this paper, we neglect the internal gauge uctuation and exam ine the resulting GL model in type II limit. The validity of this approximation will be explained in discussing the MF phase diagram later.

A . Q uadratic term

The quadratic term of the GL functional is given by




FIG.1: C om parison between H $_{\rm c2}$ (T)-curves for (2 T $_{\rm c0}$) 1 = 0:1 determ ined from a_0 (0) = 0 by neglecting (crossed symbols) and including (solid curve) the impurity-ladder vertex correction. The dashed curve is the line on which a_4 (0) = 0, and h = H =H $_{\rm c}^{\rm orb}$ (0).

Here, the notation $P_p = \frac{R}{(2-p)^2} \frac{H}{(2-p)^2} \frac{d(p_z s)}{2}$ was used. Hereafter, a bracket $P_p = \frac{d^2p_z}{(2-p)^2} \frac{H}{2}$ with subscript means an average over , so that $P_p = \frac{d^2p_z}{(2-p)^2} \frac{H}{2}$. In the impure case, there are also contributions from the impurity-ladder vertex corrections, and \hat{D}_d (2") should be replaced as follows:

where = $(2)^{-1}$, and $\hat{D_s}$ and $\hat{E_d}$ are defined by replacing $\hat{y_p}$ in eq.(7) into 1 and $\hat{w_p}$ respectively. In the dirty $\hat{z_0}$ 1, the impurity-ladder vertex correction expressed by the second term of eq.(8) becomes important, although the SC phase itself in the present d-wave case is simultaneously suppressed. As is shown later, however, the MF-FOT appears only when $\hat{z_0} > 10$, and hence, we focus here on this moderately clean case. In fact, as given in Fig.1, a change in the $\hat{z_0}$ (T)-curve due to the inclusion of the impurity-ladder vertex corrections is extremely small even when $\hat{z_0}$ 0.1. Based on this result, the second term of eq.(8) and any contribution including the impurity-ladder vertex corrections in other terms of GL functional will be neglected hereafter in the text and in Appendices.

W e should note here that, strictly speaking, the eigenstates of the operator \hat{K}_2 in the $d_{x^2-y^2}$ -wave pairing are not the LLs, and that there are nonvanishing o -diagonal matrix elements between LLL and higher LLs with indices of multiples of four. However, in the range of Maki

param eter considered in this paper, the instability line for the N = 4 LL m odes, de ned by $a_4 \, (0) = 0$ in our notation used below , lies far below H $_{\rm c2} \, (T)$ (see the dashed line in F ig.1) , and hence, we can neglect the o -diagonal elements in considering vortex states in N = 0 (and 1). Then, w $_{\rm p}$ in eq.(7) m ay be replaced by 1, and our analysis using the LL basis becomes straightforward. When focusing on a projection $^{\rm c}_{\rm q_2}^{\rm (N)}$ onto the N-th LL of $^{\rm c}_{\rm q_2}$ (r $_{\rm c}$), the corresponding eigenvalue of K $_{\rm c}$ is given by

When the SC transition in the MF approximation is of rst order and occurs within the N-th LL, this MF-FOT line, which is a part of H $_{\rm c2}$ (T), lies in the region where $a_{\rm N}$ (0) > 0, and the quartic and sixth order GL terms have to be considered to determine the H $_{\rm c2}$ (T)-line. A possibility of an instability to an FFLO-like helical vortex solid in the N-th LL may be studied, at least when $j_{\rm RN}$ (0) j 1 (see discussions below

As far as $a_N^{(2)} > 0$, the instability point to an FFLO solid state is determined by $a_N^{(1)} = 0$, and the corresponding transition is of second order.

B.Quartic term

The corresponding analysis for higher order (quartic and 6th-order) terms of the GL functional is more complicated than that for the quadratic one. As already explained, the impurity-ladder vertex corrections will be neglected in the ensuing analysis. Hereafter, it is convenient to work in a xed Landau gauge A = $(0; H \times; 0)$ and to represent the pair-eld in the N-th LL in terms of the corresponding LL orbitals $u_{N,k}$ (r_{2})




FIG. 2: Diagrams expressing the quartic term of the GL functional. The solid line implies the Green's function G, and the impurity (dashed) line carries (2 N (0)) 1 .




FIG. 3: Diagram s expressing the 6th order term of the GL functional.

We will show later (see Fig.5 (a)) that, consistently with the neglect of the second term of eq.(8), the second contribution to eq.(31) arising from \hat{K}_{4bc} is safely negligible compared with the rst \hat{K}_{4a} term in the relatively clean case with 2 T_{c0} > 10 of our interest.




FIG. 4: Results on F_4 $2F_4 = N_{layer}$ $N(0)_H^2(hj^{-(0)}fi)^2]$ calculated under three different conditions and in the pure ($T_{c0} = 1$) limit. In the open-square symbols, the square vortex lattice is assumed with the nonlocal contribution in F_4 included, while the triangular lattice is assumed in both the crossed symbols with the nonlocal contribution and the solid curve with no nonlocal one. Note that T_4 at which $F_4 = 0$ is insensitive to the nonlocal contribution and to the types of lattices.




FIG. 5: Numerical results of the dimensionless coedients (a) $V_4 = V_4$ (fk_j = 0g)= $^{4}_{H}$ and (b) $V_6 = V_6$ (fk_j = 0g)= $^{4}_{H}$ on the H $_{\rm c2}$ -curve at lower temperatures T = 0.5T $_{\rm c0}$. The value (2 T $_{\rm c0}$) 1 = 0.05 was commonly used. In (a), the cross symbols represent the result due only to Fig.2 (a).




FIG. 6: High H and low T region of M F H -T phase diagrams in (a) clean limit ((2 T $_{c0}$) 1 = 0) and (b) the moderately clean case ((2 T $_{c0}$) 1 = 0:05). See the text for further details.

In deriving the MF phase diagram and its impurity dependence, we will use an additional approximation below. Since a nonzero magnetic eld plays the roles of cutting of the low T divergences of coefficients of the higher order GL terms, the orbital depairing electrarising from the gauge invariant gradients $_{\rm j}$ has been incorporated nonperturbatively in the above expressions. Instead, algebraic $k_{\rm ij}$ dependences have arisen in the vertices $V_{\rm m}$ (fkijg) with m = 4 and 6. On the other hand, the Gaussian $k_{\rm ij}$ -dependences in F4 and F6 are direct consequences of restricting the pair-eld into the LLL

subspace and also appear in the fam iliar G L expression with spatially nonlocal higher order term s. That is, the additional k_{ij} dependences in V_m ($fk_{ij}g$) can be seen as spatially nonlocal contributions to the higher order G L term s and a ect the structure of vortex solid. A ctually, in LLL and the case with no param agnetic depairing, this nonlocality in the quartic G L term results in the structural transition between the rhombic and square vortex lattices [20]. However, an energy di erence a ecting the lattice structure is extremely small receting a weak structure dependence of the Abrikosov factors (denoted

as $_{\rm A}$ and $_{\rm A}$ below). For instance, as shown in Fig.4, the nonlocal correction to F'_4 and thus, to T is negligibly small. Therefore, at least as far as the SC transition in the M F approximation at H $_{\rm C2}$ is concerned, such nonlocal corrections are safely negligible. For this reason, the local approximation for the higher order terms will be used hereafter, and V_m (fk_{ij}g) will be replaced by V_m = V_m (fk_{ij} = 0g). Then, the GL functional derived microscopically takes the form

Tem perature variations of the coe cients V $_4$ and V $_6$ calculated along the H $_{\rm c2}$ (T)-curve are shown, respectively, in Fig.5 (a) and (b). To clarify that the contributions of Fig.2 (b) and (c) are safely negligible, V $_4$ in Fig.5 (a) was calculated in terms of (2 T $_{\rm c0}$) 1 = 0.05, the value used in Fig.6 (b) below. The coe cient V $_4$ is negative at lower tem peratures, while V $_6$ is positive over a broad region so that the G L expression (41) with a M F-FOT at H $_{\rm c2}$ (T) is well-de ned.

D.M ean eld Phase diagram

Below, the MF phase diagram will be examined based on the functional, eq.(41). First, let us neglect a possibility of an FFLO-like state and assume a straight vortex solid independent of j as the MF solution. Then, the 1st term in the bracket of eq.(41) is replaced by $_{j}\,a_{0}\,(0)\,j_{-j}\,\mathring{\mathcal{I}}$, and the M F solution is obtained in a standard way. The character of the MF transition at H 22 (T)line changes with increasing eld from the second order one to a discontinuous one at a tem perature T where V4 becomes negative (see Fig. 4 and Fig. 5 (a)), rejecting that the spin depairing is more e ective upon cooling and with increasing H . To obtain M F results in T < T , higher order terms are necessary in the GL expression. According to Fig. 5 (b), the coe cient V 6 is positive over a broad tem perature range, and thus, the expression eq.(41) term inated at the 6th order term will be su cient for our purpose. Further, let us introduce the e ective coe cients $B = V_4$ A of the quartic term and $c = V_6$ A of the 6th order term, respectively, where




FIG.7: Temperature dependences of $\mathbf{a}_0^{(1)}$ and $\mathbf{a}_0^{(2)}$ on H $_{c2}$ (T) and near T_{FFLO} , where $\mathbf{a}_0^{(s)}=a_0^{(s)}=\frac{2}{\mathrm{H}}^s$ (s = 1;2), and the pure limit was assumed. The corresponding curve of $\mathbf{a}_1^{(1)}=a_1^{(1)}=\frac{2}{\mathrm{H}}$ is also shown for a convenience.

where $T_{\rm c2}$ is the MF transition temperature. Thus, the uctuation strength is enhanced with decreasing \tilde{p} jand increasing c and, as expected, is measured at $T_{\rm c2}$ by the inverse of the energy barrier. Hence, if this MF-FOT occurs as a true FOT in real system s, a clear hysteresis is expected in a system with weaker uctuation.

However, in higher elds and lower temperatures where the spin depairing becomes more important, an FFLO-like helical vortex solid within LLL may become more favorable. As far as the width $a_{0;c}$ is su ciently small, the q_z -dependent terms have only to be incorporated in the quadratic terms in ${}^{(0)}_j$. That is, this structural transition line H $_{\rm FFLO}$ (T) between the FFLO-like solid and the straight vortex solid may be discussed within the coe cient a $_0$ (q_z^2). A ctually, according to the calculation

results of V₄ and V₆ in Fig.5, $a_{0;c}$ in Fig.6 is at most of the order of 10 2 . Assuming a helical state with the j-dependence $_{\rm j}^{(0)}$ e^{ig_{\rm g} js} in H > H $_{\rm FFLO}$, a second order structural transition line H $_{\rm FFLO}$ (T) is obtained within LLL according to eq.(13) as the curve $a_0^{(1)}$ (T) = 0 if $a_0^{(2)}$ (T) > 0 there. Numerical results on $a_0^{(1)}$ and $a_0^{(2)}$ are shown in Fig.7. We note that $a_0^{(2)}$ near H $_{\rm C2}$ is always positive along the H $_{\rm FFLO}$ (T)-line and increases upon cooling at a xed eld above H $_{\rm FFLO}$ (T). Further, since the param agnetic depairing e ect is enhanced with increasing eld and decreasing temperature, as the example in Fig.6 shows, a possible H $_{\rm FFLO}$ (T)-curve should decrease upon cooling.

Now, the MF phase diagram sFig.6 following from the GL coe cients derived above and for two di erent im purity strengths ((T_{c0})) ¹-values) will be explained. The used value of param agnetic param eter $_{0}\text{H}_{c2}^{\text{orb}}$ (0)=2 $_{\text{co}}$, corresponding to the M akiparam eter, is 0.8, which leads to the value $T = 0.36T_{c0}$ in the pure $\lim_{n \to \infty} f(x) = 0.36T_{c0}$ in the pure $\lim_{n \to \infty} f(x) = 0.36T_{c0}$ where $H_{c2}^{orb}(0) = 0.56_0 = (2 \quad 0^2)$ is the 2D orbital lim iting eld at T = 0 in pure $\lim_{t\to 0} it$, and $_0 = k_F = 2$ m T_{c0} is the coherence length. The eld values in the gures were normalized by H_{c2}^{orb} (0) (i.e., $h = H = H_{c2}^{orb}$ (0)). The curve H (T) indicated by the cross symbols is de ned by the condition $V_4 = 0$ and m ay not be directly seen in experim ents. In contrast, the portion (open circles) in T < Tof H c2 (T) on which the M F SC transition is discontinuous is experim entally measurable together with (if any) the second order transition line H $_{\rm FFLO}$ (T) (solid curve) to the FFLO vortex solid. In the temperature regions where the MF-FOT does not occur, the higher one of the dashed curves indicated by N = 0 or N = 1 becomes the H_{c2} (T)-line, on which a_0 (0) or a_1 (0) = 0, and the MF transition there is of second order.

It will be important to, in relation to real phase diagrams of related materials, understand how the H_{FFLO} (T) curve and the characteristic tem peratures are a ected by the impurity strength. By comparing Figs.6 (a) and (b) with each other, the region H $_{\rm FFLO}$ (T) < H < H $_{\rm c2}$ (T) is found to be easily lost by a slight increase of im purity strength $(T_{c0})^{-1}$. In contrast, the onset T of the MF-FOT behavior is relatively insensitive to the sam ple purity. Nevertheless, when $(2 T_{c0})^{1}$ goes beyond 0.095 while the value $_{0}$ H $_{c2}^{orb}$ (0)=2 T_{c0} = 0.8 was kept, the MF-FOT region at H $_{\rm c2}$ (T) is also lost, and the MF transition at H $_{\rm c2}$ (T) is continuous at all tem peratures. This result is contrast to other works [6, 12] in which the presence of a MF-FOT was argued under the use of dirty lim it. We nd that, instead, the FOT obtained in the dirty lim it [12] never occurs in T ! 0 lim it when $E_F > 1$ under which the usual dirty $\lim it m$ ay be valid. On the other hand, the results in ref.[6] are derived by completely neglecting the orbital depairing and are not comparable with the present ones. Further, we stress that, in contrast to results given in a previous work [11]

taking account of both the orbital and spin depairing effects, the results in Fig.6 imply that always $T > T_{\rm FFLO}$ in the present quasi 2D case under a perpendicular magnetic eld.

Since, as already mentioned, the width $a_{0;c}$ in Fig.6 is relatively small, the MF+FOT there may be regarded as being weak. However, it does not mean a strong uctuation. A ctually, in systems with a large N (0) in zero eld such as CeCoIn₅, the uctuation strength T=U_{barr} itself becomes extremely small in the low T region of our interest. On the other hand, the magnetization jump value M c at the MF+FOT should be quite small compared with the applied eld in order to justify our neglect of a spatially varying internal magnetic eld. In CeCoIn₅ under an applied eld in the tesla range, this condition is well satis ed [15] (see also Sec.IV).

In T < T_{next} where $a_1(0)$ < $a_0(0)$ (< $a_2(0)$), the H c2 (T) line and hence, the vortex lattice itself just below it are determined by the next lowest (N = 1) LL. According to the $a_1^{(1)}$ (T)-curve in Fig.7, this N = 1 state is not a modulated FFLO-like state but a straight vortex solid. Further, note that T_{next} and T_{FFLO} are close to each other (see Fig.6 (a)). These results imply that, in quasi 2D materials under elds perpendicular to the SC layers, the presence itself of the FFLO-like vortex solid is very subtle even in pure lim it. Thus, a competition between the FFLO-like solid within LLL and a solid within the N = 1 LL has to be examined just above the H_{FFLO} (T) line. Since this is an issue of a transition between vortex lattice structures de ned within the planes perpendicular to the eld, a detailed description of the stable vortex lattices in d-wave pairing cases is required to address this. As already mentioned, however, the nonlocality, at least, of the sixth order GL term a ecting the in-place lattice structure was neglected in this paper. We will postpone a study of structural transitions to higher LL solids in H > H $_{\rm FFLO}$ to our future study.

E.Properties of Helical Vortex Solid

Here, we brie y comment on linear responses and elastic properties in vortex solid phases, primarily in an FFLO-like helical solid with a modulation $_{\rm j}$ ' $_{\rm q_m}$ eign js in LLL with $\rm q_n$ 6 0. To exam ine the electromagnetic linear responses in an ordered vortex lattice phase, we have only to focus on the gradient terms with an external gauge uctuation substituted and to exam ine the G aussian uctuation around a MF solution of $_{\rm j}$. An appropriate form , consistent with the above microscopic analysis, of the gradient energy will be

Hence, the linear responses in the parallel and perpendicular directions can be considered independently.

Further, the fact that the MF value $q_{\rm m}^2$ of $q_{\rm z}^2$ is B $(r_{\rm H}^{\ 2})=A$ $(r_{\rm H}^{\ 2})$ was used. As seen in the sem inal work [5], the same form as above occurs in the case with no orbital depairing in an isotropic 3D system (see eq.(31) in ref.[5]). This familiar result (47) in plies that, in the helical solid state, there is no stationary current even along H and that a supercurrent / a_z can ow in this direction, although the super uid rigidity / B $(r_{\rm H}^{\ 2})$ vanishes with approaching H $_{\rm FFLO}$ (T).

The absence of SC response in x and y directions can be seen, as well as in the ordinary ($q_n=0$) case, most easily within the phase-only approximation [25]. Noting that any term accompanied by the in-plane periodic variation in a vortex lattice disappears after averaging spatially and that the uniform uctuation part of θ_2 is given by r_H^2 (θ_2 s), one nds that the uctuation of θ_2 in the limit of vanishing wave number can be expressed everywhere in A and B as r_H^4 (θ_2 s) a θ_2 , where s is a uniform in-plane displacement of a vortex lattice. A first integrating overs, θ_2 disappears together in the resulting uctuation free energy, in plying no SC response. This

non-SC perpendicular response is a consequence of the establishment of the Josephson relation $a_? = r_H^2$ (2 s) (leading to an electric eld E proportional to a vortex velocity v, i.e., E = v + H) and is quite dierent from the corresponding one in the case w ith no orbital depairing in the ideal isotropic 3D system w hich is a consequence of spontaneous form ation of a direction of the helical m odulation [26].

Next, let us brie y discuss the vortex elastic energy. The shear elastic energy for in-plane shear distortions is obtained, as in the case of straight vortex lattice, from the phase uctuation energy. It was already shown in ref.[22] that the quartic dispersion on the 2D wave vector q? of the massless phase uctuation and hence, the way of identifying the shear elastic mode with the phase uctuation are una ected by any change of the higher order term softhe GL model. No calculation of shearm odulus will not be performed here, and we simply assume, just for qualitative consideration, the resulting shear energy term to be positive de nite. In contrast, som e com m ent will be necessary on the tilt energy which should change through H FFLO (T). For simplicity, we focus on its expression in type II lim it with no internal gauge uctuation [21, 23]. A coording to eq.(47), the tilt energy in type Π lim it takes the form

where $j_{x_z}j = jj_{x_z}j$ $j_{y_z}j$ and the relation [21, 22, 23] $j_{y_z}q = i(q^2r_{H}^2)(q_2 - s_{y_z}q)_z$ between the transverse displacement s^T and the phase uctuation was used. On the other hand, in the straight vortex solid (i.e., in H < H FFLO (T)) where B (r_{H}^2) < 0, the dispersion $k_z^2 (k_z^2 + 4q_m^2)$ in eq.(48) is replaced by $2j_{z}^2 (r_{H}^2)j_{z_z}^2 = A(r_{H}^2)$. Thus, the macroscopic properties in both the vortex solids are qualitatively the same as each other.

However, the tilt rigidity decreases with approaching H $_{\rm FFLO}$ (T). In particular, the $k_z^2 = q_{\rm p}^2$ dependence of the tilt modulus just on H $_{\rm FFLO}$ (T) implies a short-ranged phase coherence of the vortex solid there which is consistent with the vanishing super uid rigidity on H $_{\rm FFLO}$ (T). Because this absence of SC order in the critical vortex solid (i.e., the case just on H $_{\rm FFLO}$ (T)) is due to a softening (or weakening) of an elastic modulus, an enhanced peak e ect due to an increase of the critical current is expected near H $_{\rm FFLO}$ (T), as well as the ordinary one near H $_{\rm c2}$ (T) [27], in realm aterials with random pinning e ects. This conjecture m ay be useful for searching a transition curve to the FFLO—like vortex solid.

III. STUDY OF GENUINE PHASE DIAGRAM

In this section, the real phase diagram of systems described by eq.(41) is studied by including the uctua-

tion e ects. We will focus here on the range H $\,$ (T) < H < H $_{\rm FFLO}$ (T) and hence, rewrite the rst term in the bracket of eq.(41) into $_{\rm j}$ (ao j $_{\rm j}^{(0)}$ j + $_{\rm 0}$ j $_{\rm j}^{(0)}$ $_{\rm j+1}^{(0)}$ j with $_{\rm 0}>0$. Although we have not extended our simulation work to (if any) the range H > H $_{\rm FFLO}$ de ned within the lowest LL, uctuation e ects similar to those in H < H $_{\rm FFLO}$ should be also expected in such higher elds (see below). The partition function we should exam ine is

and the in-plane coordinates r were normalized like $r=r_H$! r. Further, H_0 denotes H_{c2} (0) in the case with no MF-FOT. Since, as mentioned earlier, $a_{0;c}$ measuring the dierence (H_{c2} H_0)= H_0 is small for the Makiparameter value used in this paper, H_0 will not be distinguished from H_{c2} below. Note that, except a numerical factor, j j is identical with U_{barr} =T. The T-dependent parameter j j measures the uctuation strength, while the magnetic eld dependence is assumed only in . Thus, a change of j j can be regarded near H_{c2} as a change only of T in eq.(49) under the same F_{bc} with xed values of a_0 , o, V_4 , and V_6 , if the magnetic eld variable is appropriately rescaled, and a dierence in the anisotropy (i.e., o-value) plays no important role.

A . Theoretical consideration

First, let us explain how an ordinary physical picture on low energy uctuations and their e ect on orderings lead to the absence of a genuine transition at H $_{\rm c2}$. Like in the familiar case [9, 21] with a second order MF transition at H $_{\rm c2}$, let us start from a description deep in the ordered phase. First, since an inclusion of the orbital depairing requires the presence of eld-induced vortices, a low energy excitation in the ordered phase is inevitably an elastic mode of a vortex solid. As already noted in the nal part of Sec.II, it is clear that the form of the elastic energy and the relation between the phase uctuation and the vortex displacement [23] are essentially




FIG. 8: Two candidates of a schem atic H -T phase diagram of bulk type II superconductors with param agnetic depairing in the case with thermal uctuation and with no vortex pinning e ect. The solid curve, the thick dashed curve, and thin dashed one are the melting line H $_{\rm m}$ (T) of vortex solids, the M F +FO T curve on H $_{\rm c2}$ (T), and the ordinary H $_{\rm c2}$ curve of the second order M F transition, respectively. D ashed curves are not genuine transition lines. A possible presence of the structural transition to an FFLO -like vortex solid, neglected here for sim plicity, does not lead to any essential change on H $_{\rm m}$ (T) and H $_{\rm c2}$ (T)

una ected by di erences in the form s of higher order G L term s. Then, it is clear from the previous works [21, 23] that the phase uctuation is marginally relevant even in 3D case, and that the rigidity controlling the quasi long-ranged phase coherence in the vortex solid is the shear modulus.[21] That is, if the vortex solid is melted at H $_{\rm m}$ below H $_{\rm c2}$, we have only short-ranged orders for both the phase and the vortex position in the vortex liquid above H $_{\rm m}$ with no nite shear modulus, and thus, the vortex liquid should be continuously connected with the normal phase above H $_{\rm c2}$ [9, 21]. In this sense, the M F-FOT at H $_{\rm c2}$ should not occur. Further, to understand this from another point of view , let us note that the quasi 2D SC order parameter in the lowest LL has the form [28]

where = x + iy, z = js, $_{i}$ (z) is the complex coordinate perpendicular to H of the i-th vortex, and a Landau gauge was assumed for the external gauge eld. Since the vortex positions are highly disordered above H $_{m}$, the uctuation e ect above H $_{m}$ is essentially described only by the amplitude A (z). However, A (z) depends only on z irrespective of the form of the higher order G L terms. That is, since the amplitude uctuation itself has a reduced dimensionality and is 1D-like in 3D systems [29] even in the present case, the amplitude uctuation will push the vortex lattice freezing eld H $_{m}$ down to a lower eld, and the M F-FOT should not be realized as a true FOT in real 3D systems [30].

Once noting that the q_z^2 -form of the tilt elastic term in $H < H_{\rm FFLO}$ is replaced in $H > H_{\rm FFLO}$ by $(jq_z j - q_i)^2$, the above argument precluding a genuine FOT at $H_{\rm c2}$

can be applied to such higher elds with no modi cation. Note also that the continuous transition at H $_{\rm FFLO}$ is a structural transition between the ordered vortex solids and hence, together with FFLO—like states them selves, will not be lost due to the SC $\,$ uctuation as far as H $_{\rm m}$ > H $_{\rm FFLO}$ (see Sec. IV).

The theoretical discussion given above implies that, as far as H $_{\rm m}~<~{\rm H}_{\rm c2}\text{,}$ a genuine transition at H $_{\rm c2}$ cannot occur. Then, it is at least natural to expect that, following the familiar case in T > T with a second order H_{c2} -transition, H_m < H_{c2} at any nonzero T and hence that, as in Fig.8 (a), a genuine transition at H $_{\rm c2}$ never occurs at any nonzero tem perature. However, caution will be necessary in the present case with a MF-FOT. For instance, a H m de ned in term s of the Lindem ann criterion [23] m ay lie above H_{c2} in a case with weak enough uctuation because any elastic modulus, proportional in the lowest LL to some power of hj j2i, is nonvanishing on approaching H c2 from below . Of course, there will be no possibility that the actual H $_{\mbox{\scriptsize m}}$ lies above H $_{\mbox{\scriptsize c2}}$. Then, one may consider another possible phase diagram Fig.8 (b) realizable for a case with weak enough uctuation, in which, re ecting a reduction of thermal uctuation upon cooling, H_m (T) at low enough tem peratures virtually coincides with H $_{\rm c2}$, and both a large jum p ofm agnetization (re ecting a large condensation energy) and a tiny hysteresis, arising from the vortex lattice melting, will be seen at H_{c2} on the solid curve. An important point is that, even in the scenario Fig.8 (b), a large hysteresis occurring as a consequence of a large jump of magnetization, i.e., a hysteresis at therm alequilibrium resulting directly from the MF-FOT, cannot occur. A coording to the experim ental data [13, 15, 16] in the situation of our interest in this paper corresponding to CeCoIn5 under a eld H kc, the phase diagram of Fig. 8 (a) seems to be always realized. However, it is theoretically valuable to clarify whether Fig.8 (b) may be realized or not in real system s. Results of our num erical simulation, perform ed for exam ining our theoretical argum ents given above, will be reported below.

B. Sim ulation results

In this subsection, we explain our methods and results of M onte C arlo (M C) simulations for the model eq.(49). Our simulation method closely follows that used in the simulations [32, 33] for the familiar G L model with a positive quartic term in place of jin eq.50). On a xed SC layer, the pairell is expanded in terms of the LLL basis functions $_{\rm n}$ (x;y) consistent with a quasiperiodic boundary condition [32] as $_{\rm n}$ $_{\rm n}$ $_{\rm n}$ $_{\rm n}$ (x;y), and the system sizes $L_{\rm n}$ and $L_{\rm p}$ of a rectangular cell satisfy the commensurability with a triangular lattice ground state through the relation $L_{\rm x}=L_{\rm y}=3N_{\rm x}=2N_{\rm y}$ (= $2N_{\rm x}=3N_{\rm y}$) in 2D (layered) case. Note that, as men-

tioned earlier, the ground state in the present case is, due to the neglect of nonlocality in the GL higher order term s, a triangular lattice, although the pairing state assum ed originally is a four-fold d-wave one (see the sentences above eq.(41)). In the layered case, a periodic boundary condition is assumed across the layers. The system sizes we have studied were $(N_x, N_y) = (6, 4)$ and (8, 6) in 2D case and (6, 6) in the layered case. The M arkov chains for c_n are generated by the M etropolis algorithm. For 2D case (layered case), we used 5 10°) MC steps for them alization and another 10 MC steps for further observation in both cases. As in the gures in Sec.II, we have assumed the value 0:8 for $_0 H_{c2}^{\text{orb}}$ (0)=2 T_{c0} . Further, when assuming a N (0) value appropriate to $CeCoIn_5$ [31] and that $T=T_{c0}=0:1$, the j (T) jvalue is estimated to be in the range between 2:0 and 3:0 used in the simulations.

To study uctuation e ects on the M F-FOT, them ean-squared average of the pair-eld hj j²i was calculated. It corresponds to them agnetization when a_0 is them easure, prim arily, of H . Hence, if it shows not a true discontinuous jump but a rounded behavior at H $_{\rm c2}$ broadening with decreasing j j a genuine FOT at H $_{\rm c2}$ is judged to be absent. Further, as a measure of the vortex-positional ordering (vortex-solidication), we have examined the structure factor S (k) dened [29] as the Fourier transform of the correlation function of j (r) j². In the gures, -dependences of these physical quantities are shown. A lthough a change of implies a change of H at a xed T, the vortex density is xed at any simulation.




FIG. 9: Numerical data of -dependence (i.e., H-dependence) of hj \hat{j} i in 2D case, for j j= 2:0 (crossed symbols) and j j= 3:0 (plus symbols). Dashed and solid curves are the corresponding MF results. A coording to eq.(43), the MF transition point corresponds to = 0:75 (1:69) in = 2:0 (3:0). The system size (6,4) was commonly used.




FIG. 10: S (k) data corresponding to the j = 2.0 data in Fig.9 at (a) = 0.75 and (b) 2.0. (c) S (k) at = 2.0 for larger system size (8, 6).

First, let us present and explain 2D simulation results in which = 0. The obtained results (symbols) are shown in Fig.9 and 10. The corresponding MF curves are also drawn for comparison. The feature, that the simulation data lie above the MF curve in $H_m < H < H_{c2}$, is




FIG. 11: Num erical data of hj \hat{j} i in the layered case composed of four layers. The crossed symbols (plus symbols) are results in j j= 2:0 (3:0).

not surprising but presum ably a reection of a dimensionality dependence of the amplitude uctuation (compare with Fig.11 below). It is found in the literature [34] that a sim ilar dim ensionality dependence appears in the magnetization in the case with a positive quartic coe cient. As is clear particularly from the j j = 2 data of Fig.9, the nearly discontinuous jum p of hj j2i at H c2 is rounded due to the uctuation, and thus, no genuine FOT has occurred at H $_{c2}$. W e note that $_{0}$ (T = 0:1T $_{c0}$) ' 50 for the parameter values used here. Hence, if the abscissa in Fig.9 is reexpressed as the reduced eld (H $H_0)=H_0$ even this rounded behavior of hj j^2 i for j j=2 cannot be distinguished from a strictly sharp discontinuity, and the di erence H $_{\text{c2}}$ H $_{\text{m}}$ will not be visible (see Sec.IV). Thus, the presence of a genuine FOT cannot be argued through merely a steep growth of hjj2i in a real system with weak SC uctuation.

Next, let us exam ine whether the melting position coincides or not with the M F transition eld H $_{\rm c2}$ (T). The melting transition is widely believed to be a weak FOT, and this should be found [32] in M onte C arlo simulations as a tiny discontinuity in therm odynam ic quantities. Unfortunately, due primarily to numerical diculties, our

simulation is restricted to too small systems to observe such a discontinuity. For our purpose of determining H $_{\rm m}$, however, it is su cient to nd where the B ragg peaks of the vortex lattice disappear. Figure 10 shows snapshots of the structure factor on j (r $_2$) j when j j= 2.0. No vortex positional ordering is seen at H $_{\rm c2}$. By comparing Fig.10 (a) and (b) with Fig.9, one nds that nearly sharp B ragg peaks appear at H $_{\rm m}$ below H $_{\rm c2}$, while most of the entropy has been lost near H $_{\rm c2}$ above it. The two eld (or temperature) scales, one characterizing the steep growth of hj j²i and another corresponding to the sudden growth of vortex positional ordering, are clearly distinguished.

We have also exam ined the size dependence of S (k) data. By comparing the data in Fig.10 (b) and (c) with each other, it will be clear that the six-fold symmetry of Bragg peaks is more remarkable in the former, i.e., in a smaller size. It means that the solidication is enhanced by the boundary condition in a smaller system. This size dependence will be su cient for justifying our expectation that the vortex solidication (ormelting) occurs below H $_{\rm c2}$.

Next, we report on consequences of an extension of simulation for the layered system composed of four layers to weaker uctuation cases with j j > 3.0 (i.e., at





FIG. 12: Structure factor de ned from the correlation function of j (r) \hat{j} for j j= 3.0 at (a) = 1.65,(b) = 1.25.





FIG. 13: (a) Numerical data, similar to Fig.11, for j j= 35. (b) The history of hj \hat{j} i at = 2.0 and = 2.19 in the H - increase process. Note the strong dependence on M onte C arbo steps of hj \hat{j} i when = 2.19, i.e., in the vicinity of H $_{\rm c2}$.

lower tem peratures). As the numerical data in Fig.13 (a) show, a hysteresis in the vicinity of H c2 suggestive of a genuine FOT appears between two hj j2i curves for j j= 3:5, respectively, in increasing H (corresponding to a heating) and decreasing H (corresponding to a cooling). However, this hysteresis is not due to the vortex lattice freezing or melting included in the scenario of Fig.8 (b) because, as the simulation results in j j 3 have show n, the hysteresis accompanying the m elting is unobservably small (Although the melting eld H m is estimated to lie close to = 2:0 through S (k) data, it is not easy to conclude a separation between H_m and H_{c2} for this case). Further, since, as mentioned below eq.(51), an increase of j (T) j can be regarded as a decrease only of T in the partition function (49) under the same F_{loc} (41), it is difcult to imagine a scenario [30] that the MF result would become exact in a very low but nite T region. A ctually, the hysteresis in Fig.13 (a) is not due to a genuine FOT in therm alequilibrium: The = 2:19 data in Fig.13 (b) show that the system, at least in the vicinity of H c2, has not reached the therm alequilibrium even during the M C steps we could observe.




FIG. 14: (a) hj \hat{f} i Data similar to Fig.13 (a) for the 1D GL model, eq.(53), taken at MC steps 1 10^6 . (b) Data at a = 4.74 showing a recovery of thermal equilibrium after many MC steps.

A ctually, a sim ilar situation occurs, if the uctuation is weak enough, in other systems with a MF-FOT but no true phase transition. To illustrate this statement, we show in Fig.14 results, corresponding to Fig.13, for a familiar 1D GL model with a negative quartic coecient

where $\,$ is a function only of x, and a in this case m ay be regarded as a tem perature variable. This 1D m odel

is used here for comparison because the uctuation in 3D GL model within LLL is expected to be similar to that of the corresponding 1D GL model in zero eld. We chosen the values jw j= 5.0 and f = 4.0, together with the system size composed of 10^2 -sites. Due to a smaller number of degrees of freedom in SC uctuations in this 1D case, a tendency of a full relaxation to the thermal equilibrium (i.e., a disappearance of hysteresis), as F ig 14 (b) shows, manages to be veriled within the practically observable MC steps. In contrast, in the case of quasi 2D systems expressed by eq.(50), it is quite dicult to verify such a full relaxation within practically possible MC steps because of a much larger number of degrees of freedom in a quasi 2D vortex state.

Sum m arizing this subsection, for any j j-value with H $_{\rm m}$ lying below H $_{\rm c2}$, no true FOT occurs at H $_{\rm c2}$, and the phase diagram Fig.8 (a) is justified. For larger j j values when H $_{\rm m}$ m ay not be distinguished from H $_{\rm c2}$, it is practically dicult to verify whether Fig. 8 (b), in place of Fig.8 (a), is realized as a true phase diagram, and a hysteresis can appear in numerical experiments at H $_{\rm c2}$ even without a genuine FOT occurring there.

IV . D ISC U SSIO N

As explained in Introduction, the present work was originally motivated as an extension of the problem of vortex phase diagram to the more general cases with spin (param agnetic) depairing. Since the absence of MF second order transition at H c2 in lower elds is wellestablished, it is unreasonable to expect the MF-FOT at H_{c2} resulting from the Pauli param agnetic depairing in higher elds to truly occur as a genuine FOT. The recent nding of an FOT-like nearly discontinuous crossover at ${\rm H}_{\rm c2}$ in the heavy ferm ion superconductor ${\rm CeCoIn}_5$ in H k c [15, 16] provides us with a good occasion of a detailed com parison between the present theory and real data. Further, recent data in H ? c [13] showing a small hysteresis in heat capacity and suggesting a second order transition between the FFLO-like vortex solid and the ordinary vortex solid will stimulate detailed theoretical studies of vortex phase diagram in the region with param agnetic depairing.

As shown in Sec.II, in quasi 2D systems under elds perpendicular to the layers, a FOT at H $_{\rm c2}$ should naturally occur in T < T at the mean-eld level in clean

enough superconductors with a moderately strong param agnetic depairing, and the onset temperature $T_{FFI,O}$ from which an FFLO-like vortex solid begins to appear lies much below T . The results, that this modulated solid state is rarely seen compared with the apparent FOT at H_{c2} and is easily lost by a small amount of im purities, are consistent with the observations [13] in a heavy ferm ion superconductor $C \in C \circ In_5$ in H k c but seem to be a contrast to the conclusions on phase diagram in previous works [11]. Further, the range of T $(0.2 < T = T_{c0} < 0.36)$ shown in Fig.6 following from the value $_0 \text{H}_{c2}^{\text{orb}}(0) = 2 \text{ T}_{c0} = 0.8 \text{ and sm all (} \text{T}_{c0}\text{)} ^1 \text{-values}$ is comparable with that (T = T_{c0} ' 0:25) in CeCoIn₅ under H k c [13, 15, 16]. When the N (0)-value in CeCoIn₅ in zero eld [31] is used further, we not the nearly discontinuous jum p value of m agnetization at H c2 when T = 50 (m K) to become 20 (G) which is comparable with the estimated value 30 (G) in ref.[15]. Further, the width H (T) of the magnetization jump at H $_{\rm c2}$ will be estimated using the numerical data of Fig.11 as follows. Using the relations $_0$ (T) ' 50 (0:1T_{c0}=T)²⁼³ and (T) / T $^{1=3}$, suggested in Sec.III, and assuming $j (T = 0.1T_{c0})j = 2.0$, the data in Fig.11 im ply H (T = $0.1T_{c0}$) ' 0.1(T) and H (T = $0.025T_{c0}$) ' 0.03(T), which seem to be rather narrower than those of available data [15, 17]. It is not surprising because, even in a genuine FOT, an entropy (or a magnetization) jump is broadened due to an inhom ogeneity in realm aterials.

As shown and mentioned in Sec.III, the absence of a true FOT at H_{c2} should be an appropriate interpretation for observations [15, 16] at least in H k c where no m easurable hysteresis was observed although the ordinary magnetic hysteresis related to the peak e ect near H_{c2} [35] m ight appear. On the other hand, observations of a tiny hysteresis were recently reported in speci c heat data [13, 18] and also in magnetization data [15] of CeCoIn₅ in H ? c. Exam ining m icroscopic aspects in H? cleading to a MF phase diagram is beyond the scope of the present paper and will not be considered here. However, the issue of the genuine phase diagram in Sec.III is more generic and may be applicable to the H? c case in CeCoIn₅. Because the uctuation e ect in H? c is weaker than that in H k c at the same T, the observed hysteresis in refs.[13, 15, 18] can be understood within the present theory arguing the absence of a genuine FOT at H c2, if it has the same origin as a hysteresis in num erical sim ulations at low enough T, shown in Figs.13 and 14, which arises from an incomplete relaxation at long but nite time scales in a system with a strong MF-FOT. In relation to this, we point out that the onset of hysteresis in ref.[13] lies slightly above the tem perature T_{FFLO} at which H_{FFLO} (T) branches from the MF-FOT (i.e., H_{c2} (T)) line. It im plies that the onset of hysteresis has nothing to do with the appearance of the FFLO -like state and thus that there is no physical reason favoring a term ination of som e genuine SC (superconducting) FO T . A Itematively, the observed hysteresis m ight accompany a true magnetic FOT induced by the hj j²i-nucreation at H $_{\rm c2}$ as a consequence of a coupling between the SC and a magnetic order parameters. In relation to this, we point out the observation of a large magnetic hysteresis [17] in H $\, ? \,$ c just below H $_{\rm c2}$ to which the corresponding one was not seen in the vanishing of resistivity (i.e., a SC ordering).

Finally, let us point out that the present theory easily explains why, in elds parallel to the layers, the transition to an FFLO -like phase and the nearly discontinuous crossover at H $_{\rm c2}$ im plying the M F-FOT were measured not in organic materials with larger anisotropy but in a heavy ferm ion material with weaker anisotropy. At least at the MF level, the case with a eld parallel to the layers in more anisotropic materials is subject to a stronger param agnetic depairing and is the best candidate for observing the param agnetic e ects such as the FFLO-like state and the MF-FOT. The organic materials satisfy this requirement, and actually, the upwardly increasing H c2 (T) curve determ ined resistiviely [36] under high elds parallel to the layers is an evidence [37] that the spin depairing is microscopically important without being disturbing by an impurity e ect. However, both the MF-FOT and a transition to an FFLO-like state have not been seen in the organic materials. On the other hand, since such a upward H c2 (T)-curve is not visible in the heavy ferm ion material CeCoIn₅ with a much weaker anisotropy, one might wonder why these crossover and transition arising from the spin depairing have occurred in this material. This puzzling facts are easily resolved by taking account of uctuation e ects exam ined in this paper. Typically, in the organic and cuprate materials [36, 38], the uctuation e ect is much stronger compared with those of $C \in CoIn_5$. Actually, a shorter coherence length tends to result in a larger M akiparam eter and simultaneously to enhance the uctuation even in the parallel eld case [7, 39]. Consequently, as shown in Sec.III, the MF-FOT behavior is rounded and is transmuted into a broad continuous crossover by the SC uctuation, reecting the absence of the true FOT at H c2. Further, a remarkable eld and temperature range of the vortex liquid region in which the resistance is nitemay be created below H c2 (T)-curve even in the parallel eld case [39] where the uctuation e ect is m in im ized. Since the FFLO-like state is limited to a narrow eld range below H_{c2} , and the modulation parallel to the eld does not lead to any ordering in the vortex liquid, the vortex liquid region should mask and erase the FFLO-like phase in a strongly uctuating superconductor. For these reasons, cleaner superconducting materials with weaker uctuation such as CeCoIn5 are the best candidates for exam ining the MF high eld phase diagram in the case with Pauliparam agnetice ects.
