# Short tim e evolved wave functions for solving quantum $m$ any-body problem $s$

#### Abstract

The exact ground state of a strongly interacting quantum $m$ any-body system can be obtained by evolving a trial state with nite overlap with the ground state to in nite im aginary time. In $m$ any cases, since the convergence is exponential, the system converges essentially to the exact ground state in a relatively short time. Thus a short tim e evolved wave function can be an excellent approxim ation to the exact ground state. Such a short tim e evolved wave function can be obtained by factorizing, or splitting, the evolution operator to high order. H ow ever, for the in aginary tim e Schrodinger equation, which contains an irreversible di usion kemel, all coe cients, or tim e steps, $m$ ust be positive. (N egative tim e steps would require evolving the di usion process backw ard in tim e, which is im possible.) H eretofore, only second order factorization schem es can have all positive coe cients, but w ithout further iterations, these cannot be used to evolve the system long enough to be close to the exact ground state. In th is work, we use a new ly discovered fourth order positive factorization schem e which requires know ing both the potential and its gradient. W e show that the resulting fourth orderw ave function alone, w ithout further iterations, gives an excellent description of strongly interacting quantum system s such as liquid ${ }^{4} \mathrm{He}$, com parable to the best variational results in the literature. This suggests that such a fourth order wave function can be used to study the ground state of diverse quantum $m$ any-body system $s$, including B ose $E$ instein condensates and Ferm i system s.

$W$ e consider a quantum system of $N$ particles $w$ ith $m$ ass $m$ described by the $H$ am iltonian:
where $T$ is the kinetic energy operator, $V$ is a sum of pair-w ise potentials $v\left(r_{i j}\right)$ and $=h^{2}=(2 \mathrm{~m})$.

In the coordinate representation $(R ;)=h R j() i=$ $h R$ je ${ }^{H} j$ i, where $R=f r_{1}::: r_{N} g$ denotes the set of all
particle coordinates. If the intial wave function $j i$ is expanded in the set of exact eigenfunctions $f n g$ of the H am iltonian H, then Eq. (3Ti) has the m ore explicit form,

A ssum ing the non-degeneracy of the ground state $\left(E_{n}\right.$ $\mathrm{E}_{0}>0 ; \mathrm{n}(0)$, the above wave function becom es proportional to the exact ground state wave function in the lim it of in nite im aginary tim e. A basic strategy is then to start w ith a good trial wave function and evolve it in im aginary time long enough to dam $p$ out all but the exact ground state wave function.

Since the im aginary tim e evolution cannot be done exactly, one usually develops a short-tim e propagatorby decom posing e ${ }^{\mathrm{H}}=e^{(\mathrm{T}+\mathrm{V})}$ into exactly solvable parts, and further iterate this short tim e propagator to longer tim e. This is essentially the approach of the Diusion M onte C arlo (D M C ) m ethod tions introduces the com plication of branching, which is the hallm ark of Di usion and G reen's Function M onte C arlo m ethods $[\underline{[4]}]$. O ur idea is to develop a short tim e propagator via higher order decom position that can be applied for a su cient long tim e to project out an exœllent approxim ation to the ground state w ithout iteration.
$F$ irst and second order factorization schem es such as

are well known, but w ithout iterations, they cannot be applied at su ciently large value of to get near to the ground state. It is also well known that in the context of sym plectic integrators, the short tim e evolution operator can be factorized to arbitrarily high order in the form [51 $1 \times 12$

w ith coe cients $\mathrm{fa}_{\mathrm{i}} ; \mathrm{b}_{\mathrm{i}} \mathrm{g}$ determ ined by the required order of accuracy. H ow ever, as rst proved by Sheng [1] later by Suzuki [14] (using a m ore geom etric argum ent), beyond second order, any factorization of the form (G)
$m$ ust contain som e negative coe cients in the set fa ${ }_{i} ; \mathrm{b}_{\mathrm{i}} \mathrm{g}$. G oldm an and $K$ aper [][] later proved that any factorization of the form (G) must contain at least one negative coe cient for both operators. This $m$ eans that for decom positions of the form (G), one m ust evolve the system backw ard in tim e for som e interm ediate tim e steps. $T$ his is of little consequence for classical dynam ics, or real time quantum dynam ics, both of which are tim ereversible. For the im aginary tim e Schrodinger equation, whose kinetic energy operator is the tim e-irreversible di usion kemel, this is detrim ental. This is because $e^{a_{i} T} / e^{\left(r^{0} r\right)^{2}=\left(2 a_{i}\right)}$ is the di usion $G$ reen's function. For positve $a_{i}$, this kemel can be sim ulated by $G$ aussian random walks. If $a_{i}$ were negative, the kemel would be unbound and unnorm alizable, w ith no probabilistic based ( $M$ onte C arlo) sim ulations possible. $T$ h is is just a $m$ athem atical restatem ent of the physical fact that di usion is an irreversible process. Positive decom position coe cients are therefore absolutely essentialfor solving any evolution equation having an irreversible com ponent, such as the im aginary tim e Schrodinger equation.

Since both classical and quantum dynam ics are tim ereversible, there is a lack of im petus to search for higher order factorization schem es with only positive coe cients. W hile higher order factorizations of the form ( $\overline{\text { G }})$, w ith negative coe cients, have been studied extensively in the literature $[1010,4121]$, it w as only recently that Suzuki [1] ] and Chin [1] have found some fourth order (but no higher order) allforw ard tim e step decom position schem es. In order to bypass Sheng and Suzuki's proof, one $m$ ust introduce a higher order com $m$ utator $[V$; [T ; V ] in additional to operators $T$ and $V$ used in ( $\overline{(\underline{6})}$ ). In this w ork, we use the fourth order factorization schem e $[1]_{2}^{-1}$ referred to as schem e A:

This schem ew as also found by K oselo $\quad \overline{1} \overline{2} \overline{8} 1$, but his coefcient for the double com $m$ utator term is incorrect by a factor of three too large. For a m ore detailed discussion of positive factorization schem es and forw ard sym plector integrators, see Ref. [1] $\left.{ }^{\prime}\right]$.

To go from state vectors to coordinate wave funckions, we insert com plete sets of coordinate states, 1 =

$T$ he interm ediate coordinates $S$ are also som etim e referred to as \shadow" positions. Each decom position schem e then corresponds to a speci c wave function for the ground state. For instance, the rst-order schem e gives the linear wave function,

now w th $C^{0}=1=(2)$.
In all these wave functions, there is only a single para$m$ ater, the im aginary time, that we can vary. Allelse are $x e d$ by factorization schem es. If the factorization schem e can accurately reproduce the im aginary tim e evolution of the wave function, the resulting energy must fallm onotonically from the initial energy tow ard the exact ground state energy with increasing. To the extent that these $w$ ave function are not the exact im ginary tim e w ave function, the energy $w$ illeventually rise again. T hus for each wave function there is a optim al where it will be \closest" to the exact ground state.

To test the quality of the above wave functions we use them to describe the ground state of a strongly correlated quantum system of $\mathrm{N}{ }^{4} \mathrm{He}$ atom s interacting via a two-body A ziz HFDHE2 potential. [201] At equilibrium, the system is in a liquid state and has a density of ${ }^{3}=0: 365(=2: 556 \mathrm{~A})$. The sim plest description of the ground state is $M \mathrm{dM}$ illan's Jastrow wave function,

w th $\mathrm{b}=12$. W e will us this w ave function as our intialwave function in all our sim ulations.

For all three wave functions, the expectation value of the $H$ am iltonian can be com puted from

$T$ he iterated $w$ ave fiunctions sim ply require $m$ ore integration variables. For exam ple, in the case of the linear and quadratic $w$ ave function, the above can be expressed as

w here $\mathrm{p}\left(\mathrm{R} ; \mathrm{S}_{\mathrm{L}} ; \mathrm{S}_{\mathrm{R}}\right)$ is the probability density function, $E_{L}\left(R ; S_{L} ; S_{R}\right)$ is the local energy, and $S_{L} ; R$ are the respective left (L), right ( R ) auxiliary, or shadow, variables. For the quartic $w$ ave function, the corresponding expressions for the probability density function and energy expectation value are sim ilar but $w$ th the addition of tw o $m$ ore auxiliary shadow variables $S_{\mathrm{L} ; \mathrm{R}}^{0}$.

W e use the $M$ etropolis $M$ onte Carlo algorithm [21] to sample the probability density from a 9 N and 15 N dim ensional con guration space, corresponding to two and four sets of shadow coordinates in the case of linear/quadratic and quartic wave functions respectively. In these com putations, the $M$ etropolis steps are subdivided in two parts. First, one attem pts to m ove real particle coordinates at random inside cubical boxes of side length . Second, analogous attem pts are $m$ ade to $m$ ove shadow coordinates inside cubicalboxes of side length sh. For instance, in the case of the quadratic wave function, we rst attem pted to $m$ ove all the $R$ coordinates, then $m$ ove the shadow coordinates $f S_{L} g$, then $f S_{R} g$. The param eters and sh were adjusted so that the acceptance ratio forboth particle and shadow m oves was nearly 50\% .

In addition to the ground state variational energy, we have also com puted the radial distribution function $g(r)$, and its Fourier transform, the structure factor $S(k)$. $T$ hese quantities are spherical averages and have been com puted for both the realparticles and the shadow coordinates. The radialdistribution function is de ned by

where the angular brackets denote an average $w$ ith respect to $j(R ;) j^{2}$ and is the particle density. The structure factor $S(k)$ is obtained from the average $\frac{1}{N} h \quad k \quad k i$, where $k=P_{j=1}^{N} \exp (i k \quad f)$, a procedure which is only possible on a discrete set ofk values allow ed by the periodic boundary conditions.

A $l l$ sim ulations presented in this work have been done w th $\mathrm{N}=108$ atom s of ${ }^{4} \mathrm{He}$ in a cubic box w th periodic boundary conditions. To enforce periodicity all correlations sm oothly go to zero at a cuto distance, $r_{C}=L=2$,

In $F$ ig. ${ }_{1}^{11}$ '1 we show the equilibrium energy per particle for liquid ${ }^{4} \mathrm{He}$ for various short tim e evolved wave functions as function of the im aginary time param eter. Other results from literature are also indicated for com parison: $M+M S$ is the energy obtained by a shadow wave function having a pure repulsive M dM irlan (M) pseudopotential $\left[\frac{2}{2}\right]$ of th pow er law form for both particles and shadows. [23] $M+A S$ is the energy obtained by a shadow wave function w th an attractive shadow -shadow pseudopotential of scaled A ziz HFD HE 2 potential (AS) form . [2A] O J+AS refers to a shadow wave function $w$ ith an optim ized Jastrow particle-particle pseudopotential (O J) and scaled A ziz H FD HE 2 shadow shadow pseudopotential (AS). [4] GFMC is the G reen's Function M onte Carlo calculations with M cm illan form for im portance and starting function. [4] T he experim ental value is taken from $R$ oach et al [25].

As expected, each of our factorized wave function reaches an energy $m$ inim um $w$ th increasing value of. $T$ he atness and depth of the energy $m$ inim un im prove $m$ arkedly $w$ th the order of the $w$ ave function. The linear wave function has a shallow and narrow m inim um at $=0: 002$ and only im proves upon M dM illan's result ( $=0$ ) by $0: 3 \mathrm{~K}$. Them inim um of the quadratic $w$ ave function is much better at $=0: 006 \mathrm{w}$ th a value of 6:393 K. The quartic wave function's energy m inim um
extends further out to $=0: 015$ attaining $6: 809 \mathrm{~K}$, which is lower than all existing variationalM onte C arlo calculations that we are aw are of. To dem onstrate the necessity of the gradient term, we have also plotted results obtained from $\left[\bar{T}_{1}\right)$ w thout the gradient term in the potential. In the present case, gradient term is responsible for $50 \%$ of the im provem ent from that of the quadratic $w$ ave function.

To give an quantatitive com parison, we sum $m$ arize various ground state equilibrium energies for ${ }^{4} \mathrm{He}$ in Table

In $F$ ig. ${ }_{2}$ we show the equilibrium pair distribution function $g(r)$ for ${ }^{4} \mathrm{He}$ as obtained from the quartic $w$ ave function. This $g(r)$ is com pared $w$ th the respective $g(r)$ obtained from the M + AS shadow wave function and the experim ental one of Svensson et al [2] obtained by neutron di raction at saturated vaporpressure at $T=1: 0 \mathrm{~K}$. It is known $\left.n 4^{2}\right]$ that the $M+A$ S curve di ens from the erxperim ental one because it predicts a dim inished nearestneighbor $m$ axim um and the entire curve is shifted by about 0:1A to larger values of r com pared to the experin ental results. The pair distribution function that we obtained is in exœellent agreem ent w ith the experim ental one.

In F ig. $\overline{1}_{131}^{1}$ we show $\mathrm{S}(\mathrm{k})$ at equilibrium density ${ }^{3}=$ $0: 365$ as obtained from the quartic wave function. T he experim entals ( $k$ ) shown in this gure is the result reported by Svensson et al [2-6]. The overall agreem ent betw een our short-tim e evolved stnucture factor w ith experim ent is excellent except at $s m$ all $k$. This is not unexpected because our im aginary tim e is still rather short for the w ave function to develop the necessary long-range
correlation to produce the linearbehavior $]_{1}$ of $(k)$ observed in bulk ${ }^{4} \mathrm{He}$.

In this w ork, based on recent ndings on forw ard tim e steps decom position schem es, we have im plem ented a fourth order Short-T in eEvolved wave function for describing the ground state of strongly interacting quantum systems. O ur approach is system atic, free of arbitrary param eters, and can be applied to any general quantum $m$ any-body problem. In the case of liquid ${ }^{4} \mathrm{He}$, we have produced ground state energy and structure results better than any existing VMC calculations, but w thout the use of com plicated branching processes as in DMC or GFMC. Since the anti-symm etric require$m$ ent on Ferm ion wave functions can be $m$ ore easily im plem ented on the variationallevel, our quartic w ave functions $m$ ay be of great utility in studying Ferm isystem s.

O ur second order wave function is sim ilar in structure to the class ofshadow w ave functions [2] our w ave function follow s directly from the second order factorization schem e w ithout any particular adjustm ent of pseudopotential or scale fiunctions. O ur use of a positive factorization schem e to produce a much im proved fourth order wave fiunction dem onstrates that there is a system atic way of im proving this class of $w$ ave functions by introducting $m$ ore shadow coordinates. Currently, there is no know $n$ sixth order forw ard factorization schem es, and hence no sixth order Short-T im eEvolved wave function is possible.
