COMPETING STYLES OF STATISTICAL MECHANICS: II. Comparison of Theory and Experiment and Further Illustrations

In the present follow-up article of a previous one [1] we illustrate the use of the Unconventional Statistical Mechanics described and discussed in the latter. This is done via the analysis, resorting to Renyi's approach, of experimental results in the case of so-called "anom alous" lum inescence in nanom etric quantum wells in sem iconductor heterostructures, and the so-called "anom alous" cyclic voltam m etry in fractal-like electrodes in microbatteries. A lso a purely theoretical analysis is done in the cases of an ideal gas and of radiation com paring the conventional and unconventional approaches. In all of these situations it is discussed which is the failure to satisfy F isher's C riteria of E ciency and/or Su ciency thus requiring to resort to the unconventional approach, and what determ ines the value of the infoentropic index in each case, and its dependence on the system characteristics. M oreover, on the basis of the results we obtain, it is conjectured that the infoentropic index may satisfy what we call a law de ning a "path to su ciency".

1. IN TRODUCTION

In a preceding article [1] (heretofore referred to as I) has been presented the construction of a so-called Unconventional Statistical M echanics (USM), that is to say auxiliary forms for use instead of the conventional one { the latter based on the quite general and well established form alism of Boltzm ann and G ibbs { when, as there noticed, the researcher is unable to satisfy F isher's C riteria of E ciency and/or Su ciency in Statistics, namely, a failure in the characterization of the system and its dynamics in what is relevant for the problem in hands. In the present paper we apply the theory to some particular cases, namely two experim ental situations involving systems with fractal-like structures, and an analysis of ideal gases.

We consider in next section measurements of \anom alous" lum inescence in nanom etric quantum wells in sem iconductor heterostructures. In section 3 we describe the case of experim ents of cyclic voltam m etry in m icrobatteries with thin-In fractal electrodes, where it is involved the so-called \anom alous" di usion of charges. In section 4 is presented a study of ideal gases comparing the case when a proper characterization is used and the one when as incom plete characterization is used. In all cases we resort to the use of Renyi statistics [2,3] described in I; as expected the infoentropic index can only be 1 in the rst situation (the criteria of e ciency and su ciency are satis ed), but di erent from 1 in the incom plete description when the criteria of e ciem cy and/or su ciency are faltering. As already noticed in I, the infoentropic index (when di erent from 1) depends on several characteristics of the system and its dynamics, viz. the fractal topography, the type and size of the system's geometry, its equilibrium or nonequilibrium therm odynam ic state, the experim ental protocol, and so on. Furtherm ore, as we shall see below, it appears that the infoentropic index can be related to quantities characterizing the system and its description, through relations which can be considered as indicating a kind of \path to su ciency".

A first the presentation of the versections with the applications, in a last section we add some additional comments and a summary of the results.

2. \ANOM ALOUS" LUM INESCENCE

There exists now adays a large interest on the question of optical properties of quantum wells in semiconductor heterostructures, which have been extensively investigated in the last decades as they have large relevance for the high performance of electronic and optoelectronic devices (see for example R ef. [4]). To deal with these kind of systems, because of the constrained geometry that they present (where phenom ena develop in nanom eter scales) the researcher has to face diculties with the theoretical analysis. A most relevant question to be dealt with is the one related to the interface roughness, usually having a kind of fractal-like structure, that is, it is present a spatially varying con new ent, which leads to energies and wavefunction depending on boundary conditions which need account for spatial correlations. As a consequence the di erent physical properties of these system s appear as, say, \anom alous" when the results are com pared with those that are observed in bulk materials. A particular case is the one of photolum inescence which we brie y describe here. The conventional treatment via the well established Boltzmann-Gibbs formalism has its application in paired because of the spatial correlations resulting from the spatially varying con nement (as noticed above), relevant in the characterization of the system, on which one does not have access to (obviously the interface roughness varies from sample to sample and one does not have any easy possibility to determ ine the topography of the interface). This is then the reason why the criterion of su ciency is not satis ed in this case.

Let us consider a system of carriers (electrons and holes) produced, in the quantum well of a heterostructure, by a laser pulse. They are out of equilibrium and their nonequilibrium m acroscopic state can be described in terms of an inform ational-based statistical therm odynam ics [5]. It is characterized by the time evolving quantities energy and density or alternatively by the intensive nonequilibrium variables (Lagrange multipliers in the variational approach to statistical mechanics) quasitem perature T_c (t) and quasi-chem ical potentials $_e$ (t) and $_h$ (t) (e for electrons and h for holes) [6]. E lectrons and holes do recombine producing a lum inescence spectrum which, we recall, is theoretically expressed as

where f^e and f^h are the populations of electrons and of holes, $\} = \}! E_G$; with ! being the frequency of the em itted photon and E_G the energy gap, and the $e^{(h)}_{nk_2}$ are the electron (hole) individual energy levels in the quantum well (index n for the discrete levels and k_2 for the free m ovem ent in the x y plane).

The textbook expression for the energy levels corresponding to the use of

perfectly sm ooth bidim entional boundaries is given by

where L_{QW} is the quantum -well width and $m_{e(h)}$ is the elective mass and the populations f take a form that resembles instantaneous in time Ferm i-D irac distributions [5,6]. Using this expression in the calculation of I of Eq. (1) and com paring it with the experim ental results [7] one nds a disagreem ent, and then it is used the name of \anom alous" lum inescence for these experimental results. This is a consequence that we are using an improper description of the carriers' energy levels { we are not satisfying the criterion of su ciency (as discussed in I) {, resulting of ignoring the roughness of the boundaries (with self-a ne fractal structure [8]) which needs be taken into account in these nanom etric-scale geom etries, and then the boundary conditions to be placed on the wavefunctions are space dependent. Hence complicated space correlations are to be introduced, but to which we do not have access (inform ation), as already noticed. Hence, this limitation on the part of the researcher breaks the su ciency criterion, and application of the Boltzm ann-G ibbs-Shannon-Jaynes construction is impaired. As noticed in the preceding article, one can try to circum vent the di culty (which, we stress once again, resides in the limitations the researcher has to possess a proper characterization of the system and its dynamics, and not in Boltzmann-Gibbs statistics) introducing unconventional statistics based on parameter-dependent structural inform ational entropies.

To deal with the \anomalous" lum inescence in nanom etric quantum wells in sem iconductor heterostructures, we have used the unconventional statistics that is derived from R enyi structural entropy, which depends on a single parameter, namely, the infoentropic index (see I). Taking as basic variables, for describing the nonequilibrium therm odynamic state of the \hot" carrier system, the energy E_c (t) and electron and hole particle number (or density), N_e (t) and N_h (t) [6] (the therm odynam ically conjugated intensive variables are the quasitem perature T_c (t) and quasi-chem ical potentials $_e$ (t) and $_e$ (t)), and using R enyi informational entropy, as shown in I [cf. Eq.(I-42)], we do have for the carriers' populations, to be used in Eq. (1), that

Here B and are modied form s of the Lagrange multipliers associated to the basic variables energy and particle number (see I). The rst, B, plays the role of

a reciprocal of a pseudotem perature, and of a quasi-chem ical potential (see I and [6]). Using these populations in the nondegenerate limit (cf. Eq. (53) in I), which depend on $\frac{e(h)}{nk_2}$, that is, the ideal single-carrier energy level of Eq. (1), the lum inescence spectrum is given by

where $_{eff}$ (t) = $\frac{m_{h}}{M}B^{e}$ (t) + $\frac{m_{e}}{M}B^{h}$ (t), $m_{x}^{1} = [m_{e}]^{1} + [m_{h}]^{1}$, and $M = m_{e} + m_{h}$. The second contribution in the last term in Eq. (4) is much smaller than the rst, as veri ed a posteriori, and then we approximately have that

The experiments reported in [7] are time integrated, that is, the spectrum is given by

where t is the resolution time of the spectrum eter. Using Eq. (5) in Eq. (6), and in the spirit of the mean-value theorem of calculus we write

introducing the mean value $_{
m eff}$ (as an open parameter), which we rewrite as

 $_{eff}$ ¹ = k_B , de ning an average, over the resolution time t, e ective tem perature of the nonequilibrium carriers, that is, a measure of their average kinetic energy (see [9]).

In Fig.1 is shown the thing of the experimental data with the theoretical curve as obtained from Eq. (7). It contains the results referring to four samples having dierent values of the quantum well width. The corresponding values of , and the kinetic temperature are given in Table I. The information-entropic index depends, as expected, on the dimensions of the system : as the width of the quantum well increases the values of keep increasing and tending to 1. This is a clear consequence that the fractal-like granulation of the boundary surface

becomes less and less relevant, for in uencing the outcome of the phenomenon, as the width of the quantum well falls outside the nanometer scale, and is approached the situation of a normal bulk sample. On the other hand the kinetic temperature of the carriers is smaller with increasing quantum well width, as also expected once the relaxation processes, mainly as a result of the interaction with the phonon system, become more elective and the cooling down of the hot carriers proceeds more rapidly.

M oreover, we can empirically derive what we term as a law of \path to su - ciency", namely,

where, by best tting, L_1 ' 139 17 L_2 ' 204 24, all values given in Angstrom . We do have here that as L largely increases, the entropic index tends to 1, when one recovers the expressions for the populations in the conventional situation (see I), but as L decreases tends to a nite value $L_1=L_2$, in this case 0:7 0:06: This indicates that the insu ciency of description when using Eq. (2) in the calculations (the ideal energy levels) becomes less and less relevant as the size of the system increases as already commented.

It is relevant to notice that there exists computer-modelled experiments, in which a certain controlled roughness of the quantum -well boundaries is introduced, Schrodinger equation is solved and the corresponding energy levels are obtained [10]. The conventional statistics is applied, and the results, for this m odel, qualitatively agree with the experimental ones in real system s. Furthermore, the results of the computer modelled system, with the su ciency criterion being satis ed, can be reproduced using the ideal eigenvalues of Eq.(2) but in the Renyi statistics we used adjusting the infoentropic index [7]. A nother observation is that experiments in which are present quantum wells with the same width, but obtained with careful and improved methods of growing, show that as smoother and smoother the boundary surfaces the entropic index increases tending to 1, the value corresponding to the ideal situation of perfectly sm ooth surfaces [7]. Moreover, from the experim ental data [7] it can be noticed that the linewidth , in each of the four samples of Fig. 1, appears to depend on tem perature T, for T > 20K, through a power law, say, Τ,with approaching 1 (the conventional result) as the quantum -wellwidth increases, as expected; study of the connection of and the infoentropic index is under way.

As a consequence, it can be noticed that through measurements of lum inescence it is possible to obtain an evaluation of the microroughness of the samples being grown, what implies in a kind of method for quality control. On this we may comment that the interface structural properties in quantum wells (QW's) have been extensively investigated, as they are extremely important for the high performance of electronic and optoelectronic QW -based devices [11{13]. Sem iconductor heterostructures interfaces have been investigated by means of direct or indirect characterization techniques. Direct investigations of the interfacial quality have been obtained, for instance, by scanning tunneling microscopy, atom ic force microscopy, and transmission electron microscopy [14]. However, interfaces are not easily accessible through these direct investigation methods, so optical techniques (which indirectly probe the interfaces) can constitute a useful approach in sem iconductor-interface characterization in heterostructures, as shown above.

This rst illustration of the theory clearly evidences the already stated fact that the infoentropic index is not a universal one for a given system, but it depends on the know ledge of the correct dynam ics, the geom etry and size including the characteristics and in uence of the boundary conditions (e.g. the fractality in the present case), the macroscopic (therm odynam ic) state of the system of equilibrium or nonequilibrium conditions, and the experimental protocol.

The case we presented consisted of experiments in time-integrated optical spectroscopy. The phenomenon of \anomalous" luminescence in nanometric quantum wells in sem iconductor heterostructures, is also present in the case of time-resolved experiments (nanosecond time resolution where the infoentropic index and the (nonequilibrium) kinetic temperature change in time accompanying the irreversible evolution of the system [15]). The use of USM in a completely analogous way as done above (note that Eq. (4) is valid for a time-resolved situation) allows to determ ine the evolution in time of the kinetic temperature (t), and the infoentropic index (t), which is then changing in time as it proceeds the evolution of the irreversible processes in the nonequilibrium therm odynam ic state of the carriers, which is a work under way.

3. \ANOMALOUS" DIFFUSION

As a second illustration we consider the question of behavior of fractal electrodes in m icrobatteries. As a consequence of the now adays large interest associated to the developm ent ofm icrobatteries (see for example R ef. [16]), the study of grow th, annealing, and surface m orphology of thin - Im depositions used in cathodes, has acquired particular relevance. These kind of systems are characterized by m icroroughneessed surface boundaries in a geom etrically constrained region (nanom etric thin $\ln s$), and then fractal characteristics can be expected to greatly in uence the physical properties [8]. In other words the dynam ics or hydrodynam ics involved in the functioning of such devices can be expected to be governed by som e type or other of scaling laws. Such characteristics have been experimentally evidenced and the scaling laws determined. Researchers have resorted to the use of several experimental techniques: atom ic force m icroscopy allows to obtain the detailed topography of the surface { and then measuring the fractality of it {; cyclic voltammetry is an electrochemical technique used for the study of several phenomena, also allowing for the characterization of the fractal characteristics (scaling laws) of the system [17{19]. Particularly, through cyclic voltammetry it can be put into evidence the property of the so-called \anom alous" di usion in these systems, what we consider here.

The di erence of chem ical potential between an anode and a cathode with a thin lm (nanom etric fractal surface) of, say, nickel oxides, produces a movem ent of charges in the electrolyte from the form er to the latter. In a cyclic voltam metry experiment these charges circulate as a result of the application of an electric eld, e (t), with particular characteristics: It keeps increasing linearly in time as $e_0 + vt$, where v is a scanning velocity, during an interval, say t, and next decreases with the same scanning velocity, i.e. $e_0 + vt$ vt, until recovering the value e_0 . A current i (t) is produced in the closed circuit, which following the eld e (t) keeps increasing up to a peak value i_p , and next decreases. This current is the result of the movement of the charges that keep arriving to the thin lm fractal-like cathode.

It is found that there follows a power law relation between the peak value, i_p , of the current and the rate of change, v, of the electric eld, namely i_p v. Such current in the fractal electrode, generated by the application of the external potential, depends on the charges that are brought to the interface. Such density of charges n (x;t) at the interface is the one accumulated as a result of a di usive motion, generated by the di erence of chemical potentials between both electrodes. U sing the standard Fick's law it follows that the power index must be 1=2:0 bærvation shows that it departs from that value and to account for the disparity it has been postulated an \anom alous" di usion law of the type

where when = 1 is recovered the standard result. Such kind of result can be derived using the USM of I, and we resort to the statistics based on Renyi

structural inform ation-entropy, as done in the previous section. The question now is which is the source of the lack of su ciency in the well established Boltzm ann-G ibbs form alism, which forces us to resort to the unconventional approaches. The answer resides in that is being used a quite incomplete hydrodynam ic approach to describe the motion of the uid. Fick's law is an approximation which gives good results under stringent conditions in posed on the movem ent (one being the lim it of very large wavelengths, that is, the movement is characterized by being of smooth variation in space (near uniform), see Appendix A). Motion of the particles (charges) towards the thin Im in the cathode proceeds through the m icroroughneessed fractal region, and then involves a description requiring to consider interm ediate to short wavelengths. Hence, for its description one needs to rem ove the lim itations that restrict the m ovem ent to be purely di usive, that is, to introduce a higher-order generalized hydrodynam ics [21,22] (see also section 4). This means to introduce as basic hydrodynam ic variables not only the density, n (r;t), but its uxes of all order, I_n (r;t) and $I_n^{[r]}$ (r;t), where r 2 indicates the order of the ux and its tensorial rank: see Eqs. (38) to (42) in Section 4. The motion is then determined by a complicated set of equations of evolutions of the type [5,21,23]

where r = 0 for the density, r = 1 for the rst (vectorial) ux, or current, and r 2 for the all higher-order uxes, $J_n^{[r]}$ are the collision operators, and r is the operator indicating to take the divergence of the tensor. Solving this set of coupled equations of evolution is a form idable, alm ost unmanageable, task. As a rule one uses, depending on each experimental situation, a truncation in the set of equations (i.e. they are considered from r = 0 up to a certain value, say n, of the order r). Furtherm one, to build and solve the set of equations with the spatially quite complicated interface boundary conditions is practically not possible (at m ost can be attempted in a computer modelled system). Hence, introducing such truncation produces a failure of the criterion of su ciency when using the conventional, and universal, approach. Consequently, a way to circum vent the problem is, as done in the previous section, to make calculations in terms of unconventional statistical mechanics, what we do resorting to Renyi's approach.

We take a truncated description introducing as basic variables the densities of energy and particles and the rst (vectorial) particle ux, the corresponding dynam ical operators being

The unconventional statistical operator is in this case given by Eq. (I21) using in it the auxiliary (\instantaneous frozen" or quasiequilibrium) statistical operator

where F_n (r;t) and F (r;t) are modi ed Lagrange multipliers that the variational method introduces, = $1=k_B T$ with T being the temperature of the system, and then we are assuming that the material motion does not a ect the therm al equilibrium, and (t) ensures the normalization of the distribution, is a point in phase space and we shall designate by d the element of volume in phase space (taken adim ensional).

The equations of evolution for the basic variables, derived in the context of the kinetic theory based on the Nonequilibrium Statistical Ensemble Formalism (NESEF) [1,5,24] are

that is, the exort probability that the unconventional statistics requires to be used in the calculation of averages values (cf. Eq. (18) in I). To solve the system of Eqs. (16) and (17), we need in Eq. (18) to express the right-hand side in terms of the basic variables. The scattering operator takes in general the form of the kind that is present in the relaxation-time approach, as for example shown in Refs. [23{25], namely

then it has been proved the empirical law, with the power expressed in terms of the infoentropic index ; the latter is then determ ined from the experimental value of , which should be contained in the interval 0:5 < 1, once 1 < 5=3.

In Fig. 2 are shown the experimental results linking the values of the peak current for varying values of the scanning velocity v, from which can be derived the values of for each v, and then those of through Eq. (29). Hence, keeping all other characteristics of the experiment xed, the entropic index is dependent on the experimental protocol, in this case on v. From Fig. 2 and Eq. (25), it can be derived (similarly to what was done in the previous section) a \path to su ciency", given in this case by

where, by best tting, v_1 ' 235 20 and v_2 ' 145 15, in mV=s: As we can see, as v largely increases goes to 1 { when one recovers the conventional result, that is, the standard Fick's law, indicating that the Criterion of Su ciency in the conventional Boltzm ann-G ibbs form alism is satisfactorily veri ed { while for sm all values of v, tends to the lower bound value $v_1=v_2$ (' 1:6 0:15 in the experiment considered above). We can interpret this as a consequence that a large rate of change of the electric eld leads to a very rapid transit of the charge through the roughened layer at the boundary giving no time for the m ovem ent tending to get adapted to the m orphology of the thin Im boundary.

In the present type of experiments in electrochemistry we can derive the same conclusion as the one of the previous section in the experiments in semiconductor physics: the infoentropic index is not an universal one for a given system but depends on the correct dynamics, geometry and size as well as the characteristics and in uence of the boundary conditions, the macroscopic (therm odynamic) state of the system, and the experimental protocol.

Two other interesting problems belong to this question of an \anom alous" di usion-advection in polym er solutions and \anom alous" current in ionic-conducting glasses [28]. In the rst case, m acrom olecules under ow, one faces the di culty in the description resulting from the self-sim ilarity in a type of average fractal structure (w hat we have called \Jackson Pollock E ect", in view of the anology with his painting with the dripping m ethod, leading to fractal structures [29]). W ithout entering into details, given elsewhere [28], the \anom alous" di usion-advection equation has the form

In the second case, ionic-conducting glasses, the di culty in dealing with them consists into the presence of long-range correlations in space, mediated by C oulom b interaction, having scaling characteristics. It leads to the so-called C urievon Schwaitler current

that is, following a power law in time. Again, resorting to USM (in Renyi approach) while ignoring the scaling characteristic, we arrive at such power law, with power related to the infoentropic index by the expression

4. ID EAL GAS IN INSUFFICIENT DESCRIPTION

As additional illustrations we consider, rst, an ideal gas of N particles in a volum e V, but in the therm odynam ic lim it and we call r_j and p_j the position and velocity of the j-th particle, with $\hat{H}() = p_j^2 = 2m$ being the H am illustration in . The most general description of this system in any circum stances is in terms of all the observables of the system, that is from the know ledge of the single-particle dynam ical function [5], which in classical mechanics is given by

Hence, if we want to analyze an experiment where these s uxes are accessible, calculating expected values and response function depending on them, we should introduce USM .We proceed next to analyze such

In section 3 we have applied these results, for s = 1, to derive an \anom abus" di usion equation (for thing the experimental data) in voltammetry measurements in microbatteries with fractal electrodes, and in continuation we present an additional application consisting in a study of hydrodynamic properties of an ideal gas of photons in black-body radiation, extending these results to deal now with a quantum system.

5. RADIATION IN INSUFFICIENT DESCRIPTION

Let us consider an ideal gas of photons in the presence of an uniform ux of energy (generated, for example, having di erent temperatures at both ends of the container). We look for the determ ination of the energy, what is done, on the one side using the conventional approach in a description that includes the energy and the energy ux as basic variables and, on the other side, using a quite incom plete description which includes only energy, but dealt with in USM . We indicated by $!_k = c k$ the photon frequency-dispersion relation, and by $a_k a_k^y$ the annihilation (creation) operators in states jki. The energy and ux of energy dynam ical operators are given by

It can be noticed that C¹ a $_{\circ}^{4}c^{2}$ is something like the square of a ux of energy composed of the energy density of the radiation, a $_{\circ}^{4}$, traversing at the speed of light, while we should expect I to be composed of something like the density of energy traversing at a speed determ ined by the gradient of tem perature, and then, in fact, we do have that for the ideal gas of photons (black-body radiation) works quite wellm eaning that the insu ciency of characterization can be ignored.

6. ID EAL GAS IN A FINITE BOX

W e consider in this section other observation concerning the ideal gas, namely, that as a rule work in the therm odynam ic lim it is usually taken, what im plies an in nite

volume, but real systems are nite [30]. Then in the case of an ideal quantum gas in a nite box of volume V and area A, summation over the states k $[h_x (=L_x);n_y (=L_y);n_z (=L_z)]$ (where $n_x;n_y;n_z$ are 1;2, etc. and $L_x;L_y;L_z$ are the size of the sides of the box) can be exactly replaced by an integral only in the therm odynamic limit. O therw ise we do have corrections depending on the area of the surface, and in the calculation of the partition function, internal energy, etc., there appears nonextensive term s.

A coording to Pathria's textbook $[\beta 1]$, and see also $[\beta 2]$, the density of states of the ideal gas in the nite box is given by

Using USM in Renyi's approach, in the insu cient condition, namely, using the therm odynam ic limit (in nite-size box), that is using in the calculations the escort probability [cf. Eq. (19)] in terms of the auxiliary Renyi's heterotypical distribution

where, evidently, in the therm odynam ic lim it approaches 1 as it should. Moreover, from Eq. (88) we can clearly see that the infoentropic index depends on the system dynam ics, its geometry and size, and the therm odynam ic state.

Further applications of USM are available in the literature on the subject, and we can mention the interesting cases of its use on dealing with hydrodynamic turbulence and collider physics in [33] and [34] respectively.

7.FINAL REM ARKS

We have illustrated in this paper the use of what we have called Unconventional Statistical Mechanics, an auxiliary form alism which can provide a theoretical approach to situations when the conventional, and wellestablished Boltzm ann-Gibbs statistical mechanics has its use in paired because of a lack of a proper know ledge (for the problem in hands) of the characterization of the system and its dynamics on the part of the researcher (the Fisher's criterion of su ciency is not satis ed as discussed in [1]).

We have here dealt with \anomalous" luminescence from quantum wells in sem iconductor heterostructures, where the failure of su ciency resides at a microscopic level, in that one does not know the proper quantum mechanical states in the thin (nanometric scale) quantum well. This is the result that we cannot precisely solve Schrodinger equation for the carriers because a failure to impose boundary conditions on the fractal-like morphological structure of the boundaries, to which we do not have easy access; evidently the wave function is largely a ected by the roughness of the frontiers in the nanometric structure. As shown, as the width of the quantum well increases, the \anomaly" tends to disappear. This is an example in the realm of sem iconductor physics.

A second illustration, the one in section 3, is in the area of electro-physicochem istry, namely the behavior of thin electrodes with a fractal-like morphology in microbatteries. An analysis of experiments of the so-called cyclic voltammetry has been performed, whose results are a consequence of the occurrence of an \anomalous" di usion of charges from the electrolyte. In this case the failure of su ciency resides at a macroscopic, or, better to say, mesoscopic level, when classical O nsagerian hydrodynamics is used instead of the higher-order hydrodynamics that the problem requires. As described the \anomaly" depends on the experimental protocol, and tends to disappear as the rate of charge transfer is increased.

The third illustration, see section 4, is a purely theoretical analysis concerning \anom alous" statistics of an ideal gas. As shown, once the ideal gas is perfectly and completely characterized in terms of the one-particle density function (D irac-Landau-W igner single-particle dynamical operator in the quantum case), the only possible description is the conventional one. But, if instead we work with truncated sets of linear combinations of the one-particle density, viz. the densities of particles and energy and the set of their uxes up to a certain order, in a partial generalized grand-canonical description (and then we do have insu ciency of description), to overcome the fact that we are not complying with the criterion of su ciency (i.e. to calculate properties) unconventional statistics can be introduced, at the price of having undeterm ined parameter(s). In term s of them one obtains \anom alous" hydrodynam ic laws, for example, in the lowest order approximation, \anomalous" di usion, with a power law, in the subsequent order an \anom alous" M axwell-C attaneo equation (dam ped waves), and so on. As the order used in the higher-order hydrodynam ics increases the \anom aly" tends to disappear because one is approaching a description equivalent to the one in term s of the single-particle density matrix.

It can be noticed that we have always written the word anom alous within quotation marks: This is so because there is nothing anom alous in the physical laws governing the system : what is \anom alous" is the result obtained using the unconventional approach when, as noticed, we are unable to comply with the criterion of su ciency in the use of the proper Boltzm ann-G ibbs statistics. Moreover, concerning the, what we have called, \path to su ciency" evidenced in the three cases we presented, it is tempting to conjecture that it may be a general characteristic of unconventional statistical mechanics, in any of the cases when di erent infoentropic-index-dependent structured inform ational entropies are used.

F inally, we add a couple of comments concerning other possible situations that can be analyzed in terms of USM, and its connection with the criteria of e ciency and su ciency.

Application of a USM resorting to Havrda-Charvat structural infoentropy to the question of the evolution of a nonequilibrium temperature-like variable, say T (t), in the case of a system with long-range spatial correlations [35] shows that in the approach to equilibrium is present a long and near-stationary plateaux above the reservoir temperature which is to be attained in the long range once naltherm al equilibrium follows. The calculations are not related (com pared) to experim ental results, and so we do not know if they have any meaning, except to leave a suggestion of theoretical results in search of an experiment. If the experin ent shall show in fact that there are di erences in relation to the conventional calculation (\anom alous" results) one should look where F isher's criteria of e ciency and su ciency is not satis ed (if it is the case, as already noticed should be related to in proper handling of the long-range correlations; see below the case of the one-electron transistor). There exists a situation in the physics of sem iconductors where is also present a near stationary state in the way to equilibrium associated to a slowing-down of the relaxation processes. In the case of the out of equilibrium photoin jected double plasma in sem iconductors (see for example Chapter 6 in [5]) what is called the carriers' quasitem perature T (t) follows a path to equilibrium which strongly depends on the experim ental protocol [36]. Therm al equilibrium with the reservoir follows very rapidly (tens to a hundred picoseconds) when the exciting laser pulse is short (pico-to subpico-second scale), but is slow and presenting a long near plateaux when the exciting lase pulse is long (tens of picesconds duration). Such behavior in the latter case is not properly described by theory in the conventional form alism but could, we think, as in [35] be obtained resorting to USM with an appropriate adjustment of the infoentropic index involved in, for example, H avrda-C harvat or R enviapproaches. The original failure in this case consisted that in the treatment that was applied one does not comply with the criterion of su ciency by not considering the facts responsible for the phenom enon to occur, namely, \phonon bottleneck" and am bipolar di usion (the latter keeps decreasing the density of particles), which once incorporated in the description produces an excellent agreement of (conventional) theory and experiment, and we have su ciency at work [36].

A nother interesting case to be considered is the one of single-electron transistors [37], when long-range and strong (because not screened) C oulom b interaction leads to di culties when dealt with in a simple way in the conventional approach. A gain, the point is a failure of su ciency: in this case is the proper characterization of the states of the system as a result of long-range interconnected correlations. W hen renorm alization of the carrier states is introduced, su ciency is restored and there follows an excellent agreem ent between (conventional) theory and experimental data [37]. We conjecture that instead of application of the renorm alization group for, as said, restore su ciency (i.e. a good m in ical description of the carriers' states), one could use the unrenorm alized description in term s of USM (a point to be considered in the future).

In the last two cases above it is also conjecturable that there m ay be present a kind of \path to su ciency", of the like of those presented in the three other form er exam ples.

In a concluding remark, we can say, in summary, that the illustrations here presented of the application of the theory of the preceding article, allows for gaining a better perspective of USM, which appears as a useful and practical form alism for the macroscopic description of systems when the research cannot comply with criteria of e ciency and/or su ciency in the conventional, well established, and physically and logically sound Boltzm ann-G ibbs theory. Basically it is a sophisticated thing form alism to be used in the referred conditions, namely, when one does not have a proper access to the characteristics of the system that are relevant to determ ine the property of the system we are studying.

It is worth noticing that in the illustrations we presented there appears a quite interesting connection between theory, experiment, and front-line technology.

A specil clicitizer for validity is given in Ref. [38], where it is considered a Brownian-like system composed of two ideal unds in interaction between them. 


