Self-energy-functional approach: A nalytical results and the M ott-H ubbard transition

The self-energy-functional approach proposed recently is applied to the single-band Hubbard m odel at half-lling to study the M ott-H ubbard m etal-insulator transition within the m ost sim ple but non-trivial approximation. This leads to a mean-eld approach which is interesting conceptually: Trial self-energies from a two-site single-in purity Anderson model are used to evaluate an exact and general variational principle. While this restriction of the domain of the functional represents a strong approximation, the approach is still therm odynamically consistent by construction and represents a conceptual in provement of the \linearized D M F T " which has been suggested previously as a handy approach to study the critical regime close to the transition. It turns out that the two-site approximation. For the critical point at T = 0, the entire calculation can be done analytically. This calculation elucidates di erent general aspects of the self-energy-functional theory. Furtherm ore, it is shown how to deal with a number of technical di culties which appear when the self-energy functional is evaluated in practice.

I. IN TRODUCTION

The correlation-driven transition from a param agnetic m etal to a param agnetic insulator (M ott-H ubbard transition^{1,2,3}) is one of the m ost interesting problem s in condensed-m atter physics. As a prime example for a quantum -phase transition, the M ott-H ubbard transition is important from the physical point of view but also for the developm ent and test of general theoretical m ethods to treat correlated electron system s. The m inim um m odel required to study the M ott-H ubbard transition is the single-band H ubbard m odel.^{4,5,6} Inherent to this m odel is the competition between the electrons' kinetic energy which tends to delocalize the electrons and favors a m etallic state and the on-site C oulom b interaction w hich tends to localize the electrons to avoid double occupancies and thereby favors an insulating state at half

lling. Except for the one-dimensional case,⁷ how ever, exact results with regard to the nature of the transition and the critical interaction strength U_c are not available { even for this highly simplified model system. A direct numerical solution using exact-diagonalization or quantum M onte-C arlo methods⁸ su ers from the diffut to access the therm odynam ic limit or the low-temperature, low-energy regimes.

Considerable progress has been made in recent years due to the development of the dynamical mean-eld theory $(DMFT)^{9,10,11}$ which focuses on the opposite limit of in nite spatial dimensions D = 1.^{12,13,14,15} W ithin the DMFT the problem is simplied by mapping the original lattice model onto an impurity model the parameters of which must be determined by a selfconsistency condition. Dierent techniques to solve the e ective impurity model have been employed to study the M ott transition within the DMFT, iterative perturbation theory,^{9,16,17} exact diagonalization,^{18,19,20,21} renormalization-group methods,^{22,23,24} and quantum M onte-C arb.^{25,26,27,28,29} O ne of the most important characteristic of the transition is the value of the critical interaction strength U_c at zero temperature. Roughly, the di erent techniques to solve the m ean- eld equations predict U_c=W 1 1.5 where W is the width of the free density of states.

Recently, a self-energy-functional approach (SFA) has been put forward.³⁰ The SFA is a general variational approach to correlated lattice models where the grand is considered as a functional of the selfpotential . As this functional is constructed from an energy in nite series of renormalized skeleton diagrams, it is not known in an explicit form and the variational prin-[] = 0 cannot be exploited directly. U sually, ciple one replaces the exact but unknown functional with an explicitly known but approximate one { this is essentially the standard diagram matic approach⁷ which leads to weak-coupling approximations in the end.³¹ Opposed to this weak-coupling perturbational approach, the functional dependence [] is not approximated at all in the SFA. The key observation is that the functional, though unknown explicitly, can be evaluated on a restricted domain of trial self-energies S. The evaluation of the functional is exact, while the approximation is due to the fact that the self-energy in the variational principle is no longer considered as arbitrary. In this way, depending on the choice for the space S, som e well-known but also som e novel approximations can be realized. Here we are interested in the single-band Hubbard model with Ham iltonian H. As argued in Ref. 30 a useful trial selfenergy has to be constructed as the exact self-energy of a di erent model (\reference system ") with H am iltonian H⁰. The reference system can be chosen arbitrarily { it. must, how ever, share the same interaction part with the original model H . The variational parameters at one's disposal are therefore the one-particle param eters of the reference system t⁰. The trial self-energy is parameterized as = (t⁰), and the variational principle reads $((t^0)) = 0t^0 = 0$. To provide trial self-energies is the

only purpose of the reference system H 0 . W henever one is able to compute for the reference system H 0 , an exact evaluation of $[(t^{0})]$ is possible.

Choosing H⁰ to be a system of decoupled sites, yields a Hubbard-I-type approximation. An improved approxin ation is obtained when H⁰ consists of decoupled clusters with a nite number of sites $N_c > 1$ per cluster as has been considered in Refs. 32,33. This approach not only recovers the so-called cluster-perturbation theory $(CPT)^{34,35,36}$ but also gives a variational in provem ent (V-CPT) which e.g. allows to describe phases with spontaneously broken symmetry.³³ Another possibility is to take $N_c = 1$, which implies the trial self-energy to be local, but to include a coupling to a number of n_b additional uncorrelated (\bath") sites. In this case the reference system consists of a decoupled set of single-im purity And erson models (SIAM) with $n_s = 1 + n_b$ sites each. As has been shown in Ref. 30, this approach not only recovers the DMFT (namely in the limit n_b ! 1) but also provides a new variant of the exact-diagonalization approach, namely for any nite nb. As compared to previous DMFT-exact-diagonalization approaches,^{18,19,20,21} the construction gives a therm odynam ically consistent approximation even for small nb. More complicated reference system sm ay be taken for the construction of consistent approximations, for example a system of decoupled clusters of size N $_{\rm c}$ where each site in the cluster is coupled to n_b additional bath sites. It has been show n^{32} that in the lim it n_b ! 1 the cellular DMFT (C-DMFT) is obtained,³⁷ while approximations with nite n_b represent cluster approxim ations which \interpolate" between the CPT $(n_b = 0)$ and the C-DMFT $(n_b = 1)$.

In the present paper the M ott transition is studied within the most simple but non-trivial approximation: The variational principle [] = 0 is exploited using a local trial self-energy from a reference system with N_c = 1 and a single additional bath site only, n_b = 1. As n_s = 1 + n_b = 2 this approximation will be referred to as the two-site dynamical in purity approximation (n_s = 2-DIA) in the following.

The paper is organized as follows: A brief review of the self-energy-functional approach will be given in the next section II. The general aspects of the evaluation of the SFA are discussed in Sec. III while Sec. IV focuses on local approximations ($N_c = 1$, n_s arbitrary) in particular. In Sec.V the further specialization to the case $n_s = 2$ is considered. The $n_s = 2$ dynam ical-im purity approxin ation is motivated (i) by the fact that at the critical point for the M ott transition the entire calculation can be done analytically, (ii) by the conceptual sim plicity of the approach which rests on a single approximation only and (iii) by making contact with a linearized DMFT (L-DMFT)^{38,39,40,41,42,43} developed previously. This is discussed in detail in Sec.V while Sec.VI then presents the analytical calculation for the critical regime. The results are discussed in Sec.VII. The complete phase diagram for T = 0 and nite temperatures is addressed in Sec. V III and the conclusions are given in Sec. IX .

II. SELF-ENERGY-FUNCTIONAL THEORY

Useful information on correlated electron systems can be gained by exact-diagonalization or quantum M onte-Carlomethods applied to a lattice of nite size.⁸ This approach, however, su ers from the diculty to access the therm odynam ic lim it and is therefore of lim ited use to describe phases with long-order and phase transitions. On the other hand, using an embedding approximation, one can directly work in the therm odynam ic lim it and describe phase transitions while the actual num erical treatment has to be done a system of nite size only. In the context of an embedding technique we have to distinguish between the original model of in nite size H and an (e.g. spatially) truncated reference system H⁰. The reference system must not necessarily be nite but it may consist of an in nite number of decoupled subsystems with a nite num ber of degrees of freedom each. In any case, H $^{\rm 0}$ must be exactly solvable.

If one is interested not only in the equilibrium therm odynam ics but also in the elementary one-particle excitations, an embedding technique should focus on a dynam icalquantity, such as the frequency-dependent self-energy

. The know ledge of then allow s to derive a therm odynam ic potential as well as di erent static and dynam ic quantities via general relations. The main steps are the following: (i) Truncate the original model H to obtain a sim pler model H⁰ which is tractable numerically. (ii) C alculate the self-energy ⁰ of the reference system . (iii) U se = ⁰ as an approximation for the self-energy of H and determ ine the grand potential as well as further quantities of interest. (iv) To get a self-consistent scheme, optimize the parameters of H⁰ by a feedback from the approximate solution at hand. Ideally, the last step should be based on a general variational principle. This is exactly the strategy of the self-energy-functional approach (SFA) proposed recently.³⁰ A brief review of the essentials of this approach is given in the following.

Consider a system of fermions on an in nite lattice with on-site Coulom b interaction at temperature T and chemical potential . Its Hamiltonian H = H₀(t) + H₁(U) consists of a one-particle part which depends on a set of hopping parameters t and an interaction part with Coulom b-interaction parameters U:

The grand potential can be obtained from the stationary point of a self-energy functional

as has been discussed in Ref. 30. Here the subscript t indicates the parametric dependence of the functional on the hopping. This dependence is exclusively due to G₀ = 1=(! + t), the free G reen's function of H. Further, F [] is the Legendre transform of the Luttinger-W and functional [G]. As the latter is constructed as




FIG.1: Schematic representation of the single-band Hubbard model H (a) and a possible reference system H 0 (b). H 0 is a set of decoupled single-in purity Anderson models with one correlated (U > 0) in purity site and a number of $n_{\rm s}$ 1 uncorrelated (U = 0) bath sites each. In the gure $n_{\rm s}$ = 4. Note that the interaction part is the same for (a) and (b). Variational parameters are the one-particle parameters of H 0 .

an in nite series of renorm alized skeleton diagram s,⁷ the self-energy functional is not known explicitely. Nevertheless, the exact evaluation of $t_{\rm t}$ [] and the determ ination of the stationary point is possible³⁰ on a restricted space S of trial self-energies (t⁰) 2 S. Due to this restriction the procedure becomes an approximation.

G enerally, the space S consists of t^0 representable selfenergies. is term ed t^0 representable if there are hopping parameters t^0 such that = (t^0) is the exact self-energy of the model H⁰ = H₀ (t^0) + H₁ (U) (\reference system "). N ote that both the original system H and the reference system H⁰ must share the same e interaction part. For any

param eterized as (t^0) we then have:³⁰

where ${}^{0}(t^{0}), G_{0}^{0} = G_{0}(t^{0}) = 1 = (! + 1)$ t⁰), and (t⁰) are the grand potential, the free G reen's function and the self-energy of the reference system H 0 while G $_{0}$ is the free G reen's function of H . For a proper choice of t⁰, a (num erically) exact com putation of these quantities is possible. Hence, the self-energy functional (3) can be evaluated exactly for this = (t^0) . A certain approximation is characterized by a choice for S.As is param eterized by t⁰, this means to specify a space of variational param eters t⁰. Any choice will lead by construction to a non-perturbative approach which is therm odynam ically consistent as an explicit expression for a therm odynam ical potential is provided. It turns out that a stationary point of the self-energy functional is a saddle point in general. As in di erent standard variationalm ethods, such as in the tim e-dependent density-functional approach,44 in the G reen's-function approach³¹ and also in a recently considered variant, 4^{5} this implies that there is no strict upper bound for the grand potential. For a further discussion of the general concepts of the SFA see Ref. 30.

So far the discussion is completely general. In Sec. IV we will consider H to be the Hubbard model and H 0 to be a system of decoupled single-impurity Anderson models (SIAM). Each SIAM consists of $n_{\rm s}$ sites, one

correlated site (with U > 0) and n_s 1 uncorrelated \bath" sites (U = 0). This is illustrated by Fig. 1 for $n_s = 4$. Note that for any choice of n_s , the original system and the reference system share the same interaction part { as required by the general theory. The one-particle param eters of H⁰ are the variational param eters, i.e. the one-particle energies of the original sites and the bath sites and the hopping (\hybridization") between them. As noted in Ref. 30, the dynam ical mean-eld theory (DMFT) is recovered in the limit $n_s \ ! \ 1$. For $n_s < 1$ one obtains a new variant of the DMFT-exactdiagonalization approach.^{18,19,20,21} For a nite number of bath sites, the DMFT self-consistency condition cannot be strictly satis ed. In the DMFT-ED method one therefore has to introduce a certain measure which allows to minimize the error due to the discretization of the bath. The conceptual advantage of the SFA consists in the fact that this measure is replaced by a variational procedure which is based on a physical variational principle. As shown in Ref. 30, a very good quantitative agreem ent with results from full DMFT calculations can be achieved for the quasi-particle weight even with $n_s = 4$. W ith $n_s = 2$ a much simpler approach is considered here (Secs. V and VI) which, however, is still therm odynam ically consistent and allows for simple and system atic investigations of the M ott transition.

III. EVALUATION OF THE SELF-ENERGY FUNCTIONAL

The evaluation of the self-energy-functional theory can be done by solving the Euler equation³⁰ corresponding to the variational principle. W hile such an approach is possible in principle, it appears complicated as dynam ical two-particle quantities of the reference system are required. An attractive alternative consists in the direct calculation of the grand potential along Eq. (3). The num erical computation of $t[(t^0)]$ for a given set of one-particle param eters t⁰ is straightforward for a reference system H⁰ of nite size. There are, however, a few technical di culties which appear in the practical calculation and which shall be discussed in the following. The problem of nding a stationary point of the function t⁰! t_{t} [(t⁰)] is not addressed here as this is a standard num erical problem very similar to the problem of nding a minimum of a real single-valued function of several argum ents.

 $_{\rm t}$ [(t^0)] consists of three parts as given by Eq. (3). The grand potential of the reference system can be calculated as $^0(t^0)$ = T $\ln tr^0 exp((H^0 N^0)=T) = T \ln_m exp((E_m^0 N_m^0)=T)$ from the many-body eigenenergies $E_m^0 N_m^0$ of H $^0 N^0$ where N 0 is the total particle num ber operator. Direct num erical diagonalization or (at T = 0) the Lanczos technique⁴⁶ m ay be used.

Next, the second term on the rhs.ofEq. (3) is discussed. In the following the dependence of on t^0 will

be suppressed for convenience and its dependence on ! is made explicit in the notations. The diagonalization of H 0 N 0 yields (via the Lehm ann representation) the G reen's function G $^0(!)$ and the free G reen's function G $^0(!)$ of the reference system. The self-energy is then obtained from the D yson equation of the reference system (!) = G $^0_0 {}^1(!)$ G $^{01}(!)$. Using the self-energy (!), one obtains the (approximate) G reen's function of the original model via G (!) (G $^1(!)$ (!)) 1 . The remaining task is to calculate Trln (G) for a lattice consisting of a nite number of sites L. The therm odynam ic lim it L ! 1 is performed in the end. Translational symmetry is not necessarily required.

It is important to note that G (!) is causal, i.e. G (! + $i0^+$) = G_R(!) iG_I(!) with G_R(!), G_I(!) Herm itian and G_I(!) positive de nite for any real! (0^+ is a positive in nitesimal). The causality of the G reen's function G (!) is ensured by the causality of (!) and G₀(!), see Appendix A. The latter are causal as these are exact quantities.

Let $!_m$ be the (real, rst-order) poles of G (!). For $! ! !_m$ we have G (!) ! $R_m = (! !_m)$ where due to the causality of G (!) the matrix R_m is positive de – nite. Therefore, the frequency-dependent diagonalization of G (!) = U (!)g (!)U (!)^y with unitary U (!) (for real !) yields a diagonal G reen's function g (!) with elements g_k (!) that are real for real! and have rst-order poles at ! = $!_m$ with positive residues.

As the G reen's function can be written as G (!) = 1=(! + t (!)), the unitary transformation U (!) also diagonalizes the real and symmetric matrix t + (!), i.e.t+ (!) = U (!) (!)U (!)^y and g_k (!) = 1=(! + k(!)). The k(!) are real for real ! and have rstorder poles at ! = n with n being the poles of the self-energy. For ! ! n we have (!) ! $S_n=(! n)$ with positive de nite S_n . Consequently, the residues of k(!) at ! = n are positive.

The trace $\Tr"$ in Eq. (3) consists of a sum T^P over the ferm ionic M atsubara frequencies i! = i(2n + 1) T (n integer) and a trace $\tr"$ with respect to the quantum numbers ; see Eq. (1). The convergence of the frequency sum is ensured by the usual factor exp(i! 0⁺) from the diagram rules. The calculation then proceeds as follows:

In Eq. (4) In denotes the principal branch of the logarithm, f(!) = 1=(exp(!=T) + 1) is the Ferm i function, and C is a contour in the complex ! plane enclosing the rst-order poles of the Ferm i function in counterclockwise direction. In step (a) the transform ation U (!) is performed under the trace. Convergence of the integral for ! ! 1 is ensured by the Ferm i function and by the factor $e^{!0^+}$, respectively. Step (b) results from analytical continuation to real frequencies. In step (c)

 $(1 =) \text{Im } q_k (! + i0^+)$ 0 has been used (see Appendix B). At this point the causality of the G reen's function is essential, as discussed above. In step (d) the Ferm i function is written as a derivative with respect to ! and integration by parts is perform ed. Step (e) uses the results of Appendix C for the derivative of the step function. As the di erent diagonal elem ents of the G reen's function, q_k (!), have the same set of poles and zeros,⁵⁵ the sum over k becom es trivial and yields a factor 2L only where L is the dimension of the hopping matrix, i.e. the number of orbitals. The factor 2 accounts for the two spin directions. The contribution from the poles of the selfenergy (Appendix C) is denoted by R . A part from this correction term, Trln ((G₀(t)¹ (t⁰))¹) turns out to be the grand potential of a system of non-interacting quasi-particles with unit weight and energies given by the poles of G(!) $(G_0^1(!))$ $(!))^{1}$.

Consider now the third term on the rhs. of Eq. (3). A calculation completely analogous to Eq. (4) results in:

Here $!_{m}^{0}$ are the poles of G⁰. Again, the rst term in Eq. (6) is the grand potential of a non-interacting system of ferm ions with one-particle energies given by the

poles of the G reen's function G⁰. The same holds for the second term, but with energies given by the poles of the self-energy. By construction, the self-energy is the same for both, the original system and the reference system. Hence, the same correction term R appears in Eqs. (4) and (6) and cancels out in Eq. (3).

Note that a pole of G (!) at $! = !_m$ with residue $R_m ! 0$ implies a pole of $G^0(!)$ at the same frequency $!_m$ (with residue R_m^0 ! 0). Hence, contributions due to poles with vanishing residues cancel out in Eq. (3). The reason is the following: Suppose that $q_k(!) =$ $R_{k,m} = (! !_m)$ for ! close to $!_m$ with residue $R_{k,m} ! 0$. For the diagonal elements of t + (!) this im plies that $_{k}$ (!) = (1=R $_{k,m}$) (! ! m) near ! m . A zero of $_{k}$ (!) with in nite positive coe cient $1=R_{k,m}$ must be due to (!). Therefore, for the diagonal elements of $t^0 + (!)$ this means that ${}^{0}_{k}(!) = (1=R_{k,m})(!)$. Consequently, $g_k^0(!)$ 1=(! + ${0 \atop k}(!)$ = R_{km} =(! !_m) for ! close to $!_m$ with R_{km} ! 0. The argument also shows that although the residues do not appear in Eqs. (4) and (6) explicitly, one can state that poles with small residues will give a sm all contribution in Eq. (3).

Based on the causality of the respective G reen's functions, an e cient algorithm can be set up to nd $!_{m}$ and $\binom{0}{m}$ num erically which are then needed in Eqs. (4) and (6). The poles of G $^{0}(!)$ are directly obtained from the diagonalization of the reference system . The problem consists in nding the poles of G (!). A llow ing for poles with vanishing (very small) residue, one can assum e the function g_k^0 (!) for xed but arbitrary k to display all the poles of G⁰(!). Since g_k^0 (!) is of the form $g_k^0(!) = \int_m^{0} R_{k,m}^0 = (! !_m^0) \text{ with } R_{k,m}^0 = 0, \text{ it is m ono-}$ tonically decreasing. Hence, there is exactly one zero of g_k^0 (!) located in the interval between two adjacent poles $!_{m}^{0}$ and $!_{m+1}^{0}$. As g_{k}^{0} (!) is monotonous, the zero $_{m}$ can easily be found num erically by an iterative bisection procedure. The zeros of g_k^0 (!) are the poles of 0_k (!) and the poles of 0_k (!) are the same as the poles of ${}_k$ (!). Now, since $g_k(!) = 1 = (! +$ _k (!)), g_k (!) and g⁰_k (!) must have the same set of zeros. The function g_k (!) is m onotonically decreasing. Therefore, the poles of g_k (!) can be found between the m by using the same iterative bisection procedure once again.

$\ensuremath{\operatorname{IV}}$. LOCAL APPROXIMATIONS

In the following we consider H to be the single-band H ubbard m odel:

For the reference system H⁰ shown in Fig. 1, the selfenergy is local: $_{ij}(!) = _{ij}(!)$. Clearly, the approxim ation is the better the more degrees of freedom are included in H⁰. The optimal local approximation is obtained with the most exible (but local) trial self-energy. This is the DM FT which is recovered for an in nite num – ber of uncorrelated bath sites (per original correlated site), i.e. for n_s 1! 1. On the other hand, $n_s = 1$ corresponds to a Hubbard-I-type approximation. Here it will be shown that, for arbitrary n_s , the evaluation of the self-energy functional reduces to a one-dimensional integration only. This is an important simplication for any practical numerical (or even analytical) calculations.

In case that the self-energy is local it is advantageous to start from step (c) in Eq. (4). A ssum ing translational sym metry, them atrix t+ (!) is diagonalized by Fourier transform ation to reciprocal space. Its eigenvalues $_{k}(!)$ are given by $_{k}(!) = (k) + (!)$ where k = (k;) and (k) is the tight-binding B loch dispersion. The self-energy is taken to be spin-independent and independent of the site index, i.e. a param agnetic hom ogeneous phase is assumed for sim plicity. The second term on the rh.s. of Eq. (3) then becomes:

Here L is the number of lattice sites, the factor 2 stems for the spin summation, $_0(z) = L^{1} L_k^{-1}(z = (k))$ is the non-interacting density of states, and $R_0(z) = \frac{R_z}{1} dz^0 _0(z^0)$ is an antiderivative. Note that there is no \correction term " R , as the derivative in Eq. (8) is with respect to z.

The reference system H⁰ is a set of decoupled singleimpurity Anderson models with one correlated (\impurity") size and n_s 1 bath sizes each. The Ham iltonian is H⁰ = $_{i}$ H⁰(i) with

The parameters $_1$, $_k$, and V_k for k = 2; :::; n_s are the on-site energies of the in purity site and of the bath sites, and the hybridization between them, respectively. These are the variational parameters of the theory.

The third term on the r.h.s. of Eq. (3) reads:

is the hybridization function. The nal expressions (8) and (10) involve one-dimensional integrations only and can therefore be calculated numerically without serious problem s.

V. TW O-SITE DYNAM ICAL IM PURITY APPROXIMATION

In the follow ing we will focus on the case $n_{\rm s}=2,$ i.e. on the two-site dynam ical-in purity approximation ($n_{\rm s}=$ 2-D IA). There are dimensions which are followed up:

(i) For any approximation within the context of the SFA, one has to compute the self-energy of the reference system H⁰. As the interaction part is the same for both, H and H⁰, this still constitutes a non-trivialm anybody problem which can only be treated by num erical m eans in m ost cases. The reference system characterized by $N_c = 1$ and $n_s = 2$, represents an exception: For a special point in the space of m odel param eters (zero tem perature, half-lling and $U = U_c$, the critical interaction for the M ott transition), the entire calculation can be done analytically. This not only includes the diagonalization of the reference system which actually is a simple dim er m odel but also and m ore im portant here, the exact evaluation of the self-energy functional for the trial self-energies considered and the subsequent variational optimization. Therefore, the study of the $n_s = 2-D$ IA is ideally suited to elucidate di erent technical points which are relevant for any N $_{\rm c}$ and ${\rm n_s}$ and which must be considered carefully.

(ii) The $n_s = 2$ -D IA must be considered as inferior when compared to approximations with higher n_s and

when compared to $n_s = 1$ (the DMFT) in particular. On the other hand, one has to keep in mind that the DMFT must always be supplemented by an additional (num erical) method to solve the mean-eld equations which necessarily involves additional approximations. Even if the additional approximations can be controlled, DMFT results always depend on the accuracy of the num ericalmethod employed. As concerns the $n_s = 2$ -DIA, there is no such diculty: The theory rests on a single approximation only, namely the restriction of the space S to self-energies representable by the two-site reference system { the rest of the calculation is rigorous. It is this conceptual simplicity which makes the approximation attractive.

(iii) T hat an approach referring to an $n_s = 2$ -site SIAM is able to give reasonable results has been shown beforehand by the linearized DMFT (L-DMFT). 38,39,40,41,42 The L-DMFT is a well-motivated but ad-hoc simpli cation of the full DMFT and m aps the H ubbard m odel selfconsistently onto the $n_s = 2$ -site SIAM just at the criticalpoint for the M ott transition. The L-DMFT can be also be considered to represent the low est-order realization of a more general projective self-consistent method (PSCM).²² A s com pared to the fullDMFT, the linearized theory yields surprisingly good estimates for the critical interaction U_c in the single-band model, on translation invariant lattices³⁸ as well as for lattice geom etries with reduced translational sym m etry.³⁹ T he approach can also be extended beyond the critical regim e.43 The main disadvantage of the L-DMFT is that it not consistently derived from a therm odynam ical potential. A nother intention of the present paper is therefore to suggest a two-site m ethod that conceptually improves upon the L-DMFT in this respect. In fact, as the parameters of the e ective $n_s = 2$ -site impurity model are determined via a physically meaningful variational principle, the two-site approximation within the SFA should be regarded as an optim altwo-site approach. The interesting question is, of course, whether or not this im provem ent of the m ethod also implies improved results. To this end the results from the analytical evaluation of the $n_s = 2-D$ IA have to be compared with those of the L-DMFT and with available num erical results for $n_s = 1$ (full DMFT). This represents a good check of the practicability of the new method. As the $n_s = 2$ -site DIA still represents a very handy method, it can also be employed to investigate overall trends. It will be interesting to study the critical interaction U_c for a variety of di erent geom etries (i.e. for di erent free densities of states).




FIG.2: The grand potential (per site) as calculated from Eq. (3) and Eqs. (8) and (10) for the reference system with $n_s = 2$ as a function of the hybridization strength V (only the di erence (V) (V = 0) is plotted). Calculations for the Hubbard model at zero temperature T = 0 and halflling (= U=2). The free density of states is taken to be sem i-elliptical with a band width W = 4. The interaction strength is varied from U = 5 to U = 6 as indicated. A rrows indicate stationary points of the self-energy functional. The M ott transition takes place at a critical interaction strength $U_c = 5:85$.

Let us rst consider a num erical evaluation of the theory. Fig. 2 shows the results of a num erical calculation along the lines discussed above for the param agnetic phase of the H ubbard m odel at half-lling and zero tem - perature. The free density of states (DOS) $_0$ (z) is taken to be sem i-elliptical with a band width W = 4. The calculations are perform ed using the $n_s = 2$ -D IA, i.e. there is one bath site (per correlated site) only. Due to m anifest particle-hole symmetry, two of the variational pa-

ram eters, the on-site energies, are already xed: $_1 = 0$ and $_2 = = U = 2$. As a function of the remaining variational param eter, the hybridization strength V $V_{k=2}$ the grand potential (V) = [(V)] shows two (nonequivalent) stationary points for U = 5 (see Fig. 2): a minimum at a nite V = 0.37 and a maximum at V = 0 (as (V) = (V), there is another minimum at V = 0.37 which can be ignored here). The two stationary points correspond to two physically di erent phases: For V > 0 the interacting local density of states is nite at ! = 0 while it vanishes for V = 0. So there is a metallic and an insulating phase coexisting. Due to the lower at the respective stationary point, the metallic phase is stable as compared to the insulating one. W ith increasing U the optim alV_{m et} and the energy di erence (0) j decrease. For U = U_c j (V_{met}) 5:85 there is a metal-insulator (Mott-Hubbard) transition which is characterized by a coalescence of the stable m etallic with the metastable insulating phase. For U > U_c there is the insulating phase only.

Q ualitatively, this continuous transition is completely consistent with the preform ed-gap scenario^{11,22} (how - ever, see also Refs. 47,48,49). For U < U_c the self-energy is a two-pole function. This leads to a three-peak structure in the interacting local density of states: Sim ilar as in the full DMFT, there are two Hubbard \bands" separated by an energy of the order of U, and a quasiparticle resonance at ! = 0.0 n approaching the critical interaction U_c from below, the weight z of the resonance vanishes linearly z (U_c U) leaving a nite gap for

 $U > U_{\rm c}$. As shown in Ref. 30 the quasi-particle weight calculated from the self-energy at the respective optim al $V = V_{m \ et}$ is in a very good quantitative agreement with results from full DMFT calculations in the whole range from U = 0 to $U = U_{\rm c}$ { for $n_{\rm s} = 4$ and even for $n_{\rm s} = 2$ which is the case considered here.

VI. \LINEARIZED "DYNAMICAL IM PURITY APPROXIMATION

In the following we will concentrate on the critical regime U ! U_c . It will be shown that the critical interaction strength can be calculated analytically for $n_s = 2$. The independent analytical result can be compared with the numerical one of the preceeding section. This represents a strong test of the numerics.

Consider the function (V) = [(V)]. As (V) = (V) there must be a stationary point of (V) at V = 0 for any U. This implies that the linear term in an expansion around V = 0 is missing, i.e.:

The coe cient A depends on U. A ssum ing that them etal is stable against the insulator for U < U_c, we must have A < 0 for U < U_c and A > 0 for U > U_c. This is a necessary condition for a continuous (\second-order") transition and consistent with the num erical results displayed in Fig.2. Therefore, the critical point for the M ott transition within the two-site m odel is characterized by

The task is to calculate the three contributions to the grand potential following Eq. (3), to expand in V up the the second-order term and to nd the interaction strength satisfying the condition (15).

Consider the grand potential of the reference system rst. W ith $_1 = 0$, $_2 = U=2$ and = U=2 the ground state of the two-site system, Eq. (9), lies is the invariant subspace with total particle num berN $^0 = 2$. The groundstate energy E $_0^0$ is readily calculated:

This implicit analytical equation for U_c is the nalresult. For an arbitrary free DOS no further simplications are possible.

VII. DISCUSSION

It should be stressed once more that Eq. (28) results from an exact variational principle simply by the restriction that the trial self-energies be representable by the two-site reference system. The two-site model generally yields a two-pole self-energy which is the minimal requirement for a three-peak structure of the single-particle excitation spectrum. Therefore, it may also be stated that Eq. (28) gives the optim al result for a two-pole selfenergy.

Eq. (28) turns out to be m ore complicated as compared to the result of the linearized DM FT : 38

For a sem ielliptical free DOS with variance = 1 (band width W = 4), one has $U_c^{(L DMFT)} = 6$ and $U_c^{(BR)} = 6.7906$. The numerical solution of Eq. (28) is straightforward and yields $U_c = 5.8450$. As expected this is fully consistent with the numerical determination of U_c (Sec.V). The result is close to the one predicted by the L-DMFT.C on pared to numerical estimates from




FIG. 3: Critical interaction U_c as a function of the inverse band width W⁻¹. Calculations for di erent (norm alized) free densities of states $_0(z)$ as indicated (where 3 < z < 3 and $0 < _0(z) < 1.5$ in the insets).

full DM FT calculations $U_c^{(DMFT)} = 5.84$ (NRG, Ref. 23) and $U_c^{(DMFT)} = 5.88$ (PSCM, Ref. 22), one can state that the prediction of the L-DMFT is improved.

Results for di erent free densities of states are displayed in Fig. 3 and Tab. I. For a meaningful com – parison each DOS has unit variance = 1 where $2 = \frac{1}{1} dz_0 (z) z^2$. The band width W varies. The DOS with the smallest W (but = 1) consists of two

-peaks while W = 1 for a G aussian DOS.C learly, there is no true M ott transition in the form er case (but also in the latter this is questionable). However, the inclusion of these extrem e cases is instructive when studying the

trend of U $_{\rm c}$ as a function of W . Note that for ~=~1 the L-DMFT yields U $_{\rm c}$ = 6 irrespective of the form of the DOS.

The critical interaction from the two-site DIA is always close the L-DMFT result but considerably lower than the Gutzwiller value. The two-site DIA con m s the central prediction of the L-DMFT that it is the variance of the DOS that is crucial for the critical interaction. How ever, there is also a weak trend superim posed, namely a system atic increase of U, with decreasing band width W (with the exception of the Gaussian DOS). This is the sam e trend that is also present in the G utzw iller results. It would be interesting to see whether or not this trend is con med by full DMFT calculations. Comparing the full D M FT results for the G aussian, for the rectangular and the sem i-elliptic DOS shows the mentioned trend. However, the comparison of the two-site DIA and of the L-DMFT with the full DMFT for the available num erical data is not fully conclusive.

VIII. FINITE TEM PERATURES

So far only the zero-tem perature lim it has been considered. The M ott transition at nite tem peratures, how – ever, is particularly interesting as there is a com prehensive physical picture available with a com paratively com – plex phase diagram. This phase diagram in the U-T plane was rst suggested by the iterative perturbation theory.^{9,11} The nature of the transition and the topology of the phase diagram have been established entirely using analytic argum ents⁴⁹ and has been worked out quantitatively using di erent num erical m ethods.^{24,27,28,29} The critical regim e is accessible by the projective self-consistent m ethod.²²

A sthisphase diagram represents a valuable benchm ark for any approximation, it is interesting to see whether or not it can be rederived within the most simple twosite D IA. The application of the theory for nite T is straightforward but can no longer be done analytically. As for the derivation of the T = 0 results in the noncritical regime (see Sec. V), calculations are performed along the lines of Sec. IV.




FIG. 4: G rand potential per site at U = 5.2 for di erent T as a function of V. The arrows indicate the stationary points.

It turns out that for nite tem peratures the M ott transition is predicted to be discontinuous. This is dem onstrated in Fig. 4 which shows (V) for dierent T and xed U = 5.2 (n_s = 2). At low but nite T there are three stationary points (see arrows) corresponding to three different phases of the system. The m etallic phase has the largest value V = $V_{m et}$. W ith increasing temperature $V_{m et}$ decreases and $(V_{m et}) / T^2$ for low T. This gives a linear entropy S (T) = 0 (T)=0T and a linear specic cheat $C_v = T0S(T)=0T = T / z^1T$ as it is characteristic for a Fermi liquid (= U=2 is xed). The insulating phase has the smallest value V = V_{ins} , and the grand potential (V_{ins}) / T for low T. For T ! 0 the entropy approaches S ! L ln 2 re ecting a 2^{L} -fold ground-state degeneracy of the insulator which is known

to be an artifact of mean-eld theory.¹¹ The speci c heat C_v vanishes exponentially for T ! 0. For U = 5:2 and low T, however, the insulating phase is metastable as compared to the metallic phase since $(V_{ins}) > (V_{met})$. Due to the di erent behavior at low T, there must be a tem perature $T_c(U)$ where $(V_{ins}) = (V_{met})$. In fact, for T = $0.012 > T_c (U = 5.2)$ the insulator is stable as compared to the metal. At $T_c(U)$ or, conversely, at a critical interaction $U_c(T)$, the $n_s = 2-D$ IA thus predicts a rst-order transition with a discontinuous jump in the entropy. As can be seen in Fig. 4, the metallic phase ceases to exist for still higher tem peratures, and only the insulating phase is left. This is due to a coalescence of the metallic with a third phase at another critical tem perature T_{c2} (U) (or, conversely, at a critical interaction U_{c2} (T)). This third phase turns out to be less stable as com pared to the m etal and to the insulator in the entire parameter regime. Similarly, one can de ne a critical tem perature T_{c1} (U) (at sm aller U) and thus a critical interaction U_{c1} (T) where the insulating phase coalesces with the third phase.




FIG.5: Phase diagram for the M ott transition in the paramagnetic phase of the H ubbard m odel at half-lling. C alculations for a sem i-elliptical density of states with band width W = 4. Reference system H⁰: two-site m odel. U_{c2}: critical interaction strength up to which there is a (m etallic) solution sm oothly connected with the m etal at U = 0. U_{c1}: critical interaction strength down to which there is an (insulating) solution sm oothly connected with the M ott insulator for U ! 1 . U_c: rst-order transition line in the coexistence region, term inating at the second-order critical point at T_c.

Calculations for di erent U and T have been perform ed to obtain the entire phase diagram within the two-site approach. The result is shown in Fig. 5. For U U_{c2} (T) there is a metallic phase which is smoothly connected to the U = 0 limit. On the other hand, for U U_{c1} (T) there is an insulating phase which is smoothly connected with the M ott insulator for U ! 1. Metallic and insulating phase are coexisting for U_{c1} (T) U U_{c2} (T). At zero

tem perature, the m etal is stable as compared to the insulator in the entire coexistence region, and the transition is continuous at $U_c = U_{c2}$. For nite tem peratures the transition is discontinuous at a critical interaction U_c (T) with U_{c1} (T) U_c (T) U_{c2} (T). W ith increasing temperatures the coexistence region U_{c1} (T) U_{c2} (T) shrinks and disappears above a critical temperature T_c which is de ned via U_{c1} (T_c) = U_{c2} (T_c). Above T_c the m etallic phase is smoothly connected with the insulating phase.

Q ualitatively, this is exactly the same result that is obtained within the fullDMFT.¹¹ It is very remarkable that the rather complex topology of the phase diagram can be reproduced with a comparatively simple two-site model as a reference system. This shows that it is essential to perform the mapping onto the reference system in a way which is therm odynamically consistent and which is controlled by a physical variational principle. Note that the L-DMFT, or its extension away from the critical point at T = 0,⁴³ fails to reproduce the discontinuous transition for T > 0 and the critical tem perature T_c due to the ad-hoc character of the approximation.

Q uantitatively, one should expect some deviations from the results of the full DM FT due to the sim plicity of the two-site model. C om paring with the NRG result²⁴ for U_{c1} (T = 0) 4.8 5.0, the two-site approximation overestimates the critical interaction by a few per cent. The determination of the critical tem perature is di cult in any num erical approach. T_c 0.05 0.08 is estimated

from the QMC and NRG results of Refs.24,27. Thus, the two-site approximation underestimates $T_{\rm c}$ by more than a factor 2. It is worth mentioning that the numerical effort to obtain the entire phase diagram in the U $\,$ T plane is of the order of a few m inutes on a standard workstation which is negligible as compared to a DMFT-QMC calculation.

IX. CONCLUSIONS

O urpresent understanding of the M ott-H ubbard transition is mainly based on the exact solution of the onedimensional case on the one hand and on the D = 1 m ean-eld picture provided by the DMFT on the other hand. For the physically more relevant two- or threedimensional H ubbard m odel, how ever, neither the analytical concepts developed for D = 1 nor the mean-eld theory can be expected to give an essentially correct and comprehensive description. D irect numerical approaches, such as QMC, are able to give essentially exact results for a D = 2;3 dimensional lattice of nite spatial extent. How ever, the relevance of the results for the therm odynamic limit and, in many cases, for the low-temperature, low-energy regime remains an open question.

In this situation, a combination of a direct num erical approach for systems of nite size with the mean-eld concept appears to be advantageous. This is more or less the direction that is followed up by the di erent cluster extensions of the DMFT.^{37,51,52,53} V ia a generalized mean-eld concept, the original lattice problem given by the Hamiltonian H is mapped onto a cluster problem described by a Ham iltonian H⁰. In fact, due to the presence of strong short-range antiferrom agnetic correlations a considerable revision of the mean-eld picture is probably necessary.⁵⁴ However, the cluster extensions of the DMFT su er from the fact that the mean-eld form ulation requires that the sites of the nite cluster are coupled to uncorrelated baths with an in nite number of degrees of freedom each. This circum stance com plicates the practical solution of the H⁰ problem (which must be solved repeatedly during the self-consistency cycle) so much that additional approximations are required and/or stochastic num ericalm ethods.

The self-energy-functional approach o ers an interesting alternative as the reference system H 0 , the original modelH is mapped onto, is by no means completely predeterm ined. The SFA gives a very general prescription how this mapping can be performed while keeping the therm odynam ical consistency of the approach as an explicit expression for the grand potential is provided. In this way the DM FT and the cellular DM FT are recovered as certain limits for special choices of H 0 , namely for a decoupled system of clusters of size N $_{\rm c}$ = 1 or N $_{\rm c}$ > 1 including couplings to $n_{\rm b}$ = 1 bath degrees of freedom . There is, how ever, the additional possibility to construct approximations with $n_{\rm b}$ < 1 which are consistent in them selves in the same way as are the DM FT and the

Now, the question is whether or not an approximation with a nite number of bath sites $n_{\rm b} < 1$ can be tolerated. Note that even in the (C-)DMFT it becomes necessary to reduce the problem posed by H 0 with $n_{b} = 1$ to a num erically tractable one with a nite num ber of degrees of freedom . W hile this additional approxim ation is controlled within QMC or ED approaches, for example, it nevertheless violates therm odynam ical consistency. W ithin the SFA, on the contrary, the approxim ation is derived from a therm odynam ical potential for any $n_{\rm b}$, in nite or nite or even so small as $n_{\rm b} = 1.D$ epending on the quantity and accuracy one is interested in, there can be a rapid convergence with respect to n_b (cf. Ref. 30) so that a sm all num berm ight be su cient. For cluster approxim ations, the best choice is by no means clear as it must be balanced with the choice of the cluster size N_c. This strongly depends on the lattice dimension. In fact, it has been show n³² that for the one-dim ensional Hubbard model a larger N $_{\rm c}$ is to be preferred as com pared to a larger n_b .

In this context, it is interesting to see where one are led to with the most simple reference system conceivable. This is a model H 0 characterized by N $_{c}$ = 1 and $n_{b} = 1$ which yields the so-called two-site dynam ical im purity approximation (DIA). The answer is given with the present paper: Even in this approxim ation the M ott transition shows up. At zero tem perature the transition tums out to be continuous at a nite critical interaction U_c where there is a coalescence of the m etallic with a coexisting insulating phase. For nite tem peratures, on the other hand, the transition is discontinuous. The rst-order line U c (T) term inates at a second-order criticalpoint $(U_c(T_c);T_c)$, and for $T > T_c$ there is a sm ooth crossover only. This is qualitatively the same picture that has been found beforehand in the full DM FT.Furtherm ore, the two-site D IA yields a U_c at T = 0 that is surprisingly close to the result of the full DMFT. In this respect the two-site DIA is of similar quality as the linearized DMFT, 38 another approach that is based on a mapping onto the two-site SIAM . Whether or not the $\rm U_{c}\mbox{-}results$ of the two-site D IA $\,$ in prove on those of the L-DMFT is di cult to decide in view of the existing (full) DMFT data. M ore important, however, the conceptual improvement gained is substantial: While the mapping procedure on the two-site model, though physically motivated, is done in an ad-hoc way in the L-DMFT, the two-site DIA is derivable from a therm odynamical potential and can be characterized as an optim altwo-site approach in fact.

The fact that a reasonable m ean-eld description of the M ott transition is possible even for the simple two-site D IA, m otivates further SFA studies of the transition with improved approximations in the future (e.g. using nite clusters, N $_{\rm c}$ > 1, and small $n_{\rm b}$). In case of larger and m ore complex reference systems, how ever, it becomes m ore and m ore important to have a num erically e cient and accurate m ethod for the evaluation of

the self-energy functional at hand. The detailed analysis of the di erent contributions to the functional has been another major intention of the present study. Using the causality properties of the G reen function, it has been shown that the important Trln (G) term can be written as the grand potential of a system of non-interacting quasi-particles with unit weight (apart from a correction term that cancels out in the functional eventually). W hile this result is also interesting by itself, it is very well suited for an e cient num erical im plem entation. As the energies of the cticious quasi-particles are given by the poles of the G reen function, they can be found in a com paratively simple way by exploiting general causality properties. In particular, there is no need for a small but nite Lorentzian broadening, ! ! ! + i , which must be introduced in a more direct way to evaluate the functional^{32,33} This will become in portant when studying the critical regime of the M ott transition, where an accurate com putation of sm all energy di erences is vital, using an approxim ation with several variational param eters. Studies in this direction are intended for the future.
