In purity e ects on s+ g-wave superconductivity in borocarbides Y (Lu)N $\frac{1}{2}B_2C$

Recently a hybrid st g-w ave pairing is proposed to describe the experim ental observation for a nodal structure of the superconducting gap in borocarbide Y N i_2B_2C and possibly LuN i_2B_2C . In this paper the impurity e ects on the st g-w ave superconductivity are studied in both Born and unitarity lim it. The quasiparticle density of states and therm odynam ics are calculated. It is found that the nodal excitations in the clean system are immediately prohibited by impurity scattering and a nite energy gap increases quickly with the impurity scattering rate. This leads to an activated behavior in the tem perature dependence of the speci c heat. Qualitative agreement with the experimental results is shown. C om parison with d-w ave and some anisotropic s-w ave studied previously is also made.

I. IN TRODUCTION

The superconductivity in rare earth nickel borocarbides RN i₂B₂C (R=Y, Lu, Tm, Er, Ho, and Dy) is of great interest in recent years.^{1;2} Am ong them, the two nonm agnetic borocarbides YN i2B2C and LuN i2B2C have relatively high superconducting (SC) transition temperatures, which are 15.4K and 16.5K, respectively. Although they were initially understood by an isotropic s-wave pairing,³ recent various experim ental results, including specic heat,4 {7 therm al conductivity,8;9 Ram an scattering,^{10;11} NMR relaxation rate,¹² photoem ission spectroscopy, 13 scanning tunneling m icroscopy and $spectroscopy_{\prime}^{14}$ have shown that they may be another glass of nodal superconductors. For example, both the H dependence of the specic heat and H linear dependence of the therm al conductivity in the vortex state indicate the existence of nodal excitations.46 In particular, com pelling evidences are presented by Izawa et al.⁸ based on the angular dependent therm al conductivity measurements in a magnetic eld that the gap function of YN i2B2C is highly an isotropic with an isotropy ratio less than 10², i.e., it has essentially nodes and moreover, the nodes are point-like which are located along [1,0,0] and [0,1,0] directions. Due to Doppler shift in the presence of supercurrent ow r^{15} the zero energy quasiparticle density of states (DOS) becomes nite and is sensitive to the relative orientation between the magnetic eld and nodal direction. Thus the nodes can be unam biquously extracted from the angular modulation of the therm alconductivity. Based on the same physicalm echanism the angular dependent specic heat in YN i2B2C was measured by Park et al. and the conclusion for the existence of the point nodes can be also drawn. In addition, the therm alconductivity in LuN i2B2C was measured by Boaknin et al. as a function of temperature and eld strength.⁹ They claim ed that the gap m inim um is at least 10 tim es sm aller than the gap m axim um and

possibly goes to zero at nodes. Thus YN i2B2C (and pre-

sum ably LuN $i_{\rm 2}B_{\rm 2}C$) becomes the rst superconductor in which the gap function with point nodes is clearly identied.

Theoretically, M aki et al. have proposed that the so called s+ g-wave spin singlet gap function, i.e., $^{16;17;8}$

can describe the experimental observation in Y (Lu)N i_2B_2C . Here ; are the polar and azim uthal angles of k, respectively. The second 'g-wave' component is given by a fourth degree A_{1g} basis function: $k_x^4 + k_y^4 = 6k_x^2k_y^2$ in tetragonal crystal symmetry. In the gap function the amplitudes of s- and g-components are assumed to be equal. Thus 4 (and only 4) point nodes at = =2 and = 0; =2; ;3 =2 are realized, which is exactly what has been observed experimentally.⁸

So far, a m icroscopic theory for the s+g-wave pairing is not available which m ight be complicated due to the complex Ferm i surface of borocarbides¹⁸ and the possibility of strongly anisotropic Coulomb interactions. A phenom enological theory has been constructed by two of us,¹⁹ which shows that a stable coexistence of s- and qwave with the ne tuning, i.e., the equal am plitudes of them are possible. On the other hand, the correctness of the s+g model could be checked by comparing the theoretical predictions with the available experimental data. Up to now, quite a few physical quantities based on the s+ g m odel such as therm alconductivity, 8 R am an spectra,²⁰ sound attenuation²¹ etc. have been calculated and good agreem ent with the experim ental results is obtained. This in turn stimulates us to continue studying m ore properties.

In this work the inpurity e ects on the s+g model will be investigated. Experimentally there have been extensive studies on Pt-substituted borocarbide Y (N i₁ $_x$ Pt_x)_2B_2C. The ultrahigh-resolution photoem ission spectroscopy was performed by Yokoya et al.¹³ They found a sm allbut signi cant di erence for the spectra in the SC states between x = 0 and x = 0.2 com pound,

which is contributed to the change in an isotropy of the SC gap: a strong an isotropic gap in x = 0 and an alm ost isotropic one in x = 0.2. That is, the gap anisotropy is wiped out by introducing impurities. Consistent result can be obtained from the electronic specic heat C measurements by Nohara et al.⁵ The temperaturedependence of C (under zero eld) shows a power law behavior for x = 0 but a therm ally activated behavior for x = 0.2. Very recently, the angular dependent therm alconductivity for Y (N $i_{1} \times Pt_{x}$)₂B₂C with x = 0.05 in the SC state was measured.²² There is no angular modulation left. This shows that the gap anisotropy is nearly com pletely suppressed by only 5% Pt substitution. It is the purpose of this work to see how soon a full energy gap will be opened by the impurities for the s+g-m odel through the calculation of the DOS. Furtherm ore, the therm odynam ics like speci c heat will be calculated. The crossover from a power law behavior in a pure system to an activated behavior in the presence of in purities will. be exhibited.

II.FORM ALISM

The e ects of nonm agnetic in purities are treated by the self-consistent T -m atrix approximation.²³ Forbenet of readers, we brie y summarize the formulation in the following. To begin with, the Matsubara G reen's function in Nambu representation is written as (quantities with a hat represent matrices)

where $!_n = (2n + 1) T$ (T: tem perature) is the M atsubara frequency, k the electron energy measured from the chem ical potential, k the gap function which has been assumed to be real. \circ_0 and $\circ_{1,3}$ are unit and Paulim atrices, respectively. The self-energy $(i!_n) = _u T(i!_n) with _u = N_i = (N_0)$. Here N_i is the total number of in purities and N₀ is the zero energy DOS per spin for the spectrum $_k$. The T-m atrix T satis es $\hat{T}(i!_n) = \hat{K} + \hat{K}\hat{G}(i!_n)\hat{T}(i!_n)$, where $\hat{G}(i!_n) = (1=N_0)_k \hat{g}(k;i!_n)$. K is the T-m atrix in the normal state: $\hat{K} = \hat{\gamma} = c w$ ith $c = \cot_0$. And $_0$ is the swave phase shift controlled by the strength of a single in purity potential.²⁴

The matrix \hat{A} (A = ;T;G) is decomposed into $\hat{A} = A_0^{0} + A_1^{1} + A_3^{3}$. Then one obtains $G_3 = 0$ if assuming particle-hole symmetry.²³ Further T_3 and correspondingly $_3$ vanish if we only concern Born (c 1) and unitarity (c = 0) limit. The left $_{0;1}$ are obtained as follows

Above $\frac{1}{n} = \frac{1}{n} \frac{1}{R}$ i ₀; $\sim_k = \frac{1}{k} + \frac{1}{1}$, and h imeans angular average d = (4). It deserves to point out that the o -diagonal self-energy ₁ is zero for d-wave but nite for the current s+ g-wave. This di erence will lead to di erent behavior of their respective DOS functions.

The gap function is connected to the matrix element g_{12} by $_{k} = T _{i!_{n}} _{k^{0}} V_{kk^{0}} g_{12} (k^{0}; i!_{n})$ with $V_{kk^{0}}$: the pair potential. It is often assumed $V_{kk^{0}} = V f (k) f (k^{0})$, which is valid for $j!_{n} j < !_{D}$ (a cut-o). Then the follow-ing equation for the gap am plitude is obtained:

where $V = V N_0$ is a dimensionless interaction constant.

By solving Eqs. (3)-(5) self-consistently, we can obtain the renom alized with in purity concentrations at all tem peratures and further calculate the observable quantities like speci c heat. In the following we adopt the in purity scattering rate parameter in the normal state $= u = (1 + c^2)$, which reduces to $u = c^2$ in Born limit (c 1) and u in unitarity limit (c = 0).

III. DENSITY OF STATES

We rst consider the DOS, which is given by (per spin)




FIG.1. The quasi-particle DOS for st g-wave. (a) The results for various in Bom limit. The low energy region is enlarged in the inset. (b) Comparison between unitarity and Bom limit for a xed = 0.5.0 nly subtle di erences exist in both limits.

It is noticed that if one scales the input parameters and E by , the DOS can be obtained by only solving Eqs. (3) and (4) without explicit calculation of for the moment. The results for a few ratios = are shown by Fig. 1 in both Born and unitarity limit. (Note that the scaled = is still a m onotonous function of .) From the gure a few features are clearly seen: i. There is no essential di erence between the results in both lim its, as seen by an example in Fig. 1b. Num erically we have $G_0^2 + G_1^2 / 1$ in unitarity limit. Thus Eq. (3) can be rewritten into a unied form : $_0 = G_0; _1 =$ G₁ in both lim its, leading to nearly the same DOS. ii. An energy gap opens up immediately when \neq 0 and grows quickly with . As seen from the inset of Fig. 1a, a relatively big energy is already present for small = = 0.02. gap !_q Actually $!_q$ is well approximated by $!_q = = (1 + 2)$. For interm ediate = = 1, the gap an isotropy is nearly suppressed and the DOS approaches the fam iliar shape of an isotropic swave gap. All the above results are quite dierent from those ford-wave.^{25{31} Forexample, a nite DOS is induced by in purities around zero energy for dwave. A lso, a resonance behavior at low energy exists in unitarity lim it for d-wave, which does not appear in the s+g-state. We point out that the main result seen from the DOS based on the s+ g m odel, i.e., the gap an isotropy is suppressed by impurity scattering, is consistent with the conclusion drawn from the photoem ission data.¹³

At this stage, we would supplement a remark. Previously, in order to clarify the role of sign change in a gap function, som e hypothetical an isotropic s-w ave gap functions e.g. j $\cos 2$ j 26 which vanishes at the same nodes as d-wave but never change sign, have been studied in the presence of impurities. The obtained DOS for 60 has qualitatively sim ilar properties to that shown here. This is understandable in the sense that the current s+ g-w ave (without sign change) is essentially an anisotropic s-wave. On the other hand, however, we would point out an im portant di erence between the current s+ g-w ave gap and the one jcos2 ; The form er contributes only a few point nodes, while the latter gives line nodes, on a threedim ensional Ferm i surface. This will lead to notable differences on som e observable quantities, e.g., the angular dependent therm alconductivity, which has actually been used to identify whether the SC gap in YN i2B2C has really point or line nodes.⁸ A s far as the D O S is concerned, a quantitative di erence is that the opened gap ! g increases with for s+g-wave much faster than that for

 $j\cos 2$ j since point nodes are easily removed by impurity scattering. This is consistent with the experimental observation that YN i_2B_2C in the SC state is very sensitive to impurities as mentioned above.

IV .TRANSITION TEM PERATURE, SC ORDER PARAMETER AND THERMODYNAM ICS

In this section we focus on the thorough solution of Eqs. (3)-(5). Considering the limit ! 0, we rst extract the transition temperature $T_{\rm c}$ analytically. In both Born and unitarity limit, we obtain the following equation which is di erent from the standard A brikosov-G or kov (AG) one^{32}

where $T_{\rm c0}$ is the transition temperature at = 0, and (z) is the digamma function. The prefactor $p=\frac{{\rm hf}^2\,(k)\,i}{{\rm hf}^2\,(k)\,i}$ ' 0:169 for the current st g-wave. Note that for the usual nodal superconductors with only a single angular momentum pairing like d-wave or pure g-wave, the prefactor is unity, i.e., Eq. (7) becomes the standard AG equation.^{27;28} Therefore, for d-wave there exists a critical : $_{\rm c}=T_{\rm c0}{=}(2e)$ ' 0:882T_{\rm c0} at which $T_{\rm c}$ vanishes, whereas for st g-wave $_{\rm c}=1$. In the limit ! 0, Eq. (7) gives




FIG.2. $T_c=T_{c0}$ (solid lines) and (;T = 0)= $_{00}$ (dotted lines) vs. = $_{00}$ for s+g- and d-wave. Note that for each quantity the results in two lim its are the same for s+g-wave. For d-wave the quantity (;T = 0)= $_{00}$ is shown in unitarity lim it.²⁸

The dependence of T_c on is shown in Fig.2, where is scaled by $_{00} = (=0;T=0)$. The result for d-wave is also shown for comparision. From Eq. (8) we have the linear relation at $! 0: T_c=T_{c0} = 1 \quad q = _{00}$ with q = 0.366 for s+ g-wave and 1:68 for d-wave. Here we have used the BCS ratios $_{00}=T_{c0}$ ' 2:76 and 2:14 for s+ g- and d-wave, respectively.

We try to evaluate from the experimental data on T_c . For Y (N i₁ $_xPt_x)_2B_2C$, $T_c = 12.1K$ at x = 0.2,¹³ i.e., $T_c=T_{c0}$ ' 0:786. Then we have = $_{00}$ ' 0:94. For x = 0.05, $T_c = 13.1K$,²² corresponding to = $_{00}$ ' 0:55.





FIG.3. (;T)= $_{00}$ as a function of T=T_{c0} at dierent = $_{00}$ for s+ g-wave.

The SC order parameter (;T) is solved numerically. In what follows we give the results only in Born limit. Those in unitarity limit are practically the same. In Fig. 3, (;T) is given as a function of T for a few . In addition, (;T = 0)= $_{00}$ is shown in Fig. 2, which decreases slow ly (slower than $T_c=T_{c0}$) with .

W e further calculate the therm odynam ics. The entropy S is given by

with Ferm i function $f(E) = 1 = (1 + e^{-E})$. In Fig.4 we have shown the entropy $S = S_n$ vs. $T = T_{c0}$ for a few , where $S_n = -T$ with $= \frac{2}{3}^{-2}N_0$ is the entropy in the normal state. In the inset the same gure is reploted but S is scaled by a constant T_{c0} . This is helpful to understand the speci c heat shown below .

The speci c heat is given by $C = T \frac{@S}{@T}$, which can be explicitly expressed as




FIG.5. The DOS with change of T for = $_{00} = 0.2$ (with corresponding $T_c=T_{c0} = 0.934$). It is seen that the DOS at $T=T_{c0} = 0.3$ is only slightly changed from that at T = 0. W ith increasing T, the bump at relatively high energy dissolves gradually, and the peak becomes narrow and simultaneously shifts towards zero. When T ! T_c , the DOS is close to an inverse square root function valid for an isotropic swave gap. Finally it will become the straight line 1" at $T = T_c$.

where $C_n = T$ is the speci c heat in the normal state. In Eq. (10) the second term is contributed by the T-dependence of the DOS. It is important only at high temperatures because at low T, about T < $0.2T_{c0}$ (see Fig. 3), (;T) is nearly T-independent and also the DOS. For an instructive look at how the DOS changes with T in the whole range, we have shown in Fig. 5 an example for $=_{00} = 0.2$.




FIG. 6. The specic heat $C = C_n$ vs. $T = T_{c0}$ for $= _{00} = 0$; 0:2 and 1:0. The low temperature region is enlarged in the inset.

The speci c heat $C = C_n$ vs. $T = T_{c0}$ is shown in Fig.6. W emainly concern the low temperature behaviors, which are enlarged in the inset. The notable observation is that the T-dependence changes from a power law behavior in the pure case into an activated behavior in the presence of impurities. This is due to the opening of a full gap by impurities as seen from the DOS. Thus the low energy quasi-particle excitations are exponentially sm all.

The above point becomes more transparent if we present the analytical results for the speci c heat at low T where only the rst integration in Eq. (10) contributes. In the pure case, the DOS is linear at low energy E : $\frac{N(E)}{N_0} = \frac{E}{4}$. For about 0:1 =T > 5, i.e., T < 0:05T co, this linear formula can be used throughout the whole range in the integration. Then we have

i.e., a linear T-dependence (or T² dependence for C). W hen > 0, the lower limit of the integration becomes $!_g$. In view of sech² (E=2T) ' 4 exp(E=T) at low T (about $!_g=T > 5$), an exponential factor exp($!_g=T$) is naturally expected after the integration irrespective of the concrete form of N (E). Explicitly, for T < 00 we have obtained (!g')

Experimentally the specic cheat was measured by Nohara et al.⁵ for Y (N $i_1 x Pt_x$)₂B₂C with x = 0 and 02. By tting the experimental data they have exhibited a power law relation C / T^n with n 3 for x = 0 com – pound and C / exp(const=T) for x = 0.2. The essential features of the experimental data in both pure and impure systems have been reproduced by our theoretical results, although some di erences exist for the accurate T-dependences between theory and experiment.

In addition, the speci c heat jump at the transition tem perature can be analytically derived. For a pure system, we have

where $x = (2 T_c)$, $a = hw^2 i$, $b = hw^4 i$ with $w = sin^4 \cos 4$, and ⁽ⁱ⁾(z) (i = 1;2;3) are the poly-gam m a functions. From Eq. (14), we obtain $\frac{C C_n}{C_n} = 0.901(1:016)$ for = 0.0 = 0.2(1), which are consistent with the numerical values in Fig. 6.

V.CONCLUSION

In the present paper we investigate the impurity e ects on s+g-wave superconductivity in YN i2B2C and possibly $LuNi_2B_2C$. Unlike in the usual nodal superconductors we have discovered that the results in Born and unitarity lim it are practically the same. There is no resonant scattering associated with nonmagnetic in purities. A lso unlike in the usual nodal superconductors, the quasiparticle energy gap opens up immediately by impurity scattering and grows quickly with the scattering rate. In other words the nodal excitations are prohibited im mediately when impurities are introduced, which is clearly seen from the quasi-particle density of states. Indeed we could evaluate that the energy gap opens up even for $Y (N_{1} + xPt_x)_2B_2C$ with x = 0.01. From the value for at x = 0.05, we estimate = 0.0 = 0.1 for the crystal with x = 0.01, which is substantial for a gap opening. Therefore the s+ g-wave superconductivity is very sensitive to impurity scattering.

A loo we have calculated the speci c heat, which shows a change from a power law dependence of T in a pure system into an activated behavior in the presence of im purities. C om pared with the experim ental data by N ohara et al_{r}^{5} the theoretical results have reproduced the m ain features. The accurate com parison needs in provem ents in both theoretical and experim ental side.

Finally we point out that the sensitivity to impurities predicted by s+g-m odel is con rm ed by the angular dependent therm al conductivity m easurements on the single crystalY (N $i_1 \times Pt_x$)₂B₂C with x = 0.05,²² where the gap anisotropy has been cleared out. In a forthcoming paper we shall discuss other properties such as super uid density etc. within the same form altreatment.
