O rbital A pproxim ation for the R educed B loch E quations: Ferm i-D irac D istribution for Interacting Ferm ions and H artree-Fock E quation at F inite Tem perature

A bstract

In this paper, we solve a set of hierarchy equations for the reduced statistical density operator in a grand canonical ensemble for an identical many-body ferm ion system without or with two-body interaction. We take the single-particle approximation, and obtain an eigen-equation for the single-particle states. For the case of no interaction, it is an eigen-equation for the free particles, and solutions are therefore the plane waves. For the case with two-body interaction, however, it is an equation which is the extension of usual Hartree-Fock equation at zero temperature to the case of any nite temperature. The average occupation number for the single-particle states with mean eld interaction is also obtained, which has the same Ferm iD irac distribution form as that for the free ferm ion gas. The derivation demonstrates that even for an interacting ferm ion system, only the lowest N orbitals, where N is the number of particles, are occupied at zero temperature. In addition, their practical applications in such elds as studying the temperature elects on the average structure and electronic spectra for macrom olecules are discussed.

1 Introduction

Quantum statistical mechanics provides a most general theoretical fram ework for studying the structure and dynamics of an interacting many-body system. Combined with mathematical laws of statistical distribution, it investigates the microscopic quantum states of a system with many degrees of freedom, its corresponding macroscopic thermodynamic behaviors, and their interplay [1-4]. It covers the usual quantum mechanics as a special case at zero temperature [5].

Experimental investigation of temperature or pressure elects on the electronic structure and related spectra form olecules or solids has been for some time [6-8]. However, a complete or system atic theoretical work has not been developed and seen in the literature. The quantum chemistry at nite tem – perature or pressure is not a well-de ned or well-established eld [9]. Indeed, the elect of temperature or pressure on microscopic structure is a complicated phenomenon. There exists dilerent functioning mechanisms. O ne consideration is that the variation of the temperature, according to

the Ferm i-D irac statistics, will change the therm all probability distribution of single-particle states for a free electron gas. Similar situation should be expected to occur for an interacting electron system, and therefore its microscopic structure will be correspondingly altered. Another consideration is that, for m olecules or solids, the therm al excitation will cause the change of the time scales for the molecular motions. This will most likely bring about the transitions of electronic states, and therefore lead to the breakdown of the Born-Oppenheim er approximation. Electron-phonon interaction is a fundam ental topic in solid state physics and its tem perature dependence is well-known. In this article, we tack le the issues in a simpler way. We treat only an interacting identical ferm ion system, or neglect the coupling of the electronic motion with those of the nucleus in molecules or solids. We expect that some sort of the general conclusions will come out from this study. As a matter of fact, this is also the approach usually adopted in non-adiabatic m olecular dynam ics, in which purely solving the eigenequation for the electrons will provide the reference states for investigating the coupling motions between the electrons and the nucleus of the molecules.

In a recent paper [10], we have deduced a set of hierarchy equations for the reduced statistical density operators in both canonical and grand canonical ensem bles. They provide a law according to which the reduced density m atrix varies in tem perature. They also o er a route for a direct determ ination of the reduced density operator for the statistical ensem bles.

This paper is an initial endeavor, on the basis of the equations we derived in paper [10], to investigate the issues related to the interplay between the microscopic structure and macroscopic observables, and speci cally, the tem - perature e ects on the electronic structure of molecules or solids. We take the orbitalm odel and solve the equations for the grand canonical ensemble in an approximate way. In the next Section, we insticonsider the case of a free electron gas, and evaluate the terms related to the single-particle operator of the reduced B loch equations, we get the solutions of a plane wave as well as the usual Ferm i-D irac statistics of a free electron gas. In Section 3, we solve the equations for the identical ferm ion system with two-body interaction. We obtain an energy equation for the single-particle states which is the extension of usual H artree-Fock equation at zero temperature to the case of any nite temperature. The average occupation number is also obtained which has the same form as that for a free ferm ion gas, which is the Ferm i-D irac distribution. The Section 4 is a sum mary and conclusion. The implications and possible applications are discussed.

2 Free Ferm ion G as

In this and next sections, we consider the solution of reduced B loch equations for the grand canonical ensemble we derived in paper [10] as shown below,

The h (i) and g (i; j) are one- and two-body operators, and the rest of symbols are de ned in [10]. We choose a grand canonical ensemble for our study because we want to compare our results with those already known for a free ferm ion gas. Just like solving any other equations of motion, the exact solutions can be obtained only for very few cases. Some sort of approximations have to be made. Nevertheless, more universal conclusions might be possibly obtained. A common approximation scheme is to truncate the hierarchy. Depending on the specific physical situation, this is accomplished by approximating the higher-order density matrix as a functional of the lower-order ones. In this paper, the system considered is N -ferm ions and the decoupling scheme we assume is to express D $^{p+1}$ by D p in the following way [11-15],

That is, the pth-order reduced density matrix can be expressed as a p-fold G rassmann product of its rst-order reduced density matrices. This implies that we have taken an independent-particle approximation. To proceed further, we need to evaluate various terms of right hand side of Eq. (1).

We rst study the case without any interaction, where we only need to calculate the rst and second terms of Eq. (1). For the rst term,

For the second term, the calculation is more complex, and the following form ulae related to the decomposition of a permutation group in terms of its subgroups are needed [16],

where A_p is a pth-order antisym m etric operator, and (p+1;i) is an exchange between p+1 and i. Therefore,

For the special case of p = 1, inserting Eqs. (5) and (8) into Eq. (1) yields

This is the Bloch equation for the st-order reduced density matrix of an identical particle system with no interaction under single-particle approximation.

De ne

From above equation and its conjugate, we get

This means that h and ¹ commute. Since they are also Herm itian, they have common eigenfunctions fj $_{i} > g$, which are plane waves,

Substituting Eq. (15) into Eq. (11), we can obtain the equation the therm al probability ! (;; ;) satisfies,

Its solution takes the form ,

which is just the usual Ferm iD irac distribution. Therefore, by directly solving the reduced B loch equations for the reduced density matrix in a grand canonical ensemble under orbital approximation, we not only have obtained the eigen solutions of a plane wave but also have recovered the usual Ferm i-D irac distribution for the free electron gas.

3 Hartree-Fock Equation at Finite Tem perature

In this section, we solve the reduced B loch equation (1) for the case of an identical ferm ion system with two-body interaction under the orbital approximation (4). The rst term and the second term remain the same as those for the free ferm ion case. We need to evaluate the remaining two terms. In particular, for p = 1, the Eq. (1) reads

The last two terms can be evaluated in a straightforward way, which yields

are called the C oulom b and exchange operators, respectively. The action of K is

Substitution of Eqs. (19) and (20) into Eq. (18) yields the B loch equation for the rst-order reduced density matrix of N interacting ferm ions under orbital approximation,

is called the Fock operator at nite tem perature. Rede ne the norm alized rst-order reduced density operator

From Eq. (27) and its conjugate, we get

which means that the Fock operator F and ¹ commute. They are also Herm itian, and therefore they have common eigenvectors $fj_i > g$. These vectors are determined by the following eigen equation for the Fock operator,

The rst-order reduced density operator is correspondingly expressed as

where ! (; ; ; i) is the therm alprobability that the orbital is found to be in the state fj i > g at nite temperature T. Substituting Eq. (30) into Eq. (27), we can obtain the equation this therm alprobability ! (; ; i) satisfies,

Its solution has the same usual form of Ferm i-D irac statistics for the free electron gas as follows,

with energy levels f $_{i}$ g determ ined by Eq. (29).

4 Discussions and Conclusions

In this paper, we have solved the set of hierarchy B loch equations for the reduced statistical density operator in a grand canonical ensemble under single-orbital approximation for the identical ferm ion system without or with two-body interaction. For the case without any interaction, we not only get a plane wave solution for the eigenstates and eigenvalues, but also recover the usual Ferm iD irac distribution of a free electron gas. For the situation with two-body interaction, we obtain an eigen-equation for the single-particle states. It is the extension of usual commonly used Hartree-Fock equation at the absolute zero temperature to the case of any nite temperature. The

average occupation number formula for each single-particle state is also obtained, which has the same analytical form as that for the free electron gas with the single-particle state energy determined by the Hartree-Fock equation at nite temperature (29).

From Eqs. (21), (22) and (30), we see that the Coulomb operator J, the exchange operator K, and therefore the Fock operator F are both the ∞ -herent and the incoherent superpositions of single-particle states. They are all temperature-dependent through an incoherent superposition factor, the Ferm iD irac distribution, ! (;; i). Therefore, the mean force and corresponding m icroscopic structure are temperature-dependent.

It is easy to see that, when temperature is zero, only N single-particle states with energy levels small than the chemical potential are occupied as for the free electron gas. That is, the fact that only lowest N orbitals (or holes) are occupied holds also for the interacting case. Therefore, only a single determ inant wavefunction is enough for a description of interacting N -particle wavefunctions. Say in another way, there exists a correspondingly e ective and strict one-particle state description of an interacting N -particle system. This is also the spirit of current density functional theory [17], and is consistent with the third law of therm odynam ics.

Even though we have simplied the structure issue for a molecule or a solid at nite temperature, the equations we obtained in this paper will nd wide applications. The examples include the investigation of temperature e ects on the average structure and the electronic spectra of macrom olecules and the study of conduction electrons in metals and so forth [18-21].
