We study the elect of a magnetic ux in a 1D disordered wire with long range hopping. It is shown that this model is at the metal-insulator transition (MIT) for all disorder values and the spectral correlations are given by critical statistics. In the weak disorder regime a smooth transition between orthogonal and unitary symmetry is observed as the ux strength increases. By contrast, in the strong disorder regime the spectral correlations are alm ost ux independent. It is also conjectured that the two level correlation function for arbitrary ux is given by the dynam ical density-density correlations of the C alogero-Sutherland (C S) model at nite temperature. Finally we describe the classical dynam ics of the model and its relevance to quantum chaos.

The addition of disorder to an otherwise metallic sam ple strongly m odi es its properties. A s disorder increases eigenfunctions start to localize. A MIT is observed in the therm odynam ic lim it in system s of dim ension greater than two. The moments of the eigenfunctions at the M IT show anom alous scaling with the sample size [1] L, $d^{d}rj$ (r) j^{2q} / L $D_{q}(q 1)$, P_{q} is the inverse par- $P_{\alpha} =$ ticipation ratio and D $_{\rm q}$ is a set of exponents describing the transition. Thus the scaling at the M IT is in between that of a good m etal, \mathtt{P}_{q} / $\mathtt{L}^{-d\,(q-1)}$, and that of an insulator (localized eigenfunctions), P_q / L⁰. E igenfunctions with such anom alous scaling are nam ed \multifractals", for a review see [2]. Signatures of a M II are found not only in the eigenfunctions [3] but also in the spectral uctuations [4]. It was argued in [5] that although level repulsion typical of the metallic regime is still present at the M II, the long range correlations are weaken due to the multifractal character of the wavefunctions. The num ber variance was claim ed to be asym ptotically linear with a slope around 0:25 [5]. These features, level repulsion and sub-Poisson num ber variance com bined with the scale invariance of the spectrum [4] are named 'critical statistics' [6] and are considered genuine spectral signatures of a M IT . Eigenfunction and spectral properties are indeed related, for multifractal eigenstates not too sparse the slope of the number variance is related to the multifractal exponent D₂ by $= \frac{d D_2}{2d}$ [7], where d is the dim ension of the space. D i erent generalized random matrix model (gRMM) have been successfully employed to describe 'critical statistics' [8]. Recently [9,10], the spectral correlations of one of those gRM M was dem onstrated to be equivalent to the spatial correlations of the Calogero-Sutherland (CS) model [11] at nite tem perature. Temperature in the CS model is related with the multifractal exponent D $_2$ at the transition.

Short range Anderson [12] models have been broadly utilized for numerical investigation at M IT. However in certain systems, like glasses with strong dipole interactions [15], long range hopping is possible and thus the Anderson modelm ust be modi ed accordingly. A lthough the introduction of long range hopping dates back to the fam ous Anderson's paper on localization [12], these m odels did not attract too m uch attention until the num erical work of 0 ono [13,14] and the renorm alization group treatm ent of Levitov [15] in the context of glassy system s. The m ain conclusion of these works was that power low hopping m ay induce a M IT even in one dimensional system s if the exponent of the hopping decay m atched the dimension of the space. A related problem, a random banded m atrix with a power law decay was discussed in [16]. It was shown analytically that for a 1=r band decay the eigenstates are multifractal and the spectral correlations resemble those at the M IT. Intense num erical study in recent years [17] has corroborated the close relation between this random banded m atrix m odel and the Anderson m odel at the M IT.

A nother related issue of current interest is the e ect of a magnetic eld at the M II [18,19]. In the metallic regime, an exact analytical treatment was developed in [20]. It turns out that, in this limit, the two level correlation function describing the crossover between orthogonal (no ux) and unitary symmetry is equivalent to the dynamical density-density correlations of the CS model [21] (see also [22] for dierent initial conditions) provided that \time" in the CS model is traded by magnetic eld in the disordered system. Numerical results at the 3D M II [18] show that the magnetic ux still in uences the short-range spectral correlations. The impact on long range correlations is still not settled [19] though there is agreement that the e ect, if any, must be small.

O ne of the m aim aim s of this paper is to further clarify this issue by investigating a one dimensional (1D) wire with power low hopping and a magnetic ux attached to it. This model presents typical features of a M IT for all values of disorder with the advantage that much larger volumes can be simulated. We also conjecture, based on the analogy with the CS model above mentioned, a exact expression for the two level spectral correlation function at the M IT for arbitrary ux.

Our starting point is the following Ham iltonian describing a 1D closed wire with long-range hopping,

where, n;m label the lattice sites, r = n m, n and nm are two sets of random number both distributed in a box [W;W], F (r;b) is the long range hopping term,

0 < < 1 is the band size and N is the system size Since F (r;b) 1=r for N r our model is critical, namely reproduce typical features of a M IT for all values of [16]. Sine-like interaction is introduced in order to assure periodicity. The phase factor (Peierls substitution) above is related to the magnetic $\underset{m_m}{\text{ux}}$ (in units of the fundamental ux h=c) by, $\underset{m_m}{\text{nm}} \underset{m}{\text{Ad}r} = (n m)=N$ for n m < N=2 and $\underset{nm}{\text{nm}} = \underset{n}{\overset{n}{\text{Ad}r}} \text{Ad}r = (1 (n m)=N)$ for n m > N=2, is the magnetic ux.A is the (constant) potential vector. Such Ham iltonian may be relevant for glassy systems [14], quantum e ect of classical anom alous di usion [23] and quantum chaos [25].

The spectral uctuations are studied by direct diagonalization of the H am iltonian (1) for di erent sizes ranging from N = 500 to N = 8000. The eigenvalues thus obtained are unfolded with respect to the m ean spectral density. The number of di erent realizations of disorder is chosen such that for each N the total number of eigenvalue be at least 2 10^6 . In order to avoid edge e ects, only 30% of the eigenvalues around the center of the band are utilized. W ithout loss of generality we have set W = 1.

First we investigate short range correlations by evaluating P (s), the level spacing distribution (LSD). This correlator gives the probability of having two eigenvalues at a distance s. In the insulator regime (uncorrelated eigenvalues) P (s) = e^{s} , in the metallic regime (W igner-Dyson statistics) P (s) s for s 1 (the presence of a ux drives the spectrum from = 1 orthogonal to = 2unitary symmetry). At criticality one expects level repulsion as in W igner-D yson statistics s 1 and exponential decay fors 1, P (s) e^{s} with > 1 [26]. In gure 1 we plot P (s) for dierent ux values and = 2. A sthe ux strength increases, a transition is clearly observed between orthogonaland unitary symmetry. For s 1 (see inset) level repulsion is still present, P (s) s is W igner-Dyson like but with the prefactor modied by the ux. The strong disorder regime is reached by choosing a coupling constant (= 0.44) such that the resulting spectrum resembles the one at the 3D $\,\rm M$ IT . As observed in gure 2, P (s) is alm ost independent of the ux strength. For s > 1 the decay is exponential (see inset) and independent of the ux. For s 1, the e ect of the ux is still in portant, only for 0 the expected P (s) s behavior for orthogonal sym m etry is recovered. Such result agrees with previous [18,19] num erical simulations. Let us now move to long range spectral correlations.




FIG.1. Level spacing distribution P (s) for = 2 and different uxes . A transition between the Gaussian Orthogonal (GOE) and Gaussian Unitary (GUE) ensemble is observed as the ux is increased, even the asymptotic behavior of P (s) is modiled by the ux.

The number variance ${}^{2}(L) = hLi^{2}$ $hL^2 i = L$ $2^{R_{L}}_{0}$ ds (L s)R₂ (s;) (R₂ (s;) is the two level correlation function) measures the sti ness of the spectrum . Fluctuations are small in the metallic regime (W igner-Dyson statistics) with 2 (L) log(L) for L 1. For localized eigenstates, the eigenvalues are uncorrelated (Poisson statistics) and 2 (L) = L. As mentioned earlier, the num ber variance is asym ptotically proportional to L (< 1) at the M IT. In gure 3 we plot the number variance in the weak disorder regime (=2) for dierent ux values. As the ux is increased, a sm ooth transition is observed between criticalGOE [10,9] and criticalGUE [8]. We remark the slope is not modied by the ux. This is in apparent disagreem ent with the results for a 2D Anderson model in the weak multifractality regime where the slope is two times smaller in the unitary case [20]. The reason for that is the way in which the ux is introduced due to the long range hopping. If the ux in (1) is introduced as usual in short range m odels the 2D Anderson model results are recovered. The asymptotically linear num ber variance (see q 3) together with the level repulsion indicates that our model is described by critical statistics [6]. The strong disorder regime is explored by choosing a coupling constant (= 0.44) such that the slope of the num ber variance 0:29 be sim ilar to that at the 3D M II. We observe (g 4) that the ux only modi es the spectral correlations up to (L 1) (see inset g 4). Beyond this point the number variance is independent of the ux, thus suggesting that symmetry is washed out by disorder. W e want to stress that the transition from weak to strong disorder is not sharp. As

decreases, the ux in pact decreases smoothly. Curiously, untilvalues of very close to those at the 3D M IT, the e ect, although small, is still sizable. Such behavior makes more di cult an accurate account of the ux at the 3D M IT. Finally let us mention that although not shown in the gures it was explicitly checked that the spectral correlators are not dependent on the size of the matrix as expected at a M IT.




FIG.2. P (s) for = 0.44 and di erent uxes. Only for s 1 the system is sensitive to the ux.Fors 1 all curves become indistinguishable (inset).

After discussing the numerical results we propose an exact analytical relation for the two level correlation function of (1). We claim that such correlation function is equivalent to the dynamical density-density correlations of the CS model [11], $j \frac{e^2}{e^2} + \frac{(2)}{4}$ $\frac{1}{16j}\frac{1}{(x_1 - x_1)^2} + \frac{1}{4N^2}\int_{j}^{k} x_j^2$ Н́сs at nite tem perature where the position of the CS particles corresponds with the (unfolded) eigenenergies of 2 and temperature h is related to \cdot . (1), \tim e" Let us rst argue how these density-density correlations are obtained [10,21]. The density of probability of the CS ground state (zero tem perature) for (= 1;2;4)is equivalent to the joint distribution of eigenvalue of the Gaussian random matrix models (GRMM). In the large N limit, the two point spectral correlations of the GRMM are explicitly expressed through a spectral kernel. Such kernel in the language of the CS model corresponds with the amplitude of probability of having two free ferm ions in a ensemble of N around two arbitrary positions. The idea is that, based on the Luttinger liquid nature of the CS m odel [24], the density-density correlations of the CS model at nite low temperature can be obtained by using the results of GRMM but replacing the spectral kernel above mentioned by its nite tem perature analogue. In the grand canonical ensem ble $n \frac{n(x) - y(y)}{1 + z^{-1} e^{E_n = h}}$ where n are [8], K (s = x) $y;0)_{h} =$ the single particle wave functions for free ferm ions and $E_n = n = N$. In the large N lim it the wave functions are replaced by plane waves with energy given by k^2 .

D ynam ical density-density correlations [21] can be included in this form alism by expressing the time dependent density as $(s;t^2) = e^{\hat{H}_{cs}t}$ (s) $e^{\hat{H}_{cs}t}$. The crossover between orthogonal and unitary symmetry in the GRMM [20] corresponds in the language of the CS model with density-density correlations with initial conditions given by particles distributed according to the CS model for = 1 and then evolving for t > 0 according to the CS model for = 2 (free fermions). The density-

density correlations in this case [21] are also expressed through a spectral kernel as the one m entioned above but now involving the propagation of free ferm ions (hole and particle). C om bining both e ect, the dynam ical (w ith the inital conditions above m entioned) density-density correlations of the CS m odel at nite tem perature are given by (see [9,21] for details),

where $n_H(k) = 1$ $p_P(k) = \frac{1}{1 + ze^{k^2 + h}}$ is the hole occupation number, $z = 1 = (e^{1-h} \quad 1)$ is the fugacity, is the magnetic ux (time), and h is related to by 2 h $1 = for h \quad 1$ [16].

The ! 0 lim it in (3) yields the density-density correlations of the CSm odel at nite temperature h 1 [10,9] which resembles the two point spectral correlations of a disordered system at the localization-delocalization transition. The lim it h ! 0 corresponds with the exact analytical result for the crossover between orthogonal and unitary symmetry of a disordered system in the metallic regime [20] which is equivalent to the exact dynam ical density-density correlations of the CSm odel [21].




FIG.3. Number variance 2 (L) for weak disorder = 2 and di erent ux strengths. Lines are the analytical prediction (3) and symbols are the results obtained from the num erical diagonalization of (1) for N = 8000.

The s 1;h 1 limit of (3) also agrees with the density-density correlations obtained in [24,22] by using conform all eld techniques.

N um erical calculations also support the validity of our conjecture. As observed in g 3, the agreem ent between the analytical num ber variance based on (3) and the num erical result is excellent for the whole range of uxes at

2. We remark that no tting is involved as the value

of h utilized corresponds with the analytical prediction $h = \frac{1}{2}$ 0.079 [16]. In the strong disorder regime (see gure 4) the agreement is also remarkable but in this case no relation between h in is known so the parameter h = 0.267 is the best t to the numerical results. We want to point out that further work is needed to test whether the conjecture (3) is valid beyond the h 1 lim it.




FIG. 4. Number variance 2 (L) for a disorder (= 0.44) m in icking a true 3D Anderson transition. The lines represent the analytical prediction (3) (h = 0.267) for no ux (segment) and maximum ux (solid). The symbols correspond to the numerical diagonalization of (1) for N = 8000. The dependence on the ux observed for small L 1 (see inset) is also reproduced by (3).

Finally we study the relation between classical and quantum properties of our model. For = 0;h 1, the two level spectral correlation function (s 1) can be expressed through the spectral determ inant of a diffusion operator [28] describing the classical dynam ics of (1),

where, $e^{G(s)} = \frac{D(s)}{2^{-2}s^2}$, $D^{-1}(s) = \frac{Q}{m \in 0} \frac{m^2 + s^2}{m^2}$ is the spectral determ inant and m = m = h are the eigenvalues of the (anom alous) di usion operator. As expected, the 1; = 0), $\lim \pm of(3)$ coincides with (4). Unlike (s short range models, the type of classical di usion associated with (1) is anom alous [23]. Such di usion is described by a fractional Fokker-Planck equation [29]. For band decaying as 1=r, 1=2 < < 3=2, the resulting clas $t^{=(2)}$ [16]. sical dynam ics is superdiusive with irj In the our case (=1) the associated fractional Fokker Planck equation is rst order in space [30] and the eigenvalues of the di usion operator (4) are thus linear in m instead of quadratic as for norm aldiusion. This link between anom alous classical motion and quantum correlations at the M IT m ay be utilized to nd out conditions for the Anderson transition in quantum chaotic system s.

In conclusion, we have perform ed a num erical and analytical investigation in a 1D w ire with long range disorder and a ux attached to it. In the weak disorder regime we have observed that despite the critical character of the model the e ect of the ux is still important. By contrast, in the strong disorder limit, the spectral correlations are almost independent of the ux except for sm all eigenvalue separations. We have also conjectured, by exploiting an analogy with the CS model, an exact analytical relation for the spectral correlations at the M II valid for arbitrary ux and disorder h 1. We have suggested that, at least in 1D, the M II, a quantum mechanic phenom enon, may be related with certain features of the classical dynamics (anom alous di usion). We expect this relation to be relevant in quantum chaos problem s.
