M onte Carlo Investigation of Ising N anotubes and N anostrips

Abstract. Monte Carlo simulations of the magnetization temperature dependence L nanotubes (periodic lateral boundary conditions) and nanostrips (free lateral in D boundary conditions) with D = 8, 16, 32, 64 L ! 5000 have been perform ed. The apparent critical tem perature was determ inated using the B inder C um ulant m ethod (crossing of data for D L with data for D 2L) and it was found to be $\overline{x} = 0$ for sm all D values (D < D), as it m ight have been expected. No scaling of M L $^{=}$ vs $J^{T}jL^{1=}$ with $\mathbf{j}^{\mathsf{T}}\mathbf{j} = \frac{\mathbf{j}^{\mathsf{T}} \mathbf{T}_{c} \mathbf{j}}{\mathbf{T}_{c}}$ was fulled. However with $\mathbf{j}^{\mathsf{T}}\mathbf{j} = e^{4=T}$ ($\mathbf{T}_{c} = 0$ for D < D '6), instead of $\mathbf{j}^{\mathbf{T}}\mathbf{j} = \frac{\mathbf{j}^{\mathbf{T}} \mathbf{T}_{c} \mathbf{j}}{\mathbf{T}_{c}}$; scaling did hold. For D D the Binder Cumulant method produced clear phase transitions at T_C T_c (d = 2); and susceptibility peaks were also observed. (Note that $T_{\rm C}$ is a non-universal quantity). The elective critical exponents did show a crossover tow ards one dim ensional behaviour. The evolution of the apparent e ective dimensionality (as de ned by the e ective critical exponents) for nanotubes and nanostrips as a function of D can be interpreted in analogy with what happens in thin lm s of thickness D $\,$ L: the elective exponents go from $\,_{\rm effm}$ (D = D) = 0 $\,$ D) ' 1=8 and from $^{1}_{\rm effm}$ (D = D) = 0 to $^{1}_{\rm effm}$ (D D)' 1=15 to _{effm} (D but, eventually, for L $\, ! \,$ 1 , and for T extrem ely close to T_{C} (D), both $\,$ (D) and ¹ (D) cross over to (d = 1) = 0, ¹ (d = 1) = 0, respectively as expected. However our M onte C arb investigation did produce the novel result that there is a critical

our M onte C arbo investigation did produce the novel result that there is a critical thickness, D = D = 6 associated with a certain apparent e ective dimensionality, which separates nanotubes with D = D (for which $T_C(D) = 0$) from nanotubes with D > D, for which $T_C(D)$ is nite and positive.

1. Introduction

Phase transitions in Ising systems with thin Im geometry have been studied by many authors using series expansion, renorm alization group and M onte C arlo calculations [1]-[11]. Attention was focused on the evolution of the elective critical exponents at the vicinity of the critical temperature T_c , with the aim of determining the universality class of the thin Ims. The thickness dependence of the Im critical temperature was analyzed by means of numerical nite size M onte C arlo simulations [1, 7, 10], using free and periodic boundary conditions at the surfaces of the plates. It was found [12, 13] that, for periodic boundary conditions, the T_c (D) scaling prediction for system s interm ediate between d = 2 and d = 3, given by

holds, where $d_{d=3}$ ' 0:63 is the correlation length exponent for three dimensional Ising system s.

The scaling of the data and the crossover observed in elective critical exponents, which is due to the fact that the correlation length is sensing a nite thickness $(D \ L)$ as the tem perature goes tow ands T_c ; dem onstrated unambiguously that thin lm s belong to the two dimensional (d = 2) universality class.

In this study we exam ine Ising systems with geometries intermediate between one dimensional and two dimensional, with the same purpose in principle, as in the investigation of thin lms. Short-ranged isotropic Ising systems with a locally square lattices were investigated. In the case of d = 1-like systems it is clear that the determination of T_c , which is a non universal quantity, can be discutt as D approaches 1, because the phase transition in a d = 1-in nite Ising system is attained only at $T_c = 0$ and the exponents and 1 for the d = 1 Ising system are equal to zero in that limit. However this does not preclude the possibility that $T_c > 0$ for beyond a given D and e ective critical exponents $_{eff}(D) > 0$ and $_{eff}^1(D) > 0$ appears which should eventually crossover towards = 0 and $^1 = 0$ as T approaches T_c (D) very closely.

Before presenting the results of our MC investigation let us anticipate what is expected to be analogous in the behaviour M (I) for strips of xed width D and the behaviour M(T) for Im sof xed thickness D, and what m ay be expected to be di erent. For strips we may expect that, at least for large enough widths D, there is a real phase transition with a T_C (L D) approaching T_c (d = 2) = 2:269118:..: in the same way as for lm s of large enough T_c (L L D) was approaching $\frac{1}{2}$ (d = 3) = 4:5115:... This e exts the fact that even though strips of xed nite D and length L! 1 belong certainly to the d=1 universality class, the transition temperature is not a universal quantity and there for T_c may be zero for a while with D increasing from D = 2;3;4:...,but it is not necessarily so for large enough D values. On the contrary for very large D values, T_{C} (D) must be expected to approach T_{C} (d = 2). We can expect in both cases, whenever $T_{C} > 0$, that e ective maximun critical exponents effm and l_{effm} can be determ inated for given D values, but also that for large enough L and tem peratures

very close to T_C (D) the elective critical exponents crossover to their one dimensional respective values (= 0 and ¹ = 0) for any D, in analogy with what happens with ln s [9]-[11].

The di erence between strips and lm s, how ever, is that in the form er T_c (d = 1)=0 and there is nothing that precludes T_c (D) = 0 in a certain range of D values, fi. D D: In contrast T_c (d = 2) = 2.269118 is non-zero from the beginning and lm s with small thickness D must be expected to grow from this T_c value from the very beginning. In the other words, T_c (D) a non universal quantity m ay have a threshold D = D beyond which and only beyond which T_c (D) becomes positive and growing with D:

2. Results

In this work numerical nite size simulations of phase transitions in D \perp Ising system s (D \perp) with free and periodic boundary conditions have been performed to investigate the width dependence of the critical temperature if any of strips and tubes. Metropolis [14] and W ol single cluster methods [15] were used to perform M onte C arlo investigations of the temperature dependent magnetization M (T) in systems of width D = 8, 16, 32, 64 and lengths 100 \perp 5000. Periodic boundary conditions were always used along the L direction to delete secondary boundary elects, while the conditions along the width (perpendicular to the L direction) of the system were modiled from free to periodic in order to analyze boundary elects. O ur analysis how ever concentrates on results obtained using periodic boundary conditions.

The param eters of the algorithm (therm alization time, relaxation time and number of states for the energy count) were increased until inding that the main results did not change appreciably as these values were further increased and as it was con in edithat good statistics were obtained. The calculations involved 140000 M onte C arbs steps per spin for each data value (each temperature or each eld). It may be noted that changing from 50000 M C steps to 140000 M C steps no noticeable in provements were observed. To reduce the critical slowing down as much as possible at the vicinity of the critical point we used a W ol single cluster algorithm. Initial conditions at a given temperature were taken from the equilibrium conditions at the previous temperature. A description of the random number generator used may be found in [16].

Taking into account that T_c may be positive beyond a certain D as explained above, we have investigated (i) the critical tem perature dependence as a function of the width D, by simulating D L systems to locate T_c (D;L! 1), which for D larger than some D = D is expected to be non-zero, (ii) the scaling of the magnetization data for two orm ore di erent L values with a constant D, using [17] " = $e^{4=jT T_c j}$ for D D, in the corresponding scaling variable.

The apparent critical temperature for each strip (free boundary conditions) or nanotube (periodic boundary conditions) of width D, ie T_c (D; L! 1) was determined using the B inder Cumulant [18] U_L for two or more dimensions (See below). We

did nd that the crossing tem perature between the U_L curves for a constant width D was strongly dependent of L for sm all D values. The L dependence of the B inder Cum ulant U_L crossings for tubes and strips of width D is much m ore pronounced that the same e dependence for thin lm s with thickness D [10] but, eventually, as shown in Figure 1 below, it becomes stabilized for large L. A part from possible corrections to scaling, this dependence on L m ay be connected with the fact that the B inder Cum ulant is de ned for second order phase transitions with an exponent € 0, while our system s, for sm all enough D ⁰s, are approaching the linear chain critical behaviour, for which d=1 = 0. The value of U_L becomes increasingly di cult to determ ine exactly for sm aller D ⁰s because the crossing occurs at the magnetization saturation region, but the crossing becomes increasingly an ambiguous for D D.

We can check the U_L crossings obtained with D L and D 2L, to de nea "crossing critical tem perature" T_c (D;L). This "crossing critical tem perature" seems to approach a xed T_c (D) \notin 0 as L ! 1, for D > D. Figure 1 shows that the "crossing critical tem perature" obtained with the D L and D 2L systems for D > 6 tends to a xed tem perature value T_c (D) as L ! 1 in such a way that 0 Ξ (D) T_c (d = 2) with T_c (d = 2) = T_c (D = 1) = $\frac{1}{2}\ln(1 + \frac{p}{2}) = 2269185314$ as given by 0 nsager [19]. An inset in Figure 1 shows a triple crossing for D = 64.

The evolution of T_C (D;L) for increasing width D can be tted approximately by means of an exponential. We take T_C (D), the transition temperature, as the extrapolated value at L ! 1 . Table 1 gives the T_C (D) values for periodic and free boundary conditions using them ethod described above. A gain, we may note that T_C (D) is well de ned but always som ewhat overestimated in this way. It may be noted that the transition temperature T_C (D) for the same D value is higher for systems with periodic boundary conditions than for systems with free boundary conditions, i.e the nanotubes require more thermal energy than the strips to under go the phase transition, because their spins are more strongly bound due to the more stringent boundary conditions.

It is true that the B inder Cumulant m ethod, in particular the B inder Cumulant m ethod crossing M (T) data for two orm ore nite size lattices, f.i. D L; D 2L; D 4L ... is a phenom enological m ethod but it is well grounded in general scaling arguments and, used with appropriate care, produces very reliable results. Figure 1 shows that it is necessary to go to relatively large nanotube and nanostrip lengths in order to stabilize the crossing temperature, but, of course, T_c (D) begins to become very well de ned as D grows beyond D D.

As shown below to scale data properly for D 6 it is necessary to use T c (D) = 0, corresponding with B inder C um ulant but crossing at T = 0. W e m ight say that D ' 6 corresponds to a certain interm ediate e ective dimensionality 1 d 2, as discussed below in m ore detail.

Figure 2 gives 1 $\frac{T_{C}(D)}{T_{C}(d=2)}$ vs D for periodic (full circles) and free (open circles) boundary conditions in a log-log representation. The di erence between both sets of points show s the e ects of the boundary conditions on the critical tem perature. An inset in Figure 2 shows a susceptibility peak for D = 64. Note that the scaling prediction for

system s of dimensions D L is

and it does only hold for widths larger than D ' 6. This is in contrast to the thin In s case [10], in which the corresponding scaling prediction Equation (1) was fulled at any thickness with periodic boundary conditions. Thus, this plot serves to identity empirically D = 6, below which all strips are electively equivalent to linear chains for most practical purposes.

Figure 3 shows a tofTc(D)

to data for D = 16;32;64 (see Table 1) obtained with D = 6;m = 0:353 = 0:011. These T_c values are used later for scaling purposes.

W e m ay note that the B inder C um ulant crossings are always close to 2=3. This m eans that the values found are almost equal to the d = 1 B inder C um ulant value. In all cases the values found are always far from the d = 2 B inder Cumulant value [20]. This fact implies that the universality class of the nanotubes (and nanostrips) must be d = 1. This fact does not preclude the existence of elective critical exponents. In order to investigate the scaling behaviour of nanotubes with D from D = 2 to D = 16 > D = 6 we can use the following procedure: (a) for D 6 we may take Tc = 0, and note that the appropriate scaling variable for " is " = e^{4-T} (identical to the case of the one dimensional chain). We note that d=1 = 0 and 1 = d=1 = 2did not scale properly for all D values. Then we did tray di erent values for eff and $1 = _{eff}$: $_{eff}$ = 0 was correct for all D < D and $1 = _{eff}$ (D) was found to be $1 = _{eff}$ (2) ' 0:897 0:005; 1 = (4) ' 0:371 0:003: (b) On the other hand, for D D T C (D) 0, as given by Equation (3), and scaling was properly obtained with " = $\frac{\text{I} T_{c}(D)}{T_{c}(D)}$ using eff(6) ' 0:034 0:001 and 1 = eff(6) ' 0:176 0:005; $_{eff}$ (8) ' 0:0425 0:001 and $1 = _{eff}$ (8) ' 0:203 0:003; and nally (16) ' 0:040 and 1= (16) ' 0.247: This is illustrated in Figures 5-9. It may be noted that for D = 32and D = 64 the nanotubes (or nanostrips) begin to show that D is not properly D L with our data, L = 500;1000, and the transition begins to appear less well de ned, specially for the lower L value.

Using the one dimensional chain scaling " = $e^{4=T}$ instead of " = $\frac{\text{J} T_c \text{j}}{T_c}$ for D < D; we can check that the exponent _{eff} evolves from _{effxl=1} ' 1=2 towards _{effxl=2} = 7=4.

We note once m one that for L !~1~ and at T approaching very closely $T_{\rm C}$ (D) the elective exponents cross-over to the d = 1 exponents for any <code>niteD L</code>.

3. Concluding rem arks

In conclusion, our M onte C arb simulations show that: (a) T_c (D), which is a non-universal quantity, is T_c (D) = 0 for D < D = 6, and T_c (D) > 0;. It is well

approximated by Equation (3), being always smaller than T_c (d = 2) = 2:269185314; for D D = 6; (b) the universality class of nanostrips and nanotubes is onedimensional but their phase transitions behaviour shows a qualitative change at the critical dimensionality D = 6. Strips and tubes with very large D comparable to L are characterized by elective critical exponents approaching those of two-dimensional system s.

It is clear that strips and nanotubes with D nite must be considered always onedimensional systems. However our data show that regarding the transitions temperature T_C (D), there is a denite change of behaviour at D D 6: A closer analysis of the dependence on D of the elective critical exponents is left for further investigation.

It should be very protable to investigate the temperature dependence of the magnetization by means of exact transferm atrix calculations, possible in principle for D values up to D > D ' 6. For D = 2 such calculations con m unambiguously that the universality class is the same as for the linear chain (D = 1) with T_C (D = 2) = 0 but it would be interesting to see what happens for increasingly higher values. Valuable inform ation could be obtained in this way on the characteristics of the phase transition and perhaps on the functional form of the scaling function. This is left for further work.

We hope to have shown here that M onte C arb m ethods properly used, limited as they are, can provide very useful information on the phase transition features of low dimensionality Ising systems such as nanotubes and nanostrips.













Figure 4.E ective critical exponent $_{\rm eff}$ as a function of log $J\!\Gamma_{\rm C}$ (D) $\,$ T j for various thickness.








Figure 9. Scaling plot of the m agnetization for nanotubes of D = 16 and L = 500,1000 using " = $\frac{jT T_{c} j}{T_{c}}$ as scaling variable with T_c 1:525:
