P hase diagram s of the generalized spin $\frac{1}{2}$ ladder under staggered eld and dimerization: A renormalization group study

In the weak-coupling regime of the continuous theories, two sets of one-loop renorm alization group equations are derived and solved to disclose the phase diagram s of the antiferrom agnetic generalized two-leg spin $\frac{1}{2}$ ladder under the e ect of (I) a staggered external magnetic eld and (II) an explicit dimerization. In model (I), the splitting of the SU (2)₂ critical line into U (1) and Z₂ critical surfaces is observed; while in model (II), two critical surfaces arising from their underlying critical lines with SU (2)₂ and Z₂ characteristics merge into an SU (2)₁ critical surface on the line where the model attains its highest symmetry.

I. IN TRODUCTION

The physics of quantum phase transitions in onedim ensional system s has attracted m uch attention in recent years because not only of its speciality the conform al symmetries and universalities in (1+1)-critical models,^{1,2,3} but also of its generality the quantum criticalphenom ena in higher dim ensions.⁴ A general question is posed as follows: If a critical system de ned in the ultraviolet lim it is deformed by more than one relevant perturbations, what is the fate of the system? Can the criticality be reached again in the infrared lim it because of the \cancellation" e ect am ong these perturbations, thus a quantum phase transition takes place? A typical m odel of this sort is the so-called double-frequency sine-G ordon m odel, 5,6 where an Ising transition was thought to be driven by two competing relevant perturbations. The description of the phase transition requires a nonperturbative scheme being able to identify correctly those degrees of freedom that remain massive and the lowenergy ones that eventually becom e critical and undergo the transition.

The same strategy was extended to a more com plicated non-Abelian case a two-leg spin $\frac{1}{2}$ Heisenberg antiferrom agnetic ladder subject to a site-parity-breaking dimerization eld.7 The non-trivial aspect of the nonperturbative approach adopted in this study of the strong-coupling lim it of the model is that one has to preserve the SU (2) symmetry, which cannot be spontaneously broken, in the Ising m odel language which apparently has only a discrete sym m etry. This hidden sym m etry was realized when using very non-local duality transform ations for the coupled Ising models. An e ective low-energy Ham iltonian depicting the ensuing quantum phase transition was derived and the transmutation of all physical elds at the infrared xed point was identied. It was unam biguously shown that a quantum phase transition occurs from the universality class of SU (2) level 2 Wess-Zumino-Novikov-Witten (WZNW) model in the ultraviolet lim it to the universality class of SU (2) level 1 W ZNW model in the infrared lim it.

A nother possible scenario was set up by introducing a staggered magnetic eld, which explicitly breaks both SU (2) and bond-parity symmetries, to the generalized spin ladder.⁸ D epending on which phase the model belongs to in absence of the staggered eld, either U (1) or Z_2 criticality was predicted under the e ect of the staggered eld. An interesting new phase that interpolates between the Haldane spin liquid phase and the spontaneously dimerized phase was found beyond the transitions. The main features of this intermediate phase are: partially (transverse) coherent spin excitations and partially (longitudinal) non-vanishing string order parameter.

As we can see, the physics of the generalized spin $\frac{1}{2}$ ladder under the e ect of the dimerization or the staggered eld is very rich. In this paper, we shall scrutinize these two models in a more general perspective and try to understand the phase diagram s as a whole. Our main attention is to be paid to the overall topology of the phase diagram s; while the physical properties in various phases are only to be mentioned brie y if available.

The paper is organized as follows. In Sec. II, we present a short overview of the continuous version of our models. In Sec. III, we derive two sets of renorm alization group (RG) equations and central charge form ulas. These equations are (num erically) solved and analyzed in Sec. IV to bring about the phase diagram s of the continuous models. The implication to the ladder system s is sum marized and concluded in Sec.V.

II. MODELSAND THEIR CONTINUOUS FIELD-THEORETIC MAPPINGS

We consider a standard two-leg spin- $\frac{1}{2}$ antiferrom agnetic (J > 0) Heisenberg ladder (J₂) generalized to include a four-spin interaction (V):^{9,10}

superim posed by either a staggered m agnetic eld, m odel (I),

Throughout the paper, we treat the models only in the weak-coupling regime, providing

In this limit, the eld-theoretic approach in continuum is of advance and power in describing the low-energy physics of the models. In fact, the resulting H am iltonians are represented by four interacting M a jorana (real) ferm ions or, equivalently, four coupled Ising models.

A coording to R efs. 7,8,9,11, we have the follow ing m appings in terms of M a pranas ($_{\rm R\,;L}$) and Ising variables (;):

having an O (4) symmetry is inherited from two decoupled Heisenberg chains with SU (2) SU (2) symmetry, v Ja^{12} The mass terms result from part of the interchain coupling (J_2) and the four-spin interaction (V), both of which have the same scaling dimension, d = 1:

where the singlet (associated with 0) and triplet (= (1 ; 2 ; 3)) m asses are related to the parameters of the lattice spin m odel by

respectively. Here c and c^0 are some positive constants. The marginal term s are from the current-current part of the interchain coupling with scaling dimension d = 2:

where $g_1 = \frac{1}{2}J_2$ a and $g_2 = \frac{1}{2}J_2$ a , with (> 0) the marginally irrelevant coupling in the chains. Obviously, the symmetry of the continuous model H_{gen} is O (3) Z₂, corresponding to SU (2) Z₂ for the lattice model (1) (Z₂ arising from the interchange of two chains), unless J₂ = 0 when the highest symmetry of O (4) is reached, corresponding to SU (2) SU (2). The eld-theoretic counterparts of the staggered eld (2) and the dim erization (3) are represented, respectively, by

where with a magnitude order of the lattice constant is the short-distance cut-o of the theory. While H keeps the O (3) invariance for the triplet sector intact, H_h breaks this symmetry down to O (2) Z_2 . This is a relection of the oriented eld (2) lowers SU (2) to U (1) Z_2 .

In what follows, we shall address model (I):H $_{gen}$ + H $_{h}$, and model (II):H $_{gen}$ + H $_{h}$, in RG approach.Ourpurpose aims at drawing the phase diagrams by analyzing the infrared properties of the RG equations.

III. DERIVATION OF THE RG EQUATIONS

It is rather straightforward to establish the one-loop RG equations out of the operator product expansions¹ (OPE's) between the perturbative operators.¹³ For a criticalm odel perturbed by

where C_{UV} is the central charge of the unperturbed critical system (the ultraviolet xed point). In the present case, $C_{UV} = 2$ is the central charge of two decoupled chains. Undernormalization (13), the OPE coe cients c_{ij}^{k} are related to the three-point function hO_iO_jO_ki, and thus are complete symmetric among the indices (ijk).¹ Not only this procedure simplies the calculations, but also is it essential to give rise to a correct form for the central charge (16).

A. RG equations for model (I)

However, as we have known, the symmetry of model (II) is higher than that of model (I) | the O (3) symmetry in the triplet sector [i.e., the SU (2) symmetry in the original lattice model] should remain. In other words, the division of the triplet into doublet and singlet is futile in the present case. This fact is released in the RG equations also. From Eqs. (23), by reversing the signs of the coe cients involving c_{88}^2 , c_{88}^3 , c_{88}^5 , and c_{68}^6 , three of the eight equations are redundant, in plying $_1 = _2$, $_4 = _5$, and $_6 = _7$. As a result, the RG equations degenerate to

IV. SOLUTIONS TO THE RG EQUATIONS AND THE EMERGING PHASE DIAGRAMS

To analyze the infrared behaviors of our present m odels, in this section, we numerically integrate these two sets of RG Eqs. (23) and (29) to depict generic phase diagrams for the spin ladder under a staggered eld or dimerization. On account of the fact that for a system in a massive regime, the role of marginal coupling is usually exhausted by renormalizing the mass and velocity, it is reasonable to take no thought of these marginal perturbations at the outset and argue that the overall qualitative feature remains correct although the position and shape of phase boundary may not be exact. Let us begin with a known system | the generalized spin ladder (1)⁹ | as an example. A variant of this model includes four-spin ring exchange, which is believed to be relevant to some exotic properties in real ladder materials.^{16,17,18}

In the following we denote the bare ultraviolet couplings by $^{(0)}$ (L = 1) and the renorm alized infrared couplings by $^{(1)}$ (L = 1).

A. Phase diagram of the generalized spin ladder




FIG.1: Phase diagram of the generalized spin ladder. There exist two critical lines L:SU $(2)_2$ and L: Z_2 , and four massive sheets S:H⁽⁾ and S:SD⁽⁾. Notice the dimension the Haldane phases are only symbolic rather than a true order.

In this case, the RG equations are trivially $_{-1} = _{1}$ and $_{-3} = _{3}$. Unless the initial value (bare coupling) vanishes, $_{1}^{(0)} = 0$ or $_{3}^{(0)} = 0$, the system is always renormalized to some strong-coupling massive phase as L ! 1. Because of relations in Eqs. (20), $_{1}^{(0)} = \frac{m_{t}}{v}$ and $_{3}^{(0)} = \frac{m_{s}}{v}$, we conclude that $m_{t} = 0$ and $m_{s} = 0$ are phase transition lines on which the model become escritical. They belong to the universality classes of critical SU (2)₂ W ZNW model and Z₂ Ising model, respectively.⁹ As a base for our further exploration, we draw the phase diagram of the generalized spin ladder (1) in Fig.1.

A coording to R ef. 9, there are four massive phases divided by two critical lines. The second and fourth quadrants of the gure are two Haldane (H⁽⁾) spin liquid phases, and the rst and third quadrants belong to spontaneously dimerized (sD⁽⁾) phases. The \downarrow + = "sectors are actually related by duality of reversing the signs of the masses. The axis of abscissas represents a critical model with an SU (2)₂ W ZNW universality class (L SU (2)₂), and the axis of ordinates a Z₂ (Ising) one (L Z₂). A L though the Haldane phases and the dimer phases share

the feature of non-vanishing topological string order param eter in common and thermodynam ically they are indistinguishable, the symmetry of the ground state and the behavior of the dynam ical susceptibility are com pletely di erent.

(i) $S: H^{(+)}$ phase $\begin{bmatrix} 1 \\ 1 \end{bmatrix}^2 = +1$, $\begin{bmatrix} 1 \\ 3 \end{bmatrix}^2 = 1$]: Neither parity (site or bond) sym m etry nor translational sym m etry is broken. There is a coherent peak for the dynam ical spin susceptibility at $q_2 = , q , !$ jn_t j characterizing coherent S = 1 single-m agnon excitations.

(ii) S: H⁽⁾ phase $\begin{bmatrix} 1 \\ 1 \end{bmatrix} = 1$, $\begin{bmatrix} 1 \\ 3 \end{bmatrix} = +1$]: No symmetry breaking (except for the hidden string order). The peak is at $q_2 = 0$, q, ! $jn_t j$ instead.

(iii) S: $sD^{(+)}$ phase $\begin{bmatrix} 1 \\ 1 \end{bmatrix} = +1$, $\begin{bmatrix} 1 \\ 3 \end{bmatrix} = +1$]: The discrete site-parity and translational sym m etries are spontaneously broken. The corresponding order param eter is h(1)¹ (S_{1n} $p_{n+1} + S_{2n} p_{n+1})$ if 0 (0-phase). No coherent peak in the spin susceptibility (square-root singularity only).

(iv) S: sD⁽⁾ phase [$_{1}^{(1)} = 1$, $_{3}^{(1)} = 1$]: The discrete symmetries are broken with an order parameter h(1)¹ (S_{1;n} \mathfrak{F}_{m+1} S_{2;n} \mathfrak{F}_{m+1})i \mathfrak{s} 0 (-phase). No coherent peak either.

W e also show in the gure the directions of the lattice m odel parameters J_2 and V via relation (8), although the exact scales for the coordinates are not known. We nd that the standard ladder with positive, antiferro-(negative, ferro-) J_2 is in Haldane H⁽⁺⁾ (H⁽⁾) phase. The pure four-spin coupling model with $J_2 = 0$ is in the sD⁽⁾ phase when V > 0 or in the sD⁽⁺⁾ phase when V < 0. This is a special case with a higher symmetry.

It is also interesting to check in RG sense the ow of

the central charge. For this simple model we have

Considering this is a perturbative one-loop result and should not be taken seriously when approaches unity, we assume that we can m in ic the true xed point property by introducing a cuto in . If we are allowed to choose this cuto to be $\frac{2}{3}$, the correct central charges for both SU (2)₂ and Z₂ can be recovered, since for the form er when $(_1;_3) = (0; \frac{2}{3}), C = \frac{3}{2}$, and for the latter when $(_1;_3) = (\frac{2}{3};0), C = \frac{1}{2}$. The existence of the SU (2)₂ criticality was recently con m ed by a direct estim ate of the num erical value of the central charge.¹⁷

B. Phase diagram of model (I)

M odel (I) is the generalized spin ladder (1) in a staggered eld (2). The RG equations regarding the relevant perturbations now become

Evidently, the equations are invariant under the transformation $_8$! $_8$, which corresponds to h ! h in the original spin model. We need only deal with the positive case. At rst glance the system has two mathematical xed points: (a) ($_1$; $_2$; $_3$; $_8$) = (0;0;0;0) and (b) ($\frac{3}{4}$; $\frac{3}{4}$; $\frac{3}{4}$; $\overline{3}$). The one at the origin is an unstable xed point recounting two decoupled chains as our starting point; while the xed point (b) is fallacious. This is due to the fact that $_1$ and $_2$ are not completely independent, i.e., initially $_1^{(0)} = \frac{_{00}^{(0)}}{_2} = \frac{_{m_{t}}}{_{v}}$, rendering the xed point (b) physically unaccessible. How ever, the values in (b) do have full play in the the structure of the phase diagram.




FIG. 2: Phase diagram of the generalized spin ladder in a staggered eld. The massive phases occupying di erent blocks are separated by interfaces either second-ordered (enclosed by solid line) or with the transition nature unknown from the RG equations alone (dashed line).




FIG.3: Sectional plot of the phase diagram of the generalized spin ladder in a staggered eld: (a) $_{3}^{(0)}$ is a constant as 02. (b) $_{1}^{(0)} = _{2}^{(0)}$ is a constant as 02.

The emerging phase diagram of model (I) is shown in Fig. 2. It is notable that all the interesting phases lie in the rst three quadrants of the base and the fourth quadrant is in some sense rather barren. This is controlled by the $\$ xed point" (b) mentioned above. To make the structure clearer, we anatom ically plot gures in two intersecting planes (see Fig. 3). Various phases are labeled in the gures, where \B " denotes a block or bulk space that is always massive, \S " stands for a surface or sheet as phase boundary separating two di erent phases, which can be critical or rst-ordered, and \L " is an intersectional line of two sheets.

Now let us interpret in some detail the obtained phase diagram. We take the example with a parameter range where two consecutive phase transitions occur when increasing the staggered eld one belongs to the U (1) universality class; the other's property is not determ ined by the RG theory itself (probably rst-ordered). Suppose a generalized spin ladder o ers such a kind of parameters:

Now the system is subjected to a staggered eld. It is found when the eld is increased to




FIG. 4: Param etric plot of the RG ows across two phase transitions. The gures in the left column describe the ows in the vicinity of the U (1) transition, where the solid lines correspond to ${}_{8}^{(0)} = ({}_{8}^{(0)})_{c1}$, the dashed lines to ${}_{8}^{(0)} = ({}_{8}^{(0)})_{c1}$ 0:001, and the dotted lines to ${}_{8}^{(0)} = ({}_{8}^{(0)})_{c1} + 0:001$. The gures in the right column are in the vicinity of the second (unidenti ed) transition, where the solid lines correspond to ${}_{8}^{(0)} = ({}_{8}^{(0)})_{c2}$, the dotted lines to ${}_{8}^{(0)} = ({}_{8}^{(0)})_{c2} = 0:001$, and the dash-dotted lines to ${}_{8}^{(0)} = ({}_{8}^{(0)})_{c2} = 0:001$, and the dash-dotted lines to ${}_{8}^{(0)} = ({}_{8}^{(0)})_{c2} + 0:001$. Notice in panel (f) the dash-dotted line for ${}_{3}$ (L) eventually approaches +1 after an uptum that is not shown in the gure.

the system undergoes a second-order phase transition with a U (1) universality class (or Gaussian xed point). The behaviors of the RG ows in the vicinity of this transition is shown in Figs. 4 (a), (b), and (c). Below

the U (1) transition the system is in the bulk massive phase B: H⁽⁺⁾ characterized by the couplings renormalized to $\binom{(1)}{1}$; $\binom{(1)}{2}$; $\binom{(1)}{3}$; $\binom{(1)}{8}$ = (+1;+1; 1;0) (the dashed lines in the gures). At the transition, the infrared property becomes $\binom{(1)}{1}$; $\binom{(1)}{2}$; $\binom{(1)}{3}$; $\binom{(1)}{3}$ = (0;+1; 1;0) (the solid lines in the gures). Since 1 is proportional to the split doublet mass, m^d_t, it is bound to attribute this transition to a U (1) character. Now we are in the bulk phase of B: I characterized by (1;+1; 1;0) (the dotted lines in the gures). This is an interm ediate phase interpolating between the Haldane phase and the spontaneously dimered phase. The most distinctive features of this phase are that it has only transverse coherent spin excitations and longitudinal string order parameter. (For detailed properties, cf. Ref. 8.)

If the staggered eld is further increased to reach the point

the second transition occurs. The RG ows around this transition is shown in Figs. 4 (d), (e), and (f). At the transition the couplings are renormalized to (1;+1; 1; 3) (the solid lines in the gures). After the transition the system enters the $B:H^{()}$ phase characterized by (1;+1;+1;1) (the dash-dotted lines in the gures). Unfortunately, we can tell very little from the present scheme regarding the property of this transition. It may be a rst-order transition or even a crossover.

In this way, we are able to classify most of the phases and transitions by the infrared properties inferred from the RG equations. We summarize the main results as follows.

C om paring with the zero-eld case (previous subsection), we nd that three massive phases $sD^{()}$ and H $^{(+)}$ are essentially passed from their h = 0 counterparts directly except for the broken symmetry $_1 \in _2$. However, B:H () phase is di erent from S:H () in the sense that $\binom{(1)}{2}$! +1 instead of 1 and $\binom{(1)}{8}$! 1 instead of 0. Obviously, B: I is a totally new phase which has no zero-eld counterpart.

It is perspicuous that the critical surfaces split from the SU $(2)_2$ critical line and having U (1) and Z_2 criticalities correspond to the infrared xed points with $(_1;_8)$ / $(m_t^d;h)$! (0;0) and (2;8) / $(m_t^s;h)$! (0;0), respectively. The other Z_2 criticality is trivially same as and connected to the one when h = 0, $(_3;_8) / (m_s;h) !$

(0;0). At least one of the four unknown boundaries (dashed lines in Fig. 2 and 3) can be identied as Z_{2} , i.e., S: $[SD^{()}+H^{()}]$. The reason is to be shown soon. c. Lines :

These lines are intersections of two surfaces. The special values here are associated with the $\$ xed point" (b) of Eqs. (32).




FIG. 5: A top-view plot of the phase diagram of the generalized spin ladder in a staggered eld. The true phase boundaries in the base (h = 0) should be extended as shown by the arrows.

To close our discussion, we show in Fig. 5 a top-view of the phase diagram. The U(1) zone is con ned in a wedged area dem arcated by the SU (2)₂ line $\begin{pmatrix} 0\\1 \end{pmatrix} = \begin{pmatrix} 0\\2 \end{pmatrix} = 0$ and ${}_{1}^{(0)} = {}_{2}^{(0)} = \frac{1}{3} {}_{3}^{(0)} > 0$, i.e., $m_{t} = \frac{1}{3} m_{s} > 0$. The latter condition amounts to V = 0 and $J_2 > 0$ via relation (8), coinciding with the location of a standard spin ladder with antiferrom agnetic interchain coupling. The adjacent Z₂ region is delimited by condition ${}_{1}^{(0)} = {}_{2}^{(0)} = \frac{1}{5} {}_{3}^{(0)} < 0$. The trivial Z_2 region is within the Z_2 line $_{3}^{(0)} = 0$ and $_{1}^{(0)} = _{2}^{(0)} = 3_{3}^{(0)} > 0$. The unidenti ed sheet have $_{1}^{(0)} = _{2}^{(0)} = _{3}^{(0)}$ as its boundary in the base. This is a model with $J_2 = 0$, i.e., only four-spin interchain coupling. However, one might have noticed that there is som ething unnatural here. Considering the internal relation between the B:H⁽⁾ phase in the bulk and the S:H $^{()}$ phase in the base, we suggest in the true situation the boundary of this sheet should bend over to connect to the critical lines in the base (as shown by the arrows in Fig. 5). By combining the \integrating out" method and the study of the bosonized model, we observe that a Z_2 surface, connecting two axes, covers the whole third quadrant in Fig. 5.

C. Phase diagram of model (II)

Now we turn to Model (II), the generalized spin ladder (1) under dimerization (3). It follows from Eqs. (29) by retaining only the relevant couplings:




FIG.6: RG ows to the xed point $(_1; _3; _8) = (\frac{3}{4}; \frac{3}{4}; \frac{p}{3})$ (solid line) at $_1^{(0)} = _3^{(0)} = 0:1$ and $(_8^{(0)})_c = 0:137410$, and below $(_8^{(0)} = (_8^{(0)})_c = 0:001$, dashed line) and above $(_8^{(0)} = (_8^{(0)})_c + 0:001$, dotted line) the transition.

This is a model with an unbroken O (3) symmetry. As before, we have an invariance $_8$! $_8$ (i.e., !). In contrast with the previous model, now the system has really a xed point ($_1$; $_3$; $_8$) = ($\frac{3}{4}$; $\frac{3}{4}$; $\overline{3}$) besides the trivial one at the origin. This xed point occurs at $_1$ = $_3$, or equivalently m t = m s, corresponding to the pure four-spin coupling model (J_2 = 0) when the system has a higher SU (2) SU (2) O (4) symmetry. This is also the condition for the line where the SU (2)₁ sheet m erges the Z_2 sheet into the SU (2)₂ sheet. The RG ow s around this x point are shown in Fig. 6, where we choose the

initial values for the base quantities: ${}_{1}^{(0)} = {}_{3}^{(0)} = 0.1$. The initial value of the dimerization for the xed point is ${}_{8}^{(0)}{}_{c} = 0.137410$.




FIG. 7: Phase diagram of the generalized spin ladder under -phase dimerization.




FIG.8: Sectional plot of the phase diagram of the generalized spin ladder under dimerization.

The phase diagram of this model is plotted in Fig. 7, and Fig. 8 is for the sectional pictures of the same phase diagram, where we have labeled various phases. A s before, the classi cation of phases and criticalities is associated with the infrared properties of the system resulted from the RG equations.

Three massive phases H () and sD (+) are same as their = 0 counterparts. Since the sym metry of phase sD (+)is dimension the explicit dimension perturbation (3), it is still spontaneously dimension. However, B:D ()phase is dimension S:sD (), because now the system is explicitly dimension with the same symmetry of the perturbed H am iltonian. In the infrared lim it $\binom{(1)}{8}$! 1 instead of 0. It is also noticed from the gures that phase B:H⁽⁾ is restricted to a rather sm all region in the phase space. Thism ay not be the real situation (see discussions at the end of this section).

Like the case before, the identication of the SU $(2)_2$ and Z₂ criticalities is directly due to the fact that in addition to the dimerization ($_8^{(1)}$), the triplet ($_1^{(1)}$) and singlet $\binom{1}{3}$ masses are renormalized to vanish, respectively. How ever, the reference of the interface between phases $H^{(+)}$ and $D^{()}$ to an SU (2)₁ criticality is a bit subtle. This conclusion is drawn from other studies of the standard ladder under dim erization.^{7,19,20,21} In Ref. 19, a standard spin $\frac{1}{2}$ ladder with ferrom agnetic interchain coupling under 0-phase dim erization (the dual case of our present m odel) was sem iclassically m apped onto an 0 (3) nonlinear sigm a model with som e topological angle. The SU $(2)_1$ criticality is realized when this angle equals . On the other hand, an e ective H am iltonian was explicitly derived in Ref. 7 which describes the same transition in terms of a single spin- $\frac{1}{2}$ chain with bond alternation, and the transmutation of all physical quantities from the ultraviolet xed point to the infrared xed point was established. We have only one unidentied surface, S: $[H^{()}-D^{()}]$, in this model.

The only critical line in this model represents the xed point of Eqs. (39), the RG ow for the point on which is shown in Fig. 6. This is a very special line with a higher 0 (4) symmetry: it is not only the ridge line where all sheets m eet, but also the common boundary shared by all four phases (blocks) of the model.

Since the obtained phase diagram is grounded on the relevant part of the one-loop RG equations, the position of the phase boundaries may not be so correct. For instance, considering the intim acy between the bulk $B:D^{()}$ phase and the S: $SD^{()}$ phase in the base, most plausibly the SU (2)₁ sheet is connected to the SU (2)₂ line of = 0, and the boundary for the unidenti ed sheet is pushed to connect to the Z_2 line in the base (see F ig. 9). So the space for the bulk $B:H^{()}$ phase is considerably enlarged. This is supported by the fact that, as we have mentioned, the $(J_2 > 0)$ standard ladder (V = 0) undergoes the SU (2)₁ transition under the (-phase) dimeriza-




FIG.9: Top-view plot of the phase diagram of the generalized spin ladder under dimerization. The true SU $(2)_1$ sheet should connect to the SU $(2)_2$ line in the base, and the unidentied sheet to the Z_2 line in the base (as shown by the arrows).

tion. So the SU $(2)_1$ sheet cannot term inate at the location which is a result from the approximate RG Eqs. (39) as shown in Fig. 7.

V. SUMMARY AND DISCUSSIONS

Based on the one-loop RG equations and the assum ption that the relevant perturbations govern the relative structure of various phases in the parameter space, we have speculated from the infrared properties of these equations the phase diagram s of two related spin ladder m odels in the weak-coupling regim e.

In model (I), the external staggered eld breaks the SU (2) symmetry down to U (1) and Z_2 , so that the criticalities at most have the same symmetries and no room for SU (2) to live. Indeed, we nd both U (1) and Z₂ criticalities com e forth with the introduction of the staggered eld (see Fig. 2 and 5), which actually evolve from the underlying SU $(2)_2$ criticality in absence of the eld. The present result con m s the picture we obtained through a som ew hat di erent approach in Ref. 8. In that study, we literally integrated out the fast degrees of freedom associated with the singlet m odes close to the SU $(2)_2$ line and derived an e ective action which describes the triplet sector with an isotropy induced by the staggered eld. The vanishing of the split e ective triplet m ass m anifests the criticality accordingly. The new observation is that the interm ediate phase (B:I), which interpolates between the Haldane phase ($B:H^{(+)}$) and the dimerphase ($B:sD^{(-)}$), is restricted to a very lim ited region, and there should exist another (unidenti ed) transition which separates B: I phase from the large-h (Haldane) phase (B:H⁽⁾) which occupies most of the space in the phase diagram . From the infrared property (36), we see that B: I phase is quite unique entirely due to the staggered eld, and there is no resemblance preexisting when h = 0.

C om paring with m odel (I), m odel (II) is relatively sim – ple in the sense that the SU (2) sym m etry is unbroken and the O (3) sym m etry in the triplet sector remains, and the number of RG equations is thus reduced. All four bulk phases can basically be traced back to their counterparts when = 0. N one the less, as we have seen, the phase diagram of this m odel is by no m eans uneventful (see Fig. 7 and 9). The phenom enon extrem ely intriguing is the m erging of SU (2)₁ and Z₂ critical sheets into SU (2)₂ sheet. The inform ation encoded in the RG equations reveals that this occurs at som e critical dim erization strength $_{\rm c}$ (V) when the system has a higher O (4) sym m etry or SU (2) SU (2) in the original lattice m odel, i.e., J₂ = 0. The m erging line with SU (2)₂ criticality is shared by all four m assive phases of the m odel.

The benevolent aspect of our present theory is that we are able to assort di erent phases according to their infrared properties from the RG ow s, and the identi – cation of the critical sheets that energe from the underlying critical lines in the base should be reliable. These critical sheets, including two Z_2 and U (1) in model (I) and SU (2)₂ and Z_2 in model (II), can also be veri ed to exist²² by means of \integrating out" procedure em – ployed in Ref. 8, although the term inating positions of these sheets are unknown by this approach. How ever, as one may have perceived, the insolvency of the present

theory is that not all of the transitions can be attributed. E ven worse is the phase boundaries resolved from the one-loop equations may not be accurate. (See our suggestions for the modi cation of the phase diagrams in Fig. 5 and 9.) Therefore, although the topology of the phase diagram s we believe has been overall and qualitatively captured, the unwavering pin-pointing of the phase diagram s has to resort to other, say numerical, methods. For example, it is predicted here for model (II) of pure four-spin interaction (V), when increasing the dimerization, there is only one second-order (SU (2)₂) transition which connects directly two dimerized phases with mutually mism atched orders. If adding a bit positive J₂ coupling, one would expect two consecutive transitions: Z₂ and SU (2)₁ in a row.
