# M odi cation of the classical H eisenberg helim agnet by weak uniaxial anisotropy and m agnetic eld

C lassical ground state of the isotropic H eisenberg spin H am iltonian on a primitive B ravais lattice is known to be a single-Q planar spin spiral. A uniaxial anisotropy and external magnetic eld distort this structure by generating the higher-order Fourier harm onics at wave-vectors nQ in the spatial spin con guration. These features are not captured in the form alism based on the Luttinger-T isza theorem, where the classical ground state energy is m inimized under the \weak" condition on the length of the spins. W e discuss why the correct solution is lost in that approach and present an alternative m icroscopic treatment of the problem. It allows to nd the classical ground state for generalQ for both easy-axis and easy-plane uniaxial second-order an isotropy, and for any orientation of the magnetic eld, by treating the e ect of anisotropy (but not the eld) as a perturbation to the exchange structure. As a result, the classical ground state energy, the uniform m agnetization, and the m agnetic B ragg peak intensities that are m easured in experiment, are calculated.

#### I. IN TRODUCTION

For more than three decades, helical spin structures have been a subject of intensive studies. Having been discovered theoretically in the pioneering works of Yoshim ori<sup>1</sup> and Villain<sup>2</sup>, they were found experim entally in a large variety of materials. Most extensive work was devoted to the investigation and explanation of dient ordered phases and phase transitions in the rare-earth metals from Tb to Tm. These phases were shown to result from the intricate distortion of the incommensurate, almost ferrom agnetic exchange helim agnet by temperature and strong crystal eld anisotropies<sup>3,4</sup> How ever, for the reason discussed below, a classical treatment, nally generalized by Lyons and Kaplan<sup>5</sup>, predicts no such distortion in the ground state of the quasi-isotropic Heisenberg Ham iltonian at T = 0.

A simple but nontrivial example of the commensurate spiral is a triangularm agnetic ordering found in the hexagonalantiferrom agnets of C sN iC  $\downarrow$  type. Theirm agnetic structure consists of six sublattices, three in each hexagonalplane at an angle 120 to each other, whereas spins in the adjacent planes are antiparallel. Such com – pounds have recently attracted much attention because of their pronounced quasi-one-dimensional nature (exchange between the adjacent spins along the hexagonal axis is much stronger than that between the neighbors in the plane). Experiments<sup>6,7,8</sup> have demonstrated large deviations of the staggered magnetization and susceptibility in these materials from the results of the mean

eld (M F) calculations which should be valid for classical spins, S 1, and thus the importance of quantum

uctuations. Therefore, these are also excellent examples of quantum helim agnets which also have been recently

studied in the literature.9,10,11 Chubukov12 and Tanaka et. al.13 calculated classical spin reorientation process in magnetic eld (see also Ref. 14) and the antiferromagnetic resonance spectra in the hexagonal antiferromagnets of C sN iC by type on the basis of six-sublattice model. It appears that even for six sublattices the problem is very di cult to handle in this way, and essentially no explicit analytical results can be obtained for the spin-wave spectrum. Our motivation in the present work was to develop a sim pler and more general procedure for nding the classical ground-state spin con gurations, which would allow to perform reasonably unsophisticated spin-wave calculations. We adopt the approach sim ilar to that used by Nagam iya<sup>3</sup> and Kaplan<sup>4</sup>. Essentially, it is extension of the iterative procedure st suggested by Cooper et al.<sup>15</sup> for the easy-plane, alm ost ferrom agnetic spirals, to a general helim agnet. However, keeping in m ind its application to the commensurate antiferrom agnets, we will neither discuss here the incom m ensurability e ects, nor changes in the ordering wave-vector Q by the anisotropy and magnetic eld that occur for general Q position. These problems, as well as the incom m ensurate-com m ensurate transitions, were treated elsewhere in the fram ework of the phenom enological approach.<sup>16,17</sup>

W e start from the following spin Hamiltonian, which describes the low-tem perature magnetic properties of a large class of crystals where spins of the magnetic ions are localized at lattice sites,

Here the st term is the Heisenberg exchange interaction, the second term describes the lowest-order uniaxial

anisotropy, and the last term is the Zeem an energy ( is the gyrom agnetic ratio). The anisotropy arises from the magnetic spin-spin and spin-orbit interactions. Hence, the constant D incorporates a small relativistic ratio  $(v=c)^2$ , where v is the average velocity of the electron in the atom , and c is the velocity of light. This constant is usually considered to be small in comparison with the exchange coupling constants J<sub>ii</sub> which are of the electrostatic origin. This condition, however, can be violated in the quasi-low-dimensional magnetic materials, where the superexchange path along som e directions is indirect and the corresponding constants J<sub>ij</sub> are very sm all. A though such cases, as well as singlet ground state system s in which D is intrinsically very large may also be of interest, in the present paper we will always in ply condition jJ<sub>ij</sub>j€ 0 ful lled. W e also restrict our attention Ðј to the cases in which sum mation in (1) is perform ed over a single B ravais lattice with N sites.

In the spin-wave theory, the ground state and the excitation spectrum of quantum Hamiltonian (1) are obtained in a sem iclassical approximation, based on 1=S expansion. The starting point for such calculation is to nd an equilibrium spin con guration with the minim um ground state (GS) energy  $E_{GS}$  in the classical lim it, S ! 1 . In the case of the isotropic Heisenberg Ham iltonian, a rather complete spin-wave theory describing its low-tem perature properties has been developed.9,10,11 However, the problem becomes extremely complicated if the anisotropy which exists in real compounds is included together with the magnetic eld. In this case, even for classical helim agnets, very little general results were actually obtained. Som e particular cases were successfully treated in Refs. 3 and 15, but resulted in rather involved and hardly usable expressions (in part, because an attem pt to account for the six-fold anisotropy, in addition to the easy-plane anisotropy, made problem much more com plicated). Here we present calculation of the ground state spin con gurations for the Ham iltonian (1) for different orientations of the magnetic eld, and taking into account the anisotropy (but not the eld) as a rst-order perturbation of the exchange H am iltonian.

#### II. FAILURE OF THE WEAK CONDITION

It is known that ground state of a system of equivalent classical spins on a simple B ravais lattice, in the exchange approximation, is a at spin spiral described by a wave-vector Q (this includes ferrom agnetism (Q = 0) and antiferrom agnetism (Q = K = 2) as particular cases). A rigorous proof of this result is obtained by solving the mathematical problem of noting the absolute minimum of the function (1), which depends on 3N classical variables S<sub>1</sub>, under N conditions,

in posed on the lengths of the classical spins. This problem is solved by introducing N Lagrange multipliers i. Sw itching to the Fourier representation to use the lattice translational sym m etry, one obtains the following system of equations for spin con guration which m inim izes the H am iltonian

Here  $J_k$ ,  $S_k$ , and k are the lattice Fourier transforms of the functions  $J_{ij}$ ,  $S_i$ , and k, respectively;  $e_z$  is a unit vector along z direction, and  $k_{i0}$  is a three-dimensional K ronekker symbol. From Eq. (3) we easily obtain the classical ground-state energy as

There are two points to note here. First, Eq. (3) is a complicated inhom ogeneous system of nonlinear equations, for which no general solution is easily found. Second, the resultant ground-state energy explicitly depends only on the values of  $_0$  and S $_0$  (on the latter only if H  $\stackrel{\bullet}{\bullet}$  0), so all  $_k$  for k  $\stackrel{\bullet}{\bullet}$  0 seem to be irrelevant. This fact encourages one to bok for the solution for which the Lagrange multipliers have the form  $_k = _0 _{k,0}$  and the system is largely linearized. Evidently, such procedure is equivalent to taking into account only one of the N conditions given by the second relation in Eq. (3), or to replacing Eq. (2) by the so-called \weak" condition,  $_i S_i^2 = N S^2$ . This standard approach was form alized by Lyons and K aplan<sup>5</sup>. Then, the solution is easily found in the form of a single-Q spiral,

which is actually a correct result for D 0 and H along the z axis. In this case one can easily choose vectors S<sub>0</sub> and S<sub>Q</sub> in (5) that satisfy all N \strong" conditions (2) for any D, or for any direction of the eld, if D = 0. Thus, according to the Luttinger-T isza theorem, the resultant spin con guration is the solution of (3), is it m inim izes the energy (1) under the \strong" conditions (2).

Unfortunately, except for the above in portant but sim – ple cases, sim ple solution obtained in this way appears to be physically meaningless. For exam ple, for the negative (easy-axis) anisotropy, the H = 0 m agnetic structure predicted with the help of the \weak" condition is a collinear con guration with spins of varying length, parallel to the z axis.<sup>4</sup> This prediction, in particular, contradicts the experimental data in C sN iC l<sub>3</sub> and related compounds, where the easy-axis anisotropy is known to align the spin plane parallel to z-axis and to distort slightly the perfect 120 exchange structure, initially described by a spiral with  $Q = (\frac{1}{3}; \frac{1}{3}; 1)$ , in reciprocal lattice units (rlu). In fact, the \incorrect" collinear phase, corresponding to the longitudinal helim agnet, also appears in C sN iC L, in the narrow tem perature interval between the two T\_N  $^{18}. \label{eq:rescaled}$ 

The reason for this contradiction and inconsistency of the trick with the \weak" condition is the following. It is easy to see, that by weakening the conditions on the spin length one may obtain additional minima that do not satisfy Eq. (2). These artifacts are thrown away by verifying all the conditions explicitly. However, som e extrem a of the initial problem (3) are also lost in this way. This can be visualized by considering the energy surface (1) in the space of spin components, cut through by the \physical" manifold (2). If the real solution, is the globalm inimum, is one of the intersection points, it will be inevitably missed by employing the \weak" condition, since it is not an extrem um of the function (1) in the extended space.

# III. TRANSFORMATION TO THE LOCAL AXES




FIG.1: Transform ation to the local axes for the distorted exchange spiral.

In order to perform the spin-wave calculation, one denes the local coordinate axes,  $x_{i}y_{i}z_{i}$ , such that classical spin at a site i points in  $z_{i}$  direction. The spin operators are then transformed to these axes and expanded into a series in Bose operators, eg using Holstein-Primako transformation. Because the local axis  $z_{i}$  is a classical equilibrium direction for spin at site i, the linear in spin deviations (ie, in operators  $a_{i}^{+}; a_{i}$ ) term s are absent in the resultant boson H am iltonian. Starting from this point, one can develop a slightly di erent procedure to nd the classical ground state of the H am iltonian (1) and its sub-

sequent decomposition into a series in Bose operators. First, we transform the spins from the crystallogra cxyz frame to the local coordinate axes  $x_iy_iz_i$ . In general, this is achieved by two rotations: rst, by an angle  $_i$  around the y axis, and then by an angle  $_i$  around the new  $x_i^0$  axis, as shown in Fig.1. In the resultant local frame the spin operators are

Here the matrices  $T_{i}^{(a)}$  and  $T_{ij}^{(ex)}$ , which de ne the bilinear in spin components form s coming from the anisotropy and the exchange coupling, respectively, are given by

where  $_{ij} = _i _j$ . The angles  $_i$  and  $_i$  must be chosen so as to cancel the term s  $S_i^x S_j^z$  and  $S_j^y S_j^z$  which give rise to the linear, in  $\hat{a}_{i}^{\dagger}$ ;  $\hat{a}_{i}$ , contribution to the H am iltonian (8). This leads to the following system of 2N equations:

where  $\sim = =$ S.Evidently, this system for the angles  $_{i}$  and  $_{i}$  cannot be solved for arbitrary D and H.As it was mentioned above, only the cases D = 0 and D > 0, H k z can be treated explicitly<sup>1,11</sup>. However, we can start with the Heisenberg exchange H am iltonian in a magnetic eld

as a zero approximation and then bok for the corrections, expanding them in powers of D. A very similar approach was developed by Andreev and Marchenko<sup>19</sup> in the framework of the phenomenological Lagrangian theory. They found a rather simple and general solution of the problem in the leading order of perturbation.

#### IV. EASY-AXISANISOTROPY (D < 0)

First, we consider the more complicated case of the easy-axis anisotropy, which leads to the most general distortion of the exchange structure. W ithout the loss of generality we can set the magnetic eld to lie in the yz plane. In this case the \right" unperturbed spiral should contain the z axis already at H = 0. Therefore, we look for the solution of Eq. (11) in the form,

In most cases we will consider only the leading (ie, the lowest order in D) corrections  $_{i}$ ,  $_{i}$ . Thus, substituting (12) into (11), it is su cient to expand the trigonometric functions to the rst order in  $_{i}$ ,  $_{i}$ . As a result, we obtain the following equations for the deviations

which are rather easy to solve. Indeed, upon convolution with  $J_{ij} \cos(p r_{ij})$ , the variations  $_i$  and  $_i$  should yield the trigonom etric functions  $\cos(p r_j)$ ,  $\sin(p r_j)$ ,  $\cos(2p r_j)$ ,  $\sin(2p r_j)$ , etc, which must cancel the right-hand side of the Eq. (11). Thus, they should be searched in the form of an expansion,  $_i = _n (_n \cos(np r_i) + _n \sin(np r_i))$ , where the order of the coe cients  $_n$ ,  $_n$  is H  $^n$  and  $\mathcal{P}$  J<sup>=2</sup>.

An important remark is due here. One can also book for the solution of Eq. (11) with  $_{i} = + Qr_{i} + _{i}$ , instead of Eq. (12). It diers by rotation of the arbitrarily chosen \ rst" spin, and thus of the whole spin structure, by an angle within the plane of the spiral. Evidently, in the leading approximation (to the rst or-

der in D ) all such structures have the same energy, as it was the case for the pure exchange. This fact re ects the rem aining continuous degeneracy of the ground state with respect to such rotations. Moreover, by perform ing the corresponding expansions, it can be shown in a straightforward algebraic way that this degeneracy exists for all orders in H and D jup to n which satis es the condition ng 0, if such n exists. This condition m eans that spin structure is a commensurate spiral and can be described in terms of n sublattices. In this case the continuous degeneracy corresponding to spin rotations within the spiral plane is lifted in the order H  $^{n}$  and  $\mathfrak{P} \mathfrak{f}^{n=2}$ . The ground state preserves only n-fold degeneracy corresponding to the arbitrary choice of the \ rst"

spin, ie, to the rotation of all spins in the exchange structure by an angle (2 m)=n in the plane of the spiral. In the case of the incom mensurate helim agnet, where this discrete symmetry is absent, the continuous degeneracy of the ground state is not lifted.

The above conclusions can be established from very general argum ents. Evidently, a perturbation of the nsublattice exchange spiral by adding D  $_{1}\cos^{2}(+_{1})$  $_{i}\cos($  +  $_{i})$  to the exchange H am iltonian is and H invariant with respect to the transform ation ! + (2 m)=n. Thus, the perturbed ground-state energy should not contain harm on ics below cos(n) and sin(n). Hence, explicit dependence on the angle in its Taylor expansion with respect to the perturbation param eters D and H only appears in the n=2-th and n-th order term s, respectively. A nother way to establish this fact is based on exchange sym m etry argum ents<sup>19</sup>. Exchange structure with n sublattices has an n-fold rotation axis perpendicular to the spin plane. Thus, the low est-order perturbation of the exchange energy which has appropriate symmetry and which lifts such rotations must be proportional to cos(n). In the case of the uniaxial an isotropy which already contains the two-fold symmetry, it is achieved in the n=2-th order of perturbation. Magnetic eld, on the other hand, can lift the n-fold rotation axis characteristic of exchange spiral only in the n-th order of perturbation. With the continuous GS degeneracy removed, the energy gap appears in the corresponding (form erly) Goldstone mode. This gap is induced by an \e ective  $\mathfrak{P}^{n}\mathfrak{f}^{2}$ , or  $\mathbb{H}^{n}$ , and, therefore, is of the order eld"

 $\mathcal{D}^{n=4}$ , and  $H^{n=2}$ , respectively.

This situation was closely studied in the hexagonal C sN iC k-type antiferrom agnets, which are our reference in the present paper. It was shown, that in the easy-axis case the structure with = 0, described by Eqs. (12), is stabilized by the anisotropy in the third order of perturbation, and that the magnon gap  $\mathcal{D} \mathcal{J}^{=2}$  appears.<sup>20,21</sup> For the easy-plane antiferrom agnetic spiral in the transverse eld the situation is di erent (as we discuss later), and the structure with = = 2 is realized.<sup>12,14</sup> B elow, we consider the solution (12), which is stabilized by the easy-axis anisotropy, D < 0, for two in portant orientations of the magnetic eld.

## A. Magnetic eld perpendicular to z-axis

This eld orientation gives rise to the most general distortion of the exchange spiral. D eviations of the angles satisfying (13) are found in the form

Note, that according to these expressions, the anisotropy causes a small modulation of the spiral winding angle, ( $Q r_i$ ), which propagates as  $2(Q r_i)$ . This naturally results in appearance of the harmonics at wavevectors 2Q and 3Q in the lattice Fourier transform of the ground-state spin arrangement, in agreement with the early results of N agam iya et al,<sup>3</sup> and C ooper and E lliott.<sup>15</sup> A nother point to be mentioned here is that sm all variations (14), which are treated here in the linear approximation, actually contain term swhich increase with the magnetic ekd (the most dramatic is the second term in #, proportional to H<sup>2</sup>). Therefore, although these expressions are valid up to very high ekds, they fail near the spin- ip transition, at

In fact, this failure is indicative of a phase transition to a new spin arrangement of the \fan" type, that was considered in detail by Nagamiya et al.<sup>3</sup> A simple way to study this transition and the behavior of the system in the vicinity of the spin- ip eld H<sub>2</sub>, is to expand the angles <sub>i</sub> in small deviations from =2. This approach was applied in Ref.14, where the eld-induced transitions in the easy-plane triangular antiferrom agnet C sM nB r<sub>3</sub> were studied.

The classical ground-state energy corresponding to the spin arrangem ent of the globalm in imum found above can be easily calculated from Eqs. (7) (10),

where we have introduced the transverse spin susceptibility per site, as follows,

Spin structures are usually studied in neutron scattering experiments, by measuring the intensities of the magnetic B ragg peaks. At each k, these are proportional to the structure factor, is the square of the absolute value of the corresponding Fourier transform of spin density, S<sub>k</sub>, which, therefore, can be called a B ragg am plitude. Thus, for comparison with the experiment, it is important to calculate the nonzero B ragg am plitudes S<sub>k</sub> which result from the solution (14). Introducing the unit vectors  $e_x$ 

and ey along the x and y axes, respectively, we obtain,

In calculating the B ragg intensities,  $I_k = \beta_k \hat{j}$ , one has to keep in m ind that vectors  $S_Q$  and  $S_{3Q}$  have a nonzero im aginary part.

## B. Magnetic eld along z-axis; low elds

This case seems to be less complicated, since the distortion of the exchange spiral (5) occurs only at low edds,  $H < H_c$   $\overline{p} \overline{p} \overline{j}$ , and is such that it leaves the spins co-planar. This means that  $_i = 0$ , and that the second equation in (11) and in (13) is automatically satis ed. The rst equation is reduced to a rather simple relation, from which, to the leading order in D and H, the small deviations  $_i$  are,

It is clear from these expressions, that a leading order is insu cient for our approximation. To be consistent to the rst order in the anisotropy constant D , one has to gerform the expansions to the second order in  $\mbox{ H}$

A ctually, we can calculate the hom ogeneous component of the spin density, S<sub>0</sub>, (ie them agnetization) with better accuracy than in Eq. (21), to  $\mathcal{D} \stackrel{3=2}{J}$ . To be completely consistent in this order, one should add to <sub>i</sub> term s like  $\sin (30 r_i)$ , with  $\mathcal{D} \stackrel{3=2}{J}$ . How ever, retained in the rst order, these terms would not contribute to S<sub>0</sub>. For

our purpose it is therefore su cient to take  $_{i}$  in the form (18), and simply retain more terms in the subsequent expansions. In this way we obtain the following correction to S<sub>0</sub>,

This expression includes the leading nonlinearity of the magnetization, which is often important for com parison with experiment.

#### C. Magnetic eld along z-axis; high elds

This is the sim plest and the best-known case. At some critical eld,  $H_c$   $\frac{1}{D}$  jJ, a usual spin- op transition takes place, and structure becomes the same as that of the magnetized exchange spiral, (5),

These expressions hold up to a full saturation. The corresponding spin- ip eld,  $H_2$ , is de ned from the condition sin  $_0 = 1$ . Comparing the expressions (20) and (24) for the ground state energy, one obtains the following universal form ula for the spin- op eld  $H_2$ ,

#### V. EASY-PLANE AN ISOTROPY (D > 0)

For the easy-plane H eisenberg helim agnet, spin reorientation in m agnetic eld reveals no new features in addition to those described in the previous section. All spin con gurations occurring in this case have their exact analogs for the easy-axis helim agnet. Therefore, it is su cient to establish the correspondence between the cases. The simplest case is that of m agnetic eld directed along the z axis. The spin arrangement in this case appears to be exactly the same as in Sec. 4.3, and is described by the sam e expressions, Eqs. (23) and (24). H ow ever, here we must keep in m ind that constant D is now positive.

If the eld is applied in the easy plane, eg along the x axis, the spin arrangement in low elds is similar to that

described in Sec. 4.2. This correspondence, however, is not as direct as the one above. Since all spins lie in the same plane, the solution of Eqs. (11) is obtained with  $_i = =2$  and  $_i = Qr_i + _i$ . The rst equation is then autom atically satis ed, while the second one, for  $_i$ , becomes exactly the same as equation for  $_i$  in the case of a small eld along the z-axis in the easy-axis case, D < 0, H k z, H < H c, but with D = 0. Since now the symmetry breaking in the (easy) spin plane is di erent, we must consider two possible solutions.

A .F irst, we assume  $_i = \sin \varrho r_i + \# \sin 2\varrho r_i$ , which is exactly the same as considered in Sec. 4.2. In this case we nd that and # are given by Eqs. (18) and (19), but with D = 0. It is clear from the transform ation Eq. (7) that the resultant Fourier components of the spin density are given by the same expressions (21), only with  $e_x$  and  $e_z$  replaced by  $e_y$  and  $e_x$ , respectively. Evidently, such solution can be stabilized by the magnetic eld in the case of a nearly ferrom agnetic helim agnet, where spins tend to align along the eld direction.

B. Now consider the solution with  $_i = =2 + \cos Q r_i + \sin 2Q r_i$ . Parameters and # are again given by Eqs. (18) and (19). As discussed above, in our approximation this solution is degenerate with the previous (A), and di ers from it only by the phase multipliers in Bragg am plitudes,

It was shown by Chubukov<sup>12</sup> for the case of a sixsublattice commensurate helim agnet C SM nBr<sub>3</sub>, that it is a type-B structure that is stabilized by magnetic eld in the sixth order,  $H^6$ . A non-zero frequency, corresponding to the magnon gap  $H^3$ , appears in the magnetic resonance spectrum. Magnetic eld favors this solution for an antiferrom agnetic spiral because in this case it tends to align all spins perpendicular to its direction. In a general case of n-sublattice antiferrom agnetic spiral, structure (26) is stabilized by the magnetic eld in the n-th order, as we have discussed in Sec. 4.

Above the spin- op transition which occurs for H ? z and D > 0 at same  $H_c$ , given by (25), the spin structure becomes exactly the same as that discussed in Sec. 4.1 (assuming H  $\,$  k y), and is described by the same expressions, but with D > 0.

### VI. CONCLUSION

In this paper we presented a general perturbative treatment of the spin reorientation process for a weakly anisotropic spin spiral described by the classical Heisenberg spin Hamiltonian (1) in a magnetic eld. The calculations were performed up to the rst order in the anisotropy constant D. Previously, each particular case of this general problem was treated individually, typically in the fram ework of the multi-sublatticem odel. M any examples of such approach are found in the literature devoted to calculating the spin reorientation in \triangular" antiferrom agnets on hexagonal lattice.<sup>12,13,14</sup> A part from the loss of generality, in m any in portant non-trivial cases such calculations are very di cult and lead to involved form ulas which depend on a particular setup of the exchange couplings. As a result, in m ost cases neither the spin-waves spectrum, nor even the m agnetic resonance frequencies, can be calculated in an explicit analytical form on the basis of the sublattice m odel. In contrast, the description presented here is quite general, and the results are rather sim ple. They provide a solid basis for spin-wave calculations and for the estim ates of the spin-

uctuation contribution to the ground-state energy which can offen be very in portant (even for selecting the correct ground state). A lthough here we calculated the spin con gurations only for two principal orientations of the magnetic eld, the derivation can be easily generalized for any eld orientation. To this end, one must sim ply retain all relevant terms in Eqs. (11), (13), and adm ix the sin (Q  $r_i$ ) and cos(Q  $r_i$ ) rotations to the angle variations i, i. Thus, for example, some results reported in R ef. 14 can be obtained in a more general way.

As discussed above, one can treat the magnetic structures and the long-wavelength spin dynam ics within the perturbation approach based on exchange approximation in the fram ework of the phenom enological macroscopic Lagrangian theory, as was proposed by Andreev and Marchenko.<sup>19</sup> For the system's described by the Ham iltonian (1) the leading relativistic corrections are equivalent to our treatment of the anisotropy. The macroscopic

theory has the advantage of being less sensitive to the

uctuation e ects (the mean-eld ground state is chosen better, to partially account for the uctuations). However, it also has two substantial disadvantages in com parison with the m icroscopic description presented here. First, it is not aim ed at (and is not suitable for) calculating a m icroscopic spin-density distribution, or a spinwave spectrum in the whole Brillouin zone. Therefore, the results cannot be directly compared with neutron scattering experiments which are the most sensitive and powerful tool for studying spin systems. Second, to reproduce the higher-order e ects, such as nonlinear m agnetization given by Eq. (22), m acroscopic theory requires introducing additional phenom enological constants. It is clear, that m icroscopic theory which is developed here in the classical-spin approximation is far from being com plete, and requires additional treatment of quantum corrections. This point, as well as calculation of the spinwave spectra, are beyond the scope of this paper, and will be subjects of our further studies.
