## How do sound waves in a Bose-Einstein condensate move so fast?

## Abstract:

Low -m om entum excitations of a dilute Bose-E instein condensate behave as phonons and m ove at a nite velocity  $v_s$ . Yet the atom s m aking up the phonon excitation each m ove very slow ly;  $v_a = p=m ! 0$ . A simple \cartoon picture" is suggested to understand this phenom enon intuitively. It im plies a relation  $v_s=v_a$   $N_{ex}$ , where  $N_{ex}$  is the number of excited atom s m aking up the phonon. This relation does indeed follow from the standard B ogoliubov theory.

In a dilute, non-ideal Bose-Einstein (BE) condensate the spectrum of quasiparticle excitations is linear at low momentum: E (p) yp. Thus, long wavelength excitations are phonons | quantized sound waves | that travelat speed v<sub>s</sub>. The standard Bogoliubov theory gives this result and it is also expected on general grounds since hydrodynamics applies to any medium at long length scales.

However, this fam iliar result has a puzzling aspect to it. Very low momentum atoms move very slow ly while very low momentum phonons move at a nite speed  $v_s$ . But how can a phonon in a dilute medium move so much faster than the atoms that make it up? Surprisingly, this issue seems not to be addressed in the literature. The purpose of this brief note is to o er an intuitive explanation.

It is important to stress that the puzzle arises because we are considering a dilute medium. In solids and liquids, where the atom s are \touching" (separations less than the interaction range), a tiny motion of one atom can be transmitted almost immediately to its neighbours, allowing compression and other waves to move at speeds much greater than the speed of the atom s them selves. However, in a dilute gas with only short-range interactions (and theoretically the interatom ic potential can be replaced with a delta-function pseudopotential [1]) disturbances can only be communicated onwards by the atom s them selves travelling from one collision to the next. Thus, the disturbance should propagate no faster than the atom s' own speeds. Indeed, for an ordinary, classical gas the speed of sound is of order the average speed (rm .s. velocity) of the atom s for this very reason.

Of course, the above intuitive argument is inherently classical. One may immediately observe that it can fail in the BE-condensate case because the atoms are not localized entities | each atom's wavefunction spreads out over distances much greater than the interatom is spacing. While that observation is enough to remove any logical paradox it only shows that the trick is possible; it does not really explain how the trick is done. The aim here is to o er a more tangible intuitive picture. (It should be recognized, how ever, that any intuitive explanation of an inherently quantum phenom enon will necessarily involve an element of \quantum mystery" that is not satisfactorily explicable in classical terms.)

In the standard theory of a uniform dilute Bose gas [1, 2] the quasiparticle annihilation operators  $b_k$  are related to the atom annihilation operators  $a_k$  by a Bogoliubov transformation:

where n is the number density and a is the scattering length. (We set  $\sim = 1$ .) The quasiparticle spectrum is obtained as

where E (p) =  $p^2=2m$  is the original atom spectrum . The resulting Bogoliubov spectrum is

Thus, a low-momentum quasiparticle moves at a nite speed dE = dp  $\frac{1}{4} na=m^2$  y.

Due to interactions the ground state, even at zero tem perature, does not have all the atom s in the p = 0 m ode [1, 2]. The number of non-condensate atom s is

Substituting (1) and using the fact that the ground state is annihilated by  $b_k$  gives

(which leads to the familiar result for the depletion 1  $N_0=N=\frac{8}{3}\frac{na^3}{na^3}$ .) A similar computation in a one-quasiparticle excited state pi  $\frac{1}{2}$  Digives

which shows that an extra number  $N_{ex}$  of atoms have been excited from the condensate into the p and p m odes. Speci cally,

$$N_{ex} = N_{+} + N_{-} = \frac{1}{1 - \frac{2}{p}} + \frac{\frac{2}{p}}{1 - \frac{2}{p}};$$

Note that  $N_{+} = N_{+} + 1$ , giving a net m om entum p to the whole excitation.

W hen p is large one has  $_{\rm p}$  0, so that  $N_{\rm ex}$  1. Thus, a high-m om entum quasiparticle is essentially a single moving atom. For sm all p, however, one has  $_{\rm p}$  ! 1, so that  $N_{\rm ex}$ becomes very large. Thus, a low-m om entum quasiparticle (a phonon) is a coherent state of m any atom s with m om enta p and p.

Now we ask: W hat are all these excited atoms doing? ... and how does the collective excitation of slow-moving atoms manage to move so fast? As an answer we suggest the picture in Fig. 1.



Figure 1: Cartoon picture of a phonon. Solid arrows represent excited atoms with momentum p or p.Dashed arrows represent condensate atoms.




Figure 2: Spacetim e picture

This picture shows a series of \creations" (where two condensate atoms scatter into p and p atoms) and \annihilations" (where a p and a p atom scatter back into two condensate atoms). (E ach \creation" event \borrows" some energy that is repaid in the subsequent \annihilation" event.) The \creations" occur in rapid succession from left to right, resulting in an apparent motion at high speed. The situation can be seen more clearly in the spacetime picture, Fig. 2, in which each individual leg has a steep slope (the slope being the inverse of the atom speed), but the overall zig-zag path has a shallow slope (corresponding to the high sound speed).

O fcourse, this picture is not to be taken too literally since it assigns de nite trajectories to quantum mechanical particles. [W hat we have in mind is that path in Fig. 2, together with a set of similar, but more irregular zig-zag paths having the same average slope, form the class of paths that dominate the multiparticle path integral for the system .] Note that the arrangement of \creation" and annihilation" events in quick succession requires a sort of \conspiracy" | but one that is possible given the quantum coherence of the condensate as a whole. (This \conspiracy" represents the element of \quantum mystery" referred to earlier as unavoidable in any attempt to intuitively explain an inherently quantum - mechanical phenomenon.)

Let us exam ine som e consequences of the picture in Fig. 2 (taking it literally, despite our previous caveat). At any given instant, corresponding to the thin horizontal line, there are many excited atom s present; half left-moving and half (plus one extra) right-moving. If neighbouring creation events are separated in space by L and separated in time by then the overall speed of the zig-zag path | the sound speed | is  $v_s = L = .$  Let the time interval between a \creation" and a subsequent \annihilation" be T (with T when  $N_{ex}$  1). Each atom covers a distance L=2 in time T, giving an atom speed of  $v_a = \frac{L}{2T}$ . Hence the ratio  $\frac{v_s}{v_a} = \frac{L}{2T} = \frac{2T}{2T}$  Nex. That is, the spacetime in plies, for low m om entum, the form ula

Since the velocities follow from di erentiating the respective spectra, and since N  $_{\rm ex}$  is given by (8), the above equation is

This relationship indeed follows from (3) after some algebra, employing the properties of  $_{\rm p}$  of (2). In fact Eq. (10) is true at all p, although the connection with our \cartoon picture" is valid only for small p.

The preceding considerations do not x the absolute length scale. However, since Fig. 1 does indeed look like a density undulation with a wavelength L we would expect L to be 2 =p for momentum (wavenum ber) p. We can justify this relation, in order-of-magnitude terms, as follows. Each \creation" event \borrows" an energy 2E (p) =  $p^2$ -m, which is only \repaid" at the subsequent neighbouring \annihilations" at time T later. In the usual way this violation of local energy conservation can hide under the uncertainty principle provided T 1=(2E). This in turn implies that L 2T y  $\frac{2m}{p^2} \frac{p}{m}$ , and so L is of order 1=p, as expected.

Experiments, notably by K etterle's group [3, 4], have directly veried sound propagation in BE condensates. In such atom -trap experiments the longest wavelengths accessible are limited by the diameter of the cloud, hence  $p_{min} \sim =R$ , where R is the Thom as-Ferm i radius of the cloud in the appropriate direction. This consideration yields an upper lim it

where  $1 = \frac{p}{8}$  na is the healing length, related to  $v_s$  by  $v_s = - = (\frac{p}{2m})$ . The ratio of length scales m ay m ay also be written as [5, 2]

where  $a_{osc} = \bigwedge^{p} -m$  is the nom inal trap size, set by the angular frequency ! of the harm onic trapping potential.

For a typical <sup>87</sup>Rb trap with central density  $n = 10^{15}$  cm <sup>3</sup>, !=2 = 150 Hz, and a 5:3 nm one nds that  $v_s=v_a$ . 20. For the long <sup>23</sup>N a trap of Ref. [3] with 2R 450 m and 0.2 m, the maximum velocity ratio is about 250. However, since the length of the pulses created was only about 20 m, the actual  $v_s=v_a$  ratio for the phonon states studied was around 20. That is still well into the region where the \puzzle" of  $v_s$   $v_a$  is an issue.
