# $R$ igidity percolation in a eld

#### Abstract

$R$ igidity Percolation $w$ ith $g$ degrees of freedom per site is analyzed on random ly diluted E rdøsRenyigraphs w ith average connectivity, in the presence of a eld $h$. In the ( ;h) plane, the rigid and exible phases are separated by a line of rst-order transitions whose location is determ ined exactly. Th is line ends at a critical point w ith classical critical exponents. A nalytic expressions are given for the densities $n_{F}$ ofuncanceled degrees of freedom and $r$ ofredundantbonds. U pon crossing the coexistence line, $r$ and $n_{F}$ are continuous, although their nst derivatives are discontinuous. W e extend, for the case of nonzero eld, a recently proposed hypothesis, nam ely that the density of uncanceled degrees of freedom is a \free energy" for R igidity P ercolation. A nalytic expressions are obtained for the energy, entropy, and speci c heat. Som e analogies $w$ ith a liquid-vapor transition are discussed. Particularizing to zero eld, we nd that the existence of a $(g+1)$-core is a necessary condition for rigidity percolation $w$ ith $g$ degrees of freedom. At the transition point $c, M$ axwell counting of degrees of freedom is exact on the rigid cluster and on the $(g+1)$-rigid-core, i.e. the average coordination of these subgraphs is exactly $2 g$, although $c$, the average coordination of the whole system, is sm aller than 2g. $c$ is found to converge to 2 g for large $g$, i.e. in this lim it M axwell counting is exact globally as well.

## I. IN TRODUCTION

Scalar P ercolation (SP ) [1, 2] is a paradigm for the geom etric phase transition that takes place on an initially disconnected lattice of point-like sites, w hen the density $p$ of present bonds is continuously increased. A the percolation point $p_{c}$ the system becom es connected on a m acroscopic scale. This $m$ ay $m$ ean that transport can happen across the system (conductivity, uid ow ), or that the system becom es correlated on $m$ acroscopic scales, i.e. ordered. It is in fact possible to describe $m$ agnetic transitions in term s of the percolation of properly de ned chisters [3, 4, 5]. B ecause of the generality and sim plicity of the concepts involved, this paradigm has found multiple applications in science [1, [2, 6, 7]. In m ost cases, the physical variables attached to sites are scalars, i.e. each site has one associated degree of freedom.
A generalization of this paradigm considers the case in which there is $m$ ore than one degree of freedom per site, and has been term ed $R$ igidity P ercolation (RP) [ $\mathbb{C}, \mathrm{G}, 10$, 11, 12, 13, 14, 15]. In $g R P$, each site of a lattice has $g$ degrees of freedom, and each present bond elim inates one relative degree of freedom. The $m$ ost com $m$ only invoked application of RP deals $w$ th the statics of structures. Consider for exam ple the problem of bracing a fram ework in three dim ensions, i.e. rigidly connecting a set of point-like joints by $m$ eans of rotatable bars. E ach joint has three translational degrees of freedom, $g=3$, and

[^0]each rotatable bar xes the distance betw een tw o nodes, thus providing one relative constraint. The question of whether a given set of bars is enough to rigidize a given structure constitutes a classicalproblem in applied $m$ athem atics, that of raph R igidity [16, 17, 18]. In statistical physics, bonds (bars) are random ly present w ith probability p or absent w ith probability 1 p, and one asks for the typical rigid properties of such structures. U pon increasing the density p of present bonds, the system goes into the rigid phase, characterized by the existence of an extensive rigidly connected cluster. The RP problem becom es fully equivalent to $S P$ when $g=1$. $S P$ has a continuous transition in alldim ensions [1]. In tw o dim ensions the RP transition is continuous but in a di erent universality class [60] than $S P$. In the $M$ ean $F$ ield ( $M$ F) lim it, RP ( $g>1$ ) has a rst-order transition Ig, 20].
$T$ he situation is rem iniscent of the P otts m odel, whose MF transition is continuous for $q=2$ and discontinuous for $q>2$ [21, 22]. P otts $m$ odels in the presence of a eld, and their relation $w$ ith percolation $m$ odels, have been studied recently because of possible links w th the decon ning transition in Q CD 23, 24]. In the presence of a eld, and for large enough $q$, the $P$ otts $m$ odelhas a line of rst-ordertransitionsending at a criticalpoint 25, 26]. $T$ his criticalpoint appears to alw ays be in the Ising universality class.
N onzero eld values have been considered in scalar percolation studies previously [27, 28, 29, 30, 31, 32, 33]. A eld $m$ ay be introduced in percolation by allow ing for the existence of \ghost bonds" which are present w th probability $h$ and connect sites directly to a solid background (or to \in nity"). How ever, for any nonzero eld there is no SP transition. RP is som ew hat m ore interesting, as wewill nd out. In this work, RP is studied on
dihuted random graphs of the E rdøsRenyitype, w ith average connectivity , in the presence of a eld h. Unlike SP, m ean- eld RP has, in the presence of a eld, a line of rst-order phase transitions. This line ends at a criticalpoint w ith classical critical indices: $=0,=1=2$,
$=1$ and $=3$.
Som e of the analysis in zero eld is relevant for the related problem of B ootstrap Percolation (BP) [34, 35, 36, 37], also known as k-core [38] in the eld of $G$ raph $T$ heory [39, 40, 41]. In $k$ BP [34], all sites $w$ ith less than $k$ neighbors are iteratively culled. W hat rem ains, if som ething, is the k-core [38]; a subgraph were all sites have $k$ or $m$ ore neighbors. In $g$ RP a site needs at least $g$ bonds in order to be attached to a rigid cluster. Thus the \in nite" rigid cluster is a subset of the $g$-core. In Section IIB we will see that an even stronger condition exists for rigidity: $g R P$ requires the existence of a ( $g+1$ )-core [61].
O ur approach starts by deriving an equation of state for the \order param eter" R ( ;h), the probability that a random ly chosen site belongs to the rigid cluster, as a function of , the average num ber ofbonds im pinging on a site, and $h=H$, where $H$ is the applied eld. W ewill callH orh indistinctly the $\backslash$ eld" variable. The equation of state, as is custom ary in these cases, is found to accept $m$ ultiple solutions. Stability analysis is not enough to single out a unique solution. Of central im portance in order to lift this multiplicity are $r(; h)$, the average num ber of \redundant" bonds per site (see later), and $n_{F}$, the average num ber of uncanceled degrees of freedom per site. Their relevance resides in the fact that they $m$ ust be continuous functions of. Requiring that $\mathrm{n}_{\mathrm{F}}$ (or, equivalently, r) be continuous is enough to identify the physically correct solution.
This work is sim ilar in spirit to previous treatm ents of RP in zero eld on B ethe lattioes 20], i.e netw orks where each site has exactly $z$ random ly chosen neighbors. W e consider the e ect of an extemal eld, and particularize to random graphs of the E rdøsRenyitype [42]. The introduction of a eld appears to be $m$ uch $m$ ore tractable analytically on E rdosRenyi graphs than on Bethe lattioes, and th is is the $m$ ain reason why $m$ ost of the results presented here are for E rdøsRenyi graphs. For these, we are able to derive analytic expression for the densities $n_{F}$ of uncanceled degrees of freedom and $r$ of redundant bonds for arbitrary values of the eld. H ow ever in zero eld calculations are also straightforw ard for B ethe lattices, and allow us to obtain, in an entirely analytic fashion, som e of the results obtained by num erical integration in Ref. [20].
It is known that $S P$ and Potts models are particular cases of a m ore general Fortuin- $K$ asteleyn $R$ andom $C$ luster (RC) m odel, de ned by a continuous param eter q [43, 44]. SP can be obtained as the $q!1$ lim it of this $R$ andom $C$ luster $m$ odel and, in this lim it, the logarithm of the partition function coincides $w$ th the average num ber of connected clusters. It seem s possible that a sim ilar $m$ apping $m$ ight exist for RP as well, although it
has not been found up to now. H ow ever it has been proposed [20, 45] that the num ber of uncanceled degrees of freedom $n_{F}$ is a good \free energy" candidate for RP in zero eld. W hen $g=1$, each connected cluster has one uncanceled degree of freedom, so both de nitions coincide in this lim it. W e explore on this idea further in this work.
It is possible to establish a pedagogical parallel betw een the RP transition and a C ondensation transition. O ne identi es the coordination param eter $w$ ith an inverse tem perature ; the negative of the order param eter $R$ plays the role of the uid volum e V (it is also possible to identify R w ith , the uid density) 62], and the eld $\mathrm{H}=\mathrm{h}=$ is the uid pressure P . W thin this analogy, it results natural to argue that requiring the continuity of $n_{F}$ in order to identify the physically correct solution $R$ in $R$ igidity Percolation is equivalent to requiring the continuily of the free energy (giving rise to the M axw ell construction) in the Statistical $M$ echanics treatm ent of condensation transitions at the M F level [46].
It is show $n$ in this work that the idea of identifying $n_{F}$ w ith a free energy for RP leads to consistent results in the presence of a eld as well. In Section V I it is show n that: 1) the order param eter $R$ is obtained as a derivative of the free energy w ith respect to the eld, 2) the condition of stability (Section IIIC) m ay be related to the positivity of a suitable second derivative of the free energy, and, 3) the continuity of $n_{F}$ can be cast exactly in the form of $M$ axw ell's Rule of EqualA reas on the RP equivalent of a $\mathrm{P}-\mathrm{V}$ diagram (which is the $H \mathrm{R}$ diagram, see Fig. (7).
This w ork is organized as follow S : T he system under consideration is de ned in Section IIA, and its equation of state is derived in Section IIB, establishing its connectionsw ith B ootstrap P ercolation. In Section IIC the eld is introduced. Section III starts the analysis of solutions of the general equation of state, discussing stability and the existence of a critical point. The concept of redundant constraints is introduced in Section IV A and their density is calculated in Section IV B. This result is used in Section V to determ ine the value c where the rstorder transition takes place. In Section V B, the counting ofconstraints is done on the ( $g+1$ )-rigid core in zero eld, both for $E$ rd ${ }^{\circ}$ R enyigraphs and for $B$ ethe lattices. Section VI discusses several consequences of identifying the density of uncanceled degrees of freedom w th a free energy, and Section V II contains a discussion of the results.

## II. SETUP

A. R andom ly diluted graphs

W e consider graphsm ade ofN sites (or $\backslash$ nodes") where each of the $N(\mathbb{N} \quad 1)=2$ pairs ofdistinct sites is connected by a bond (or ledge") independently w ith probability p. This de nes 42] an E rodssRenyigraph w th average coordination number $=p(\mathbb{N} 1)$. In this work $w i l l$ be
taken to be oforder one．For large $N$ ，a site of th is graph is connected to k other sites w ith poissonian probability $P_{k}()=e \quad{ }^{k}=k$ ！．
A s appropriate for $R$ igidity $P$ ercolation，each node of th is graph is regarded as a \body＂w th $g$ degrees of free－ dom．For exam ple，rigid bodies in d dim ensions have $d$ translational degrees of freedom phus d（d 1 ）$=2$ rota－ tional degrees of freedom，for a total of $g=d(d+1)=2$ ． In this work，$g$ is taken to be an arbitrary integer．Each present bond represents one constraint，that is，rem oves one degree of freedom．In order to have a physical repre－ sentation in $m$ ind，a bond can be though of as a rotatable bar that xes the distance between two arbitrary points belonging to the bodies it connects［15，47］．For the class of graphs that we consider，at m ost one bond is allow ed for each pair of nodes．
A s the num ber ofpresent bonds grow $s$ ，parts ofth is graph willbecom e \rigidly connected＂．R igid connectivity of a subgraph $m$ eans（this is our de nition）that the total number of degrees of freedom in the system cannot be further reduced by additional bonds connected betw een nodes of this subgraph．Such subgraphs are custom arily called \rigid chusters＂．A rigid chuster has no intemalde－ grees of freedom left．W hen the coordination is large enough，the largest rigid cluster encloses a nite fraction of the system＇s sites，and rigidity is said to percolate．For low the system is in the exible，or oppy，phase，and there are no extensive rigid clusters．
A rough estim ate of the threshold for the appearance of an extensive rigid cluster can be obtained by equat－ ing the average number of constraints per site，which is $=2$ ，to g ．This results in the so called $M$ axwell es－
 becom es exact in the $g \gg 1 \mathrm{~lm}$ it（Section VB）．

## B．The Equation of State in zero eld

Let us now de ne $C$ to be the largest rigid cluster in the graph，if one exists．A site in C w ill be said to be a \rigid site＂．Let R be the probability that a random ly chosen node ibe in $C$ ．In order for ito be in $C$ it is necessary and su cient that it be connected to $g$ or $m$ ore other nodes $j$ in C．Our de nition of rigidity is thus recursive at this stage．
A site $j$ is rigid and connected to iw ith probability pR ． Therefore i has exactly $k$ rigid neighbors $w$ ith probabil－止 ${ }^{N}{ }_{k}{ }^{1}(\mathrm{pR})^{\mathrm{k}}(1 \mathrm{pR})^{\mathrm{N}} \mathrm{l}^{\mathrm{k}}$ ．For N large and de ning $x=R$ ，the probability $P_{k}$ to have exactly $k$ rigid neigh－ bors $m$ ay be w ritten as

show ing that the num ber $k$ of rigid neighbors of a ran－ dom ly chosen site is a poissonian variable w th average $x=R=l_{k=0} k P_{k}(x)$ ．Since a sitem ust have $g$ orm ore rigid neighbors in order to be itself rigid，w e conclude that

## B ootstrap P ercolation，or $k$－core

Let us now brie $y$ discuss the related problem of oot－ strap P ercolation［34］or $k$－core［38］．W e want to assess the probability BP $(g+1)$ that a random ly chosen site i be part of the $(g+1)$－core．A ssum $e$ this is the case．By follow ing one of its links，a neighbor $j$ is reached．j m ust have at least $g$ other neighbors．W e call these neigh－ bors of $j$ ，other than the site $i$ from which we arrived at it，the loutgoing＂neighbors of $j$ ．Each of these in tum $m$ ust have $g$ orm ore outgoing neighbors，and so on． $M$ ore form ally，let us de ne the property of $g$－outgoing－ connectedness（ $g-0 C$ ）in the follow ing（recursive）way： A site is $g-0 C$ if $g$ or $m$ ore of its outgoing neighbors also are．
On graphs of the ErdøsRenyi type，the probability to have $k$ outgoing neighbors is the sam e as that to have $k$ neighbors altogether，i．e． $\mathrm{P}_{\mathrm{k}}$（ ）（Eq．（⿴囗⿱一一 ））．This is so be－ cause links are independently present．Letting $\hat{R}$ be the probability that a site be $g-0 C$ ，by the sam e reasoning as in the previous Section we conclude that a random site is connected to exactly $k$ outgoing $g-O C$ neighbors $w$ th probability $P_{k}(\hat{R})$ ．Thus $\hat{R}$ satis es the sam e self－ consistent equation（2）asR does in the RP problem w th g degrees of freedom，i．e．

$N$ otice that，by requiring that each site in a tree have $g$ orm ore $\mathrm{g}-\mathrm{O} \mathrm{C}$ neighbors we ensure that all sites，except perhaps for the top one，have $(g+1)$ orm ore neighbors． The probability BP $(g+1)$ that the top site itself has $\mathrm{g}+1$ orm ore neighbors（which are $\mathrm{g}-\mathrm{OC}$ ）is then given by

This expression gives the density of the $(g+1) B P$ in－ nite cluster，（or $(g+1)$－core）at the point where it rst appears［34，39，41］．So one m ust rst solve（1）in order to obtain $\hat{R}$ as a function of，and then use（5）to nd BP $(g+1) . N$ um erical results［63］show that（5）is exact for large $N$ ．
$W$ e see that the $(g+1)$－core density $P B(g+1)$ is som $e^{-}$ what sm aller than $\hat{R}$ whenever $\hat{R}>0$ ，while $\hat{R}$ in tum satis es the sam e equation as the density $R$ of rigid sites in $g$ RP．Later in Section V B we will see that in zero
eld，whenever there is a $g$－rigid cluster，it contains as a subset the $(g+1)$－core．

## C. Equation of State in the presence of a ghost eld

W e now introduce a \ghost eld" H that couples to the order param eter $R$, in the follow ing way [32]: in addition to the \norm al" bonds of our graph, a num ber $\mathrm{N} H=\mathrm{N}$ h of \ghost-bonds" are assum ed to exist, each connecting one site to a unique rigid background [64]. Each ghost bond provides one constraint, i.e. rem oves one degree of freedom. M ultiple occupation is allowed, so that a random site is connected to the background by $n$ ghost bonds $w$ ith poissonian probability $\mathrm{P}_{\mathrm{n}}(\mathrm{h})=\mathrm{e}{ }^{\mathrm{h}} \mathrm{h}^{\mathrm{n}}=\mathrm{n}$ !.
It is easy to see that allextensive rigid clusters are rigidly connected to the background. From now on, a site is said to be rigid if it is rigidly connected to the background, either directly through ghost bonds, or indirectly through rigid neighbors.
If a site has $n \quad g$ ghost edges connecting it to the background, then it is rigid. O therw ise if $n<g$, it is rigid if it has, in addition to these $n$ ghost bonds, ( $g$ n) or m ore rigid neighbors. Thus using (1) we m ay write, in the presence of a eld $h=H$,

A fter a sim ple resum $m$ ation, this expression reads

w th $\mathrm{G}_{\mathrm{g}}$ given by (3). Eq. (7) generalizes (2) in the presence of a eld, and is the equation of state for our problem.
The sim plicity of (7) is one of the reasons leading us to study this particular (P oissonian) de nition of the eld. Other eld de nitions, like for exam ple assum ing that each site is rigidly attached to the background w ith probability h, or other random graph structures like B ethe lattioes [20] are also tractable $w$ th the $m$ ethods used here, but the algebra becom es $m$ ore com plicated.
$C$ learly $y=(H+R)$ plays the role of a $\backslash W$ eiss eld" in the MF equation for a ferrom agnet. By analogy we $m$ ay thus identify as the inverse tem perature, and $H$ as the $m$ agnetic eld. It is illustrative to take notice of the sim ilarities betw een (7) and other M F equations. For the P otts m odel [49],

where is the inverse tem perature, $m$ is the $m a g-$ netization, $h=H$ is the extemal eld, and $q(y)=\left(e^{y} \quad 1\right)=\left(e^{y}+\left(\begin{array}{ll}q & 1\end{array}\right)\right.$.
N otioe that when $\mathrm{g}=1$ (Scalar P ercolation), 7) gives $G_{1}(y)=1 \quad e^{y}$, the same as (8) for $q=1$. This is of course just a consequence of the known equivalence betw een Scalar P ercolation and the q ! 1 lim it of the P otts m odel[43, 44].

H ow ever, the archetypal exam ple of a rst-order transition $w$ th a two-param eter phase space is the condensation transition [46], described at the $M$ ean $F$ ield levelby the $V$ an der $W$ aals equation. The reduced form of the Van der $W$ aals equation can be w ritten as

where $(y)=27 y^{2}=(y+8)^{2}, P$ is the pressure, is the inverse tem perature and $=3^{2} \mathrm{w}$ th the number density. has the sam e general features as G and , nam ely it starts at zero, grow s shanply, and saturates for large values of its argum ent. T herefore all three system s give rise to the sam e phenom enology, including of course sharing the sam e (classical) critical indioes at their critical points.
$W$ thin an analogy w ith a condensation transition, in the RP problem plays the role of an inverse tem perature, while $H=h=$ plays the role of a pressure.

## III. ANALYSIS OF SOLUTIONS

In this Section, the solutions of our equation of state 77) are discussed. In order to obtain R ( ;h) num erically for given and $h$, onem ight for exam ple iterate (7) until a desired num erical accuracy is reached. This procedure was used in Refs [19, 20]. H ow ever in this work the follow ing altemative procedure w as preferred: given $h>0$ xed, and for a sequence of values of $y>h$, evaluate

thus de ning $R(; h)$ im plicitly. In this way one obtains the results displayed in F ig. (1). T his procedure allow $s$ us to obtain all solutions of 7), while the iterative procedure $m$ entioned above only provides the stable branches.

In zero eld, $\mathrm{R}=0$ is a solution 8 and 8 g . If is large enough, nontrivialsolutions $R>0$ exist aswell. Ifh $>0$ one has on the other hand that $\mathrm{R}>08$.
In the SP case $(g=1), G_{1}(x)=1 \exp (x)$. Thus if $h=0$ a non-zero solution for $R$ rst appears at ${ }_{c}=1$. Above c one has R (1). In this case there is a continuous transition at $=1$, a well known result for scalar percolation on random graphs [42]. If h > 0 there is no transition ( $F$ ig. (1).
A richer behavior is found for the RP case ( $g>1$ ), as shown in $F$ ig. 1 for $g=2$. In this case, as given by Eq. (10), m ay no longer be a m onotonous function of $y$, and, for this reason, $R$ becom es a $m$ ultivalued function of
. This allow s for the existence of a rst-order transition. The physical considerations which lead to the identi cation of the correct transition point will be discussed in Sections IIIC and V.

A. Spinodal Points

T he condition that asgiven by Eq. (10) be stationary in $x$ reads

and has tw $\circ$ solutions $x^{s}(g ; h)$ for all $h$ smaller than $a$ critical value $h(g)$. These two solutions in tum de ne ${ }^{s}$, which are tuming points for $R($; h ) ( See F ig. (2). In the interval ${ }_{+}^{\mathrm{s}} \ll{ }^{\mathrm{s}}, \mathrm{R}(\mathrm{i})$ has three solutions, two of which are stable as we show next. Therefore a discontinuous -driven transition takes place when $\mathrm{h}<$ $h(g) . R$ ight at $h=h$ the transition becom escontinuous (See Section IIIB), while for $h>h(g), R$ is a sm ooth function of and no transition occurs.
The thresholds s can be identi ed as spinodalpoints, as rst discussed in [20]. The true rigidity percolation transition happens at a value $\mathrm{c}(\mathrm{g} ; \mathrm{h})$ that lies in betw een the spinodals, and which we analytically determ ine later in Section V .

For zero eld the spinodal goes to in nity, and the branch 0 collapses onto the $\mathrm{R}=0$ solution, which is stable for all.

## B . C ritical P oint

## 1. C ritical Indices

TheRP transition on random graphs is sim ilar to other M F transitions w ith rst-order lines, as discussed in Section IIC. Thus it can be concluded that RP must have classical critical indices: $=1=2,=3$ and $=1$. For com pleteness we show that this is indeed the case by deriving the critical indices brie $y$ in $A$ ppendix $B$.
C. Stability analysis

Stability can be analyzed if Eq. (7) is interpreted as a recursion relation,

This condition has a sim ple physicalm eaning: increasing the average connectivity should not decrease the rigid density R. A sim ilar stability condition holds for
uids, nam ely that the coe cient of them al expansion be positive.

## 1. Scalar Percolation ( $g=1$ )

In zero eld, $R=0$ is a solution of Eq. (T), thus a xed point of Eq. (15), 8g. If $g=1$, stability (Eq. (17)) requires that $P_{0}=e^{R}<1$. Thus the trivialsolution $R=0$ becom es unstable for $>1$, where the nontrivial solution (stable because $d R=d \quad>0$. See $F$ ig, (1) rst appears. This situation is typical of continuous transitions; the ordered solution appears exactly at the point where the param agnetic solution becom es unstable.
W hen $\mathrm{h}>0$ there is only one solution for Eq. 7), and it is stable for all since $d R=d>0$ (Eq. (18)).

## 2. R igidity P ercolation ( $g>1$ )

For $g>1$ the situation is $m$ ore interesting, as several stable solutions of E q. (7) can coexist. If h h , Eq. (7) has three solutions (see Fig (2) in the range ${ }^{s} \gg{ }_{+}^{s}$. The branch joining the two spinodal points can be discarded since it is unstable (because $d R=d<0$ ). H ow ever the other tw o branches (solid lines in Fig. 2) are stable so that there is coexistence of two stable solutions for $s \gg{ }_{+}^{s}$. Thus the system undergoes a -driven rst-order transition som ew here betw een the spinodals. The precise point $c$ at which the system sw itches from one stable solution to the other is uniquely de ned by a continuity requirem ent, as we elaborate later in Section V .
The h = 0 case is sim ilar, how ever in this case the low est stable branch collapses onto the trivial solution $R=0$, while the spinodal goes to in nity.

## IV. ZEROMODES,REDUNDANTAND OVERCONSTRAINED BONDS

In this Section the counting of uncanceled degrees of freedom and the useful notions of redundant and overconstrained bonds are discussed. These w ill.be of central im portance in our subsequent treatm ent of the R P problem.
A. De nitions
$W$ e consider a graph $m$ ade of $N$ sites, each $w$ th $g$ degrees of freedom, and for the $m$ om ent assum $e$ that $h=0$, i.e. there are no ghost- eld constraints. Each present bond rem oves one degree of freedom from the system, unless it is a redundant bond. A redundant bond (or constraint) is one that links two nodes which were al ready rigidly connected, as for exam ple nodes $i$ and $j$ in F ig. 3. The addition of a redundant constraint does not reduce the num ber of degrees of freedom in the system. $T$ hus the balance of degrees of freedom reads

that its two end-nodes are rigidly connected even if b is rem oved. Let $B_{b}$ be the subset of bonds that, in the absence of b , provide rigidity to its two end-nodes. A fter adding b , any of the bonds in $\mathrm{fB}_{\mathrm{b}}+\mathrm{bg}$ (thick lines in $F$ ig.(3) can be rem oved w thout altering the totalnum ber of degrees of freedom $N_{F}$. The subset ofbonds $\mathrm{fB}_{\mathrm{b}}+\mathrm{bg}$ is said to be overconstrained. From a physical point of view, the overconstrained bonds $m$ ay be de ned as those that carry an intemal stress because of the addition of a redundant bond $b$ that has a length $-m$ ism atch.
$P$ lease notice the im portant di erence betw een the num ber of redundancies and the num ber of overconstrained bonds: when adding a redundant bond (like ij in F ig. (3) the num ber of redundancies $B_{r}$ alw ays increases by exactly one. H ow ever the num ber of overconstrained bonds $m$ ay increase by $m$ ore than one. In the exam ple shown in $F$ ig. 3, the num ber of overconstrained bonds increases by twelve.
W e then conclude that, when adding any bond to a graph, the number of redundancies $B_{r} w$ ill either increase by one (if the chosen sites w ere rigidly connected) or stay unchanged (if not), in which case the num ber of zero m odes $\mathrm{N}_{\mathrm{F}}$ will either stay unchanged or decrease by one. This im plies that the densities $r$ of redundant bonds and $n_{F}$ of zero $m$ odes $m$ ust be continuous functions of the density of present bonds. The density of
overconstrained bonds, on the other hand, needs not be continuous.
Let us now discuss how the balance of degrees of freedom is modi ed by ghost- eld bonds (Sectio IIC). If a site has $\mathrm{n}<\mathrm{g}$ present ghost edges connecting it to the rigid background, then it contributes w ith ( $g \quad n$ ) degrees of freedom to Eq. (19). If on the other hand it is connected to the background by $n \quad g$ ghost bonds, then this site has no degrees of freedom left to contribute to Eq. (19). $T$ hee ective num ber $g(h)$ of rem aining degrees of freedom contributed by an average site is thus

N otioe that $n_{F}$ and $r_{r}$ are trivially related through the addition of a know $n$ function of and $h$. Therefore the know ledge of either $n_{F}$ or $r$ provides exactly the sam $e$ physical inform ation about the system.
The im portance of (22) is tw ofold: in the rst place, as discussed above, $n_{F}$ and r must be continuous fiunctions of . A sim ilar reasoning allow s one to conclude that they $m$ ust also be continuous functions of $h$. The continuity of $r$ and $n_{F}$ is a key property, and $w$ ill be used later in Section $V$ to select the physically correct solution of (7) whenever indeterm inacies arise. Secondly, in Section VI it $w$ illbe argued that $n_{F}$ can be identi ed w ith the logarithm of the partition function for the RP problem, and the consequences of such identi cation willibe discussed. A though this identi cation is not necessary for solving the R P problem, it provides interesting additionalinsight into this problem insofar it helpsm aking a link w ith therm odynam ics.

j. A s discussed in Section IV, a bond $b_{i j}$ is overoonstrained if $i$ and $j$ are rigidly connected to the background, even in the absence of this bond. On a random graph, this happens with probability $R^{2}$. Thus a bond is present and overoonstrained w ith probability ( $=\mathrm{N}) \mathrm{R}^{2}$, and therefore the average num ber of overconstrained bonds is $\mathrm{hB} \mathrm{ov}^{\mathrm{i}}=\mathrm{R}^{2} \mathrm{~N}=2$. W e can now write Eq. (24) as

N otice that, while (23) and (24) are exact for arbitrary graphs, [25) only holds under the assum ption that two neighboring sites $i$ and $j$ are independently rigid $w$ ith probability R. Thus in deriving (26), correlations have been ignored. This is correct on random graphs of the type considered here, but fails on nite dim ensional lattices.
It is not im m ediately obvious how (26) can be integrated since we do not have an explicit expression for $R$ as a function of . However using $x=R=y \quad h$ one can $w$ rite $R^{2} d=R d x \quad x d R=(\mathbb{R} \quad(y) @ R=@ y) d y$, where $R=G_{g}(y)$ as given by 77). A fter integrating by parts,

This expression enables us to calculate the density of redundant bonds analytically. In previous work on B ethe lattices [20], [26) w as solved in zero eld by num erical integration, using for this purpose the values of $R$ that result from iteration of (2). A though the algebra becom es slightly $m$ ore com plicate, the approach used here to calculate $r$ is applicable to Bethe lattices as well. Later in Section V B we present som e results for B ethe lattioes.

## 1. The density of zero $m$ odes

U sing (7) , (21), (22), and (28) we can write

## 2. A consistency check

In the lim it ! N , allbonds are present and there are no rem aining degrees of freedom, i.e. $n_{F}!0$. It is easy to verify that Eq. (29) indeed satis es this condition.

V. LOCATION OF THE TRANSITION POINT
A. The general case

The value $c_{c}(h)$ where the transition takes place is univocally determ ined by the requirem ent that ${ }_{r}$ be a continuous function of . In order to see how this works, im agine that for a given $\mathrm{h}<\mathrm{h}$ one lets $\mathrm{h}<\mathrm{y}<1$ and calculates $\mathrm{r}(\mathrm{y}$;h) (Eq. (28) ) and (y;h) (Eq. (10)), thus obtaining a plot of $r$ vs ( $F$ ig. (4). In doing so one nds that $r$ describes a loop (som etim es called a $\backslash M$ axw ell loop" in StatisticalM echanics).
$T$ he existence of a crossing point im plies that tw o values $y_{A}$ and $y_{B}$ exist such that

Eq. 30) cannot be solved analytically in general, how ever it is easily solved num erically (by iteration) for each value of $h$ and $g$, to obtain $\mathrm{c}(\mathrm{g} ; \mathrm{h})$. In this fashion the location of the coexistence line can be calculated to arbitrary precision (Fig.55). At the transition point $c(h)$ the order param eter $R$ jum ps (F ig. (6a), but the density of redundant bonds $r$ is continuous ( $F$ ig. (6) .

B. The case of zero eld. M axw ell counting on the ( $\mathrm{g}+1$ )-rigid-core

For zero eld one has that $R=0$ for $<c$. Eq. (26) then implies that $r=0$ for $c$. At the transition point c, a rigid cluster suddenly appears that contains a fraction $R_{c}$ of the graph. In zero eld, Eq. BO reads

$E$ ven this sim pler equation does not adm it analytic treat$m$ ent. H ow ever, very precise solutions can be obtained num erically as described already. Table $\square$ contains som e exam ples.
$P$ lease notioe that $c$ is sm aller than the value 2 g needed for globalbalance of constraints and degrees of freedom. H ow ever, all degrees of freedom belonging to sites on the rigid cluster (which appears suddenly at the transition point) are by de nition canceled out by constraints. $M$ oreover, since for zero eld the number of redundant constraints per site is exactly zero at the transition (See Fig. (6), one concludes that the average num ber ofbonds per site, for sites on the rigid cluster, $m$ ust be exactly $2 g$ at $c$. The conclusion is then that sites on the rigid cluster have $m$ ore bonds than average.
$T$ his observation $m$ ap be form alized in the follow ing $w$ ay. U sing $R=x, R=\sum_{k=g}^{1} P_{k}(x)$ w ith $P_{k}(x)=e^{x} x^{k}=k!$, and $x P_{k}(x)=(k+1) P_{k+1}(x)$, condition (31) can be writ-

$T$ his sum counts the num ber of rigid neighbors for sites on the ( $g+1$ )-rigid-core, that is, the subgraph of the rigid cluster that hasm inim um coordination ( $g+1$ ). Eq. (33) $m$ eans that the ( $g+1$ )-rigid-core has an exact balance of degrees of freedom.
$C$ learly, the rigid cluster $m$ ay also contain sites not in the ( $g+1$ )-rigid-core. W hen these are considered, it is possible to see that the balance ofconstraints and degrees of freedom is still respected.

## The case of large $g$

An analytic solution of Eq. (31) is possible (though som ew hat trivial) in the $g \gg 1 \mathrm{~lm}$ it. In this case $\mathrm{P}_{\mathrm{g}}$ ! 0 and $R_{c}$ ! 1, i.e. there is a jum $p$ from $R=0$ to $R=1$ at the transition point. P lugging these observations into (31) one gets, for zero eld,

$T$ his $m$ eans that the rigid transition happens exactly at the point where global balance betw een constraints and degrees of freedom is attained. In other words, at c $M$ axw ell counting is exact on the rigid cluster for all $g$, while for g \gg 1 it is globally exact as well.

## B ethe lattices

A graph where each site has exactly $z$ random ly chosen neighbors is topologically equivalent to a B ethe lattice, except for nite-size corrections. W hen this system is random ly diluted, one obtains what is called \random bond model" in Ref. [20], in which each of the $z$ bonds on a site is present with probability $p$. We will only state the nal results for this system. In zero eld the transition point $p_{c}$ is determ ined by

The transition condition (35) gives rise to a polynom ial equation which is easily solved for sm all values of $g$ and $z$. For $g=2$ and $z=5$ the corresponding quadratic equation results in $p_{c}=0: 83484234$. For $g=2$ and $\mathrm{z}=6 \mathrm{a}$ cubic equation is obtained, and its solution is
$p_{c}=0: 656511134 . T$ his last value is consistent $w$ ith but m ore precise than $\mathrm{p}_{\mathrm{c}}=0: 656$ as obtained in previous work [19] using num erically exact $m$ atching algorithm $s$ for RP [47,50].

VI. RELATION BETWEEN $n_{F}$ AND A FREE ENERGY

In this Section, the consequences ofm aking the identication FF ! ( $\log \mathrm{Z})=\mathrm{N}$ are explored. It hasbeen shown som e tim e ago that $S P$ can be $m$ apped onto the $q!1$ lim it of the Potts model[43, 44]. This m apping allow s one to draw a parallelbetw een an equilibrium therm odynam ic transition (P otts) and percolation, which $m$ ay be described as a purely geom etric transition. O ne of the outcom es of this equivalence is the identi cation of the total num ber of clusters in percolation as the logarithm of the partition function for the resulting $P$ otts $m$ odel. $T$ he existence of this $m$ apping has had profound im pact on our understanding of scalar percolation, e.g.by allow ing the exact calculation of percolation critical indices in two dim ensions [2]. No equivalent $m$ apping has been found for RP yet. H ow ever it has been suggested [20, 45] that a possible generalization for the free energy in RP for zero eld is the total num ber of rem aining degrees of freedom (zero $m$ odes or oppy $m$ odes). In the $g=1$ case of $R P$ each cluster has one rem aining degree of freedom, thus the SP result is recovered.
In Section IV 立was shown that $n_{F}$ (equivalently ${ }_{r}$ ) has to be continuous. Thisw asused in Section $\square$ to locate the point c where the rst-order transition happens. Thus $n_{F}$ plays a role sim ilar to that of the $G$ ibbs free energy, which is also a continuous function of its intensive param eters. In this section we add further evidence supporting the identi cation of $\mathrm{F}_{\mathrm{F}}$ as the logarithm of the \partition function", or free energy, for the RP problem on random graphs. W e dem onstrate that the ansatz $Z_{R P} / e^{N n_{F}}$ is consistent also in the presence of a eld, and show how several therm odynam ic quantities result from derivatives of this free energy.
In A ppendix A 1 it is shown that the derivatives of $n_{F}$ are

## A. M axw ell's Rule of Equal A reas

T he continuity requirem ent (30) em ployed in this work to locate the true transition point $c$ is analogous to the condition that the free energy be continuous, as noted in previous work [20]. The continuity of an appropriate therm odynam ic potential is discussed in elem entary statisticalm echanics textbooks in connection, for exam ple, w ith Van der W aals' equation [46, 51], where it is used as a criterion to locate the transition. The continuity condition for our RP problem is w ritten in general as

The constant- eld heat capacity $₫$ is expected to diverge w ith the sam e exponent as the susceptibility, unless the system has certain sym $m$ etries, which is the case for the Ising m odel, but not for R P .

Since on approach to the critical point, y ! y = $\quad 1$ (Eq. (13)), we conclude that the coexistence line reaches the critical point w ith slope ( $g$ 1) in the $H-T$ plane (See Fig.5).

V II. D ISC U SS IO N

The Rigidity Percolation problem with $g$ degrees of freedom per site has been considered on ErdøsRenyi graphs with average coordination . An extemal eld $h$ is introduced by connecting each site to a rigid background, or \ghost site", with a certain probability that depends on $h$ as described in Section IIC. The resulting Equation of State (7) for the density $R$ of sites that are rigidly connected to the background, undergoes a rstorderphase transition on a \coexistence line" ${ }_{c}(h)$. This line ends at a critical point (Fig. (5) w ith classical exponents $=0,=1=2,=1$ and $=3$. For com parison, the criticalpoint ofScalar percolation (the case ofg $=1$ ) is located at $\mathrm{h}=0$ and has di erent critical exponents:
$=1,=1,=1$ and $=2$ I]. Therefore in the M F approxim ation, Scalar and R igidity percolation are in di erent universality classes. In two dim ensions, a sim ilar conclusion is reached by num ericalm eans [15, 45], were both transitions are continuous in zero eld.
It has been recently argued [54] that for certain spin system $s$, the existence of a discontinuous transition in the M $F$ approxim ation is enough to ensure that, in nite space dim ensions $d$, there is a discontinuous transition if $d$ is large enough. If a th is result holds for $R P$, one w ould expect to see a discontinuoustransition in zero eld ford (and perhaps g) large enough. Up to now, extensive nu$m$ erical sim ulations for RP have been perform ed only in tw o dim ensions [15, 45, 48, 55]. E xcept for pathological cases where the transition happens at zero dilution [15], it seem $s$ that the transition is continuous for all $g$ in tw o dim ensions. Large scale sim ulations are still needed to clarify this issue.
On Cayley Trees with a boundary, g-rigidity percolation $(R P)$ is closely related to $(g+1)$-bootstrap peroolation (BP) [19, 34]. B oth percolate at the sam e density
p ofpresent bonds, although $w$ th di erent spanning cluster densities on trees. O $n$ random graphs, which have the local structure of a tree but no boundaries, $k$-core transition stays unchanged, but the RP transition is delayed to larger $p$ values [19]. W e have explicitely shown that, at the critical concentration c where the rigid cluster rst appears, it has an exact balance of degrees of freedom, i.e. it has exactly $g$ bonds per site. $T$ his condition is satis ed both on the whole rigid cluster and on its ( $\mathrm{g}+1$ )-rigid core. H ow ever globally the system has lesser bonds than needed to attain this balance, $m$ eaning that the rigid cluster is selectively $m$ ade out of sites $w$ th $m$ ore bonds than average.
In previous work on Bethe lattices in zero eld 20] it was suggested that the num ber $n_{F}$ of uncanceled degrees of freedom is a free energy for the RP problem. For $\operatorname{SP}(g=1)$ this result holds exactly, being one of the outcom es of the Fortuyn $-K$ asteleyn $R$ andom $-C$ luster m odel [43, 44], which contains SP and the Potts m odel as particular cases. For RP, how ever, this identi cation only has the status of a plausible ansatz. $T$ his ansatz w as used recently to predict som e them odynam ic properties of chalcogenide glasses [56], for which the RP transition has been show $n$ to be relevant [11, 14, 57, 58].
Som e of the reasons to believe that this identi cation m ight be correct in generalare: a) the fact that $n_{F} m$ ust be continuous at the discontinuous RP transition, and, b) the fact that for $g=1, n_{F}$ is the num ber of connected clusters per site, so the FK result for $S P$ is recovered exactly. In this work we have show $n$ that, in the presence of a properly de ned eld $h$, the ordered param eter R can be obtained as a derivative of the free energy $w$ ith respect to $h$, thus adding further support to the belief that this identi cation is correct.
Under the assum ption that $\log Z=N n_{F}$, the entropy per site $s$ can be derived. T he resulting expression (43) was found to depend on the order param eter $R$ alone. This is a property of other M F system $s$ like for exam ple the Ising ferrom agnet.

O $n$ the pedagogical side, we have attem pted to situate the discussion in term $s$ of the parallel betw een the $R P$ transition in a eld and a condensation transition. Since only topological (connectivity) properties are im portant for RP, it can be said that, in a sense, RP in a eld is a sort of \geom etric condensation transition". Fig. 7 ilhustrates the sim ilarities between both transitions. H ow ever a closer $m$ atch is possible. C om paring (7) to (9) one notioes that, in a M F condensation transition, / ${ }^{2}=1=v^{2}$ plays the role of the order param eter $R$ in RP. From this point of view, the analog of a \volum e" in RP would be $1=R^{1=2}$. The analog of a $P-V$ plot is show $n$ in $F$ ig. 8 . N otice how ever that, w ith in this definition of a \volum $\stackrel{e}{R}_{B}^{\prime \prime}, P(V)$ does not satisfy $M$ axw ell's rule of equal areas, ${ }_{A}^{R} V(P) d P=0$.

For large M , the probability to have $n$ ghost edges on a site is $P_{n}(h)$, so one has a realization of the poissonian distribution. T his equivalent system has a total of NM ghost slots, each occupied by a ghost bond w ith a sm allprobability $\mathrm{p}_{\mathrm{h}}$, so we can now use Eq. A 7).
