D ynam ical heat channels

We consider heat conduction in a 1D dynam ical channel. The channel consists of a group of noninteracting particles, which move between two heat baths according to some dynam ical process. We show that the essential therm odynam ic properties of the heat channel can be evaluated from the diusion properties of the underlying particles. Emphasis is put on the conduction under anom alous diusion conditions.

The link between them odynam ic phenomena and microscopic dynamical chaos has been a subject of interest for a long time [1]. Examples of such a relationship is determ inistic di usion [2], where local dynamical properties, such as stability (or instability) of several xed points can change the global di usion transport from normal to anomalous B]. Another question which has attracted a lot of attention recently, is the problem of heat conductivity in deterministic extended dynamical system s [4-8]. A large num ber of models have been proposed in order to understand the conditions under which a system obeys the Fourier heat conduction law [4]. Recently, a new class of 1D m odels, "billiard gas channels", has been proposed [5-8]. These channels consist of two parallel walls with a series of scatterers, distributed along walls, and noninteracting particles that move inside. The two ends of the channel are in contact with the heat baths. By changing the shapes and positions of scatterers it is possible to change the conductivity of the channel

In this Letter we show that such billiard gas channels belong to a wider class of models, which we call dynam ical heat channels. The absence of interactions between particles and the independence of the particle dynam ics on kinetic energy allow a complete separation between the therm odynam ic aspect, which is governed by properties of the therm ostats, and the dynam ics inside channel, which is governed by di usion properties within the channel. All the essential information on heat conductivity of such a dynamical heat conductor can be obtained from the di usion properties of channel.

D ynam ical heat channel. To model dynam ics within the channel we consider N particles that move along direction X , following the dynamical equations of motion

where the function f can be either determ in istic or random .

To consider transport of heat, two heat baths with temperatures T_+ and T_- are attached to the left and right ends of the channel. The heat bath is characterized by a velocity probability density function (pdf), P_T ($V_{T\,h}$), where $V_{T\,h}$ is the thermal velocity. After colliding with

the heat bath, the particle is ejected back to the channel with a velocity $v_{T\,h}$ which is chosen from P_T ($v_{T\,h}$).

As particles do not interact, the dynam ics of the ensemble inside the channel can be described by a long trajectory of a single particle and the ux should be rescaled by the factor N . The trajectory of a particle is independent of the particle velocity $v_{T\,h}$. The only difference between "hot" and "cold" particles is that the hot ones cover the same trajectories faster then the cold ones. The velocity $v_{T\,h}$ does not change during the propagation through the channel and it can be interpreted as a temperature "label" of a particle. The dependence of the dynam ics in Eq. (1) on $v_{T\,h}$ can be taken into account by introducing a scaling factor for the time t! $t=v_{T\,h}$.

Due to the separation of the therm odynam ic characteristics from the dynam icalones, the proposed approach is not limited to Hamiltonian systems only [5-8]. We only assume that the dynamics inside the channel has a diusional character, and can be characterized by evolution of the mean square displacement (msd)

This di usion can be normal (=1), subdi usive (<1) or superdi usive (>1) [9].

Following Ref. [5], heat transfer by a particle through the channel is

where E $_{\rm j}^{\rm in}$ and E $_{\rm j}^{\rm out}$ are the energies before and after the j-collision with the heat bath. ${\rm q}_{\rm j}$ is the direction factor, ${\rm q}_{\rm j}=1$ if the (j 1)-collision is with the hot end, and ${\rm q}_{\rm j}=1$ in the case of the cold end. M (t) is the total number of collision events during time t. In the case of normal heat conductivity, Q grows linearly with t and the heat ux is de ned by

Let us start from a situation where the particle is initially located at the hot end. During disusion it can come back and collide with the hot bath again. A coording to Eq.(3) this event, on average, does not lead to

heat transfer. But when the particle reaches the opposite cold end Q increases on average as P_T ($v_{T\,h}$) $]dv_{T\,h}$. A fter that the process is reiterated starting from the cold end. Thus, the problem of heat transfer is reduced to the problem of diusion in a nite intervalunder re ecting and absorbing boundary conditions. As the initial condition we assume that at t = 0 the particle is located at the re-ecting end. The average needed to reach an absorbing boundary is the rst moment of the pdf (t) for rst arrival times. To take into account the e ect of therm odynam ic velocity should be rescaled, as mentioned above, on the time $\frac{1}{1}$ P_T $(v_{T\,h})$ d $v_{T\,h}$. Due to the absence of mass ux, the number of transitions from left to right and vise versa should be the same. Finally, we obtain the following equation for the one-particle heat ux through the channel of length L

For an ensemble of particles the heat ux should be written as $J_{\text{ens}} = N$ J(L). Here we take into account that in order to keep a density of particles in the channel xed, N should be proportional to L; namely N / L.

E quation (5) dem onstrates a complete separation between therm odynam ic and dynam ical aspects. Without loss of generality we consider the "delta"-heat bath with a simple pdf, P_T ($v_{T\,h}$) = $(v_{T\,h})$ [8].

As a model for the dynam ics in the channel we consider continuous time random walks (CTRW) [10] in a discrete lattice. This allows to cover the spectrum of diffusion regimes, from subdivision to superdivision, and to describe kinetics of deterministic Hamiltonian [11,12] and dissipative [3] systems.

The CTRW \rightarrow m odel is a stochastic process which represents an alternating sequence of waiting and jumping events [10]. A particle waits at each point for a time chosen from a waiting time pdf $_{\rm w}$ (t), and makes a jump (ight) to the left or right with equal probabilities. The jumps are characterized by the pdf $_{\rm f}$ (x;t), the probability density to move a distance x at time t in a a single igth event. We consider power laws for both pdf's[10]

Depending on asymptotic properties of $_{\rm w}$ (t) and $_{\rm f}$ (x;t), we have regim es of superdiusion, normaldiusion or subdiusion [10].

Superdi usion. To achieve superdi usion with a nite m sd hx^2 (t)i there should be a correlation between the length and duration of the individual ights. Such correlation leads to the m odel of the Levy walks with spatiotem poral pdf [10]




FIG.1: pdf (t) for rst arrival times for (a) superdiusion with $_{\rm w}$ = 2:6; $_{\rm f}$ = 1:6 for L = 100. Inset showns the scaling of the exponents with the channel length L,L $_{\rm f}$. (b) Subdiusion, $_{\rm w}$ = 0:6; $_{\rm f}$ = 2:6. Straight lines correspond to the asymptotic behaviour (see text).

that corresponds to ights with a constant velocity v. Here we assume that $_{\rm w}$ > 1, so there is a nite mean waiting time. Depending on $_{\rm f}$ we distinguish among three regimes of di usion [10], according to the exponent in Eq.(2),




FIG. 2: Evolution Q (t) vst for subdi usion, $_{\rm W}$ = 0:6; $_{\rm f}$ = 2:6 (curve (1)), normal di usion, $_{\rm W}$ = 1:6; $_{\rm f}$ = 2:4 (curve (2)), and superdi usion, $_{\rm W}$ = 1:6; $_{\rm f}$ = 1:6 (curve (3)). Curve (4) corresponds to rescaled, for one particle, Q (t) for an ensemble N = 100 in the case of competition between anomalous ights and localized events, $_{\rm W}$ = 0:4; $_{\rm f}$ = 12. Straight lines correspond to asymptotics (see text) For all cases the length of channel is L = 1000, $_{\rm T+}$ = 2 and T = 1.




FIG. 3: (a) The mean rst arrival time versus L; (b) one-particle ux J(L), Eq. (5), versus L ($T_+ = 2$ and $T_- = 1$). Results correspond to di erent di usion regimes with subdiusion, $T_+ = 0.6$; $T_+ = 0.6$; T

In order to derive the dependence of the heat ux J on the length L of the channel we start from a consideration of the survival probability (t) for a particle walking on the nite interval of the length L bounded by re ecting and absorbing boundaries. We not that for Levy walks the survival probability is (t) / e st, where s / L^{-1} for the ballistic motion (= 2), s / L^{-1} for superdiusion (1 < < 2), and s / L 2 for normaldiusion (= 1) (see inset in Figla). Then, the pdf for rst arrival times, (t), is (t) (Fig.1a) and has a nite rst moment, . As a result, in asymptotic limit the heat, Q, grows linearly with time ($E =)t_{R}(line (3) in Fig.2)$, where the mean arrival time is = $\frac{1}{0}$ t (t)dt / s 1 (Fig.3a). Thus, in the case of superdi usion, due to Levy walks, we get a norm allinear in time heat conductivity.

Finally, for the one-particle heat ux, following Eqs. (5) and (8), we arrive at the following equation for J(L) in term of the m sd exponent ,

In Fig3 b we show the num erical results for J (L) obtained for $_{\rm f}$ = 1.6 (stars) and $_{\rm f}$ = 2.4 (squares). The results

are in good agreem entwith the scaling law suggested by Eq.(9) (straight lines in Fig.3b).

Then taking Eq.(9) into consideration the therm alconductivity $k=\ J_{\text{ens}}$ (N)=r T , shows the following behavior for 1 < $\ <$ 2,

This diverges as one goes to the thermodynamic limit L ! 1 . For the ballistic case = 2, k / L and for = 1 k / const as expected.

The Levy walk model is an adequate approach form odeling of Ham iltonian kinetic in a mixed phase space [12]. Previous numerical results which have been obtained for Ham iltonian billiard channels, show that = 1:3 corresponds to the ux exponent = 1:72 [7], and = 1:8 to = 1:178 [8], which are in good agreement with the relation in Eq.(9).

In the case of Levy ights [10], unlike the Levy walks, the velocity is not introduced explicitly. Here we assume that all ights have the same duration $t_{\rm f}$ and use the following decoupled representation for ights pdf,

In this case the m sd diverges and one is tem pted to use hix (t) ji^2 to characterize the dynam ics. In the asym ptotic regim e this quantity scales as hix (t) ji^2 $t^{2-\frac{r}{2}}$ [10]. As in the previous case, here the exponent f determines the dynam ics in the channel and the dependence of f ux f (L) on L. The scaling of the m ean arrival time, f L, is consistent with the result obtained from a direct solution of a fractional Fokker-P lanck equation [14]. We note that

using of hix (t) ji² instead ofm sd gives a di erent, yet unphysical scaling, J (L) / L $_{\rm f}^{2}$ 3 , w ith an exponent which is close to that in the scaling in Eq. (9) and coincides w ith it at the points $_{\rm f}$ = 2 (norm aldi usion) and $_{\rm f}$ = 2 (ballistic di usion).

Subdi usion. In the case of subdi usion $_{\rm w}$ < 1 and $_{\rm f}$ > 2 in Eq.(6) and the mean waiting time $_{\rm w}$ diverges [10]. Them otion is characterized by long localized events and the m sd grows sublinearly, hx^2 (t) i $_{\rm t}$. The pdf of the rst arrival time, (t), has a power-law asymptotics (t) / t $_{\rm w}$ 1 (Fig.1b). This nding is in line with a result for subdi usion under a bias in a sem in nite interval with an absorbing boundary [15]. The anom alous character of the pdf (t) leads to a divergence of . Thus, in the case of subdi usion the heat Q (t) carried through the channel grows sublinearly with time (see line (1) in Fig.2),

W ithin a traditional de nition of the ux, Eq.(4), the subdi usive anom alous heat conductivity can not be distinguished from a heat isolator. We note that subdi usion regimes can not be achieved in the case of channels with Ham iltonian dynamics due to a niteness of recurrence time [9].

Coexistence of long localized events and localization the case of competition between lights and localization events the m sd exponent lis given by a relation [10]

The pdf for the arrival time, (t), is governed, like in the case of simple subdivision, by the pdf for waiting times, $_{\rm w}$ (t). The divergence of mean arrival time can




FIG. 4: Evolution Q (t) vs t for the map in Eq. (14) with $_{\rm w}$ = 05; $_{\rm f}$ = 15 (L = 1000, dt = 10 4 , $_{\rm T_+}$ = 2 and T = 1). Straight lines correspond to power law dependence in Eq. (12). Inset shown numerically obtained relation between scaling exponent for one-particle ux and exponent ($_{\rm w}$ = 1:6 for all cases). Straight lines correspond to = 3.

lead to anom alous heat conductivity, Eq. (12), even in the case of superdi usion spreading, hx^2 (t)i t , > 1, Eq. (13). Fig.1 (line (4)) shows the dependence Q (t), for the ensemble of N = 100 particles ($_{\rm w}$ = 0.4; $_{\rm f}$ = 1.2, = 1.2), rescaled for one particle.

O ne can go continuously am ong the various di usional behaviors by tunning param eters in an iterated map. As an example of determ inistic channel we consider a combined map β . This one-dimensional map generates intermittent chaotic motion with coexisting localized and ballistic motion events. The map is defined for one unit cell by the iterative rules,

$$f(X) = \begin{cases} X_{n+1} = f(X_n); \\ X + aX^{z} & 1; & 0 < X < \frac{1}{4}; \\ X & \alpha(\frac{1}{2} & X)^{z}; & \frac{1}{4} < X < \frac{1}{2}; \end{cases}$$

The param eters are a = 4^z z=(z+z) and a = 4^z z=(z+z). The localized and ballistic phases are characterized by the pdf's in Eq. (6), with the exponents $_f$ = (z 1) 1 and $_w$ = (z 1) 1 . Variation of the map param eters z and z allows to cover the diusional regime in the range 0 < 2.

The therm odynam ic velocity, v_{Th} , can be included into the map description. We x a time step dt and after one iteration of the map, Eq.(14), stretch the system time following t= t+ dt= v_{Th} . The length of channel is determined by a number of unit cells, 0 > [X] > [L]. When the particle reaches the boundary cells, [X] = 0 or [X] = [L], it is random ly placed into the interval 0 < [X] < [L] or [X] = [L]. This corresponds to a di usive rejection of particle back to the channel.

The values of the $\,$ ux exponents $\,$ obtained for the map in Eq. (14) are in agreement with the prediction in Eq.(9) for superdi usion (see inset in Fig.4). In Fig.4, we show the time evolution of Q (t) for the case of subdi usion, $_{\rm W}=0.5,_{\rm f}=1.5$. The steps in the Q (t) dependence correspond to anom abusly long waiting events when particle is trapped near marginal stable $\,$ xed points $\,$ x = $\,$ j + $\frac{1}{2}$; j = 0; ::::;L [3].

In sum mary we have introduced a class of dynam ical heat conductors. This class includes as particular cases recently proposed H am iltonian billiard channels [5-8]. In the absence of interactions between the particles and the independence of the dynam ics on particle energy, the proposed aproach goes beyond H am iltonian dynamics and allows to express heat conductivity in terms of channel diusion properties. The H am iltonian character of dynamics becomes essential when interactions between particles are introduced (like in the case of dynamical lattices [4]) or a dependence of dynamics on particle energy is included.
