Bose-Einstein Condensation of Molecular Hydrogen in Nanotube Bundles

We evaluate the elects of heterogeneity on the density of states of H_2 molecules inside interstitial channels within bundles of carbon nanotubes. As tem perature (T) falls, the density increases within those tubes having the greatest binding energy. At T 10 m K, the molecules undergo Bose-E instein condensation, exhibiting a singular heat capacity.

The subject of adsorption within bundles of carbon nanotubes has received considerable attention recently, owing to both its fundam ental interest and potential applications (e.g. gas storage and isotope separation). One focus of the research is one-dim ensional (1D) and quasi-1D phases of m atter. These include condensing and crystallizing phases of buckyballs within tubes, He and H₂ within the interstitial channels (IC's) between tubes and various gases within grooves on the outside of the nanotube bundles [1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11]. M ost analyes (including those of our group) have assumed that the tubes are identical and parallel, form ing an ordered lattice. Real nanotube bundles, in contrast, consist of a disordered array of tubes with a distribution of radii. A logical question arises: how reliable are predictions that ignore such a variable environment? Shi and Johnson have recently shown that predictions incorporating heterogeneity agree better with adsorption data than do the idealized m odels [12]. Stim ulated by their work, we have explored the behavior of quantum uids (He and H₂) in such a nonuniform environm ent at low tem perature (T). In this paper, we describe an intriguing result: Bose-Einstein condensation (BEC) of H₂ m olecules occurs as a consequence of the heterogeneity. This paper makes predictions about this phenom enon that are testable experim entally. Sim ilarbehavior is expected for ⁴H e atom s. We note that a super uid phase of para- H_2 in con ned geom etries has been proposed, but experim entalevidence of it is lacking thus far [13].

The occurrence and properties of the BEC transition are determ ined by the density of states N (E) of the constituent particles. Thus, an initial focus is the determ ination of that function, derived from the single particle energy spectrum. We assume that particles do not interact (based on the assumption of low density and weak inter-IC interactions). A typical IC presents a highly con ning geom etry for the molecules if the bundle is close-packed. Because of this con nem ent (in the x-y plane, perpendicular to the tubes), the molecules have a large zero-point energy of motion. Theoretical values [14] of this energy are of the order of 500 K. This result is consistent with an enorm ous isotopic heat di erence at low coverage (which equals the binding energy di erence) between D_2 and H_2 in a nanotube bundle observed experimentally [15]. That di erence was found to be about 250 K, a factor four larger than the di erence found on the graphite surface [16] (due to less localization in that case).

Our analysis assumes that molecules can move within the IC's in order to achieve chemical equilibrium with a coexisting vapor phase. At low T, because of the con nem ent, only the lowest energy state of transverse motion is excited. We call this state's energy $E_t(R)$, where $R = (R_1; R_2; R_3)$ is a vector whose components are the radii of the tubes surrounding a particular ${\rm I\!C}$. W e have evaluated $E_t(R)$, with interesting results. The calculation assumes that motion parallel to the IC is that of free molecules, so the total energy of a particle with (z component of) momentum p is given by $E(p;R) = E_t(R) + p^2 = (2m)$. If the potential is corrugated, one must replace the particle's mass m with its band m ass [11, 17]. The density of states for H_2 is obtained by summing over the IC's present in the given sam ple and integrating over p:

Here $g(E_t)$ is the density of states for the transverse oscillation problem and L is the length of the tubes. If the length is not constant, the variation can be included in $g(E_t)$.

The energy $E_t(R)$ is evaluated from the potential energy V (r;R) of the molecule at position r. To compute V, we add contributions from the three neighboring tubes, ignoring corrections from more distant tubes and many-body e ects associated with the screening of van der W aals interactions by the adjacent tubes [18]. Although these approximations introduce some errors in the values of E_t they do not a lect the key predictions of this work, which are sensitive to the variation of $E_t(R)$. The potential from each neighboring tube was derived with

the m ethod of Stan et al [19]. Because V (r;R) varies rapidly with r, values of $E_t(R)$ include large anharm onic and sm all anisotropic contributions.

The form of N (E) for a given collection of nanotube bundles depends on sam ple preparation. A sam ple is represented by an ensem ble of points (one for each IC) in R space. The density of points in R space, a function f (R), is de ned so that f (R) dR is the number of IC 's within an in nitesimal volume $dR = dR_1 dR_2 dR_3$, centered at R. The function f enters the transverse density of states through this expression:




FIG.1: Contour plot showing the variation $E_t(R) = E_m$ near the minimum R_m (which is chosen as the origin). From the contour closest to the minimum (the closed one) to the more distant ones, the energy contours correspond to $E_t(R) = 0.005; 0.01; 0.05; 0.1; 0.5; 1$ and 5 K.

At very low T, we need the value of f(R) only in the immediate vicinity of the global minimum of the energy (Em at Rm), but at higher T the speci c experim ental distribution a ects the results quantitatively. Here, we have assumed that the IC's are uniform ly distributed in R space within a radius spread of width 3 A near R $_{\rm m}$. M ore general results will be described in a complete report of this work . We nd, as one m ight expect, that R m occurs along the diagonal, sym metry line $(R_1 = R_2 = R_3)$. A long this line, which we call the (1,1,1) line, there occurs a global m in im um $E_m = 1052.97 \text{ K} \text{ at } R_i = 9.95 \text{ A} \cdot \text{To derive g}(E), \text{ it is}$ important to know the variation of Et (R) near thism inim um . Consider a particular displacem ent (in the R $_2$ R $_3$ plane) from R_m to a neighboring point for which R_1 has the same value, while $R_{\,2}$ and $R_{\,3}$ are slightly di erent: . This change, parallel to $R_2 = R_1 + \text{ and } R_3 = R_1$ the (0,1,-1) direction, yields an extrem ely sm all increase in the H₂ energy, indicative of a very slow variation of the function E_t (R) near R_m. This behavior, shown in Fig.1 reveals a long valley of low energy states in this direction; the same behavior occurs along the ve equivalent directions, e.g. (1,0,-1).




FIG.2: Upper panel: Calculated transverse density of states g(E). Lower panel: Total density of states N (E), obtained from Eq.1 in the text. $E_m = 1052:97$ K is the lowest energy level corresponding to $R_1 = R_2 = R_3 = 9:95$ A.

The transverse density of states g(E), from Eq. 2, is shown in Fig. 2. Note that g(E) is proportional E E_m for small E E_m ; the prefactor is deterto m ined by the principal axes of curvature of the function $E_t(R)$. This square root behavior is identical to that found near a van H ove singularity in the phonon density of states of a 3D system near a minimum in the Brillouin zone, for the sam e reason-phase space topology [20]. At higher energy, instead, the behavior of g (E) switches to E_m . This (-1/2) power law follows from the fact 1= E that the higher energy displacem ents from R m are quasi-1D. A sseen in Fig.1, the iso-energy contours are perpendicular to the diagonal, so that the energy gradient in R space is along the diagonal, with essentially constant transverse variation, a 1D situation.

Fig. 2 also presents N (E), derived with Eq. 1, which convolutes the transverse spectrum with the 1D m otion along the axis. The resulting power law behavior can be

understood from realizing that if g (E) is proportional to E_m)ⁿ, for some n, then N (E) is proportional to Œ ${\rm E}_{\,\rm m}\;)^{n\,+\,1=2}$. Hence, we $\,$ nd that N (E) is propor-(E tional to (E E_m) near threshold. This linear behavior is that characteristic of a 4D gas in free space; the result implies that this system exhibits 4D gas behavior at low T.For E > 20 mK above threshold, instead, N (E) becom es approximately constant, corresponding to the density of states of a 2D gas. Thus, there arises a dimensionality crossover originating from the anom alous transverse density of states. W e em phasize that the 4D regime is a direct consequence of the existence of a minimum in the function $E_t(R)$, a result that is not sensitive to the details of the calculation [21].

The therm odynam ic behavior of the system is derived with the usual bose gas theory. For a given number of m olecules, N, the chem ical potential is determined from the relation




FIG.3: Density of H $_2$ m olecules as a function of BEC transition temperature.




FIG. 4: Temperature dependence of the speci c heat (per molecule) for molecular density n = 1 10^{5} A 3 .

At a speci ed $T = 1 = (k_B)$, this relation yields a maximum value N_{max} when equals the lowest energy of the system, E_m , at which point BEC begins. That is, a m acroscopic fraction of the molecules fall into the lowest energy state when $N > N_{max}$. Equivalently, at xed N, BEC occurs when T falls below the inverse function $T_c = T (N_{max})$. The resulting dependence on N of T_c is shown in Fig. 3. As seen there, T_c is of order 10 mK, which is experimentally accessible. Fig. 4 shows the speci c heat C_N (T), calculated from the energy as a function of and T. The novel behavior observed in the gure is a result of the unusual form of N (E). At low T, C_N is proportional to T², a consequence of the 4D (linear) variation of N (E) at low E. Note the presence of singular behavior of C_N (T) as one approaches the transition from above and a cusp at T_c itself. At relatively high T , C_N (T)= (N k_B) is essentially unity because N (E) is 2D-like at high E; a nondegenerate 2D gas has C $_{\rm N}$ (T)= (N $k_{\rm B}$) = 1. Behavior for T > 0.2 K , not shown, is very sensitive to the distribution of nanotube radii.

D iscussions of these results with colleagues have led to several questions concerning the transition. One is this: since each IC contributes a density of states characteristic of a 1D system, why does non-1D behavior arise here? The answer is that particles can exchange between different IC's because of their common access to the vapor region. In practice, thism ay be a very slow process, leading to nonequilibrium behavior. The presence of breaks or holes in the tubes may alleviate this kinetic problem without invalidating the model, since heterogeneity is an essential aspect of the model. A nother question is whether sim ilar behavior occurs for other bose gases. Indeed, BEC of ⁴He is predicted by a sim ilar analysis to

occur if the sam ple's distribution of tubes includes those with some near its energy minima in R space, which occur near 8.5 A. Finally, one might wonder about the e ects of interparticle interactions, which have been ignored up to this point [22]. Indeed, some previous studies of H₂ in IC 's have found that a liquid-vapor condensation occurs at a higher temperature (K) (in the absence of heterogeneity) [11]. A very recent study, how ever, found that nanotubes' screening of the interm olecular interaction reduces T_c to about 10 mK [18]. How ever, that calculation om itted the role of heterogeneity, which is relevant, according to the H arris criterion, since the 3D speci c heat critical exponent is positive [23]. We expect that this condensation temperature is further reduced by disorder, enabling the BEC transition to occur.

W e sum m arize our results as follows. Heterogeneity alters the qualitative behavior of the low energy spectrum of H₂ m olecules. The lowest-lying states of the system are those of particles in that channel. As T falls, particles aggregate in the (essentially 4D) space of quantum states, (R ,p), with bose statistics having a dramatic e ect, i.e. BEC, below a transition temperature of order 20 mK. A nom alous behavior is predicted for the speci c heat, a consequence of the unusual density of states, which is 4D – like at very low energy and 2D –like at som ew hat higher energy. An experimental probe of the real-space m olecular density should reveal the needle-like concentration, below T_c , of a m acroscopic fraction of the particles within the low est energy channel.

M ost intriguing to us is that this transition is a direct consequence of disorder, since the perfectly uniform system of identical nanotubes yields strictly 1D, nonsingular behavior. Such a dram atic e ect of heterogeneity occurs elsewhere in low temperature physics. Examples include the spin-glass transition [24], the e ect of tunneling states on therm all behavior of glasses [25] and the e ects of disorder on monolayer lm s [26].
