# Strand separation in negatively supercoiled D N A

#### Abstract

W e consider Benham 's m odel for strand separation in negatively supercoiled circular D NA, and study denaturation as function of the superhelical density < 0.We propose a statistical version of this $m$ odel, based on bayesian segm entation $m$ ethods of current use in bioinform atics; this leads to new algorithm $s$ w ith priors adapted to supercoiled DNA, taking into account the random nature of the free energies needed to denature hydrogen bonds.

## 1 Introduction

Initiation of transcription in DNA requires the two strands of the double helix to separate, and strand separation is enhanced in negative supercoiled D NA. Benham $(1979,1990,1996)$ proposes a m athem aticalm odel for the process of strand separation, based on statisticalm echanics ideas, and develop algorithm s to locate interesting sites along the D NA where strand separation or replication is strongly favored (see e.g. C lote and B ackhofen (2000)). T hese com putationalm ethods are $M$ etropolis dynam ics (Sun et altri(1995)) or exact $m$ ethods relying on transfer $m$ atrices ( $F$ ye and B enham (1999)). In a typical state, som e hydrogen bonds are broken; we are interested in the repartition ofthe droplets ofdenatured bonds, and on the nature ofthe bases situated in these dom ains. O ur aim is to investigate the e ect of the num ber of droplets, of the degreee of negative superhelicity of the D NA and of the concentration in A + T bonds on the equilibrium properties of Benham 's m odel. T his is the topic of Section 2, where hom opolym ers are treated according to the num ber of connected dom ains of denatured bonds: in Section 2.1.1, we study denaturation when no restriction on the num ber of dom ains is im posed, and show that no robust and stable denatured state exists; this is the situation adapted to the algorithm s of Fye and Benham (1999). In Section 2.1.2, we study the $m$ odel when the num ber of dom ains $r_{N}$ is such that $r_{N}=N!0$, as $N!1$, where $N$ denotes the num ber of bases of the DNA. W e show the existence of a stable and robust denatured state when the duplex is su ciently negatively supercoiled. This is the regin ew here the M CM C of Sun et altri applies. W e next tum to heteropolym ers in Section 2.2 , and study localized denaturation as function of the proportion of A + T bonds and of the level of negative superhelicity of the DNA. Section 3 focus on the statistical aspects of the m odel: Section 3.1 translates B enham 's m odel in a Bayesian fram ew ork, and Section 32 show s how Bayesian seg$m$ entation $m$ ethods of current use in bioinform atics, as presented in Liu and Law rence (1999), can be of interest in the strand separation problem. This also give new algorithm s w ith prions adapted to supercoiled DNA, which take into account the random uctuations of the free energies needed to denature $A+T$ and $G+C$ bonds.

In what follow s, we consider a spin system based on a circular graph w ith node set $S, j \in j=N, N 2 N$, and, for each site i $2 S$, a spin i 2 $\mathrm{f} 1 ;+1 \mathrm{~g}$. Benham 's original model deals w th a lattice gas, w ith binary random variables $n_{i}$. W e use both notations by setting $n_{i}=(i+1)=2$, and use spins to link this $m$ odelw ith know $n m$ ean eld $m$ odels. The meaning of $n_{i}=0$ (resp. $i=1$ ) is that the bases of the double helix at site i 2 S are linked by an hydrogen bond, the link is closed, and $\mathrm{n}_{\mathrm{i}}=1$ (resp $P_{N^{i}}=+1$ ) m eans that this bond is broken, the link is open. Then $\mathrm{n}:=\mathrm{N}_{\mathrm{i}=1} \mathrm{n}_{\mathrm{i}}$ denotes the num ber of open bonds. The partitioning of the

DNA in dom ains allows the linking numbers to be regulated, where the linking number $L$ of a con guration describes the way the duplex winds about the axis, assum ing that the axis of the helix is planar. T he tw ist $T$ is the num ber of tim es the duplex revolves about its axis (see e.g. C lote and B ackhofen (2000), chap. 62). W hen the D NA is relaxed, the so-called $B-D N A$ state, a segm ent of $N$ bases produces typically the characteristic linking num ber $L_{0}=N=A$, where the constant $A$ is experim entally situated around 10:4. A negative supercoilded DNA is a con guration obtained from the $B-D N A$ by cutting the strands using topoisom erases of type $I I$; the strands then rotate around each others in the direction opposite of the tw ist of the helix, reducing then its linking number ( $L<L_{0}$ ). This forces then the circular axis of the helix to $w$ ind, producing then a m ore tw isted and com pact con guration (see e.g. Lew in (1994)). This supercoiled state perm its for exam ple to put the helix in nuclei. Benham 'sm odelperm its to quantify the w ay supercoiling enhances strand separation.

C onsider a supercoiled DNA w ith negative linking di erence $=\mathrm{L}$ $\mathrm{L}_{0}<0$, im posed during the process. A ssum e that n links betw een bases are broken; the helix unw inds locally and thus increases its linking num ber to $+\mathrm{n}=\mathrm{A}$. Because the strands car rotate around each others, the sam e process induced also a tw ist $T$, yielding a residual linking di erence ${ }_{r}=$

where i $2 R$ is the local helicity. Benham 's idea is to quantify all of these steps w ith free energy costs. T he torsional free energy $G_{t}$ is given by

for som e sti ness coe cient $C>0$. Consider a con guration in which $n$ bonds are separated in $r$ runs, that is in $r$ connected com ponents of open bonds. In what follow $s, 2 r$ is the perim eter of the con guration.

The free energy cost for separation is m odeled as

$w$ here the param eters $b_{i}$ indicate the natures of the bases located at sites i2 S:AT links are form ed of 2 hydrogen bonds, and GC links consist in 3 hydrogen bonds. Ifi2 S is associated w th an $A T$ link, we set $\mathrm{b}_{\mathrm{i}}=\mathrm{b}_{\mathrm{A}}$ t and $\mathrm{b}_{\mathrm{i}}=\mathrm{b}_{\mathrm{G}}$ otherw ise, w ith $\mathrm{b}_{\mathrm{G}} \gg \mathrm{b}_{\mathrm{A} T}$. In the hom opolym er case, $\mathrm{b}_{\mathrm{i}} \mathrm{b}>0$. $T$ his will act as an exteriorm agnetic eld in the statistical approach; when
the bases are chosen at random on the DNA w th some law, ${ }_{i} n_{i} b_{i}$ can be view ed as a random extemal eld. The free energy b needed to break the hydrogen bonds, and thus to separate a base pair, depends on the inverse tem perature :

where 4 H is the enthalpy of the reaction and m is the inverse tem perature associated to the $m$ elting tem perature $T_{m}$. Below $T_{m}$, the eld b is positive, this is the regim e we are interested in. From Benham (1992), the pBR 322 DNA is such that $4 \mathrm{H}_{\mathrm{AT}}=7: 25 \mathrm{kcal} / \mathrm{mol}, 4 \mathrm{H}_{\mathrm{GC}}=9: 02 \mathrm{kcal} / \mathrm{m} \mathrm{ol}$, and the $m$ elting tem perature $T_{m}$ follow $s$ the law

Benham (1979) investigates the therm odynam ics of supercoiled DNA, by m in im izing free energies, and introduces critical thresholds of supercoiling. In this $m$ acroscopic approach, it is show $n$ that su cient negative supercoiling im plies local denaturation. In Benham (1996), this work is extended to positively supercoiled D NA ( > 0); looking at the various plots contained in this work, we see the appearance of critical superhelical densities above which a positively supercoiled D NA rem ains intact at tem peratures higher than the $m$ elting point. The m odel does not exhibit phase transitions in the sense of $D$ e nition 11. This is a consequence of the sti ness of the rate fiunction $I_{\text {sing }}(z)$ as $\dot{k j} j!1: \lim _{\dot{j} j!}(d=d z) I_{\text {sing }}(z)=+1$, and the rate function $J(z)$ can not be decreasing in the neighborhood of $z=1$. ### 2.1.2 Lim ited perim eter

## 3 Statistical approach

### 3.1 A B ayesian m odel

In the heteropolym er case, the eld $B^{N}=\left(b_{i}\right)$ is indexed by a w ord of length $N$ on the two letters alphabet fA $+T$; $G+C g$. The DNA can be seen as a kind of geom etrical code where a word is ghed on the double helix. W hen the perim eter is xed by setting $V_{N}=U_{r ; N}, C_{r ; N}=f 2{ }_{\mathrm{N}} ; j j=2 r g$ is a nonlinear code, as a subset of ${ }_{\mathrm{N}}$, and tools from inform ation theory and bayesian statistics are of great utility for com putational issues. W e w ill see that the $H$ am iltonian of the system $m$ odels the a posteriori law on the param eter space ${ }_{N}$ given the observation $B^{N}$. First, consider the a priori probability $m$ easure on the param eter space given by

In the next Section, we im beed Benham 's m odel in a bayesian segm entation $m$ odel of current use in bioin form atics, and provide new algorithm $s$ w ith priors adapted to supercoiled DNA.

### 3.2 B ayesian segm entation for strand separation

### 3.2.1 A two coins exam ple

Liu and Law rence(1999) present a B ayesian m odelfor segm entation ofbiopoly$m$ ers, and provide algorithm $s$ for draw ing sam ples from the various posterior law s of the $m$ odel, which $m$ ight be of great interest in the strand separation problem. W e start $w$ ith their two types of coins exam ple, to $x$ ideas. Suppose you know that in a coin tossing gam e of length $N$, the rst A B emoulli have a probability of success 1 and the next $N$ A tosses have a probability $2 \in 1$ of getting a head. Let yobs be the observed sequence, whith $h_{1}$ (resp. $h_{2}$ ) heads and $t_{1}$ (resp. $t_{2}$ ) tails in the rst (resp. second) part of the sequence. The change point $A$ is treated as a $m$ issing data, and has som e prior law $g(a)$. T he likelihood of the observed data is given by

$C$ om ing back to the setting of Section 3.1, choose $V_{N}$ to be $U_{1 ; N}$, xing the perim eter to $2 r=2$. Benham 's model deals with a circular DNA, and they are N con gurations of length a , and two change points. Forgetting for a while this slight di erence, we see that the Bayesian model of Liu and Law rence can be adapted for Benham 's model: is the $m$ issing data or segm entation param eter $A$, and the prior law $g(a)$ is just the a priori $m$ easure $n$ of Section 3.1. Suppose that $i=+1,16$ i6 A and $i=1$, $A<i 6 N$. Set $B^{N}=$ Yobs and $x$ the param eter to

T hem odelofSection 3.1 can be seen as a particular case of the segm entation $m$ odel, and the a posteriori law of the change point $A$ is the $G$ ibbs m easure $; \mathrm{B}^{\mathrm{N}} ; \mathrm{V}_{\mathrm{N}}$. For the determ in istic m odel w th constant, the last step of the algorithm corresponds to sam pling with i $^{N}{ }^{N} ; V_{N}$. Fye and Benham (1999) give algorithm $s$ for strand separation using transfer $m$ atriges from statistical $m$ echanics; the $m$ ethod can be applied, thanks to the quadratic form appearing in the prior N (the transferm atrioes have com plex entries, a consequence of the gaussian transform ). T he perim eter is not lim ited, and is penalized by the exponential weight appearing in the one dim ensional Ising Boltzm an weight $\exp (4 r$ ) for a perim eter of $2 r$ (notige that this $w a y$ of penalizing too large perim eters was im plem ented in a recent work ofR am ensky et altri $(2000,2001))$. T heir $m$ ethod is applicable to situations w here the free energies for strand separation $b_{A} T$ and $b_{G c}$ uctuate: in real situations, chem ical reactions can alter these free energies. In the random ized case, the $B$ ayesian segm entation $m$ odel can also provide an interesting altemative for studying the strand separation problem $w$ th random free energies $b_{A} T$ and $\mathrm{b}_{\mathrm{G}} \mathrm{C}$.

### 3.2.2 T he general case

W e adapt the setting of Lil and Law rence(1999) and Ram ensky et al tri $(2000,2001)$, and indicate the $m$ ain features of the $m$ odel. T he num ber of dom ains or segm ents of the circular D NA can be lim ited to $r_{m}$ ax . Them issing data is the spin , w ith prior law $N$, given by $V_{N}$ and the hom opolym er of eld $b=\left(b_{A T}+b_{G C}\right)=2$, with free energies $b_{A T}$ and $b_{G C}$ given by form ula (1). can be seen as a juxtaposition ofdroplets of spins arranged around the discrete circle of length N .

Suppose they are $2 r$ dom ains $w$ ith r positive droplets, that is containing sites i w ith $i=+1$, and $r$ negative droplets. The param eter is here de ned given . W e associate to every positive droplet $\quad+\quad \mathrm{i}$ ith $i_{0}=1$, $i=+1, i_{0} 6$ i $6 i_{k}$, and $i_{k}+1=1$ a fam ily of $k+1$ i.i.d. Bemoulli ${ }_{i}, w$ ith

The priors $f$ can be chosen as in Liu and Law rence (1999) as Beta law sw ith the required expectations.

A second w ay of random izing the param eters consists in taking, independently for each segm ent, tw o positive random variables $\mathrm{b}_{\mathrm{A}}$ (!) and $\mathrm{b}_{\mathrm{G}} \mathrm{C}(!)$, distributed according to som e law, which $m$ ight be m otivated from them odynam ics or biochem istry, w th average values given by form ula (1). D raw $2 r$ i.i.d. realizations of these two random variables, and set, for each seg$m$ ent,

The observables of interest are the num ber of denatured bonds $M_{N}()$ given by $\mathrm{m}_{\mathrm{N}}()=2 \mathrm{M}_{\mathrm{N}}() \quad$, and the restricted m agnetization $\mathrm{m}_{\mathrm{N}}^{+}$and $\mathrm{m}_{\mathrm{N}}$. Infor$m$ ation on the localization of denaturation can be obtained by considering the proportion ofbroken $A+T$ and $G+C$ bonds

(see Section 2.2). B ayesian segm entation algorithm s like backw ard sam pling, as given in Liu and Law rence(1999) or Schm idler et altri(2000), can thus be applied to the strand separation problem to study local denaturation as function of the various param eters, taking into account the random uctuations of the free energies needed to denature A + T and G + C bonds.
