# The $\mathrm{sl}_{2}$ loop algebra sym $m$ etry of the tw isted transferm atrix of the six vertex $m$ odel at roots of unity

A bstract
W e discuss a fam ily of operators which com $m$ ute or anti-com $m$ ute $w$ ith the tw isted transferm atrix of the six-vertex $m$ odelat qbeing roots of unity: $q^{2 N}=1$. The operators com $m$ ute w ith the Ham ittonian of the XXZ spin chain under the tw isted boundary conditions, and they are valid also for the inhom ogeneous case. For the case of the anti-periodic boundary conditions, we show explicitly that the operators generate the $\mathrm{sl}_{2}$ loop algebra in the sector of the total spin operator $S^{Z} \quad N=2(m$ od $N)$. The in nite-dim ensional sym $m$ etry leads to exponentially-large spectraldegeneracies, as show $n$ for the periodic boundary conditions [1] $]$ ]. Furthem ore, we derive explicitly the $s l_{2}$ loop algebra sym $m$ etry for the periodic XXZ spin chain w ith an odd num ber of sites in the sector $S^{Z} \quad N=2(m$ odN $)$ when $q$ is a prim itive N th root of unity w th N odd. Interestingly, in the case of $\mathrm{N}=3$, various conjectures of com binatorial form ulas for the XXZ spin chain w ith odd-sites have been given by Stroganov and others. W e also note a connection to the spectral degeneracies of the eight-vertex m odel.

## 1 Introduction

Finite-size spectrum of the XXZ spin chain [ī, $1,1,1]$ under the tw isted boundary conditions has attracted $m$ uch interest recently and has been studied num erically or analytically such as by the

Here $j$ for $=X ; Y ; Z$ denotes the $P$ aulim atrix de ned on the jth site. U nder the periodic boundary conditions we have $\mathrm{L}+1=1$ for any . We now introduce the tw isted boundary conditions by

W e call the param eter the tw ist angle.
There are several physical applications of the tw isted boundary conditions. T he tw ist angle corresponds to the $m$ agnetic ux threaded through the ring $\left.{ }_{101}^{9}\right]$. Taking the variation of eigenvalues under changes of the ux $\left[\begin{array}{l}10 \\ 1\end{array}\right]$, the e ective $m$ ass has been evaluated exactly for the $m$ anyłoody system of interacting ferm ions orbosons in onedim ension which is equivalent to the XXZ spin chain [-4 $\underline{4}_{1}^{-1}$. T he nite-size spectrum of the XXZ spin chain under the tw isted boundary conditions has also been studied from the view point of the nite-size analysis of conform al eld theories $\left[\begin{array}{l}3 \\ 1\end{array}\right]$. A ssociated w ith the variation of the ground-state energy, the ow s of excited
 spectral ow s, we nd several level crossings w ith large degeneracy. H ow ever, it has not been discussed explicitly what kind of sym m etry operators correspond to the spectral degeneracies. T he question should be interesting in particular from the view point of the violation of the level non-crossing rule as discussed by $H$ eim ann and Lieb [1]1].

R ecently, it is found that the sym m etry of the XXZ spin chain becom es enhanced at roots of unity. The $s l_{2}$ lop algebra com m utes w ith the X X Z H am iltonian under the periodic boundary conditions, and the in nite-dim ensional algebra leads to $m$ any spectral degeneracies whose dim ensions increase exponentially w ith respect to the system size [12]. Let us introduce the param eter q through the XXZ anisotropy as

It is shown that the generators of the $s_{2}$ loop algebra com $m$ ute or anti-com $m$ ute w ith the transfer $m$ atrix of the six-vertex $m$ odel $w$ hen $q^{2 N}=1$, and all the de ning relations of the $l_{2}$ loop algebra are explicitly derived for the case in the sector $S^{Z} \quad 0$ ( $m$ odN ). H ere $S^{Z}$ denotes the $Z$ component of the total spin operator. Several aspects of the $\mathrm{sl}_{2}$ loop algebra sym m etry of the X X Z spin chain has been studied $\overline{1} \overline{1}_{1}$ to the spectral degeneracies of the transfer $m$ atrix of the eight-vertex $m$ odel has been discussed


The purpose of the paper is to fom ulate a fam ily of operators com muting w ith the XXZ H am iltonian w ith the tw isted boundary conditions. They $m$ ay explain the level crossings observed in the spectral ow s w ith respect to the tw ist angle. H ere we generalize the approach given in Ref. [1]i], and give som e extended results. A s an ilustration, we show that when
$=$ and $q$ is a prim itive 2 N th root of unity, the operators com $m u t i n g$ w ith the tw isted XXZ $H$ am iltonian generate the $\mathrm{sl}_{2}$ loop algebra for the sector $\mathrm{S}^{\mathrm{Z}}=\mathrm{N}=2$ ( m od N ). Furtherm ore, in the sector $S^{Z}=N=2(m$ od $N)$, we explicitly show the de ning relations of the $s l_{2}$ loop algebra for the case of the periodic boundary conditions where $L$ is odd and $q$ is a prim itive $N$ th root of
unity w ith odd $N$. W hen $N=3$, it is exactly the case in which various com binatorial form ulas w ere discussed recently $[2 \overline{2}, 1,2 \overline{2}, 1,1$

The content of the paper consists of the following: In $x 2$ we review the $s l_{2}$ loop algebra sym m etry of the periodic XXZ spin chain [12] ]. In x3 we introduce the transferm atrix of the sixvertex model under the tw isted boundary conditions. W e also discuss som e usefiul techniques such as the gauge transform ation and the crossing sym $m$ etry. In $x 4$ we show com $m$ utation relations of the $t w$ isted transfer $m$ atrix $w$ ith som e powers of the quantum group generators, which are fundam ental in the paper. W e also show those of the inhom ogeneous case. In x5 we
 discuss the special cases w here we can explicitly check the de ning relations of $s l_{2}$ loop algebra. F inally we note a connection to the eight-vertex model.

## 2 The loop algebra sym m etry of the periodic XXZ spin chain

Let us review the $\mathrm{sl}_{2}$ loop algebra sym $m$ etry of the XXZ spin chain under the periodic boundary conditions. Let us introduce the quantum group $U_{q}\left(s_{2}\right)$. The generators $S$ and $S^{Z}$ satisfy the de ning relations

$H$ ere, the param eter $q$ is generic. In fact, we m ay consider $U_{q}\left(L\left(S l_{2}\right)\right)$, i.e., the $q$ analogue of the universal enveloping algebra of the $s_{2}$ loop algebra. For sim plicity, how ever, we only consider $\mathrm{U}_{\mathrm{q}}\left(\mathrm{s}_{2}\right)$ in the paper.

Let $V$ denote a tw o-dim ensional vector space over $C$. On the $L$ th tensor product space $V I$, the generators $S$ and $S^{Z}$ are given by [12]

Let the symbol $6 \mathrm{v}(\mathrm{v})$ denote the transfer $m$ atrix of the six-vertex $m$ odel. $W$ e now take the param eter $q$ a root of unity. W e consider the lim it of sending $q$ to a root of unity: $q^{2 N}=1$. Then we can show the (anti) com mutation relations [1]

## 3 Tw isted transfer m atrix of the six-vertex model

### 3.1 B oltzm ann w eights

Let us consider the con guration around the vertex as shown in F ig. 1 . Variables a;b;c and $d$ are de ned on the edges at the vertex, and they take values 1 or 2 . T he value 1 corresponds
to a polarization vector that is in the upward or rightward directions, and the value 2 to a polarization vector in the dow nw ard or leftward direction. W e assign the Boltzm ann weight $X_{b d}^{a c}(u)$ to the con guration in $F i g .1$. The weight vanishes unless $a+c=b+d$, whidh we call the lice rule' or the charge conservation'. A $l l$ the nonzero Boltzm ann weights are given by

It can be m portant, since the XXZ H am iltonian can be expressed in term sof $\mathrm{U}_{j}^{+} \mathrm{s}$ and a boundary term [iַinj].

It is known that the periodic XXZ spin chain does not commute w th $\mathrm{U}_{\mathrm{q}}\left(\mathrm{sl}_{2}\right)$. In fact, the generators $S$ do not commute with the periodic XXZ Ham iltonian, since they are not com patible w ith the periodic boundary conditions. W hen $q$ is a root of unity, how ever, som e powers of $S$ can commute with it ${ }_{13}^{2} 1,1$. A s a matter of fact, the observation can be developed $m$ uch further [iz $\overline{-1}]$. $W$ e rst note that $U_{j}^{+} s$ com $m$ ute with $S$ while they do not with $T$, and $U_{j}$ scommutewith $T$ while they do not with $S$. when $q^{2 N}=1$, we can show that the transfer $m$ atrix comm uteswith $S \mathbb{N}$ ) and $T \mathbb{N}^{\mathbb{N}}$ sim ultaneously, and they generate the $\mathrm{sl}_{2}$ loop algebra [12].

We recall that $\mathrm{H}_{\mathrm{xxz}}()$ is given by the logarithm ic derivative of the tw isted transfer matrix (u; ). For instance, we can show that $S(\mathbb{N})$ and $T(\mathbb{N})$ com mute w ith the anti-periodic $X X Z H$ am iltonian in the sector $S^{Z} \quad N=2$ $(m$ od $N)$, when $q$ is a prim titive $2 N$ th root of unity. A s an application of the (anti-) com m utation relations (4-3), we discuss the case of the periodic boundary conditions w th L odd, where $q$ is a prim tive $N$ th root of unity $w$ ith $N$ odd. Taking the sam e identi cation ( $6 \overline{3} \overline{3})$ ) of the generators, we can show explicitly that they satisfy the de ning relations of the $s l_{2}$ loop algebra in the sector $S^{Z} \quad N=2(m o d N)$.

For sectors other than $S^{Z} \quad N=2(\bmod N)$, we have not explicitly shown the de ning relations of the $s l_{2}$ lop algebra. H ow ever, we have a con jecture that som e of the operators given in $\left[\left[_{2}^{2}\right]_{1}\right)$ should generate the $s l_{2}$ loop algebra. By a di erent $m$ ethod, we can show that the spectral degeneracies related to the $s l_{2}$ loop algebra also exist in the sectors other than $S^{Z} \quad N=2(m \operatorname{od} N) . W$ e can derive it from the general result on the spectral degeneracy of the eight-vertex $m$ odel [1] $\overline{1}]$ and through the XXZ lim it of the XYZ spin chain. Som e details should be discussed elsew here.
