The sl_2 loop algebra sym m etry of the twisted transfer m atrix of the six vertex m odel at roots of unity

A bstract

We discuss a family of operators which commute or anti-commute with the twisted transferm atrix of the six-vertex model at q being roots of unity: $q^{2N}=1$. The operators commute with the Hamiltonian of the XXZ spin chain under the twisted boundary conditions, and they are valid also for the inhomogeneous case. For the case of the anti-periodic boundary conditions, we show explicitly that the operators generate the sl_2 loop algebra in the sector of the total spin operator $S^Z = N=2 \ (m \ od N)$. The in nite-dimensional symmetry leads to exponentially-large spectral degeneracies, as shown for the periodic boundary conditions [12]. Furthermore, we derive explicitly the sl_2 loop algebra symmetry for the periodic XXZ spin chain with an odd number of sites in the sector $S^Z = N=2 \ (m \ od N)$ when q is a primitive N th root of unity with N odd. Interestingly, in the case of N=3, various conjectures of combinatorial formulas for the XXZ spin chain with odd-sites have been given by Stroganov and others. We also note a connection to the spectral degeneracies of the eight-vertex model.

1 Introduction

Finite-size spectrum of the XXZ spin chain [1, 2] under the twisted boundary conditions has attracted much interest recently and has been studied numerically or analytically such as by the Bethe ansatz [3, 4, 5, 6, 7, 8]. The XXZ Ham iltonian dened on a ring of L sites is given by

Here $_{\rm j}$ for = X;Y;Z denotes the Pauli m atrix de ned on the jth site. Under the periodic boundary conditions we have $_{\rm L+1}$ = $_{\rm 1}$ for any . We now introduce the twisted boundary conditions by

We call the parameter the twist angle.

There are several physical applications of the twisted boundary conditions. The twist angle corresponds to the magnetic ux threaded through the ring [9]. Taking the variation of eigenvalues under changes of the ux [10], the elective mass has been evaluated exactly for the many-body system of interacting fermions or bosons in one-dimension which is equivalent to the XXZ spin chain [4]. The nite-size spectrum of the XXZ spin chain under the twisted boundary conditions has also been studied from the view point of the nite-size analysis of conformal eld theories [3]. A sociated with the variation of the ground-state energy, the lows of excited states have been numerically investigated with respect to the twist angle [3, 4, 6, 7]. In the spectral lows, we indiscussed explicitly what kind of symmetry operators correspond to the spectral degeneracies. The question should be interesting in particular from the view point of the violation of the level non-crossing rule as discussed by Heilmann and Lieb [11].

Recently, it is found that the symmetry of the XXZ spin chain becomes enhanced at roots of unity. The sl_2 loop algebra commutes with the XXZ Ham iltonian under the periodic boundary conditions, and the in nite-dimensional algebra leads to many spectral degeneracies whose dimensions increase exponentially with respect to the system size [12]. Let us introduce the parameter q through the XXZ anisotropy as

It is shown that the generators of the sl_2 loop algebra commute or anti-commute with the transferm atrix of the six-vertex model when $q^{2N}=1$, and all the dening relations of the sl_2 loop algebra are explicitly derived for the case in the sector $S^Z=0 \pmod N$. Here S^Z denotes the Z component of the total spin operator. Several aspects of the sl_2 loop algebra symmetry of the XXZ spin chain has been studied [13, 14, 15, 16, 17, 18, 19]. In particular, its connection to the spectral degeneracies of the transferm atrix of the eight-vertex model has been discussed [16, 17]. There are also some relevant papers [20, 21].

The purpose of the paper is to formulate a family of operators commuting with the XXZ H am iltonian with the twisted boundary conditions. They may explain the level crossings observed in the spectral owswith respect to the twist angle. Here we generalize the approach given in Ref. [12], and give some extended results. As an illustration, we show that when = and q is a primitive 2N th root of unity, the operators commuting with the twisted XXZ H am iltonian generate the sl_2 loop algebra for the sector $S^Z = N = 2 \, (m \, od \, N)$, we explicitly show the dening relations of the sl_2 loop algebra for the case of the periodic boundary conditions where L is odd and q is a primitive N th root of

unity with odd N . When N = 3, it is exactly the case in which various combinatorial formulas were discussed recently [22, 23, 24, 25].

The content of the paper consists of the following: In x2 we review the $s1_2$ loop algebra sym m etry of the periodic X X Z spin chain [12]. In x3 we introduce the transfer m atrix of the sixvertex m odel under the twisted boundary conditions. We also discuss some useful techniques such as the gauge transform ation and the crossing sym metry. In x4 we show commutation relations of the twisted transfer matrix with some powers of the quantum group generators, which are fundamental in the paper. We also show those of the inhom ogeneous case. In x5 we discuss operators commuting with the twisted transfer matrix when q is a root of unity. We also discuss the special cases where we can explicitly check the dening relations of $s1_2$ loop algebra. Finally we note a connection to the eight-vertex model.

2 The loop algebra symmetry of the periodic XXZ spin chain

Let us review the sl_2 loop algebra sym m etry of the X X Z spin chain under the periodic boundary conditions. Let us introduce the quantum group U_q (sl_2). The generators S and S Z satisfy the de ning relations

Here, the parameter q is generic. In fact, we may consider U_q (L (sl₂)), i.e., the qanalogue of the universal enveloping algebra of the sl₂ loop algebra. For simplicity, however, we only consider U_q (sl₂) in the paper.

Let V denote a two-dim ensional vector space over C . On the Lth tensor product space V $^{\rm L}$, the generators S $^{\rm Z}$ are given by [12]

Here S_j denotes the jth term with $_j$ in the sum (6). Considering the auto-morphism of $U_q(L(sl_2))$, we introduce the following operators:

Let us denote by S $^{(n)}$ and T $^{(n)}$ the following operators:

Let the symbol $_{6V}$ (v) denote the transfer matrix of the six-vertex model. We now take the parameter q a root of unity. We consider the limit of sending q to a root of unity: $q^{2N}=1$. Then we can show the (anti) commutation relations [12] in the sector of $S^{Z}=0$ (mod N)

Since the XXZ H am iltonian H_{XXZ} is given by the logarithm ic derivative of the transfer m atrix, we have in the sector S^Z 0 (m od N)

Let us now consider the algebra generated by the operators [12]. When q is a primitive 2N th root of unity with N even, or a primitive N th root of unity with N odd, we consider the following identication [12]:

It is shown in Ref. [12] that the operators E_j ; H_j for j=0;1, satisfy the dening relations of the algebra U (L(sl₂)). Explicitly they are given by the following:

Here, the Cartan matrix (a_{ij}) of $A_1^{(1)}$ is defined by

The relations (17) hold for generic q, while the higher Serre relations (19) hold if q is a prim it ive 2N th root of unity or a prim it ive N th root of unity with N odd [12, 26]. The relation (18) holds if q is a prim it ive 2N th root of unity with N even or a prim it ive N th root of unity with N odd. When q is a prim it ive 2N th root of unity with N odd, we take the identication (16) with the imaginary factors.

3 Twisted transfer matrix of the six-vertex model

3.1 Boltzmann weights




Figure 1: Vertex con guration for the Boltzmann weight $X_{bd}^{ac}(u)$. The spectral parameter u corresponds to the angle between the two lines b to c and d to a, which is important to the Yang-Baxter equation (25).

Let us consider the con guration around the vertex as shown in Fig. 1. Variables a;b;c and d are de ned on the edges at the vertex, and they take values 1 or 2. The value 1 corresponds

to a polarization vector that is in the upward or rightward directions, and the value 2 to a polarization vector in the downward or leftward direction. We assign the Boltzmann weight $X_{bd}^{ac}(u)$ to the con guration in Fig. 1. The weight vanishes unless a+c=b+d, which we call the 'ice rule' or the 'tharge conservation'. All the nonzero Boltzmann weights are given by

It is easy to show that the operators X_j (u)s constructed from the Boltzmann weights (21) satisfy the Yang-Baxter equation in the following:

3.2 The six-vertex transfer matrix with the twisted boundary conditions

Recall that the operators X_j (u)s are acting on the tensor product $V^{(L+1)} = V_0 V_1$ We now do not the twisted transfer matrix of the six-vertex model by

The logarithm ic derivative of the twisted transfer matrix leads to the XXZ Ham iltonian H $_{\rm XXZ}$ () under the twisted boundary conditions

We should note that the twisted transfer matrix (26) is dierent from that of Ref. [12]: the logarithm ic derivative of the transfer matrix T^{DFM} (v;) of Ref. [12] leads to the XXZ Ham iltonian under the periodic boundary conditions for any , while that of (26) gives the twisted XXZ Ham iltonian (27).

Let the symbol (12) denote the shift operator de ned by

3.3 G auge transform ations and the crossing sym m etry

We introduce the following transformation on the Boltzmann weights of the six-vertex model [27]:

Here is arbitrary and = 1. We can show that the transformed weights X_{bd}^{ac} (u)s satisfy the Yang-Baxter equation (25) if X_{bd}^{ac} (u)s satisfy it. We call (31) a gauge transform ation. Let X_{j} (u) denote the operator dened by (22) with the X_{bd}^{ac} (u) replaced with X_{bd}^{ac} (u). Then, X_{j} (u)s also satisfy the Yang-Baxter equation (24).

Let us discuss the gauge transform ation (31) with = 1. It has two important properties. First, the transfer matrix (u;) is invariant under the the gauge transform ation due to the charge conservation. Second, when = 1, X_j (u) can be expressed in terms of the generator of the Temperley-Lieb algebra [27]. Let X_{bd}^{ac} (u) denote the transformed weight X_{bd}^{ac} (u) with = 1, respectively. In terms of the Boltzmann weights, we have the following decomposition [27]:

3.4 The Tem perley-Lieb decomposition of X ; (u)s

Let us introduce the following operators

The U_i s satisfy the de ning relations of the Tem perley-Lieb algebra [29, 30]:

for j=1;2;:::;L 1. Here Q $^{1=2}$ is given by Q $^{1=2}$ = $(q+q^{-1})$. We call U $_j$ s the Tem perkey-Lieb operators.

In term s of the Tem perley-Lieb operators, the operator X_j (u) can be expressed as follows $\beta 01$

The decomposition (37) corresponds to (32) for the Boltzmann weights.

The Tem perley-Lieb operators U_j^+ s commute with the generators of U_q (sl₂). We can show [S ; U_j^+] = 0 for j = 0;1;:::;L 1. It can be important, since the XXZ Ham iltonian can be expressed in term s of U_j^+ s and a boundary term [31].

It is known that the periodic XXZ spin chain does not commute with $U_q(sl_2)$. In fact, the generators S do not commute with the periodic XXZ Ham iltonian, since they are not compatible with the periodic boundary conditions. When q is a root of unity, however, some powers of S can commute with it [31]. As a matter of fact, the observation can be developed much further [12]. We rst note that $U_j^+ s$ commute with S while they do not with T, and $U_j^- s$ commute with T while they do not with S . when $q^{2N} = 1$, we can show that the transfer matrix commutes with S imultaneously, and they generate the sl_2 loop algebra [12].

4 Relations of the transfer matrix for generic

4.1 Decomposition of the transfer matrix

Let us consider the gauge transform ations (31) with = 1 and = 1. Due to the charge conservation, they do not change any of the matrix elements of the transfer matrix (26). Thus, we have

We denote by (u;) the right hand side of (38). Putting the decomposition (37) for X_0 (u) into (u;), and making use of the crossing symmetry (34), we can show the following:

We remark that X_{j}^{+} (u)s commute with S while X_{j} (u)s commute with T . When = 0, (39) is reduced to that of the periodic one [12].

4.3 Relations of the twisted transfer matrix

U sing the relations (41), we can derive the following relations of the twisted transfer m atrix for generic q:

Here we note that S com m ute with X $_{LL}^+$ (u) and X $_{RR}^+$ (u), and also that T com m ute with X $_{LL}$ (u) and X $_{RR}$ (u). Some dierent form softhe com m utation relations are given in Appendix A.

We remark that some relations of S $^{(N)}$ with the transfer matrix have been investigated [32].

4.4 Inhom ogeneous case of the twisted transfer matrix

We de nethe inhomogeneous transferm atrix of the six-vertex model under the twisted boundary conditions by

Through the relation (49) we can derive commutation or anti-commutation relations for the inhom ogeneous twisted transferm atrix (u; ; fw_jg). Let jkii denote such a vector with $S^Z = k$. Then we have

We note that for the case of = 0, the inhom ogeneous result was addressed at the end of Ref. [12].

5 The loop algebra sym m etry

5.1 Operators com muting with the twisted transfer matrix

Let us assume that q is a root of unity: $q^{2N} = 1$. We denote by jki such a vector that has a xed S^Z value and it is equivalent to k m od N: S^Z k (m od N). Here k is an integer or a half-integer. Let m and n be two non-negative integers such that m n (m od N). Then we have

The relations (55) are derived from (45). We note that when m = n the expressions (55) are also valid for the case of generic.

Let us denote by (n) the least non-negative integer which is equivalent to $n \mod N$. In the sector S^Z $(m \mod N)$ we have commutation relations X (u;p) = (u;p)X, where X s are given by

and com mutation or anti-com mutation relations X $(u;p) = q^{N}$ (u;p)X, where X s are given by

Here we assume that 'and pare such integers or half-integers that 'pare integers.

In the sector S^Z ' (m od N), the operators (56) and (57) commute with the twisted XXZ H am iltonian H_{XXZ} () with p (m od N). We recall that H_{XXZ} () is given by the logarithm ic derivative of the twisted transfer matrix (u;). For instance, we can show that $S^{(N)}$ and $T^{(N)}$ commute with the anti-periodic XXZ H am iltonian in the sector S^Z N=2 (m od N), when q is a primitive 2N th root of unity. Putting '= N=2 and p= N=2 in (57), we have

5.2 Sym m etry operators for the inhom ogeneous twisted transfer m atrix

From the equations (54), in the sector S^Z ' (m odN), we have the commutation relations X (u;p;fw_jg) = (u;p;fw_jg)X where X s are given by

Here we recall that 'and p are such integers or half-integers that 'p are integers.

5.3 The sl₂ loop algebra at =

Let us discuss the anti-periodic boundary conditions or the twisted boundary conditions with = . In the sector S Z N = 2 (m od N), we can show explicitly the de ning relations of the sl_{2} loop algebra. We consider two cases: (i) q is a primitive 2N th root of unity with N even (L is even); (ii) q is a primitive 2N th root of unity with N odd (L is odd).

Let us consider the form ula for generic q

Taking the $\lim_{x\to \infty} it q^{2N}$! 1 in the sector S^Z N=2 (m od N), we have the following for the cases (i) and (ii):

$$[S^{+(N)};S^{-(N)}] = [T^{+(N)};T^{-(N)}] = \frac{2}{N}S^{Z}$$

W e thus take the following identication for the cases (i) and (ii):

$$E_0^+ = T^{(N)}; E_0^- = T^{(N)}; E_1^+ = S^{(N)}; E_1^- = S^{(N)}; H_0^- = H_1^- = \frac{2}{N}S^Z;$$

Then, we can show that they satisfy the de ning relations of the sl_2 loop algebra: (17), (18) and (19).

5.4 The sl loop algebra sym metry of the periodic XXZ spin chain with L

As an application of the (anti-)commutation relations (45), we discuss the case of the periodic boundary conditions with L odd, where q is a primitive N th root of unity with N odd. Taking the same identication (63) of the generators, we can show explicitly that they satisfy the dening relations of the sl_2 loop algebra in the sector S^Z N=2 (mod N).

For sectors other than S^Z N=2 (m od N), we have not explicitly shown the de ning relations of the sl_2 loop algebra. However, we have a conjecture that some of the operators given in (57) should generate the sl_2 loop algebra. By a dierent method, we can show that the spectral degeneracies related to the sl_2 loop algebra also exist in the sectors other than S^Z N=2 (m od N). We can derive it from the general result on the spectral degeneracy of the eight-vertex model [16] and through the XXZ lim it of the XYZ spin chain. Some details should be discussed elsewhere.
